Dear Prime Minister, the ministerial position has stabilized; what is needed is legal reform

THE supreme Amiri measures related to suspending certain articles of the Constitution were not issued without reason. They followed a careful review of the country's ongoing situation, marked by years of crises that have paralyzed all sectors, strained the national economy, hindered public affairs, and dissipated efforts.

When the new era began, the first step was to give the National Assembly an opportunity to rise to the occasion and deal with matters in a way that would enable Kuwait to confront regional and international challenges.

Unfortunately, instead of taking the right approach, the MPs, immediately from the very first moment, escalated tensions, with rhetoric suggesting the country was heading toward a series of critical crises. As a result, cauterization became the last resort.

Today, the road has been paved for the government. With the stability of the ministerial positions and the suspension of the parliamentary pressures once aimed at the ministers, the government, which is the one entrusted with implementation and legislation, now has the opportunity to fulfill its responsibilities in both execution and legislation. Ministers must take the lead in updating and amending the laws relevant to their ministries; without these reforms, Kuwait will struggle to achieve progress.

As we previously mentioned, around 900 laws have remained unchanged since 1962. Many of these laws were approved based on personal interests, often driven by the principle of "scratch my back and I will scratch yours," or motivated by envy, which



3 escape gallows as Kuwait executes 5

Arab expat gets death for fatally stabbing Asian friend

KUWAIT CITY, Jan 19: The Ministry of Interior executed five individuals on Sunday

morning, including three Kuwaiti men, a Kuwaiti woman and an Arab expatriate. A total of eight individuals were convicted of premeditated murder and were scheduled for execution, but three of them obtained pardons from the victims' blood relatives just hours before the executions were carried out.

According to security sources, the executions took place in the Central Prison building based on the judicial rulings issued

Among the executed convicts was a Kuwaiti citizen who was affiliated with a terrorist organization and had killed a police

officer by running him over during the national celebrations in 2016. The Kuwaiti woman who was executed was sentenced for the murder of her friend in Sabah Al-Salem, and the sentence issued against her had been delayed since September in an attempt to obtain pardons from the victim's blood relatives. Also, a Kuwaiti citizen who had killed another in Kabad was

The sources revealed that three of the convicts managed to secure pardons, with one having completed the procedures related to the pardon, while the others were in the process of obtaining the necessary pardons from the victims' blood relatives. Last September, the Ministry of Interior had executed six convicts based on judicial rulings issued against them.

Meanwhile, the Criminal Court sentenced an Arab expatriate to death for stabbing his Asian friend to death in Farwaniya

1995 fee law scrapped

Public service costs now in hands of gov't entities

KUWAIT CITY, Jan 19: After repeated rejections by previous National Assembly councils of amendments to the law governing public service fees, Decree Law No. 1 of 2025 has been issued, effectively canceling Law No. 79 of 1995 related to fees and financial costs for the use of public facilities and services, reports Al-Seyassah daily.

The decree, published in Kuwait Alyawm, grants each government entity the authority to determine the fees and costs for using public facilities and services

This will be done through decisions made by the competent authority within each entity, in accordance with relevant regulations and subject to approval by the Council of Ministers.

The explanatory memorandum highlights the need for greater flexibility in managing financial resources and ensuring the sustainable delivery of

By canceling the previous law, the government aims to -- ensure effective use and management of public facilities, allow ministries and government departments to establish tailored mechanisms for pricing services and ensure fees do not compromise the minimum standard of living for citizens.

The fees for public services will now undergo detailed study and analysis by relevant authorities.

PART advances Kuwait Railway project with consulting tender

KUWAIT CITY, Jan 19: A government report revealed that the Public Authority for Roads and Transportation (PART) has included a tender for a consulting agreement for the establishment phase of the Kuwait Railway Company. This will be followed by the creation of a company responsible for the operation and maintenance of the project, which is part of the implementation phases of the GCC railway project.

The report explained that the method and type of partnership with the private sector will be studied for the establishment of this company.

The project offers major investment opportunities for the private sector and supports two of the important objectives of the nine-year development plan, which are:

1. Enhancing a dynamic private sector and transforming Kuwait into an attractive investment hub led by private

sector involvement. 2. Promoting general privatization, which will contribute to public finance reforms, diversify income sources, improve service quality, provide job opportunities in the private sector, and boost efficiency and innovation.

The report outlined seven investment opportunities in the project, which will be offered through tenders in stages, as

1. Consulting tender for project design, which has been issued, and the award procedures are being finalized. Work is expected to begin soon, at a cost of KD 2.426 million and an implementation period of 12 months.

2. Consulting tender for design and implementation stages, which covers project management and control.

3. Project implementation tender,

of the Public Authority for Printing and Publication of Holy Quran, Sunnah, and their Sciences shall be transferred to the Ministry of Awqaf and Islamic Affairs. The employees working in the authority will be transferred to the ministry, and they will retain their same grades, salaries, and financial benefits.

Truce holds

Hamas captivity DEIR AL-BALAH, Gaza Strip, Jan 19, (AP): Three hostages

released from Gaza are now in Israel in the first test of a fragile ceasefire with Hamas.

The three hostages are Romi Gonen, 24, kidnapped from the Nova music festival, and Emily Damari, 28, and Doron Steinbrecher, 31, kidnapped from Kibbutz Kfar Aza.

Later on Sunday, Israel is expected to release around 90 Palestinian prisoners.

A gradual release of 33 captives over the next six weeks has been agreed on. In exchange, Israel will release almost 2,000 Palestinian prisoners and Palestinians from Gaza who have been detained. Israel's military said the three

released hostages would undergo an initial medical assessment.

'Selective tax' plan gains support 3 released from for health and economic benefits

KUWAIT CITY, Jan 19: In a recent announcement, Minister of Finance and Minister of State for Economic Affairs and Investment, Noura Al-Fassam, revealed that the Ministry of Finance is planning to introduce a 'selective tax' law aimed at goods that pose health

The tax, expected to generate revenues of approximately 200 million dinars annually, targets harmful products like tobacco, energy drinks and soft drinks.

Economic experts have expressed their support for this initiative, noting its potential to reduce health risks while diversifying Kuwait's sources of

Entrepreneur Asrar Hayat welcomed the proposed tax, emphasizing the need to impose taxes on large companies, particularly those involved in government tenders or BOT projects.

She also highlighted the necessity for detailed studies before implementation, ensuring that small projects are not unfairly burdened.

According to Hayat, this tax could help curb the smuggling of harmful products to neighboring countries that have already enacted similar taxes. She further noted that implementing

such taxes would prevent over-reliance on a single income source, strengthening Kuwait's economic stability. Hayat also pointed out that the tax would likely lead to a 5-20 percent re-

duction in the consumption of harmful products within the first few years. However, she warned that heavy smokers from wealthier demographics may not be as affected, stressing the importance of public awareness campaigns

Ramadan work hours to total 4.5

KUWAIT CITY, Jan 19: Official working hours in the public sector during the month of Ramadan in 2025 will be "flexible", reports Al-Anba daily quoting informed sources.

They explained that the flexible working hours system will continue, with official working hours remaining at 4.5 hours. However, female employees who wish to take advantage of two grace periods - 15 minutes at the beginning of the shift and another 15 minutes at the end - will have their working hours reduced to 4 hours. Male employees will receive only one 15-minute grace period, either at the start or end of their shift.

The advantages offered during Ramadan in 2024, which include grace periods and leave hours, will also apply this year.

The Diwan had implemented flexible working hours last Ramadan, allowing two flexible hours at the beginning of the shift, with the shift in 2023 being divided into three periods

Meanwhile, Head of the Civil Service Commission (CSC) Dr. Issam Al-Rubaian announced that the registration periods for job seekers for the year 2025 will be revealed soon, indicating that the first registration period is scheduled for March. However, sources stressed that it may be more appropriate to open the registration period

in February, instead of the usual March start, as it coincides with the beginning of the month

They affirmed that this timing could prove challenging for employees due to the increased number of holidays during the Ramadan period.

Kuwaitis constitute over 30% students in private schools

KUWAIT CITY, Jan 19: The private education in Kuwait provides a diverse array of options tailored to meet the needs of students and their families, complementing the public education sector.

Its aim is to enhance the efficiency and diversity of the educational process, preparing students for a competitive global environ-

The private education in Kuwait plays a pivotal role in shaping the educational landscape, offering diverse and high-quality options that appeal to Kuwaiti families. While challenges persist, the sector continues to evolve with new initiatives and regulations aimed at improving standards and ensuring accessibility.

By fostering collaboration between public and private sectors and addressing the concerns of parents and students, Kuwait can further enhance its private education system and prepare its youth for a bright future.

The total number of students enrolled in private education stands at 266,232, including 80,515 Kuwaiti students and 2,025 students with special needs, who are distributed across 7,681 classes encompassing a variety of nationalities.

Kuwaiti students constitute approximately 30.25 percent of the total enrollment in private education.

dustry has asked companies and institutions to consult with the Consumer Protection Department regarding the postponement of licenses for seasonal and unplanned offers until after the conclusion of Kuwait Shopping Festival (KSF) 2025. In an official statement posted on its 'X' account, the minis-

try clarified that if the license period for seasonal or unplanned

offers overlaps with the Kuwait Shopping Festival that runs from Jan 21 to Mar 31, 2025; businesses must coordinate with the Consumer Protection Department to postpone the license until after the festival ends in early April. The ministry pointed out that the issuance of licenses for promotional offers, discounts, sales, raffles and gifts is tem-

porarily suspended for all companies and commercial institu-tions. This decision is in line with the exclusivity granted to the Kuwait Shopping Festival, as approved by the Permanent Committee for the Celebration of National Holidays and Occasions. It is also pursuant to Administrative Resolution No. 19/2025, which gives the Major International Festivals Company the authority to organize and manage festivals and

Success rate in 12th grade exams exceeds 85 percent



"The Supreme Committee for Nationality Investigation, under the leadership of the First Deputy Minister of Interior and Minister of Defense, has made significant strides in addressing issues related to nationality violations in Kuwait," columnist Badr Khaled Al-Bahr wrote for Al-Jarida daily.

"Guided by directives from the Supreme Command, the committee is close to finalizing the closure of the Article 8 file -- a major step towards ensuring justice and integrity in the national records

"The ongoing efforts to expose forgers and restore nationalities in alignment with legal frameworks reflect the seriousness of addressing infiltration into Kuwait's social fabric.

"Such crimes have not only compromised national identity but also resulted in the illegal acquisition of state funds and properties. The committee's work is essential in upholding Kuwait's sovereignty and ensuring accountability for

"Moreover, there is a pressing need to examine cases of naturalization under the clause of 'noble deeds.' This provision, originally intended to reward acts of merit, appears to have been exploited in ways that contradict its lofty ideals.

"Special attention should be given to individuals who gained nationality through political favoritism, particularly by representatives affiliated with religious parties. Such affiliations pose risks to national unity and security, underscoring the importance of opening this file for transparent review.

"Turning to the broader Arab context, we see a strange pattern among some leaders and factions of celebrating defeats as victories. Throughout history, defeated leaders have often embraced denial, misleading their people into believing in illusory triumphs. Examples cited include Saddam Hussein, Muammar Gaddafi and others who proclaimed victory even in the face of overwhelming losses.

"The recent actions of Hamas in Gaza reflect a similar narrative. Despite the devastating consequences of the October 7 war with Israel, including the destruction of Gaza's infrastructure and immense civilian suffering, Hamas declared victory.

"This self-proclaimed triumph, does little to address the realities on the ground -- where families mourn their losses, children are orphaned and survivors face insurmountable challenges.

"Hamas's leadership has been accused of prioritizing political agendas over the well-being of Gaza's residents, leaving them trapped and besieged. Messages from within Gaza reveal the grim realities of life under blockade, with injured civilians unable to access medical treatment due to exorbitant fees and closed borders. The region's plight, compounded by fears of settlement in neighboring countries, underscores the dire need for a humanitarian solution.

"The history of ceasefire agreements with Israel paints a bleak picture. Truces, such as the one commemorated in 2009 following the deaths of 1,300 Palestinians, often fail to hold, resulting in

renewed violence and suffering.
"The Oslo Agreement of 1993, once hailed as a path toward peace and the establishment of a Palestinian state, remains unfulfilled. Instead of progress, the conflict has persisted, with Israel expanding settlements and reneging on commitments.

"Amid these challenges, where is the legitimacy of Hamas's claims of victory and prisoner releases? What we look for is more honest appraisal of the situation. Genuine peace and stability require addressing the root causes of the conflict and prioritizing the welfare of the people over political posturing.

"The ongoing efforts to rectify nationality violations in Kuwait and the broader reflections on conflicts in the Arab world highlight the importance of integrity, accountability and a commitment to the well-being of people.

"Whether addressing internal issues or international conflicts, the path forward requires transparency, justice and a focus on sustainable solutions that prioritize humanity over politics.'

KUWAIT CITY, Jan 19: Kuwait's emergency police officers have arrested two expatriates and referred them to the Directorate-General for Drug Control, for possessing 213 bottles of homemade alcohol and 260 Kuwaiti dinars in cash believed to be proceeds from the sale of alcohol,

reports Al-Anba daily. According to a security

source, the suspects were spotted by a police patrol in Mahboula driving a sedan attempting to change route after seeing the patrol car. They were forced to pull over and after checking the car, police found the homemade booze bottles.

The bootleggers, during interrogation, have confessed to trafficking the homemade alcohol.

Maid goes missing after robbing elderly sponsor

KUWAIT CITY, Jan 19: An elderly Kuwaiti man has filed a complaint at a police station in the Ahmadi Governorate, accusing a domestic worker of theft in his house, reports Al-Anba daily.

According to the man's statement, when he woke up in the morning his wife informed him that their worker was absconding and after several attempts to contact the female worker failed, he ran a check of the house and discovered the maid had escaped with a cell phone and several electrical appliances.

The case has been referred for investigation and subsequently handed over to the Criminal Investigation Department. A travel ban has also been imposed on the domestic worker.

Road repairs continue: The General Traffic Department has announced the continuation of maintenance work at the Maghreb Road intersection with the Fourth Ring Road, reports Al-Seyassah daily.

The second phase of the project begins today and will continue until January

As part of this phase, the secondary exit from Morocco Expressway towards Jabriya will be closed.

This closure affects drivers coming from Ahmadi towards the city, who use the exit to reach Salmiya and Jabriya via the Fourth Ring Road.

Drivers are advised to plan alternative routes and exercise caution while navigating the area to avoid delays and ensure safety during the maintenance period.

2 hurt as 5 Kuwaiti men fight over car parking in Shamiya

PADA supervisor accused of forgery

KUWAIT CITY, Jan 19: Five young Kuwaiti men were involved in a fight allegedly over 'the right to park the vehicle' in Shamiya, reports Al-Anba daily. Two of the men have reportedly claimed to have been assaulted and have submitted medical reports to support their case to the area police station.

According to a security source, the complainants are – an employee of the Ministry of Interior (born in 2001) and the other a student at a private university (born in 2002).

The incident happened, they said, at the Wahran

According to one of the complainants one of the suspects who was in the car yelled at him while walking, talking on the phone and he was attacked with a 'ring box' even thought the victim said he replied politely.

He added at this point, his friend came to his rescue seeing he being assaulted, but he too was beaten for no reason.

The suspects were arrested based on the car plate number provided to the police by the victims.

During interrogation, one of the suspects is said to have denied using the ring box or the offensive

Police have asked to see CCTV cameras from nearby areas to get the full details of the brawl.

PADA under probe: The Public Authority for Combating Corruption (Nazaha) has announced the referral of the Public Authority for Disability Affairs (PADA) to the Public Prosecution, reports Al-Rai

The referral is based on the suspicion that the supervisor committed forgery, which is punishable under Articles 257 and 259 of the Penal Code.

Kuwaiti hurt in mishap: A collision between two cars on the Sixth Ring Road left a Kuwaiti citizen injured with fractures and caused heavy traffic disruption, reports Al-Anba daily.

Upon receiving a report of the accident, the Operations Room of the Ministry of Interior dispatched rescue and paramedic teams to the scene. The injured citizen was rushed to the nearest hospital for treatment. Rescue personnel also towed the two vehicles to clear the roadway and alleviate traffic congestion.

Kuwaiti seamstress robbed by shop worker

Feb 5 verdict in case against ex-sports body president

KUWAIT CITY, Jan 19: The Criminal Court has set the session of February 5 for issuing its verdict in the case filed against a former sports federation president who is accused of fraud, forgery, and money laundering by organizing referee camps and tournaments, after the court heard the defense's plea, reports Al-Anba daily.

The Public Prosecution charged the defendant with money laundering, involving KD 1,181,529, which was allegedly obtained through crimes of forgery of official documents and fraud. The defendant was also charged with collaborating with a public employee to forge official documents from a travel and tourism office, and falsely documenting expenses for the Kuwait Fencing Federation. He allegedly submitted fake invoices to the Public Authority for Sports to justify the expenditure of the illicit funds.

Kuwaiti seamstress robbed: Following instructions from the investigator at the Maidan Hawalli has been added to the wanted list, in connection with accusations of stealing wedding dresses and a collection of crystal items valued at over 16,000 Kuwaiti dinars, reports Al-Anba daily.

It remains unclear whether the suspect stole the items in a single instance or over multiple occasions, as well as the worker's relationship with the tailor shop where the theft occurred.

The investigation began after a Kuwaiti woman, born in 1975, reported to the police that she had been betrayed by one of her employees at her private tailoring business.

She explained that despite her efforts to contact the worker through multiple channels, she was unable to reach him. The stolen items included wedding dresses, engagement dresses, and a collection of crystal and accessories.

The woman expressed concerns that the accused might flee the country with the stolen goods.

A case of breach of trust was filed, and the matter has been transferred to the criminal investigations department for further action to apprehend and interrogate the accused.



Kuwait inks bilateral agreement on aviation operations with Mongolia

New pact boosts trade, tourism and safety

KUWAIT CITY, Jan 19, (KUNA): Kuwait's Directorate General of Civil Aviation (DGCA) signed a bilateral agreement with Mongolia on Sunday to regulate air transport between the two countries.

The agreement establishes legal frameworks for designating airlines, operational mechanisms, and technical aspects related to

aviation security and safety.

In a statement to KUNA, President of DGCA, Sheikh Humoud Mubarak Al-Humoud Al-Sabah emphasized that the agreement aims to ensure safe aviation operations between Kuwait and Mongolia, which enhances joint cooperation in the aviation sector.

Sheikh Humoud added that the agreement focuses on implementing the legal and technical measures necessary for airline operations at Kuwait International to ensure the safety and security of passengers

He noted that this agreement was part of Kuwait's broader efforts to establish similar agreements with various countries in the near future, aiming to strengthen the aviation sector, and promote tourism in Kuwait.

On his part, State secretary of Ministry of Roads and Transport, Sandagdorj Batbold expressed his satisfaction with the agreement, stating that this would have a positive impact on trade and tourism between Kuwait and Mongolia

stifled development and allowed a few influential individuals to divide the nation's resources. even at the expense of the country and its peo-

This paralyzed state activities, causing the nation to turn inward and hindering the development of various industries. It also restricted the flow of capital from abroad, especially with the lack of mechanisms to attract foreign investment.

Moreover, this environment contributed to the failure to secure food security, which is the basic pillar for any country to maintain the minimum level of self-reliance. Also, certain laws have even driven investment away, with many

laws being contradictory or overlapping. The challenges faced by small and medium enterprises are a prime example of this, with many finding safer and more attractive environments for growth in neighboring countries.

Therefore, with the recent changes and the stability of the ministerial positions, it is now the responsibility of each minister to review the laws within their ministry's scope. They must seriously strive to learn from the experiences of both neighboring and distant countries that have advanced through progressive laws that align with the current era, cater to societal needs, and eliminate the obstacles that have hindered development.

Today, there is intense competition both regionally and globally to modernize industries, support innovation in various fields, and achieve self-sufficiency. International conditions demand that we think outside the box and embrace broader perspectives. The main factor in this is making room for creativity, and allowing citizens to contribute their full potential.

It is also important to abolish laws that prioritize individual interests without providing any real benefit to the country. 'Selective tax'

Al-Manea also stressed the importance of monitoring market prices to ensure that taxes are not exploited to unjustifiably raise and that tax revenues are directed toward strengthening Kuwait's health sector.

Former Director General of the General Department for Combating Drugs, retired Major General Badr Al-Ghadouri, linked the proposed tax to reducing addiction rates.

He pointed out that cigarettes and other harmful products often serve as gateways to more serious addictions. Al-Ghadouri also noted that the selective tax, already applied in several Gulf Cooperation Council (GCC) countries, helps reduce the consumption of harmful products and generates much-needed revenue for governments.

The proposed selective tax aligns with GCC agreements from 2016, which set tax rates on harmful products such as tobacco, soft drinks and energy drinks.

For instance, countries like Saudi Arabia, the UAE, Oman and Bahrain have implemented excise taxes on these goods, with varying tax rates ranging from 50 percent to 100 percent. Kuwait's introduction of a selective tax would bring it in line with regional efforts to reduce smoking rates and other health risks.

According to 2024 statistics from the Arab Statistics website, Kuwait ranks second in the Gulf in terms of smoking rates, with 22.1 percent of the population affected.

This places Kuwait just behind Bahrain, which leads the region with 25.1 percent of its population smoking.

Meanwhile, in Tel Aviv, thousands of people gathered to watch the news on large screens erupted in cheers. For months, many had gathered in the square to demand a ceasefire deal.

The deal ushers in an initial six-week period of calm and raises hopes for the release of dozens of militant-held hostages and an end to the devastating 15-month war. A last-minute delay by Hamas put off the truce's start by nearly three hours and highlighted its fragility.

Even before the ceasefire took effect, celebrations broke out across the territory and some Palestinians began returning to their homes. Israel earlier announced the names of the first three hostages to be freed in exchange for the planned release of 90 Palestinian prisoners later Sunday.

The truce, which started at 11:15 a.m. local time, is the first step toward ultimately ending the conflict and returning nearly 100 hostages abducted in Hamas' Oct. 7, 2023 attack. An Israeli official confirmed that Romi Gonen,

24, Emily Damari, 28, and Doron Steinbrecher, 31, were the hostages being released Sunday. Gonen was abducted from the Nova music festival, while the others were kidnapped from Kibbutz Kfar Aza. Damari is an Israeli-British dual citizen.

The official, who spoke on condition of anonymity in line with regulations, said the families had approved the publication of the names.

In the interim between 8:30 a.m. and when the ceasefire took hold, Israeli fire killed at least 26 people, according to Gaza's Health Ministry. It did not say whether they were civilians or fighters. The military has warned people to stay away from Israeli forces as they retreat to a buffer zone inside Gaza.

Article 3 of the decree law prohibits any official or civil entity from printing or importing any edition of the Quran without obtaining a permit from the Ministry of Islamic Affairs.

The explanatory memorandum stated that, "In recognition of the pioneering role of the State of Kuwait and its commitment to spreading the Islamic call, including the printing and publishing of the Quran, the traditions of the prophet, and their sciences, this law was enacted to strengthen the role of the Ministry of Awqaf and Islamic Affairs.

"The ministry will now bear responsibility for this important task using its accumulated expertise, available resources, and capabilities to ensure the work is carried out efficiently, with high quality, and at a reduced financial cost. This is in line with the state's general policy, and in light of the current economic conditions, which call for efficient performance

while minimizing public spending. "Violations of the provisions outlined in Article 3 would result in a fine ranging from KD 3,000 to KD 5,000, along with the confiscation of the violating publications and a closure of the facility for a period between three months and one year."

Meanwhile, Decree No. 8/2025 was issued, which amends the decree-law concerning the Ministry of Awqaf and Islamic Affairs. The amendment changes the ministry's name from "Ministry of Awqaf and Islamic Affairs" to the "Ministry of Islamic Affairs".

According to informed sources, the recent amendment to the name of the Ministry of Awqaf and Islamic Affairs was made at the request of the ministry itself with the aim of granting the General Secretariat of Awqaf independence as a separate entity and eliminating any potential

Previously, government studies recommended dissolving the Public Authority for Printing and Publication of Holy Quran, Sunnah, and their Sciences, and integrating its responsibilities under the Ministry of Awqaf and Islamic Affairs. This recommendation followed concerns about the authority's limited achievements and the significant overlap of its competencies with those of other government bodies.

In addition, sources clarified that this move is part of a comprehensive government plan to restructure public institutions with similar functions. The objective is to streamline government operations, reduce public spending, and eliminate overlapping duties, which would, in turn, reduce administrative inefficiency.

Thomas-Greenfield urges America to stay proactive on world stage

Biden's departing UN envoy warns US rivals will fill vacuum if Trump abandons global leadership

WASHINGTON, Jan 19, (AP): The outgoing U.S. ambassador to the United Nations says she watched America's leadership diminish in the world during Donald Trump's first presidency and China fill the vacuum. Linda Thomas-Greenfield is warning that if it happens again during Trump's second term, adversaries will move in anew.

In a wide-ranging interview with The Associated Press, Thomas-Greenfield said during Joe Biden's presidency, the United States again engaged with the world, rebuilt alliances and reestablished America's leadership.

"That is the gift that we hand over to the next administration," she said, "and I hope that they will accept that gift in the spirit in which it is being given to them."

In a brief meeting with Trump's nominee, Rep. Elise Stefanik of New York, Thomas-Greenfield told her "that the U.N. is important, and that it is important that we not cede any space to our adversaries.'

Those rivals "will change the rules of the road," she warned. "And so, U.S. leadership is extraordinarily important.

In his first term, Trump called the United Nations "just a club for people to get together, talk and have a good time." He suspended funding to its health and family planning agencies and withdrew from its cultural and education organization UNESCO and top human rights body. That's raised uncertainty about what's ahead, especially because the United States is the U.N.'s biggest single donor.

Stefanik has called for a "complete reassessment" of U.S. fund-

world "have to be more proactive in our engagement" to try to end these conflicts.

Greenfield focused on Sudan, say-

ing she wished there was closure on

Sudan, where nearly two years of fighting has created famine and the world's worst displacement crisis, is an example "of where as an international community, we could have done more sooner and ended the suffering sooner."

Thomas-Greenfield, now 72, started her career as an academic and lived in Liberia, where she first saw U.S. diplomats at work and decided to join the Foreign Service in 1982.

She spent much of her more than 40-year career in Africa, returning to Liberia as ambassador, and rose to be assistant secretary of state for African affairs from 2013 to 2017, when Trump took office.

Biden brought her out of retirement to become U.N. ambassador and a member of his Cabinet.

At the United Nations, she said she's gained a much broader perspective on Africa's important place in the world and urged recognition of its immense resources - its people.

"Africa is an extraordinarily young continent," Thomas-Greenfield said. "These young people will be the future of the world.

At the U.N., Thomas-Greenfield harkened back to her Louisiana roots, saying she was going to engage in "gumbo diplomacy" by cooking the state's famous dish - which mixes up lots of different flavors - for fellow

'Marked by a yellow tag'

Detained Nobel laureate highlights human rights violations in Belarus

TALLINN, Estonia, Jan 19, (AP): The yellow name tag that Ales Bialiatski wears on his prison garb sets him apart from other inmates in Penal Colony No. 9 in eastern Belarus.

It marks Bialiatski as a political prisoner to be singled out for harsh treatment. Because he's been labeled an "extremist" by authorities, he's routinely denied medications, food parcels from home and contact with relatives, and is subjected to forced labor and stints in punishment cells, according to former inmates.

Authoritarian President Alexander Lukashenko often claimed in his three decades in power that Belarus has no political prisoners, but activists say it currently holds about 1,300 of them. Many endure harsh conditions like Bialiatski, 62, who won the Nobel Peace Prize in 2022 for his human rights activism and is believed to be in worsen-

Belarus will hold a presidential election on Jan. 26 with no real opposition candidates. That all but assures a seventh term for Lukashenko, who was dubbed "Europe's last dictator" early in his tenure.

The vote is shining a spotlight anew on Belarus' human rights record after balloting in 2020 that was denounced at home and abroad as fraudulent. It triggered mass antigovernment protests that led to a harsh crackdown on dissent and thousands of arrests.

"Bialatski's fate underscores the catastrophe in the center of Europe that Lukashenko's regime has plunged Belarus into," said opposition leader Sviatlana Tsikhanouskaya, who ran in the 2020 election but was forced into

Her husband, activist Siarhei Tsikhanouski, also is imprisoned and hasn't been heard from for nearly 700 days.

"If the authorities are openly abusing the Nobel laureate and demonstra-

tively turning his life into hell, then it is not difficult to imagine the torment that thousands of other Belarusian political prisoners are experiencing, Tsikhanouskaya told The Associated

In recent months, Lukashenko has pardoned some political opponents, but critics say it's a revolving door, with his government simultaneously arresting others in a continuing crack-down. Nearly 65,000 people have been arrested since 2020, and many of them alleged they were beaten or tortured in custody, which the government denied. Activists say at least seven have died behind bars.

Bialiatski was arrested in 2021 amid raids by the country's KGB. In March 2023, he was convicted on charges of smuggling and financing actions that 'grossly violated public order," and sentenced to 10 years. Authorities labeled him as especially dangerous because of alleged "extremist" tenden-

He was transferred to the harsh Penal Colony No. 9 in 2023, and Bialiatski's wife, Natalia Pinchuk, hasn't heard from him since August, she told AP in a December interview. A food parcel she had sent to him was returned to her in November - an ominous sign of his bleak conditions.

New administration set to roll out series of executive orders and other actions in first days

Trump returns to Washington for celebrations ahead of inauguration

WASHINGTON, Jan 19, (AP): Donald Trump returned to Washington Saturday evening to celebrate with family, supporters and political allies ahead of his second inauguration, a triumphant return for the Republican four years after he departed the city under the shadow of an attack by his sup-

Trump marked his return to power with a celebration at his Trump National Golf Club in Sterling, Virginia, about 30 miles outside Washington.

He addressed the crowd, giving shoutouts to Virginia Gov. Glenn Youngkin, Amazon founder Jeff Bezos, and declaring his Mideast envoy Steve Witkoff a "great negotiator." Witkoff this past week helped negotiate a ceasefire deal between Israel and Hamas that's scheduled to take effect on

Soon after his remarks, Trump stepped out onto a clubhouse balcony while guests gathered on the patio below him for a fireworks display and performance by tenor Christopher Macchio.

Trump returned to Washington as organizers of Monday's Inauguration Day ceremony were scrambling to move inside most of the outdoor events, including the swearing-in of president and vice president that traditionally takes place on the steps of the U.S. Capitol, due to forecasted frigid tem-

It will be the first time since President Ronald Reagan took the oath of office in 1985 for his second term that the ceremony will be moved inside the U.S. Capitol.

Trump made his way from West Palm Beach, Florida, with his wife Melania Trump and their son Barron aboard a U.S. military C-32 aircraft on a flight dubbed Special Air Mission 47 - a nod to Trump becoming the 47th president on Monday.

It's a courtesy that's traditionally been extended by the outgoing administration to the incoming one. Trump did not make a government plane available to President Joe Biden ahead of his inauguration in 2021, and instead the Democrat flew to Washington on a privately chartered aircraft.

As his motorcade neared his golf club for Saturday's celebration, he was greeted by dozens of well-wishers who gathered along the roadside and chanted "Trump" and "USA,

With a blast of Arctic air expected to leave the nation's capital facing frigid temperatures on Inauguration Day, Trump opted to move inside most of Monday's outdoor events, including the swearing-in ceremony.

"I think we made the right decision. We'll be very comfortable now," Trump told NBC News in a phone interview

On Pennsylvania Avenue leading to the White House, crews were breaking down metal bleachers that would have been used for outdoor inauguration viewing stands.

Even before Trump got to town, groups of protesters began taking to the street in the morning as a light sleet fell. Melody Hamoud, a Washington resident, wore a pink hat that she had on at a 2017 march to protest Trump's first in-

"I just didn't want to sit home and fret in front of the TV," she said. "I wanted to feel like our movement still has energy and be around others who felt the same."

Timothy Wallis, 58, flew in for the inauguration from Pocatello, Idaho, with friends. The group had tickets to watch the ceremony outside but haven't been able to get tickets to any of the indoor events.

"We found out on the plane," he said about the change of plans.

Wallis said he was disappointed about the switch and a little bemused since he's used to cold at home

"We left snow to come here," he said. "I brought my gloves!"

He confirmed he'll "most likely" grant an extension that might allow TikTok to keep operating in the U.S. beyond Sunday, when a law that prohibits mobile app stores and internet hosting services from distributing TikTok to U.S.

And Trump in the NBC News interview confirmed that his administration would begin its effort "very early, very quickly" on following through on a campaign promise of mass deportations of migrants living in the U.S. without legal permission.

Federal immigration officers are expected to initially target more than 300 people in the Chicago area with histories of egregious, violent crimes after Trump takes office Monday, according to an official familiar with the planning who spoke on condition of anonymity because plans have not been made public.

'Well, it's got to happen, and if it doesn't happen, we're not going to have a country any longer," said Trump, who declined to say where the deportation operations would begin.

Trump, a Republican, left office in 2021 as a political pariah after his refusal to accept his loss to Democrat Joe Biden led a mob to overrun the Capitol. He then broke tradition by skipping Biden's inauguration.

Biden will adhere to one of the most potent symbols of the democratic handover, welcoming Trump to the White House and joining him on the ride to the Capitol before Trump The first time Trump was sworn into office eight years

Special call to action as Trump takes office

Civil rights leaders, King family mark MLK Day

WASHINGTON, Jan 19, (AP): When President-elect Donald Trump is sworn in as president of the United States inside the Capitol's rotunda, he will do so facing a bust of the Rev. Martin Luther King Jr. on the federal holiday commemorating King's legacy.

It's a disquieting contrast for some civil rights advocates who wish to fulfill the late reverend's dream of non-violent social revolution.

Events honoring King and advocating for his vision of a just society will occur across the nation as many in the U.S. observe the peaceful transfer of power in the capital. The concurrent events have been met with mixed feelings by civil rights leaders, who broadly reviled Trump's rhetoric and stances on race and civil rights during his third presidential campaign.

But many leaders, including King's own family, see the juxtaposition as a poignant contrast and a chance to refocus the work of advancing civil rights in a new political era

"I'm glad it occurred on that day because it gives the United States of America and the world the contrast in pictures. Is this the way you want to go - or is this the way you want to go?" said the Rev. Bernice King, the late King's youngest daughter and CEO of the King

"It's not a day that he can be the star, which he loves to be," King's daughter said of Trump. "He has to contend with that legacy on that day, regardless of how he manages it and handles it in his presentation. I hope those around him are advising him well to honor the day appropriately in his speech."

This is the third time in the nearly 40 years since the federal King holiday became law that it coincides with a presidential inauguration. Presidents Bill Clinton and Barack Obama also were sworn in for their second terms on the holiday. Both praised King in their remarks; it is yet to be seen if and how Trump who falsely claimed his first inauguration had larger crowds than King's March on Washington - will acknowledge the day. "Will he sound a message of

unity and a presidency for all, or will he continue to focus on his base and some of the divisive policies he's championed, like an anti-DEI stance, rounding up immigrants and cutting important parts of the social safety net through this DOGE (Department of Government Efficiency) process?" asked Marc Morial, president of the National Urban League civil rights

Morial added that Trump's inauguration landing on MLK Day represented "a contradiction of

Many civil rights leaders will spend the day commemorating King's legacy after a week of public and private organizing, giving speeches and strategizing how to respond to the incoming administration's agenda.

"It's the best of times and the worst of times," said Derrick Johnson, president of the NAACP, an organization whose members mentored, collaborated and clashed with King throughout the Civil Rights Movement.

EU sends election observers to Kosovo: An election observation mission has been set up by the European Union to oversee parliamentary elections in Kosovo scheduled for Feb. 9.

The poll is expected to be a key test for Prime Minister Albin Kurti, whose governing party won in a landslide in the 2021. Tensions with neighboring Serbia remain tense since the former Serbian province declared independence in 2008, which Belgrade doesn't recognize.

A team of 100 observers will monitor the elections, un-derlining "continuous EU support for Kosovo to further strengthen its democratic governance," Nathalie Loiseau, the French member of the European Parliament who has been appointed as chief of the mission, said Saturday. (AP)

Ski lift accident leaves 30 injured: At least 30 people have been injured in a ski lift accident at the Spanish resort of Astún, in the Pyrenees mountain range, emergency services for Spain's northern Aragon region

ASEAN FMs seek breakthrough in Myanmar conflict, South China Sea dispute

LANGKAWI, Malaysia, Jan 19, (Agencies): Southeast Asian foreign ministers gathered Sunday for their first meeting this year under the regional bloc's new chair, Malaysia, seeking a breakthrough over Myanmar's drawn-out civil war and territorial disputes in the South China Sea.

The retreat on the idyllic northern resort island of Langkawi was the first major meeting of the 10-member Association of Southeast Asian Nations hosted by Malaysia. Officials said it aims to chart the bloc's direction for the year as it tries to resolve Myanmar's deadly four-year crisis and tensions over China's increasing assertiveness in the South China Sea.

Malaysian Foreign Minister Mohamad Hasan said Myanmar - represented by a low-level Foreign Ministry official after its junta leaders were barred from formal ASEAN meetings - briefed the gathering about plans for a general election this year. But the bloc wants Myanmar's government to ensure peace before any polls are held, he said

"We said the election has to be inclusive. The election cannot be in isolation, it has to involve all stakeholders," he told a news conference at the end of the retreat. "We told them the election is not our priority. Our priority is to stop the violence.

The crisis in Myanmar has emerged as one of the bloc's biggest challenges since a military coup ousted an elected civilian government in February 2021, plunging the country into conflict. It has sparked an armed resistance movement, with rebel forces now controlling large parts of the country. The war has killed tens of thousands of people, and displaced

ASEAN's peace plan and other efforts to seek a solution have so far been futile, hampered by the bloc's non-interference policy and the Myanmar junta's refusal to comply. The military government hopes an election will legitimize its rule, but critics say polls are unlikely to be

Malaysia, which brought Myanmar into ASEAN during its chairmanship

of the bloc in 1997, is expected to take a more proactive stance as the Myanmar crisis has led to the flourishing of criminal activities, online scams and human trafficking along Myanmar's border.

Hasan said Malaysia had appointed Othman Hashim, a former foreign ministry senior official, as special envoy for ASEAN chair to Myanmar to engage various factions in the country to find a way forward.

"We have no intention to carve out Myanmar," he said, adding that dialogue and diplomacy were the best strategies to help the country return to a democratic path.

Hasan said the meeting also dis-

cussed implications of the second term of incoming U.S. President Donald Trump on the region amid its rivalry with China. He said ministers raised concerns that competition between the major powers may increase tensions and have spillover effects in the region. He said ASEAN ministers stressed the urgency to bolster

regional unity and make economic integration a top priority amid the global uncertainties.

"We must ensure that ASEAN remains our central go-to platform for solution seeking... We are the speakers and not the spoken-for. We must drive our own path forward," he said.

Tensions in the South China Sea,

one of the world's vital shipping lanes, were also high on the agenda following violent confrontations in the waters last year. Hasan said the ministers called for accelerated negotiations between ASEAN and China on a code of conduct in the waterway. Officials earlier targeted them for conclusion in 2026 but the talks have stalled over disagreements including whether the pact should be binding and its scope of coverage.

"We stressed that the South China Sea must remain peaceful and stable," Hasan said.

ASEAN members Vietnam, the Philippines, Malaysia and Brunei along with Taiwan have overlapping claims with China, which asserts sovereignty over virtually all of the South China Sea.

Chinese and Philippine vessels clashed repeatedly last year. Chinese forces also assaulted Vietnamese fishermen and Chinese patrol vessels ventured into areas that Indonesia and Malaysia claim as exclusive economic zones. ASEAN has not openly criticized China, which is the bloc's

top trading partner.
As chair, Malaysia is likely to push for quiet diplomacy as it balances security challenges with economic gains, analysts say.

"It would be pragmatism on Malaysia's side, as the country - as well as ASEAN as a whole - lack the diplomatic and military heft to confront China on the South China Sea," said Muhamamd Faizal Abdul Rahman, a research fellow at Singapore's S.Rajaratnam School of International Studies.

US rejects Venezuelan President Maduro's reelection, but WH keeps financial lifeline

CARACAS, Jan 19, (AP): Things seemed to be looking up for Venezuela in 2022. Following years of authoritarian rule and withering economic sanctions, President Nicolás Maduro had agreed to work toward a democratic presidential election. The White House, in return, granted him a financial lifeline: a permit for U.S. energy giant Chevron to pump and export Venezuelan oil.

Oil wells roared back to life and massive tanker ships returned to Venezuela's coast to be filled with heavy, hardto-refine crude destined for the U.S.

Maduro's promised election was neither fair nor free, and the longtime president was sworn in this month for a third six-year term despite credible evidence that his opponent got more votes. Yet, the sanctions reprieve the U.S. offered "to support the restoration of democracy" is still helping fill state

Venezuela's opposition says Ma-

duro's government has earned billions of dollars from exports allowed by the

The White House has ignored calls from the main opposition coalition, as well as Republicans and Democrats in the U.S. Congress, to cancel a permit that now accounts for around a quarter of the South American country's oil

Senior administration officials have struggled to explain why the permit has been left in place under questioning by reporters, saying only that sanctions policy toward Venezuela is frequently reviewed. President Joe Biden told reporters last week he "didn't have enough data" to adjust oil-related sanctions before he leaves office Monday.

Venezuela sits atop the world's largest proven oil reserves and once used them to power Latin America's strongest economy. But corruption, mismanagement and eventual U.S. economic sanctions saw production steadily decline from the 3.5 million barrels per day pumped in 1999, when the fiery Hugo Chávez took power and began his self-described socialist revolution, to less than 400,000 barrels per day in

California-based Chevron Corp., which first invested in Venezuela in the 1920s, does business in the country through joint ventures with the stateowned company Petroleos de Venezuela S.A., commonly known as PDVSA.

The joint ventures produced about 200,000 barrels a day in 2019, but the following year, U.S. sanctions imposed by then-President Donald Trump forced Chevron to wind down production.

In 2020, when the COVID-19 pandemic contributed to a 30% decline in the country's economic activity, Venezuela's Central Bank reported yearover-year inflation of over 1,800%. For many, rummaging through garbage in search of food scraps or valuable items became a common activity.

S.Korea's impeached president formally arrested

Hours after South Korea's impeached President Yoon Suk Yeol was formally arrested, triggering rioting by his supporters, his lawyers said Sunday that he remains defiant in his refusal to answer questions over the probe into his declaration of martial law last month.

Yoon was formally arrested early on Sunday, days after being apprehended at his presidential compound in Seoul. He faces possible imprisonment over his shortlived authoritarian push, which set off the country's most serious political crisis since its democratization in

Yoon's arrest could mark the beginning of an extend-

ed period in custody, lasting months or more.

The decision to arrest Yoon ignited unrest at the Seoul Western District Court, where dozens of his supporters broke in and rioted, destroying the main door and windows. They used plastic chairs, metal beams and police shields that they managed to wrestle away from officers. Some were seen throwing objects and using fire extinguishers, destroying furniture and office machines, smashing glass doors and spraying water on computer servers. They shouted demands to see the judge who had issued the warrant, but she had already

Hundreds of police officers were deployed and nearly 90 protesters were arrested. Some injured police officers were seen being treated at ambulance vans. The court said it was trying to confirm whether any staff members were injured and assess the damage to its

In a statement issued through lawyers, Yoon lament-

ed that the court did not recognize the "just purpose" of his martial law decree but also urged his supporters to express their frustrations peacefully. He called on the police to adopt a lenient stance toward the protesters.

In granting law enforcement's request for an arrest warrant for Yoon, the court said he was a threat to destrov evidence. Yoon and his lawvers on Saturday appeared before the court and argued for his release.

The Corruption Investigation Office for High-Ranking Officials, which is leading a joint investigation with police and the military, can now extend Yoon's detention to 20 days, during which they will transfer the case to public prosecutors for indictment. Investigators are examining whether Yoon's Dec. 3

martial law decree amounted to an attempted rebellion. While South Korean presidents have wide-ranging immunity from prosecution while in office, the protection does not extend to allegations of rebellion or treason.

Yoon's lawyers could also file a petition to challenge the court's arrest warrant. Yoon Kab-keun, one of the president's lawyers, said he will not attend a questioning by the anti-corruption agency set for Sunday afternoon and will remain at the detention center.

Yoon Suk Yeol's appearance in court caused chaotic scenes in nearby streets, where thousands of his fervent supporters rallied for hours calling for his release. Even before the court issued the warrant for Yoon's arrest, protesters repeatedly clashed with police. At least two vehicles carrying anti-corruption investigators were damaged as they left the court after arguing for Yoon's arrest. (AP)

Kenya deploys 217 more cops to Haiti: Kenya has deployed 217 more police officers to Haiti as part of a multinational force to curb gang violence plaguing the Caribbean nation, Kenya's interior minister said on Saturday. According to the minister, Kipchumba Murkomen, the police officers de-

"The Kenya-led mission has made tremendous progress in reducing gang violence, earning praise across the globe," Mukomen said as he shared a photo of himself with some of the officers aboard a plane.

Kenya first sent troops to Haiti in June and the total deployment now exceeds 600. Kenya's President William Ruto has pledged to deploy 1,000 troops as part of the U.N.-backed force in Haiti. (AP)

Scores feared dead in Nigeria tanker blast: Scores of people were believed to have died and many others sustained injuries early Saturday after a tanker laden with gasoline exploded when it overturned, spilling its content on a busy road in Nigeria's north-central state of Niger, a senior official said. Many residents in the Dikko area of the state were caught in a heavy fire while trying to scoop fuel from the gasoline tanker, said Mohammed Bago, the

Niger governor, in a statement. Scores were said to have been burned to death," Bago said, noting those who were not so close to the tanker escaped with injuries. He described the incident as "worrisome, heartbreaking, and unfortunate." (Xinhua)

Indian police volunteer convicted of rape, murder of trainee doctor

NEW DELHI, Jan 19, (AP): An Indian court on Saturday found a police volunteer guilty for the rape and murder of a trainee doctor, a crime that sparked countrywide protests and hospital strikes last year amid renewed concerns over lack of safety for women.

The killing of the 31-year-old physician while she was on duty at a hospital in the eastern city of Kolkata in August highlighted once again the chronic issue of violence against women in the country. The trial in the case was fast-tracked through India's notoriously sluggish legal system and arguments began in November.

Judge Anirban Das said the sentence for 33-year-old Sanjay Roy will be announced on Monday and could range from life imprisonment to the death penalty.

Police discovered the bloodied body of the woman at the city's R.G. Kar Medical College and Hospital's seminar hall on Aug. 9. An autopsy later found the victim had been strangled and confirmed sexual assault.

Roy was arrested a day after the crime. He has since consistently maintained his innocence and told the court that he was not guilty.

Kuwait real estate market sees strong liquidity growth in 2024

Liquidity hits 3.512 billion dinars

KUWAIT CITY, Jan 19: According to Al-Shall's latest report, the liquidity in Kuwait's real estate market for 2024 reached approximately 3.512 billion dinars, marking a 21.3 percent increase from the previous year, which had liquidity of about 2.896 billion dinars, reports Al-Jarida daily.

The liquidity for the second half of 2024 amounted to about 1.939 billion dinars, outpacing the first half's 1.573 billion dinars. This growth parallels the performance of the stock market, highlighting a positive trend for both key assets in Kuwait.

Over the past 15 years, the market has experienced significant fluctuations, especially after the global financial crisis of 2008-2009. The highest liquidity level occurred between 2010 and 2014, reaching 4.992 billion dinars. The market liquidity started to decline in 2015, following a sharp drop in oil prices, and continued to fall into 2017, reaching about 2.382 billion dinars.

However, liquidity rebounded in 2018 and remained relatively strong until the impacts of the COVID-19 pandemic led to a sharp decline in 2020. Post-pandemic recovery in 2021 saw liquidity rise to 3.936 billion dinars, the second-highest level in 15

In 2024, market liquidity grew by 21.3 percent, driven by significant increases in the investment and commercial housing sectors. Private housing activity saw a modest increase of 4.9 percent, totaling around 1.530 billion dinars, but its relative share of the market decreased from 50.3 percent in 2023 to 43.6 percent.

The investment housing activity

surged by 33.6 percent, reaching 1.210 billion dinars, increasing its market share to 34.4 percent. Commercial activity also rose by 45.1 percent, amounting to 745.4 million dinars. with its contribution to market liquidity climbing to 21.1 percent.

The private and investment housing combined accounted for 78 percent of total market liquidity in 2024. The average transaction value for private housing fell slightly to 437 thousand dinars from 469 thousand in 2023.

However, the average value for commercial transactions rose to 5.5 million dinars, up from 4.4 million dinars, while investment housing transactions saw an increase to one million dinars from 789 thousand.

The overall increase in real estate sector trading by 9.5 percent in 2024 reflects a growing confidence in the market, with the liquidity shift toward investment and commercial sectors playing a key role in the sector's per-

145 projects in 5 Arab nations capture 89% of total Capex

Arab automotive sector 'attracts' \$25 billion in foreign investments

KUWAIT CITY, Jan 19: The Arab Investment & Export Credit Guarantee Corporation (Dhaman) revealed that the automotive sector in Arab countries attracted 184 foreign projects, with Capex of more than \$25 billion, providing more than 102,000 jobs from January 2003 to October 2024.

In its fourth sectoral report for 2024 on the Arab automotive sector in Arab countries, issued at its headquarters in the State of Kuwait today, the Corporation said that 5 Arab countries: Saudi Arabia, Morocco, the UAE, Algeria and Egypt, drew 145 foreign projects with a share of 79% of the total, with Capex of more than \$22 billion representing 89%. These projects created more than 91,000 jobs with a share of 89% of the total

The report, which focuses on four key pillars: 1- Evolution and future of auto sales until 2028, 2- foreign trade in vehicles and their components for 2023, 3- foreign projects in the automotive sector, 4- assessment of investment and business risks in auto sales for 2024, showed that China ranked first as the most important investor in the Arab region with 27 projects between 2003 and 2024 with capex nearly \$8 billion and creating roughly 20,000 jobs

It indicated that the top 10 companies held around 41% of new projects implemented, 67% of the Capex and 58% of new jobs, and that Japan's Nissan topped the list with 18 projects or roughly 10% of the total. China's Human Horizon came first as the largest investor in the estimated Capex with a value of \$5.6 billion. The French Renault ranked first in terms of the number of new jobs with 15,000 jobs, making up 15% of the total.

As for risks and rewards for investment and business in auto sales activity in 16 Arab countries according to Fitch, monitored through two indicators of risks and rewards for 2024, the Gulf countries, led by the UAE, topped the Arab list as the best and most attractive destination for investment and business in auto sales activity for 2024, followed by Saudi Arabia, Qatar, Kuwait, Oman and Bahrain, respec-

The report expected a hike of more than 5% in vehicle sales in the Arab region (16 countries) to exceed 2.3 million vehicles by the end of 2024, or 2.4% of the global total amid a likely hike to about 3 million vehicles by 2028. It also pointed out a large geographical concentration of sales in a limited number of countries, where 5 countries: Saudi Arabia, the UAE, Algeria, Morocco and Kuwait had around 75% of overall vehiclesales in the region by the end of 2024.

Concerning passenger car sales in the region (12 Arab countries), they are likely to exceed 1.8 million cars by the end of 2024, up 4.5% compared to 2023, with Saudi Arabia ranking first with a share of 45% amid a projected rise in sales in the region to exceed 2.2 million cars by 2028, according to Fitch.

Regarding the vehicle fleet index per 1,000 population, the report showed that the Arab average went up by 9 points to 307 vehicles per 1,000 population by the end of 2024, even though Libya and five Gulf countries exceeded this average. Yet, it is likely to keep rising to 353 vehicles per 1,000 population by 2028

The report also indicated that Arab countries' foreign trade in road vehicles and their components shot up by about 23% to over \$126 billion in 2023, as a result of the hike in the value of exports by around 29% to \$29 billion(supported by the growth in the re-export activity of vehicles, cars and their components, which accounted for \$14 billion in the GCC countries alone in 2023), and imports by roughly 21% to \$97 billion, with around 82% of the total trade concentrated in 5 Arab countries: the UAE, Saudi Arabia, Morocco, Iraq and Kuwait, with atotal value of \$103 billion.

It added that the top 9 exporting countries to the region during 2023 held roughly 75% of the total Arab imports of road veicles andtheir components with a value of nearly \$73 billion. Japan topped the list as the largest exporter tothe region with a value of \$17 billion (more than 17% of total). The region's top 10 importing countries accounted for 80% of the total Arab exports of vehicles and their components with a value of more than \$23 billion, led by Iraq as the region's largest importer with a value of \$10 billion or 34% of the total.

The report concluded that passenger vehicles came in the forefront of Arab imports of vehicles and their components during 2023, with a value of more than \$63 billion representing more than 65% of overall imports, while vehicle parts and accessories came second with a value of \$14 billion, making up 14% of the total.

'Energy sector vital to Libya's economy'

Libya Energy & Economy Summit opens in Tripoli

TUNIS, Jan 19, (Agencies): Libyan Prime Minister Abdulhamid Mohammad Al-Dbeibeh opened the third Libya Energy and Economic Summit in Tripoli on Saturday in the presence of OPEC and OAPEC secretaries general Haitham Al-Ghais and Jamal Al-Loughani, respectively.

Nearly 1,500 energy corporate leaders, ministers, policymakers, and service and technology providers take part in the two-day global event.

The gathering aims to support Libya's energy sector and infrastructure, promote investment and explore new business opportunities, according to a statement from the Libyan government.

In his inaugural speech, Al-Dbeibeh said his government considers the energy sector the mainstay of national economy. The government strives to rehabilitate the oilfields and was able to re-operate 10 of them, thus raising the oil output capacity to 1.4 million bpd, he noted.

TRIPOLI: The Acting Chairman of Libya's state-owned National Oil Corporation (NOC) Masoud Sulaiman said on Saturday the company plans to increase daily oil and gas production to two million barrels over the next three years if 'the right funds are made available."

Speaking at the third Libya Energy and Economy Summit in Tripoli, Sulaiman announced that Libya's oil sector is on a path of continuous recovery. He highlighted the NOC's achievements over the past three years, including a significant increase in crude oil production, which has surpassed 1.41 million barrels per day, along with gains in gas and condensate production, according to a NOC statement published on its Facebook page.

US labor market remains robust whilst headline inflation ticks up

United States

US Consumer Price Index

In December, US consumer prices experienced their most significant increase in nine months, primarily due to rising energy costs. The Consumer Price Index (CPI) climbed by 0.4% on the month following a 0.3% rise in November, with energy products, especially gasoline, contributing notably to this uptick. Food prices also saw an increase, with egg prices surging due to an avian flu outbreak. Annually, the CPI went up by 2.9%, slightly surpassing expecta-tions. Despite this, core inflation, which excludes food and energy, showed signs of slowing. Core CPI rose 0.2% on the month, below the previous 0.3% increase, and 3.2% annually, better than the forecasted 3.3% figure. As a result, equities rallied, with the S&P 500 rising by 2.9%, while the Nasdaq Composite, dominated by technology stocks, surged 2.5%. Markets are anticipating a potential rate cut by the Federal Reserve in June. However, the Fed is expected to proceed cautiously with rate reductions, considering economic resilience and potential inflationary risks from forthcoming tariffs and immigration policies. At its upcoming January meeting, the Fed is likely to maintain current rates

US Producer Price Index

The December Producer Price Index (PPI) rose 0.2% monthly and 3.3% annually, lower than economists' expectations of 0.3% and 3.4%, suggesting inflation may not be accelerating as feared. Core PPI, excluding food and energy, remained flat monthly and edged up to 3.3% annually. A surge in energy prices, particularly a 9.7% increase in gas prices, drove the monthly rise. Economist Chris Rupkey warned that the positive report might be temporary, with potential inflationary pressures from President-elect Donald Trump's proposed tariffs on key trading partners, which could increase costs for American consumers. Despite the annual PPI reaching its highest since February 2023, the data signals moderated inflation trends for now.

Unemployment Claims

US initial jobless claims rose by 14,000 to 217,000 in the week ending January 11, 2024, exceeding expectations of 210,000 but remaining below the second-half 2024 averages, reflecting a strong labor market. Outstanding claims fell to 1,859,000, continuing a decline from November's peak of 1,908,000. The four-week moving average of claims decreased by 750 to 212,750, smoothing out volatility. Non-seasonally adjusted claims rose by 45,228 to 351,885, with notable increases in California (+13,074), Michigan (+15,175), and Texas (+10,677). The robust labor market supports the Federal Reserve's hawkish stance.

Retail Sales US retail sales rose by 0.4% month-over-month in December 2024, the smallest increase in four months, down from an upwardly revised 0.8% in November and below the expected 0.6%. Despite the slowdown, consumer spending remained strong. Key gains were recorded in miscellane-ous store retailers (4.3%), sporting goods (2.6%), and furniture (2.3%). Increases also occurred in gasoline stations (1.5%), clothing (1.5%), food and beverage stores (0.8%), and motor vehicle dealers (0.7%). However, sales fell in building materials (-2%), food services (-0.3%), and health stores (-0.2%). Core sales, excluding volatile categories, rose 0.4% m/m.

Europe

Inflation

The Eurozone's annual inflation rate rose to 2.4% in December 2024, the highest since July, up from 2.2% in November and in line with expectations. The increase was driven by base effects from last year's energy price declines, with energy costs rebounding (0.1% vs -2% in November) and service inflation slightly accelerating (4% vs 3.9%). Food inflation eased as slower unprocessed food price growth (1.6% vs 2.3%) offset faster gains in processed food, alcohol, and tobacco (2.9% vs 2.8%). Inflation rose in Germany (2.8%) and France (1.8%) but fell in Italy (1.4%). Core inflation remained steady at 2.7%. The ECB expects inflation to return to its 2% target by year-

United Kingdom

Inflation UK inflation unexpectedly de-

clined in December, fueling expectations of an interest rate cut next month. Annual price growth slowed to 2.5% in December, down from 2.6% in November, marking the first decrease in inflation in three months. The drop was largely due to falling hotel prices and smaller-than-usual increases in airfares. However, inflation remains above the Bank

of England's target. Following the inflation data, investors increased their expectations for an interest rate cut next month, with a second cut anticipated by the end of the year. The Bank of England held interest rates steady at 4.75% last month, citing weaker-than-expected economic performance and stagnant growth between October and December.

Retail Sales

UK retail sales fell by 0.3% month-over-month in December 2024, contrary to expectations of a 0.4% increase, following a revised 0.1% rise in November. Declines in food store sales (-1.9%) were partly offset by a 1.1% rise in non-food stores, with clothing sales surging by 4.4% and stronger Christmas sales boosting department and household goods stores. Year-on-year, retail sales rose 3.6%. Excluding fuel, sales dropped 0.6% on the month but rose 2.9% annually. For Q4, sales fell 0.8% compared to Q3 but increased 1.9% year-on-year. In 2024, retail sales volumes grew 0.7%, recovering from declines of 2.9% in 2023 and 4.1% in 2022. The GBP/USD currency pair

closed the week at 1.2163.

Asia Pacific

Chinese Economy China's economy grew by 5.4% year-on-year in Q4 2024, up from 4.6% in Q3 and exceeding expectations of 5.0%, marking the fastest annual growth in 1.5 years. This was driven by stimulus measures introduced since dustrial output reach an 8-month high, while retail sales recovered from a 3-month low. However, unemployment hit a 3-month high. Exports surged, reaching the highest level in three years, with firms rushing shipments ahead of possible US tariffs. Imports also unexpectedly rose to a 27-month peak. For 2024, GDP grew by 5.0%, meeting Beijing's target but

above the 3.0% growth in 2023.



US sanctions on Russia's energy sector impact key importers

Oil prices surge to 5-month highs in early 2025 amid supply tightness

Oil prices declined for the second consecutive year in 2024 after expectations of a recovery in oil demand in China failed to realize while record production in the US forced prices to remain subdued during the year. The market in 2024 two distinct halves with gains seen during the first half of the year followed by declines during the second half. Prices remained below the 80/b mark for most part 2H-2024 also due to lower economic growth seen in key economies in Europe. Also, the war on Gaza and Lebanon, the Russia/Ukraine conflict and the supply disruption in the Red Sea further added to the risks in the oil market, resulting in temporary support to prices. Meanwhile, a consistently strengthening US Dollar against a basket of currencies limited demand growth from key emerging market oil importers.

The start of 2025 was marked by a healthy recovery in prices backed by talks of renewed stricter sanctions on Russia coupled with hopes of higher demand from China. The colder weather conditions as well as crude oil inventory decline for the eighth consecutive week in the US also added support to oil prices. The record gain in natural gas prices also led to talks of gas to oil switch for electricity generation. However, uncertainties related to oil production policies in the US after the formation of the new government capped further gains as the market expects policy support for further production growth in the US. Talks of trade wars and retaliatory sanctions and tariffs also increased speculations in the oil market as Canada and Europe work on their respective strategies to tackle the expected hike in tariffs by the incoming US government.

The US government introduced new sanctions on Russia's energy sector last week and imposed harsher curbs on key oil supplying companies in Russia including Gazprom and Surgutneftegas and on 183 vessels that have shipped Russian oil. Key oil importers like India and China are expected to be the most impacted as reports suggested that these countries benefitted from the lower priced Russian oil during 2024. There is a winddown period until 12-March-2025 to settle payments for Russian oil as the sanctions also include curbs on dealing with Russian banks. A report from IEA showed that the banned vessels carried around a fifth of seaborne Russian oil or 1.6 mb/d during 2024.

Supply side factors have also supported the recent crude oil price trend. While OPEC+ production remained constrained, oil production in the US declined for the fifth consecutive week until the week of 10-January-2025. Weekly oil production data from the US showed output at 13.48 mb/d last week as compared to a record high of 13.63 mb/d reached at the start of December-2024. OPEC crude oil production remained range-bound during last month at 26.7 mb/d, as per data from OPEC secondary sources, after a recovery in production in swing producers were offset by fall in output in larger producers in the group.


Oil Market in 2024

Crude oil traded in a relatively narrow range but mostly trended downward during 2024...

The oil market in 2024 was characterized by continued risk on the geopolitical front with the continued war on Gaza, the Russia/Ukraine conflict and the disruption of the Red Sea route. However, the risk premium related to the war faded as the market witnessed record oil supplies from the US that limited the impact of OPEC+ curbs on the oil market. In addition, lower-than-expected demand growth in China in 2024 also affected the sentiments in the oil market. The Chinese government announced measures to support the economy only came during the tail end of the year and were mostly related to policies with an implied impact on crude

oil demand in the country.

In terms of prices, crude oil traded in a relatively narrower range in 2024 vs. 2023. Crude oil prices only briefly breached the USD 90/b mark during the 1H-2024 and mostly traded around the USD 85/b mark. However, the third quarter of the year witnessed continued decline in prices going below the USD 70/b mark by the second week of September-2024 as OPEC+ discussed unwinding of the supply cuts that were ultimately postponed. The last quarter of the year mostly saw range bound prices below the USD 75/b mark.



OPEC reference basket prices peaked at a yearly high of USD 91.11/b at the start of April-2024, the highest prices since the end of October-2023 led by tensions in the Middle East region in addition to an increase in crude oil imports in China during March-2024. Brent spot prices also peaked around the same time at USD 92.8/barrel during the first week of April-2024. On the other hand, the lowest point during the year was seen in September-2024 when OPEC reference basket prices reached USD 70.8/ barrel while Brent spot crude reached USD 70.3/barrel. The year closed with OPEC reference basket trading at USD 74.59/barrel resulting in a decline of 4.9% during the year, while Brent prices saw a slightly smaller yearly decline of 4.0% after reaching USD 74.58/barrel by the end of the year. Future prices witnessed an even smaller decline of 3.1% for near term Brent contracts that traded at USD 74.64/b at the close of the year. The spread between Brent and WTI crude grades narrowed during the year and stood at an average of USD 4.44/b as compared to an average of USD 4.69/b in 2023. The spread at the end of the year narrowed to USD 2.47/b as compared to USD 5.2/b at the start of the year.

The consensus estimates on crude oil grades underwent drastic changes during 2024 as unprecedented events occurred during the year, in addition to underwhelming recovery in global oil demand, especially in China. The Bloomberg estimate for Brent crude oil future prices in 2024 started the year with a forecast of USD 84.6 per barrel but closed the year significantly lower at around USD 80 per barrel. A similar downgrade was seen in forecasts from the EIA for both Brent and WTI crude grades.

OPEC Production

The production policy for the countries under the OPEC+ agreement (DoC) remained unchanged during the year after the implementation of additional voluntary cuts of 2.2 mb/d at the start of the year. The group's attempt to unwind the output cuts and the voluntary cuts were unsuccessful as oil prices remained subdued during the year. OPEC production witnessed consistent growth during the first half of the year followed by a steep decline during September-2024 due to a fall in production in Libya. The recovery in production in the country supported the growth during October-2024 and November-2024 resulting in the highest yearly production rate for OPEC at 27.17 mb/d at the end of November-2024.

Average OPEC crude oil production declined for the second consecutive year during 2024. Output from the 12-mem-

bers in the OPEC averaged at 26.6 mb/d during the year as compared to 27.0 mb/d during 2023, registering a decline of 1.6% or 435 tb/d, according to data from OPEC secondary sources. The decline was led by fall in output from 7 out of the 12 producers in the group while the remaining 5 producers reported higher production. Saudi Arabia once again registered the biggest decline in crude oil production during 2024 after the implementation of voluntary cuts. Average crude oil production in the Kingdom reached 8.97 mb/d during 2024 as compared to 9.6 mb/d in 2023, registering a decline of 6.6% or 636 tb/d during 2024. Kuwait was next with the second-biggest decline in average crude oil production at 172 tb/d with production averaging at 2.42 mb/d in 2024 as compared to 2.6 mb/d during 2023. Iraq and Algeria also recorded decline in average production during the year. Iraq produced at an average rate of 4.2 mb/d in 2024 registering a decline of 99 tb/d as compared to 2023. Algeria, meanwhile, recorded a decline of 66 tb/d and produced at an average rate of 907 tb/d during 2024, the lowest in four years. Average oil production in Libya also declined during the year to 1.11 mb/d as compared to 1.16 b/d in 2023 mainly led by production embargo in the country during August-2024. Average monthly output in Libya declined to the lowest in four years during August-2023 to reach 0.54 mb/d as a result of a political standoff in the country that halted production and exports

from the terminals in the country.

On the other hand, Iran reported the biggest increase in output during the year reaching an average of 3.26 mb/d in 2024 as compared to 2.86 mb/d during 2023, registering an increase of 0.4 mb/d or 14.0%. Venezuela was next with an output growth of 107 tb/d in 2024 reaching an average production of 856 tb/d, the highest in six years. Nigeria recorded the third-biggest production growth during the year at 94 tb/d and an average yearly production of 1.4 mb/d, the

Oil Prices

Oil prices surged to the highest level in five months last week following consistent gains since the start of the year. Brent spot prices gained 10.9% since the start of the year until Wednesday (13-Jan-2025) to reach USD 82.7/b, while Brent futures breached the USD 80/b mark for the first time since October-2024 and traded around USD 81/b on Thursday. The gains came after data showed tightening oil market in 2025 led by sanctions on Russia coupled with positive data that suggested higher demand for crude oil. The latest weekly data on crude oil inventories in the US showed the longest streak of declines since 2021 with eight consecutive

weeks of declines that pushed aggregate inventories to the lowest level in almost two years at 412.7 million barrels as of 10-January-2024. The prompt spread on WTI widened to 1.29 per barrel indicating a backwardation in the oil market and reflecting tightening market conditions.

On the other hand, rig count data from Baker Hughes indicated that the aggregate oil rigs in the US once again went below the 500 mark and was reported at 497 for the week ended 19-January-2024. The decline in rig count coupled with higher supplies from the US indicated better well productivity in the sector.

Meanwhile, in its latest forecast, the EIA made a slight upgrade to its forecast for Brent crude for 2025. The agency expects Brent crude spot to average at USD 74.0/b in 2025 as compared to its previous forecast of USD 73.58/b. The forecast for 2026 showed a steep decline from of around 10.8% from 2025 estimates and is expected to reach USD 66/b, as per the EIA. The broader consensus estimate from Bloomberg showed a downgrade in estimates for the next four quarters and prices are expected to reach USD 72.75/b by year end. In terms of monthly trend, Brent crude averaged at USD 73.8/b during December -2024 after witnessing a marginal monthly decline of 0.7% vs. November-2024. The OPEC crude basket, meanwhile, showed a small gain of 0.1% and averaged at USD 73.1/b.

World Oil Demand

The global oil demand growth forecast for 2025 was kept unchanged by the OPEC in its latest monthly report. The agency expects demand to grow by 1.45 mb/d this year to reach 105.2 mb/d. However, there was a revision to demand data for 2024 that resulted in a downgrade of 0.07 mb/d to total demand forecast for 2025. The year 2024 was characterized by strong demand fundamentals in the US with indicators like labor, unemployment rates, economic growth rates as well as industrial production and manufacturing all pointing to a resilient year despite higher inflation rates. The most recent data on industrial production in the US for December-2024 showed a monthly growth of 0.9% with the index reaching the highest since February- 2024. The data on inflation also showed progress with core consumer price index showing a decline for the first time in six months during December-2024 at 3.2% while headline CPI came in line with expectation at 2.9% as compared to 2.7% in November-2024. On the other hand, oil demand in China failed to reach the levels expected at the start of 2024 and overall imports of crude oil declined during the year by 1.9%. This was the first yearly decline in crude oil imports in China (excluding the pandemic years) in two decades. In terms of regional trend, the demand in the OECD region is expected to grow by 0.11 mb/d while non-OECD region is expected to show a stronger growth of 1.34 mb/d in 2025. Meanwhile, the forecasts from the IEA showed demand increasing by a relatively smaller pace of 1.05 mb/d in 2025 to reach 104.0 mb/d as compared to 102.9 mb/d in 2024.

For 2026, the OPEC forecasts suggest steady growth in demand driven mainly by higher demand from China and India. In its first forecast for the year 2026, the OPEC expects world oil demand to grow by 1.43 mb/d to reach 106.63 mb/d. The growth is expected to mainly come from the non-OECD region with demand in the region expected to grow by 1.31 mb/d in 2026 to reach 60.62 mb/d. Non-OECD demand, meanwhile, is expected to see a much smaller growth of 0.12 mb/d and is expected to average at 46.0 mb/d during the year. Demand from India, China and Other Asia are expected to see the strongest growth during the year.

Oil Supply

According to IEA, global oil supply increased by 20 tb/d in December-2024 to reach 103.5 mb/d led by higher production from Libya that more than offset a seasonal decline in production from non-OPEC+ suppliers. Data also showed a noticeable decline in production in the UAE and Kuwait. Data from Rystad Energy showed a fall in output from shale patches in the US for the first time in six months during December-2024 to reach 10.5 mb/d. The decline is expected to continue in the coming weeks led by the cold snap in the Permian basin that affects pipeline flows.

Conference to explore global trends and geopolitics

TikTok goes dark as US ban takes effect

Company's app was removed

NEW YORK, Jan 19, (AP): Millions of TikTok users in the United States are no longer able to watch videos on the social media platform as a federal ban on the immensely popular app takes effect.

The company's app was removed Saturday evening from prominent app stores, including the ones operated by Apple and Google, while its website told users that the short-form video platform was no longer available. The blackout began just hours before the law took effect.

Users opening the TikTok app on Saturday encountered a pop-up message preventing them from scrolling videos that read, "Sorry, TikTok isn't available right now."

"A law banning TikTok has been enacted in the U.S.," the message said. "Unfortunately that means you can't use TikTok for now."


"We are fortunate that President Trump has indicated that he will work with us on a solution to reinstate Tik-Tok once he takes office," the notice continued, in a reference to President-elect Donald Trump's pledge to "save" the platform. The company told its users to stay tuned.

The only option the message gives to U.S. users is to close the app or click another option leading them to the platform's website. There, users are shown the same message and given the option to download their data, an action TikTok previously said may take days to process.

Before the announcement went out, TikTok said in another message to users that its service would be "temporarily unavailable" and the company was working to restore its U.S. service "as soon as possible." But how long the platform will remain dark is unclear.

Apple said in a statement on its website that TikTok and ByteDance apps were no longer available in the U.S., while visitors to the country could have limited access. "Apple is obligated to follow the laws in the jurisdictions where it operates," the company said.

"If you already have these apps installed on your device, they will remain

on your device. But they can't be redownloaded if deleted or restored if you move to a new device. In-app purchases and new subscriptions are no longer possible," the statement said, adding that the change could impact performance, security and compatability with future versions of iOS and iPadOS.

TikTok CEO Shou Chew posted a video thanking Trump for his commitment to work with the company to keep the app available in the U.S. and a "strong stand for the first amendment and against arbitrary censorship."

"We are grateful and pleased to have the support of a president who truly understands our platform. One who has used talk to express his own thoughts and perspectives, connecting with the world and generating more than 60 billion views of his content in the process," Chew said.

In an interview with NBC News on Saturday, President-elect Donald Trump said he was thinking about giving TikTok a 90-day extension that would allow them to continue operating. If such an extension happens, Trump - who once favored a TikTok ban - said it would "probably" be announced Monday, the day that he is sworn in as president. TikTok CEO Shou Chew is expected to attend Trump's inauguration with a prime seating location.

In Washington, lawmakers and administration officials have long raised concerns about the app, which they see as a national security threat due to its Chinese ownership. TikTok is owned by ByteDance, a technology company based in Beijing that operates the well-

known video editing app CapCut and Lemon8, both of which were also unavailable for service Saturday evening.

The federal law required ByteDance to cut ties with TikTok by Sunday or face a nationwide ban. The statute was passed by Congress in April after it was included as part of a high-priority \$95 billion package that provided foreign aid to Ukraine and Israel. President Joe Biden quickly signed it, and then TikTok and ByteDance quickly sued on First Amendment grounds.

While defending the law in court, the Biden administration argued it was concerned about TikTok collecting vast swaths of U.S. user data that could fall into the hands of the Chinese government through coercion.

Officials have also warned the algorithm that fuels what users see on the app is vulnerable to manipulation by Chinese authorities, who can use it to shape content on the platform in a way that's difficult to detect. But to date, the U.S. has not publicly provided evidence of TikTok handing user data to Chinese authorities or tinkering with its algorithm to benefit Chinese inter-

Supreme Court upholds TikTok ban: Five essential reads on case & its consequences

The U.S. Supreme Court on Jan. 17, 2025, upheld a law requiring TikTok's China-based parent company, ByteDance, to sell the video app by Jan. 19, 2025, or face a nationwide ban on the app. In a unanimous decision, the court rejected TikTok's claim that the law violates its First Amendment rights. The company shut down the app shortly before midnight on Jan. 18.

The court's ruling is the latest development in a lengthy saga over the fate of an app that is widely popular, especially among young Americans, but that many politicians in Washington say is a security risk.

The ruling is unlikely to be the end of the story. President Joe Biden said that he will not enforce the law in the waning hours of his administration. President-elect Donald Trump said he will reverse the ban and is reportedly considering an executive order to do so.

But why is TikTok controversial? Are the claims of it being a national security risk valid? And what will the case mean for free speech? The Conversation's contributors have been on hand to answer these questions.

swer these questions.

Politicians who wanted to ban TikTok, or at least sever its links to China, fear that the app provides a way for the Chinese Communist Party to influence Americans or use their data for malicious purposes. But how much influence does the

Chinese government have on Tik-Tok? That question is addressed by Shaomin Li, a scholar of China's political economy and business at Old Dominion University.

Li explains that the relationship between TikTok, ByteDance and the Chinese Communist Party is nuanced - it isn't simply a matter of officials in Beijing telling ByteDance to jump and the parent company dictating how high its subsidiary will leap. Rather, as with all companies in China, employees are under certain obligations when it comes to advancing national interests. In China, private enterprises, such as ByteDance, operate as joint ventures with the state.

"Regardless of whether ByteDance has formal ties with the party, there will be the tacit understanding that the management is working for two bosses: the investors of the company and, more importantly, their political overseers that represent the party," Li writes. "But most importantly, when the interests of the two bosses conflict, the party trumps."

The risks TikTok poses to U.S. users are similar to the risks posed by many popular apps, principally that the app collects data about you. That data, which includes contact information and website tracking, plus all data you post and messages you send through the app, is available to use or misuse by ByteDance and any other entity that has or gains access to it.

Iowa State University cybersecurity researcher Doug Jacobson writes that U.S. officials and lawmakers are concerned that the Chinese government could exploit TikTok user data to spy on U.S. citizens. Government hackers could use the TikTok data to trick users into revealing more personal

informatio

But if the goal is to counter Chinese hackers, banning TikTok is likely to prove too little, too late. "By some estimates, the Chinese government has already collected personal information on at least 80% of the U.S. population via various means," Jacobson writes. "The Chinese government - along with anyone else with money - also has access to the large market for personal data."

Banning TikTok could also make U.S. users more vulnerable to hackers of all stripes. Rochester Institute of Technology computer security expert Robert Olson writes that many of the 170 million U.S. TikTok users could try to get around a ban on the app, with negative consequences for their digital safety

If TikTok ends up banned from Apple's and Google's app stores, users could try to access the app elsewhere via sideloading. This practice of getting around the Apple and Google app stores leaves users vulnerable to malware posing as the TikTok app. TikTok users might also be motivated to circumvent Apple and Google security controls in order to keep the app installed, a move that would make users' phones more vulnerable.

"I find it unlikely that a TikTok ban (is) technologically enforceable," Olson writes. "This ... legislation - aimed at improving cybersecurity - could motivate users to engage in riskier digital behavior."

In its legal challenge to the U.S. government, ByteDance claimed the government is violating its First Amendment rights. Technology law scholars Anupam Chander of Georgetown University and Gautam Hans of Cornell University write that ByteDance had

grounds for its claim, and that the implications go beyond this case.

TikTok is a publisher - an online publisher of users' videos. Forcing ByteDance to divest TikTok is a form of prior restraint - the government preventing speech before it occurs, Chander and Hans write.

"By forcing the sale of TikTok to an entity without ties to the Chinese Communist Party, Congress' intent with the law is to change the nature of the platform," they write. "That kind of government action implicates the core concerns that the First Amendment was designed to protect against: government interference in the speech of private parties."

Security and legal issues aside, the forced sale to a U.S.-based company or ban of TikTok in the United States is a questionable approach to solving the problems the law aims to address: potential Chinese government influence in the U.S., harm to teens and data privacy violations, writes Arizona State media scholar Sarah Florini.

The Chinese government - and other U.S. adversaries - have long used social media apps owned by U.S. companies to attempt to influence American public opinion. TikTok is hardly alone in posing harm to teens, as the Facebook whistleblower case amply demonstrated. And vast amounts of Americans' personal data are already available to any buyer on the open and black markets.

"Concerns about TikTok are not unfounded, but they are also not unique. Each threat posed by TikTok has also been posed by U.S.-based social media for over a decade," Florini writes.

Nigeria admitted as partner country of BRICS bloc: Brazil

ABUJA, Nigeria, Jan 19, (AP): Nigeria has been admitted as a "partner country" of the BRICS bloc of developing economies, according to Brazil, the group's chair.

BRICS was formed by Brazil, Russia, India and China in 2009, with South Africa added in 2010, as a counterweight to the Group of Seven leading industrialized nations.

Last year, the bloc added Iran, Egypt, Ethiopia and the United Arab Emirates. Saudi Arabia has been invited to join. Turkey, Azerbaijan and Malaysia have formally applied to become members, and a few others have expressed interest.

Nigeria becomes the ninth BRICS partner country, joining Belarus, Bolivia, Cuba, Kazakhstan, Malaysia,

Thailand, Uganda, and Uzbekistan.

"With the world's sixth-largest population - and Africa's largest - as well as being one of the continent's major economies, Nigeria shares convergent interests with other members of BRICS," Brazil's government said in a statement Friday.

"It plays an active role in strengthening South-South cooperation and in reforming global governance - issues that are top priorities during Brazil's current presidency."

President-elect Donald Trump last year threatened 100% tariffs against BRICS if they act to undermine the U.S. dollar. The bloc's leaders have voiced their commitment to introduce an alternative payment system that would not be dependent on the dollar.

Treasury nominee calls for stronger Russia sanctions & Fed independence

WASHINGTON, Jan 19, (AP): U.S. Treasury nominee Scott Bessent on Thursday faced sharp questions from both Democrats and Republicans on tax policy, tariffs, China, Russia sanctions and the future of an IRS tax filing system that Republicans have called to be cut.

Bessent sat in front of the Senate Fi-

nance Committee for his confirmation hearing, where he told lawmakers that the U.S. faces economic calamity if Congress does not renew provisions of President-elect Donald Trump 's Tax Cuts and Jobs Act. He also asserted the Federal Reserve should remain independent from the president's influence and U.S. sanctions on Russian oil should be more aggressive.

He was introduced by a fellow South Carolinian, Republican Sen. Lindsey Graham, who said the U.S. needs a treasury secretary "who knows what he's doing, has the trust of the president and loves his country." Graham added: "Your ship came in with this guy."

this guy."
But Democrats, including Sens. Ron
Wyden of Oregon and Michael Bennet
of Colorado, expressed frustration that
Trump's promise to extend provisions
of his 2017 tax cuts would benefit the
wealthiest taxpayers and add to the
growing national debt that has surpassed \$36 trillion.

Bennet assailed Bessent for shedding "crocodile tears" over the debt and spending, while the Tax Cuts and Jobs Act drove up the debt. "There's so many things I think you owe the American people after we have seen the catastrophe" from the tax cuts.

Bessent is a billionaire who, before becoming a Trump donor and adviser, donated to various Democratic causes in the early 2000s, notably Al Gore's presidential run. He also worked for George Soros, a major supporter of Democrats.

Republican Sen. Ron Johnson of Wisconsin also probed Bessent with questions about bringing national spending down to pre-pandemic levels.

In his testimony, Bessent committed to maintaining the IRS' Direct File program - which allows taxpayers to file their returns directly to the IRS for free - at least for the 2025 tax season, which begins Jan. 27. Republican law-makers say the program is a waste of money because free filing programs already exist, although they are not popular.

He also called for stronger sanctions on Russia, saying the Biden administration's sanctions regime isn't "muscular" enough. "I believe the previous administration was worried about raising U.S. energy prices during an election season," he said.

Promoting economic growth remains govt's top priority

Britain's CPI falls as inflation pressure persists

LONDON, Jan 19, (Xinhua): Britain's Consumer Price Index (CPI) unexpectedly declined in December, drawing concerns about inflation and monetary policy outlook.

The Office for National Statistics (ONS) reported Wednesday that December's CPI fell slightly to 2.5 from 2.6 percent in November. The core CPI decreased to 3.2 from 3.5 percent, while the CPI service annual rate dropped to 4.4 from 5 percent. These figures surpassed market expectations, as earlier surveys had predicted CPI to remain steady at 2.6 percent.

Grant Fitzner, chief economist at the ONS, pointed out that the price declines in sectors such as hotels and tobacco offset rising energy costs. Easing inflation provided relief for the British Treasury, which has been grappling with concerns over economic and fiscal stability.

Commenting on the latest figures, Chancellor of the Exchequer Rachel Reeves emphasized that promoting economic growth remains the government's top priority, though much work remains to be done.

From firms' perspective, the impact of this decline in prices might be limited. Companies face mounting cost pressures due to fiscal measures set to take effect in April, including increases in National Insurance Contributions (NICs) for employers and a rise in the minimum wage.

These policies are forcing many businesses to raise prices to offset higher costs. According to a recent survey by the British Chambers of Commerce (BCC), 75 percent of firms reported that rising labor costs have compelled them to increase their product and service prices.

Stuart Morrison, research director at the BCC, welcomed the slower pace of inflation but highlighted its insignificance in altering the broader economic picture.

Labor cost pressures remain acute, particularly in the hospitality sector, where most companies expect to hike prices in the next three months.

Similarly, a survey by the British Retail Consortium (BRC) echoes the trend. Some 67 percent of 52 chief financial officers surveyed by the BRC plan to raise prices in response to higher NICs.

BRC Chief Executive Helen Dickinson warned that new fiscal measures are likely to push costs up by an additional 7 billion British pounds (about 8.52 billion U.S. dollars) by 2025 for retailers. Given the slow-growing nature of the market and low-profit margins, most retailers have no choice but to raise prices. So she expects steady increases in food inflation throughout the year.

Research institutions have reached a general consensus on the trajectory of Britain's inflation.

Monica George Michail, an assistant researcher with the National Institute of Economic and Social Research (NIESR), forecasts "headline inflation to rise in January 2025 due to base effects from last year dropping out, before slowing again."

Some analysts argue that the new inflation data may allow the Bank of England (BoE) to cut rates in February, while some others say more data is needed to support any changes in the interest rate due to significant inflationary pressures persisting

"The path ahead on interest rates this year is likely to remain slow and cautious," said Morrison. "The upcoming Trump presidency has heightened global uncertainty and inflation expectations."

Threat of tariffs looms

Mexico and EU revamp trade deal days before Trump takes office

MEXICO CITY, Jan 19, (AP): Mexico and the European Union on Friday announced a revamped trade agreement that they said would substantially increase trade and investment, days before the inauguration of U.S. President-elect Donald Trump, who has threatened to slap sweeping tariffs on Mexico and other trading partners.

The new Global Trade Agreement between Mexico and the 27-nation bloc would reduce Mexican tariffs of agri-food imports from Europe, remove a number of barriers that would allow European companies to more easily invest in Mexico and boost Mexican exports of raw materials like fluorspar (used in electronics) as well as antimony, copper, zinc and lead.

The updated deal, which first entered into force 25 years ago, also seeks to facilitate "strategic cooperation on key geopolitical issues," the European Union said in a statement.

"We have entered a new era in our strategic partnership with Mexico today. Our upgraded agreement shows the E.U. and Mexico united for freer trade and an open global economy," said Kaja Kallas, vice president of the European Commission, in a statement.

The announcement comes days before the return to the White House of Trump, who has threatened to impose tariffs as high as 25% on all Mexican imports, which could deal a

sharp blow to both economies. While an updated agreement with the E.U. could mitigate some of the potential losses from disrupted U.S.-Mexico trade, trade between Mexico and the European Union still represents only a small portion of Mexico's annual trade with the United States.

U.S.-Mexico trade netted more than \$800 billion in 2023. In contrast, trade between Mexico and the European Union reached \$84 billion in the same year, according to the EU.

Gabriela Siner, director of economic analysis of the local financial group Banco Base, hailed the updated agreement with the E.U. as a step towards reducing the near "hegemonic power" the U.S. exerts over Mexican exports, given their strong trade ties.

"This is very positive for Mexico, because it needs to diversify its exports," said Siller, noting that 80% of Mexico's exports go to the U.S. "This gives the United States all the power to demand whatever they want - and along on togisfor."

Mexico's economy ministry has not commented on the updated agreement

Also on Friday, Mexico's Economy Secretary Marcelo Ebrard said on the social platform X that he was in Detroit meeting with representatives of the city's automotive sector in an effort to strengthen the bilateral relationship.

Rapper's shooting trial set to begin

A\$AP Rocky at a crossroads: A glorious future or prison?

LOS ANGELES, Jan 19, (AP): A\$AP Rocky is at a crossroads. He could soar to new heights of celebrity in 2025, or be brought back to earth quickly by a trial starting Tuesday that could led to his imprisonment for years.

The hip-hop star, and longtime partner to Rihanna, with whom he has two toddler sons, is set to touch the highest levels of high fashion as one of the celebrity chairs of the Met Gala in May along with Pharrell Williams, LeBron James and others.

And his modest acting career will get a major boost from starring alongside Denzel Washington in director Spike Lee's "Highest 2 Lowest," planned for a summer release.

But at the Los Angeles trial that's expected to last about three weeks, he is charged with two felony counts of assault with a semiautomatic firearm. He's accused of firing on a former friend on the streets near a Hollywood hotel in 2021. If convicted, he could get up to 24 years in prison.

The 36-year-old has pleaded not guilty, and his attorney says he committed no crime.

"We're ready to go. It's been a long time," defense lawyer Joe Tacopina said after a hearing Wednesday. "It's been something that's waiting over Rocky's head and Rihanna and their family's heads for a while. We're anxious to get this thing underway and get this behind him.'

The trial has its roots in high school in New York, when the Harlem-raised Rakim Mayers, now known as A\$AP Rocky, met Terell Ephron, also known as A\$AP Relli, who will be the trial's most important witness.

Ephron testified at a 2023 preliminary hearing that he brought Rocky into a crew of young creators who called themselves A\$AP - for "Always Strive and Prosper." 'We had dreams, pretty much," Ephron said.

He testified that the members remained close even as Rocky became rich and famous, but the relationships would

eventually erode.

The feud came to a head in Hollywood on the night of Nov. 6, 2021, when according to Ephron, Rocky fired at him three or four times, the shots grazing his knuckles.

Ephron went to the police two days later, and brought shell casings he had picked up himself - both points the defense will seize on.

"You need nothing more than Mr. Ephron's testimony by itself," Deputy District Attorney Paul Przelomiec, the case's lead prosecutor, told a judge at the 2023 hearing,

The trial is full of large personalities, along with two huge names that will loom over the proceedings despite having no direct role: President-elect Donald Trump and Rihanna.

The trial begins the day after the second inauguration of Trump, whom Tacopina represented in the defamation and sexual abuse lawsuit of writer E. Jean Carroll. And Rocky himself became an unlikely cause celebre for then-President Trump during his first term when Trump publicly declared he was trying to get the rapper freed and returned to the U.S. when he was jailed after a brawl in Sweden in 2019.

But Trump has no power over these proceedings, and

could not pardon Rocky if he's convicted.

Those anticipating the trial have long been asking whether

Rihanna may attend. "The mother of his children is she going to be here?" Superior Court Judge Mark Arnold asked the defense at an October hearing. "She's welcome to be here whenever she wants I'd just like to know."

Tacopina has been unable to give a definitive answer, but has said that he does not expect it.

"He's very protective of Rihanna and doesn't want her anywhere near this proceeding," he said after Wednesday's hearing. "But that's a family decision they'll make."

Tacopina said he has no intention of bringing Rihanna's name up at trial, but Arnold suggested he may when screen-

The judge, a former sheriff's deputy, has an affable but no-nonsense style and dispenses with many court formalities. He said he will keep the juror selection process simple, and a jury should be seated quickly.

In an uncommon move in LA County courts, he will allow cameras in court for nearly the entire trial.

"I believe that the public deserves to see what goes on in

Tacopina has also represented other hip-hop figures, including Meek Mill and YG. The lawyer who normally practices in New York is gregarious, quick with a joke and always happy to talk to the media, but can be ruthless in cross-examination.

When discussing Ephron's minor injuries at the 2023 hearing, he said, "It's a miracle he survived that shooting" and was admonished for his tone.

Deputy District Attorney John Lewin, best known for his successful murder prosecution of real estate scion Robert Durst, was a late addition to the prosecution team. He's also known for his aggressive cross-examination, including a re-

lentless, weeks-long questioning of Durst. The case against Rocky will largely depend on how credible the jurors find Ephron.

Police officers who searched the Hollywood sidewalk after a report of shots fired found no shell casings. Police recovered no fingerprints from the 9 mm casings Ephron brought them, and no 9 mm pistol was found when a search warrant was served on Rocky.

Surveillance video captured parts of the incident. Prosecutors at the 2023 hearing showed a video still with a man in a hooded sweatshirt whose face is not visible holding what appears to be a gun, along with another image showing the face of the man in the sweatshirt, with no gun visible. A detective testified that investigators established it was Rocky.

Tacopina said he has not decided whether Rocky will testify, which he is legally allowed to avoid.

"He is eager to tell his story, he would love the opportunity to do so," the lawyer said Wednesday. "He is very articulate and very intelligent, he's a good human being, that would come out if he testifies, but that decision has not been made yet. It depends on how the case goes.'

Bronx. Sharief Bodden, 29, was charged Friday in the killing of Peter Forrest, a 64-year-old Bronx resident, who under the stage name P. Fluid had been a frontman for 24/7 Spyz.

The Bronx band was part of a wave of Black-led rock groups, including Living Colour and Fishbone, that emerged in the 1980s, melding elements of heavy metal, funk, R&B, punk and other genres.

Among the band's signature songs was was a remake of Kool & the Gang's "Jungle Boogie." Forrest quit the band during its 1990 tour with Jane's Addiction, according to Rolling Stone.

Kuwait ranks average regionally in cancer prevalence

More than 90% of thyroid cancer cases can be cured

KUWAIT CITY, Jan 19: A member of the Board of Directors of the Cancer Aware Nation (CAN) and the official responsible for the annual head and neck cancer awareness campaign Dr. Iman Al-Shammari says Kuwait's rank among Gulf countries in terms of cancer prevalence is "average" due to increased public awareness and governmental and community initiatives focused on educating people about the disease.

In a press statement, Dr. Al-Shammari explained that thyroid cancer is the second most common cancer among women in Kuwait, after breast cancer, with an annual incidence ranging between 160 and 200 cases, compared to about 600 cases of breast cancer. Women are most susceptible to thyroid cancer after the age of 40. In men, thyroid cancer fluctuates between the ninth and tenth most

Dr. Al-Shammari said, "We began raising awareness about head and neck cancers around ten years ago due to the growing prevalence of these cancers in Kuwait and worldwide. It is important to note that head and neck cancers vary in severity, from aggressive to less aggressive forms. While thyroid cancer accounts for approximately 85 percent of head and neck cancers in both Kuwait and globally, it is one of the cancers that can be cured completely in more than 90 percent of

She affirmed the importance of raising public awareness about the early detection of thyroid cancer and the use of modern screening and treatment techniques.

Dr. Al-Shammari indicated that Kuwait may go for years without recording any deaths from thyroid cancer, which reflects its high curability and instills optimism and hope in the hearts of patients.

She shared the story of a patient who was diagnosed with thyroid cancer years ago while still a high school student. With treatment, she made a full recovery, got married, and continues to live a normal life.

Dr. Al-Shammari explained that the treatment for thyroid cancer is generally less intensive compared to other cancers. It typically involves surgery, radioactive iodine therapy, and hormonal therapy. Patients do not need chemotherapy or concentrated radiation, which are often more difficult to endure. This makes thyroid cancer treatment more manageable.

Regarding the stages of thyroid cancer treatment, Dr. Al-Shammari revealed that the treatment process typically begins with the removal of the thyroid gland, followed by treatment with radioactive iodine, and then continued lifelong treatment with radioactive iodine.

She said thyroid cancer is often linked to radiation exposure, particularly when individuals are exposed to radiation during childhood, because the effects of radiation exposure can take more than 20 years to manifest.

Dr. Al-Shammari went on to say that thyroid cancer detection relies on ultrasound examinations, which are available in all Kuwaiti hospitals, adding, "If a tumor is found, the treating physician will take a biopsy to determine the type of cancer and develop an appropriate treat-

On the subject of side effects, Dr. Al-Shammari said, "The most common early signs of thyroid cancer include persistent difficulty swallowing, voice changes (hoarseness), and swelling in the neck area.

Some types of head and neck cancers can affect children, though at very low rates. Annual cases in children sometimes do not exceed one, and there may be years without any cases being recorded. Thyroid cancer in children typically begins as lymphoma before progressing to thyroid cancer.'

New treatment shows promise for tough-to-treat high blood pressure

WASHINGTON, Jan 19, (AP): Nothing doctors prescribed controlled Michael Garrity's dangerously high blood pressure until they zapped away some nerves on

If that sounds weird, well, kidneys help regulate blood pressure in part through signals from certain nerves. The new treatment disrupts overactive renal nerves.

"My blood pressure would spike and I'd run out of breath and feel tired, and that doesn't happen anymore," said Garrity, 62, of Needham, Massachusetts. He still takes medicine but at lower doses, his blood pressure normal for the first time in years.


About half of U.S. adults have high blood pressure, a major risk for heart attacks, strokes, kidney failure, even dementia. Many people don't even realize they have hypertension until it's done serious

"Know your blood pressure, know the numbers," stressed Dr. Randy Zusman of Massachusetts General Hospital, who specializes in the hardest-to-treat cases and advises people who think they're fine to at least get a yearly check.

And only a fraction of patients have their hypertension well-controlled, meaning there's a need for novel strategies. The Food and Drug Administration approved that "renal denervation" option about a year ago, based on studies showing a modest benefit in patients whose blood pressure remains high despite multiple medicines.

Now, after the American Heart Association recently deemed it promising, some hospitals including Mass General Brigham are cautiously offering it as they work out who are good candidates - and whether their insurance will cover a minimally invasive procedure costing thousands of dol-

Two numbers describe blood pressure. The top, "systolic" pressure, is the force blood puts on the walls of arteries as its pumped out of the heart. The bottom "dia-

Normal is less than 120 over 80. Blood pressure naturally fluctuates throughout the day, higher when you're physically active or stressed. But when it stays high - consistently 130 over 80 or higher, according to the most recent guidelines - it stiffens arteries and makes the heart work harder.

It doesn't take a doctor's visit. Pharmacies and sometimes even libraries offer screening, and people can use at-home

To avoid falsely high readings, the American Medical Association has tips: Sit quietly with feet on the floor, legs not crossed. Place the cuff on a bare arm, not over clothing. Don't dangle the arm - rest it on a table.

Lifestyle changes are the first step, especially for otherwise healthy people. Guidelines urge losing weight, exercise, eating more fruits and vegetables, limiting salt and alcohol, and taking steps to handle

New finding uncovers Huntington's cause

NEW YORK, Jan 19, (AP): Scientists are unraveling the mystery of what triggers Huntington's disease, a devastating and fatal hereditary disorder that strikes in the prime of life, causing nerve cells in parts of the brain to break down and die.

The genetic mutation linked to Huntington's has long been known, but scientists haven't understood how people could have the mutation from birth, but not develop

"The conundrum in our field has been: Why do you have a genetic disorder that manifests later in life if the gene is present at conception?" said Dr. Mark Mehler, who directs the Institute for Brain Disorders and Neural Regeneration at the Albert Einstein College of Medicine and was not involved in the research. He called the research a "landmark" study and said "it addresses a

gait, personality changes and impaired judgment - typically begin between the ages of 30 and 50, gradually worsening over 10 to 25 years.

Scientists at the Broad Institute of MIT and Harvard, McLean Hospital in Massachusetts and Harvard Medical School studied brain tissue donated by 53 people with Huntington's and 50 without it, analyzing half a million cells.

They focused on the Huntington's mutation, which involves a stretch of DNA in a particular gene where a three-letter sequence - CAG - is repeated at least 40 times. In people without the disease this sequence is repeated just 15 to 35 times.

If India qualifies for the semifinals or final, both matches will also be in Dubai. If India doesn't qualify for the final, it will be staged in Lahore on March 9.

Lie McGrath leads Norway sweep in World Cup slalom

WENGEN, Switzerland, Jan 19, (AP): Atle Lie McGrath protected his firstrun lead and completed a Norwegian sweep of the podium in a World Cup slalom on Sunday.

McGrath celebrated victory just as he did posting the fastest time in the morning run - kicking up his right ski to flip it end over end and catching it, in the style of Swiss former downhill star Didier Cuche to delight fans in the finish area.

The United States-born Norwegian finished 0.18 seconds ahead of Timon Haugan, who was 10th-fastest in the first run. Henrik Kristoffersen was 0.29 back in third and extended his lead in the season-long slalom standings.

While Switzerland has been the strongest men's team across the World Cup disciplines this season, Norway is a solid second now with five race wins by five different skiers. Haugan and Kristoffersen also each won a slalom and joined McGrath for hugs after he

Switzerland is still searching for a first slalom win at Wengen since 1987, though had Tanguy Nef, Loic Meillard and Daniel Yule finishing fourth, fifth and sixth.

McGrath, whose father Felix raced for the U.S. team at the 1988 Calgary Olympics, had described Cuche after his morning run as "one of my he-

"He told me in Kitzbühel last year that if I taught his son how to ski slalom he would teach me the Cuche Flip because I'm so bad at it," said the 24-year-old McGrath, who did it expertly twice Sunday.

McGrath further explained his emotions because he failed to finish the past two slaloms, including at nearby Adelboden last Sunday, following three straight podium finishes.

"The last two weeks I have been challenging and feeling like I'm the best slalom skier in the world and not getting results. I felt today it had to

happen," he said. McGrath said he heard the racecourse commentary while standing in the start gate and knew his teammates led the race, so "there was no other choice" but to complete the sweep.

Kuwait bids farewell to Handball World Championship

Tunisia edges Algeria

ZAGREB, Jan 19: Kuwait bids farewell to the 29th edition of the 2025 Handball World Championship, which is being held in Croatia, Denmark, and Norway and will conclude on February 2nd. The team suffered its third consecutive loss in the preliminary round of Group 3, losing to Qatar 22-25.

The "Blues" had previously lost their first two group matches—against Austria 26-37 and France 19-43—leaving them in last place in Group 3. With this result, Kuwait has been eliminated from the race for a qualification spot in the main round. The team will now focus on improving its world ranking through the remaining matches.

Despite the loss, the Kuwaiti team showed resilience throughout the match, with the goal difference and performance levels remaining close. The first half ended with Qatar leading 11-7.

The tournament, which spans across three host countries—Croatia, Norway, and Denmark—has seen Kuwait struggle in the competition. The team suffered heavy losses against Austria (37-26) and France (43-19), the 2024 European champion and second-place finisher in the previous World Cup edition. In other Group C action, France triumphed 35-27.

Meanwhile, in another Arab match, Tunisia claimed a narrow 26-25 victory over Algeria in Group B. Tunisia secured its first win in the tournament, after two previous defeats.. In Group B, Denmark defeated Italy with a dominant 39-20 shoreline.

In Group F, Spain triumphed over Japan 39-20, while Sweden defeated Chile 42-30.

Group G saw Slovenia beat Cape Verde 36-24, and Iceland dominated Cuba with a 40-19 victory.

West Indies bowled out for 123 runs

MULTAN, Pakistan, Jan 19, (AP): Offspinner Sajid Khan masterminded Pakistan's emphatic 127-run win against the West Indies with a match haul of nine wickets in the first test on Sunday. Khan followed his four-wicket haul

in the first innings with 5-50 as the West Indies were bowled out for 123 runs in the second after being set a target of 251 runs on a spinning pitch.

Alick Athanaze, playing in only his 12th test match, made a fighting 55 off 68 balls before he became Khan's fifth victim with inexperienced West Indies resistance folding in the second session on Day 3.

"As long as we get 20 wickets and are able to put in a good performance, we will be happy," Pakistan captain Shan Masood said. "We did not know whether in these conditions the ball would spin as it is cold ... but our spinners were clinical.

Khan replicated his first-innings show with the new ball by yet again removing the top four batters as the tourists limped to 54-5 inside the first session that saw 11 of the 12 wickets falling to the spinners.

Leg-spinner Abrar Ahmed, who shared the new ball with Khan, claimed figures of 4-27 that included the wickets of Kevin Sinclair (10) and Gudakesh Motie (0) off successive balls with both edging to Salman Ali Agha in the slips as the tourists lost their last four

wickets without scoring a run.

"The batters didn't play as well as they should have," West Indies captain Kraigg Brathwaite said. "We just have to be brave ... it is important to be positive on these types of pitches. We should still trust our defence. If we can bring it together batting and bowling wise, we can come out on top.'

In a sensational 2-1/2 hour first session, left-arm spinner Jomel Warrican had grabbed a career-best 7-32 as Pakistan batters also struggled on their own engineered wicket for spinners. Warrican featured in all but one dismissal in Pakistan's second innings as the home team was bowled out for 157 runs inside 1-1/2 hours after resuming

It gave Pakistan an overall lead of 250 runs after West Indies conceded a 93-run first innings lead when it was dismissed for 137 inside one session on Day 2 in reply to Pakistan's score of 230.

Khan removed Brathwaite (12), Mikyle Louis (13), Keacy Carty (6) and Kavem Hodge (0) for the second successive time in the match as the tourists' ploy to counterattack the offspinner failed with slow bowlers getting purchase off the sluggish surface.

The team is playing together and it is great," Khan said. "The wicket had a lot of turn and bounce. The spin bowling coach spoke to me and in the second innings, I bowled a little slower and did not leak too many runs."

Brathwaite holed out at deep midwicket while going for an overly ambitious shot; Carty lobbed an easy catch behind the wicket while attempting a sweep, while Hodge and Louis were bowled by Khan's sharp-turning de-

Athanaze delayed the inevitable by sharing a 41-run stand with debutant Tevin Imlach (14) and completed his half century with a cover driven boundary before Ahmed hurried the collapse to finish off the West Indies resistance.

Coco drops a set but reaches Australian Open quarterfinals

Next chapter in Alcaraz, Djokovic rivalry unfolds at Australian Open

MELBOURNE, Australia, Jan 19, (AP): It's time for the eighth installment of the riveting, intergenerational rivalry between Novak Djokovic

and Carlos Alcaraz This one, though, will be the first at the Australian Open - and the first in the quarterfinals of a tournament; each of the others came in either a semifinal or final. The other quarterfinal on the bottom half of the men's bracket will be No. 2 AlexanderZverev against No. 12 Tommy

Alcaraz reached his 10th career Grand Slam quarterfinal, tied for the most by a man before his 22nd birthday, by advancing when 15th-seeded Jack Draper stopped playing because of a hip injury after dropping the first two sets Sunday

Djokovic, who is being coached in Melbourne by old rival Andy Murray, did his part at night in Rod Laver Arena, needing to work a little longer but getting through just the same with a 6-3, 6-4, 7-6 (4) victory over No. 24 Jiri Lehecka. Djokovic smacked a ball off a wall in the third

set, drawing boos and whistles from some spectators. When they made more noise moments later, chair umpire Mohamed Lahyani admonished the folks in the stands to be more polite toward the

Otherwise, though, Djokovic had plenty of

support, from the Serbian flags in the stands to the chants of his nickname, There is plenty at stake at this tournament for both No. 3 seed Alcaraz, who is 21, and No. 7 Djokovic, who is 37.

Alcaraz seeks to become the youngest man

to complete a career Grand Slam with at least one trophy from all four of the most prestigious events in tennis. His four so far came elsewhere: two at Wimbledon by virtue of wins over Djokovic in the 2023 and 2024 finals, and one apiece at the U.S. Open in 2022 and the French Open last year. At the majors, though, Alcaraz leads 2-1.

On Sunday, Alcaraz was ahead 7-5, 6-1 when Draper decided he couldn't continue. He'd been dealing with physical issues after winning each of his first three matches at Melbourne Park in

Coco Gauff's consecutive-set streak ended at the Australian Open. Her bid for a second Grand Slam title continued on Sunday with a 5-7, 6-2, 6-1 comeback victory over Belinda Bencic in the fourth round. Gauff now faces No. 11 Paula Badosa in the quarterfinals on Tuesday. Badosa defeated Olga Danilovic 6-1, 7-6 (2) to get to the final eight in Melbourne for the first time

The winner of Gauff vs. Badosa will play either No. 1 Aryna Sabalenka, who is seeking a third consecutive Australian Open title, or No. 27 Anastasia Pavlyuchenkova, the 2021 French

Sabalenka stretched her winning streak in Melbourne to 18 matches by defeating 14th-seeded Mirra Andreeva 6-1, 6-2, and Pavlyuchenkova beat No. 18 Donna Vekic 7-6 (0), 6-0.

Atletico's win streak ends

Barcelona held again at Getafe

BARCELONA, Spain, Jan 19, (AP): Barcelona was bested by Getafe's de-fense again in a 1-1 draw in La Liga on Saturday, while Atletico Madrid's club record winning streak ended after a late penalty miss by Antoine Griez-

Barcelona got its first goal in five visits to Getafe thanks to Jules Koundé in the 10th minute, but Getafe equalized and clamped down to get a fourth consecutive draw at its stadium against the powerhouse. bThe last time Barcelona won at Coliseum Stadium was in 2019, making the fixture an annual quagmire for the Catalan club.

Barcelona was coming off huge wins: A 5-2 thrashing of Madrid in the Spanish Super Cup final and a 5-1 win over Real Betis in the Copa del Rey. Barcelona visits Benfica in the Champions League on Tuesday.

But José Bordalás's Getafe, with its physical, defensive style, once again frustrated Barcelona in Hansi Flick's first visit as its coach.

Koundé put Barcelona ahead when Pedri threaded a pass to meet the right back's move into the area. Goalkeeper David Soría blocked his first effort but Koundé scrambled the rebound out of

Soría's grasp and over the line. Moments after Raphinha headed a cross by Koundé into the side netting, Getafe leveled in the 34th during a de-

fensive letdown by the visitors. Mauro

Arambarri put in a loose ball after Iña-

ki Peña did well to make a one-handed save of a volley by Coba de Costa. Griezmann had a chance to at least

snatch a point for Athletico after a video review awarded a 90th-minute penalty for a handball by defender Sergio González. But the French forward stroked his spot kick wide. Griezmann and Julián Alvarez hit

the woodwork in the first half, but Athletico couldn't respond after Leganes defender Matija Nastasic scored with a 49th-minute header.

Last week, Atletico broke its own record of 13 consecutive victories from 2012-13.

Leganes returned to the first division this season and has become a giant-slayer in the top-flight. The modest club from Madrid stunned Barcelona when it was leader in December. Its win over Atletico lifted it into 15th

Atletico, which was the biggest spender for Spanish clubs in the summer, is trying to win its third league under Simeone after titles in 2014 and 2021. Simeone said that during those championship runs, his side lost to smaller clubs Almeria (in 2014) and Levante (in 2021), and that didn't stop it from still beating Barcelona and Madrid to the title.

Atletico defenders Javi Galán and Clement Lenglet received their fifth yellow cards of the season and will miss the next round against Villarreal.
