



Al-Jarallah highlights media challenges

Amir receives UAE Accountability Authority chief

KUWAIT CITY, Jan 26: Dean of Kuwaiti Journalism and Editor-in-Chief of Al-Seyassah and Arab Times newspapers Ahmad Al-Jarallah expressed his concerns about the state of media in the country, highlighting the challenges posed by outdated media laws and the lack of government support.

Al-Jarallah made the statement at a press conference Sunday; during which he pointed out that while media outlets used to receive some form of government support, they are now left to navigate a complex legal landscape on their own. He touched on the financial burdens of newspapers, indicating that they do not receive State funding and often incur annual expenses exceeding KD1 million.

He also called for action against fake accounts, which have proliferated and are causing harm to individuals.

Info minister praises Kuwaiti media as regional leader

'New media regulation law nears completion'

KUWAIT CITY, Jan 26: Minister of Information and Culture and Minister of State for Youth Affairs Abdulrahman Badah Al-Mutairi says the media regulation law will see the light soon and will play a major role in promoting responsible freedom of expression. Acts of aggression against the divine entity, prophets, and the sovereign will be the only transgressions subject to penalty.

Al-Mutairi said this during a press conference held yesterday morning at the General Secretariat of the Council of Ministers in Shaab to announce the launch of the activities of Kuwait as the Capital of Arab Culture and Media, and in response to remarks from the Dean of Kuwaiti Journalism and Editor-in-Chief of Arab Times and Al-Seyassah newspapers Ahmed Al-Jarallah, who was present at the event.

Al-Mutairi praised Kuwaiti media, describing it as a leading force in the Gulf and Arab media arena.

He highlighted the contributions of the pioneering figures in Kuwait who shaped the nation's media legacy, which is rooted in art, freedom, and culture, with its influence reaching far beyond regional borders.

Al-Mutairi explained that Kuwait is proud to be chosen as the Arab Capital of Culture and Media for 2025, an honor granted annually by the Arab League Educational, Cultural, and Scientific Organization and the Council of Arab Information Ministers in appreciation of the contributions countries make to culture and media both regionally and internationally.

The title of Arab Capital of Culture is awarded to the city that showcases its role in promoting culture, arts, and literature, and also reflects Arab heritage through cultural programs held throughout the year. It is also granted to the city that plays a major role in developing the Arab media scene, enhancing media diversity, and supporting the modern media infrastructure.

Kuwait's selection for this title represents recognition of its leadership in both culture and media, and affirms its commitment to advancing cultural and media content that reflects its national identity and rich cultural heritage.

PACI 'removes' 554 addresses

KUWAIT CITY, Jan 26: The Public Authority for Civil Information (PACI) announced that it has re-moved the residential addresses of 554 individuals from its records, reports Al-Seyassah daily.

The decision was based on building demolitions or declarations from property owners.

PACI emphasized that affected individuals must visit its office to register their new addresses within 30 days, providing the necessary supporting documents.

MAYS AL-JABAL, Lebanon: Israeli forces in southern Lebanon on Sunday opened fire on protesters demanding their withdrawal in line with a ceasefire agreement, killing at least 15 and injuring more than 80, Leba-nese health officials reported.

The dead included two women and a Lebanese army soldier, the Health Ministry said in a statement. (AP)

Social aid restored to 485 women **following Kuwait Amir directives**

KUWAIT CITY, Jan 26: Confirming details published in Al-Seyassah daily, Acting Undersecretary of the Ministry of Social Affairs, Dr. Khaled Al-Ajmi, announced the resumption of social aid disbursement to 485 women, including widowed wives of Kuwaiti citizens and divorcees whose nationalities were revoked under "Article 8.

The move comes in response to the directives of His Highness the Amir Sheikh Mishaal Al-Ahmad to ensure a dignified life for this category, as instructed by the Council of Ministers.

Dr. Al-Ajmi revealed that the total amount transferred to beneficiaries' bank accounts was 413,718.336 Kuwaiti dinars, covering 485 eligible cases

He commended the Family Care Department for its efficiency in expediting the disbursement process, which eased the burden on beneficiaries and contrib-

uted to their stability. The Ministry of Interior announced this was done during the first 14 working days in coordination with relevant authorities.

Additionally, the Public Authority for Civil Information announced the activation of the "My Identity" application starting January 12, 2025, specifically for individuals whose nationalities were withdrawn.

Employees were stationed in Hall No. (2) at the Authority's headquarters to assist those facing difficulties in activating the app or updating required data, such as personal photos or passport copies.

In emergency cases, the office successfully processed seven instances and facilitated travel procedures with ease

The office also demonstrated effective outreach, responding to approximately 150 calls daily, while 2,429 forms were registered via a link shared through WhatsApp.

Bust yields cash, ammo, narcotics

KUWAIT CITY, Jan 26, (KUNA): The Ministry of Interior said Saturday that 21 culprits in 17 psychotropic drug charges have been arrested and referred to investigators.

During the 21 arrests, members of the General Administration for Drug managed to seize 6.213 kg of hashish, 8.16 kg of marijuana, and 3.11 kg of 'shabu' (methamphetamine), according to a statement from

the Ministry's General Directorate of Security Relations and Media.

The psychotropic seizures also include 153 gm of cocaine, 550 gm of 'chemical,' 10 gm of heroin, 100 gm of psilocybin (magic mushrooms), 20 mg of marijuana oil (THC), 12,042 Lyrica capsules, 400 Captagon tablets, and 147 other psychotropic tablets.

They also include nine bullets and cash amounting to KD 20,825 (USD 67,550) in revenue of the drug trade, the statement added

KUWAIT CITY, Jan 26: The revenues of the Kuwaiti-Omani Duqm **Refinery from its operations over the** past year are expected to range from \$4.5 to \$5 billion, especially since its 2023 revenues exceeded \$2 billion, say sources from the Omani oil sector.

Sources revealed the management of the refinery intends to increase its production capacity by 15 percent during 2026, explaining that it was possible to increase production by about 10 percent last year, but the Kuwaiti-Omani management decided to take it slow, especially since the refinery was at the beginning of its operations and international organizations always advise against increasing the production capacity of refineries in their first operational year.

Sources said the Duqm Refinery Administration will re-experiment with the Omani Sohar Refinery, which was completed in 2007, with a refining capacity of 116,000 barrels per day. "In recent years, its refining capacity increased to 198,000 barrels after spending more than \$2.5 billion to increase its daily refining capacity," sources added.

15% increase in production eyed by 2026

Sources pointed out that the entry of the Duqm Refinery, which has a refining capacity of 230,000 barrels per day of Kuwaiti and Omani crude, into the production line of Omani refineries has contributed to raising the refining capacity in the Sultanate to 534,000 barrels per day; considering that the refining capacity of Mina Al-Fahal Refinery is 106,000 barrels per day and that of Sohar Refinery is about 198,000 barrels per day

Sources confirmed that Duqm Refinery sales were tremendously active during the past year, considering many countries rushed to buy its products due to its strategic location -- overlooking the southeastern coast of Oman, as this unique location makes it overlook the most important international shipping lines in the Indian Ocean and the Arabian Sea.

Sources stated: The fact that this location is far from geopolitical tensions in other international shipping routes, which witnessed tension in the past year indicates that among the reasons for the rush to buy Duqm products is that these products are compatible with global environmental requirements like jet fuel, liquefied petroleum gas and diesel.

Sources affirmed that Dugm Refinery will remain the largest joint strategic project between Kuwait and Oman, and it is the largest Gulf project among joint Gulf investments.

Sources added the Duqm Refinery recently won Best Company Award in the refining sector for the year 2024 within the awards of the International Finance Organization; while Chief Executive Officer (CEO) David Baird won the Best CEO Award in the refining sector for the year 2024.

At the same time, sources indicated that Kuwait Petroleum International Company and the Omani OQ Company are currently preparing to celebrate the anniversary of the official operation of the joint Duqm Refinery, which took place on Feb 7, 2024.

Sources said OQ Company benefited from the experience of the Kuwaiti side in the excellence, development and leadership of the joint Duqm Refinery; adding that a delegation from the leaders of the Duqm Refinery in Oman recently visited the Mina Abdullah Refinery to exchange experience and ideas in the interest of the joint cooperation between Oman and Kuwait in the refinery sector, as well as strengthening relations between Kuwait National Petroleum Company and Duqm Refinery Company.

KUWAIT CITY, Jan 26: The Ministry of Health has officially launched the annual employee evaluation process, integrating it with the activation of a smart fingerprint application to improve administrative efficiency and modernize the working system, reports Al-Seyassah daily.

Abdul Rahman Al-Fares, the Assistant Undersecretary for Administrative Affairs, urged all employees to promptly activate the application to ensure their inclusion in the annual evaluation.

This initiative is part of the Ministry's broader strategy for digital transformation and the modernization of its administrative systems in line with international best practices.

In a significant update, the Ministry confirmed that fingerprint and facial recognition devices will be phased out within the next week, with the smart fingerprint system taking full responsibility for documenting attendance and departure.

This move reflects the Ministry's commitment to improving operational processes and enhancing efficiency.

Work on port project gains momentum after gov't nod

KUWAIT CITY, Jan 26: Following the Cabinet's approval last Tuesday of the Chinese State Construction and Transportation Corporation Limited to implement, manage and operate the Mubarak Al-Kabeer Port ambitious project, work has gained significant momentum.

The Ministry of Public Works received 'conditional approval' from the Audit Bureau last Thursday to enter a direct contract worth 3.1 million dinars for the study, design and preimplementation services necessary for the project.

Power outages in 26 areas

The Ministry has stated that the maintenance is essential to enhance the reliability and performance of the electrical infrastructure. Residents and businesses in the affected areas are encouraged to take necessary precautions to minimize inconvenience during the outages.

New project ... vague goals?

Saffairs, which would have preferred to be called Religious Affairs (this reflects the reality of its role), stated that a 'development' project had been included to boost the country's economy, due to the decline in the country's resources as a result

of fluctuating oil prices, by converting mosques to become environmentally friendly, within ten years!!

The project

is set to cost 33 million dinars, and its implementa-

tion will lead

to significant reductions: a 40 percent decrease in electricity consumption, a similar 40 percent reduction in water usage, and a 50 percent decrease in maintenance costs.

Environmentally, the project will deliver substantial benefits, cutting carbon emissions by 5,478,600 kilograms (per every 100 mosques), improving air quality, reducing waste, and increasing recycling opportunities.

Additionally, it will recycle gray water to help green the areas surrounding the mosque buildings, which covers approximately one hectare.

The project will also generate financial savings, amounting to 5 million and 235 thousand dinars in electricity and water costs across all mosques, while reducing annual carbon emissions by about 93,136 kilograms.

A key outcome of the project will be the creation of job opportunities for local and national talent in the field of sustainable buildings, with local companies benefiting as well.

This will not only enhance employment prospects but also drive economic returns, contributing positively to the country's investment climate (God is Great).

We appreciate the Ministry of Is-

lamic Affairs for its detailed presentation of the project's advantages and accurate figures.

However, the citizen has the right to express some reservations, as many of the ministry's previous projects, which have cost the state hundreds of millions of dinars, have resulted in little to no tangible outcomes, such as the moderation of the Holy Quran and other initiatives.

It can be reasonably argued that the impressive numbers provided above might have been derived from a 'make-up hectare' study -- designed to satisfy the needs of government decision-makers and often created by well-known research offices with a vested interest, tailored to meet the ministry's requirements.

If the ministry officials truly believe in the integrity and significance of the study, it would be beneficial for them to publish it on the ministry's website for public scrutiny.

Many senior specialists and stakeholders involved with the ministry harbor genuine doubts about the study's credibility, as it seems based on assumptions that are far from realistic.

The Ministry of Islamic Affairs is aware that the cost of this project could be halved if cooperative societies were invited to contribute to implementing the study's recommendations, in line with their role in community service.

Alternatively, allowing companies and individuals to sponsor one or more mosques could help offset costs

Unfortunately, such proposals are often not in the 'interest' of many ministry officials, which raises concerns about the project's long-term value and the broader commitment to financial efficiency.

Shine or decline ... Trump leading America into uncharted waters

"IN MY opinion, the election of Donald Trump to a second term could mark a significant turning point in America's role on the world stage, as Susan Thornton, a former US diplomat, suggests," columnist Dr Abdullah Sahar wrote for Al-Rai

daily. "The shift could be more drastic than many expect, accelerating the decline of American hegemony. Unlike past empires that crumbled slowly over time, Thornton argues

"I believe this aligns with Trump's broader intentions: a shift away from the liberal trade system established in 1947. His protectionist policies, such as imposing steep tariffs on Chinese, Canadian and Mexican exports and taxing US companies that outsource production, could challenge the core principles of global free trade.

"His stance on punishing countries that circumvent the dollar further exemplifies his confrontational approach to global trade dynamics.

"Moreover, Trump's preference for bilateral agreements over multilateral ones further isolates the US from traditional alliances.

"His tactics, which favor shortterm gains over long-term strategy, suggest a volatile foreign policy. In the Middle East, his relationships with the Zionist elite and his openness to negotiating with Iran reflect the complexity and unpredictability of his approach.

"Trump's presidency is emblematic of an 'exceptional president,' one who could either rejuvenate the US to reclaim its dominance or lead it into a period of severe decline and internal division. Historical examples of such exceptional leaders -ike Napoleon Bonaparte and Adolf of the Kuwaiti people toward their workers. In this story, Mr. Saeed shares:

2 Kuwaitis accused of peddling and consuming drugs acquitted

Media person fined KD50,000 for inciting sedition

KUWAIT CITY, Jan 26: The Criminal Court, presided over by Counselor Mohammad Al-Sanea, acquitted two Kuwaiti citizens accused of trafficking and consuming hashish.

The court found that the arrest and search warrant issued by the Public Prosecution was invalid due to lack of serious investigations. The case involved allegations that the ac-

cused were in possession of narcotics for the purpose of trade and use.

Following secret investigations, the antinarcotics officers executed a search and arrest operation on February 14.

The evidence, including narcotics and psychotropic substances, was reportedly seized from their residences in Abu Fatira, Egaila and Hawalli.

Lawyer Ali Haider, representing the accused, argued that the arrest and search procedures were invalid because they were not supported by serious investigations, as required by Court of Cassation precedents. The court agreed, ruling that the invalid warrant rendered all evidence obtained inadmissible.

The ruling underscores the critical legal standard that investigations must meet to ensure the validity of warrants and subsequent legal actions.

Media personality fined: The Criminal Court has imposed a fine of 50,000 Kuwaiti dinars on media personality Aisha Al-Rasheed for inciting sedition and insulting Shiite citizens via her video clips during the holy month of Muharram.

Following her indictment for violating the National Unity Law and insulting a segment of society via her YouTube channel, the Public Prosecution had released Al-Rasheed on 500 dinars bail

This case underscores Kuwait's commitment to preserving national unity and holding individuals accountable for content that threatens social harmony.

Kuwaitis in traffic brawl

Two young men perish as car skids, collides with lamppost

KUWAIT CITY, Jan 26: A tragic accident in the Saad Al-Abdullah area claimed the lives of two young men after their vehicle skidded and collided with a lamppost, reports Al-Rai daily

Emergency services, including police patrols and ambulances, responded promptly to the scene following a report of the incident. Upon arrival, paramedics confirmed that both individuals in the vehicle had succumbed to their injuries.

Authorities have registered the case as a collision resulting in fatalities. The bodies of the victims were transferred to the forensic medicine department after receiving the necessary directives from the investigator on-site.

Further investigations are ongoing to determine the circumstances surrounding the accident.

Weekly GTD statistics: The weekly report of the Rescue Police, covering Jan 12 to Jan 18, show 10,127 traffic violations were issued and 15 vehicles were impounded, reports Al-Anba daily.

This is in addition to officers dealing with 198 traffic accidents.

During the campaigns conducted by the Rescue Police, 172 individuals were arrested, including 95 expatriates reported absconding and wanted in connected with theft and 38 individuals for not holding identification documents.

Furthermore, 39 expatriates of various nationalities were arrested for violating the residency laws and were handed over to the General Directorate of Residency Affairs Investigation.

The operations also led to the seizure of 43 vehicles wanted for legal issues.

Kuwaitis in traffic brawl: A Kuwaiti citizen, born in 1962, has filed a complaint at the Shamiya Police Station, accusing a compatriot of assaulting him over a dispute, reports Al-Anba daily.

The complainant stated that the accused grabbed him by his collar during the altercation, which occurred inside the premises of a well-known company.

He mentioned that the company's surveillance cameras may have captured the incident. A case has been filed.

In a separate incident, a traffic dispute escalated into a physical altercation between two Kuwaiti citizens.

According to a security source, a citizen born in 1987 accused another, born in 1988, of assaulting him following a traffic disagreement in the suburb of Hawalli.

Both parties were referred to the competent authorities after completing the investigation.

Kuwaiti hurt in accident: A collision and subsequent rollover of a vehicle on Subbiya Road Saturday evening resulted in injury to a Kuwaiti citizen who is believed to be in his forties, reports Al-Anba daily

The daily said the man rushed to the Jahra Hospital and admitted to the intensive care unit.

The daily added, after the Operations Department of the Ministry of Interior received a report emergency medical services personnel promptly rushed to the site of the mishap.



Hashish and drug related items found in possession of Kuwaiti citizen

Kuwaiti held for carrying drug-laced cigarette, hash

KUWAIT CITY, Jan 26: Authorities have referred a 32-year-old citizen to the General Department for Drug Control after discovering a cigarette infused with a narcotic substance, a piece of hashish, drug paraphernalia, and rolling papers in his possession, reports Al-Anba daily.

According to a security source, a patrol unit conducting routine rounds in the Ahmadi area grew suspicious of a driver displaying erratic behavior. The individual was stopped, and officers confirmed that he was under the influence of narcotics. A precautionary search of his vehicle led to the discovery of the aforementioned items.

The case has been handed over to the appropriate authorities for further investigation.

Abused on phone: The investigator at the Faiha Police Station is looking for an unknown person who is said to have verbally abused and threatened to cause harm to a Kuwaiti citizen, reports Al-Anba daily.

The complainant, born in 1985, reported receiving a WhatsApp call from an unknown number while he was in the parking lot of his residence in the Al-Nuzha area last Thursday.

The citizen told police he does not know the caller.



Heritage Village back on agenda

PPP law may unlock project

KUWAIT CITY, Jan 26: The Heritage Village project. which has been delayed for years, is once again a point of discussion at the Municipal Council's upcoming regular session.

Dr. Hassan Kamal, a council member, raised the issue of the delay and the municipality has provided a detailed response.

According to their statement, the project was initially awarded to 'International Investor' company following a decision by the committee in

charge of executing the Municipal Council's powers.

The original contract was signed in November 2004 between the Ministry of Finance, the Heritage Village Company and the International Investor Company.

An annex to the contract was signed by the Ministry of Finance and the Heritage Village Company in December 2014. However, in 2019, the Ministry of Finance took steps to vacate the project investor administratively.

The project then took another turn in August 2023, when the Cabinet issued Resolution No. (826), directing the Ministry of Finance to work with the Ministry of Public Works, the Municipality and other relevant parties to continue the necessary construction and technical work for the development of Abdullah Al-Ahmad Street and the Heritage Village. The goal is to preserve the surrounding heritage buildings while moving forward with the project.

In February 2024, the Ministry of Finance informed the Municipality that it had received the project on September 20, 2023 and expressed its intent to offer it through a bidding process.

To ensure legal compliance, the Ministry requested information from the Public-Private Partnership Projects Authority (PPP) regarding the application of Law No. (116) of 2014, which governs publicprivate sector partnerships.

On May 6, 2024, the PPP Authority confirmed that the Heritage Village project falls under the scope of this law, which doesn't preclude it from being offered under other applicable systems.

The Municipality also highlighted the ongoing coordination with the Central Bank and the Ministry of Interior to address any requirements for completing the project through private sector involvement. Multiple meetings have been held on this matter, with the latest in October 2024.

The municipality will submit a tech-nical report to the Municipal Council to request the allocation of the project, enabling it to proceed with further steps in coordination with relevant government bodies.

This update underscores the ongoing complexity of the Heritage Village project, which has faced several administrative and procedural hurdles. It will be interesting to see how the Municipal Council addresses these concerns and if the project will finally move forward with the involvement of the private sector.



caused by this aggression, which disrupted the balance within society, corruption took root in its ugliest forms, and some constitutional institutions were severely damaged.

As a result, we witnessed the ma-jority of MPs of the successive terms of the National Assembly being more focused on their personal interests, regardless of whether they are in the best interests of Kuwait and its people. These MPs justified their actions under the guise of freedom and democracy, as if Kuwait is the only democratic country in the world.

Under this pretext, laws were created to benefit certain MPs or specific groups of people, often at the expense of the vast majority of the people. Many opposed these laws, but their voices were too faint to be heard. Meanwhile, a group worked tirelessly to defend these legislations, which only served to entrench corruption.

Furthermore, since 1962, Kuwait has seen around 47 successive governments, with the ministerial position proving to be unstable. Some ministers held their positions for no more than seven or eight hours, while others left within a month or two. This instability was often due to fears of grilling motions or the lack of competence among some ministers to take up political-executive roles, which require both astuteness and integrity. For some, the title of "former minister" seemed to be the only objective of holding the position.

Ministerial stability is essential in every country, even in long-established democracies, as countries prioritize ensuring that ministers serve a fixed term, free from political and parliamentary blackmail.

This flawed path continued to harm institutions, solidify corruption, and became a norm until the arrival of a new era. This shift has led both the people and the region to recognize that Kuwait now has an efficient leader with a clear vision and who prioritizes the country's interests above all else.

Everyone is reminded of the saying of Caliph Othman ibn Affan (May God be pleased with him): "God deters by power whoever is not deterred by the teachings of the Quran."

The reform process began in response to the people's demands concerning the developments which have already started showing positive results, and in other areas being actively worked on for improvement.

It is important to emphasize that true reform begins with updating outdated laws. As we have mentioned before, there are 900 laws that need to be upgraded, with some requiring complete annulment. The majority, however, should be amended for the better, especially those related to services and pringing about more openness.

It is true that Kuwaitis have embraced the vision of the new era, whether in terms of renewing the national identity or working to restore Kuwait's leadership position.

However, we must highlight that achieving these goals requires accelerating openness, even though we should expect some challenges along the way. Let these challenges serve as motivation for development, not as a reason for Kuwait to revert to a path of decline. The leadership of the new era is listening well, constantly evaluating progress, and reviewing all developments in a way that avoids any negative consequences.

Indeed, Kuwait must return to a position of leadership, as it possesses all the capabilities needed to achieve this goal. The country is not lacking in wealth, intelligence, or initiative. What Kuwait needs most is to streamline processes to fulfill the ambitions of the new era, which is the same ambition of the Kuwaiti people

'Federal oversight laws violated'

Trump fires 17 independent inspectors general at government agencies

WASHINGTON, Jan 26, (AP): The Trump administration has fired about 17 independent inspectors general at government agencies, a sweeping action to remove oversight of his new administration that some members of Congress are suggesting violated federal oversight laws.

The dismissals began Friday night and were effective immediately, according to two people familiar with the actions. They spoke on condition of anonymity to provide details that have not been made public. Neither confirmed the exact number of firings, but an email sent by one of the fired inspectors general said "roughly 17" inspectors general had been removed.

Trump confirmed the move in a conversation with reporters aboard Air Force One on Saturday, claiming, "it's a very common thing to do." He said he would "put good people in there that will be very good.

Congress was not given the legally required 30-day notices about the removals - something that even a top Republican is decrying.

"There may be good reason the IGs

were fired. We need to know that if so," Sen Chuck Grassley, chair of the Senate Judiciary Committee, said in a statement. "I'd like further explanation from President Trump. Regardless, the 30 day detailed notice of removal that the law demands was not provided to Congress," said Grassley, R-Iowa.

The role of the modern-day inspector general dates to post-Watergate Washington, when Congress installed offices inside agencies as an independent check against mismanagement and abuse of power. Though inspectors general are presidential appointees, some serve presidents of both parties. All are expected to be nonpartisan.

Sen. Lindsey Graham, R-S.C., acknowledged that the firings violated statutes but shrugged it off: "Just tell them you need to follow the law next time," he said.

Democrats and watchdog groups, however, used the dismissals to raise alarm that Trump was making it easier to take advantage of the government

on the beat preventing bad things from happening," Max Stier, president and CEO of the nonpartisan Partnership for Public Service, said in a statement. "Their work saves the taxpayer tens of billions of dollars every year." The White House did not comment on Saturday. President Donald Trump was in Las Vegas for a speech focused on his campaign promise to end federal taxation on tips.

But the moves were consistent with the president's first week back in the White House, which has featured a series of steps to remake the federal government. Trump has done everything from using executive orders to impose hiring freezes and crack down on diversity, equity and inclusion initiatives, to suggesting that he wants to shutter the Federal Emergency Management Agency and leave disaster recovery up to individual states affected by major emergencies.

Yesterday, in the dark of night, President Trump fired at least 12 independent inspector generals at important federal agencies across the administration," Senate Democratic leader Chuck Schumer of New York said Saturday on the chamber's floor. "This is a chilling purge and it's a preview of the lawless approach Donald Trump and his administration are taking far too often as he's becoming president."

Schumer said the dismissals are 'possibly in violation of federal law" and help demonstrate that the move "is a glaring sign that it's a golden age for abuse in government and even corruption.

The Washington Post, which first reported the firings, said that many were appointees from Trump's first term. Among those inspectors general reportedly removed included those for the Departments of Agriculture, Commerce, Defense and Education.

In a lengthy statement Saturday, Hannibal Ware, the chairman of the Council of the Inspectors General on Integrity and Efficiency, an independent entity that represents the interests of government watchdogs, noted that inspectors general conduct their "oversight in a strictly non-partisan manner. They are appointed, by law, without regard to their political affiliation and, during their tenures, they work effectively across Administrations and with Congress, without regard to political party."

He suggested that the firings violated the legal requirements that presidents notify Congress 30 days before firing an inspector general and provide a detailed rationale for the decision.

S.California rain helps firefighters

After weeks of windy and dry weather, rain has fallen in parched Southern California and is expected to aid firefighters who are mopping up multiple wildfires. But potentially heavy downpours on charred hillsides could bring new troubles such as toxic ash runoff.

Los Angeles County crews spent much of the past week removing vegetation, shoring up slopes and reinforcing roads in devastated areas of the Palisades and Eaton fires, which reduced entire neighborhoods to rubble and ash after breaking out during powerful winds Jan. 7

Most of the region was fore-cast to get around an inch (about 2.5 centimeters) of precipitation

over several days, but "the threat is high enough to prepare for the worst-case scenario" of localized cloudbursts causing mud and debris to flow down hills, the National Weather Service said on social me-

dia. "So the problem would be if one of those showers happens to park itself over a burn area," weather service meteorologist Carol Smith said. That could be enough to create de-

bris flows." Rainfall that began late Sat-urday was expected to increase Sunday and possibly last into early Tuesday, forecasters said. Flood watches were issued for some burn areas, while snow was likely in the mountains. (AP)

WASHINGTON, Jan 26, (AP): As President Donald Trump tightens the nation's immigration policies, lawmakers in Democratic-led states are proposing new measures that could erect legal obstacles for federal immigration officials and help immigrants lacking legal status avoid deportation.

In just his first week in office, Trump's administration has halted southern border; lifted longtime rules restricting immigration enforcement near schools, churches and hospitals; attempted to end birthright citizenship; and ordered federal prosecutors to investigate state or local officials who they believe are interfering with his crackdown on illegal immigration

Hundreds of bills on immigration already have been introduced in states and more action is expected next week. Republican Govs. Ron De-Santis of Florida and Bill Lee of Tennessee have called special legislative sessions to begin Monday to support Trump's immigration agenda.

Meanwhile, Democrats in states such as Connecticut, Hawaii, Massachusetts, New Mexico, Oregon and Washington are backing measures to

expand health care and higher education for immigrants, restrict landlords from inquiring about immigration status or block government agreements to open new immigrant detention cen-

Many U.S. adults support stronger security at the southern border and deporting immigrants in the U.S. illegally who have been convicted of violent crimes, according to a survey by The Associated Press-NORC Center for Public Affairs Research. But some in 10 American adults support deporting all immigrants living in the U.S. illegally while a similar share are opposed.

Unlike in criminal courts, there is no constitutional right to a governmentfunded attorney in immigration courts. As Trump ramps up deportation efforts, some state measures would help pay for attorneys to defend people facing immigration proceedings.

One leader of such efforts is New York Assemblywoman Catalina Cruz, who came to the U.S. at age 9 from Colombia and remained without legal status for over a decade before gaining permanent residency and becoming a U.S. citizen and a lawyer.

Cruz has filed more than a half-dozen bills to aid immigrants. One would assert a right under state law to legal counsel in immigration proceedings in New York, or elsewhere if the immigrant was living in New York. Another would authorize state grants for organizations to hire, train and equip staff to provide legal aid to people facing deportation.

"In a world where the threat of mass deportations is imminent," the legislation "gives people an opportunity to fight their case, to fight for their families, to fight for their rights," Cruz said.

Cruz estimates 60% of the residents in her New York City legislative district are noncitizens, adding, "People are terrified.'

New York is among several states that already fund legal aid for immigrants. But advocates want about twice as much money as Democratic Gov. Kathy Hochul has proposed.

"This is a moment where investing in due process and fairness for immigrants at risk in New York is of fundamental importance," said Shayna Kessler, director of a universal representation initiative at the nonprofit Vera Institute of Justice.

Some legislative proposals also would fund attorneys who could help immigrants obtain legal residency.

Zelenskyy enjoys conversations with Trump

'US has not stopped military aid to Ukraine'

KYIV, Ukraine, Jan 26, (AP): Ukrainian President Volodymyr Zelenskyy said Saturday the US has not stopped military aid to Ukraine after newly sworn in US Secretary of State Marco Rubio announced he would pause foreign aid grants for 90 days.

Zelenskyy did not clarify whether humanitarian aid had been paused. Ukraine relies on the US for 40% of its military needs. "I am focused on military aid; it has not been stopped,' he said at a press conference with Moldovan President Maia Sandu.

The two leaders met in Kyiv on Saturday to discuss the energy needs of Moldova's Russian-occupied Transnistria region, which saw its natural gas supplies halted on Jan. 1 due to Ukraine's decision to stop Russian gas transit. Ukraine has said it can offer coal to the Transnistrian authorities to make up for the shortfall.

The future of US aid to Ukraine remains uncertain as President Donald Trump begins his second term in office. The American leader has repeatedly said he wouldn't have allowed Russia's invasion of Ukraine to start if he had been in office, although he was president as fighting grew in the east of the country between Kyiv's forces and separatists aligned with Moscow, ahead of Putin sending in tens of thousands of troops in 2022

On Thursday, Trump told Fox News that Zelenskyy should have made a

deal with Putin to avoid the conflict. A day earlier, Trump also threatened to impose stiff tariffs and sanctions on Russia if an agreement isn't reached to end the fighting in Ukraine.

Speaking in Kyiv on Saturday, Zelenskyy said he had enjoyed "good meetings and conversations with President Trump" and that he believed the U.S. leader would succeed in his desire to end the war.

'This can only be done with Ukraine, and otherwise it simply will not work because Russia does not want to end the war, and Ukraine does," Zelenskvy said.

With Trump stressing the need to quickly broker a peace deal, both Moscow and Kyiv are seeking battlefield successes to strengthen their negotiating positions ahead of any prospective talks.

For the past year, Russian forces have been waging an intense campaign to punch holes in Ukraine's defenses in the Donetsk region and weaken Kyiv's grip on the eastern parts of the country. The sustained and costly offensive has compelled Kyiv to give up a series of towns, villages and hamlets. Russia's Defense Ministry claimed

Friday that Russian troops had fought their way into the center of the strategically important eastern of Velyka Novosilka, although it was not possible to independently confirm the claim.

Elsewhere, three civilians were killed Saturday in shelling in the Russian-occupied area of Ukraine's Kherson region, Moscow-installed Gov Vladimir Saldo said.

He urged the residents of Oleshky, which sits close to the frontline in southern Ukraine, to stay in their homes or in bomb shelters.

Italy's PM defends warlord repatriation

ROME, Jan 26, (AP): Italy's prime minister on Saturday addressed growing criticism of the repatriation of a Libyan warlord wanted by the International Criminal Court, as Giorgia Meloni cited an appeals court order and security concerns.

The repatriation of Ossama Anjiem to Libya, a key partner in Europe's efforts to keep migrants from crossing the Mediterranean and landing on its shores, sparked outrage from human rights groups and questions from Italy's opposition parties.

Meloni said her government will ask the ICC to clarify why it took months to issue the arrest warrant for Anjiem, also known as Ossama al-Masri, and why it was issued only after he traveled through at least three European countries.

Thousands in Germany protest rise of far right

Tens of thousands of Germans on Saturday protested in Berlin and other cities against the rise of the far-right, anti-immigrant Alternative for Germany (AfD) party ahead of

the Feb 23 general election. At Berlin's Brandenburg Gate, a huge crowd blew whistles, sang anti-fascist songs and carried banners denouncing AfD. Activ-

ists said they hoped the rally also would draw attention to other farright parties in Europe and the new administration of US President Donald Trump.

"Those who fuel racism and at-tack climate protection are not just campaigning, they are endangering lives," Luisa Neubauer with the Fridays for Future climate group

told the crowd, which police estimated at 35,000. Police estimated the crowd at the Cologne rally at 40.000.

MINSK, Jan 26, (AP): The smiling face of President Alexander Lukashenko gazed out from campaign posters across Belarus on Sunday as the country held an orchestrated election virtually guaranteed to give the 70-year-old autocrat yet another term on top of his three decades in power.

"Needed!" the posters proclaim be-neath a photo of Lukashenko, his hands clasped together. The phrase is what groups of voters responded in campaign videos after supposedly being asked if they wanted him to serve again.

But his opponents, many of whom are imprisoned or exiled abroad by his unrelenting crackdown on dissent and free speech, would disagree. They call the election a sham - much like the last one in 2020 that triggered months of protests that were unprecedented in the history of the country of 9 million people.

The crackdown saw more than 65,000 arrests, with thousands beaten, bringing condemnation and sanctions from the West. His iron-fisted rule since 1994 -

Lukashenko took office two years after the demise of the Soviet Union - earned him the nickname of "Europe's Last Dictator," relying on subsidies and political support from close ally Russia.

He let Moscow use his territory to invade Ukraine in 2022, and even hosts some of Russia's tactical nuclear weapons, but he still campaigned with the slogan "Peace and security," arguing he has saved Belarus from being drawn into war. "It's better to have a dictatorship like in Belarus than a democracy like Ukraine," Lukashenko said in his characteristic bluntness.

His reliance on support from Russian President Vladimir Putin - himself in office for a quarter-century - helped him survive the 2020 protests.

Observers believe Lukashenko feared a repeat of those mass demonstrations amid economic troubles and the fighting in Ukraine, and so scheduled the vote in January, when few would want to fill the streets again, rather than in August. He faces only token opposition.

S.Korean prosecutors indict Yoon over martial law

SEOUL, South Korea, Jan 26, (AP): South Korean prosecutors on Sunday indicted impeached President Yoon Suk Yeol on rebellion in connection with his short-lived imposition of martial law, news reports said, a criminal charges that could put him to death or jail for life if convicted.

This is the latest blow to Yoon, who

was impeached and arrested over his Dec. 3 martial law decree that plunged the country into huge political turmoil, shaking South Korean politics and financial markets as well as its international image

Separate from criminal judicial proceedings, the Constitutional Court is now deliberating whether to formally dismiss Yoon as president or reinstate him.

South Korean media outlets, including Yonhap news agency, reported that the Seoul Central District Prosecutors' Office indicted Yoon over rebellion. Calls to the prosecutors' office and Yoon's lawyers went unanswered

Yoon, a conservative, has steadfastly denied any wrongdoing, calling his martial law a legitimate act of governance meant to raise public awareness of the danger of the liberal-controlled National Assembly which obstructed his agenda and impeached top officials. During his announcement of martial law, Yoon called the assembly "a den of criminals" and vowed to eliminate "shameless North Korea followers and

anti-state forces. After declaring martial law on Dec 3, Yoon sent troops and police officers to the assembly, but enough lawmakers still managed to enter an assembly chamber to vote down Yoon's decree unanimously, forcing his Cabinet to lift it.

The martial law imposition, the first of its kind in South Korea in more than 40 years, lasted only six hours. However, it evoked painful memories of past dictatorial rules in the 1960s-80s when military-backed rulers used martial laws and emergency decrees to suppress opponents.

South Korea's constitution gives the president the power to declare martial law to keep order in wartime and other comparable emergency states, but many experts say the country wasn't under such conditions when Yoon declared martial law

SEOUL, South Korea, Jan 26, (AP): North Korea said Sunday it tested a cruise missile system, its third known weapons display this year, and vowed "the toughest" response to what it called the escalation of U.S.-South Korean military drills that target the North.

The moves suggested North Korea will likely maintain its run of weapons tests and its confrontational stance against the US for now, even though President Donald Trump said he intends to reach out to North Korean leader Kim Jong Un.

The official Korean Central News Agency said Kim observed the test of sea-to-surface strategic cruise guided weapons on Saturday.

The term "strategic" implies the missiles are nuclear-capable. KCNA said the missiles hit their targets after traveling 1,500-kilometer (932-mile) -long elliptical and figure-eight-shaped flight patterns, but that couldn't be independently verified.

KCNA cited Kim as saying that North Korea's war deterrence capabilities "are being perfected more thoroughly" and affirming that his country will make "strenuous efforts" to defend stability "on the basis of more powerfully developed

South Korea's Joint Chiefs of Staff said North Korea had launched "several" cruise missiles toward its western waters from an inland area at around 4 p.m. on Saturday. It said South Korean maintains a readiness to "overwhelmingly" repel any provocations by North Korea in conjunction with its military alliance with the US.

In a separate statement carried by KCNA on Sunday, North Korea's Foreign Ministry criticized the US for People's Republic of Korea, the abbreviation of its formal name. The Foreign Ministry warning was in line with Kim's vows to implement the "toughest" anti-U.S. policy during a year-end political meeting.

North Korea views US military training with South Korea as invasion rehearsals though Washington and Seoul have repeatedly said their drills are defensive in nature. In recent years, the U.S. and South Korea have expanded their military exercises in response to North Korea's advancing nuclear program.

The start of Trump's second term raises prospects for the revival of diplomacy between the US and North Korea, as Trump met Kim three times during his first term. The Trump-Kim diplomacy in 2018-19 fell apart due to wrangling over US-led economic sanctions on North Korea. During a Fox News interview broadcast Thursday, Trump called Kim "a smart guy". Asked whether he will reach out to Kim again, Trump replied, "I will, yeah."

Many experts say Kim likely thinks he has greater bargaining power than in his earlier round of diplomacy with Trump because of his country's enlarged nuclear arsenal and deepening military ties with Russia.

India celebrates Republic Day with Indonesian president as chief guest

NEW DELHI, Jan 26, (AP): India celebrated its 76th Republic Day on Sunday with a colorful parade displaying its military might and cultural diversity on a boulevard in the heart of country's capital. Indonesian president was the guest of honor.

Tens of thousands of people lined the road on a cold Sunday morning to watch the long parade to mark the anniversary of the official adoption of India's Constitution on Jan 26, 1950, nearly three years after independence from British colonial rule.

Soldiers from India's military and paramilitary, along with their bands, marched as the country's leaders and other guests watched. Various floats displayed India's cultural diversity with one showcasing the Maha Kumbh festival, the ongoing massive Hindu festival touted as the world's largest religious gathering.

The parade took place on Rajpath Avenue, built by India's former British rulers and lined by huge lawns, canals and rows of trees. The avenue was redeveloped as part of the celebrations of the 75th anniversary of Indian independence and renamed Kartavya Path, or the Boulevard of Duty, in 2022.

Visiting Indonesian President Prabowo Subianto attended the event as the chief guest and was flanked by India's president and prime minister. A 342-member band and marching contingent from the Indonesian National Armed Forces joined the parade, the first time the ASEAN country's troops

MELBOURNE, Australia, Jan 26, (AP): Australians celebrated and protested across the country on Sunday as Australia Day drew attention to political differences over Indigenous rights months out from a federal election.

Australia Day marks a British colony being established at Sydney Cove on Jan. 26, 1788, which eventually led to Britain claiming the entire country without a treaty with its Indigenous inhabitants.

"If the prime minister doesn't have the strength of leadership to stand up to mayors and others who don't want to celebrate Australia Day, then our country's in more trouble than we first realized," Dutton said two weeks ago.

Dutton has accused Albanese of "equivocating" on his support for Australia Day to appease the minor Greens party. The Greens party opposes celebrations on Jan 26. Many

Leslie Voltaire made the comment in an interview with The Associated Press in Rome on Saturday following a meeting with Pope Francis at the Vatican. He visited the pope to ask for help for Haiti.

"I'm knocking on the doors of people who love Haiti. The pope loves Haiti, and he is eager to help," Haiti's interim president said.

The pontiff and Voltaire discussed the dire situation in Haiti where gangs have killed civilians and operate across the Caribbean nation with impunity. Half of Haiti's 11.4 million people are already hungry, according to Voltaire, and losing humanitarian assistance will make the situation dramatically worse.

"Trump said that Haiti is a 'shithole,' so I don't think he will care about Haiti," Voltaire said, noting that thousands of people are already being repatriated from the Dominican Republic every week

Congo severs ties with Rwanda

GOMA, Congo, Jan 26, (AP): Congo severed diplomatic ties with Rwanda as fighting between Rwanda-backed rebels and government forces raged around the key eastern city of Goma. leaving at least 13 peacekeepers and foreign soldiers dead and displacing thousands of civilians.

The M23 rebel group has made significant territorial gains along the border with Rwanda in recent weeks, closing in on Goma, the provincial capital of around 2 million people and a regional hub for security and humanitarian efforts. Congo, the United States and UN experts accuse Rwanda of backing M23, which is mainly made



ing the rebels, but last year acknowledged that it has troops and missile systems in eastern Congo to safeguard its security, pointing to a buildup of Congolese forces near the border. UN experts estimate there are up to 4,000 Rwandan forces in Congo.

Prime Minister Anthony Albanese's center-left Labor Party government has attempted to accommodate differing views of Australia Day since it won elections in 2022.

The government in 2023 decided to allow public servants to work on Australia Day and take another day off instead, reversing a previous conservative government order that they must not work on Jan. 26 when it falls on a week day.

Opposition leader Peter Dutton has said that all councils will be required to hold citizenship ceremonies on Jan. 26 if his party wins elections due by May 17.

Mexico says Trump labeling criminal organizations as terrorists doesn't help

MEXICO CITY, Jan 26, (Agencies): Mexican President Claudia Sheinbaum said on Friday that U.S. President Donald Trump's labelling criminal organizations as terrorists "does not help" to combat them.

The importance of combating criminal organizations is strengthening actions and prioritizing collaboration and respect between Mexico and the United States, she said at a daily press conference.

Noting that Mexican government does not want fentanyl to reach the United States or anywhere, Sheinbaum said: "We are fighting these criminal groups and what we want is collaboration and coordination. Unilateral decisions do not help.'

In 1996, the US government enacted a law to allow itself to have the authority to designate a list of Foreign Terrorist Organizations. On Monday, Trump signed an executive order moving toward designating drug cartels as foreign terrorist organizations.

Sheinbaum said the Mexican government is conducting a legal analysis to evaluate the possible implications of the executive order.

Meanwhile, escorted by locals on bicycles and in cars that awaited his arrival outside his hometown in Mexico, Arturo Zacarías Meza returned home days after Houthi rebels in Yemen released him and his fellow crew mem-

Kuwait's financial sector sees mixed performance

Assets rise by 4.84% yoy in Nov

Al-Seyassah/Arab Times Staff KUWAIT CITY, Jan 26: In November 2024, bank financ-

ing for financial institutions (excluding banks), covering both residents and non-residents, experienced a significant monthly decline of 127.6 million dinars or 41.2 percent, bringing the total financing to 181.6 million dinars.

This marks a decrease from 309.2 million dinars recorded in October 2024. However, on an annual basis, the financing saw a substantial increase of 112 million dinars or 160 percent, compared to 69.7 million dinars in November 2023.

In terms of local banks' financing for financial institutions, there was a slight monthly decline of 0.2 percent or 7 million dinars, reducing the accumulated balance to 2.635 billion dinars in November, down from 2.642 billion dinars in October.

On a yearly basis, however, financing grew by 33 percent, or 656 million dinars, compared to 1.979 billion dinars in November 2023.

Throughout 2024, bank financing for financial institutions fluctuated monthly, starting at 188.6 million dinars in January, with a subsequent decrease in February to 165 million dinars.

Financing picked up in the following months, peaking at 309.2 million dinars in October before dipping to 181.6 million dinars in November.

In terms of local banks' overall assets, there was an annual increase of 4.84 percent, totaling 91.41 billion dinars by the end of November, up from 87.19 billion dinars in the same period in 2023.

This increase was attributed to factors such as a 12.67 percent rise in foreign assets, which reached 27.53 billion dinars and a 4.07 percent increase in claims on the private sector, now standing at 47.07 billion dinars.

Further breakdowns of assets revealed a 17.67 percent increase in other assets, totaling 3.33 billion dinars; a 5.72 percent decrease in claims on public institutions, which reached 3.46 billion dinars and a 10.84 percent drop in mutual deposits in the local interbank market.

As for credit facilities, they increased by 745 million dinars in November, totaling 57.118 billion dinars, compared to 56.373 billion dinars in October. Personal credit facilities alone amounted to 19.273 billion dinars.

Deposits in local banks also saw an increase in November, rising by 332 million dinars to 53.690 billion dinars, compared to 53.358 billion dinars the previous month.

However, private sector deposits in foreign currencies saw a slight decline by 0.1 percent, reaching 1.9 billion dinars (approximately \$6.3 billion). On the other hand, local banks' claims on the Central Bank, represented by

Central Bonds, decreased by 25.3 percent to 1.7 billion dinars (about \$5.6 billion). This mixed performance in bank financing and local banks' assets highlights both challenges and growth in Kuwait's financial sector as the country navigates economic fluctuations.

KUWAIT CITY, Jan 26, (KUNA): Boursa Kuwait concluded Sunday's trading session with the general index climbing 100.94 points, or 1.32 percent, to close at 7,776.97 points. A total of 378.6 million shares were exchanged through 18,486 cash transactions, with a total value of 97.2 million Kuwaiti dinars (approximately \$299.3 million).

The Main Market Index edged up by 7.08 points, or 0.10 percent, to settle at 7,236.96 points. Trading volume reached 167.6 million shares through 8,458 transactions, valued at 29.3 million dinars (about \$90.2 million). The Premier Market Index posted a significant rise of 130.69 points, or 1.60 percent, closing at 8,295.71 points. It recorded a trading volume of 210.9 million shares across 10,028 transactions,

Markets navigate policy shifts, data, and volatility as Trump takes office

This week, US markets saw significant volatility following President Trump's policy announcements after his inauguration. At the World Economic Forum in Davos, President Trump's speech solidified his protectionist stance on trade, and reiterated calls for tariffs on imports, lower interest rates, and reduced oil prices. This came as US unemployment claims rose only marginally, amidst mixed PMI data ahead of next week's FOMC meeting. In Canada, inflation eased to 1.8% y/y, and monthly retail sales remained flat, increasing expectations of a rate cut by the Bank of Canada this month. In Europe, this week's surge of data triggered fluctuations in the euro currency. Eurozone PMI showed modest improvement, with Germany's composite PMI returning to expansion, whilst France continued its contraction due to weak demand and political uncertainty. Meanwhile, the UK saw a rise in unemployment to 4.4%, despite strong wage growth. In Asia, the Bank of Japan raised its policy rate to 0.50%, the highest in 17 years, due to accelerating inflation. In contrast, the People's Bank of China kept its lending rates unchanged as the yuan weakened, signalling a cautious monetary stance. Overall, global markets remain volatile, driven by the flurry of political developments, economic data, and central bank stances.

United States and Canada

Trump's Inauguration Triggers Market Shifts Amidst Policy Changes and Protectionist Measures

Donald Trump's inauguration as the 47th US President was marked by sweeping executive orders and market volatility. Key policy changes included the withdrawal from the Paris Climate Accord and the World Health Organization, reversals of nearly 80 Biden-era directives, and the suspension of birthright citizenship. Immigration reforms, declaring a 'national energy emergency', diversity programme eliminations, and hiring freezes underscored a shift toward protectionist policies, setting the stage for significant domestic and global challenges. Trump also ordered investigations into trade imbalances, without imposing immediate tariffs, though he suggested potential levies of 25% on Canada and Mexico, and 10% on China. On Friday, DXY fell to a one-month low after Trump said he would "rather not" use tariffs on China, dampening inflation expectations. DXY was last seen at 107.44.

Trump Pushes Federal Reserve to Cut Rates, and Escalates Tax Policy Amidst Economic Concerns

Ahead of the Federal Reserve's meeting next week, President Trump ramped up pressure for interest rate cuts, criticising Fed Chair Jay Powell's cautious stance. The central bank is expected to hold rates at 4.25%-4.5% after three consecutive cuts totalling 100bps since September 2024. Economists have expressed concerns that Trump's policies—especially tariffs, tax cuts, and immigration reforms—could undermine inflation control, which remains above the 2% target. Meanwhile, President Trump threatened to double tax rates for foreign nationals and corporations. This measure targets perceived discriminatory international tax policies, particularly against US multinationals. The administration also withdrew support for the OECD global tax pact, which was expected to generate \$192B annually in tax revenues.

ing Claims Hit a Three-Year High of 1.9M

Initial unemployment claims in the US rose by 6K to a seasonally adjusted 223K for the week ending January 18, 2025, higher than the expected 219K. Continuing claims, a proxy for long-term unemployment, reached 1.9M, the highest since November 2021, suggesting greater challenges for job seekers. Despite these figures, initial claims remain near pre-pandemic averages, indicating a resilient labour market. Nonfarm payrolls had grown by 256K in December, contributing to a 2.2M job increase in 2024. Economists note potential distortions from seasonal factors, extreme weather, and the Trump administration's pro-business policies, including federal employment cuts, which could shape the labour market in the coming months.

US Composite PMI Falls 9-Month Low of 52.4; Manufacturing Hits 50.1, Services Drops to 52.8

In January, the US private sector showed mixed signals of economic activity. The S&P Global Composite PMI fell to 52.4 from 55.4 in December, marking a nine-month low. The Manufacturing PMI improved to 50.1, up from a revised 49.4, reaching a seven-month high and indicating a slight return to expansion. Meanwhile, the Services PMI declined significantly to 52.8 from 56.8, also a ninemonth low. Business optimism remains strong, bolstered by expectations of growth-friendly policies under the new administration. However, inflationary pressures have resurfaced, driven by supplier price hikes and wage increases, with broad-based cost growth across goods and services posing potential challenges for monetary policy adjustments.

Canada's Inflation Rate Eases to 1.8% y/y as CPI Contracts 0.4% m/m, Core Inflation Nears BoC Target

Canada's Consumer Price Index (CPI) eased to 1.8% y/y in December 2024, down from 1.9% in November, reflecting the impact of a sales tax break that began mid-month. On a monthly basis, CPI contracted 0.4% in December, driven by lower prices for alcohol (-1.3%), restaurant food (-1.6%), and children's clothing. The tax relief affected approximately 10% of the CPI basket and is expected to have a more pronounced effect in January. Core inflation metrics, CPI-median and CPI-trim, edged down to 2.4% and 2.5% respectively, approaching the midpoint to the Bank of Canada's target range of 1 to 3%. Markets now anticipate an 93% likelihood of a 25-basis-point rate cut on January 29. USD/CAD was last seen at 1.4341.

Canada's Retail Sales Flat in November at CAD 67.57B, Motor Vehicles Offset Sectoral Declines

Canada's retail sales were unchanged in November at CAD 67.57B (\$467B), as declines in six of nine subsectors, including food and beverage (-1.6%) and general merchandise (-1.0%), offset a 2% rise in motor vehicle and parts sales, according to Statistics Canada. Excluding automotive sales, retail sales fell 0.7%. Economists attribute the muted figures to delayed Black Friday effects and mid-December tax holidays. Retail sales, a key GDP indicator, contribute nearly 40% to consumer spending, which underpinned Q3 economic growth. Preliminary data suggest a 1.6% rise in December.

Europe and the United Kingdom

Eurozone PMI Composite Hits 50.2 Amidst Marginal Growth in Services

Eurozone PMI data for January highlighted cautious economic improvement, with the PMI Composite rising to 50.2 from 49.6, indicating marginal growth after five months of contraction. Manufacturing PMI climbed to 46.1, its highest in eight months, though still contracting, while services PMI dipped slightly to 51.4 but remained expansionary. Germany's PMI Composite rose from 48.0 to 50.1, marking a return to growth, while France continued to contract with a PMI Composite of 48.3. Inflationary pressures persisted, as input prices in manufacturing rose for the first time in four months, driven by a weaker euro and higher CO2 taxes, with markets assigning a 97% probability of a 25bps cut by the ECB next week. EUR/USD was last seen at 1.0495.

Europe Prepares for Potential US Tariffs Amid Trade Tensions and 1% GDP Surplus

European Central Bank President Christine Lagarde has warned Europe to prepare for potential US trade policy shifts under President Donald Trump, who has hinted at selective tariffs targeting EU goods. Speaking at the World Economic Forum in Davos, Lagarde noted that Europe's trade surplus with the US, almost 1% of GDP in 2023, underscores its reliance on key sectors such as chemicals and pharmaceuticals. Lagarde questioned the feasibility of US domestic manufacturing substituting EU imports, citing the US economy's full capacity and historically low unemployment. She emphasised Europe's need to remove internal trade barriers, enhance competitiveness, and implement urgent reforms to strengthen its position in global trade negotiations.

UK Ünemployment Rises to 4.4% in November as Job Growth Slows and Wages Climb 5.6%

The UK's unemployment rate edged higher to 4.4% in

the three months to November 2024, exceeding the forecasted 4.3%, according to the Office for National Statistics. Employment growth slowed significantly, with a net increase of 35K jobs, compared to October's 173K. Claimant count data also reflected weaker labour market momentum, with a modest rise of 0.7K in December 2024, following a revised decline of 25.1K in November. Wage growth remained robust, as average earnings, both with and without bonuses, rose 5.6% y/y in the same period, consistent with market expectations. These figures underscore the UK labour market's softening amidst broader economic headwinds, impacting employment prospects and wage dynamics. GBP/USD was last seen at 1.2483.

UK Composite PMI at 50.9; Services at 51.2 and Manufacturing at 48.2 Signal Mixed Growth

The UK S&P Composite PMI increased to 50.9 in January, up from 50.4 in December, marking a three-month high and narrowly indicating growth. The Services PMI edged higher to 51.2 from 51.1, while Manufacturing PMI improved to 48.2 from 47.0 but remained in contraction. Despite these gains, employment fell at its fastest rate since 2009 (excluding the pandemic), as businesses cited higher social security costs following payroll tax hikes in October 2024. Inflationary pressures intensified, with input and output prices at their highest levels since mid-2023. Business optimism hit its lowest point since late 2022, underscoring challenges for the Bank of England ahead of its February 6 rate decision.

Asia-Pacific

BOJ Raises Policy Rate to 0.5%, Upgrades Inflation Projections in Boost for Yen

The Bank of Japan (BOJ) raised its key policy rate by 25bps to 0.5%, the highest level in 17 years, citing stronger-than-expected inflation and stable global financial conditions. The BOJ's latest outlook report revised up its inflation projections to 2% or higher for the first time, with Japan's core consumer prices (excluding fresh food) rising 3% in December 2024. The yen strengthened by 0.8% against the US dollar, reaching a high of 154.85, while 10-year Japanese government bond yields rose 2bps to 1.225%. This marks the third rate hike under Governor Kazuo Ueda, reflecting the BOJ's gradual tightening strategy as wage growth and currency stability remain pivotal to future policy adjustments. USD/JPY was last seen at 155.99.

China Keeps Benchmark Lending Rates at 3.1% and 3.6% Amid Yuan Weakness

China's central bank kept its benchmark lending rates unchanged for the third consecutive month in January 2025, with the one-year loan prime rate (LPR) at 3.1% and the five-year LPR at 3.6%. This decision aligns with expectations and reflects the challenges posed by a weakening yuan, which has constrained the scope for further monetary easing. While the economy met the government's 5% growth target in 2024, reducing the urgency for immediate stimulus, the depreciation of the yuan and banks' narrowing interest rate margins limit the effectiveness of further rate cuts. Market expectations for imminent rate reductions have diminished, with a more cautious monetary stance anticipated considering the currency pressures.

US economy shows strong growth with low unemployment & elevated inflation

Jobless claims rise modestly to 223,000

WASHINGTON, Jan 26, (AP): Jobless claims applications ticked up modestly last week, but the total number of Americans collecting unemployment benefits rose to their highest level in more than three years.

Applications for jobless benefits rose by 6,000 to 223,000 for the week ending January 18, the Labor Department said Thursday. Analysts were expecting 219,000 new applications.

Weekly applications for jobless benefits are considered a proxy for layoffs.

The total number of Americans receiving unemployment benefits for the week of January 11 climbed by 46,000 to 1.9 million, the most since November of 2021.

The rising level of continuing claims, the total number of Americans collecting jobless benefits, suggests that some who are receiving benefits are finding it harder to land new jobs. That could mean that demand for workers is waning, even as the economy remains strong.

The four-week average of continuing claims is about 100,000 higher than it was a year ago.

Though some signs of labor market weakness surfaced in 2024, jobs are still plentiful and layoffs historically low.

Earlier this month, the Labor Department reported that job growth in December surged and unemploy-ment fell. Employers added 256,000 jobs last month and the unemployment rate ticked down to 4.1%.

The final jobs report of 2024 underscores that the economy and hiring were able to grow at a solid pace even with interest rates much higher than they were before the pandemic. As a result, the Federal Reserve could be much less likely to cut

borrowing costs again in the coming months after issuing three cuts late in 2024.

Overall, the solid jobs figures suggest the economy is entering a post-COVID period of steady growth, higher interest rates, low unemployment, and slightly elevated inflation.

Though layoffs remain healthy by historical standards, several high-profile companies have an-

nounced job cuts in the past few months. Facebook parent company Meta announced earlier this month that it was laying off 5% of its staff and spirits giant Brown-Forman - the maker of Jack Daniel's - said it's reducing its global workforce by about 12%

Late in 2024, GM, Boeing, Cargill and Stellantis all announced layoffs.

US home sales fall to 30-year low for 2nd consecutive year

LOS ANGELES, Jan 26, (AP): The latest evidence that homeownership is becoming increasingly less accessible to many Americans: Sales of previously occupied U.S. homes fell last year to a nearly 30-year low for the second time in as many years.

Elevated mortgage rates, a years long shortage of homes on the market and record-high home prices continued to stymie prospective home shoppers, especially first-time buyers.

That led existing home sales to fall 0.7% last year to 4.06 million - the weakest showing for home sales since 1995 and edging out the terrible year for sales in 2023, the National Association of Realtors said Friday.

Even in the midst of a sales slump, a dearth of homes on the market and rising mortgage rates gave sellers an edge over buyers, helping drive up the national median home price for all of last year to an all-time high \$407,500, an increase of 4.7% from a year earlier.

"How is it possible that home sales can be this low, considering that the U.S. population has increased by more than 70 million over this time period from 1995 to today?" asked Lawrence Yun, the NAR's chief economist. "One can partly answer that question because of the affordability issue. Record-high home prices, mortgage rates having risen, but also lack of inventory

The U.S. housing market has been in a sales slump dating back to 2022, when mortgage rates began to climb from pandemic-era lows. The average rate on a 30-year mortgage surged to a 23-year high of nearly

8% in October 2023 and briefly fell to a 2-year low last September, but has been mostly hovering around 7%, according to mortgage buyer Freddie Mac.

The buying power of Americans now facing higher costs to borrow money for homes that have soared in value has been significantly stunted. With so few homes up for sale, millions of would-be homebuyers have found themselves on the sidelines.

At the end of December, there were just 1.15 million homes on the market, NAR said. While that was up 16.2% from a year earlier, the inventory remained well below the annual historical average of about 1.98 million, according to data going back to 1999.

The available inventory at the end of last month amounts to a 3.3-month supply, going by the current sales pace. In a more balanced market between buyers and sellers, there is a 4- to 6-month supply

"This means that the problems in the U.S. housing market continue to worsen in terms of availability of homes for sale and the upward pressure on home prices," Eugenio Aleman, chief economist at Raymond James, wrote in a research note.

Many factors have contributed to the housing shortage, including more than a decade of below-average new home construction and homeowners hanging on to their properties longer. And while President Donald Trump made increasing the housing supply one of his election campaign platforms, there are no quick fixes

"Over the past decade, the U.S. has averaged about 5.2 million home sales annually," said Lisa Stur-tevant, chief economist at Bright MLS. "It is going to take years before we are back at that level, maybe not even until the 2030s. The lack of inventory is the key constraint.'

A sharp drop in the mortgage rate boosted the purchasing power of Americans in 2020 and 2021. While many economists predict that the average rate on a 30-year mortgage will ease this year, they generally don't expect it to fall below 6%, about twice what it was five years ago.

When mortgage rates ease, they can encourage home shoppers. A pullback in rates last fall helped home sales increase on a monthly basis in the last three months of the year.

Home sales in December rose 2.2% from the previous month on a seasonally adjusted basis to a 4.24 million annual pace, NAR said. That topped the 4.2 million pace forecast by analysts polled by FactSet. Sales rose 9.3% in December versus the same month last vear.

The median home sales price rose for the 18th consecutive month in December to \$404,000, up 6% from a year earlier.

Limited inventory, especially in the more affordable price range of a given market, helps drive prices higher. That's one reason many first-time homebuyers, who don't have any home equity to put toward their down payment, continue to struggle.

They accounted for 31% of all homes sold last month, up from 30% in November and 29% in December 2023. However, the annual share of first-time buyers was 24%. It's been 40% historically.

Trump claims victory over inflation, but no direct action in first week

WASHINGTON, Jan 26, (AP): Two months ago, in his first network television interview after the election, Donald Trump said he owed his victory to Americans' anger over immigration and inflation, specifically the rising cost of groceries.

"When you buy apples, when you buy bacon, when you buy eggs, they would double and triple the price over a short period of time," he told NBC's "Meet the Press. "And I won an election based on that. We're going to bring those prices way down.

But in Trump's first week back in the White House, there was little in his initial blitz of executive orders that directly tackled those prices, besides directing fed-eral agencies to start "pursuing appropriate actions." He is taking steps to lower energy costs, something that Trump hopes will have ripple effects throughout the economy. Otherwise, his focus has been clamping down on immigration, which he described as his "No. 1 issue" shortly after taking the oath of office. "They all said inflation was the No. 1 issue. I said, 'I disagree,'" Trump said.

"I talked about inflation too, but how many times can you say that an apple has doubled in cost?"

Trump is banking on voters giving him a pass and continuing to blame former President Joe Biden for high prices. The Republican's comments reflect the reality that presidents have almost no levers to reduce inflation quickly without causing collateral damage to other parts of the economy.

There is more that Trump can do on energy. He is pushing to reduce regulations and increase the amount of land available for drilling. He is trying to persuade domestic and foreign oil producers to potentially sacrifice their own profits by pumping more.

During a rally Saturday in Las Vegas, Trump went after his Democratic predecessor for allowing prices to rise under his watch, and promised to take care of the problem quickly

"When I think of Biden, I think of incompetence and inflation," Trump said.

Inflation peaked at a 9.1% annual rate in June 2022 during worldwide supply chain problems after the economic shock of the coronavirus pandemic. Overall consumer prices have fallen since then, but have ticked up in recent months, from 2.4% in September to 2.9% in December, the latest figures available. Economists have warned that Trump's plans for tariffs and tax cuts could create new inflationary pressures and keep interest rates elevated.

Vice President JD Vance, in an interview with CBS' "Face the Nation" airing Sunday, defended the White House's work so far.

"Prices are going to come down, but it's going to take a little bit of time, right?" he said. He added, "Rome wasn't built in a day."

Trump's relative shift away from addressing costs could create an opening for Democrats to say he is not helping working-class voters, hoping that argument could offer the party a path back to power in Washington

Sen. Chris Murphy, D-Conn., said Trump preferred to distract people from inflation with talk of adding Greenland to the United States or seizing the Panama Canal

"It's catnip and it causes everybody to stop paying attention to their actual economic agenda, which has nothing to do with lowering costs and everything to do with rigging the economy to help the Mar-a-Lago crowd," he said.

During an interview on Fox News this past week, host Sean Hannity struggled to get Trump to focus on the economy. "Let me get to the economy," Hannity said at one point. "I'm running out of

time." "The economy is going to do great," Trump insisted.

When Trump did talk about inflation in the interview, he noted how low it was during his first term and insisted prices would not have jumped up if he had president after the 2020 election, even though higher inflation was a global trend coming out of the pandemic.

It is not clear how Trump would persuade oil companies and foreign countries

to quickly increase production, possibly costing them profits.

The Energy Information Administration reported that domestic oil production has grown at an annual rate of roughly 8.4% over the past two years to an average of nearly 13.5 million barrels a day in October. Some Trump aides suggest that could increase by an additional 3 million barrels a day.

It would be difficult to achieve that much additional production in a single year without serious changes to the global market. The International Energy Agency estimates that the oil supplied to the entire world will increase by 1.8 million barrels per day to 104.7 million barrels a day. He also has expressed opposition to climate-friendlier wind and solar energy, putting more pressure on the U.S. economy to rely on fossil fuels.

EJ Antoni, a research fellow at the Heritage Foundation, a conservative think tank in Washington, said the potential increase in energy production under Trump would ultimately flow through the economy in the form of lower prices.

"If you're going to bring down the cost of energy, you're going to bring down the cost of all kinds of goods and services," he said.

But there is a risk that some of Trump's plans taken as a whole could raise - not reduce - prices. Deporting migrants who are in the United States illegally could deprive companies of lower wage workers. The cost of tariffs, which are taxes placed on foreign imports, could be passed on to consumers.

Trump said that his strategy also might ultimately involve publicly pressuring the Federal Reserve to cut interest rates, saying in Davos that he would "demand" lower rates from central banks. The Fed sees its political independence as key for making tough choices to stabilize prices. Biden saw the independence as worth protecting, whereas Trump sees it as problematic.

The Fed raised its benchmark rates starting in 2022 to make it more expensive to borrow and succeeded enough in reducing inflationary pressures that it could trim rates late last year. Trump believes that greater oil production will put him in a position to tell the Fed what to do.

Zuckerberg claims workplaces have been 'neutered,' calls for more aggression

Research shows masculinity contest culture can harm workers and companies

□ □ □ When Meta CEO Mark Zuckerberg appeared on a geeky image of his youth. But is Zuckerberg right? Do workplaces in the U.S. need to embrace a more diesel-fueled, streetfighting, meat-eating mentality?

As a social psychologist who studies masculinity and aggression, I think it's important to evaluate what the science says about Zuckerbeg's claims - and to consider what it means for the future of workplace culture in the U.S. In 2018, sociologist Jennifer Berdahl and her colleagues coined the term "masculinity contest culture" to describe workplaces rife with cutthroat competition, toxic leadership, bullying and harassment. Integrating decades of prior research on masculinity in the workplace, Berdahl and her collaborators were able to map how masculinity contest cultures operate, as well as show how they affect organizations and individual employees. In her experiments, she had participants agree or disagree with statements such as "expressing any emotion other than anger or pride

is seen as weak," based on their perceptions of their own organization. Using advanced statistical techinques, Berdahl's team was able to distill masculinity contest cultures down to four components: "showing no weakness," "strength and stamina," "putting work first" and "dog eat dog."

Then they were able to show how these cultures are tied to a host of negative outcomes for workers and companies, such as burnout, turnover and poor well-being. And at the organization level, they can foment a dysfunctional office environment, toxic leadership and even bullying and harassment. Based on this research, then, it seems like promoting rigid masculinity in the workplace is not the best solution for an arguably already struggling Meta.

Zuckerberg's own company isn't exactly a paragon of parity: Its total workforce, as of 2022, was nearly two-thirds male, while its tech workforce was three-quarters male. Furthermore, according to psychologists Sapna Cheryan and Hazel Markus, workplaces in the U.S. still reflect what they call "masculine defaults" - cultures that reward characteristics or behaviors generally associated with men. This can range from how companies describe themselves - for example, as places that are "aggressive" and "unrestrained" - to hosting events catering to traditionally male pursuits, such as golf outings. Although Chervan and Markus' analysis centers on how masculine defaults make it harder for women to carve out their professional paths, they can harm everybody, including men My research, for example, has shown that when men feel pressured to fulfill certain masculine expectations, they can develop fragile masculine identities, which are linked

with aggression and anxiety.

Although the pervasiveness of masculinity norms can give men an upper hand in the workplace, I wonder whether men are contorting themselves to fit into outdated molds of who succeeds at work. Indeed, research shows that successful organizations promote a healthy mix of stereotypically masculine and feminine qualities.

In other words, it's best when people of all genders feel comfortable showcasing traits such as cooperation and agency, qualities that don't necessarily fall into one gender camp.

If many workplaces still possess dog-eat-dog cultures and celebrate masculinity - with evidently poor outcomes - you might wonder why billionaire corporate leaders would advocate for them.

The most generous explanation is ignorance. Zuckerberg could simply be unaware that most offices in the U.S. still possess competitive environments and traits associated with traditional masculinity. Although this could be the case,

Although this could be the case, I think there could be two other explanations for Zuckerberg's promotion of rigid masculinity norms.

There could be an economic motive. Perhaps Zuckerberg thinks that promoting his company as an arena of high-stakes competition and aggression is the best way to attract talent and spur innovation in a field already dominated by men. It's often thought that competition drives innovation. So "Meta needs to be more masculine" could actually be code for "Meta needs to breed more internal competition, which will spur innovation and turn a profit." This assumption is also misguided: Recent research has shown that internal competition may actually stifle innovation.

There could also be a psychological motive. I've found in my research that men are most likely to cling to notions of rigid masculinity when they feel pressure to "man up" and are insecure about themselves.

Perhaps Zuckerberg sees diversity efforts as a challenge to his power. Maybe he thinks aligning himself with President Donald Trump's version of masculinity will help him gain and retain power, especially as he faces challenges from other tech giants. So his promotion of an aggressive workplace, along with his slashing of policies that could

Jan. 10, 2025, episode of "The Joe Rogan Experience," he lamented that corporate culture had become too "feminine," suppressing its "masculine energy" and abandoning supposedly valuable traits such as aggression.

The workplace, he concluded, has been "neutered."

Perhaps not surprisingly, Zuckerberg has also embraced stereotypically masculine pursuits in his personal life. He's become a mixed martial arts aficionado and has shared his affinity for smoking meats. On his expansive Hawaii compound, he's even taken up bowand-arrow pig hunting. He's come a long way from the

What, then, led Zuckerberg to claim that the workplace has been neutered and must be infused with masculine energy? Has the American office really gone full "Legally Blonde"? make him look "weak," are moves to reinforce his status as a leader, as an innovator and as a man.

This isn't to say that activities such as hunting and mixed martial arts are inherently bad, or even inherently masculine: There are plenty of female hunters and UFC fighters. Nor is it to say that certain masculine characteristics in the workplace are inherently bad.

But when I see middle-aged billionaires - Zuckerberg isn't the only one - exhibiting the signs of fragile masculinity that I've observed among young adult men and adolescent boys, I can't help but wonder what the country's future holds. (AP)

70% of employees still value office community post-pandemic

Post-pandemic office-forward strategy focuses on community building

It's been five years since the pandemic lockdowns of 2020 disrupted the traditional office workplace. For a while, it seemed COVID-19 killed the office.

Companies are now returning to the office in ever greater numbers. As professors who have researched remote work and collaboration for decades, we have our counterarguments. But there are lessons to be learned from what we are calling an "office-forward" approach, where companies are encouraging employees to work from the office most of the time.

We studied an office-forward company headquartered in the Midwest with multiple satellite offices across the U.S. before the pandemic, during lockdown, and as it navigated the return-to-office landscape. We embedded ourselves within the company for just over two years and conducted field observations, focus groups and one-on-one interviews with a total of 56 employees. We were struck by how employees talked about their place of work:

"This is my place. I feel very taken care of here."

"Every time I come in, I feel welcomed."

"It is such a welcoming place to come back to work every day."

These comments speak to the positive culture of this company. But they also hint at something really interesting: Employees may see the office space as a welcoming place to be.

This is significant because research across disciplines - from anthropology to organizational science - has shown that people develop attachment to places, not spaces. Think about a house versus a home. A house is a structure; a home is a place of community.

And so, while the office is not a home, we learned that an officeforward strategy can be successful if employers transform their workspaces into workplaces, or into places of community. Here are three transformation tactics we discovered:

Can the office support community? Can the workspace be a workplace?

Our research shows that employees see the office as a positive place when it meets their needs. The more goals people can accomplish in a space, the more attached they feel to it. As one employee told us: "If you want to work independently, there's a space for that. If you want to collaborate with others, there are spaces for that. If you want to eat lunch with 50 people, you can do that. Or, if you just want to have, like, a one-on-one, you can do that as well. There is flexibility, just depending upon your mood, and maybe what you need to accomplish that day.

We think this shows the value of redesigning "spaces" as "places" that meet multiple work-related and human needs. We also documented the importance of providing a workstation for every employee. It's simple: Humans are territorial. If you can't put a picture of your family on your desk, you feel stripped of your humanity. An employee shared: "I know a lot of companies make you bounce around. Sounds terrible to me. Here, I have my little cubicle, and I love that."

Not to mention the huge inconvenience of having to truck your stuff - even your mug and your mouse - to and from the office every day. Desk-sharing is antithetical to place attachment because it treats people like cogs.

People are the ones who turn spaces into places. To accomplish this, some critical mass of people must use the physical infrastructure together.

The company we studied imagined its office as a social - not just a work - arena. It dreamed up all sorts of engagement opportunities. It hosted breakfasts and lunches, had movie nights, invited food trucks and ice cream vans, threw silent dance parties, and more.

Employees told us they enjoyed both "the informal, organic interactions when I go down to get coffee in the morning" and the "energy I feel when there are events in the office." Infusing social opportunities of all shapes and sizes into the office means people are making memories in the office together. And this means they are building community.

But this company went further. It passed the place-making baton. Employees could personalize the space. One team installed a mini-golf course; another painted a mural on an office wall in the center of the building. Employees used the space how and when they wanted to. Some did walking meetings on the treadmills; others played video games after lunch.

Most importantly, employees hosted their own activities in the office. We don't just mean baby showers and such; we mean inviting the board of a nonprofit for a meeting at the office or inviting a group of students for an office tour. Turning space-users into placemakers means people develop a sense of shared ownership of the space-turnedplace. No wonder we kept on hearing possessive language: "There's a lot of pride in the fact that this is our place" and "This is a building of the people, to put it in a slogan-y way." The office had become a place of community.

Technology is an integral part of the post-pandemic workplace. With increased flexibility, employees aren't in the office all the time, even in companies with in-person policies. Since 2022 a number of companies - some recent examples include Amazon, AT&T, Tesla and others - have implemented strict in-person requirements, suggesting that technology is disruptive to office community. But technology can be a place-maker. It can virtually extend the sense of community from the company office to the home office.

The company we studied ensured that employees continued to feel a connection to the office when working from home during the pandemic. Executives created videos, human resources staff created newsletters and mailed company swag and treats to employees' homes, and team leaders hosted virtual events and games to keep everyone connected.

Even after the pandemic, the company built Zoom rooms conducive to hybrid team meetings where all employees could feel present. It created branded virtual backgrounds and added branding to their virtual meeting rooms and software systems to remind of the office. It even hired an intern to post updates on company happenings on the company's social media channels. The result? We heard this: "I feel welcome in this virtual office, too!"

Place-making works, but it doesn't work for everyone. In our research, most employees were what we call "place-attached" before the pandemic. But after the pandemic, some had lost their sense of connection to the office and the sense of community they used to feel there. These place-detached employees felt "I'm just there to be there" and "The touchy-feely is not where I get my value from."

We estimate that about 30% of the post-pandemic workforce at this company now feels disconnected from the company culture and the emphasis on being in the office for work.

But considering how many people discovered during the pandemic that they prefer to work from home, 30% is actually quite a low number.

The surprise - for us, at least - was that about 70% of employees in the company we studied remained attached to their office space in 2025. In other words, 7 in 10 continue to find community in the office. Our research unpacks this abstract concept further: (AP)

Rose Byrne's gripping role in 'If I Had Legs I'd Kick You'

Byrne, O'Brien thriller is hottest ticket at Sundance

PARK CITY, Utah, Jan 26, (AP): Rose Byrne plays a mother in the midst of a breakdown in the experiential psychological thriller "If I Had Legs I'd Kick You.'

Anticipation was high for the A24 film, which will be released sometime this year. Its premiere Friday at the Sundance Film Festival was easily the hottest ticket in town, with even ticketholders unable to get in. Those who did make it into the Library theater were treated to an intense, visceral, inventive story from filmmaker Mary Bronstein that has quickly become one of the festival's must-sees.

Byrne plays Linda, who is barely hanging on while managing her daughter's mysterious illness. She's faced with crisis after crisis, big and small - from the massive, gaping hole in their apartment ceiling that forces them to move to a dingy motel, to an escalating showdown with a parking attendant at a care center. The cracks in her psychological, emotional and physical wellbeing are become too much to bear.

"I'd never seen a movie before where a mother is going through a crisis with a child but our energy is not with the child's struggle, it's with the mother's," Bronstein said at the premiere. "If you're a caretaker, you shouldn't be bothering with yourself at all. It should all be about the person you're taking care of, right? And that is a particular kind of emotional burnout state that I was really interested in exploring.'

Byrne and Bronstein went deep in the prepara-

tion phase, having long discussions about Linda with the goal of making her as real as possible before the quick, 27-day shoot. Byrne said she was obsessed with figuring out who Linda was before the crisis. The film was in part inspired by Bronstein's experience with her own daughter, but she didn't want to elaborate on the specifics.

"That's her story to tell," Bronstein said.

Part of Linda's story involves her therapist, played by Conan O'Brien, who joked that he didn't realize he was in a movie.

Scripts

"I'm not looking out for movie scripts or anything. But when I got a call from A24 that they wanted me to read something, I'm not stupid,' O'Brien said. "I showed it to my wife, who is one of the smartest people I know, and she read through it and she said, 'I didn't know they made movies like this anymore."

He was particularly in awe of his director and co-star, saying he felt like a fraud standing beside them.

"It was an amazing experience, one of the best experiences of my life, just to be with them and watch them work," O'Brien said. "I don't know how (Byrne) did that and not check into a hospital afterwards, because I haven't seen any actor, man or woman, sustain that level for an entire movie."

"I feel like I have to go to a hospital now, because this was the first time I watched it," he added. "I'm a mess."

A\$AP Rocky also co-stars, as a man Linda meets at the motel, but was not in Park City for the premiere. He is currently on trial, charged with firing a gun at a former friend.

The film is full of ambiguity, metaphor and iust plain artistic expression that Bronstein hesitated to explain, from the name itself to the hole in the ceiling, which takes on a somewhat supernatural quality.

"When we have nothing left to give, we have an emptiness inside of us," Bronstein said. "And that emptiness is actually not empty: It's filled with all the darkness and self-hate and doubt and fear and dread and regret and everything. ... That to me is what the hole is.'

Some of it, she said, she doesn't even fully understand. The point is the experience, and critics and Sundance audiences are already fully on board.

Bronstein, a bit of a cult figure in the film world, made her directorial debut in 2008 at the SXSW festival with "Yeast," which featured a pre-fame Greta Gerwig and was hailed by by New Yorker critic Richard Brody as a "mumblecore classic."

"If I Had Legs I'd Kick You" is only her second feature.

"This is the first time that anybody else has paid for me to make art," Bronstein said. "I'm proud to say that this is the film that came directly from my head to the screen.'

LOS ANGELES: Prosecutors said Friday that they will not file charges against Marilyn Manson after a yearslong investigation of allegations of sexual assault and domestic violence.

Los Angeles County District Attorney Nathan Hochman said the allegations are too old under the law and the evidence is not sufficient to charge the 56-year-old shock rocker whose legal name is Brian Warner.

"We have determined that allegations of domestic violence fall outside of the statute of limitations, and we cannot prove charges of sexual assault beyond a reasonable doubt," Hochman said. "We recognize and applaud the courage and resilience of the women who came forward to make reports and share their experiences, and we thank them for their cooperation and patience with the investigation.'

Nearly four years after the investigation began, then-District Attorney George Gascón said on Oct. 9 that his office was pursuing new leads that added to the "already extensive" file that authorities had amassed.

LA County sheriff's detectives said early in 2021 that they were investigating Manson for incidents between 2009 and 2011 in West Hollywood. where Manson lived at the time. The probe included a search warrant that was served on his West Hollywood home. The case was initially turned over to prosecutors in September 2021, but the Los Angeles County District Attorney's Office requested more evidence-gathering and the investigation resumed. (AP)

NEW YORK: US reality TV couple Heidi Montag and Spencer Pratt are suing the city of Los Angeles after losing their Pacific Palisades home in the wildfires that have torn through Southern California in recent weeks.

The couple, who rose to stardom on "The Hills," a spin-off of "Laguna Beach," filed the lawsuit on Tuesday along with more than 20 other property owners and residents who were affected by the Palisades Fire, according to The Associated Press.

The complaint blamed Los Angeles and its municipal water department for the water issues that hampered fire-fighting efforts and said it ultimately led to the damage to their properties.

The Eaton and Palisades fires, ignit ed by strong winds during one of the region's driest years on record, have killed 28 people and destroyed more than 12,000 structures, putting them among the most destructive fires in California history. (Xinhua)

Actor brings depth to dark roles

'The Brutalist' doesn't work without Pearce

NEW YORK, Jan 26, (AP): Over the years, Guy Pearce has been good in most all things. But he's been particularly good at playing characters with a refined disposition who harbor darker impulses underneath.

That was true of his breakout performance in "L.A. Confidential" as a squeaky-clean police detective whose ambitions outstrip his ethics. It was true of his dashing upper-class bachelor in "Mildred Pierce." And it's most definitely true of his mid-Atlantic tycoon in "The Brutalist."

"I'm really aware of how precarious we are as human beings," Pearce says. "Good people can do bad things and bad people can do good things. Moment to moment, we're trying to just get through the day. We're trying to be good. And we can do good things for ourselves and other people, but pretty easily we can be tipped off course.³

That sense of duality has served Pearce's characters well, especially his men of class who turn out to have less of it than they seem. His Harrison Lee Van Buren in "The Brutalist" may be Pearce's most colossally two-faced concoction yet. If Brady Corbet's film, which was nominated for 10 Oscars on Thursday, is one of the best films of the year, it's Pearce's performance that gives the movie its disquieting shiver.

Pearce's Van Buren is a recognizable kind of villain: a well-bred aristocrat who, at first, is a benevolent benefactor to Adrien Brody's architect László Tóth. But what begins as a friendship - Tóth, a Holocaust survivor is nearly destitute when they meet - turns increasingly ugly, as Van Buren's patronage, warped by jealousy and privilege, turns into a creeping sense of ownership over Tóth. The psychodrama eventually boils over in a grim, climactic scene in which Van Buren pronounces Tóth "just a lady of the night."

"What was great to discuss with Brady is that he is actually a man of taste," said Pearce in a recent interview. "He's a man of class and a man of sophistication. He's not just a bull in a China shop. He's not just about greed, taking, taking, taking. It's probably as much of a curse as anything that he can recognize beauty and he can recognize other people's artistry."

For his performance, the 57-year-old Pearce on Thursday landed his first Oscar nomination - a long-in-coming and perhaps overdue honor for the character actor of "Memento," "The Count of Monte Cristo" and "The King's Speech." For the Australian-born Pearce, such recognitions are as awkward as they are rewarding. He long ago decided Hollywood stardom wasn't for him.

"I get uncomfortable with that, to be honest," he says. "I'm really happy with doing a good performance. I can genuinely say within myself I've done a good job. Equally, I know when I've done a (bad) job. But I'm also well aware of how a performance can appear good purely because of the tone of the film. I might have done exactly the same performance in another movie with not such a good director, and people might have gone, 'That was full-on but whatever.' Whereas in this film, we are all better than we actually are because the film has integrity to it that elevates us all."

Like F. Murray Abraham's Saleri in "Amadeus," Peace's Van Buren has quickly ascended the ranks of great cinema villains to artists. The character likewise has some basis in reality, albeit extrapolated from a much different time and place. Corbet and Mona Fastvold, who are married and wrote "The Brutalist" together, were fueled by their hardships with financiers on their previous film, 2018's "Vox Lux."

Complicated

"We didn't have a Van Buren but we certainly had our fill of complicated relationships with the people who hold the purse strings," says Fastvold. "There's a sense of: I have ownership of the project because I'm paying for it, and I almost have ownership of you.

Pearce has been around the movie business long enough to shake hands with plenty of wealthy men putting money toward a film production. But he says none of his own experiences went into "The Brutalist."

'There's always this slew of producers at a higher level than us who come and visit the set," Pearce says. "I'm polite and I go, 'Hi, nice to meet you. Thanks.' But I'm a little caught up with what I'm doing. Then three years later you'll meet someone who says, 'You know, I was a producer on "L.A. Confidential."' Ah, were you?"

Pearce, who lives in the Netherlands with his partner, actor Carice van Houten, and their son, has generally kept much of Hollywood at arm's length. In conversation, he tends to be chipper and humble - more interested in talking Aussie rules football than the Oscar race. "Any chance to have a kick, I'll have a kick," he says with smile.

That youthful spirit Pearce tends to apply to his acting as well. Pearce, who started performing in the mid-'80s on the long-running Australian soap opera "Neighbors," doesn't like to be precious about performing.

"If I'm hanging on to it all day, it's exhausting," Pearce says. "The thing that still exists for me is using our imagination, which is kind of a childlike venture. I think there's something valuable about that even as adults. I think you can be all ages at all times."

Pearce compares receiving the script from Corbet to "The Brutalist" to when Christopher Nolan approached him 25 years ago. Both times, he went back to watch the director's earlier films and quickly decided this was an opportunity to pounce at.

In digging into Van Buren, Pearce was guided less by reallife experience than the script. The hardest entry way to the character, he says, was the voice. "Thankfully," Pearce says, "I'm friends with Danny Huston and he's got a wonderfully old-fashioned voice." He and Corbet didn't speak much about the director's hardships on "Vox Lux."

"I know that it was troubled. Brady is going to have trouble on every film he makes, I reckon, because he is such a visionary," says Pearce. "I know on this there were producers trying to get him to cut the time down. Of course, all those producers now are going, 'I was with him all the way.

To a certain degree, Pearce says, he doesn't fully understand a performance while he's doing it. He's more likely to understand it fully afterward while watching. Take that "lady of the night scene." While filming, Pearce felt he was saying that line to put Tóth in his place. "But when I watched it, I went: 'I'm just telling myself. I'm purely telling myself," he says. "There's something even more distasteful about it."

It's ironic, in a way, that Van Buren, a man bent on control, is played so indelibly by an actor who seeks to impose so little of it, himself.

"There's a performative element to Van Buren. He exhausts himself because he's trying to dominate, to be the one in charge, be Mr. Charming," Pearce says. "I don't think he can ever enter a room without being self-conscious. That's an exhausting way to be, I reckon.'

'Not Alone Anymore' earns tears, applause at Sundance

Matlin gets honest about life as a deaf actress

PARK CITY, Utah, Jan 26, (AP): Marlee Matlin gives an unflinchingly honest account of her experiences as a deaf actor in the funny and revelatory documentary "Marlee Matlin: Not Alone Anymore." The film kicked off the 41st Sundance Film Festival Thursday, as the first major premiere in the Eccles Theater in Park City, Utah.

After the screening audiences in the theater, some wiping tears away, greeted Matlin with a standing ovation when she took the stage.

The film delves into all aspects of her life, personal and professional: Her childhood and how her family handled learning she had become deaf at 18 months; her experience winning the best actress Oscar for her first movie role in "Children of a Lesser God" and her allegedly abusive romantic relationship with her co-star, the late William Hurt, which he denied; and her experiences in an industry not equipped to accommodate deaf actors.

The film was directed by Shoshanna Stern, who also is deaf. Matlin specifically requested that Stern take on the project when American Masters approached her about doing a documentary. Matlin has written about her experiences before, including her volatile relationship with Hurt and drugs, in a memoir, "I'll Scream Later." But before the #Me-Too movement, she felt her allegations were largely dismissed or glossed over.

Interviews from the book's press tour show journalists were more interested in the "amazing sex" she said she had with Hurt than the stories of the alleged physical and verbal abuse. One interviewer asked her why she waited "so long" to come forward with the claims.

The documentary isn't just a portrait of Matlin, but a broader look at deaf culture and how Matlin was thrust into the spotlight at a young age as a de facto spokesperson for all deaf causes.

In addition to being the first, and until Troy Kotsur won for "CODA" in 2022, only deaf actor to win an Academy Award, she helped lobby Congress for closed captioning and delved into the Gallaudet University protest about hiring hearing people to preside over the university, which is the subject of another Sundance documentary, "Deaf President Now!"

Matlin also faced backlash when she spoke while

presenting the best actor Oscar the year after she won, an experience that she said made her distance herself from deaf causes.

It features moving interviews from her longtime translator and other important figures in her life such as Henry Winkler, who met her when she was a student at age 12.

Winkler watched her perform a song during a school production after she wrote him a fan letter. Later, she stayed in his home for two years after her breakup with Hurt and had her wedding there. In the film, Matlin said she never would have pursued acting if it weren't for Winkler, although he disagreed.

The film is closed captioned and includes verbal translations for hearing audiences. In a unique approach, the subjects were interviewed by Stern with an earpiece, allowing them to hear translations from another room.

Matlin said she has struggled occasionally to convince the industry to let her play roles that aren't necessarily written for a deaf actor. Aaron Sorkin, who wrote a part for her in "The West Wing," dispelled the notion it is difficult to write for deaf actors.

PORTLAND, Ore.: A resident of the central Oregon city of Bend says he was the person behind some of the googly eyes that appeared on sculptures around the city in recent months and sparked a viral sensation widely covered by news outlets.

Jeff Keith, founder of a Bend-based nonprofit called Guardian Group that works to combat human trafficking, said Friday that he used duct tape to attach googly eyes to two sculptures. He said he has carried out similar pranks on other Bend sculptures before - such as adorning them with hula skirts and leis - and that they serve as a respite from the emotional toll of his work.

"It is a place for me to cope with some pretty heavy stuff," he told The Associated Press, noting that many of the trafficking victims he has worked with have been through "unimaginable trauma."

The city shared photos of the googly eye installations on social media in early December, saying the adhesives can damage the art. One photo shows googly eyes placed on a sculpture of two deer - which Keith described as his handiwork - while another shows them attached to a sphere. City officials at the time said eight sculptures were affected and that it cost \$1,500 to remove the googly eyes. (AP)

AUCKLAND, New Zealand: The Symphony Kukai has been staged in Auckland, New Zealand's largest city, showcasing the life of Kukai, a prominent symbol of cultural exchange, through a moving musical performance by both Chinese and New Zealand musicians.

In his speech before the Friday performance, Auckland Mayor Wayne Brown said that he is delighted to see this event bringing together cultures in such a positive way and taking place in Auckland.

Zhou Li, cultural consul of the Chinese consulate general in Auckland, noted in his remarks that Kukai serves as an exemplary figure of mutual learning between civilizations. Today, when China is promoting the Global Civilization Initiative, it is believed that civilization is colorful because of exchange and civilization is enriched by mutual learning, said Zhou.

Symphony Kukai, composed by renowned Chinese composer Zou Ye, was presented in the Southern Hemisphere for the first time. Conducted by British maestro Derek Morgan, the Auckland Philharmonia performed the symphony, joined by the choir of Central Conservatory of Music from China and the choir from the Music Association of Auckland. At Paris show, Hermes menswear has a dash of jockey-style boldness

PARIS, Jan 26, (AP): Hermes illuminated a gloomy Paris afternoon with its fall men's collection Saturday, as Veronique Nichanian turned to the racetrack for inspiration. Jockeys' vibrant racing silks became her muse, a dynamic counterpoint to the French maison's storied equestrian roots. "I wanted this collection to be strong and energetic," Nichanian explained, her palette pivoting from deep browns and dark teals to flashes of tomato red and lemon yellow.

The collection radiated warmth, both in spirit and texture. Fuzzy mohair coats, velvet varsity jackets and plush sheepskin outerwear

wrapped models in an embrace that seemed designed to counter winter's chill. Layering was less pronounced this season, a deliberate move to retain sleek, streamlined silhouettes. Even gray pinstripe suits - pared back to essentials - eschewed bulk, echoing Nichanian's vision of men unencumbered as they race through life.

Sweaters emerged as the collection's unsung heroes. Their bold chevrons and geometric patterns were lifted directly from the vibrant stripes of racing silks, a playful nod to Palais d'Iéna's soaring, angular architecture. A standout turtleneck, with its patchwork of triangles, rectangles, and squares in canary yellow, seemed to channel a nostalgic love for trigonometry. Elsewhere, a jacket with a shawl collar mirrored the same graphical bravado, rendered in cool tones of blue, black and white.

Though grounded in classic tailoring, the collection celebrated irreverence. Nichanian's juxtaposition of tradition and innovation captured Hermès' ethos with a quiet confidence. Here, functionality was imbued with a touch of whimsy, proving once again that the maison's refinement can still surprise and delight. In a season steeped in nostalgia and geometry, Hermès delivered a collection that was, quite literally, off to the races.

British Museum partially closed after sabotage

Paul McCartney says he fears AI will rip off artists

LONDON, Jan 26, (AP): **Paul McCartney** urged the British government not to make a change to copyright laws that he says could let artificial intelligence companies rip off artists.

The government is consulting on whether to let tech firms use copyrighted material to help train artificial intelligence models unless the creators explicitly opt out.

McCartney told the BBC that would make it harder for artists to retain control of their work and undermine Britain's creative industries.

"You get young guys, girls, coming up, and they write a beautiful song, and they don't own it, and they don't have anything to do with it. And anyone who wants can just rip it off," the 82-year-old former Beatle said in an interview to be broadcast Sunday. An extract was released Saturday by the BBC.

"The truth is, the money's go-

ing somewhere. When it gets on the streaming platforms, somebody is getting it, and it should be the person who created it. It shouldn't be some tech giant somewhere."

Britain's center-left Labour Party government says it wants to make the UK a world leader in AI. In December, it announced a consultation into how copyright law can

"enable creators M and right holders

to exercise control over, and seek remuneration for, the use of their works for AI training" while also ensuring "AI developers have easy access to a broad range of high-quality creative content."

Publishers, artists' organizations and media companies, including The Associated Press, have banded together as the Creative Rights in AI Coalition to oppose weakening copyright protections.

"We're the people, you're the government. You're supposed to protect us. That's your job," McCartney said. "So you know, if you're putting through a bill, make sure you protect the creative thinkers, the creative artists, or you're not going to have them."

The British Museum, the country's most popular tourist attraction, was partially closed to the public on Saturday after an employee who had been fired broke in and shut down computer systems, museum management said. The museum in central London, which attracts almost 6 million visitors a year, closed its temporary exhibitions and part of its permanent collection after the alleged attack on Thursday.

"An IT contractor who was dismissed last week trespassed into the museum and shut down several of our systems," the museum said in a statement on Friday. "Police attended and he was arrested at the scene.

"We are working hard to get the museum back to being fully operational but with regret our temporary exhibitions have been closed today and will remain so over the weekend - ticket holders have been alerted and refunds offered."

The Metropolitan Police force said officers were called on Thursday evening "to reports that a man had entered the British Museum and caused damage to the museum's security and IT systems." It said a man in his 50s was arrested on suspicion of burglary and criminal damage. He has been released on bail while inquiries continue.

The 266-year-old museum has had a rocky few years. It is still trying to track down some of more than 1,800 objects believed to have been stolen by a former curator and offered for sale online. **Peter Higgs**, who worked in the museum's Greece and Rome department for 30 years, was fired in July 2023 and is being sued by the museum. He denies the allegations.

Museum director **Hartwig Fis**cher resigned in August 2023, acknowledging the institution's management failed to heed warnings that artifacts including gold jewelry, semi-precious gems and antiquities dating to the 15th century B.C. were being stolen from its collection and sold on eBay.



Some health benefits of light therapy may be overhyped

Red light therapy effective for pain relief, inflammation

Red light therapy is increasingly viewed as a promising treatment for wrinkles, acne, psoriasis, scars and sun-damaged skin, and as a supportive therapy for some kinds of cancer. But does red light therapy live up to the hype that it's practically a panacea for all sorts of ailments?

Treatment with red light therapy involves exposure to red light at a very low dose in a hospital or clinic. It's also called low-power laser therapy, soft laser therapy, cold laser therapy and nonthermal LED light therapy.

The umbrella term is called photobiomodulation therapy, which covers other colors, or wavelengths, that have health benefits. These light wavelengths span the visible to the near-infrared spectrum.

Red light is easily the most popular of the photobiomodulation therapies. That's primarily due to its availability - the treatment has been around more than three decades

While it's true that other colors are also clinically and commercially available, researchers are still studying them to determine exactly how effective they are. That said, green light therapy is generally used to treat migraines; yellow light for depression; and blue light to kill resistant strains of bacteria, like MRSA infections, and to treat seasonal affective disorder, a depression that typically onsets in late fall and continues through winter.

Put simply, red light stimulates the cells in your body, energizing them while initiating blood flow to the affected area. That, in turn, spurs healing, similar to how your body responds to a cut by clotting the blood to heal a wound.

The treatment is simple and painless. The patient, either seated or lying comfortably, is exposed to the red light for three to 15 minutes. They may experience a feeling of warmth during treatment, but it should not be uncomfortable or hot. The clinician will likely recommend eye shields.

Used correctly, red light therapy is very safe. Overdosing - staying under the light too long or receiving treatments at very high power - does not necessarily cause harm, but it might reduce or slow benefits. However, just as some people are more prone to sunburn than others, some patients may be more sensitive to this light and might see redness in the skin. Those patients should receive lower light doses during treatment.

Diseases

Randomized, controlled clinical trials show that red light therapy can reduce pain, inflammation and tissue damage. Because all of these things are prevalent in many illnesses, photobiomodulation may be a powerful adjunct for treating a wide range of diseases

One example is cancer. There's now strong evidence that red light therapy can lessen pain and inflammation from radiation, chemotherapy and bone marrow stem cell transplants. Red light therapy has also reduced other complications from cancer treatment, including oral ulcers, scars and fibrosis.

Other recent human clinical studies show that photobiomodulation helps heal diabetic and burn wounds, as well as some types of ulcers. However, this therapy should not replace good wound care treatment, such as disinfection. Photobiomodulation has also worked for patients with neck and back pain and tennis elbow.

Although not proven to be effective by randomized controlled trials with large samples, which is the gold standard of research, red light therapy has been shown to benefit patients with Parkinson's, Alzheimer's, multiple sclerosis, fibromyalgia. arthritis, macular degeneration, myopia and autism in clinical case reports and lab research studies

A word of caution, however: Red light therapy may not work for all the medical conditions that proponents say it does. Red light therapy is also used for cardiovascular health, elevating mood, relieving anxiety, improving muscle performance and recovery from sports injuries, and providing anti-aging benefits to the skin. While there's some evidence to support these types of treatments, rigorous research studies are still missing.

This is a rapidly evolving field. Both LED and laser devices - beds, lamps, helmets and face masks - are readily available in clinical and nonclinical settings, such as medical spas, gyms and beauty salons. They're also available for at-home use.

Laser devices are more powerful and are typically found at a hospital, clinic or doctor's office. An LED, or light-emitting diode, is less powerful and more often used in commercial or home settings.

The general consensus is that LEDs are OK to use in commercial establishments like beauty salons and medical spas, provided practitioners receive the appropriate training. But the use of laser devices should be relegated to clinical specialists. That's because lasers, in untrained hands, have the potential to do more damage than LEDs.

As for some home products, their quality and reliability may be questionable; they might not meet minimum quality standards of output power or wavelength.

The U.S. Food and Drug Administration appears to be moving toward more rigorous evaluations of these products, especially with lasers, but there is a critical need for a certifying agency or body to take this on. These agencies would test the devices to make sure they're actually meeting specifications. That hasn't happened yet, but as it stands now, several scientific and professional organizations are exploring the possibilities. (AP)

Here's a primer, with a caveat

Which style of yoga is right for me?

NEW YORK, Jan 26, (AP): To some people, the word "yoga" evokes ritualistic chanting, long breaths and slow movement. To others, it means contorting your body into ever more complicated positions until sweat drips onto the mat.

In reality, it can be both - with a lot of variation in between. It depends on the teacher, who could be trained in several of numerous yoga styles: hatha, vinyasa, Iyengar, ashtanga, yin and more

Though all styles involve poses (asanas), they differ in significant ways. Even classes within the same style can range from calming to vigorous.

So what is the best type of class for a beginner?

"The best is the one that works for you," said Tim Senesi, who has been teaching yoga in Orange County, California, for 22 years. "There are many different paths leading toward the same aim

Here's a primer on some of the most popular styles, followed by a big caveat.

The term "yoga," which is derived from the Sanskrit for "union," actually encompasses an entire discipline that includes movement, meditation and lifestyle. Hatha, meaning "force," technically is any kind of yoga class involving asanas. If you've ever heard of a sun salutation, for instance, that is a foundational sequence of 12 asanas that begin many types of classes.

When it comes to classes listed as hatha, however, they generally are gentler with more focus on breathing

exercises (pranayama). Poses are held for a few breaths and students usually move more slowly.

Hatha can be good for beginners who are looking to relax while improving flexibility and balance.

Another style, yin, is even more focused on recovery by working to stretch the muscles' connective tissue. Students hold poses for 5 minutes or more, allowing the body to settle into a pose rather than pushing it.

A more vigorous, flowing form of yoga, vinyasa coordinates movement with breath over a progression of asanas. Some higher-level vinyasa classes move at a pace of one movement per breath.

Often they will be called Flow or

Power classes. They can be appropriate for people who are more athletic, but teachers still recommend that those students start with a beginner level.

"I wouldn't really encourage them to start in a higher level vinyasa flow class because they're not going to have the foundation to move safely through that," said Anne Van Valkenburg, of Lanai, Hawaii, who has been training yoga teachers in a blend of styles for 18 years

Another style, ashtanga, is similar except that it involves a set series of poses that students repeat day after day, often going at their own pace. As students get stronger, they advance to a higher series with more challenging poses, something akin to belt levels in martial arts

This style involves the same poses as vinyasa but classes usually move at a slower pace - although they are not necessarily easier. The focus is more on precisely aligning parts of the body through small adjustments. Poses are held for longer and students rely more often on props including cushions, blocks or straps.

Iyengar is particularly good for people recovering from injuries, or for people who are already active but want to get the foundation of yoga before moving into different styles.

These days, most teachers blend various styles in their classes, and many classes aren't billed with these terms. The few words describing the class should give you an idea of what to expect, but don't be afraid to ask questions at the studio or reach out to individual teachers.

High food insecurity, housing struggles

Women's cancer testing declines globally

DAVOS, Switzerland, Jan 26, (AP): Women's cancer testing has declined globally, according to the latest Hologic Global Women's Health Index, one of the largest collections of data on women's health and well-being.

Hologic, Inc., a leading women's health innovator, partners with Gallup to create the Index. Now in its fourth year, the Index raises new concerns about declining trends in women's health. For the first time in the history of the Index, women's cancer testing declined: Only 10% of women surveyed worldwide said they were tested for any type of cancer in the past year, down two percentage points from the first two years of the Index. This year's Index will be released recently during an event convened by Goals House, a community focused on driving progress toward the United Nations (UN) Sustainable Development Goals (SDGs) alongside the World Economic Forum in Davos, Switzerland. The event will feature a panel including Dr. Natalia Kanem, Executive Director of the United Nations Population Fund (UNFPA), Dr. Sania Nishtar, CEO, Gavi, The Vaccine Alliance and Elissa Miolene, Global Development Reporter, Devex.

"Today's data reveal a worsening trend in women's health," said Stephen P. MacMillan, Chairman, President and CEO of Hologic. "The shocking decline in cancer testing is a wake-up call. Business as usual is not working. Innovative strategies and collaborative efforts are needed to make sustained improvements in women's health and well-being around the world."

Key findings from this year

Ongoing physical pain and health issues: 34% of women reported experiencing significant pain the previous day, while 26% indicated that health problems impacted their ability to engage in everyday activities.

■ HIV testing rates for women are alarmingly low: The Index assessed women's HIV testing for the first time and found concerning disparities: Less than 0.5% of women were tested in certain countries, primarily those in the Middle East and North Africa, and no country scored above 41%. Globally, the percentage is much lower. Just 6% of women - regardless of whether they visited a healthcare professional or were tested for STIs - said they were tested for HIV in the past year.

People with ADHD die earlier than peers

NEW YORK, Jan. 26, (Xinhua): A study of more than 30,000 British adults diagnosed with attention deficit hyperactivity disorder (ADHD) found that, on average, they were dying earlier than their counterparts in the general population -- around seven years earlier for men, and around nine for women.

The study, which was published on Thursday in The British Journal of Psychiatry, is believed to be the first to use all-cause mortality data to estimate life expectancy in people with

"Previous studies have pointed to an array of risks associated with the

condition, among them poverty, mental health disorders, smoking and substance abuse," reported The New York Times on the development. The authors cautioned that ADHD is

substantially underdiagnosed and that the people in their study, most of them diagnosed as young adults, might be among the more severely affected.

Mongolia has so far vaccinated at

least 20,682 children aged 11 against human papillomavirus (HPV) as part of a nationwide campaign, according to a report released on Friday by the National Center for Communicable Diseases (NCCD).

Launched in November 2024, the vaccination campaign aims to combat cervical cancer, a significant public health concern in the country.

Hospitals nationwide are offering free HPV vaccines to 11-year-old girls and boys, provided parental or guardian consent is obtained.

■ Cancer screening among women de-clined: Only 10% of women said they underwent any type of cancer testing in the past year, reflecting a decrease of two percentage points from the first two years of the survey.

■ Women are struggling more to meet basic needs: A staggering 38% of women reported being unable to afford food at some point in the past year, marking the highest level of food insecurity in nearly two decades. And 32% of women said they could not afford adequate shelter.

More women are worried and sad: More women reported feeling worried (42%) and sad (30%) compared to Year 1 of the Index. And over one third (35%) said they felt unsafe in their communities.



Rockets beat East-leading Cavaliers for second time in week

SAN FRANCISCO, Jan 26, (AP): Anthony Davis had 36 points and 13 rebounds, LeBron James added 25 points and 12 assists, and the Los Angeles Lakers beat the Golden State Warriors 118-108 on Saturday night.

Andrew Wiggins led the Warriors with 20 points. The Lakers held Stephen Curry scoreless in the second half as he went 0 for 8 from the field after halftime. Curry finished with 13 points and nine assists.

The game marked the 25th regular-season meeting between James and Curry. James' team has won 13 of the 25.

Los Angeles improved to a season-best seven games over .500 at 25-18. The Lakers have won three in a row and five of their past six games.

Golden State fell a game under .500 at 22-23. With forwards Draymond Green (calf strain) and Jonathan Kuminga (sprained ankle) still sidelined, Golden State is in a rough stretch.

Chock, Bates match ice dance record with sixth national title

WICHITA, Kan., Jan 26, (AP): Madison Chock and Evan Bates have been the best American ice dancers for years.

Best in the world, too.

They only served to underscore that fact on Saturday, when they won their fourth consecutive title at the U.S. Figure Skating Championships and their sixth overall, matching the record held by longtime standard-bearers Meryl Davis and Charlie White.

Chock and Bates followed up their sublime rhythm dance with a winning free dance, totaling 223.52 points to easily outdistance second-place Christina Carreira and Anthony Ponomarenko. Caroline Green and Michael Parsons finished third.

"It means honestly the world," Bates said. "The U.S. championships is always an event that we hold near and dear to our hearts. I think it's because it's the competition that we grew up coming to every January, watching every year on TV as kids. It's what made us fall in love with the sport. There's something incredibly magical about this event."

Earlier in the day, two-time defending U.S. champion and reigning world champion Ilia Malinin scored 114.08 points for his short program to take a big lead into Sunday's free skate. Andrew Torgashev was 20 points back in second and Jimmy Ma in third.

In the pairs competition, Alisa Efimova and Misha Mitrofanov managed to hold their free skate together while their biggest rivals collapsed, allowing them to do one better than their silver medal from a year ago and stand atop the podium Saturday night.

Efimova and Mitrofanov scored 211.90 points for their program, set to "Je Suis Malade" by Serge Lama. Katie McBeath and Daniil Parkman also took advantage of mistakes by defending champs Ellie Kam and Danny O'Shea and 2023 runner-ups Emily Chan and Spencer Howe to capture the silver medal after a marathon day at IN-TRUST Bank Arena.

O'Shea and Kam erred on nearly every big element - their triple toe loops, throw triple lutz and throw triple toe loop. Their triple salchow into an axel was deemed invalid, and they got no points at all for a final lift on which both skaters fell. Kam and O'Shea wound up

third with 189.57 points. Chan and Howe were fourth with 183.95.

Chock, who was dealing with a food-related stomach bug all week, nevertheless joined Bates in a rollicking rhythm dance set to music from the 1950s, '60s and '70s with her longtime partner on Friday night. Chock and Bates had 92.16 points, putting them nearly 10 points clear of second-place Carreira and Ponomarenko heading into the free dance

With Chock still dealing with her illness Saturday, they still managed to pad their lead, and confirm their status as favorites not just for the upcoming world championship in Boston but also the 2026 Winter Olympics in Italy.

"Maddie has had a tough couple of days. Wasn't really able to fuel much," Bates said. "She's so tough. She's never not going to go out there and not give it her best. It took all the little energy that she had. I just tried to give the love and support to her."

Carreira and Ponomarenko finished with 210.79 points for their second consecutive silver medal, while Green and Parsons took bronze after they had been tied on 82.13 points with Emilea Zingas and Vadym Kolesnik after the rhythm dance.

In the men's short program, the 20-year-old Malinin did exactly what he's become known for: nailing quads. He opened with a quad flip, breezed through a triple axel, then hit a quad lutz in combination with a triple toe loop.

Australia ends home rugby sevens title drought

PERTH, Australia, Jan 26, (AP): Australia edged New Zealand 28-26 in another sensational women's rugby sevens final and won its first title at home in seven years on Sunday

In 2018, Australia won the women's and men's titles in Sydney but couldn't repeat the Australia Day feat in Perth.

The men were thrashed in the final by defending champion Argentina 41-5.

Gut-Behrami gets first World Cup win of season

GARMISCH-PARTENKIRCHEN Germany, Jan 26, (AP): Swiss ski star Lara Gut-Behrami has finally found a way back to winning ways, with next month's world championships looming.

The defending overall World Cup champion overcame challenging course conditions Sunday to win the last super-G before the worlds for her first victory of the season, while Lindsey Vonn placed 13th.

podiums at a super-G in Garmisch-Partenkirchen four years ago.

Federica Brignone was three-hundredths further back in third, a day after the Italian won the downhill on the same hill.

Sofia Goggia, who was runnerup to Brignone in Saturday's race, placed fourth, ahead of teammates Laura Pirovano and Marta Bassino, as the Italian team finished with four racers in the top six.

Keely Cashman shared sixth place with Bassino for the American's career-best result.

Vonn finished 1.4 seconds off the

pace in 13th, just behind her American teammate Lauren Macuga, after failing to finish her previous two races. The American standout skied out of Saturday's downhill when she missed a gate, but avoided falling.

Vonn returned to ski racing in December after nearly six years of retirement with a new titanium knee. Last week, Vonn told The Associated Press that she plans to retire again after next year's Milan-Cortina Olympics.

Last year, Gut-Behrami overtook leader Mikaela Shiffrin in the overall standings in the last two months

of the season when the American five-time champion was out nursing a knee injury.

The Swiss skier then had a slow start to the new campaign after missing the season-opening race in October. However, the defending overall champion then racked up three second places in Super-G before winning Sunday.

"It's been a weird start of the season, obviously I was struggling a lit-tle bit," Gut-Behrami said. "I had to find the confidence back, the way to push in the skis again.'

Gut-Behrami has now won at least one World Cup race in 11 of the past 12 seasons, with 2018-19 the only exception. She closed the gap to leader Brignone in the overall season standings to 70 points.

Shiffrin has been out for two months with an abdominal injury that required surgery, but the American is expected to race again in a night slalom in France on Thursday, the final women's race before the worlds.

The start of Sunday's race was delayed for 15 minutes as organizers needed more time to prepare the course after overnight snowfall and rain in the hours leading up to the race.

Ariane Raedler had a nasty tumble when she came off the course and lost balance over a patch of softer snow, but the Austrian got up quickly and appeared to have avoided injury.

Kamil scored one of the team's goals in that match. Additionally, Tunisian forward Yassin Al-Khenisi has been dealing with muscle strain and was rested from training to prevent further aggravation.

Sinner dominates Zverev to secure Mbappé scores first back-to-back Australian Open titles hat trick for Madrid



BARCELONA, Spain, Jan 26, (AP): Kylian Mbappé tucked the ball under his shirt as he raised both hands to return the applause to the Real Madrid fans who savored his first hat trick for his new club.

The France star had just led a 3-0 victory at struggling Valladolid , keeping it in position to retain the title just after the midway point of the campaign.

Gone was the inconsistent play and missed penalties from Mbappé during his first months with Madrid following his move from Paris Saint-Germain. The France captain has started pouring in goals with back-to-back multi-goal games and has Madrid in pole position with Atletico Madrid and Barcelona stalled.

"I'm very happy for the hat trick but even happier for the win," Mbappé said in fluent Spanish. "It was very important to win after Atletico's result because that gave us a bit more pressure to take advantage of it.'

Madrid's fourth straight triumph in the league combined with Atletico Madrid's 1-1 draw with Villarreal let Carlo Ancelotti's side open a four-point gap over its city rival.

Madrid trailed then-leader Barcelona at one point, but since getting blown away in a 4-0 clasico debacle, it has found its stride and is in championship mode

"My adaptation to the team is over. I feel comfortable on the field and you can see that from the way I am playing with my teammates," Mbappé said. "This gives us confidence, but you know that until the 38th round this is not

Italian extends record-breaking run

MELBOURNE, Australia, Jan 26, (AP): There's all sorts of ways beyond merely the score to measure just how dominant Jannik Sinner was while outplaying and frustrating Alexander Zverev during the 6-3, 7-6 (4), 6-3 victory Sunday that earned the 23-year-old Italian a second consecutive Australian Open championship.

The zero break points Sinner faced. Or the 10 he accumulated. The 27-13 advantage in points that lasted at least nine strokes. Or the way Sinner accumulated more winners, 32 to 25, and fewer unforced errors, 27 to 45. The way Sinner won 10 of the 13 points that ended with him at the net. Or the way he only let Zverev go 14 of 27 in that category, frequently zipping passing shots out of reach.

Well, here's is one more bit of evidence: what Zverev said about Sinner.

High praise from a guy who is, after all, ranked No. 2. Sinner has held the No. 1 spot since last June and is not showing any signs of relinquishing it. This was the first Australian Open final between the men at No. 1 and No. 2 since 2019, when No. 1 Novak Djokovic defeated No. 2 Rafael Nadal - also in straight sets.

The "things" include being the youngest man to leave Melbourne Park with the trophy two years in a row since Jim Courier in 1992-93, and the first man since Nadal at the French Open in 2005 and 2006 to follow up his first Grand Slam title by repeating as the champion at the same tournament a year later.

Sinner was asked later whether he felt more relief or excitement when he raised his arms after the last point was his.

Go to the start of 2024, and take stock. In that span, Sinner has won three of the five major tournaments, including the U.S. Open in September, meaning he now has claimed three straight hard-court Slams. His record is 80-6 with nine titles. His current unbeaten run covers 21 matches.

The only thing that's clouded the past 12 months for Sinner, it seems, is the doping case in which his exoneration was appealed by the World Anti-

Doping Agency. He tested positive for a trace amount of an anabolic steroid twice last March but blamed it on an accidental exposure involving two members of his team who have since been fired. Sinner initially was cleared in August; a hearing in the WADA appeal is scheduled for April.

While he became the eighth man in the Open era (which began in 1968) to start his career 3-0 in Grand Slam finals, Zverev is the seventh to be 0-3, adding this loss to those at the 2020 U.S. Open and last year's French Open.

Those earlier setbacks both came in five sets. This contest was not that close. Not at all.

Just before Zverev began speaking into a microphone during the trophy ceremony, a voice cried out from the stands, making reference to two of the player's ex-girlfriends who accused him of physical abuse.

During the match, there truly was only one moment that contained a hint of tension. It came when Zverev was two points from owning the second set at 5-4, love-30. But a break point - and a set point - never arrived.

A year ago, Sinner went through a lot more trouble to earn his first major, needing to get past Novak Djokovic - who quit one set into his semifinal against Zverev on Friday because of a torn hamstring - before erasing a twoset deficit in the final against 2021 U.S. Open champion Daniil Medvedev.

The game between the front-runner and the bottom side fit its billing as a mismatch.

Valladolid could draw only one save from Thibaut Courtois in the opening moments. It was all Madrid the rest of the way even though Vinícius Júnior didn't play as he completed a two-game suspension.

Mbappé swept in Madrid's first goal on the half-hour mark after a flowing team attack of quick passes to weave the ball through a packed Valladolid area that culminated in Jude Bellingham's assist for the France star.

He made it a double in the 57th by finishing off a three-against-two counterattack after Federico Valverde intercepted a Valladolid pass. Mbappé took a pass by Rodrygo and rifled in a low strike from the left side of the box.

Valladolid finished with 10 men after Mario Martín got a second booking in the 90th for a foul on Bellingham, sending Mbappé to the spot for his third.

That made it four games in a row with a goal across all competitions for Mbappé. In La Liga, Mbappé has 15, second only to Robert Lewandowski's 16 for Barcelona. He also scored twice last weekend against Las Palmas in a 4-1 win.

"Mbappé is giving us a lot. He has found his rhythm over the last couple of months and that is obviously a boost for us," Ancelotti said.

Valladolid was five points from safety.

Atletico's stalemate with Villarreal came a week after a shock 1-0 loss at Leganes.

Gerard Moreno, Villarreal's top scorer in club history, made it 120 goals for the Yellow Submarine in the 25th minute after the striker converted a penalty he earned when fouled by Reinildo.

Atletico coach Diego Simeone rested Antoine Griezmann and midfielder Rodrigo de Paul for the first half. Then he made three changes at halftime, sending on De Paul and winger Samu Lino to kickstart his sluggish attack.

The moves paid off as the hosts pressed Villarreal into its box, and Lino rammed in a $5\overline{8}$ th-minute equalizer.

Simeone sent Griezmann on immediately after and the action stayed in Villarreal's area except for two chances for Villarreal's Ayoze Pérez, who replaced Gerard. But Griezmann's header that bounced just wide in the 86th was the closest Atletico came to snatching a winner.
