# Countries flourish and stabilize when their leaders follow up their development

PEOPLE always talk about the national economy, the need to diversify the sources of national revenues, and the search for alternative revenues to strengthen the national product.

We hear a lot of explanations and talks in this regard; yet the core of the issue remains unaddressed either due to a lack of seriousness or the absence of a clear vision, particularly when it comes to the capital cycle and rectifying existing shortcomings. In truth, diversifying income sources is the basis of develop-

However, all our troubles will persist unless we open the taps to allow for well-calculated expenditures. Otherwise, we will remain trapped in a fantasy world filled with slogans and statements that are disconnected from reality. When income sources run dry, the economy begins to suffer from an accumulated deficit, leading to contraction and a decrease in the national product, which negatively impacts

Undoubtedly, strengthening the economy protects the state from many problems and crises, especially if capital is recycled wisely.

To better understand how expenditure can drive national economic growth, the following story about a concept known as Quantitative Easing (QE) could perhaps be useful:

In a small, struggling town that was facing severe economic difficulties, everyone was drowning in debt and relying on borrowing.

One day, a tourist arrived in that town and headed straight to the only modest hotel to book a room. The first thing he did was place \$100 on the reception counter before heading upstairs to inspect the

## 4-hour power cuts to last until Feb 15

KUWAIT CITY, Feb 8: The Ministry of Electricity, Water, and Renewable Energy has announced that maintenance work will be carried out on several power transformer stations across the six governorates, reports Al-Seyassah daily. As a result, 26 areas will experience partial pow-

er outages, including the Al-Sabah Health Area. The power outage will last for seven days, start-

ing Sunday, February 9, until February 15, from 8:00 am for a duration of four hours each day.

In other news, the Ministry of Electricity, Water, and Renewable Energy signed last Monday a memorandum of understanding with a company to establish a 300-megawatt power generation station under the 'independent supplier' system. This marks the first agreement of its kind in Ku-

wait, allowing the private sector to play a role in energy production and easing the financial burden on the state. However, the agreement has raised concerns among some experts regarding the potential future control of electricity and water pricing by the private sector.

Despite these concerns, there has been positive feedback from experts like former Minister of Electricity and Water Mohammad Bushehri.

KUWAIT CITY, Feb 8: As of the end of 2024, the Kuwaiti population reached 1,567,983, making it the top nationality in the country through an increase of 21,775 (1.3 percent) compared to their population of 1,546,202 at the end of 2023.

According to the latest statistics from the Public Authority for Civil Information (PACI), the Indian community came second with a population of 1,007,961, with an increase of 0.7 percent from approximately 1.000,726 at the end of 2023.

The Egyptian community came in third, with 657,280 at the end of 2024, compared to 644,042 the previous year, with an increase of 2 percent.

In fourth place is the Bangladeshi community which witnessed a rise of six percent. Their population reached 292,810 by the end of 2024, compared to 274,974 in 2023.

KUWAIT CITY, Feb 8: The Ambassador of the Islamic Republic of Iran to Kuwait Mohammad Totonji stated that the relations between the two countries have deep roots stretching back centuries, with Iranian builders playing a major role in the development and modernization of Kuwait.

He expressed hope that, under the leadership of His Highness the Amir Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah and His Highness the Crown Prince Sheikh Sabah Khaled Al-Hamad Al-Sabah, a qualitative leap in their brotherly relations will

# Gold rush fades in Kuwait as prices hit highs

KUWAIT CITY, Feb 8: In 2024, the volume of gold purchases in Kuwait saw a decline of approximately 6.12 percent compared to the previous year, reports Al-Seyassah daily.

The demand for gold in Kuwait dropped to 18.4 tons, down from 19.6 tons in 2023, which had marked the highest level of demand in the last decade.

According to data from the World Gold Council, there was a noticeable decrease in demand for jewelry, which fell to 12.3 tons in 2024, compared to 14.3 tons

On the other hand, demand for gold bullion rose to 6.1 tons in 2024, compared to 5.2 tons the previous

Further insights from the World Gold Council revealed that during the fourth quarter of 2024, Kuwait's demand for gold amounted to about 4.9 tons, an increase from 4.2 tons in the third quarter.

However, the fourth quarter of 2024 showed a slight decrease from 5.1 tons in the same period in 2023. The breakdown of demand in Kuwait during the fourth quarter showed that 1.4 tons were for bullion,

while 3.5 tons were for jewelry.

At the regional level, the demand for gold in the Middle East during the fourth quarter of 2024 increased to 68.4 tons, up from 65.5 tons in the same period of the previous year and 59 tons in the third quarter of 2024

Globally, gold demand in the fourth quarter of 2024 reached 872.5 tons, up from 729.5 tons in the previous quarter but down from 936.1 tons in the fourth quarter

KUWAIT CITY, Feb 8: Minister of Foreign Affairs Abdullah Al-Yahya revealed a plan to hold an Arab summit in Egypt at the end of February or the beginning of March.

Speaking at 'Azayez Farm' recently in the presence of several ambassadors and diplomats, Minister Al-Yahya said, "I do not believe that the issue of displacement is up for discussion at the summit. The right to self-determination belongs to the Palestinian people, and they alone should decide their fate. We continue to support this position in both the Gulf and the Arab world."

He affirmed that the summit will take place in Cairo, based on an agreement among the participating countries.

The minister said, "We support this direction and will continue to do so. However, it will depend on the agreement of all countries involved."

Minister Al-Yahya emphasized that statements from Gulf and Western nations are contrary to the issue of displacement.

He reiterated that the two-state solution stated in the Arab Initiative remains the basic guiding principle.

The minister said, "While the summit is currently being proposed, regional groups may also join the discussions, with details still being worked out."

#### Displacement

Regarding the general stance on the displacement issue, Minister Al-Yahya stated: "All positions are aligned in one direction. We have heard statements from countries through international and global media supporting the Palestinian cause, especially concerning displacement or settlement. All positions are positive for Palestine, and we in Kuwait are moving in the same direction. We are working with both Arab and international partners to uphold what has already been agreed upon".

He affirmed that there are no current communications between Kuwait and the U.S. on this matter.

When asked whether there are strong pressures preventing President Trump from implementing his plan, Minister Al-Yahya said, "The pro-

cess is moving forward positively, and all reactions are in support of the Palestinian cause. We hope that this proposal will be reconsidered, and the results of the ongoing efforts will be evident at the summit. The Arab and international position will be stronger and clearer."

When asked about U.S. President Trump's statements against Iran and if they signal the start of regional calm, he replied, "We are waiting and observing."

Regarding the reopening of the Kuwaiti embassy in Syria, the minister confirmed that the embassy will be reopened soon.

#### Security

He revealed that, "The security situation will dictate the timing of the decision. We have no reservations about reopening the embassy. While we have been busy in recent days, preparations are moving forward at full speed.

A Kuwaiti ambassador to Lebanon and a Chargé d'Affaires in Syria will be appointed in the coming days. The committee for selecting ambassadors and heads of missions meets daily, and it is expected that all appointments will be finalized within the next ten days."

Regarding sending aid to Syria, the minister affirmed that, "Aid to Syria is ongoing and will not stop. There is Gulf and Arab coordination to ensure no duplication in the aid efforts. A meeting at the senior official level will be held, and a plan will be presented on March 6 at the ministerial meeting in Makkah."

In response to a question about the Arab plan to rebuild Gaza, Minister Al-Yahya indicated that, "The plan is still in its initial stages, and outlined in bullet points. Detailed proposals are coming from multiple directions, and we will be part of this initiative.

There is a meeting scheduled in Paris on February 13, followed by a summit in Cairo, with the first major event being the meeting in Mecca on March 6. We are proceeding with a balanced approach to all these developments."

When asked about the possibility of inviting Syrian President Ahmad Al-Sharaa to visit Kuwait, he said, "During my meeting with President Ahmad Al-Sharaa, he expressed a desire to visit Kuwait. Although the details have not been specified yet, God willing, we will be honored by his presence in Kuwait."

# Mubarak Al-Kabeer educational zone unveils plan for 2025-2030

KUWAIT CITY, Feb 8: Mubarak Al-Kabeer Educational Zone has launched its strategic plan for the years 2025-2030 with 15 important projects aimed at enhancing educational outcomes, expanding digital transformation, and boosting

competitiveness.

The acting Director of Mubarak Al-Kabeer Educational Zone Nada Al-Mutairi explained that the strategy, which was prepared in December, is now being implemented. It divides the work performance into four main areas - the financial dimension, customer relations, operational efficiency, and the development of capabilities and skills.


# Kuwait must adopt steps to tackle 'Chicken War' effects

"AFTER World War II, chicken consumption in Western Europe saw a dramatic rise, with the United States becoming the primary supplier," col-umnist Prof Dr Abdul Latif Bin Na-khi wrote for Al-Rai daily.

"This influx of American chicken threatened local producers, prompting the European Economic Community

to the European Union) to impose hefty tariffs on US chicken imports.

"In retaliation, the US imposed a 25 percent tariff on the import European pickup trucks, resulting in a sharp decline in



their sales due to the higher prices. This trade standoff came to be known as the 'Chicken War. "Many critics of tariff hikes have

since cited the Chicken War as an example of the long-term negative effects of imposing tariffs -- most notably, the increased cost of goods and the widening economic deficit.

The US tariffs on European trucks, for example, led not only to a drop in demand for foreign trucks but also caused a reduction in demand for domestic trucks, as their prices also climbed due to the temporary surge in demand.

"Now, more than half a century later, the US has found itself embroiled in another form of tariff war, this time targeting Mexico, Canada, and China. The motivation behind these new tariffs primarily centers around combating the smuggling of fentanyl (a potent synthetic opioid drug approved by the Food and Drug Administration for use as an analgesic -- pain relief -- and anesthetic), that has contributed to tens of thousands of overdose deaths in the US

"China, the leading producer of fentanyl and its precursor chemicals, has been accused of selling these substances to Mexican drug cartels, which then funnel the drugs into the US. Mexico is also under fire for allegedly supporting these cartels by providing safe havens for their operations

"Similarly, Canada is facing increasing scrutiny for being a base for the manufacture and export of fentanyl and related drugs to the US and beyond.

"In response, the US President decided to delay tariff imposition on Mexico and Canada for a month, while continuing the trade war with China. This move followed announcements from the Mexican and Canadian governments that they would step up efforts to curb fentanyl trafficking

"Mexico recently deployed 10,000 National Guard soldiers to its border with the US to tackle the issue, while Canada pledged to appoint an official dedicated to addressing fentanyl trafficking and vowed to treat Mexican fentanyl cartels as terrorist organiza-

"Despite this, tensions with China have remained high. Shortly after the US imposed new tariffs, China retaliated by implementing its own tariffs on US goods, launching an antitrust investigation into Google, and filing a complaint with the World Trade Organization over the tariffs.

"Analysts believe that neither the US nor China wants to escalate the situation further, as both sides are wary of the economic and geopolitical consequences. However, this renewed trade confrontation is expected to bring more shocks to the global market.

"Given the inter-connectedness of global trade, it is essential for local economies to consider the potential impact of such international disputes.

"As the Kuwaiti economy is closely tied to global demand, particularly for oil, it is crucial for the Council of Ministers and the Kuwait Economic Society to take appropriate measures to mitigate the direct and indirect effects of the 'Chicken War' on the country's economic landscape.

"God, show what is the truth, and grant us the ability to follow it.'

"It seems that the euphoria over his victory as President of the United States of America once again made him go beyond the norm in all his moral and political actions, and even human logic in general, up to the point that he surprised his stinking beggar guest, the son of stinking Netanyahu, with proposals and facilities that he had never dreamed of, and were not on his begging agenda, and his usual schedule of demands, not the least of which was his proposal to annex the West Bank to the usurping entity, and displace its people and the people of honorable Gaza, to sites that call for nausea," Kuwaiti writer Abdulrahman Khaled Al-Hamoud wrote for Al-Seyassah daily.

"While immersed in his euphoria, he believed that he had become the ruler of this planet, messing with it as he pleases. This prompted the greatest terrorist of the era, the stinking Netanyahu, to respond to him, using the bullying language. He said: You, Mr. President, are our greatest ally and supporter in the history of the White House (may Allah cover him with black). This was after he found criminal solutions and a package of crazy decisions that the professional terrorist could not have thought of.

"Once again, this confirms that there is no longer an excuse for any Arab leader or official looking for the 'Nobel Peace Prize', just thinking about recognizing or normalizing ties and coexisting with this criminal entity. This entity has not ceased to terrify them and it has revealed its fragility, with all its power, through the heroes of Gaza -- men, women and children -- who have proven to the entire world that despite their small number and the modesty of their weapons and capabilities, they are the invincible force as they have armed themselves with faith mixed with Divine certainty. Thus, the Lord of Glory and Majesty did not let them down, and achieved a clear victory for them.

"I am fully aware that many Arab Zionists, whom Allah made deaf, will ask what victory I am talking about. I want to tell them this is after they got rid of the dignity of the legendary steadfastness of Gazans, the latter's production of blessed weapons mixed with faith; forcing more than a million Zionist dogs to return to where they came from and stopping future migration to this vanishing entity, God willing.

"This is in addition to the elimination of the huge number of members of the 'invincible' army, which all the Arab armies, individually and collectively, were unable to achieve, not to mention the collapse of the economy of this enemy, in all its aspects. The sympathy shown by all the peoples of this world for the people of Gaza, and the Palestinian cause in general, is a matter of pride, especially those who have gone beyond this sympathy to enter our true religion. Due to the faith and acceptance of the people of Gaza and the leader of the Mujahideen of this era, the martyred hero -- Yahya Sinwar --who was proud enough, such that, before his martyrdom, he purified his movement from sectarian impurities, particularly the false claim that it is the main founder of this movement, and its innocence from those who have mercy on the killers whom they likened to the martyrs of Jerusalem, and that Jerusalem is innocent among them!

"Finally, may Allah be with you, O arrogant president, as you willingly entered the hornet's nest in Canada, Mexico, Panama and many other surrounding countries.'

"Before talking about the 'crazy president', we will tell you a story. One day, before the end of the shift, a worker in a fish freezing and preservation factory entered the fish preservation refrigerator to complete his work, the refrigerator door closed suddenly and he was trapped inside," Ahmad Al-Dawas wrote for Al-Seyassah daily.

"The worker tried to open the door, but he could not, so he started screaming at the top of his voice; asking for help from his colleagues, but the shift already ended and no one remained in

the factory. "After about five hours, the worker was on the verge of death due to the severe cold, and then the guard opened the refrigerator door and saved him. manager



asked the guard Ahmad Al-Dawas how he knew that the worker was inside the factory and did not leave with his colleagues

"The guard replied: I have been working in this factory for 30 years. Hundreds of employees enter and exit the factory every day. None of them greeted me every day and asked about my condition except that worker. At the end of the work day, I did not hear from him and I missed him when all the other workers left. I knew then that he was still in the factory, so I looked for him until I found him.

"God Almighty said 'speak to people kindly', so the worker's kind words saved him.

"US President Donald Trump's policies provoked other countries, because he embraced the idea of the 'crazy president' -- the idea that by acting in a very volatile manner, the head of State can intimidate opponents and push them to make concessions, that is, intimidate other countries to achieve gains. The heads of states practiced this over the past decades.

"Yesterday, Trump threatened to impose tariffs on Canada, Mexico and China. He later postponed the imposition for a month. He then threatened to annex Canada as a US state, which is dangerous, because China might find a justification for invading and occupying Taiwan. If he imposes tariffs on other countries, they will impose tariffs on US imports as well, so the prices will increase and the demand will decrease. Trump's policies are destabilizing the international situation. He is a good president, but he is

# Banks submit 77% money-wash, terror funding reports in 1 year

FIU reveals 2,570 notifications received

KUWAIT CITY, Feb 8: A recent government report revealed that the Financial Investigations Unit (FIU) received 2,570 notifications about suspected money laundering or financing terrorism within a year, as Article 16 of the executive regulations of the Anti-Money Laundering and Financing Terrorism Law mandates financial institutions and non-financial businesses and professions to notify the unit about suspicious transactions and relevant information within two business days at the latest, reports Al-Anba daily.

This is the ninth report issued by the unit and the daily obtained a copy. It is stated that the banking sector submitted the highest number of notifications with 1,977 or 77 percent of the total, followed by money exchange companies with 566 or 22 percent, electronic payment companies with 20, financial brokerage companies with five, and then companies trading in precious metals and gemstones and financing companies with

The unit has the power to obtain any information or document it deems necessary in performing its duties from the concerned authorities, notified entities and counterpart units in accordance with Article 18 of Law No. 106/2013.

According to the report, the unit requested information from the concerned authorities to complete its report for fiscal 2023/2024 to complement the data it received from the notified parties and for it to make the right decision; considering the received information a reasonable evidence of

The number of information requests that the unit submitted to five competent authorities reached 581 with the Ministry of Interior accounting for the largest percentage at 34 percent or 199 requests, followed by the Ministry of Commerce and Industry at 21 percent or 122 requests, Ministry of Justice at 18.4 percent or 107 requests, Kuwait Clearing Company with 87 requests, and Kuwait General Administration of Customs with

As per the law, the unit has the right to notify the Public Prosecution if it has reasonable evidence to suspect that funds are derived from a crime or linked to, related to, or can be used to carry out money laundering or financing terrorism operations in accordance with Article 19 of Law 106/2013; in addition to the possibility of referring relevant information to the concerned authorities.

Moreover, the unit submitted 101 reports to the prosecution, including 61 notifications, information referrals and international cooperation referrals; as well as 99 to the concerned authorities; including 22 notifications, information referrals and international cooperation referrals. These referrals include a report with more than one notification.

In terms of cooperation with counterpart units, international cooperation is carried out through a mechanism for exchanging information on combating money laundering and financing terrorism in terms of requesting and receiving information with counterpart units or making it available as per the established procedures and the principles of Egmont Group. The number of received information requests

reached 33, while the number of referral requests totaled 16 and the number of information requests reached six -- a total of 55.

According to the case file, an expatriate born in 1979, filed a report stating that while he was walking in Block 11 in Hawally -- in front of a men's salon -- two unidentified persons in an American quad stopped him and asked for his identification card. When he took out his identification card from his pocket, one of the accused handcuffed him and forced him to get into their vehicle where he was robbed of

the above-mentioned amounts. The expatriate added that the accused, who claimed to be detectives, threatened to deport him and cause him serious harm if he asked for help from passersby. He provided police with a detailed description of the vehicle.



#### **Countries flourish**

Meanwhile, the hotel owner took advantage of the situation by quickly grabbing the \$100, and rushing to the butcher to pay off his debt. The butcher accepted the money and went to the livestock dealer to settle part of his debt. The livestock dealer then paid the \$100 to the animal feed trader, who in turn used it to pay the truck driver that brings feed from a distant town. The truck driver, upon receiving the money, hurried to the hotel where he usually stays during his trips to town and used the \$100 to pay off what he owed to the hotel

When the tourist came back down from the upper floor, he found no suitable room, decided to leave, and took back the \$100 from the counter.

In the end, none of the townspeople made any profit, but everyone managed to pay off their debts.

This sequence, in economic terms, is known as Quantitative Easing (QE). However, in reality, the result was zero because the money eventually returned to the tourist, who represents the state. Through the real capital cycle, the money flowed back to him, thus strengthening the financial cycle on one hand, and reviving the economy and boosting the national product on the other.

This story is a simplified example of how countries operate in a similar manner. When a state suffers from mismanagement and poor decisionmaking, it faces deficits due to a lack of expertise in proper governance or, at times, as a result of envy-driven

On the other hand, some countries prioritize expenditure on developing projects, promoting citizen welfare, and building partnerships with international institutions or other countries to strengthen their national economies

Last week, His Highness the Amir Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah, along with His Highness the Crown Prince Sheikh Sabah Al-Khaled, met with the Chairman and CEO of BlackRock, Larry Fink.

However, the most important step is to invest a large portion of sovereign funds in national projects, which will boost national production in the long term and push the economy forward. Many of these projects will generate revenue, either through collected fees or potential taxes.

Most countries invest their sovereign wealth domestically, which strengthens the economy, raises the per capita income, and shields the country from crises.

On the other hand, countries that restrict expenditure see higher corruption rates and rising poverty. As the saying goes, poverty is the root cause of many societal diseases.

The Filipino community came in fifth place, with a population of 223,482 at the end of 2024, showing a significant decrease of 16.3 percent from 267,259 at the end of 2023.

The Ministry of Social Affairs has instructed these cooperatives to automatically terminate memberships of individuals who have lost their citizenship, citing the loss of a fundamental membership requirement.

It's noteworthy that the profits in question pertain to purchases made in the year preceding the revocation of

# **US President Trump ends Biden's classified intelligence briefings in payback move**

PALM BEACH, Fla., Feb 8, (AP): US President Donald Trump said Friday that he's revoking former president Joe Biden's access to government secrets and ending the daily intelligence briefings he's receiving in payback for Biden doing the same to him in 2021.

Trump announced his decision in a post on his social media platform shortly after he arrived at his Mar-a-Lago home and private club in Palm Beach for the weekend.

"There is no need for Joe Biden to continue receiving access to classified information. Therefore, we are immediately revoking Joe Biden's Security Clearances, and stopping his daily Intelligence Briefings," Trump wrote. "He set this precedent in 2021, when he instructed the Intelligence Community (IC) to stop the 45th President of the United States (ME!) from accessing details on National Security, a courtesy provided to former Presidents.

ance tour of Washington that Trump promised during his campaign. He has previously revoked security clearances from more than four dozen former intelligence officials who signed a 2020 letter saying that the Hunter Biden laptop saga bore the hallmarks of a "Russian information operation." He's also revoked security details assigned to protect former government officials who have criticized him, including his own former secretary of state, Mike Pompeo, who faces threats from Iran, and former infectious disease expert Dr. Anthony Fauci.

Biden didn't immediately comment on the move.

Biden ended Trump's intelligence briefings after Trump helped spur efforts to overturn the 2020 presidential election and incited the Jan 6, 2021, attack on the Capitol. At the time, Biden said Trump's "erratic" behavior

Asked in an interview with CBS News what he feared if Trump continued to receive the briefings, Biden said he did not want to "speculate out loud" but made clear he did not want Trump to continue having access to such information.

"I just think that there is no need for him to have the intelligence briefings," Biden said. "What value is giving him an intelligence briefing? What impact does he have at all, other than the fact he might slip and say something?"

in 2022, federal agents searched Trump's Florida home and seized boxes of classified records. He was indicted on dozens of felony counts accusing him of illegally hoarding classified records and obstructing FBI efforts to get them back. He pleaded not guilty and denied wrongdoing. A judge dismissed the charges, ruling the special counsel who brought them was illegally appointed, and the Justice Department gave up appeals after Trump was elected in November.

In a related matter, Trump dismissed Colleen Shogan as the archivist of the United States, White House aide Ser-

gio Gor posted on X Friday night. Trump had said in early January that he would replace the head of the National Archives and Records Administration. The government agency drew his anger after it informed the Justice Department about issues with Trump's handling of classified documents. Shogan, the first woman in the post, wasn't the archivist of the United States at the time the issue emerged.

In his post on Biden, Trump cited the special counsel report last year into his handling of classified documents, saying, "The Hur Report revealed that Biden suffers from 'poor memory' and, even in his 'prime,' could not be trusted with sensitive information.'

#### Missing Alaska plane found, 10 people dead

Just hours after finding 10 people dead in western Alaska from one of the deadliest plane crashes in the state in 25 years, authorities raced to recover their remains and the wreckage of the small commuter plane from unstable sea ice before expected high winds and snow.

"The conditions out there are dynamic, so we've got to do it safely

in the fastest way we can," Jim West, chief of the Nome Volunteer

Fire Department, said Friday.
The Bering Air single-engine turboprop plane was traveling from Unalakleet to the hub community of Nome when it disappeared Thursday afternoon. It was found the next day after an extensive search with all nine passengers and the pilot dead.

As the community tried to process the deadly event, crews worked swiftly on unstable, slushy sea ice to recover the bodies and the wreckage with less than a day before bad weather was expected. Officials said a Black Hawk helicopter would be used to move the aircraft once the bodies were re-

# Trump signing up local law officers to help with immigration enforcement

WASHINGTON, Feb 8, (AP): For years, the Hamilton County Sheriff's Office in suburban Indianapolis has wanted to partner with federal immigration authorities to identify and detain immigrants who are in the US illegally and facing charges.

President Joe Biden's adminis-

tration never returned its calls, the sheriff's office said. But as President Donald Trump cracks down on illegal immigration, Hamilton County deputies soon could become the first in Indiana empowered to carry out federal immigration duties and one of many nationally that Trump's administration hopes to enlist.

"We definitely are joining," Chief Deputy John Lowes told The Associated Press. "We want to collaborate with ICE to make sure we keep our community safe.'

Under Trump, US Customs and Immigration Enforcement is reviving and expanding a decades-old program that trains local law officers to interrogate immigrants in their custody and detain them for potential deportation. The 287(g) program - named for a section of the 1996 law that created it - currently applies only to those already jailed imprisoned on charges.

But Trump's border czar, Tom Homan, recently told sheriffs that he wants to expand it to include local task forces that can make arrests on the streets, reviving a model that former President Barrack Obama discontinued amid concerns about racial profiling. It's unclear whether

that could allow local officers to stop people solely to check their immigra-

On Friday, Florida Gov. Ron DeSantis announced that the Florida Highway Patrol had struck an agreement with ICE to interrogate, arrest and detain immigrants suspected of being in the country illegally and deliver them to federal authorities.

The arrangement will help "fulfill the president's mission to effectuate the largest deportation program in

American history," DeSantis said.
Advocates for immigrants, meanwhile, are raising alarm about new pacts that put local law officers on immigration enforcement.

'All of these agreements, in practice, have the same track record of racial profiling, of sweeping in U.S. citizens or people who have lawful status, of having a chilling effect in terms of communities reporting crime to local law enforcement agencies," said Nayna Gupta, policy director at the nonprofit American Immigration Council.

In the early 2000s, many of the initial participants in the 287(g) program had agreements that allowed them to enforce immigration laws in their communities, not just their jails. But prob-lems arose in several places, including

In 2011, a civil rights investigation by the U.S. Department of Justice found that deputies in Maricopa County, which includes Phoenix, had engaged in a pattern of racial profiling, unlawful stops and arrests of Latinos. The Department of Homeland Security ended its agreement with the county.

The program became "the hallmark of far-right, anti-immigrant sheriffs" as a means "to feed people on the basis of their ethnicity into the deportation machine," asserted Lena Graber, senior staff attorney at the nonprofit Immi-

grant Legal Resource Center.
In recent years, ICE has offered two types of 287(g) agreements to law enforcement agencies. One model requires four weeks of training and allows local officers to question suspected noncitizens who are jailed on other charges and detain them for ICE.

## Trump wants to negotiate about Ukraine

WASHINGTON, Feb 8, (AP): months. He's indicated the U.S. Nearly three years after President Vladimir Putin invaded Ukraine, his troops are making steady progress on the battlefield. Kyiv is grappling with shortages of men and weapons. And the new US president could soon halt Ukraine's massive supply of military aid.

Putin is closer than ever to achieving his objectives in the battle-weary country with little incentive to come to the negotiating table. no



matter how much US President Donald Trump might cajole or threaten him, according to Russian and Western experts interviewed by The Associated Press.

Both are signaling discussions on Ukraine -- by phone or in person -- using flattery and threats.

Putin said Trump was "clever and pragmatic," and even parroted his false claims of having won the 2020 election. Trump's opening gambit was to call Putin "smart" and to threaten Russia with tariffs and oil price cuts, which the Kremlin brushed off.

Trump boasted during the campaign he could end the war in 24 hours, which later became six

is talking to Russia about Ukraine without Kyiv's input, saying his administration already had "very serious" discussions.

He suggested he and Putin could soon take "significant" action toward ending the war, in which Russia is suffering heavy casualties daily while its economy endures stiff Western sanctions, inflation and a serious labor shortage.

But the economy has not collapsed, and because Putin has unleashed the harshest crackdown on dissent since Soviet times, he faces no domestic pressure to end the war.

"In the West, the idea came from somewhere that it's important to Putin to reach an agreement and end things. This is not the case.' said Fyodor Lukyanov, who hosted a forum with Putin in November and heads Moscow's Council for Foreign and Defense policies.

Ukrainian President Volodymyr Zelenskyy says Putin wants to deal directly with Trump, cutting out Kyiv. That runs counter to the Biden administration's position that echoed Zelenskyy's call of "Nothing about Ukraine without Ukraine."

'We cannot let someone decide something for us," Zelenskyy told AP, saying Russia wants the "destruction of Ukrainian freedom and independence.'

He suggested any such peace deal would send the dangerous signal that adventurism pays to authoritarian leaders in China, North Korea and Iran.

#### **ICC** condemns sanctions by WH

THE HAGUE, Netherlands, Feb 8, Court on Friday called on member states to stand up against sanctions imposed by US President Donald Trump, describing the move as an attempt to harm an indispensable global court to administer justice and protect the lives of millions of innocent people.

The embattled court quickly received support in Europe from traditional allies of the US.

"Sanctioning the ICC threatens the court's independence and undermines the international criminal justice system as a whole," said European Council President António Costa, who heads the summits of the European Union's 27 leaders. It was the toughest direct criticism by a senior EU official to a decision by Trump since his return to office last



White House issued the executive order against the ICC on Thursday in response to what it called "illegitimate and baseless actions targeting America' Trump's or-

der was a response to the arrest warrant that the ICC issued last year for Israeli Prime Minister Benjamin Netanyahu over alleged war crimes in Gaza. The US and Israel aren't members of the court and don't recognize it's author-

Tens of thousands of Palestinians, including children, have been killed during the Israeli military's response to Hamas' attack on southern Israel that killed around 1,200 people in October 2023. The casualty figure of Palestinians killed is provided by Gaza's Health Ministry, which doesn't distinguish between fighters and ci-The Hague-based ICC said that it

"condemns" the move by the Trump administration. ICC President Judge Tomoko Akane called the US move "only the latest in a series of unprecedented and escalatory attacks aiming to undermine the Court.' "As atrocities continue to plague the

globe affecting the lives of millions of innocent children, women and men, the Court has become indispensable," she said.

She called for all "to stand united in the Court's defense: our 125 States Parties, civil society and all nations of the world."

#### Slovakia protesters call on Fico to resign

Huge crowds gathered in dozens of cities and towns across Slovakia on Friday to mount vocal protests against the pro-Russian policies of populist Prime Minister Robert Fico.

The latest wave of anti-government rallies was fueled by Fico's recent trip to Moscow for talks with Russian President Vladimir Putin, a rare visit to the Kremlin by a European Union leader since Moscow's all-out invasion of Ukraine began on Feb. 24, 2022.

Fico's recent remarks that Slovakia's foreign policy orientation could involve leaving the European Union and NATO contributed to the anger

of protesters.
"Resign, resign," was the the clear message to the premier. "Slovakia is Europe," they chanted.

The latest rallies took place in 41 locations in Slovakia, up from 28 two weeks ago, and in another 13 cities abroad, organizers said. (AP)

# Trudeau says Trump's talk of making Canada a US state 'a real thing'

VANCOUVER, British Columbia, Feb 8, (AP): Prime Minister Justin Trudeau on Friday said President Donald Trump's talk of making Canada the 51st US state is "a real thing" and is linked to the country's rich natural resources, local media reported.

Trudeau's comments to business and labor leaders in a closed-door session were mistakenly carried by a loudspeaker, Canada's public broadcaster CBC reported.

"Mr. Trump has it in mind that the easiest way to do it is absorbing our country and it is a real thing. In my conversations with him on.. Trudeau said of making Canada a U.S. state before the microphone cut out, according to CBC.

"They're very aware of our resources, of what we have and they very much want to be able to benefit from those," Trudeau reportedly said.

Trudeau's office did not immediately respond to a request for comment. In a post on social platform X, Gil McGowan, president of the Alberta Federation of Labor, confirmed what Trudeau said.

"Yes, I can confirm that Trudeau

# Protests and NZ leader's absence overshadow day marking founding treaty with Maori

(AP): It's often a day marked by spirited politics and at times boisterous protest. But the anniversary of New Zealand's founding document, the Treaty of Waitangi, passed in muted fashion with Prime Minister Christopher Luxon absent from the main commemorations, amid rancor over an unpopular proposed law redefining the treaty's promises.

On Feb. 6 1840, representatives of the British Crown and 500 Maori tribal leaders signed a treaty at Waitangi, in New Zealand's far north, agreeing to the terms of their relationship.

In modern times, annual events attended by lawmakers and Indigenous leaders at the treaty grounds have allowed the groups to speak face to face, even at times of racial discord.

It has also supplied a litmus test for governments and Maori about the state of the treaty partnership - and some-times prompts scenes of protest and conciliation. This year, the mood was reflected in a sermon at Waitangi's annual church service.

"To renegotiate the terms of a marriage usually requires both spouses,' Te Aroha Rountree of the Methodist church said. "It seems our spouse, the Crown, has filed for divorce.

The bitterness centers on a proposed law which has become a flashpoint at a critical moment in the conversation about how New Zealand should honor its pledges to Maori when the country

was colonized.

The Treaty of Waitangi was drafted in two versions -- one in English and the other in Maori. But the documents dramatically differed - the Maori version promised Indigenous sovereignty - and the Crown soon began to breach

It resulted in the near loss of the Indigenous language and deprivation for Maori on almost every metric.

Over the past five decades, tribes

have painstakingly clawed back the treaty's promises - which are constructed through legal judgements and billion-dollar settlements with government that return stolen land and other resources to their original owners.

A minor libertarian political party helped Luxon's government to power in 2023 on a platform of redefining the way the treaty's principles are understood by rigidly interpreting them in law to ensure Maori are not unduly dramatically reverse Maori rights in a country that has in recent years started

The bill's architect, David Seymour, met with protests at Waitangi marae - a Maori meeting house - during speeches by political leaders on Wednesday, as he made a fresh pitch for the law. The measures are widely derided and prompted tens of thousands of people to march on Parliament in Wellington last November.

As Seymour - who is Maori - spoke, women stood as one and silently turned their backs to him. Lengthy portions of his speech were rendered inaudible as demonstrators twice approached him and quietly removed both his microphone and its stand.

Those scenes perhaps explained why Luxon, the prime minister, spent the day far from Waitangi, attending commemorations on the South Island at Onuku Marae, where southern chiefs signed the Treaty months after tribes in the north.

There, he was optimistic about a path through the current animus. Seymour's treaty bill is not expected to pass and Luxon opposes it - although he agreed to usher it through a first vote as part of the deal with Seymour's party that made him prime minister.

"Looking ahead, the ability to resolve differences and build bridges will be at the heart of New Zealand's success," Luxon said.

The Senate is to take up the case when it reconvenes in June.

# Panama's president denies making deal that US ships can transit canal for free

PANAMA CITY, Feb 8, (AP): Panamanian President José Raúl Mulino denied the US State Department's claim that his country had reached a deal allowing US warships to transit the Panama Canal for free

Mulino said he had told US Secretary of Defense Pete Hegseth on Wednesday that he could neither set the fees to transit the canal nor exempt anyone from them and that he was surprised by the US State Department's statement suggesting otherwise late Wednesday.

"I completely reject that statement vesterday," Mulino said during his weekly press conference, adding that

he had asked Panama's ambassador in Washington to dispute the State Department's statement. He was scheduled to speak with US President Donald Trump on Friday.

On Wednesday evening, the US State Department said via X that "US government vessels can now transit the Panama Canal without charge fees, saving the US government millions of dollars a year. The Panama Canal Authority put out

its own terse statement later Wednesday night saying it had "not made any adjustments" to the fees. Mulino said the US statement "really surprises me because they're making an important, institutional statement from the entity that governs United States foreign policy under the president of the United States based on a falsity. And that's intolerable."

US Secretary of State Marco Rubio, who met with Mulino and canal administrators and visited the critical trade route earlier this week, said on Thursday from the Dominican Republic that he had no confusion about his discussions with Panama, but "I respect very much the fact that Panama has a process of laws and procedures that they need to follow.

# Trump orders freeze of aid to South Africa

WASHINGTON, Feb 8, (AP): US President Donald Trump signed an executive order Friday formalizing his announcement earlier this week that he'll freeze assistance to South Africa for a law aiming to address some of the wrongs of South Africa's racist apartheid era - a law the White House says amounts to discrimination against the country's white minority.

"As long as South Africa continues to support bad actors on the world stage and allows violent attacks on innocent disfavored minority farmers, the United States will stop aid and assistance to the country," the White House said in a summary of the order. The White House said Trump is also going to announce a program to resettle white South African farmers and their families as refugees.

Trump was responding to a new law in South Africa that gives the government powers in some instances to expropriate land from people. The White House said the law "blatantly discriminates against ethnic minority Afrikan-

The Expropriation Act was signed into law by South African President Cyril Ramaphosa last month and allows the government to take land in specific instances where it is not being used, or where it would be in the public interest if it is redistributed.

#### Oil revenue set at KD 15 billion

#### Kuwait approves budget with KD 6 billion deficit for FY 2025

THE government has approved the budget for the next fiscal year starting from April 1, with

estienues mated at KD 18 billion and total expenses at KD 24.5 billion, resulting in a deficit of KD 6 billion. The bud-

get is based on an estimated price of \$68 per barrel FOB Kuwait, which is conservative in comparison to our expenses. To break even and fully recover all of our expenditure, the price would need to be \$90 per barrel.

A closer look reveals that salaries and subsidies account for roughly 80 percent of the budget, leaving little room for capital investments. The government has allocated only KD 2.2 billion for capital expenditure, which is two percent lower than last year's budget

Meanwhile, oil revenues are expected to reach KD 15 billion, or approximately \$45 billion, based on an oil price of \$78 per barrel. However, Kuwait's crude oil is currently being sold in the spot market at around \$75 per barrel, which still falls short by about \$15 per barrel from the breakeven point of \$90. Oil market analysts predict that prices will likely remain between \$70 and \$75 per barrel.

We are facing another year of budget deficit, and we have to find solutions, likely involving tough decisions. If there are any remaining financial reserves, we may need to dip into them due to the ninth consecutive year of deficits. Alternatively, the government may consider international borrowing, which it has yet to explore. Another option could be to utilize profits from its overseas global investments,

which could be the quickest and most cost-effective approach. Another possible route is to

privatize some governmentowned companies, either in the oil sector or other commercial sectors where the government holds 100% ownership. However, this approach would take time, possibly years, before it comes to fruition. Once implemented, it could result in the privatization of many government-owned companies, which seems to be the case, as many of these companies, especially in the oil sector, were originally established by private Kuwaiti entities in the early 1960s.

One observation of the upcoming budget is the nine-percent increase in non-oil revenue, which is projected to reach KD 3 billion above the budget of the fiscal year until the end of

It is no surprise that the government is embarking on 90 new projects in various sectors, including roads, education, health, and infrastructure. For example, two new football stadiums are planned in the new cities in the northern parts of Kuwait, at a total cost of KD 1.7 billion.

While the budget is ambitious, we need projects that provide long-term benefits, help maintain our competitive edge, and create job opportunities for the estimated 25,000 new graduates entering the workforce each

With oil prices expected to remain around \$70 per barrel for the remainder of the year, it may be time for the government to reconsider its spending priorities. Reducing expenses and focusing on privatization could be important steps in freeing the government from non-core activities. The private sector should be allowed to take over these areas, as it is generally more efficient and capable of managing investments, and offering a professional approach to managing

She encouraged the business communities in both countries to explore the available opportunities and capabilities, and to work together to establish mutually beneficial trade relations.

At the end of the meetings, the minutes of the fourth session of the Kuwaiti-Tajik Joint Ministerial Committee were signed.

## Trump pushes for US sovereign wealth fund

Could the United States soon be joining the likes of Norway, Kuwait and Mongolia in having a national reserve to invest on projects of strategic interest? If President Don-

ald Trump gets his way, then perhaps so.
On Feb. 3, 2025, Trump issued an executive order calling

for the creation of a U.S. sovereign wealth fund. This was not entirely unexpected. After all, the idea had been floated in September 2024 not only by the Trump team,

but also by President Joe Biden's Treasury Department. Many at the time, including myself, deemed it far-fetched at best. But with the initiative now gaining traction, the time is certainly ripe to imagine what a U.S. sovereign wealth fund might look like.

In their most basic form, sovereign wealth funds are pools of government savings, usually accumulated over many years through the sale of commodities, traded goods, government-owned companies and land-use rights, among other

They share a variety of objectives, such as stabilizing government finances, ensuring the funding of retirement or education programs, saving for future generations or even managing state-owned corporations. They generally diversify investment across assets, geog-

raphies and sectors, including some, such as sports and entertainment in the case of Saudi Arabia, that are aligned with national development goals.

Sovereign wealth funds are usually associated with great wealth - Norway's "oil fund" is estimated to be worth US\$1.7 trillion. With regard to scale, Norway is hardly alone. And Norway's fund is typical in another respect: sovereign wealth funds are often based in smaller countries with outsized natural resources, like Kuwait, the United Arab Emirates and Qatar, or even tiny Guyana in the Caribbean.

#### Modest

In reality, most sovereign wealth funds are more modest in size relative to their gross domestic products.

Sovereign wealth funds are hardly new. The so-called modern era of sovereign wealth funds dates to the early 1950s with the creation of the Kuwait Investment Board.

But some government investment funds, such as the Texas Permanent School Fund, established in 1854, long predate the Kuwait Investment Board.

As is evident in the case of Texas, there are many such funds already operating in the U.S., including those in Alaska, New Mexico and Wyoming - all of which identify as "sovereign wealth funds." These, of course, are state funds, but the term "sovereign" is generously applied.

Sovereign wealth funds often invest outside of their geographies, not only to diversify returns but to avoid stimulating higher inflation that may result from investing at

In fact, the U.S. has benefited from investments by other countries' sovereign wealth funds. Developed market economies like the U.S. are attractive destinations for investment, given the relative strength of their institutions and the scale and liquidity of their financial markets.

Still, over the last decade there has been a rapid expansion in the number of sovereign wealth funds investing domestically, particularly in support of strategic national goals. Some of these include funds in Ireland, India and Indonesia.

Their investment programs target critical sectors and national "champions," with a goal to mobilize foreign capital for co-investment in local markets.

What could a U.S. sovereign wealth fund look like? Would it be well funded? And if so, how? Through taxes, treasury bond proceeds, budget transfers, tariffs?

Would it invest globally or domestically? Could it be used to reinforce the Social Security system? Will it be used to tackle the dual deficits of budget and trade? Or will it have a strategic mandate - to enhance national security, energy security or climate security?

These are all fundamental questions that must be carefully examined; creating a sovereign wealth fund should not be a backroom exercise. It needs to be conducted openly, with expert input and public deliberation.

The process belies even more challenging organizational and governance decisions concerning the legal structure, ownership and management of the fund, the independence of its governing board, and its distance from government influence in its decisions.

After all, the history of sovereign wealth funds is not without failed attempts. Take Malaysia's 1MDB, which was usurped for political and personal gain and became a multibillion-dollar corruption scandal, or Venezuela's macrostabilization and development funds, which were both effectively exhausted.

#### Breakdown

In these cases - and others - the breakdown can be connected to failures in governance, both in design and culture, and ultimately traced back to politics.

It is interesting to note that it was George W. Bush's Treasury Department during the financial crisis in 2008 that was most influential in encouraging sovereign wealth funds to define a framework of governance practices and princi-

Known as the Santiago Principles, this set of 24 precepts, agreed to in 2008, are intended to ensure transparent and sound governance with adequate operational controls, risk management and accountability.

To be successful and in line with the Santiago Principles, a U.S. sovereign wealth fund would have to be grounded in a functional governance structure that allows investment

projects to be evaluated based on commercial merit. It would also need to be free of political interference and operate openly, transparently and at arm's length from any personal or professional interests of any related parties.

The next thing to consider is the fund's investment objectives and strategy. Trump has suggested that such a fund could be used to buy TikTok. But would that represent a strategic investment that advances the national competitiveness of the U.S.?

Perhaps instead, a sovereign wealth fund might be better placed investing a majority of its capital in private markets and core infrastructure in the U.S. under a focused strategic mandate that directs money to key national priorities.

Essential here is for the fund to be "additional." That is to say it would invest in projects that other investors would not be able to finance on their own due to scale, difficulty or duration. In essence, the fund would "crowd in" investors, rather than crowding them out.

Perhaps the most critical question still remains: Where will the money come from?

Increased taxes are a nonstarter due to political will and, of course, Trump's campaign commitments.

Treasury bond issuances would only increase U.S. debtedness and likely lead to higher inflation. Allocations from the government's own budget also seem to be a non-starter, as U.S. budget deficits have long been wellentrenched.

The president has suggested that a fund could use tariff payments - but the reality of the tariff rollout is itself questionable and apparently open to negotiation.

A more practical option may be a take on the traditional private equity limited partnership. In this model, the U.S. serves as general partner and joins other institutional investors - including other sovereign wealth funds - to invest in

As general partner, the U.S. would appoint a management team that would select and manage the investments - for a fee, of course. Its mandate would be to target strong market returns, while advancing the strategic national interests of Empowering youth and shaping impactful leaders in society

#### 'US customs overwhelmed'

# Trump halts tariffs on small Chinese imports

WASHINGTON, Feb 8, (AP): President Donald Trump has paused imposing tariffs on small-value packages arriving from China, apparently to give federal agencies time to sort out how to process millions of such shipments that have come through the U.S. border every day without paying taxes.

The executive order, dated Wednesday, didn't say when the pause would end but said it would cease when the Department of Commerce could put in place "adequate systems" to "fully and expediently process and collect tariff

revenue."
"It's just showing we're moving fast, and the implications are not fully understood when some of these regulations are put in place," said John Lash, group vice president of product strategy at the supply chain platform e2open, pointing out that Trump's order affected huge numbers of small packages, many in transit.

"The volumes are absolutely incredible," Lash said. "And all of a sudden, they go from not requiring filing (for tariffs) ... to actually requiring full filing, which is a complicated task.

Ending tariff exemptions on lowcost packages from China has broad bipartisan support in Washington, and Trump pulled the plug when he raised tariffs on Chinese goods by 10% earlier this week. Goods sent through dutyfree packages became subject not only to existing tariffs - 25% for many Chinese products - but also the new 10%.

It marks another pause on Trump's policies weeks into his second administration, including orders to impose tariffs on Mexico and Canada that were suspended after the two allies took steps to appease his concerns about border security and drug traf-

The U.S. Postal Service, which would be burdened with collecting tariffs on small packages, on Tuesday announced it would not accept parcels from mainland China and Hong Kong, only to reverse the decision the next day. It said it would work with Customs and Border Protection to implement a collection process for the new

"It's one of those things where you

put in any change so quickly it catches people unprepared," Lash said.

Introduced in 1938, the so-called de minimis exception was intended to facilitate the flow of small packages valued at no more than \$5, the equivalent of about \$106 today. The threshold increased to \$200 in 1994 and \$800 in 2016. But the rapid rise of cross-border e-commerce, driven by China, has challenged the intent of the decadesold customs exception rule.

Chinese exports of low-value packages soared to \$66 billion in 2023, up from \$5.3 billion in 2018, according to a report released last week by the Congressional Research Service. And the U.S. market has been a major destination.

In 2023, for the first time, more than 1 billion such packages came through U.S. customs, up from 134 million in 2015. By the end of last year, Customs and Border Protection said it was processing about 4 million small shipments a day, many of which came from China through online retail platforms such as Shein and Temu.

Critics said the practice had allowed not only tariff evasion, but also the flow of unsafe products such as counterfeits and illicit drugs into the U.S. Supporters argued that it helped keep prices affordable for U.S. consumers and small businesses.

After Trump threw out the exemption, some analysts noted that the policy shift could lead to higher prices and delivery delays as U.S. customs officials cope with an onslaught of packages to scrutinize.

"We are talking about millions of packages every week that currently just basically get treated like domestic shipping," said Neil Saunders, a managing director with research firm

He said Temu has already adjusted by increasing its warehousing capabilities in the U.S. during the past year and shipping products in containers.

Lash said the end to the de minimis exception rule would change the crossborder e-commerce model when tariffs and filing paperwork drive up costs, prompting overseas sellers to turn to bulk shipping.

# US adds 143,000 jobs in January

WASHINGTON, Feb 8, (AP): U.S. employers added just 143,000 jobs last month, but the unemployment rate fell to 4% to start 2025.

The first monthly jobs report of Donald Trump's second presidency points to a solid but unspectacular labor market. January job creation dipped from the 261,000 added in November and 307,000 in December. Economists had expected about 170,000 new jobs in January.

The outlook is uncertain as Trump prepares to shake up economic policymaking by cutting federal jobs, imposing big taxes on foreign goods and deporting millions of undocumented workers. His tariffs and immigration crackdown could push up prices, potentially rekindling the inflation that turned many U.S. voters against President Joe Biden and helped return Trump to

For now, most Americans still enjoy unusual job security. But for those looking for work, the job hunt has been getting harder compared with the red-hot hiring days of 2021 to 2023.

Average hourly wages rose by 0.5% from December and 4.1% from January 2024, a bit hotter than forecasters had expected. That may be disappointing for the inflation fighters at the Federal Reserve. Still, some inflationary pressure from wage gains is being offset by U.S. productivity growth, which allows companies to pay more and earn fatter profits without rais-

"Employers are really maintaining their workforce, but they are not hiring significantly, nor are they laying off," said Gregory Daco, chief economist at the consulting firm EY Parthenon. Daco expects average job growth to slow to between 100,000 and 150,000 a month this year (down slightly from the 2024 average of 166,000 new jobs a month).

The Labor Department also revised payrolls for November and December up by a combined

Citing the strong upward revisions from late 2024, Carl Weinberg and Mary Chen of High Frequency Economics wrote that "There is no cause for concern about the strength of the economy in today's employment report." But they added that hiring in recent months suggests the Fed will be in no hurry to cut interest rates after doing so three times in 2024.

January hiring was narrow. Healthcare (44,000 new jobs), retail (34,000) and government (32,000) together accounted for 77% of new jobs last month. Mines shed 8,000

The Labor Department said the Los Angeles wildfires and a cold snap in the Northeast and Midwest had "no discernable" impact on the January jobs numbers.

The future is cloudier.

A federal judge on Thursday temporarily blocked President Donald Trump's plan to push out federal workers using financial incentives. A federal hiring freeze that Trump imposed Jan. 20 is a "negative for employment growth," Bradley Saunders, an economist at Capital Economics, wrote last week

Economists are also worried about Trump's threats of a trade war against other countries. He's already imposed a 10% tax on imports from China and is threatening tariffs on Canada, Mexico and the European Union and possibly, a universal levy on all imports.

Tariffs paid by U.S. importers, but typically passed along to customers, could heat up inflation - which has fallen from the four-decade high it reached in mid-2022 but is seemingly stuck above the Fed's 2% target. If tariffs push prices higher, the Fed may cancel or postpone the two interest-rate cuts it had forecast for this year. That would be bad for economic growth and job creation.

Employers also worry about the economic fallout from Trump's promises to deport millions of immigrants working in the United

Coastal Luxury Outdoors, a Florida pool, maintenance and landscaping company, is struggling to find workers.

"We're highly reliant on immigrant labor, to the point where even if we see reduced demand due to tariffs and other factors, we'll still need to boost our staffing levels," said Rafi Friedman, company president.

Friedman said the company has a core administrative staff of about a dozen people and a field service staff that fluctuates by the season. More than 80% of the field workforce is Hispanic, most of them foreign born. Friedman said the company verifies their immigration status be-

""Because our work is highly seasonal, we're always replacing at least some of our workforce from year to year, and in periods of high anti-immigrant sentiment, that turnover only gets more difficult to manage," he said.

The job market has already lost momentum. American payrolls increased by 2 million last year, down from 2.6 million in 2023, 4.6 million in 2022 and a record 7.2 million in 2021 as the economy recovered from COVID-19 lockdowns. Employers are posting fewer jobs and monthly job openings have tumbled from a record 12.2 million in March 2022, to 7.6 million in December - still a decent number by histori-

Aujanique Star, 20, of Fife, Washington, is a pre-nursing student who has been trying to switch from her caregiving job to a position in retail for nearly a year. But after submitting as many as 20 applications, she just keeps facing rejections.

"It makes me feel more frustrated that I have all this work experience and all this loyalty towards my jobs. ... What am I missing?"

As the labor market cools, American workers are losing confidence in their ability to find better pay or working conditions by changing jobs. The number of people quitting has fallen from a record 4.5 million near the height of the hiring boom in April 2022, to December's 3.2 million, which is below prepandemic levels.

In regular annual revisions, the Labor Department reported Friday that job creation from April 2023 through March 2024 wasn't as good as originally reported: 589,000 fewer jobs were created over those 12 months. Preliminary estimates, released in August, had suggested the downward revisions would be bigger - 818,000

White House press secretary Karoline Leavitt on Friday said the economy during Joe Biden's presidency "was far worse than anyone thought.

Yet Trump is inheriting a healthy unemployment rate and stable economy, just not one that would necessarily make him happy.

response to US tariff threats VANCOUVER, Feb 8, (AP): Prime Minister Justin Trudeau said Friday that Canada must think "tactically and strategically" on how to deal with U.S. President Donald Trump's threats to

impose hefty tariffs on all Canadian Speaking in Toronto at the opening of a one-day summit on the Canada-U.S. economic relationship, Trudeau told the gathering of trade, business and labor experts the country must work with the U.S. to avoid

He also said Canada needs to eliminate internal trade barriers and expand its trade with other nations.

"This is a moment," said Trudeau. "This is a time in our country's history that really matters.'

Later, local media reported that Trudeau told business leaders at the summit that Trump's comments to make Canada the 51th state are "a real

"Mr. Trump has it in mind that the easiest way to do it is absorbing our country and it is a real thing. In my conversations with him on...,' Trudeau said, before the microphone cut out, Canada's public broadcaster CBC reported.

Trump on Monday agreed to a 30day pause on threats to impose 25% tariffs on imports from Mexico and Canada, with another 10% tariff on Canadian oil, natural gas and electric-

Trump had threatened the tariffs to ensure greater cooperation from the countries to stop illegal immigration and prevent fentanyl smuggling, but he has also pledged to use tariffs to boost domestic manufacturing and raise revenues for the federal gov-

Trudeau said Canada can use the 30-day extension to show U.S. officials the country's increased spending on border security. Canada has announced a \$1.3 billion Canadian dollars (\$900 million) border security plan that includes drones, helicopters, more border guards and the creation of a joint task force.

Trudeau also has promised to appoint a new fentanyl czar, who will serve as the primary liaison between the Canadian and U.S. governments, even though less than 1\(\tilde{\pi}\) of the fentanyl and illegal immigrant crossings into the U.S. come from Canada.

"We need to be very deliberate about how we continue to engage closely with the United States to make the case that Canada is responsible for a tiny part of the North American fentanyl problem, but that we are also bitterly touched by this tragedy," Trudeau

He added that Canada needs to be prepared if Trump decides to go ahead with the tariffs after 30 days.

"We need to be ready to respond ro-bustly," he said. "We also have to be ready to support Canadians through the responses we're giving and through a difficult time of tariffs.

Canada had planned to retaliate to the U.S. action with 25% tariffs on \$155 billion Canadian dollars (\$109 billion) worth of American goods.

Trudeau said it's also time to have "genuine free trade in Canada," while strengthening its trade relationships with other countries.

Candace Laing, president and CEO of the Canadian Chamber of Commerce, said she is happy the meeting is focused on internal trade, trade diversification and responding

to U.S. tariffs. "It's clear that we can't just tinker around the edges with incremental steps right now," she said. "We've got to be bold so that businesses and communities can pivot to be more resilient and less reliant on what happens in the U.S.," Laing said in

a statement. The summit is being hosted by the government's newly created advisory council on Canada-U.S. relations, and includes business and labor leaders, Indigenous leaders and public policy experts. Several federal cabinet ministers are also attending.

Joining the Canadian Chamber of Commerce are representatives from the Global Automakers of Canada, the Federation of Canadian Municipalities and Canadian Manufacturing and Exporters plus the National Chief of the Assembly of First Nations Cindy

Woodhouse Nepinak. Dennis Darby, president and CEO of Canadian Manufacturers and Exporters, said he intends to tell the government that if tariffs are imposed, businesses and workers will need help in the form of direct government relief, tax relief or wage subsidies.

WASHINGTON, Feb 8, (AP): The average rate on a 30-year mortgage in the U.S. eased for the third week in a row, a smidgen of relief for prospective home shoppers getting into the market before the busy

spring homebuying season starts. The average rate fell to 6.89% from 6.95% last week, mortgage buyer Freddie Mac said Thursday. A year ago, it averaged 6.64%.

Borrowing costs on 15-year fixed-rate mortgages, popular with homeowners seeking to refinance their home loan to a lower rate, also retreated this week. The average rate fell to 6.05% from 6.12% last week. A year ago, it averaged 5.9%, Freddie Mac said.

Mortgage rates are influenced by several factors, including how the bond market reacts to the Federal Reserve's interest rate policy decisions. The average rate on a 30-year mortgage briefly fell to a 2-year low just above 6% last September, but has been mostly rising since then, echoing a sharp rise in the 10-year Treasury yield, which lenders use as a guide for pricing home loans.

The yield, which was at 3.62% in mid-September, reached 4.79% three weeks ago amid fears inflation may remain stubbornly higher than the Fed's 2% target. A solid U.S. economy and worries about tariffs and other policies potentially coming from President Donald Trump have also helped push bond yields

The 10-year Treasury yield was at 4.43% in midday trading Thursday.

Elevated mortgage rates, which can add hundreds of dollars a month in costs for borrowers, have discouraged home shoppers, prolonging a national home sales slump that began in 2022.

While sales of previously occupied U.S. homes rose in December for the third month in a row, 2024 was the worst year for home sales in nearly 30 years. worse than 2023, which had been the worst in de-

New data on pending home sales points to potentially further declines in coming months. The Nation-

al Association of Realtor's pending home sales index fell 5.5% in December from the previous month, ending a four-month streak of increases.

A lag of a month or two usually exists between when a contract is signed and when the home sale is finalized, which makes pending home sales a bellwether for future completed home sales.

For those hoping that mortgage rates will retreat significantly, economists say that's unlikely.

Forecasts mostly call for the average rate on a 30year mortgage to remain above 6% this year, with some economists including an upper range as high

The Federal Reserve left its benchmark interest rate unchanged last week after cutting it three times in a row to close 2024, a sign of a more cautious approach as the Fed seeks to gauge where inflation is headed and what policies the Trump administration

# **Baltic states sever final energy ties with Russia**

VILNIUS, Feb 8, (AP): The flow of electricity between the Baltic countries of Estonia, Latvia and Lithuania and Russia was officially severed Saturday morning after officials switched off the Soviet-era grid's transmission lines and prepared to join the rest of Europe on Sunday.

This came more than three decades after the collapse of the Soviet Union, ending the Baltics' final ties to oil- and gas-rich Russia. For the three countries, as well as the rest of Europe, the move was steeped in geopolitical and symbolic signifi-

"The Baltic energy system is finally in our hands, we are in full control," Lithuania Energy minister Žygimantas Vaiciunas told reporters.

On Saturday, all remaining transmission lines between them and Russia, Belarus and the Russian exclave of Kaliningrad, wedged between EU members Poland and Lithuania and the sea, were switched off one by one. Lithuania first - where a specially-made 9-meter (about 29-foot) tall clock in downtown Vilnius counted down the final seconds - then Latvia a few minutes later, followed by Estonia.

For 24 hours after detaching from the Soviet-era grid, the Baltic Power System will operate independently. If all goes as planned, the power system will merge with the European energy networks on Sunday afternoon through several links with Finland, Sweden and Poland.

European Commission President Ursula von der Leyen, as well as the presidents of Poland and the Baltic states, are expected for a ceremony in Vilnius on Sunday evening along with other dig-

The Baltic countries, which are all NATO members, have often had chilly ties with Russia since de-

claring independence from the USSR in 1990 - and relations soured further over Russia's full-scale invasion of Ukraine in 2022.

# Lamar vows to bring raw storytelling to Super Bowl

NEW ORLEANS, Feb 8, (AP): Kendrick Lamar aims to infuse his Los Angeles hip-hop flavor into New Orleans while staying true to his storytelling roots during Sunday's Super Bowl halftime performance.

"Being in the now and being just locked-in to how I feel and the energy I have now, that's the L.A. energy for me," he said Thursday at a press conference hosted by Apple Music. "That's something I wanted to carry over to New Orleans and for the world to see. This is me. This is Kendrick Lamar, 37 years old, and I still feel like I'm elevating, I'm still on

a journey.' The rap megastar will take the Super Bowl stage fresh off a Grammy triumph, where he claimed two of the night's biggest awards - song and record of the year - for his diss track "Not Like Us."

When asked what viewers can expect, Lamar answered: "Storytelling. I think I've always been very open about storytelling through all my catalog and my history of music. And I've always had a passion about bringing that on whatever stage I'm on.'

Lamar will be bringing hip-hop back to the NFL's championship game, where he performed as a guest artist with Dr. Dre, Snoop Dogg, Mary J. Blige, 50 Cent and Eminem in

2022. On Sunday, he becomes the first solo hip-hop artist to headline the halftime show.

"It reminds me of the essence and the core response of rap and hip-hop and how far it can go," he said. "It puts the culture at the forefront, where it needs to be and not minimized to just a catchy song or verse. This is a true art form, so to represent it on this type of stage is like everything that I've worked for and everything that I believe in as far as the

SZA will join him but few other details about the performance were revealed, bowing to a tradition in which head-liners keep their plans secret. Rihanna waited until her Super Bowl performance in 2023 to reveal she was pregnant with her second child.

The Super Bowl will be held Sunday at the Caesars Superdome, with the two-defending champions Kansas City Chiefs facing off against the Philadelphia Eagles in a championship rematch.

The Super Bowl pregame will have some Louisiana flavor: Jon Batiste will hit the stage to sing the national anthem, while Trombone Shorty and Lauren Daigle are slated to perform "America the Beautiful."

Batiste said he'll be thinking of his grandfather, a veteran

who recently died.

"I think about a lot of people in my life who have represented what I believe this song is about and should be about at its highest aspirational level," he said. "When I channel that, it makes it feel like it's me. But it's way bigger than me. I'm just a vessel for that energy in the world to continue. If that can happen, I might get choked up."

Ledisi will perform "Lift Every Voice and Sing" as part

of the pregame performances.

The national anthem and "America the Beautiful" will be performed by actor Stephanie Nogueras in American sign language. Otis Jones IV will sign "Lift Every Voice and Sing," and the halftime show will be signed by Matt Maxey.

The pregame performers are all Louisiana natives. In just a week, Lamar will go from dominating the Grammys with five wins in all his categories to taking center stage at the Super Bowl halftime show.

Fresh off releasing his highly-acclaimed album "GNX," Lamar is also gearing up for a major tour alongside SZA, his former Top Dawg Entertainment labelmate. The Grand National Tour kicks off April 19 in Minneapolis and concludes June 18 in Washington, D.C.

"I'm honored to be next to her talent," Lamar said of SZA.

LOS ANGELES, Feb 8, (AP): A\$AP Rocky's longtime friend and collaborator testified at his Los Angeles trial Friday that the hip-hop star fired a starter pistol that he carried as a prop during a scuffle with a former friend on a Hollywood street in 2021.

The testimony from the man who goes by A\$AP Twelvyy who was part of the same A\$AP Mob crew as both the accuser and the defendant dating back to high school - is essential to Rocky's defense against two felony counts of assault with a semiautomatic

Twelvyy's testimony suggested Rocky's accuser, their mutual friend who goes by A\$AP Relli, knew the pistol wasn't real when Rocky first pulled it out.

"He told him to shoot that fakeass gun," Twelvyy said under defense questioning.

#### **Deterrent**

Twelvyy testified that when Rocky did fire the gun, it was only to deter Relli from attacking a fourth crew member at the scene, A\$AP Illz,

Deputy District Attorney John Lewin seized on this during his cross examination.

"Can vou explain to me," he asked, "how pulling out a prop gun that Relli knew was fake was going to act as a deterrent to anything? "The sound," Twelvyy an-

swered. "The sound," Lewin repeated back incredulously. "Can you ex-

plain how the sound of a gun that somebody knows is phony and not real is going to scare anybody?" Twelvyy replied, "It's so loud

that you would think it was a real gunshot and move away.'

The A\$AP Mob was a crew of musicians and other creators that formed at a New York high school nearly 20 years ago.

But just one member, Rocky, became a major mainstream success starting in the early 2010s with a pair of No. 1 albums. He has since been nominated for three Grammys, but has become known as much for his dealings in fashion as his music, and for his relationship with Rihanna, with whom he has two toddler sons.

Twelvyy, a rapper whose legal name is Jamel Phillips, has acted as an on-stage hype man for Rocky and appeared in his music videos.

He said that he saw Rocky with the starter pistol three times, first on a New York music video shoot in July 2021, then at a Harlem block party in September of that year, and then in Los Angeles shortly before the Nov. 6 incident.

"This is still like COVID era so he didn't have security." Twelvyy said. "And that was basically his line of defense.'

Lewin later asked him how he could've known it was a prop gun in the first place, and how he might have known that the one he pulled out in Los Angeles was the one he'd seen earlier.

A bloody and cartoonish mess

# Quan, DeBose lead action-comedy 'Love Hurts'

LOS ANGELES, Feb 8, (AP): Ke Huy Quan plays a happygo-lucky real estate agent named Marvin Gable whose past life as a hitman comes back to haunt him in "Love Hurts." The action-comedy goes hard on elaborately choreographed fight sequences and violent, bloody deaths. Anything from a boba straw to a cookie cutter is fair game in these gruesome

But while the derivative and cartoonish spectacle can be fun and impressive at times, "Love Hurts" just doesn't work in the end, hampered by a lack of directorial vision, comedic pacing and an ensemble of caricatures instead of characters. "Love Hurts" may only run 83 minutes, but if you've seen the 2:41 trailer, you've kind of seen it all.

It had a lot going for it too, including two recent Oscar winners in Quan and "West Side Story's" Ariana DeBose in the lead roles, a fine premise and a hoard of fun actors in the ensemble. Sean Astin plays Quan's boss at the real estate agency, a stunty, nostalgia play for "Goonies" fans that actually gives the film a rare, touching, authentic moment, and Marshawn Lynch, who is proving himself to be a comedic gem no matter the material. But there's something immensely off about the tone, which isn't clever or silly enough to be funny, and its ham-fisted attempts to tie it to Valentine's Day with various subplots about love,

from the jaded assistant who falls for a poetry-writing goon to another hired thug who is trying to get his wife (who we never meet) back.

Poor Quan is the one who must do all the cringey voiceover, though he mostly comes out unscathed. As audiences saw in "Everything Everywhere All at Once," he's great at switching believably between debonair fighter and tame nice guy, and he is undeniably compelling as a lead. He just needs a better movie

around him. DeBose, on the other hand, has only a barely-there character to play with. Rose Carlisle is a thinly drawn femme fatale in heels and leopard print coats with a penchant for laughing maniacally and drawing mustaches on Marvin's real estate billboards. She was supposed to be dead after a deal gone wrong, but Marvin spared her because of love, I guess. Now she wants her life back, and, presumably, Marvin, though their chemistry might suggest otherwise. Basically, she needs to kill his crime lord brother Knuckles (Daniel Wu, whose defining character trait is sinisterly drinking boba) to be free. There's a lot of talk about "hiding ain't living" which sounds fine in theory but never quite syncs up - Marvin likes his new, non-violent life.

Like "John Wick," "The Fall Guy" and other less memorable

movies, "Love Hurts" is the latest in a string of films directed by guys who cut their teeth as stuntmen. This is a tale as old as cinema, but most recent efforts usually seem to have a common denominator in David Leitch, who has a producer credit on this one. Directing responsibilities on "Love Hurts" went to Jonathan Eusebio, who was a fight coordinator on "John Wick," and perhaps needed a bit more help here - a better script, sharper editing that could help the comedic moments work better and a coherent vision.

Artificiality as an aesthetic is all fine and good, but "Love Hurts" feels a little too much like the charmless, ripped-fromthe-Magnolia-showroom homes that Marvin is hawking to perky yuppies around Milwaukee. It may seem good enough in a Zillow photo or a movie trailer, a facsimile of what we think homes and films of a certain quality should look like. But spend a little time with the plastic-y sliding barn door, or the goon whose only zinger seems to be calling Rose the B-word, and you come to realize that it's all hollow underneath - a "Truman Show" set without the real world behind it.

"Love Hurts," a Universal Pictures released in theaters Friday, is rated R by the Motion Picture Association for "strong, bloody violence and language throughout." Running time: 83 minutes. One and a half stars out of four.

Def Jam Recordings, which was the parent company of Murder Inc., announced Gotti's death in a statement late Wednesday night. It did not give a cause of death.

Gotti, whose real name was Irving Lorenzo, created the iconic hip-hop and R&B imprint with his brother in the late 1990s, with the label gaining worldwide prominence through platinum-selling artists Ashanti and Ja Rule. Gotti also worked with some of rap's most legendary artists like Jay-Z, Nas and DMX, among other huge names in the genre.

"His creative genius and unwavering dedication to the culture birthed countless hits, defining an era of music that continues to resonate with fans worldwide," the statement from Def

Murder Inc.'s blazing run in the early 2000s produced some of music's biggest crossover records, usually involving his two biggest stars, like Ja Rule and Ashanti's "Always On "I'm Real" by Jennifer Lopez and Ja Rule, "Foolish" by Ashanti and "What's Luv" by Fat Joe featuring Ja Rule and Ashanti. ## 1714 Stradivarius violin sells for \$11.3m at auction

NEW YORK, Feb 8, (AP): A violin made in 1714 by the legendary luthier Antonio Stradivari sold for \$11.3 million at an auction in New York on Friday, short of estimates that would have made it the most expensive instrument ever sold.

Sotheby's auction house had estimated that the "Joachim-Ma Stradivarius" violin could sell for between \$12 million and \$18 million, with the higher end of the range potentially eclipsing the record-breaking \$15.9 million someone paid for another Stradivari violin at auction more than a decade ago.

The "Joachim-Ma Stradivarius" is regarded as one of Stradivari's best works, built during his "Golden Period" at the height of his craftsmanship and acoustic mastery, according to the auction house.

Adding to the intrigue, the violin is believed to have influenced legendary composer Johannes Brahms when he wrote the famed "Violin Concerto in D Major" and was actually played during the concerto's 1879 premiere.

"This extraordinary violin represents the pinnacle of craftsmanship and classical music history, its unparalleled sound and storied provenance captivating collectors and musicians alike," Mari-Claudia Jimenez, chair at Sotheby's. "The Joachim-Ma Stradivarius garnered global attention, achieving one of the highest prices ever for a musical instrument - an acknowledgment of its rarity and historical importance.

Bidding at Sotheby's began at \$8 million and within seconds shot up to \$10 million, as auctioneer Phyllis Kao scanned the room, looking for someone to put up \$10.5

"Am I selling? At \$10 million," she said, looking to potential bidders.

The room was quiet. "Last chance, at \$10 million," she said. "I can sell, and I will, at \$10 million, unless

you go on."
"Sold. \$10 million," she said, banging a gavel.

The final price includes auction house

The name of the instrument comes from two of its famous violin virtuoso owners, Joseph Joachim of Hungary and Si-Hon Ma of China. Ma's estate gifted the violin to the New England Conservatory in Boston after his death.

The conservatory will use the proceeds to fund student scholarships.

"The sale is transformational for future students, and proceeds will establish the largest named endowed scholarship at New England Conservatory," said Andrea Kalyn, president of New England Conservatory. "It has been an honor to have the Joachim-Ma Stradivari on campus, and we are eager to watch its legacy continue on the world stage.



HONOLULU: Jim Becker, a worldtraveling journalist who covered Jackie Robinson's big-league baseball debut and the US Army's retaking of Seoul during the Korean War, died Friday. He was 98.

He died of natural causes at a Honolulu hospital, said his goddaughter Carla Escoda Brooks.

Becker served as an Associated Press bureau chief in Manila, New Delhi and Honolulu and covered Margaret Thatcher as a freelance journalist in London. But he said his most important story was about an underdog Hawaii high school football team that won a league championship, a tale he told as a Honolulu

Star-Bulletin columnist. Becker joined the AP in 1946 fresh out of the Army when he walked into the wire service's New York headquarters without an appointment and was hired to start the next day.

He watched Robinson become the first Black player on a Major League baseball team when editors sent him to the trailblazing athlete's first game as a Brooklyn Dodger.

Nearly half of Robinson's teammates had signed a petition because they didn't want to play with a Black man. But the stadium crowd was supportive of Robinson, Becker said, adding that half of Brooklyn was Jewish "and they knew a little something about prejudice." (AP)

**NEW YORK:** The next novel by Ian McEwan will be a post-apocalyptic story, set in part in the 22nd century and centered on a scholar's immersion into a poem written during hap-

pier times. McEwan, the Booker Prize-winning British author, is calling "What We Can Know" a work of science

fiction "without the science." "I've written a novel about a quest, a crime, revenge, fame, a tangled love affair, mental illness, love of nature and poetry, and how, through all natural and self-inflicted catastrophes, we have the knack of surviving," McEwan said in a state-ment released Friday through Alfred A. Knopf, which announced the

book will be published Sept. 16. "In our times, we know more about the world than we ever did, and such knowledge will be hard to erase. My ambition in this novel was to let the past, present and future address each other across the barriers of time.'

The 76-year-old McEwan has previously imagined disasters and disruptions - and how we respond whether the threat of climate change in "Solar," a radiation cloud in "Lessons" or artificial intelligence in "Machines Like Me." Knopf publisher and editor-in-chief Jordan Pavlin said in a statement that "What We Can Know" is an exploration of the "limits of our knowledge," whether of other people or the arc of the past.

"As the title suggests, the book calls into question the limits of our knowledge about our most intimate companions, and about history itself. Pavlin said. "How many irrecoverable secrets and stories are lost to the past? McEwan's genius in this novel is to recover, in an exquisite feat of storytelling, a long-lost secret." (AP)

#### **Axiom crew prep** for space mission

WARSAW, Poland, Feb 5, (AP): What do a wedding necklace, Polish savory dumplings and a photo of Hungary's first astronaut have in common?

They will all be among personal items taken by astronauts journeying to the International Space Station (ISS) in the spring. The date has not yet been set.

The four members of the Axiom mission hail from the US, India, Hungary and Poland and will travel on the Space X Crew Dragon spaceship.

At a news conference Wednesday, three of the astronauts said they were having the time of their lives, training hard for their travel as well as preparing for the medical and technological experiments they will conduct during the nearly two weeks they will spend in space.

"We have to remind ourselves that space flight is a risky and serious business but it's also fun and, next to space flight, the training for a space flight is the next best thing, so we are having a time of our lives," mission pilot Tibor Kapu said in English.

Sławosz Uznaski-Winiewski said the hardest parts of the training were the "waiting and the uncertainty" as well as being away from home and not having "too much family time.'

The head of the European Space Agency, Josef Aschbacher, stressed that space research was "strategic" for many rea-

sons, including security.

Crew members will take with

them items of national and personal significance. Retired U.S. astronaut Peggy

Whitson, the mission commander, who has a doctorate in biochemistry, is taking the necklace that she wore at her wedding, along with photos of the crew and her family.

Uznaski-Winiewski is taking freeze-dried Polish traditional pierogi, or dumplings, along with poems by Wisława Szymborska, a Nobel literature laureate; music by Frédéric Chopin; a piece of amber; and some salt from the historic Wieliczka salt mine. He will also have a small national white-and-red flag that Poland's first man in outer space, Mirosław Hermaszewski, wore on his suit in 1978.

# Flu season in the US is the most intense it has been in 15 years

NEW YORK, Feb 8, (AP): The US winter virus season is in full force, and by one measure is the most intense in

One indicator of flu activity is the percentage of doctor's office visits driven by flu-like symptoms. Last week, that number was clearly higher than the peak of any winter flu season since 2009-2010, when a swine flu pandemic hit the nation, according to data posted Friday morning by the Centers for Disease Control and Pre-

Of course, other viral infections can be mistaken for flu. But COVID-19 appears to be on the decline, according to hospital data and to CDC modeling projections. Available data also suggests another respiratory illness, RSV, has been fading nationally. The flu has forced schools to shut

down in some states. The Godley Independent School District, a 3,200-student system near Fort Worth, Texas, last week closed for three days after 650 students and 60 staff were out Tuesday.

Jeff Meador, a district spokesman, said the vast majority of illnesses there have been flu, plus some strep throat. He called it the worst flu season he could remember.

So far this season, the CDC estimates, there have been at least 24 million flu illnesses, 310,000 hospitalizations and 13,000 deaths - including at least 57 children. Traditionally, flu season peaks around February.

Overall, 43 states reported high or very high flu activity last week. Flu was most intense in the South, Southwest and western states.

In Rochester, New York, the flu season has been intense but not necessarily worse than at the peak of other vears, said Dr. Elizabeth Murray, a pediatric emergency medicine doctor at the University of Rochester Medical

She said there's a lot of flu, but there's also still a lot of RSV and a surprising number of babies with COVÎD-19.

"All of the respiratory illnesses are around, with a vengeance," Murray

The CDC declined to let an Associated Press reporter speak to an agency flu expert about recent trends. The Trump administration ordered a temporary "pause" on health agency communications and has continued to refuse interview requests that were routinely granted in the past.

Late Friday afternoon, a CDC spokesperson acknowledged that the new data shows "the highest absolute value" of flu-like illness when compared with other seasons, but added that the statistic is complicated: That value references a baseline estimate for doctor's office visits, but the baseline is recalculated every year. In late January, the CDC was describing the season as "moderate" in severity.

US health officials recommends that everyone 6 months and older get an annual flu vaccination.

#### Argentina to exit WHO

## **WHO** warns of Gaza's critical health needs as hospitals shut

NEW YORK, Feb 8, (Agencies): The World Health Organization (WHO) said that the health needs of the Gaza Strip are enormous as many hospitals and health centers are out of service.

In a virtual press briefing from Gaza late Thursday, WHO Representative in the West Bank and Gaza Rik Peeperkorn said Al-Awda Hospital is the only partially functional medical facility in northern Gaza and Kamal Adwan Hospital has been completely destroyed and the Indonesian Hospital is out of service.

He added that in southern Gaza, the three main hospitals, notably the Kuwaiti Hospital, Al-Emirati Field Hospital and Al-Najjar Hospital, are not functional.

He emphasized that 12,000 and 14,000 patients, including at least 5,000 children, are in need of medical evacuation out of Gaza.

As the Rafah frontier crossing has been opened for evacuations, he regretted that it is not sufficient.

"We need to expedite (medical evacuations). There should be more patients going through Rafah into Egypt. But we also want other medical corridors," he said.

On the health situation in the West Bank, the WHO representative said the WHO is trying to provide all supplies for main hospitals and medical facilities there.

Meanwhile, Argentina's president has ordered the country's withdrawal from the World Health Organization due to "profound differences" with the UN agency, a presidential spokes-person said Wednesday.

President Javier Milei 's decision echoes that of his ally, US President Donald Trump, who began the process of pulling the United States out of WHO with an executive order on his first day back in office on Jan. 21.

The loss of another member country will further fracture cooperation in global health, though Argentina was expected to provide only about \$8 million to WHO for the agency's estimated \$6.9 billion 2024-2025

Argentina's decision is based on 'profound differences in health management, especially during the (CO-VID-19) pandemic," spokesperson Manuel Adorni told a news conference in Buenos Aires. He said WHO guidelines at the time led to the largest shutdown "in the history of man-

Argentina will not allow an international organization to intervene in its sovereignty "and much less in our

## Uganda implements Ebola screening to prevent spread

KAMPALA, Feb 8, (Xinhua): Ugan- screening starting fully at Entebbe da has started screening departing travelers for Sudan Ebola virus disease (SVD) at the East African country's border points to prevent the exportation of the virus.

Travelers departing through Ugan-da's 53 designated border points and Entebbe International Airport, the country's main international gateway, are being screened for the deadly viral hemorrhagic fever, Henry Kyobe Bosa, incident commander at the Ministry of Health, told Xinhua by telephone.

Bosa said a thermal scanner has been deployed at the Entebbe airport for departing travelers for high-temperature detection, and sanitization measures have also been instituted.

"We have heightened active surveillance. We have instituted exit airport, and we are rolling the same across the entire 53 designated border points," said Bosa. "If the temperature is detected high, then that individual will be refused to exit and linked to the isolation. This is to ensure that we localize the Ebola outbreak within the country without spreading it out."

Uganda last week declared an Ebola outbreak after a 32-year-old nurse succumbed to the disease. The country's Ministry of Health said two relatives of the index case have tested positive for the virus and 234 people who had contact with the deceased have been identified and isolated.

With the World Health Organization and other partners, Uganda is currently carrying out a clinical efficacy trial for a vaccine for the Sudan variant of the Ebola virus.

# **South Sudan confirms first case of mpox**

JUBA, Feb 8, (Xinhua): South Sudan on Friday confirmed its first mpox case, with authorities pledging heightened vigilance to prevent further transmission.

Acting Minister of Health James Hoth Mai said the National Public Health Laboratory confirmed the case in a Ugandan national who had recently traveled to his home

country, where an active outbreak is ongoing.

"This outbreak has been declared following confirmation by the National Public Health Laboratory on Thursday using real-time polymerase chain reaction testing of skin lesion samples collected from a 31-year-old male, a Ugandan national," Mai told reporters in Juba, the capital of South Sudan.

He said the health ministry has activated the Public Health Emergency Operations Center to coordinate the response, leveraging existing incident management systems currently addressing cholera and other public health emergencies.

The minister added that the confirmed case is under isolation at Gudele Hospital, where a team of experts from the government and partner organizations has been mobilized to conduct a detailed field investigation, trace contacts, and ensure close monitoring.

Meanwhile, a total of 107 people have been killed in the ongoing mpox outbreak in Africa since the beginning of 2025, according to the Africa Centers for Disease Control and Prevention (Africa CDC). More than 13,500 mpox cases have been reported in 12 African countries, of which 3,683 were confirmed, Africa CDC Director-General Jean Kaseya told an online media briefing Thursday.

#### **Fueled by England and Saudi Arabia**

# Record January transfers in men's soccer valued at \$2.35b with almost 6,000 deals

ZURICH, Feb 8, (AP): Fueled by England and Saudi Arabia, clubs spent a record \$2.35 billion on international transfer deals in a booming January trading period for men's soccer, FIFA said.

The 5,863 international transfers - those between clubs in different countries that are processed by FIFA — also was 900 more than the previous highest, which was recorded last year.

In January 2024, only one transfer — Gonçalo Ramos confirming a permanent move to Paris Saint-Germain from Benfica - was reportedly valued at more than 30 million euros (\$31 million).

There were 10 such transfer fees agreed last month, including four to Manchester City, and topped by Colombia forward Jhon Durán's \$80 million move from Aston Villa to join Cristiano Ronaldo at Saudi club Al Nassr.

English clubs collectively spent the most with a \$621.6 million outlay on transfer fees and recouped just \$186 million selling players to clubs in other countries.

The next biggest deficit was Saudi Arabia, where clubs spent more than \$160 million above what they earned. The spending of \$202 million was mostly fueled by Al Nassr, Al Hilal and other clubs all owned

with sovereign wealth by the Public Investment Fund.

German clubs spent \$295.7 million, which was mostly offset by earning \$226.2 million in transfer

French clubs took in the highest total of transfer fees, \$371 million, and spent just \$209.7 million to make a collective profit of more than \$160 million.

Clubs in Portugal made sales of \$176.4 million and spent only

\$40.2 million for a combined profit of \$136 million.

In the United States, clubs spent \$145 million and took in \$125 million in transfer fees, according to FIFA research.

Eight months after his last competitive match, Spanish defender Sergio Ramos will resume his illustrious career on another conti-

nent. Ramos, who will turn 39 in March, will play for Monterrey of Liga MX in Mexico where he will have a chance to play in the next edition of the FIFA Club World

The veteran, who won the World Cup in South Africa 2010, has not played an official match since May of last year when he was playing for Sevilla in the Spanish league.

Monterrey, one of the most economically powerful clubs in Mexico, did not reveal the details of the agreement.

'We have been trying to sign him since last summer, but we did not come to terms and we tried again in this new window," said Monterrev's team president Jose Antonio Noriega. "The team needs him, he has quality, enormous experience, enormous personality and he is an undisputed leader."

Monterrey, commonly known as Rayados, are one of three Mexican teams that will participate in the first edition of the expanded Club World Cup set to be played in the U.S. next summer. The other two are León and Pachuca.

Ramos also won Euro 2012 with Spain and five Spanish League titles and four Champions League titles with Real Madrid, where he played for 16 seasons.

#### Short-handed Suns rally past Jazz

NEW YORK, Feb 8, (AP): Cam Johnson scored 18 points, D'Angelo Russell had 17 and the Brooklyn **Nets limited Miami to nine** points in the fourth quarter of its first game since trading Jimmy Butler, beating the Heat 102-86.

Miami shot 2 for 21 (9.5%) in the fourth quarter and was out-scored 31-9 after leading by six through three quarters.

The Heat didn't have Andrew Wiggins, Kyle Anderson or Davion Mitchell, the three players they acquired in what became a five-team deal when they sent Butler to the Golden State Warriors. Terry Rozier scored 20 points off the bench for the Heat and Bam Adebayo added 18.

Nic Claxton had 12 points, 10 re-

bounds and four blocks for Brooklyn.

#### Suns 135, Jazz 127

In Phoenix, Devin Booker scored a season-high 47 points, Grayson Allen hit a 3-pointer at the buzzer to force overtime and the short-handed Phoenix Suns rallied to beat the Utah

With 0.8 seconds left in regulation, Allen caught an inbounds pass and hit the 3-pointer from the right wing to tie it at 122. Allen opened the extra period with another 3 and the Suns scored the first eight points of overtime to pull away and snap a

three-game losing streak.

John Collins led Utah with 21 points.. Lauri Markkanen added 20. The Suns led 111-98 with 5:31 left in regulation, and the Jazz responded with a 13-0 run to tie it. Utah led

Scottie Barnes scored 21 points and Gradey Dick added 17 for the Raptors, who lost their third in a row.

#### Cavaliers 134, Wizards 124

In Washington, Donovan Mitchell ed 27 and the Cleveland Cavaliers pulled away late for a 134-124 victory over the Washington Wizards.

Darius Garland added 23 points and Jarrett Allen had 12 points and 12 rebounds to help the Eastern Conference leaders win for the sixth time in their last seven games.

Jordan Poole scored a career-high 45 points for the NBA-worst Wizards, who were trying to extend a

# Man City survives Orient scare

Man United beats Leicester in dramatic FA Cup

LONDON, Feb 8, (AP): Manchester City survived a scare against third-division Leyton Orient on Saturday to advance to the fifth round of the FA Cup.

Orient threatened to pull off a famous upset when it led 1-0 at halftime against Pep Guardiola's fourtime defending Premier League champion.

But City fought back after the break with goals from substitutes Abdukodir Khusanov and Kevin De Bruyne.

"That's why this competition is unbelievable," Guardiola said.

Orient went ahead in spectacular fashion when Jamie Donley's shot from just past the halfway line hit the bar and rebounded off the back of City goalkeeper Stefan Ortega into the back of the net in the 16th minute at Brisbane Road.

It was officially credited as an own goal, but Donley took the congratulations as he celebrated wildly in front of the home fans. He was also rewarded with the player-of-the-match award. But the goal wasn't enough to hold

off City's fightback. Rico Lewis' effort deflected of Khusanov in the 56th to level the match and De Bruyne flicked a shot past Josh

Keeley in the 79th to seal victory. It wasn't all good news for Guardiola, however, with \$61.8 million midfielder Nico Gonzalez injured and substituted after 22 minutes of his debut. Leeds, top of division two, was knocked out Millwall - losing 2-0 at

Harry Maguire scored a controversial injury time winner as Manchester United came from behind to beat Leicester 2-1 and move into the last 16 of the FA Cup.

United went behind to a Bobby De Cordova-Reid goal four minutes before halftime. Joshua Zirkzee equalized in the 68th minute and Maguire grabbed the late winner.

There was a heated debate over whether the England center half was in an offside position but there is no VAR in the FA Cup and the goal stood.

"This (loss) wasn't necessary," an unhappy Leicester coach Ruud van Nistelrooy told broadcaster ITV.

"This was half a meter (offside). Then extra time, stay in the game, you never know what happens. We deserved to go into extra time and maybe penalties. Decisions like these in our level are hard to swallow.'

The result marked the first time in

United's history that the club has won three times at home against the same team in the same season. United beat Leicester 5-2 in the League Cup and 3-0 in the Premier League at Old Trafford.

The result was a boost for new coach Ruben Amorim and a bitter letdown for Van Nistelrooy, who was the interim manager at United before being moved on and taking charge at Leicester, a one-time FA Cup cham-

pion, was 1-0 up at the break. Manuel Ugarte was dispossessed near the touchline and Bilai El Khannouss' low cross was hit goal-bound by Wilfred Ndidi but deflected in off De Cordova-

The introduction of substitutes Alejandro Garnacho and Zirkzee lifted United in the second half and Zirkzee got the equalizer with the simplest of finishes after good work from the Argentine player down the left flank.

Then, just as the game looked like going into extra time, Bruno Fernandes threw a long ball into the box for Maguire to head the winner.

"(It was a) great finish to the game," Maguire said. "The second half we played a lot better. The first half was nowhere near good enough, we played at a slow tempo and we didn't really

#### Australia on the brink of series sweep after dominant third day

There was a winning sign for China until the last two laps when Lin Xiaojun tumbled off the ice on the curve right after taking over the lead from Liu Shaoang.

China eventually finished fourth, while South Korea clocked two minutes and 41.534 seconds to cross the finish line first.

Within two hours, Lin stepped on the men's 1,500m final track with high hopes. In a nail-biting sprint, Lin finished 0.029 seconds behind to settle for the second place, while Park Jiwon of South Korea claimed gold in two minutes and 16.927 seconds. It didn't take long for Lin to bounce back, as the 28-year-old broke through under pressure from South Korean skat-

ers in the men's 500m final, clocking 41.150 seconds to take the gold. South Korea's Park and Jang Sung-woo took the silver and bronze respectively.

In other short track speed skating races, Kim Gil-li of South Korea won the women's 1,500m final, with China's Gong Li and Zang Yize taking silver and bronze respectively. Choi Min-jeong of South Korea pocketed the women's 500m gold.

China took three of four speed skating gold medals on Saturday. Ning Zhongyan, one of the Chinese delegation's flagbearers at the opening ceremony, won the men's 1,500m race, while Chinese skaters swept the women's 1,500m podium, with Han Mei bagging the gold. China's Olympic champion Gao Tingyu took the men's 100m gold, while Lee Na-hyun of South Korea won the women's 100m

Several Chinese skiers put on remarkable performances on snow at the Yabuli Ski Resort.

Li Fanghui secured the host nation's first gold medal at the Harbin Games, triumphing in the women's freeski halfpipe event. The 21-year-old led the competition with a score of 95.25 points, with compatriot Zhang Kexin claiming silver with 89.25.
