

WGS key to global progress, says PM

DUBAI, Feb 10, (KUNA): The World Governments Summit in Dubai is a global platform for exchanging expertise amongst global leaders, enabling decision-making, which shapes the world's future and its sustainable development, said His Highness the Prime Minister Sheikh Ahmad Abdullah Al-Ahmad Al-Sabah on Monday.

This statement came after His Highness the Prime Minister and the accompanying delegation's arrival to the UAE.

The WGS is held during rapid challenges facing the world, which made it paramount for governments around the globe to address and find solutions, he stressed, saying that the summit was a chance for bettering government services, cooperation as well as boosting productivity.

Consumer goods up 2.1%

Kuwait's wholesale price index sees 0.7% increase

KUWAIT CITY, Feb 10: The general index of wholesale prices in Kuwait increased by approximately 0.7 percent on an annual basis by the end of December 2024, reports Al-Seyassah daily.

According to a statement from the Central Statistical Bureau, the index reached 149.4 points at the end of the fourth quarter of 2024, compared to 148.3 points in the same quarter of 2023.

The index for imported goods rose by 0.4 percent, local goods by 1.3 percent, and the index for materials in the agriculture and fishing sector increased by 2.7 percent. This was driven by a 2.2 percent rise in prices for crop cultivation and animal production activities, a 0.3 percent increase in the prices of imported goods, and an 8.1 percent rise in local goods prices.

The index for the mining and quarrying sector fell by 0.9 percent, due to a 0.7 percent decrease in sand and crushed stone prices and a 3.2 percent drop in local goods prices, while imported goods rose by 0.8 percent.



Acting PM calls for collective action in tackling regional risks

Kuwait leads disaster risk reduction at Arab forum

KUWAIT CITY, Feb 10: Acting Prime Minister and Minister of Interior Sheikh Fahad Yousef Saud Al-Sabah affirmed that the State of Kuwait is keen on strengthening regional cooperation, and to become a model of lead-

ership and collective responsibility. In his opening speech at the Sixth Arab Regional Forum for Disaster Risk Reduction that Kuwait is hosting from Feb 9-12, Sheikh Fahad Al-Yousef pointed out that Arab countries today live in a world characterized by the increasing frequency and diversity of natural and human risks. "This requires us to work intensively and rapidly to develop our capabilities to adapt and confront these risks," he

He added "Kuwait has many national initiatives in the field of disaster risk reduction, considering it has achieved tangible progress in strengthening governance and building national capacities in this field.'

He pointed out that the challenges the countries in the region are currently facing necessitate strong regional and international cooperation; indicating the agenda of the forum consists of vital topics that aim to raise awareness, improve knowledge of risks, invest in resilience, and build a sustainable development system that is aware of risks.

He confirmed that "Kuwait has completed a strategy that is considered a declaration for disaster risk reduction, out of its desire to develop policies and procedures to mitigate disaster risks." He called for the discussion and adoption of this strategy in order to establish a strong political framework that supports the implementation of the Sendai Framework and Arab Strategy for Disaster Risk Reduction

He stressed that the 'Kuwait Declaration' is

not just a document; as it is rather an expression of the collective will to expedite work in this field, which reflects the political commitment of Arab countries.

He praised the role played by regional and international partnerships in achieving common goals, cooperation between Arab countries, and the exchange of expertise and knowledge to achieve the desired progress in the field of disaster risk reduction.

A total of 22 Arab countries and a number of international organizations attended the forum, during which they will adopt a disaster risk reduction strategy developed in the name of the State of Kuwait and will implemented in the next three years by all Arab countries.

This forum is jointly organized by the Government of the State of Kuwait and the Regional Office for Arab States of the United Nations Office for Disaster Risk Reduction in partnership with the Arab League.

It highlights the continuation and follow up of what Arab countries have achieved, as well as evaluate the progress in the implementation of the Sendai Global Framework for Disaster Risk Reduction and the Arab Strategy for Disaster Risk Reduction 2030, while identifying regional priorities for the next two years and adopting the Kuwait Declaration and an action plan for the period 2025-2027.



KUWAIT CITY, Feb 10: "Kuwait is a regional and global model worthy of emulation in the field of health promotion and sustainable development, under the directives of its wise leadership that focuses on achieving health and national security by overcoming challenges and meeting the requirements of promoting community health and its sustainable development," says Health Minister Dr. Ahmad Al-Awadhi.

In his opening speech at the Second Kuwait Conference on Healthy Cities (Healthy Cities for Community Development), Al-Awadhi pointed out "Kuwait Vision 2035 and the national development plans are considered a strategic framework that puts a major challenge on our shoulders in terms of providing high-quality healthcare for all segments of society.'

He affirmed the ministry is committed to promote and protect public health, ensure the continuation of the health gains it has achieved, and provide a decent and safe life for present and future generations. 'Radical educational reforms must to avert total collapse'

"KUWAIT'S educational system is in dire need of urgent reforms to prevent a total collapse. Education experts and stakeholders have consistently warned that deteriorating academic outcomes indicate that the system has entered a critical danger zone," columnist Talal Abdul Karim Al-Arab wrote for Al-Jarida daily.

"We, alongside many others, have highlighted the decline in educational standards, emphasizing that nations flourish when they cultivate well-educated, committed, and mature youth,

while regression in education leads to scientific stagnation, poor performance, and devel-

opmental setbacks. "Despite massive budgets allocated to education over the years, Kuwait's educational institutions have failed to keep



Talal Al-Arab pace with global standards. Once ranked among the best, they now produce outcomes that are alarmingly shallow compared to other nations.

"The Ministry of Education's budget has quadrupled over the past two decades, increasing from approximately 486 million dinars in 2003 to more than 2.2 billion dinars in 2023.

"However, instead of investing in improving educational institutions and integrating advanced global technologies, 82% of this budget has been directed toward salaries and bonuses.

"This misallocation of resources has resulted in a catastrophic failure. Over the past 20 years, Kuwait has spent more than 29 billion dinars on education, yet the system remains in its worst state in history.

"Corruption has taken root, with widespread cheating, fraudulent academic achievements, and an influx of unqualified teachers holding forged certificates. The introduction of fingerprint attendance controls only further exposed the laxity in educational institutions.

"Meanwhile, substantial financial rewards were distributed under the pretext of "excellent work," without yielding any tangible improvements in academic performance.

"As a consequence, Kuwait ranks at the bottom of international education indices, failing to meet both global and regional benchmarks. Education specialist Dr. Rawaa Al-Jarallah recently revealed alarming statistics in an interview with the insightful Ahmed Mohammed Al-Barjas

"She highlighted the stark contrast between Kuwait's education system and those of other nations, not only in terms of quality but also in the total time students spend in education before gradu-

"While students in developed countries of study before earning a university degree, Kuwaiti students complete their education in just six years. The root causes are evident -- excessive holidays, rampant absenteeism, and a culture of avoiding

both learning and teaching "Perhaps most concerning is the ne-glect of the Arabic language, the cornerstone of our cultural identity. Kuwait ranks the worst in the Arab world in

Arabic language instruction.
"While global standards demand between 350 and 380 hours of study in a native language, Kuwaiti students receive a mere 200 hours. The result? Some children reach the age of 10 without even knowing how to read or write properly.
"The Ministry of Education aspires to

adopt best practices from top-performing education systems like those of Finland, Singapore, and South Korea.

"However, implementing these reforms will take years before yielding any tangible benefits. In the meantime, Kuwait continues to suffer the consequences of an education system in cri-

"The question is no longer whether Kuwait can afford to fix its education system -- it is whether it can afford not to. Without immediate and radical reforms, we risk condemning future generations to mediocrity, stagnation, and irrelevance in an increasingly competitive world."

Also:

"US President Donald Trump's proposals to deport the people of Gaza to other countries are nothing more than an attempt to repeat the tragedy of the 'Trail of Tears' that took place between 1830 and 1850. At that time, the US Congress passed two important laws: the Reallocation Act and the Indian Removal Act," columnist Dr Abdullah Sahar wrote for Al-Rai daily.

"The then US President Andrew Jackson used these laws to implement the forced displacement of some indigenous tribes, especially the Choctaw, Seminole, Cherokee, and Shawnee, who were among the largest tribes that learned agriculture and adapted to the modern lifestyle, making them the most 'civilized' in the eyes of European settlers immigrating to America.

"But this 'civilization and adaptation' did not help them, as they were forcibly displaced from their fertile lands in the states of Tennessee, Alabama, Georgia, and Mississippi, which were coveted by European settlers, and were transported to other areas hundreds of miles away.

"During this harsh journey, between 15 and 25 thousand indigenous tribesmen died from cold, hunger, and disease, in addition to the mistreatment by the soldiers who supervised their deportation, making it a journey narrated in

"Ironically, during this tragedy, Federal Court Chief Justice John Marshall ruled in favor of the Cherokee tribe, invalidating the Georgia government's decisions targeting Native American lands as unconstitutional, a legal victory

"In response to the ruling, US President Andrew Jackson famously responded with his famous phrase: 'John Marshall has made his decision, now let

"He continued his decisions to for-cibly deport the tribes, disregarding the law, the treaties his government had concluded with the tribes, or even the humanitarian disasters that resulted from this genocide.

"During this period, between 60,000 and 100,000 Native Americans were displaced to remote areas that are now known as the state of Oklahoma.

"This area was not chosen randomly, but because it was poor in resources and undesirable to white settlers, making it an isolated exile for the tribes that were

"Forced displacement was not simply a greed for fertile land or natural resources such as gold, but was part of a dangerous ideological doctrine known as 'Manifest Destiny.

"This idea, which gained wide political acceptance, was based on an ideological religious interpretation that the white man had a divine right and even duty to spread Western civilization to indigenous lands, even if it meant kill-

ing, displacing, and occupying.
"What Netanyahu is doing today in terms of crimes against international law is a reflection of the same fanatical ideology of what is known as Manifest

Destiny. "His extremist ideas, which give him a license to liquidate, kill, and displace others, he has declared indirectly through his speeches, but he has not dared to publicly declare the displacement of the Palestinian people to Arab countries, as Trump did.

"Trump was more explicit when he announced his proposals without any regard for the international resolutions that the US government had previously approved at the United Nations, nor for the rulings issued by international courts, nor even for the treaties con-

cluded by civilized countries. "The fundamental question that arises amidst these incidents is : Is this similarity between American policies in the nineteenth century towards indigenous citizens and what is happening today in Palestine towards indigenous citizens merely a historical similarity, or is it a behavioral approach rooted in ideological fanaticism that permits occupation and considers it a sacred right, even if the price is the annihilation of entire na-

tions and civilizations?"

"I followed some excerpts of the prisoners' handover, especially the most recent. I saw the Palestinian youths, particularly the Hamas fighters, and the quantity of equipment and weapons they carried. I was surprised as there was a large crowd of them, the number is huge -- in thousands. This confirms that all the Israeli allegations about killing a large number of Hamas fighters and the rest of the Palestinian factions are just illusions," Adel Al-Jarallah Al-Kharafi wrote for Al-Seyassah daily.

"The numbers I saw are large, which means that the Palestinian resistance, despite the pain and losses, is fine, and is in its best condition. Therefore, the allegations about the day after the resistance in Gaza are nothing but gibberish. In spite of all the difficulties they have

been facing, these people have not been broken. Thus, Israel will not be able to end the issue, as it plans to do so. It should rather reconsider calculations and accept an independent Palestin-

ian State.

"Also, displacement attempts will not happen -- whether in Gaza or the West Bank, because people of this type cannot be broken by anyone, no matter how strong the latter. They can never be forced to be displaced, especially since they have lived through the displace-ment catastrophe since 1948. They were displaced in camps and suffered from the humiliation of losing security and

homeland for 75 years.

"This spirit of self-sacrifice has not faded through the years. At this point, we remember David Ben-Gurion's statement: The old die and the young forget. He died without witnessing any Palestinian forgetting his land and history.

"In 1969, Golda Meir said: There is no such thing as Palestinians. She denied the right of the Palestinian people to exist. The response came through the operations carried out by the Palestinian resistance movement, which prompted Meir to say a year later: I am ready to listen if there is a glimmer of hope for an independent Arab State in Judea and Samaria (using the biblical name for the West Bank), and perhaps, in Gaza as well. If they call it Palestine, so be it, why should I care?'

"Over the past seven decades, the Israelis and the major western powers have been trying to 'liquidate' the Palestinian cause, but the response has always been the most painful. On Oct 7, 2023, a Palestinian generation that does not believe in compromises was born. Therefore, this guiding spirit makes the miracles of Palestinian history and it will bring about the independent State."

Legal action will be taken against violators, including towing and impounding vehicles and issuing citations. Last year's experience, along with the com-

mitment and cooperation of citizens and residents with security personnel, as well as their adherence to instructions, played a great role in maintaining security and reducing accidents and other illegal activities.

The sources encouraged everyone to enjoy the national holidays while respecting the laws, to ensure an atmosphere of joy and celebration.

521 citations issued: The quarterly statistics (from October to December 2024) from the Audit and Follow-up Department of Municipal Services at the Ahmadi Municipality Branch revealed that 521 citations were issued and 1,173 warnings were given following the inspection of 1,397 shops, reports Al-Seyassah daily.

MoE launches job promotion teams

Al-Dhafiri moves to end delays

KUWAIT CITY, Feb 10: In confirmation of the reports published on January 8 and 27 regarding the discontent over the delay in forming job promotion teams in educational zones, Undersecretary of the Ministry of Education and Chair of the Technical Committee for Studying the

Formation of Work Teams and Committees Mansour Al-Dhafiri has approved the formation technical teams specialized in job promotions for



employees in the educational zones, schools, and kindergartens for the current year.

The teams will take necessary steps to implement promotion deci-

The decision was taken following a meeting of the Technical Committee for Studying Work Teams and Committees. During this meeting, it was agreed to form work teams in line with the decisions of the Civil Service Council, particularly Decisions No. 16/2011 and No. 40/2016 regarding the system for work teams in government agen-

Al-Dhafiri endorsed the formation and distribution mechanism, which specifies that the ministry's headquarters will form two work teams, in addition to two work teams in each educational zone, during the dates of raising the job level in the classified job groups set for January and July 2025.

The head of each team will select its members, with a maximum of ten members, as per Article 4 of Civil Service Council's Resolution No. 6/2011. No member can be added to the team without the undersecretary's approval.

According to the decision, the head of each team is responsible for presenting the team's results, meeting minutes, and achievement rates to the technical committee tasked with studying the formation of work teams and committees in the Ministry of Education after completing the assigned tasks. The work team is not authorized to form sub-teams or additional committees.

The draft proposal to form each team must include complete details about its members, including name, civil ID number, work center, job title, and the specific assignment to the team. Priority will be given to the participation of Kuwaiti members, and the project must be submitted to the undersecretary of the ministry for approval.

Al-Dhafiri affirmed the importance of coordination and follow-up by providing representatives of the ministry's Financial Controllers Bureau with a copy of the draft decision.

He said the Administrative Affairs and Administrative Development Sector will be tasked with preparing the related draft decisions and distributing copies to the undersecretary's office, the Financial Administration/Assignees Division, and the committee's rapporteur.

According to informed educational sources, the issuance of job promotion decisions, which were originally set to be implemented in early January, has been delayed but is expected to be completed by March 31.

They indicated that this delay has disrupted the promotion schedule for educational staff, and caused a setback in improving job performance among

Meanwhile, sources told Al-Seyassah that financial reforms remain a top priority for the government, and several policy adjustments are being considered to improve

Youth Theater Days Festival opens Feb 15



Kuwait's wholesale

The manufacturing industries group index increased by 0.6 percent during the year, due to a rise in food manufacturing prices by 1.9 percent, beverage manufacturing prices by 3.2 percent, textile manufacturing prices by 4.7 percent, clothing manufacturing prices by 5.5 percent, wood, wood products, and cork by 0.4 percent, paper manufacturing prices by 0.4 percent, chemicals manufacturing prices by 1.1 percent, crystal products and stone building materials by 0.5 percent, computers, electronics, and optical products by 1.9 percent, electrical equipment manufacturing by 1.2 percent, and motor vehicles by 1.5 percent. Prices for both imported goods and local goods increased by 0.4 percent and 1.1 percent respectively

When materials are classified by production stage, raw material prices and final material prices rose by 3.9 percent and 1.4 percent respectively, while simple materials prices decreased by 1.9 percent.

Regarding final use, prices for consumer goods and capital goods increased by 2.1 percent and 0.8 percent respectively, while prices for production goods decreased by 1.5 percent.

Kuwait public

On her participation in the forum, Al-Fassam said it includes a dialogue session on fiscal policy design options to confront increasing debt pressures with the aim to review the current economic challenges and adopt flexible and balanced financial policies.

She pointed out that the forum "will showcase Kuwait's successful experience in the process of issuing bonds and sovereign debt for the state, which achieved success in 2017 as we entered the international financial mar-

kets by issuing bonds worth USD eight billion"

In this regard, Al-Fassam said that given the high credit rating of Kuwait, this issuance received great demand and was covered at a rate of 3.6 times the total value of the issuance itself, and orders now exceeded USD 29 billion, with more than 500 foreign and international investors participating in the issuance, which reflects strong confidence in the creditworthiness of Kuwait and its economic policies.

On the public debt, she said it does not exceed 60 percent of the country's gross domestic product, which is what countries are committed to, and Kuwait has the lowest debt percentage on a regional level

a regional level.

PAHW inks KD785m deals for major housing project

6,455 homes, infrastructure set for 2028

KUWAIT CITY, Feb 10: The Public Authority for Housing Welfare (PAHW) has signed four contracts for the construction and maintenance of 6,455 houses and public buildings; in addition to asphalt surface layer works, low and medium voltage cable supply, installation works, and road lighting works in seven suburbs within the affordable housing project.

In a press statement on the sidelines of the signing of the contracts, acting Director General of PAHW Rashid Al-Enezi pointed out that "with these contracts, the authority has completed all contracts related to the construction and maintenance of houses and public buildings, asphalt surface layer works, supply and installation of low and medium pressure cables, and road lighting works in all sectors of the affordable housing project."

He also confirmed the signing of six contracts with local and international companies to implement the city works with a total value of KD 785,372,093; while the implementation period for each project is 1,095 days.

He revealed that the affordable housing project consists of 9,800 houses with public buildings and their site connection works; indicating that the implementation includes asphalt surface layer, road lighting network, and the supply and installation of low and medium pressure cables.

He said the project consists of 74 public buildings, including two kindergartens, 10 primary schools, eight intermediate schools, six secondary schools, two Islamic centers, 14 mosques, 16 houses for imams and muezzins, a fire station, a tele-

phone exchange, two community development centers, two social unit centers, two police stations, two specialized health centers, an ambulance center, two central markets, two gas branches, and a diwaniya for the elderly.

He confirmed that the signing of these contracts is in line with the authority's commitment to achieve its strategic goal in providing integrated housing projects that contribute to improving the citizens' standard of living. He said the institution is following up the implementation of the first and second contracts; which started at the beginning of January and include the construction of 3,345 houses and a number of public buildings.

He went on to say that this is in addition to the surface layer of asphalt, supplying and installing low and medium pressure cables and road lighting works in sectors (BP-1) and (BP-3); disclosing that the target completion date is early 2028.

'US is not subsidizing Canada'

Trump serious about Canada becoming 51st state in Super Bowl interview

WASHINGTON, Feb 10, (AP): US President Donald Trump said he is serious about wanting Canada to become the 51st state in an interview that aired Sunday during the Super Bowl pre-

"Yeah it is," Trump told Fox News Channel's Bret Baier when asked whether his talk of annexing Canada is "a real thing" - as Canadian Prime Minister Justin Trudeau recently warned.

"I think Canada would be much better off being the 51st state because we lose \$200 billion a year with Canada. And I'm not going to let that happen,' he said. "Why are we paying \$200 billion a year, essentially a subsidy to Canada?

The US is not subsidizing Canada. The US buys products from the natural resource-rich nation, including commodities like oil. While the trade gap in goods has ballooned in recent years to \$72 billion in 2023, the deficit largely reflects America's imports of Canadian energy.

Trump has repeatedly suggested that Canada would be better off if it agreed to become the 51st US state - a prospect that is deeply unpopular among Canadians.

Trudeau said Friday during a closed-

door session with business and labor leaders that Trump's talk of making Canada the 51st US state was "a real thing" and tied to desire for access to the country's natural resources.

"Mr Trump has it in mind that the easiest way to do it is absorbing our country and it is a real thing. In my conversations with him on

," Trudeau said, according to CBC, Canada's public broadcaster. "They're very aware of our resources of what we have, and they very much want to be able to benefit from those?

Speaking to reporters aboard Air Force One on Sunday as he traveled to the Super Bowl game in New Orleans, Trump continued to threaten a country that has long been one of the US's closest allies. He claimed that Canada is "not viable as a country" without US trade, and warned that the founding NATO member can no longer depend on the US for military protection.

"You know, they don't pay very much for military. And the reason they don't pay much is they assume that we're going to protect them," he said. "That's not an assumption they can make because - why are we protecting another country?"

In the Fox interview, which was pretaped this weekend in Florida, Trump

also said that he has not seen enough action from Canada and Mexico to stave off the tariffs he has threatened to impose on the country's two largest trading partners once a 30-day exten-

"No, it's not good enough," he said. "Something has to happen. It's not sustainable. And I'm changing it."

Trump last week agreed to a 30-day pause on his plan to slap Mexico and Canada with a 25% tariff on all imgas and electricity, which would be taxed at 10%, after the countries took steps to appease his concerns about border security and drug trafficking. Aboard Air Force One, Trump said

that he would on Monday announce a 25% tariff on all steel and aluminum imports into the US, including from Canada and Mexico, and unveil a plan for reciprocal tariffs later in the week.

"Very simply it's if they charge us, we charge them," he said.

Trump's participation in the Super Bowl interview marked a return to tradition. Presidents have typically granted a sit-down to the network broadcasting the game, the most-watched television event of the year. But both Trump and his predecessor, Joe Biden, were inconsistent in their participation.

Biden declined to participate last year - turning down a massive audience in an election year - and also skipped an appearance in 2023, when efforts by his team to have Biden speak with a Fox Corp. streaming service instead of the main network failed. During his first term, Trump participated three out of four years.

Trump was the first sitting president to attend the Super Bowl in person something he told Baier he was sur-

"I thought it would be a good thing for the country to have the president at the game," he said.

During his flight to New Orleans, Trump signed a proclamation declaring Feb. 9 "the first ever Gulf of America Day" as Air Force One flew over the body of water that he renamed by proclamation from the Gulf of Mexico.

Trump in the interview, also defended the work of billionaire Elon Musk, whose so-called Department of Government Efficiency, or DOGE, has been drawing deep concern from Democrats as he moves to shut down whole government agencies and fire large swaths of the federal workforce in the name of rooting out waste and inefficiency.

Musk, Trump said, has "been terrific," and will target the Department of Education and the military next.

"We're going to find billions, hundreds of billions of dollars of fraud and abuse," Trump predicted. "I campaigned on this.'

He was also asked about his dancing, which has become a popular meme on social media.

"I don't know what it is," he said. 'I try and walk off sometimes without dancing and I can't. I have to dance.'

Vance and Musk question authority of courts as Trump's agenda faces legal pushback

WASHINGTON, Feb 10, (AP): Top Trump administration officials are openly questioning the judiciary's authority to serve as a check on executive power as the new president's sweeping agenda faces growing pushback from the courts.

Over the past 24 hours, officials ranging from billionaire Elon Musk to Vice President JD Vance have not only criticized a federal judge's decision early Saturday that blocks Musk's Department of Government Efficiency from accessing Treasury Department records, but have also attacked the legitimacy of judicial oversight, a fundamental pillar of American democracy, which is based on the separation of powers.

"If a judge tried to tell a general how to conduct a military operation, that would be illegal. If a judge tried to command the attorney general in how to use her discretion as a prosecutor, that's also illegal. Judges aren't allowed to control the executive's legitimate power," Vance wrote on X on

Sunday morning.

That post came hours after Musk said overnight that the judge who ruled against him should be impeached.

"A corrupt judge protecting corruption. He needs to be impeached NOW!" said Musk, who has been tasked by President Donald Trump with rooting out waste across the federal government.

Musk also shared a post from a user who had suggested that the Trump administration openly defy the court

"I don't like the precedent it sets when you defy a judicial ruling, but I'm just wondering what other options are these judges leaving us," the person had written, in part.

The court order against Musk barred his team temporarily from accessing a Treasury system that contains sensitive personal data, such as Social Security and bank account numbers for millions of Americans. Musk and his team say they are simply rooting through government systems to identify waste and abuse at the direction of the Republican president.

Deputy White House chief of staff Stephen Miller called the ruling "an assault on the very idea of democracy

"What we continue to see here is the idea that rogue bureaucrats who are elected by no one, who answer to no one, who have lifetime tenure jobs, who we would be told can never be fired, which, of course, is not true, that the power has been cemented and accumulated for years, whether it be with the Treasury bureaucrats or the FBI bureaucrats or the CIA bureaucrats or the USAID bureaucrats, with this unelected shadow force that is running our government and running our country," Miller said on Fox News Channel's "Sunday Morning

The pushback comes as the administration's efforts to dismantle government agencies and eliminate large swaths of the federal workforce are being held up by the courts.



UK touts clampdown on illegal working as it seeks to look tough on immigration

LONDON, Feb 10, (AP): The British government on Monday touted its success in raiding businesses that employ unauthorized workers and deporting thousands of migrants with no right to

What's billed as a "blitz on illegal working" is part of a pledge by the center-left Labour government to reduce immigration -- a priority for many voters -- and stop the growing popularity of the hard-right party Reform UK.

But for migrants groups, and some Labour Party members, the images uncomfortably recall a previous Conservative government's pledge to make Britain a "hostile environment" for illegal migration. That led to thousands of longterm legal residents being denied housing, jobs or medical treatment because they could not prove their status. Dozens were detained or deported to countries they had not visited for decades.

The government said Monday that immigration enforcement teams have carried out more than 5,000 raids since Labour was elected in July on businesses including nail bars, convenience stores, vape shops, restaurants and car washes, and made almost 4,000 arrests. The figures are significantly higher than the previous year, when the Conservatives were in power.

Britain also has deported more than 16,000 people in the same period. The government plans to release video footage of migrants being deported later Monday in a PR move that has been criticized as crass and insensitive.

Home Office Minister Angela Eagle defended the government's tough ap-

"We have to have a system where the rules are respected and enforced," she told the BBC. "It's important that we show what we are doing and it's important that we send messages to people who may have been sold lies about what will await them in the UK if they get themselves smuggled in."

The government says the perception that it's easy to find work in Britain is a "dangerous draw" for migrants who try to cross the English Channel on small boats. Authorities in the UK and France have struggled for years to stop the dangerous crossings, which brought more than 38,000 people to Britain in 2024. More than 70 people perished in the attempts.

Prime Minister Keir Starmer has said the crime gangs are a threat to global security and should be treated like terror networks. The Border Security, Asylum and Immigration Bill, which faces a key vote in Parliament on Monday, contains new powers including the ability to seize suspected traffickers' phones before they are arrested.

US officials bound for Europe for talks on Ukraine

President Donald Trump's national security adviser said Sunday that top administration officials will meet with European officials this week about how to end the war in Ukraine, nearly three years after Russia launched an all-out invasion.

Less than a day earlier, the New York Post reported that Trump had a phone call with Russian leader Vladimir Putin to discuss steps toward a negotiated solution. Speaking to reporters aboard Air Force One as he flew to the Super Bowl in New Orleans, Trump declined to discuss his reported phone conversation with Putin.

"I don't want to do that. We're trying to end that war. It's a war that would have never happened if I were president, it would have never happened, but we're making progress. But I can't tell you," he said.

Asked to clarify whether his conversations with Putin took place before he took office or after, Trump said, "I've had it. Let's just say I've had it. And I expect to have many more conversations. We have to get that war ended. It's going to end.'

There was no immediate confirmation of the call by the Kremlin.

In a television interview, National Security Advisor Mike Waltz said the Russian economy is not doing well and that Trump "is prepared to tax, to tariff, to sanction" Moscow to get Putin to the negotiating table. Waltz also underscored that the Trump administration is looking to use this week's engage ments to begin talks on clawing back some of the United States' assistance to Ukraine. He said European allies will also need to take a greater role in supporting Ukraine going forward.

"We need to recoup those costs and that is going to be a partnership with the Ukrainians in terms of their natural resources and their oil and gas and also buying ours," Waltz said in an appearance on NBC's Meet the Press. "Those conversations are going to happen this week. And I think an underlying principle here is that the Europeans have to own this conflict going forward. President Trump is going to end it. And then in terms of security guarantees, that is squarely going to be with the Europe-

Vice President JD Vance will be in Paris on Monday for an artificial intelligence summit that's gathering government officials and will head later in the week to the Munich Security Conference, where Ukrainian President Volodymyr Zelenskyy will lead the battle-weary country's delegation. Secretary of State Marco Rubio, Defense Secretary Pete Hegseth and Trump's special envoy on Ukraine and Russia, Keith Kellogg, will also be in Munich.

Tropical cyclone warning issued for residents of NW Australia

SYDNEY, Feb 10, (Xinhua): Residents of northwest Australia have been told to prepare for a tropical cyclone likely to form within days.

The Bureau of Meteorology (BoM) on Monday said that a tropical low system off the north coast of Western Australia (WA) in the Indian Ocean has a "high chance" of reaching tropical cyclone strength within 48 hours.

A tropical cyclone warning has been put in place for towns along a 650-km stretch of coast in WA's Kimberley region, including the town of Broome with a population of about 15,000.

The BoM said that damaging wind gusts of up to 100 km per hour could develop in the region on Tuesday. It warned residents to expect localized heavy rainfall and abnormally high

It said the system may reach category 3 severe tropical cyclone strength by late Tuesday or Wednesday. A flood watch warning has been put in place for catchments in the northern part of the Kimberley region.

"Although there is no immediate danger you need to start preparing for dangerous weather and keep up to date," the WA Department of Fire and Emergency Services said in a post on social media.

"Ensure your emergency kit is complete and check your family knows what to do. Your emergency kit should include canned food and water to last five to seven days, a first aid kit, medi-

cation, cash and a battery-operated radio and spare batteries to listen to warnings," the department said.

It urged people in the area to secure vehicles, boats, gas bottles, rainwater tanks and other loose material around their homes.

Meanwhile, a man has been critically injured in a brawl involving up to 40 armed people in western Sydney. Police in the state of New South Wales (NSW) said on Monday that officers were called to reports of a brawl "involving between 30 and 40 people armed with knives, machetes and baseball bats" at a public park 18 km west of central Sydney at about 5:40 p.m. on Sunday.

Officers arrived at the scene in the suburb of South Granville, causing the group to disperse on foot and in cars. "Police located a 28-year-old man with serious head injuries," a NSW

Police statement said.

Ambulance crews were sent to the scene and treated the man before taking him to a local hospital in a critical

Shortly after, police arrested a 29-year-old man in a nearby street. He was taken to a police station and charged with affray and carrying a knife in a public place.

In another development, Australian police have seized more than 40 kg of cocaine found in refrigerated contain-

ers imported into Sydney. The Australian Federal Police (AFP) and Australian Border Force (ABF) said on Monday that about 41 kg of cocaine was found in the containers that arrived at Sydney's Port Botany from Chile and Belgium in January.

They said that officers have observed a recent drug import trend where cocaine is hidden by criminal syndicates in refrigerated containers used by legitimate businesses to import goods.

Once the container has arrived in Sydney, local members of the syndicates attempt to break into the docks or other storage areas to recover the

The AFP and ABF said in a joint statement that there has been a significant increase in the use of the tactic since April 2023 and that they are now actively targeting refrigerated containers arriving in Sydney.

They said that more than one tonne of cocaine has been seized in total from the containers since 2023, as well as tracking devices used by organized crime gangs to monitor and identify the containers

"The relationship between China and the Cook Islands is not directed against any third party and should not be subject to or disrupted by any third party," Chinese Foreign Ministry spokesperson **Guo Jiakun** said Monday.

New Zealand's Foreign Minister Winston Peters said he had repeated in a phone call to Cook Islands Prime Minister Mark Brown that he should discuss with New Zealand the contents of the so-called Comprehensive Strategic Partnership and other agreements that Brown intends to

sign in China. 'This lack of consultation is a matter of significant concern to the New Zealand government," Peters' office said in a statement

Sunday. The Cook Islands, a collection of 15 small islands with a population of 15,000 but a large exclusive economic zone, has been self-governing in free association with New Zealand, its largest source of aid. The almost 60-year-old arrangement allows Cook Islanders to hold New Zealand citizenship and passports and to work and live in New Zealand.

Brown has said that New Zealand has been advised that the deal with China does not touch on security but that New Zealand does not have to review the exact wording of any documents.

He has said his state visit to Beijing, starting this weekend, would focus on renewable energy and agriculture but that it would also touch on maritime issues and shipping and seabed minerals development, areas New Zealand, Australia, the US and others have been particularly concerned about.

Choi urges security posture against Pyongyang threats

South Korea and US troops hold live-fire drills near border with North Korea

TOKYO, Feb 10, (Agencies): South Korea and US troops have been staging a large-scale combined live-fire exercise at a firing range near the inter-Korean border to enhance their joint operational capabilities, Seoul's Air Force said Monday, said Yonhap

The three-week exercise began last Monday at a complex in Pocheon, about 30 km south of the Demilitarized Zone separating the two Koreas, mobilizing some 2,000 troops and over 150 pieces of military hardware, according to the Army.

Troops of the allies have formed combined units to stage various drills, involving such as South Korean K1A2 tanks, US Stryker combat vehicles, Apache attack helicopters and A-10 attack aircraft, it said.

The drills are designed to strengthen the allies' combined operational capabilities and help the US military's rotational Stryker unit adjust to conditions on the Korean Peninsula after its arrival in South Korea last October, the

report said. North Korean leader Kim Jong-un has accused the US of standing behind the world's disputes, reaffirming the country's policy to further develop its nuclear forces, the state-run Korean Central News Agency reported Sun-

Kim made the remarks during his visit to the Ministry of National Defense the previous day in celebration of the 77th anniversary of the founding of its armed forces, the Korean People's Army.

Kim also claimed that US nuclear strategic assets deployed on the Korean Peninsula, the US-led nuclear war simulation exercises and the US-Japan-South Korea military cooperation are "inviting military imbalance" on the peninsula and in Northeast Asia, causing "a new conflicting structure" and posing a grave challenge to North

Amid stalled diplomacy with the US and South Korea in recent years, Kim has focused on enlarging and modernizing his arsenal of nuclear weapons. In response, the United States and South Korea have expanded their bilateral military exercises and trilateral training involving Japan. North Korea has lashed out at those drills, calling them rehearsals to invade the country.

Since his Jan. 20 inauguration, Trump has said he would reach out to Kim again as he boasted of his highstakes summit with him during his first

Ishiba on Friday, Trump said that "We will have relations with North Korea, with Kim Jong Un. I got along with him very well, as you know. I think I stopped the war."

North Korea hasn't directly responded to Trump's recent overture, as it continues weapons testing activities and hostile rhetoric against the US. Many experts say Kim is now preoccupied with his dispatch of troops to Russia to support its war efforts against Ukraine. They say Kim would still eventually consider returning to diplomacy with Trump if he determines he would fail to maintain the current solid cooperation with Russia after the war

Meanwhile, South Korea's Acting President Choi Sang-mok on Monday called for coordinated efforts from all government agencies, including the military and police, to ensure security against North Korean threats, Yonhap News Agency reported.

Choi also called for joint efforts by the public and private sectors in an annual central integrated defense council meeting, highlighting the need for unity in response to North Korean provocations.

The meeting was attended by some 150 officials, including the defense minister, acting police chief, fire chief and civilian experts.

"In these grave security conditions, we must stand together as one team to establish a comprehensive security posture that protects the daily lives and safety of our people from North Korea's various provocations," Choi was quoted as saying.

He cited recent threats, including short-range ballistic missile and cruise missile launches, balloons carrying trash, along with Pyongyang's dispatch of soldiers to support Russia's war in Ukraine.

Choi, who assumed interim leadership while serving as finance minister, stressed that national security is directly tied to the economy.

"Strong security is the foundation for economic growth and the public livelihood," he said.

In another development, one worker was killed and the other was injured on Monday in South Korea's oil storage tank explosion, according to Yonhap news agency.

The explosion occurred at about 11:15 am local time (0215 GMT) at a factory in Ulsan, some 300 km southeast of the capital Seoul. One of the two workers in their 30s

at the scene was taken to a hospital unconscious to undergo surgery, but died

The other suffered a serious injury that was not life-threatening.

The two victims were believed to be caught in the explosion while opening a hatch on top of the tank and checking

the amount of petrochemicals inside. The fire authorities mobilized about 230 firefighters and 44 equipment, including fire trucks, to put out the fire that broke out after the explosion.

There were four to five other tanks containing lubricants, biodiesel and others around the tank where the explosion and fire broke out.

The fire was completely extinguished some three hours later.

Federal court grants request to block detained Venezuelan immigrants from being sent to Gitmo

ALBUQUERQUE, NM, Feb 10, (AP): A federal court on Sunday blocked the Trump administration from sending three Venezuelan immigrants held in New Mexico to Guantanamo Bay Naval Base in Cuba as part of the presi-

dent's immigration crackdown. In a legal filing earlier in the day, lawyers for the men said the detainees "fit the profile of those the administration has prioritized for detention in Guantanamo, i.e. Venezuelan men detained in the El Paso area with (false) charges of connections with the Tren

de Aragua gang."
It asked a US District Court in New Mexico for a temporary restraining order blocking their transfer, adding that "the mere uncertainty the government has created surrounding the availability of legal process and counsel access is sufficient to authorize the modest injunction.'

During a brief hearing, Judge Kenneth J. Gonzales granted the temporary order, which was opposed by the government, said Jessica Vosburgh, an attorney for the three men

"It's short term. This will get revisited and further fleshed out in the weeks to come," Vosburgh told The Associated Press.

A message seeking comment was left for US Customs and Immigration Enforcement.

The filing came as part of a lawsuit on behalf of the three men filed by the Center for Constitutional Rights, the American Civil Liberties Union of New Mexico, and Las Americas Immigrant Advisory Center.

The Tren de Aragua gang originated in a lawless prison in the central Venezuelan state of Aragua more than a decade ago and has expanded in recent years as millions of desperate Venezuelans fled President President Nicolás Maduro 's rule and migrated to other parts of Latin America or the US.

Homeland Security Secretary Kristi Noem said last week that flights of detainees had landed at Guantanamo. Immigrant rights groups sent a letter Friday demanding access to people who have been sent there, saying the base should not be used as a "legal

White House Press Secretary Karoline Leavitt said Wednesday that more than 8,000 people have been arrested in immigration enforcement actions since Trump's Jan. 20 inauguration.

Trump has vowed to deport millions of the estimated 11.7 million people in the US illegally.



Ecuador's conservative incumbent and leftist lawyer advance to presidential runoff

GUAYAQUIL, Ecuador, Feb 10, (AP): Ecuador will choose its next president in a runoff election after conservative incumbent Daniel Noboa and leftist lawyer Luisa González garnered enough votes Sunday to beat 14 other candidates.

The contest, set for April 13, will be a repeat of the October 2023 snap election that earned Noboa a 16-month presidency. Noboa and González are now vying

for a full four-year term, promising voters to reduce the widespread criminal activity that upended their lives four years ago.

The spike in violence across the South American country is tied to the trafficking of cocaine produced in neighboring Colombia and Peru. So many voters have become crime victims that their personal and collective losses were a determining factor in deciding whether a third president in four years could turn Ecuador around or if Noboa deserved more time in office.

Noboa, an heir to a fortune built on the banana trade, and González, the protégée of Ecuador's most influential president this century, were the clear front-runners ahead of the

Figures released by Ecuador's National Electoral Council showed that with 80% of ballots tallied, Noboa received more than 3.71 million votes, or 44.43%, while González earned over 3.69 million votes, or 44.17%. The 14 other candidates in the race were far behind them.

Voting is mandatory in Ecuador. Ecuador's National Electoral Council reported that more than 83% of the roughly 13.7 million eligible voters

KIB Group achieves profit of KD 23.1 million for year 2024

KUWAIT CITY, Feb 10: The Chairman of Kuwait International Bank (KIB), Sheikh Mohammed Jarrah Al-Sabah, announced the Bank's financial results for the year ended on 31 December 2024, highlighting that KIB achieved a net profit attributable to shareholders of KD 23.1 million, marking a 21% increase over the last year, with earnings per share (EPS) of 11.04 fils. Meanwhile, total operating income increased by 26% over 2023, reaching KD 91.4 million in 2024.

In this regard, Al-Jarrah highlighted that the financial results achieved by KIB reflect the Bank's effective strategy that is focused on continuous innovation and excellence in banking services, as well as its ability to adapt to market changes and competition. This success is further supported by its robust financial position and solid, stable capital base.

Al-Jarrah said: "At KIB, we believe success is not solely measured by numbers but by our ability to anticipate the future and sustain high performance. That's why we invest significantly in technology, digital infrastructure and human capital development, ensuring we meet our customers' needs at the highest standards in a rapidly changing market environment."

As for the financial statements for 2024, Al-Jarrah noted that the total assets witnessed a 9% growth, amounting to KD 3.92 billion, in comparison to KD 3.62 billion at the end of 2023. This growth came primarily as a result of an increase in the financing portfolio by 14%, reaching KD 2.85 billion at the end of 2024, compared to KD 2.49 billion at the end of 2023. Additionally, the financial investments portfolio which primarily concentrated on high-quality Sukuk recorded a significant growth of 42%, amounting to KD 150.7 million, bringing the total to KD 513.4 million at the end of 2024, compared to around KD 362.7 million in 2023.

Regarding dividends' distribution among the shareholders, Al-Jarrah stated that KIB's Board of Directors proposed cash dividends of 5 fils per share and 5% as bonus shares from the issued and paid-up capital, subject to the approvals of the Bank's shareholders' general assembly and competent regulatory authorities.

Al-Jarrah added: "KIB's growth in 2024 was driven by its focus on strengthening its financing portfolio and diversifying investments, which contributes to long-term financial stability. The Bank remains committed to supporting the national economy by backing initiatives and projects that promote innovation and entrepreneurship. Additionally, the Bank is dedicated to creating sustainable value for the community, customers, and shareholders, while upholding the highest standards of governance and transparency."

Al-Jarrah concluded his remarks by emphasizing that the Bank's positive results would not have been possible without the exceptional efforts of its dedicated team and the unwavering support of its valued shareholders. He reaffirmed KIB's commitment to investing specially in technology, digital infrastructure, developing human capital and implementing future plans to meet market demands, all while upholding its social responsibility to deliver sustainable value for all stakeholders.

On his part, Raed Jawad Bukhamseen, Vice Chairman and Chief Executive Officer of KIB, stated: "This year's results represent a pivotal milestone in our journey, reflecting our strategic focus on innovation and sustainable growth. This approach has allowed us to strengthen our competitiveness significantly by optimizing our financing portfolio and adopting innovative digital solutions that keep pace with market

Bukhamseen added: "The Bank has effectively achieved a balance between growing its investment portfolio and expanding its banking services, leading to a significant increase in operating revenues. These results highlight the Group's exceptional performance and growth in key financial indicators, showcasing the success of our strategy and our commitment to the highest standards in the banking industry."

Commenting on KIB's financial performance, Bukhamseen noted the increase in the net financing income by 29% in 2024, to reach KD 68million, in comparison with the approximate KD52.9million in 2023. Fee and commission incomeincreased to KD 17.4million, up from KD 12.2million, reflecting a growth rate of 43%. This contributed to a rise in total operating income, which reached KD 91.4million compared to KD 72.6million in 2023, marking a growth of 26%.

Discussing the Bank's financial position, Bukhamseen highlighted that depositors' accounts in KIB grew by 30%, totaling of KD 2.75 billion by the end of 2024, with the comparison with 2.12 billion in 2023. Meanwhile, shareholders' equity attributable to the shareholders grew by 4% to reach KD 348 million. The issuance saw investor demand exceeding twice the original size of the issued Sukuk, with final pricing achieving the tightest spread ever achieved onan AT1 Sukuk globally at the time of issuance, at 195 basis points above US Treasury. Furthermore, the AT1 Sukuk issued in 2019 were fully redeemed by way ofexercising of the Call Option in 2024.

Establishing KIB Invest

In 2024, the Bank officially launched its investment arm, Al Dawli Invest Investment Company (KIB Invest), to engage in Islamic investment activities and provide a diversified suite of investment solutions tailored to meet clients' evolving needs, Bukhamseen noted. Wafra operations to boost production to 230,000 bpd

KUWAIT CITY, Feb 10: According to sources from the oil sector, the joint Wafra operations between the Kuwait Gulf Oil Company and Saudi Chevron Company aim to boost the field's production capacity to 230,000 barrels per day by 2027, up from the current 170,000 barrels per day.

Meanwhile, the management overseeing the joint Khafji field operations between Kuwait Gulf Oil Company and Saudi Aramco plans to raise the field's production capacity from 270,000 to at least 360,000 barrels per day by early 2028. To achieve this, Khafji operations are increasing off-

shore drilling platforms. A contract was recently signed with a leading digital transformation company to integrate artificial intelligence into the development of Khafji field facilities. The contract also aims to enhance cybersecurity and

protect Khafji field data through artificial intelligence, and establish an advanced digital systems monitoring center to track potential threats or violations of information security laws and regulations. In addition, Saudi Arabia is working on developing the Khafji region into an industrial logistics city, which will primarily support the interests of the Khafji

field and joint Kuwaiti-Saudi oil projects planned to

be established in the promising Khafji industrial re-The sources revealed that the future merger of Kuwait Gulf Oil Company with Kuwait Oil Company will not disrupt the joint Khafji operations, citing the smooth transfer of Kuwait's share in the Khafji project

to the Kuwait Arabian Oil Company and Kuwait Gulf

Oil Company without issues. Kuwait Oil and Gulf Oil are currently working on completing the transition process. However, full production from the Khafji and Wafra fields, which are managed by Kuwaiti Gulf Oil Company and Saudi Aramco, has not yet been restored to their maximum capacity of approximately 550,000 barrels per day due to an eight-year shutdown period, during which several

facilities suffered a decline.

KUWAIT CITY, Feb 10: Kuwait Finance House (KFH) held the earnings webcast for highlighting the Group's financial performance and results during the fiscal year 2024. Meanwhile, Senior Deputy Group CEO, Dr. Shadi Zahran, talked about the Group's financial performance for the financial year ended 31 December 2024.

Zahran said: "The Group has achieved Net Profit After Tax attributable to Shareholders for the year ended 31st December 2024 of KD 601.8mn higher by KD 17.3mn or 3.0% compared to 2023 of KD 584.5mn. The higher profits are mainly from an increase in total operating income. Partly offset by higher net monetary loss that resulted from the application of IAS-29 "Financial reporting in Hyperinflationary Economies" on the financial statements of the group subsidiary in Türkiye Kuwait Turk Participation Bank (KTPB) and the increase in operating expenses."

He added: "Financing income has increased by KD 692.3mn or 31.6% compared to the last year mainly due to increase in the gross yield. Net financing income at KD 1,147mn increased by **KD 181mn** or 18.7% compared to last year mainly due to an increase in financing income by KD 692.3mn offset by increase in finance cost and distribution to depositors by **KD 511.2mn**.

Speaking about the operating income profile, contribution of net financing income to operating income increased from 66% in 2023 to 70% in 2024 due to increase in net financing income and decline in investment income.

Group NFM for 2024 at 3.12% is higher by 44bps compared to 2023. Average vield improved by 227bps while average COF also increased by 183bps. This was the result of full year impact of rate changes and repricing of assets and liabilities during the year.

Zahran indicated that by looking at provisions and impairments, group total impairment charge increased by KD 14.1mn compared to 2023.

"KFH cautious approach towards provisioning have contributed to financing provision balance exceeding ECL required as per CBK IFRS 9 by KD 539mn as of 31 December 2024" commented Zahran.

As for the Net Monetary Loss, application of IAS-29 on the financial statements of KTPB resulted in recognition of net monetary loss of KD 155.3mn in the current year with an increase of **KD 82.5mn** compared to last year due to the continued inflation and significant maturity of CPI linked sukuk during last quarter of 2023.

Speaking about the financial position, Zahran said that the Total Assets at KD 36.7bn decreased by (3.4)% in 2024. Net financing receivables at KD 19.1bn decreased by (1.8)% mainly due to sale of KFH Bahrain in addition to foreign currency volatility during the year. Excluding these impacts, group net financing receivable would be higher in 2024 by **5.5%**.

Investments in debt securities at KD 6.9bn as at the end of year 2024.

Deposits as of 2024 are KD 19.2bn. The contribution from CASA deposits to total group customer deposits as at the end of 2024 is 44.4%. Contribution of customer deposits to total **funding** is **66.5**% compared to 71.4% in 2023.

KFH Group Chief Strategy Officer, Fahad Al-Mukhaizeem highlighted the Kuwait operating environment with an overview on KFH. He also talked about KFH's strategy, as well as Full Year-2024 results.

Al-Mukhaizeem said: "In light of the evolving monetary policy landscape, the Central Bank of Kuwait (CBK) has implemented a measured and balanced strategy to align with local economic conditions, uphold macroeconomic stability, and promote sustainable growth. Consequently, during 2024, CBK has reduced the discount rate by 25 basis points, bringing it down to 4.00%, effective September 19, 2024."

At the macroeconomic level, Kuwait's GDP is forecasted to reach KD 39.4 billion in 2024 according to the most recent International Monetary Fund (IMF) report released in October 2024. Additionally, the average inflation rate reached declined to 2.9% during the year 2024according to the latest issued data Central Statistical Bearu. Kuwait's crude oil price reached USD 74.2 per barrel as of the end of December 2024, down by 6.7 % from the same period of the previous year.

Al-Mukhaizeem mentioned that in 2024, Kuwait's economic development is marked by a strategic focus on diversification and resilience in the face of global economic challenges. The government is actively implementing initiatives aimed at reducing reliance on oil revenues by promoting sectors such as finance, technology, and tourism. Investments in infrastructure development are also a priority, with significant projects underway to enhance transportation and connectivity. Additionally, the Central Bank of Kuwait's monetary policies, including adjustments to the discount rate, are designed to foster a stable economic environment conducive to growth.

As a result, Kuwait is positioning itself to achieve sustainable development and attract foreign investment, ultimately aiming for a more balanced and robust economy. In terms of credit ratings, Kuwait maintains a robust profile with an A+ rating and a stable outlook from Standard & Poor's, an A1 rating from Moody's, and an AA- rating from Fitch, all with stable outlooks.

He added: "KFH's long term credit rating stands at A by Fitch with Stable Outlook, and at A2 by Moody's with Stable outlook. Furthermore, KFH continued its efforts to achieve financial solidity and sustainable growth, capitalizing on the flexible business model, strong asset quality, abundant liquidity, continuous diversification of financing and wide geographical spread in different markets worldwide, most prominently Kuwait, Bahrain, Turkey, Egypt, UK and Germany."

Additionally, KFH ranked first among the largest listed companies on Boursa Kuwait in terms of a market capitalization approximately KD 12.4 billion as of the end of December 2024 according to Boursa Kuwait.

Gulf Bank reports KD 60.2 million net profit for 2024

KUWAIT CITY, Feb 10: Gulf Bank K.S.C.P. ("Bank") announced its financial results for the full year ending 31 December 2024. The Bank reported a net profit of KD 60.2 million, reflecting a decline of KD 11.0 million or 15.5% compared to a net profit of KD 71.2 million for the same period in 2023.

Earnings per share for the year were 16 fils, and the Board of Directors is recommending a cash dividend distribution of 10 fils per share, representing a 63% cash payout ratio. In addition, a 5% bonus share distribution is proposed, subject to shareholder approval at the Annual General Meeting scheduled for March 2025.

Furthermore, Gulf Bank recorded an operating income of KD 199.3 million for the full year 2024, marking an increase of 4.8% compared to the previous year. Operating profit also saw a rise, reaching KD 106.7 million, reflecting a growth of 3.2% compared to 2023.

The decline in net profit for the full year of 2024 is primarily attributed to an increase in total provisions and impairments, which increased by KD 14.9 million for the full year compared to the same period last year. Nevertheless, in the fourth quarter the total provision cost has significantly decreased compared to both the previous quarters of 2024 and the same period last year.

Now looking at the financial performance of the fourth quarter of 2024, the Bank reported a net profit of KD 20.0 million, an increase of 14.8% over the fourth quarter of 2023. Operating income for the mentioned period was KD 53.3 million, an increase of 6.3% compared to the same period of last year.

The Bank's prudent risk management approach has effectively mitigated risks and maintained the quality of its loan portfolio. As of 31 December 2024, the Bank's non-performing loans (NPL) ratio stood at 1.3%, compared to 1.2% at the end of the previous year. Additionally, the Bank continues to maintain a robust NPL coverage ratio of 340%, including total provisions and collateral

As of 31 December 2024, total credit provisions reached KD 270 million, whereas IFRS 9 accounting requirements (i.e., ECL or expected credit losses) were KD 177 million. This results in a substantial excess provision level of KD 94 million, over and above what is mandated by IFRS 9 accounting requirements.

In comparison to 31 December 2023, Gulf Bank's total assets increased by 4.3% to reach KD 7.5 billion, with net loans and advances rising by 5.2% to KD 5.5 billion. Additionally, total deposits grew by 4.3% to reach KD 5.6 billion, while shareholders' equity increased by 2.1% to reach KD 834 million for the year ended 2024.

The Bank's capital position remains robust, supported by strong internal capital generation. As of 31 December 2024, the Bank's regulatory Tier 1 capital ratio stood at 15.2%, exceeding the regulatory minimum of 12% by 3.2%. Additionally, the Capital Adequacy Ratio (CAR) was 17.3%, surpassing the regulatory minimum of 14% by 3.3%.



Million KD Net Profit for Full Year 2024





'The Investment Conference 2025' brought together thought leaders, industry experts and investors to discuss ideas that move markets

KUWAIT CITY, Feb 10: Kamco Invest and Burgan Bank successfully hosted the second edition of their investment conference under the theme "Exploring Trends: Ideas That Move Markets". The conference, attended by thought leaders and industry experts, in addition to institutional and high-net-worth investors from Kuwait and the region, discussed crucial topics spanning the global economy, geopolitics, and various asset classes. The conference actively supports the vision to transform Kuwait into a regional financial and trade hub.

In his capacity as the Chief Executive Officer of Kamco Invest and the Vice Chairman of Burgan Bank, Faisal Sarkhou inaugurated the conference during a welcome speech addressed to the audience and participants. He stressed the importance of the conference, which reflects the commitment to analyzing the key forces shaping global and regional economies, from geopolitical and regulatory shifts to technological advancements and sector-specific opportunities.

Sarkhou also highlighted the strategic partnership between Kamco Invest and Burgan Bank, following Burgan Bank's majority acquisition of Kamco Invest. This collaboration brings together two established institutions with independent track records and deep-rooted expertise, creating a more integrated financial ecosystem. By leveraging their combined strengths, they are enhancing investment solutions and expanding opportunities for clients in a rapidly changing financial landscape.

Oxford Economics: Strong fiscal positions and continued progress on diversification agendas position the GCC region as a standout performer in the global economy.

Scott Livermore, Chief Middle East Economist at Oxford Economics, provided insights into the macroeconomic and geopolitical landscape, emphasizing the expectations of Oxford Economics for another year of steady but unspectacular global growth. However, this masks three very different stories: US exceptionalism, structural downturn in China and European malaise.

Globally, interest rates are expected to decline gradually, except in Europe, where monetary easing remains constrained. Meanwhile, fiscal policy will play a crucial role in shaping economic prospects. In the GCC, strong fiscal positions and continued progress on diversification agendas position the region as a standout performer in the global economy.

Trade policy uncertainty remains the primary risk to the baseline forecast. While the GCC is not currently a direct target of potential trade actions by President Trump, any disruption to global trade would have negative repercussions for the region. Additionally, ongoing geopolitical tensions in various parts of the world pose further risks to global economic stability.

Investing in human capital, fostering private-sector participation, and strengthening regional cooperation will be critical in mitigating external shocks and securing a prosperous, diversified future for the GCC.

Dr. Merza Hasan, Senior Advisor at the Arab Fund for Economic & Social Development (AFESD) and Dr. Nasser Saidi, President of Nasser Saidi & Associates explored in a panel discussion the dynamic transformation of Gulf Cooperation Council (GCC) economies amidst global and regional challenges. The session was moderated by Abdullah AlSharekh, Managing Director of Markets and Investment Banking at Kamco Invest & Board Member at Burgan Bank.

Dr. Hasan and Dr. Saidi underscored the need for GCC countries to move beyond reliance on cyclical oil revenues. They highlighted that while the region has enjoyed robust cyclical growth, the emerging challenges—softening oil prices and an increasing fiscal dependence on hydrocarbons—demand a decisive shift towards structural reforms and economic diversification. Both panelists agreed that long-term resilience will hinge on effectively transitioning to a model that prioritizes productivity-led growth.

The discussion also delved into the delicate balance between fiscal discipline and strategic government spending. Panelists noted that while significant public investments remain crucial for fostering innovation and building competitive sectors, these must be managed within a framework that safeguards fiscal sustainability. They explored various approaches,

including more prudent debt issuance and enhanced use of sovereign wealth funds, as a means to finance the necessary reforms without compromising long-term fiscal health.

Finally, the panel addressed the impacts of global uncertainty, from fluctuating interest rates to trade tensions, on the regional economy. Dr. Hasan and Dr. Saidi stressed the importance of agile monetary policies and the role of central banks in ensuring a smooth transition in changing global financial conditions. They also emphasized that investing in human capital, fostering private-sector participation, and strengthening regional cooperation will be critical in mitigating external shocks and securing a prosperous, diversified future for the GCC.

The panel on GCC Public Markets explored key macroeconomic and structural shifts shaping the investment landscape as we enter 2025. The panelists included Raman Subramanian, Managing Director & Global Head of Solutions Research at MSCI, Iyad Ghulam, Head of Equity Research at SNB Capital, Thomas Mathew, Vice President - Equity & Fixed Income at Kamco Invest, and moderated by Sarah Dashti, Vice President - Equity & Fixed Income at Kamco Invest.

Global challenges such as high inflation, rising interest rates, geopolitical tensions, and the ongoing trade war continue to influence market dynamics. Meanwhile, the GCC remains focused on economic diversification and energy transition, with large-scale projects such as Saudi Vision 2030 and Kuwait's new initiatives creating investment opportunities.

The discussion explored the growing importance of thematic investing, with a focus on mega projects and major events as key themes, particularly in infrastructure, construction, and tourism. These themes are expected

to create opportunities across various sectors, including industrials, utilities, real estate development, and banking, as they shape the market landscape. The GCC's weight in MSCI Emerging Markets indices remains underweight by 4%, signaling potential for increased foreign investment. A key development could be Saudi Arabia raising its Foreign Ownership Limit (FOL) to 100%, which could potentially unlock USD 9-10 billion in inflows. Furthermore, recent changes in foreign investment rules for Makkah and Madinah are projected to contribute an additional USD 600 million to Saudi weight this May from MSCI EM trackers alone, this is if we assume all other companies' weights remains as is.

Raman Subramanian from MSCI highlighted that the combined weight of GCC countries in the MSCI Emerging Markets Index has risen significantly, increasing from just over 1% in June 2014—when Qatar and the UAE were first included—to over 7% today. This expansion, driven by an annualized outperformance of more than 2% over the MSCI Emerging Markets Index and a fourfold increase in the region's broader opportunity set over the past decade, underscores the GCC's rapid rise in global equity markets.

With structural shifts shaping market dynamics, investors in GCC equities must strategically position themselves to capitalize on emerging trends. While the global macroeconomics shifts and economic diversification accelerate, thematic investing for active managers will be key to capturing long-term megatrends in the region's evolving public markets.

Space (EGLS), Fabrice Fraikin, Managing Partner & Co-founder of Flexam Invest, Mohammad Al Othman, Senior Executive Director of Alternative Investments at Kamco Invest, and moderated by Hassan Farran, Chief Executive Officer of Kamco Invest – London.

The discussion underscored how higher borrowing costs have reshaped the investment landscape, prompting a renewed focus on fundamentals, risk management, and diversification. With traditional market tailwinds no longer a given, investors are emphasizing downside protection and strategic asset selection to navigate evolving market conditions effectively.

Within real estate, the panel highlighted the shifting behavior of occupiers and the growing importance of selective market positioning. While broad market movements may not guarantee returns, careful analysis of local dynamics, tenant behavior, and diversification strategies can mitigate risks and enhance resilience. The conversation also touched on the interplay between interest rates, asset pricing, and development trends.

On the debt side, private credit continues to offer attractive opportunities, particularly in asset-backed finance, which benefits from lease rate increases and natural inflation protection. With rising default risks in certain highly leveraged sectors, effective downside risk management remains paramount. A disciplined approach to asset selection, collateral-backed structures, and strong origination strategies has proven essential in sustaining high-yield investments.

Ultimately, the panel reinforced that in a high-interest rate environment, investors must adopt a proactive and fundamentals-driven approach. Whether in real estate or private credit, identifying structurally resilient assets and managing risk exposure are as important as ever to achieving sustainable returns.

namic venture capital landscape in the GCC, emphasizing the pivotal role of exits in strengthening the MENA VC ecosystem. The discussion delved into how founders and investors navigate exit strategies, the key drivers of success, the role of governments in fostering growth, and the evolving influence of private capital in the region. The panel featured distinguished speakers including Abdulaziz Alomran, Cofounder & CEO of Impact46, Suleiman Al Anjeri, Co-founder & CEO of Yiswa App and Co-founder & Former COO of Dabdoob, and Elie Habib, Co-founder & CEO of Anghami. The session was moderated by Dalal Al Shave, Senior Vice President at Kamco Invest.

The conversation underscored the significance of exits in fueling the MENA venture capital ecosystem, as they pave the way for second-time founders, attract seasoned investors. and inject fresh capital into the market. Whether through IPOs or M&As, successful exits provide liquidity, encourage reinvestment, and drive innovation. By understanding the factors that contribute to successful exits and addressing regional challenges, both entrepreneurs and investors can better navigate this evolving landscape, fostering a cycle of entrepreneurship and reinvestment. When founders successfully exit, they gain invaluable experience, financial capital, and credibility. Many of these entrepreneurs go on to launch new ventures, leveraging their insights to scale faster and more efficiently.

The discussion also highlighted the region's growing talent and creativity in shaping a more robust digital market ecosystem. While the venture capital landscape continues to expand, the pathway from startup to exit remains a work in progress across multiple markets. Once this process becomes more structured, innovation will accelerate naturally, driven by the financial incentives of a well-defined system. Unlike developed markets, where exit strategies are more established, the MENA region is still navigating its own challenges. Key to unlocking this

potential is a regulatory environment that allows agility and rapid decisionmaking, as well as seamless access to customers across borders.

Panelists highlighted the recent momentum in the IPO market, citing notable listings such as Rasan, Talabat, and Nice One. These IPOs offer valuable insights into the region's evolving public market dynamics. However, challenges such as market fragmentation, late-stage funding gaps, and scalability constraints continue to hinder startups seeking viable exit opportunities.

By addressing these challenges and strategically leveraging capital market opportunities, the region can unlock its full entrepreneurial potential, paving the way for a thriving and sustainable venture ecosystem.

The last session was a live interview conducted by Faisal Al Othman, Director - Equity & Fixed Income at Kamco Invest, with Cathie Wood, Chief Executive Officer & Chief Investment Officer of ARK Invest who believes that disruptive innovation drives long-term growth by transforming industries through simplicity, accessibility, and cost reduction. The firm focuses exclusively on disruptive technologies, identifying leaders, enablers, and beneficiaries to capture long-term capital appreciation.

AlOthman noted that Kamco Invest has been investing in artificial intelligence, automation, and technology through a diverse range of exposures, recognizing the transformative potential of these themes in global economic evolution. By actively seeking opportunities across the tech value chain, Kamco Invest is positioning itself to capitalize on the growth and innovation emerging globally.

Traditional investors often underestimate the scale and impact of disruptive innovations, which is why ARK differentiates itself through active management of high-conviction portfolios. Cathie mentioned that the convergence of artificial intelligence (AI), blockchains, multiomic sequencing, energy storage, and robotics is set to reshape global economic activity. This transformation could accelerate real economic growth from 3% to over 7% within the next seven years.

Breakthroughs in AI, in particular, could significantly impact the global equity market. By 2030, the portion of market value tied to disruptive innovation could expand from 16% to 60%, reflecting AI's growing influence across industries.

AI's ability to solve complex problems and automate knowledge work will revolutionize every sector, reshaping business models and accelerating innovation. Robotics, powered by AI, will redefine manufacturing, transportation, and supply chain resilience.

Advancements in energy storage, particularly in battery technologies, will enable autonomous mobility systems and drive the transition to decentralized energy generation.

Public blockchains will play a crucial role in redefining the financial ecosystem by facilitating decentralized money and contracts, increasing transparency, and reducing costs. Meanwhile, multiomic sequencing will transform healthcare by unlocking new possibilities in digital biological data, precision medicine, and gene editing.

The rise of open-source AI models is reshaping the competitive landscape, with new models continuously altering industry dynamics. As AI technology advances at an exponential pace, akin to compounding interest, platforms like DeepSeek will be critical in capturing future market opportunities.

There is 'panic, fear and confusion'

HIV infections could increase six times if US cuts support: UNAIDS

LONDON, Feb 10, (AP): The head of the UN AIDS agency said Monday the number of new HIV infections could jump more than six times by 2029 if American support of the biggest AIDS program is dropped, warning that millions of people could die and more resistant strains of the disease could emerge.

In an interview with The Associated Press, UNAIDS Executive Director Winnie Byanyima said HIV infections have been falling in recent years, with just 1.3 million new cases recorded in 2023, a 60% decline since the virus peaked in 1995.

But since President Donald Trump's announcement the US would freeze all foreign assistance for 90 days, Byanyima said officials estimate that by 2029, there could be 8.7 million people newly infected with HIV, a tenfold jump in AIDS-related deaths - to 6.3 million - and an additional 3.4 million children made orphans.

"We will see a surge in this disease," Byanyima said, speaking from Uganda. "This will cost lives if the American government doesn't change its mind and maintain its leader-ship," she said, adding that it was not her place to criticize

any government's policy.

Byanyima pleaded with the Trump administration not to abruptly cut off funding, which she said has resulted in "panic, fear and confusion" in many of the African countries hardest hit by AIDS.

In one Kenyan county, she said 550 HIV workers were immediately laid off, while thousands of others in Ethiopia were terminated, leaving health officials unable to track the epidemic.

She noted that the loss of US funding to HIV programs in some countries was catastrophic, with external funding, mostly from the US, accounting for about 90% of their programs. Nearly \$400 million goes to countries like Uganda,

Mozambique and Tanzania, she said. "We can work with (the Americans) on how to decrease their contribution if they wish to decrease it," she

said. Byanyima described the American withdrawal from global HIV efforts as the second biggest crisis the field has ever faced - after the years-long delay it took for poor countries to get the lifesaving antiretrovirals long available in rich countries.

Byanyima also said the loss of American support in efforts to combat HIV was coming at another critical time, with the arrival of what she called "a magical prevention tool" known as lenacapavir, a twice-yearly shot that was shown to offer complete protection against HIV in women,

and which worked nearly as well as for men.

Widespread use of that shot, in addition to other interventions to stop HIV, could help end the disease as a public health problem in the next five years, Byanyima said.

She also noted that lenacapavir, sold as Sunlenca, was developed by the American company Gilead.

International aid, Byanyima said, "helped an American company to innovate, to come up with something that will pay them millions and millions, but at the same time prevent new infections in the rest of the world." The freeze in American funding, she said, didn't make economic sense.

"We appeal to the US government to review this, to understand that this is mutually beneficial," she said, noting that foreign assistance makes up less than 1% of the overall US budget. "Why would you need to be so disruptive for that 1%?"

Byanyima said that so far, no other countries or donors have stepped up to fill the void that will be left by the loss of American aid, but that she plans to visit numerous European capitals to speak with global leaders.

"People are going to die because lifesaving tools have been taken away from them," she said. "I have not yet heard of any European country committing to step in, but I know they are listening and trying to see where they can come in because they care about rights, about humanity.

Phones 'banned' in Brazil schools

SAO PAULO, Feb 10, (AP): Brazilian students returned to class last week with a new task: staying away from their smartphones as a new law restricting their use in schools takes

President Luiz Inácio Lula da Silva signed a bill in January limiting smartphone access at schools, in line with a trend seen in the US and Europe. It applies to public and private schools, and applies to classrooms and the halls.

Phones are still allowed for educational purposes, with the teacher's permission, and when needed for the student's accessibility and health. Schools have the autonomy to set their own guidelines, such as whether students can keep phones in backpacks or store them in lockers or designated

Before the federal law, most of Brazil's 26 states - including Rio de Janeiro, Maranhao and Goias - had already passed measures applying some restrictions to phone use in schools. As of 2023, nearly two-thirds of Brazilian schools had some limitations, with 28% banning them entirely, according to a survey last year by the Brazilian Internet Steering Committee.

But rules varied between states and between schools, and authorities and administrators struggled with enforcement.

That may have contributed to support for federal legislation from across the political spectrum - both allies of leftist Lula and the far-right former President Jair Bolsonaro. A survey released in October by Brazilian pollster Datafolha said that almost two-thirds of respondents wanted to ban smartphone use by children and teenagers at schools. More than threequarters said those devices do more harm than good to their children.

Porto Seguro, a nearly 150-year-old smartphones in classrooms last year and encouraged students to disconnect completely once a week. This year, it expanded its ban to include hallways, requiring students to keep their phones in lockers for the entire school day, including breaks.

"Students were having trouble concentrating," school principal Meire Nocito said in an interview Thursday. "There was also the issue of social isolation. Many students who used technology excessively would isolate themselves during breaks, interacting only through social media.'

"Banning cellphone use has helped create a space for social interaction, fostering relationships and teaching students to navigate conflicts, which are a natural part of human interactions. It has been very positive," she added.

Pakistan commits to global cancer battle

ISLAMABAD, Feb 10, (Xinhua): Pakistani President Asif Ali Zardari and Prime Minister Shehbaz Sharif reaffirmed the country's commitment to global efforts in the fight against cancer as Pakistan marked World Cancer Day recently.

The president said that the day serves as a reminder of the immense challenges posed by the disease and an opportunity to inspire hope through collective action, innovation, and resilience, the President's Office said in a statement

"By raising awareness and strengthening our healthcare response, we can collectively combat cancer and reduce its impact on our communities," the president said.

Meanwhile, the prime minister highlighted the government's focus on enhancing cancer care infrastructure, investing in research, and ensuring access to affordable and high-quality treatment for all citizens, the Prime Minister's office said in a statement.

He added that Pakistan continues to work in partnership with healthcare professionals, researchers, and international organizations to enhance its capacity for cancer prevention and treatment. World Cancer Day is observed annu-

ally to raise awareness and encourage action in the global fight against cancer. Meanwhile, cancer remains one

of the leading causes of mortality in Mongolia, accounting for one in every five deaths, according to the country's National Cancer Center (NCC) on

"A total of 4,755 people died from cancer in Mongolia in 2024, account-

ing for one in five deaths in the country," the NCC said in a statement on the occasion of the World Cancer Day, which falls on Feb. 4 each year.

Additionally, the Asian country, with a population of 3.5 million, recorded 8,169 new cases of cancer in 2024, marking an increase of nearly 13 percent compared to the previous year. The NCC attributed this rise in part to

improved early detection efforts.

While 80 percent of cancer patients in Mongolia were previously diagnosed at a late stage, the situation has improved, with the figure dropping to 65 percent, the center noted.

The most common types of cancer among Mongolians include liver, stomach, lung, cervical, and colorectal cancer, reflecting long-standing public



Noh takes Founders Cup

SCOTTSDALE, Ariz., Feb 10, (AP): Thomas Detry nearly aced the rowdy par-3 16th hole in a stretch of four closing birdies, shooting a 6-under 65 on Sunday to win the Phoenix Open by seven shots for his first PGA Tour victory.

A year after soggy conditions led to multiple delays, perfect weather greeted players at TPC Scottsdale's Stadium Course. The fans also were on their best behavior - as much as they can be at the PGA Tour's wildest stop - following a mayhem-filled 2024 tournament.

Detry took advantage of the ideal conditions and navigated the rowdiness to enter the final round with a five-shot lead. Top-ranked Scottie Scheffler, Jordan Spieth and Daniel Berger all made charges, but Detry hit it to 16 inches on 16 to seal his first win in 68 PGA Tour starts.

Detry added two more birdies to finish at 24-under 260, becoming the first Belgian to win on the PGA Tour.

Berger (67) and Michael Kim tied for second. Spieth shot 68 to tie for fourth at 16 under in his second tournament since wrist surgery last summer.

Scheffler shot 31 on the front nine to reach 14 under, only to fade. He gad a 5-over 41 on the back nine for a 72, dropping into a tie for 25th at 8 under in his second start since he injured his hand on a broken glass

Yealimi Noh turned a one-shot deficit into a threeshot lead over three-time champion Jin Young Ko in the span of two holes on the back nine Sunday and cruised from there to her first LPGA Tour victory in the Founders Cup.

The 23-year-old from Northern California shot a 3-under 68 to finish at 21-under 263 at Bradenton Country Club, four shots better than Ko (71). Noh made her last bogey of the week on her final hole Friday, then surged into the lead Saturday with a 63

Noh was making her 111th career start, the first of her sixth season on tour. She made 10 straight pars, allowing Ko to edge in front, but holed birdie putts of about 15 feet on the 13th and 12 feet on the par-4 14th while Ko made bogey on each - her first bogeys of the week.

Ko missed a chance to win the event that honors the tour's founders on a fourth venue. She won in 2019 at Desert Ridge in Phoenix, 2021 at Mountain Ridge in New Jersey and 2023 in a playoff at Upper Montclair, also in New Jersey.

Megan Khang (68) was another shot back. Miyu Yamashita, Hannah Green and Jin Hee Im tied for fourth at 13 under. Top-ranked Nelly Korda, who won a different tournament on this course last year to kick off a seven-win season, closed with a 71 to finish nine shots back.

In Riyadh, Saudi Arabia, Adrian Meronk of Poland won LIV Golf's first tournament under the lights Saturday night, shooting a 1-under 71 to complete a wire-to-wire victory.

Meronk finished at 17-under 199 after opening with rounds of 62 and 66 at Riyadh Golf Club. Jon Rahm and Sebastian Munoz tied for second, two strokes back after rounds of 67.

Rahm's Legion XIII won the team title.

Li Haotong of China made a 15-foot birdie putt on the final hole Sunday for a 3-under 69 and a one-stroke victory over Denmark's Rasmus Neergaard-Petersen in the Oatar Masters.

Li let out a loud roar, pumped both fists and wept in the arms of his caddie after his winning putt at Doha Golf Club. He finished at 16-under 272 for his fourth European Tour title.

Neergaard-Petersen closed with a 65.

Miguel Angel Jimenez won the Trophy Hassan II on Saturday at age 61 for his 14th PGA Tour Champions victory, beating Steven Alker by two strokes.

Jimenez drove the green on the par-4 17th to set up an eagle in a closing 4-under 69 at Royal Golf Dar Es Salam. The Spanish player finished at a tournament-record 11-under 208. Alker shot 71.

Kyle Westmoreland won the Astara Goplf Championship for his first Korn Ferry Tour title Sunday, shooting a 1-under 71 in light rain for a one-stroke victory.

Westmoreland won a day after shooting a careerbest 61 on the Lagos Course at Country Club de Bogota. The 33-year-old Air Force Academy graduate finished at 18-under 265.

Pierceson Coody (66) and Christo Lamprecht (68) tied for second.

England's Cara Gainer beat India's Diksha Dagar in a playoff in the Lalla Meryem Cup in Morocco for her first Ladies European Tour title. Gainer closed with a 4-under 69 to match Dagar (67) at 9-under

Josh Geary won the Vic Open on Sunday at 13th Beach Golf Links for his first PGA Tour of Australasia title in almost 12 years. The New Zealander shot a 6-over 78 in high wind to finish at 13 under, four strokes ahead of Connor McKinney. Jamie Rutherford of England won the Cape Town Open on Sunday for his first Sunshine Tour title. He shot a 3-under 69 in windy conditions to finish at 14 under. Keenan Davidse was two strokes back after a 67.

PSG starts as the big favorite to advance

Blockbuster clash as Man City hosts Real in Champions League playoffs

LONDON, Feb 10, (AP): Real Madrid vs. Manchester City in the Champions League is the accidental blockbuster of the new knockout playoffs round, which starts Tuesday.

Surprisingly, the past two title winners finished midtable in the new 36-team standings format that ended in January. The top eight teams skipped the playoffs and went directly to the round of 16 in March.

The penalty for City and Madrid is now to meet in the extra stage inserted into the format just to enter the round of 16 that they have come to expect as their rightful place.

Bayern Munich and Paris Saint-Germain also are wealthy and influential clubs now facing unexpected jeopardy in the two-leg playoffs on back-to-back midweeks in February.

The bonus for UEFA and broadcasters is having global attractions in action for two extra games after an expanded opening league phase. If record 15-time champion Madrid is to retain its European title, it will take playing 17 games instead of 13 last season.

New signings Omar Marmoush in attack and Nico Gonzalez in midfield have barely settled in - with Gonzalez getting injured early into his debut in the FA Cup and now a doubt for the Madrid game.

Madrid, however, is now rolling as La Liga leader since its early-season wobbles when Kylian Mbappé took longer than expected to settle in.

The France superstar has scored nine goals in his last eight games, most recently the equalizer against Atletico Madrid in the Spanish league on Saturday. His first game in a Madrid shirt against Erling Haaland is a key narrative among many before the winner is decided on Feb. 19 at the Santiago Bernabeu stadium.

An all-France game in February was impossible in the past 20 years because UEFA separated teams from the same country until the quarterfinals draw. Now the

tennis-style seeded knockout bracket does not keep national rivals apart.

There could have been Dutch and Italian derbies in the playoffs but Juventus was paired with PSV Eindhoven and Feyenoord got AC Milan. All four are former European champions.

Juventus and PSV meet Tuesday for the second time in Turin this season. Juventus, which has drawn more games than it has won this season, beat PSV 3-1 in September in the first of the 144 league-phase games.

Bayern reached the final when the Champions League title was last decided at its stadium in Munich - in 2012 when Chelsea won on penalties after a 1-1 draw.

The seven-time European

back to a home-field final on May 31 after placing 12th in the league standings. Still, the blow of being in the playoffs was softened by being drawn against Celtic instead of Man City.

Spurs ravaged by injuries this season

Two cup exits in week leave Ange under major scrutiny

LONDON, Feb 10, (AP): Two cup exits in a three-day span have left Tottenham staring at the prospect of another trophyless season and manager Ange Postecoglou facing the biggest crisis in his time at the club.

A 2-1 loss at Aston Villa in the fourth round of the FA Cup on Sunday came on the heels of an exit from the English League Cup semifinals after a 4-0 second-leg thrashing at Liverpool on Thursday.

With Tottenham languishing in 14th place in the Premier League, the team's only chance of a first piece of major silverware since 2008 lies in winning the Europa League. Spurs have advanced to the last 16 of the second-tier European competition.

In September, Postecoglou put pressure on himself by saying in an interview: "I don't usually win things, I always win things in my second year (with a team). Nothing's changed."

He was referring to spells at Australian clubs South Melbourne and Brisbane Roar, Japanese side Yokohama F. Marinos, Scottish giant Celtic and also with Australia's national team, which won the Asian Cup in his second year as coach.

Postecoglou has only a few months left of his second campaign at Tottenham, where he started so promisingly - the team was undefeated and top of the Premier League after 10 games of his first season - but has imploded, leaving question marks over the Australian's style of play.

Tottenham has been ravaged by injuries this seaso as the games came thick and fast in a number of competitions, and at least now has gaps in the schedule for more rest before recovering key players like Cristian Romero, Dominic Solanke and Micky van der Ven.

"This group of players has done an unbelievable job for 2 1/2 months. An unbelievable job," Postecoglou said. "Can't praise them highly enough

for the effort they've put in - a small group of players playing twice a

week since the middle of November. "They will get some opportunity to recover now, we'll get some players back over the next couple of weeks and we'll look forward to resetting and finishing the season strongly."

Postecoglou will hope for more goals from Mathys Tel, a 19-year-old French forward who joined on the last day of the winter transfer window and scored a late strike against Villa to set up a tense finale.

Ultimately, Tottenham was undone by a big error from goalkeeper Antonin Kinsky, who let a shot from Jacob Ramsey squirm through his grasp after just 57 seconds. Morgan Rogers added a second for Villa in the 64th.

"Wasn't a great start - it's the last thing you want," Postecoglou said. "That gave them some momentum for the first 45 minutes and we struggled to get some control."

Unwavering motivation

Indian skater defies age and defines legacy at Winter Asiad

HARBIN, Feb 10, (Xinhua): Vishwaraj Rajendrasinh Jadeja stepped off the ice, his breath still heavy from the grueling 5,000-meter race at the Harbin 2025 Asian Winter Games. A thin sheen of sweat lingered on his forehead as he walked into the mixed zone, his body exhausted yet his spirit undeterred.

spirit undeterred.
"Very painful. Very, very painful," Jadeja admitted after finishing 14th out of 16 competitors. "I was very nervous. But it was okay. I'm already performing better than my time in 2017 in Sapporo. I am very happy with it." At 39, Jadeja has inked his name into the record books as the oldest speed skater at the Harbin Games and the most senior member of India's delegation. Yet, for the father of two daughters, age is not a barrier but a testament to his resilience. He has spent nearly two decades pushing boundaries in a sport that had little representation in India when he first embarked on this journey.

Jadeja's path to ice was never a predetermined one - his sporting roots were on wheels, not blades.

He was born into an athletic family in Gujarat, one of the most industrialized states in India and the birthplace of Mahatma Gandhi. His father was a three-time national champion in roller and inline speed skating, and his aunt also competed in inline skating. Following their footsteps, Jadeja made his debut at the national championships in 1999, before becoming a national champion and representing India's national team in roller sports.

But something greater stirred him. Watching the Olympic Games on television - beginning with Atlanta 1996 - ignited a dream within him, a dream that his chosen sport could not fulfil. Inline skating never made it into the Olympic program, forcing Jadeja to confront a harsh reality. If he wanted to become an Olympian, he would have to start over.

"I packed my bags and moved to Europe to pursue the dream of representing India in long-track speed skating at the Winter Olympics," he recalled.

In 2008, at the age of 22, he laced up ice skates for the first time in Sweden, diving headfirst into an entirely new world. That same year, he watched the Beijing Olympics, further solidifying his determination.

"It was amazing to see, and to hold your [national] flag at the Olympics is obviously the greatest honor of your life. So I think that is something which inspired me a lot to keep pursuing what I do," he told Xinhua.

His coach Wim Nieuwenhuizen, who has mentored him for 15 years, vividly remembers those early days. "He came as a roller skater, with-

out any idea how to skate on ice. He learned skating very well so that he could become one of the best, although not the fastest anymore," Nieuwenhuizen said.

The Dutch coach described Jadeja as "a crazy guy," an athlete with unwavering "motivation, will, and courage" to leave India for Europe in pursuit of his Olympic dream.

Jadeja came painfully close to realizing that dream twice. Before the PyeongChang 2018 Winter Olympics, a severe back injury left him unable to walk for a month, derailing his qualifi-

cation hopes. Again, in the lead-up to Beijing 2022, he narrowly missed out.

Despite these heartbreaks, he refused to walk away.

"You just want to improve yourself every day a little bit. And you keep trying to do that over and over again," he said.

Jadeja is notably the best speed skater in India, having set 65 national records in his career and participated in over 200 international competitions.

At the Harbin Winter Asiad, he is competing in four events - men's 1,500m, 5,000m, team sprint, and team pursuit. India made its debut in the team sprint on Monday and now faces the team pursuit on Tuesday.

Despite finishing lower in the standings in his individual races, Jadeja remains upbeat. "We are here to get inspired and inspire," he emphasized.

For Jadeja, competing is only part of his mission. He has established a skating school, actively planning its expansion to nurture the next generation of Indian skaters.

"Now we're trying to open skating schools all over the country because I'm very happy that kids are inspired by the whole Indian team's journey to the Asian Winter Games. I hope the next contingent is bigger. In 2017, we had a very small contingent. Now we are almost twice as big, which is a great hing." Jadeja expressed gratitude to coaches and personnel from the Netherlands, South Korea and China, and to the Asian Skating Union in helping India prepare for the Harbin Winter Asiad and develop the sport in his country.

"It was great to see all the Asian countries coming together for the promotion of the sport, for the well-being of the athletes. Together we can do a lot of good, great things," he said.

Despite his unwavering dedication, Jadeja acknowledges that his time as a competitor may be drawing to a close. After years of constant travel, he is considering shifting his focus toward family.

"I think I will finish. This is my last year," he revealed.

But when pressed about whether he might appear at the next Asian Winter Games, he left the door slightly ajar.

"I'm taking one day at a time. Let's see where we get," he said.

"I didn't achieve the result I was hoping for, but I am very happy to have been part of this experience, and it will definitely boost my confidence moving for-

that winter sports are flourishing in their countries. Faris Alobaid, 37, marked Kuwait's Asian Winter Games debut in alpine skiing

on Sunday. An investor by profession, he set aside his busy schedule to focus on preparing for the event.

"Sport is the best way to bring people together, fostering friendship and showcasing different talents," said Alobaid.

"This is an excellent opportunity to showcase our country to the world, demonstrating our friendliness and openness for business," the Kuwaiti added.

Kuwait has recently established several ice hockey clubs and constructed a

high-level rink for hosting international ice hockey events. Since 2023, skiing has been actively promoted in the country. Alobaid, who learned to ski at the age of eight in the French Alps, has become a pioneering figure in his country's skiing scene. Six months ago, he hired a coach for the newly-established Kuwait national team. "We understand the theory of turning and not

Japan's Takatsugu Uda was 10 seconds behind Yamashita to earn the silver, while Kazakhstan's Olzhas Klimin secured the bronze in 21 minutes and 20.3 seconds.

Hurts throws for two touchdowns to earn MVP honors

NEW ORLEANS, Feb 10, (AP): Yo Philly: Jalen Hurts and Nick Sirianni are world champions.

A ferocious Philadelphia Eagles defense tormented and frustrated Patrick Mahomes while Hurts made all the plays the offense needed.

So much for the Kansas City Chiefs' quest for a Super Bowl three-peat.

It wasn't even close. Cooper DeJean got a pick-6 on his 22nd birthday, Josh Sweat pressured Mahomes all night and the Eagles routed the Chiefs 40-22 on Sunday to secure the franchise's second Super Bowl championship.

Hurts threw for two touchdowns and ran for a score on a tush push to earn Super Bowl MVP honors, and Vic Fangio's defense was so dominant that the Eagles didn't need much from Saquon Barkley. The game-changing running back finished with 57 yards, breaking Terrell Davis' record for yards rushing in a season, playoffs included. Hurts threw for 221 yards.

"This is the ultimate team game. You can't be great without the greatness of others. Great performance by everybody - offense, defense, special teams," Sirianni said. "We didn't really ever care what anyone thought about how we won, or their opinions. All we want to do is win.

Hurts has been doubted since he started for Alabama in a national

New Zealand reaches tri-nation series final

LAHORE, Pakistan, Feb 10, (AP): Kane Williamson trumped South African opener Matthew Breetzke's record-breaking debut ODI hundred and led New Zealand to the tri-nation series final with a six-wicket win on Monday.

Williamson followed his Saturday's half century against Pakistan with an unbeaten 133 off 113 balls -- his first ODI century since 2019 World Cup - and cruised New Zealand to 308-4 for its second successive win.

The tournament is being served as build up for the Champions Trophy later this month and Williamson has tuned up perfectly for the mega event with two meaningful knocks. Breetzke had earlier became the first cricketer to score 150 in his maiden ODI

appearance and guided an understrength South Africa to 304-6 after New Zealand captain Mitchell Santner won his second successive toss and elected to field. Williamson and Devon Conway setup the run-chase with a solid second-wicket

partnership of 187 runs against a weakened South African pace bowling attack. Fast bowlers Marco Jansen and Kagiso Rabada are among seven players scheduled to join the South Africa team for Champions Trophy over the weekend after the tri-nation series final on Friday.

Williamson used his feet well against inexperienced bowlers and even experienced wrist-spinner Tabraiz Shamsi also couldn't separate the pair on a flat

Williamson completed his second fastest century in ODIs off 72 balls with a single, but Conway missed out on his hundred when he fell for 97 while attempting the landmark with a square cut.

Conway made it to the playing XI after Rachin Ravindra got a blow on his forehand in the field during New Zealand's thumping 78-run win in the first match at the newly renovated Gaddafi Stadium on Saturday.

The left-hander fully capitalized on a missed stumping chance when he was on 36 and hit nine fours and a six before he was brilliantly caught at point by Senuran Muthusamy - one of the four debutants for South Africa. New Zealand middle-order stuttered briefly when left-arm spinner Muthusamy

got the wickets of Daryl Mitchell (10) and Tom Latham of successive balls with the latter falling for his second successive duck in the tournament. Glenn Phillips (28 not out), whose maiden ODI century had romped New Zealand to a big win on Saturday against Pakistan, and Williamson then shared an

unbroken 57-run stand to seal the match. Williamson raised the victory with eight balls to spare with his 13th boundary when he smashed Muthusamy through mid-off.

Debutant opening batter Breetzke, who isn't part of South African squad for this month's Champions Trophy, smashed 150 off 148 balls and broke West Indies batter Desmond Haynes' record of 148 against Australia in 1978. South Africa rode on Breetzke's blitz to score 304-6.

After losing captain Temba Bavuma (20) inside the power play, the 26-year-old Breetzke shared 93-run stand with Jason Smith (41) - another batter overlooked for the Champions Trophy. He pushed the scoring rate with some exhilarating hitting - especially on the off side of the wicket - and added further 131 runs with Wiaan Mulder, who made 64 off 60 balls.
