KUWAIT CITY, Feb 11: Assistant Minister of Foreign Affairs for Development and International Cooperation Ambassador Hamad Al-Mishaan has confirmed that Kuwait is taking measures to combat terrorism and financing it.

Al-Mishaan made the statement on the sidelines of a workshop on developing investigation capabilities, effectively pursue cases of financing terrorism and implementing Security Council sanctions: in cooperation with the United Nations Office on Drugs and Crime (UNODC) through video conference at Saud Al-Nasser Al-Sabah Kuwaiti Diplo-

matic Institute on Tuesday.

He disclosed "this is part of a series of measures we are taking, because Kuwait is currently going through the evaluation phase in the Financial Action Task Force. We are intensifying workshops and awareness on this issue, not only for employees of the Ministry of Foreign Affairs; but also for the concerned parties in banks and investment companies in order to raise awareness on this matter.



Weather conditions to improve Thursday

Stormy symphony of rain, thunder, fog to hit Kuwait

KUWAIT CITY, Feb 11: Kuwait's Meteorology Department has forecast changes in weather conditions over the coming days, with rain, thunderstorms, and fog expected across the country, reports Al-Seyassah

According to the department, a weakening highpressure system will give way to an incoming lowpressure system carrying a humid air mass. This shift will bring increasing low and medium clouds, with scattered light rain starting Tuesday morning. Rainfall is expected to intensify gradually, ranging from light to moderate, and will continue intermittently until Thursday morning, occasionally accompanied by thunderstorms.

The Director of the department Dharar Al-Ali told KUNA that the rains will be accompanied by southeasterly winds, which will be active at times, and there will be a chance of dense fog forming on Wednesday evening. This will cause a reduction in horizontal visibility, which could be completely ab-

He explained that the weather conditions are expected to improve from Thursday afternoon with the return of the high-pressure system, causing clouds to decrease and the chances of rain to diminish.

The weather on Wednesday will be cold and cloudy, with northeasterly winds shifting to southeasterly. These winds will be light to moderate, ranging from 10 to 40 km/h, with a chance of scattered rain, which may occasionally be accompanied by thunder. The expected maximum temperatures will be between 17 and 19 degrees Celsius.

The sea will be light to moderate, with waves rising to between two and six feet at times. At night, the weather will remain cold and cloudy, gradually becoming partly cloudy. Winds will shift from north easterly to variable directions, light to moderate in speed, sometimes reaching stronger gusts between 8 and 40 km/h. Scattered rain is still possible, with occasional thunderstorms and the potential for fog in some areas. Minimum temperatures are expected to range between 10 and 12 degrees Celsius. The sea will continue to be light to moderate, with waves ris-

ing to between two and six feet. On Thursday, the weather will improve, becoming moderate and partly cloudy, with horizontal visibility gradually improving. Winds will shift to a northwesterly direction, light to moderate in speed, ranging between 8 and 32 km/h. There may still be light scattered rain in the southern parts of Kuwait. Maximum temperatures are expected to reach between 19 and 21 degrees Celsius, and sea conditions will remain light to moderate, with waves between one and four feet.

Thursday evening will see moderate, partly cloudy weather, with winds shifting to a northwesterly direction, light to moderate in speed (8 to 32 km/h). The minimum temperatures will range from 10 to 12 degrees Celsius, and the sea will continue to be light to moderate, with waves between one and four feet.

75% local purchase mandate for co-ops

KUWAIT CITY, Feb 11: In line with the recommendations of the Council of Ministers to enhance local production, achieve food security, support Kuwaiti farmers, and increase the share of national products in cooperative markets, Minister of Social Affairs, Family, and Childhood Affairs Dr. Amthal Al-Huwailah issued a ministerial decision yesterday to mandate cooperative societies to purchase no less than 75 percent of their agricultural product needs directly from approved marketing outlets by participating in daily auctions. These transactions will be conducted through automated invoices to ensure transparency and improve the efficiency of buying and selling operations, reports Al-Seyassah daily.

Kuwait's CPI score holds at 46: report

KUWAIT CITY, Feb 11: Kuwait has maintained its score in the Global Corruption Perceptions Index (CPI) for 2024 at 46, while its global ranking dropped by two positions from 63rd to 65th. Kuwait's ranking in the Arab world has decreased from 4th to 7th, and in the Gulf region, it ranked 6th.

For the seventh consecutive year. Denmark topped the index with a score of 90, followed by Finland with 88 and Singapore with 84. The global average for the Corruption Perceptions Index is 43 points, and more than half of the countries (56 percent) scored lower than that.

Kuwait dispatches 23rd plane to Syria with 10 tons of aid

KUWAIT CITY, Feb 11, (KUNA): Kuwait dispatched the 23rd relief aircraft to Syria on Tuesday, carrying 10 tons of flour as part of the ongoing relief campaign, organized by the Kuwait Zakat House in coordination with the Ministries of Foreign Affairs and

In a statement to KUNA, before the plane's departure, Projects and Local Organizations Superintendent at the Zakat House, Aayed Al-Mutairi emphasized that the continuation of the air bridge reflects Kuwait's deep-rooted commitment to humanitarian assistance and the historical ties between the two nations.

The aid shipments were requested by the Syrian Arab Red Crescent (SARC), which assesses urgent needs across provinces, particularly in light of increasing demand for essential food, medicine, and shelter supplies due to instability and a lack of infrastructure, Al-Mutairi explained.

He also noted that Kuwait Zakat House plans to expand relief efforts by organizing ground convoys in the near future, aiming to transport large quantities of essential supplies, and that these efforts are being coordinated with Kuwait's Ministry of Foreign Affairs and other relevant authorities to facilitate cross-border humanitarian assis-

Acting Manager for Foreign Activities, Abdulrahman Al-Terkeit reaffirmed the organization's commitment to aiding Syrians since the start of the crisis over a decade

SARC has highlighted the urgent need for essential items, particularly flour, and future aid shipments will prioritize medicine and shelter supplies to address urgent humanitarian needs, Al-Terkeit added.

This plane is Kuwait Zakat House's fourth relief flight, bringing its total aid shipments to 122 tons, he cumulative assistance delivered through the Kuwaiti air bridge to Syria now stands at 601 tons.

Meanwhile, Kuwait's 22nd aid-loaded plane arrived at Damascus International Airport on Monday, carrying 10 tons of foodstuff, coordinated by Ministry of Social Affairs, Ministry of Foreign Affairs, Ministry of Defense and Kuwait Red Crescent Society (KRCS).

KRCS collaborated with humanitarian and charitable associations, as well as official institutions, in coordination with the Syrian Arab Red Crescent, to secure arrival and delivery of the aid

Overall volume of Kuwaiti aid reached 591 tons so far.

Question on 'Metro Project' deferred at MC panel meet

KUWAIT CITY, Feb 11: The Technical Committee at the Municipal Council, led by Munira Al-Amir, convened Tuesday during which it deliberated on eight items in its agenda.

The committee requested detailed studies from the executive body on two matters: amending the Municipal Council's decision on the Egaila Beach development project (No. 7) and adding a fastfood restaurant activity to the main roads.

Three requests were returned to the executive body for updates as follows: allocating land for a stray dog shelter, amending the requirements for residential complex buildings, and addressing the residential construction percentages issue in Abu

The committee deferred the vice-chairman's question about the Metro Project, the Real Estate Ûnion's observations on building work regulations, and a soft drink company's request to allocate sidewalk space for coolers.

'Excessive use of social media leads to depression, anxiety'

KUWAIT CITY, Feb 11: Acting Director for Educational Activities and Supervisor of the Social and Psychological Services Department at Jahra Educational District Aida Bushehri said the department has conducted a study about the impact of social media on the academic performance of a random sample of around 3,000 students in the intermediate and secondary stages; indicating that the study took two months of continuous work, reports Al-Anba daily.

Bushehri made the statement after attending the 27th forum about the impact of using social media on the academic performance of students at Mohammad Al-Mahini School, with a large number of psychological and social researchers in attendance.

She disclosed that the study showed the negative and positive effects of social media and smart devices, citing the negative effects as distraction, poor concentration and lack of understanding among students who spend a lot of time on social media. She warned that the excessive use of electronic communication tools could lead to depression, anxiety, tension and isolation.

She stated that the study recommended opening a file for a student proven to be using smartphones and social media sites for more than 10 hours a day, because he needs psychological and social intervention by specialists. She revealed that seven percent of the study sample use their smartphones for around eight to 10 hours a day.

She added the study revealed that 30 percent of the sample use 'Tik Tok', 21 percent use 'Snapchat', 18 percent spend their time on other social media sites, 10 percent are on 'Instagram', 9.5 percent on electronic games, 6.8 percent on 'WhatsApp' and $\bar{1}.4$ percent on 'Twitter'.

She stressed the need to focus on raising the awareness of society in general, and the students in particular, about the dangers of excessive use of the aforementioned applications and the need to use them properly through seminars, media outlets and school administrations,

She also emphasized the importance of regulating the use of distance learning programs in solving assignments and reviews to fully benefit from modern technology, and keep students away from anything that distracts them and wastes their time. She recommended activating the 'Teams' application all the time, not only during crises

Article 153 of penal code cancellation step in right direction

KUWAIT CITY, Feb 11: The announcement of Justice Minister Nasser Al-Sumait about the government's move to cancel Article 153 of the Penal Code, which includes the legal excuse for the perpetrator of an honor crime, is a step in the right direction towards the victory of Kuwaiti women's rights, considering the demand of women's, liberal and legal movements in the country to amend it have extended for more than 20 years.

The newspaper interviewed female activists and constitutional experts who confirmed they are pleased with this development and emphasized that this article violates Article 29 of the Constitution, which guarantees equality between men and women. They pointed out some have taken advantage of the loophole to commit honor crimes and kill women in order to obtain their inheritance. Some even referred to it as "a black spot in Kuwait's humanitarian, regional and international record.

Head of Women's Cultural and Social Society Lulwa Al-Mullah stated that "we have repeatedly called for the repeal of this article, particularly since it continued to contribute to violence against women, as it lessens the punishment for men who kill their wives for committing adultery and allows them to kill their mothers or sisters, which is unfair. Repealing this article is a victory for women as well as for the Con-

stitution, particularly Article 29. Constitutional expert and Professor of Law at Kuwait University Dr. Mohammad Al-Filli said the move to cancel Article 153 of the Penal Code is a good development, especially since the text of this article is in favor of men in the event they commit felony when surprise infidelity occurs. "If this text is removed, the general rules in Penal Code will apply to men, so there will be reciprocity between men and women and there will be no discrimination between them," he elaborated.

On the constitutional suspicion over Article 153; he clarified that since the mitigation text in Article 153 is for men without considering the women, canceling this article is absolutely consistent with Article 29 of the Constitution, which stipulates gender equality.

Legal advisor Anwar Al-Rasheed strongly supports Al-Sumait's announcement regarding the government's move to cancel Article 153 of the Penal Code, stressing that "it is unconstitutional and the cancellation will relieve the country of continuous criticism from international human rights organizations.

Former head of the Kuwaiti Liberal Society and Kuwaiti women's rights activist Iman Hayat confirmed that "this step is wonderful and in the right direction, considering it is unfair for women." She called for the continuation of efforts to address all issues related to Kuwaiti women's rights.

Women's rights activist and cybersecurity expert Huda Al-Kuraibani considers Article 153 of the Penal Code a stain on the forehead of Kuwaiti law; indicating that she participated in several campaigns to combat discrimination against Kuwaiti women in the past, describing Article 153 as "racist."

Trump, Arab swing state voters and the Gaza card

"One of the things that irritated me the most and I cannot forget was the justification given by some Arab Americans who supported Trump in the last election, claiming that he would stop the war in Gaza! And I would respond to them that he will, but it is unwise to expect that it would be in favor of the Palestinians and Arabs", columnist Dr. Samer Abu Rumman wrote for Al-Anba daily.

"In U.S. presidential elections,

it is common to have swing states where both the Democratic and Republican parties enjoy relatively equal levels of support from voters. In the 2024 election, there were seven swing states: Arizona.

Michigan, vada, North Caro-

lina, Wisconsin, and Pennsylvania. 'When voting, some Arab Americans chose to support Trump due to their dissatisfaction with the Biden administration and its unconditional support for Israel in its aggression against Gaza since October 7

"In contrast, Trump promised to stop the war. This shift in support among Arab American voters played a key role in determining the results in favor of Trump in three of the swing states.

"In Wisconsin, the Arab vote contributed to Trump winning 51.2 percent of the votes, compared to 47.3 percent for Kamala Harris, and 1.5 percent for Jill Stein.

"In Pennsylvania, the Arab American vote narrowed the gap between the candidates in favor of Trump, who received 49.8 percent, compared to 48.7 percent for Kamala Harris, and 1.5 percent for Jill Stein.

"The biggest shock came in Michigan, home to the largest Arab American community in the U.S., particularly in cities like Dearborn and Hamtramck, where Trump received 42 percent of the votes, compared to 36 percent for Kamala Harris, and 18 percent for Jill Stein. This was a striking shift compared to the 2020 presidential election results, when Biden won 69 percent of the votes compared to Trump's 30 percent.

'Trump's victories in these states earned him 44 electoral votes, thus easily surpassing the necessary 270 votes to win the election!

"However, the joy of Arab Americans who voted for Trump was shortlived, just as I expected and told It wasn't long before he made his thoughts known about deporting the residents of Gaza to Jordan and Egypt, and having the United States manage and develop the Gaza Strip! This sparked outrage among some Arab Americans and made them regret their decision!

"Trump succeeded in using Gaza to secure Arab votes, even though his recent statements should not be surprising to anyone who paid attention to his positions during his first term. He did whatever he wanted without any regard for anyone, such as moving the U.S. Embassy to occupied Jerusalem and recognizing Israel's oc-cupation of the Golan Heights. So, it is no surprise now to see him manipulating Gaza's fate and its people, and arrogantly dealing with Jordan and Egypt, claiming they will respond to his demands!"

"It is difficult to convince ourselves that we live in a democratic country when freedom of opinion is stifled, the right to express ourselves is restricted, and dozens of individuals who post on social media or show interest in political matters are detained or referred to court for allegedly insulting sister countries. This contradiction raises concerns about the true nature of our democracy", columnist Abdul Latif Al-Duaij

wrote for Al-Jarida daily. "Our constitution guarantees freedom of opinion and expression. It clearly states that Kuwait is an Arab country, and its people are part of the Arab nation. If this is the case, then Arab affairs should be considered a local matter that is open to discussion just like any other issue within Kuwait. The people of Kuwait should have the right to engage in these discussions freely, without fear of retribution.

"Arab presidents and officials often visit us, but these visits are rarely about political understanding; they are more about seeking financial support . Meanwhile, officials from these countries discuss our internal issues, impose solutions on our problems, and constantly remind us of our iden-

tity as part of the Arab nation. "Consequently, we are expected to engage with and contribute to Arab issues and crises. Unfortunately, the people around us from the Arab tribes have nothing but crises and problems. It seems as though our involvement is more about addressing these challenges rather than giving solutions for ensuring peace and stability in the region.

"If we are truly part of the Arab nation, as our Constitution suggests,

and if we are obligated and invited to contribute to various Arab efforts, then why don't our intellectuals and those concerned with public affairs have a say in this matter? Why isn't it our right to discuss our required contributions and to question the seriousness and honesty of those who are responsible for coordinating or overseeing this involvement?

"We live in a region that is boiling with problems, and drowning in socalled solutions and remedies. It is difficult, if not impossible, to stand as a mere bystander. As we have shown, we are part of these problems, and we often provide the solutions, especially when they are based on financial support. However, we don't see prisoners for insulting countries like Japan or criticizing the regime in Argentina. Instead, we have fugitives and prisoners in our country, not for committing crimes, but for simply expressing their opinions about the countries and leaders with whom we share common issues.

"In fact, most of those convicted and imprisoned for their opinions in our country are those who were accused of insulting Arab presidents or officials. Criticizing internal conditions or policies hardly ever results in imprisonment. This stark contrast raises questions about the true nature of freedom of expression."

"In a press conference a few days ago, US President Donald Trump said in brief: 'The people of Gaza will leave their country and go abroad, such as Jordan, Egypt, Morocco and Somalia. We will take responsibility for dismantling all unexploded bombs and weapons there. We will level the site to the ground, get rid of the destroyed buildings, and create economic development that provides jobs and housing for the people in the region," Ahmad Al-Dawas wrote for Al-Seyassah daily.

"He added: We will implement tourism projects, so that the Gaza coast becomes like the French Riviera tourist resorts (end of his speech). This means following the policy of ethnic cleansing.

"We said in a previous article that Trump is applying the idea of the 'crazy president' -- a theory that by acting in an extremely volatile manner, the head of State can intimidate opponents and push them to make concessions to achieve gains. The heads of states have been practicing it over the past decades.

"This is a negotiating tactic, rather a trick, aimed at imposing concessions from Hamas and the Arab leaders. After Trump's proposal, Hamas may agree to completely relinquish power, as if it is saying: Enough, I will not remain in Gaza, do not expel the residents from their land' which, as we said, is to intimidate opponents and push them to give up.

"However, Saudi Arabia has taken a tough stance. Years ago, it was heading towards a normalization agreement with Israel on the condition of establishing a Palestinian State; but after Trump's proposal, it immediately announced that it would not establish official relations with Israel until Palestine is recognized

Stephen Cook, said in Foreign Policy Magazine:

Trump's plan is an absolute madness. Seizing Palestinian lands would lead to American war crimes and absolute regional chaos. The proposal is not just moral bankruptcy, but pure madness. "He added: If Trump wants to

transfer the Palestinian population, he will issue orders to the Army, which the American officers refuse to comply with, on the grounds that it is illegal and a crime against humanity. This will undermine the peace process in the region, re-empower Iran at a time it is weak, and embroil America in a regional conflict.

"The writer, Simon Siddall, said in an article published in the British newspaper, 'The Guardian': Trump is just another coward, denying the need for a Palestinian State. Harrison Cass wrote in the National Interest Magazine: Do not believe what Trump says about Gaza. In the Foreign Policy Magazine, writer Alexandra Sharp stated: The proposal provokes shock and global condemnation.

"This proposal did not receive support from European capitals.

"In our opinion, the proposal is excellent, if it is implemented with the presence of the people of Gaza, not by expelling them from their land.

"Some Arab countries will try to persuade President Trump to accept an alternative plan for the recovery of Gaza that includes aid provided by

Officer, lawyer, Kuwaiti get jail in drugs lawsuit

Court reopens luxury cars case

KUWAIT CITY, Feb 11: The Court of Cassation, headed by Judge Abdullah Al-Jassem, sentenced a State Security officer to seven years in prison, a lawyer to four years in prison and a citizen to five years in prison for consuming hasish, while it acquitted an Iranian in the same case and cancelled the life sentence imposed on him, and acquitted all defendants of smuggling and trafficking drugs.

Case files indicate that the Ministry of Interior personnel arrested the defendants while trying to smuggle about 200 kilograms of hashish into the country.

The Public Prosecution charged all defendants with smuggling the hashish with the intent to trade in it under illegal circumstances.

It also charged one of the defendants with smuggling psychotropic substances 'pregabalin' and 'amphetamine' and the possession of hashish with the intent to sell it under illegal circumstances, as well as driving under the influence of drugs.

Another defendant was charged with possessing hashish with the intent to use it without proving that he is legally authorized to do so. Attorney Abdul Mohsen Al-Qattan, the lawyer of this defendant whose 15-year prison sentence was cancelled, argued that the investigations were inconclusive. He demanded for the acquittal of his client.

Luxury cars case reopens: The Court of Cassation decided to reopen the pleadings in the luxury cars case in which two citizens are accused of defrauding 500 people and postponed the hearing until March 10.

The Court of Appeals had earlier increased the sentence of the owner and manager of the luxury car office by upholding 10-year imprisonment and fining them about KD 34 million, in addition to two years in prison with hard labor for the charges of fraud and deception.

The two defendants, both citizens, faced charges of fraud and money laundering with large sums after they were accused by more than 500 people in and outside Kuwait of defrauding them by supplying various vehicles and laundering their money obtained through fraud. They were accused of transferring the money that they obtained from the victims -estimated at more than KD 17 million and KD1.5 million Qatari rivals -- to hide their illegal source, after making the victims believe that they could buy luxury vehicles at a lower price from agencies, and then ship and deliver the vehicles to them.

Felon lawyer pays price: The Kuwait Lawyers Society has decided to remove a lawyer from its register of practitioners following a final and binding court ruling issued by the Court of Cassation that confirmed his conviction in a drug trafficking case, reports Al-

The society stressed that the decision was made after the lawyer's suspension period, which preceded the final ruling, in accordance with the standards of integrity, professionalism, and the regulations governing the legal profession.

'Inciting debauchery'

Court adjourns appeal filed by artiste Boland

KUWAIT CITY, Feb 11: The Court of Cassation adjourned the appeal filed by broadcaster Halima Boland against the ruling of the Court of Appeals

to refrain from pronouncing her punishment for the charge of inciting indecency and immorality until the session scheduled for Feb 17 to announce the verdict, reports Al-Seyassah daily.

The Criminal Court had earlier charged Boland with inciting debauchery and immorality, and misuse of a telephone due to her pictures and video clips



The plaintiff filed a complaint against her, claiming that she incited him to indecency and immorality through her pictures and private videos; while the accused claimed that the plaintiff insulted her by cursing her, so she filed a complaint against him on charges of insulting and misusing

Dog, gun, narcotics left in car as driver escapes

KUWAIT CITY, Feb 11: An unidentified individual driving a pick-up truck collided with a bus at a roundabout in the Al-Oyoun area of Jahra and fled the scene immediately prior to the arrival of the security personnel, leaving behind the vehicle, a dog, a gun, and a substance suspected to be a narcotic inside the vehicle, reports Al-Seyassah daily.

According to security sources, Jahra emergency patrols, while conducting their daily duties, witnessed the collision between the pick-up truck and the bus at the roundabout in Al-Oyoun, which resulted in the truck overturning. After the accident, the driver exited the vehicle and fled.

Upon searching the truck, officers found a dog, a gun, and a substance suspected to be narcotics.

The source stated that investigations are ongoing, and detectives are working on apprehending the fugitive.

Man acquitted of theft: The Misdemeanor Court acquitted an employee of a men's accessories company of betrayal of trust and theft of gold jewelry and branded pens, reports Al-Anba daily. The Public Prosecution referred the accused to the

court after investigating him on charges related to seizing the jewelry and branded pens that the company entrusted to him.

Lawyer for the accused, Attorney Abdulrahman Al-Muqaddam, pointed out the absence of the elements of the crime of betrayal of trust, the inconclusive investigations and lack of incriminating evidence. He explained that for one to be convicted of betrayal of trust, the material and moral elements of the crime must be proven, stressing both of these elements were not seen in the case of his client. He stated that the criminal intent in betrayal of trust is proven if the perpetrator has the intention to add the money he received to his property and embezzle it for himself, indicating there is no evidence to confirm this.

He added that betrayal of trust means the accused committed the act of embezzlement, squandering or misuse, and harm the victim; asserting his client did not commit any of these acts.

On the other hand, a citizen filed a report at a police station in Hawally Governorate; stating that his car was burgled and the suspect stole a bag containing official documents and an undisclosed amount while his car was parked at a cooperative society parking lot.

The citizen stated that he discovered the side window of the car was broken, and that the perpetrator was able to open it and steal the aforementioned items.

KUWAIT CITY, Feb 11: Undersecretary of the Ministry of Electricity, Water and Renewable Energy Dr. Adel Al-Zamel has formed a technical working team; led by Director of the Department of Groundwater Studies and Research Huda Al-

The team will review the recommendations of the Purchasing Committee concerning tender study, evaluate committee conclusions, look into the format of letters sent to the Central Agency for Public Tenders (CAPT), and provide feedback in collaboration with the concerned committees.

Meanwhile, the closing date for participation in the tender for the establishment, completion and maintenance of the Hawally water distribution complex and the corresponding works will be on March 4, say sources from the Ministry of Electricity, Water and Renewable Energy.

Sources confirmed that the bids of competing companies will be submitted to the Central Agency for Public Tenders (CAPT), which will open the bidding envelopes and then refer them to the ministry to pave the way for the preparation of the technical study by a committee specialized in studying bids. Sources said the study and bids will be referred to CAPT that will award the tender to the company with the best bid financially and technically, clarifying the study will be referred to the State Audit Bureau SAB) for review, audit and approval; followed by the signing of the contract with the

winning company.

Sources revealed that the ministry allotted KD4 million in its annual budget as the estimated cost of the project, which may increase or decrease depending on the bids submitted to CAPT.

In a press statement issued yesterday, the Ministry of Social Affairs explained that the decision mandates the appointment of a representative from each cooperative society to attend the daily auctions, with priority given to Kuwaitis.

Cooperative societies must allocate 30 percent of the total area of central markets for displaying local agricultural products for the benefit of the Kuwaiti Farmers Union

Cooperative societies will bear the cost of daily losses from local products, provided the losses do not exceed five percent of the value of purchases within one week. The person responsible for this will be identified, and necessary measures will be taken to minimize loss percentages.

The decision further set a profit margin of no more than 20 percent on local agricultural products

The administrative supervisor in each cooperative society will be responsible for reviewing daily purchase invoices, ensuring compliance with the decisions, and submitting monthly reports to the relevant department in the Ministry of Social Affairs. These reports will include violations, actions taken against non-compliant societies, and recommendations to address any regulatory loopholes.

The new decision also mandates the formation of a joint committee comprising representatives from the Ministry of Social Affairs, the Ministry of Commerce and Industry, the Public Authority for Agricultural Affairs and Fish Resources (PAAAFR), and the Union of Consumer Cooperative Societies

The committee will be chaired by the undersecretary of the Ministry of Social Affairs and will be responsible for overseeing the implementation of the decision. It will also submit monthly reports on compliance levels and evaluate the decision's impact.

The new decision revokes ministerial Resolution No. 115/2022, which supported the promotion of local agricultural products in cooperative societies, along with any provisions that conflict with the new decision

The decision will take effect immediately upon its issuance and publication in the official gazette, obligating all relevant parties to begin its implementation.

Kuwait vows

He added that the workshop was held through the coordinated efforts of the Kuwaiti Ministry of Foreign Affairs and the UNODC, shedding light on the issue of financing terrorism and the implementation of Security Council resolutions in this regard.

On the upcoming evaluation of Kuwait, he said "we are now in the one-year phase of the review. We are improving the laws and procedures, and amending the regulations in Kuwait to be in line with international requirements. On the meeting held with the minister of Social Affairs one day ago, Al-Mishaan disclosed that "it was a coordination meeting with the Ministry of Social Affairs, as the Ministry of Foreign Affairs is concerned with the issue of charitable societies outside Kuwait while the Ministry of Social Affairs is in charge of Kuwaiti charitable societies operating inside the country. We are coordinating with the Ministry of Social Affairs. Our work is unified, and we ensure that the work is within the legal and correct frameworks."

He added "we are improving all decisions and procedures for the benefit of Kuwaiti charitable societies and ensure their funds reach the rightful beneficiaries. This step improves the reputation of Kuwait in the international community."

He went on to say that the number of participants in the previous workshop was about 300; while Tuesday's workshop had more than 500 participants. "We made it easy for everyone to participate through the audio-visual communication system, as we are keen to have the largest possible number of participants in this workshop. Both the private and government sectors responded massively," he asserted.

He also underscored the need for everyone to follow the instructions. He said the Central Bank has launched a campaign called, 'Be Aware,' to educate the public on the subject of donation and participation in any project in which the citizen may not

know who the participants are.

With regard to cryptocurrencies, he pointed out "we are currently facing terrorist operations that have developed and entered into financing their operations with cryptocurrencies and artificial intelligence. We must keep pace with this development to combat it, especially in the matter of cryptocurrencies."

He then expressed his "deep appreciation and gratitude to the staff of the UNO-DC for their relentless efforts to make the workshop a reality. It was launched within the framework of cooperation between the State of Kuwait and the Office to reach new

horizons of joint cooperation."
He continued: Our workshop today is one of the outcomes of the High-Level Confer-

ence to Enhance International Cooperation to Combat Terrorism and Secure Borders, which was hosted by the State of Kuwait in November 2024 during which the 'Kuwait Declaration' was issued. We are holding our workshop amid worrying geopolitical developments in the region, which is witnessing an increased pace of operations related to financing terrorism and financing the proliferation of weapons, which threaten the security and stability of societies and hinder efforts to achieve development and sustainable peace. Although these challenges are cross-border and require international coordination to coordinate efforts in this regard, it is the responsibility of countries at the national level to enhance their capabilities to keep pace with developments arising from this scourge. It requires coordinating national efforts with international standards for combating terrorism and the proliferation of weapons, given the threat this phenomenon poses to peace and stabil-

He also revealed that terrorist organizations launch attacks, plan operations, recruit individuals, and raise funds in new ways that exploit the financial system and the legal framework to spread their influence and carry out their activities, especially artificial intelligence and digital currencies to avoid monitoring and follow-up procedures.

The top scorers among the Arab States are the United Arab Emirates with 68, Qatar with 59 and Saudi Arabia with 59. Libya with 13, Yemen with 13 and Syria with 12 scored the lowest.

According to the report issued by Kuwait Transparency Society in collaboration with the Transparency International, Kuwait's score was derived from eight sources such as Bertelsmann Foundation Transformation Index 2024, Economist Intelligence Unit Country Ratings 2024 and Global Insights Country Risk Ratings 2023 among others.

Kuwait's evaluation in four sources by 18 points helped compensate for the decrease in its evaluation in the other four sources by 17 points, resulting in a partial balance in the overall total.

Also, the significant improvement in Kuwait's evaluation in the Country Risk Rating issued by the Economist Intelligence Unit's Economic Intelligence Unit for 2024, by 14 points, from 37 to 51, is the best result achieved in Kuwait's evaluation this year. This improvement significantly contributed to maintaining Kuwait's position without a decline in the overall index score.

Cabinet slams Netanyahu's remarks on Saudi

KUWAIT CITY, Feb 11, (KUNA): Kuwait's Cabinet on Tuesday strongly condemned the remarks of the Israeli occupation's Prime Minister Benjamin Netanyahu's comments on Saudi Arabia, in which he suggested the establishment of a Palestinian state on Saudi territory, backing Riyadh's unyielding support for the Palestinians.

independent Palestinian state based on 1967 borderlines, with East Jerusalem as its capital; the Cabinet emphasized amid its weekly session presided over by Acting Prime Minister and Interior Minister Sheikh Fahad Yusuf Al-Sabah.

Fresh off his visits to a number of Arab nations, including Egypt, Jordan, Oman and the UAE, the Kuwaiti Acting Premier briefed the Cabinet on the results of talks he held with political leaders in these countries, all of which focused on bilateral relations and matters of mutual concern, he said.

Minister of Information and Culture and State Minister for Youth Affairs Abdurrahman Al-Mutairi then addressed the Cabinet over the progress on a plan for a government communications center, informing the state ministers of the details on the initiative.

In his address to the Cabinet, Minister of State for Housing and Municipal Affairs Abdullatif Al-Meshari updated his fellow ministers on a state program for housing welfare sustainability, outlining the steps and measures that have been taken to bring that plan to fruition.

The primary objective of the aforementioned plan is to ensure that citizens have access to adequate housing, in line with proper solutions and mechanisms that focus on sustainability, the cabinet said.

Kuwait to expand power stations, boost renewable energy projects

Bushehri honors innovation winners at awards ceremony

KUWAIT CITY, Feb 11: Minister of Electricity, Water and Renewable Energy Dr. Mahmoud Bushehri expects the ministry will pass next summer safely; while stressing the need to rationalize electricity consumption during peak hours and to take into account setting the air conditioning indicator to 23 or 24 degrees instead of 18 to 19 degrees.

Bushehri made the statement at the ceremony honoring the winners of the Second Innovation and Excellence Award, which was held Tuesday.

He disclosed "our combined electricity production capacity amounts to 19,377 megawatts, distributed over 110 gas and steam turbines, in addition to the combined cycle production units. The rate of production of electricity production units next summer is expected to reach about 18,000 megawatts; in addition to purchasing 1,000 megawatts from the Gulf interconnection network, which will help us pass the next summer safely."

He urged everyone to rationalize electricity consumption during summer, especially at peak hours – from 11:00 am to 5:00 pm, considering that the real problem the ministry faces during the summer months is the air conditioning units, which consume the largest amount of electrical energy.

the largest amount of electrical energy.

He added "we are not asking consumers to turn

off the air conditioning during summer, but we hope that they set the air conditioning indicator to 23 or 24 degrees instead of setting 18 or 19 degrees to reduce energy consumption, especially during peak hours."

Regarding the ministry's future projects, he revealed "we have future plans to expand the construction of electric power stations according to optimal demand. Some stations have reached the end of their useful life and must be removed; hence, the need to build new stations to replace them."

He affirmed coordination with China to implement a renewable energy project, indicating the ministry collaborating with the Public-Private Partnership Projects Authority to implement another project

to produce a total of 5,000 megawatts.

He added "we seek to have our electricity production from renewable energy reach 30 percent of the total electricity produced in Kuwait. We consider

this a strategic goal that we want to achieve over the next four years. We have several projects that have been approved and adopted. We will work on implementing them to produce 20,000 megawatts after three years. This will give us more comfort due to the implementation of energy projects."

In a speech he delivered at the Innovation and Excellence Award ceremony, Electricity and Water Conference and Achievements Exhibition held Tuesday at the Courtyard Marriott Hotel, Bushehri stressed the importance of the Innovation and Excellence Award and the Leadership and Creativity Conference in the field of electricity, water and renewable energy in the State of Kuwait.

He pointed out that launching this award under the slogan "Your Excellence Distinguishes You" reflects the ministry's vision of supporting national competencies and encouraging them to innovate and create.

He stressed the importance of discussing all the

topics mentioned above in specialized workshops held over two consecutive days by researchers and those interested in them from companies and businessmen, as this event is not limited to being a tribute to creative ideas but a platform to explore the talents and latent capabilities of the ministry's employees. He reviewed a number of main axes regarding the ministry's strategy related to energy and water security, including, for example, direct investment in renewable energy and the shift to clean fuel technologies in electricity generation and water production processes with the aim of reducing gas emissions and achieving carbon neutrality, in addition to localizing modern technology used in the fields of security, smart grid management and energy storage.

Private jets collide in Arizona, one dead

One person was killed and others were injured when a private jet owned by Mötley Crüe singer Vince Neil collided with another jet Monday afternoon at the Scottsdale Airport in Arizona, authorities said.

Neil's jet was landing at the airport when it veered off the runway and collided with another parked plane, Neil's representative Worrick Robinson, IV, said in a statement. There were two pilots and two passengers on Neil's plane, but he was not among them.

"Mr. Neil's thoughts and prayers go out to everyone involved, and he is grateful for the critical aid of all first responders assisting today,' Robinson said.

The arriving jet veered off the runway and collided with the Gulfstream 200 jet that was parked on private property, according to Kelli Kuester, aviation planning and out-reach coordinator at the Scottsdale Airport. It appeared that the left main landing gear of the arriving jet failed, resulting in the collision, she

Virginia gov declares storm emergency as snow, ice bear down on mid-Atlantic states

WASHINGTON, Feb 11, (AP): A wintry mess was bearing down on mid-Atlantic states Tuesday with forecasts of significant snow and ice accumulations prompting warnings of potential power outages.

The National Weather Service said travel would become treacherous Tuesday through early Wednesday in much of Virginia and West Virginia.

Virginia Republican Gov Glenn Youngkin on Monday declared a state of emergency ahead of the storm, allowing state agencies to assist local governments. Schools and government offices throughout Virginia were closed Tuesday.

The heaviest snow, up to 10 inches (25.4 centimeters), was forecast in portions of northern and central Virginia and eastern West Virginia. Ice accumulations could range from a glaze in Kentucky and West Virginia to a half-inch (1.3 centimeters) in the Roanoke Valley of southwest Virginia, the weather service said. Power outages and tree damage were likely in places with heavy ice buildups.

"Did you think winter was over? Think again!" the weather service's office in Blacksburg, Virginia, said in a post on the social media platform X.

Appalachian Power, which serves 1 million customers in West Virginia, Virginia and Tennessee, said it has requested 700 additional workers from neighboring utilities to assist with problems by Tuesday morning.

In northern Virginia, the National Park Service closed a portion of the George Washington Memorial Parkway, a narrow highway that winds its way through woods along the Potomac River. Winter storm warnings extended from Kentucky to southern New Jer-

US President Trump unleashes chaos by distraction upon int'l community

LONDON, Feb 11, (AP): The Danes are scrambling. Colombia has backed down. Mexico and Canada stand in a purgatory between tariff wars with the US and ... not. China has retaliated, launching a trade war between the economic superpowers. The Brits, long proud of their "special relationship" with the United States, are leaning into their tradition of quiet diplomacy.

It's as if President Donald Trump has flung a bag of marbles across the global stage, under the feet of foreign leaders who have often stepped together through eight decades of postwar global order.

Everyone, it seems, is responding to Trump - even Australia's leader, when asked last week for his thoughts only a few hours after Trump announced the US would "take over" the decimated Gaza Strip and turn it into the "Riviera of the Middle East."

"I'm not going to, as Australia's prime minister, give a daily commentary on statements by the US president," Anthony Albanese told reporters.

Acknowledged publicly or not, world leaders are watching Trump's woodchipper approach to some American government institutions and wondering about those of the post-Cold War order: What of the US roles in NATO, the United Nations, the World Bank and other pillars of the international order? On US-controlled NATO, Trump has long questioned the value of the pact and threatened not to defend members of the alliance that fail to meet defense-spending goals. On his first day back in the Oval Office, Trump began to pull the United States out of the World Health Organization for the second time, an act that would leave the UN agency without its biggest donor. WHO's leaders huddled over a response and asked diplomats to lean on Washington to reverse Trump's decision. A German envoy worried: "The roof is on fire."

"Trump's actions portend a permanent shift in the landscape - not just a switch that flips back in four years' time," wrote Heather Hurlburt, a political and international affairs expert with Chatham House, a think tank in London.

Outside of leadership circles, anyone who depends on US aid for food and medicine is coming to grips with the life-and-death implications of not having it after Trump's drive to dismantle USAID and its six-decade mission to stabilize countries by providing humanitarian aid. The Vatican charity voiced outrage Monday at what it called "unhuman" US plans to gut USAID,

"We're waiting for the decisions, but we are not very, I would say, optimistic," said Arjana Qosaj Mustafa of the Kosovo Women's Network, an umbrella group of 140 NGOs. "But nevertheless, we are resilient. So we'll try to do our best.

Emboldened by his reelection and with help from presidential friend Elon Musk, Trump has unleashed his signature chaos by distraction on the world.

Presidential orders and utterances - he's suggested annexing Canada and taking over the Panama Canal - occur at a speed that can atomize opposition. No one person or government can keep track of them all. And that, rather than clarity, is

the effect of what Trump's allies call "flooding the zone." Got a problem with it? Trump has an answer: "Fafo," short for "mess around and find out," except the first word isn't "mess." The president posted the acronym on social media, complete with a photo of him in a fedora and pinstripes.

Ask Colombia what happens when you say no to Trump. Its president briefly resisted planeloads of immigrants during Trump's first week - until the 47th US president threatened the country with as much as a 50% hike in tariffs. Colombia accepted the immigrants. Boom, example set.

The enforcement technique has long delighted Trump's supporters, who turned out for him during the 2024 election heavily influenced by their anxiety over the economy and their own finances, according to APVotecast. Trump says he's trying to save taxpayer money and spend it on issues that align with American interests.

Take Greenland and the Gaza Strip. The isolationist, "America first" president says the US will do so. He eventually ruled out using the military to move Gaza's 2 million people elsewhere, but his plan to develop the seaside enclave into a luxury resort apparently stands.

Never mind that friends and foes alike, from the volatile Mideast to China and the staid UK, have cast the idea as a nonstarter. Powerful Saudi Arabia issued an "absolute rejection" of it. Or that it could jeopardize the fragile hostages-for-prisoners ceasefire in the Israel-Hamas war, Egypt's peace deal with Israel. It could

Also, Palestinians streaming back to what once were their homes after 15 months of relentless air raids overwhelmingly say they're not leaving. But Trump's plan has found support in Israel, with leaders there taking care to say leaving would be 'voluntary" rather than forced expulsion, which would be a war crime.

"We are not a bad ally," Danish Prime Minister Mette Frederiksen found it necessary to tell reporters last week, like other leaders on their heels as they respond to the Trump administration.

In this case, according to the Copenhagen Post, Frederiksen was responding to comments by Vice President JD Vance on Fox News' "Sunday Morning Futures," that the EU and NATO member nation was "not being a good ally." He repeated that an American acquisition of Greenland was "possible."

That came after Frederiksen had flown to European capitals last month to urge other countries on the continent to respond with one voice against Trump's vow to make Greenland part of the United States. Denmark also has legislation to crack down on racism toward Greenlanders and has sent \$2 billion to the Arctic island for its security.

Federiksen also shared a photo on Facebook Jan. 26 of European leaders dining at her home, with the caption: "We have always stood together in the Nordic countries. And with the new and more unpredictable reality in which we are facing, good and close alliances and friendships have only become more important."

European rights chief presses Greece on '23 migrant shipwreck as questions remain

ATHENS, Greece, Feb 11, (AP): A top European human rights official urged Greek authorities Tuesday to address claims of negligence in a 2023 boat disaster that killed hundreds of migrants

off the coast of southern Greece. Michael O'Flaherty, the Council of Europe's human rights commissioner, cited recent findings by Greece's Ombudsman that maintained Greek coast guard officers failed to prevent one of the Mediterranean's deadliest migrant shipwrecks

Hundreds of migrants died when the Adriana, an overcrowded fishing trawler, sank in international waters off Pylos in southern Greece in June 2023. Survivors claim the Greek coast guard failed to respond to initial distress calls before the vessel capsized - an assertion strongly disputed by the government.

Greek Ombudsman Andreas Pottakis found "clear indications" that senior coast guard officials disregarded imminent danger to the migrants.

"The Commissioner, who liaises closely with the Ombudsman, notes his important findings and encourages the authorities to take resolute action to ensure appropriate criminal and disciplinary ac-

countability," O'Flaherty's office said in a report Tuesday. A copy of the report was provided to The Associated Press.

During his visit to Greece last week,

NATO allies await US defense secretary's visit

BRUSSELS, Feb 11, (AP): US Defense Secretary Pete Hegseth will on Wednesday become the first member of the new Trump administration to visit NATO, where the allies are keen to understand how America now plans to influence the course of the war in Ukraine

Hegseth's trip comes just ahead of the third anniversary of Russia's fullscale invasion. Most U.S. allies fear that Russian President Vladimir Putin will not stop at Ukraine's borders if he wins, and that Europe's biggest land war in decades poses an existential

threat to their security.

President Donald Trump has promised to quickly end the war. He's complained that it is costing the American taxpayer too much money. Some allies worry that a hasty deal might be clinched on terms that are not favorable to Ukraine.

Hegseth will first take part in a meeting of the Ukraine Defense Contact Group at NATO's Brussels headquarters. Former Defense Secretary Lloyd Austin set up the main international forum for drumming up arms and ammunition for Ukraine in 2022.

Over the last three years, around 50 countries have collectively provided Ukraine more than \$126 billion in weapons and military assistance. But this week for the first time, the meeting will be convened by another country; the United Kingdom. No decision has been made on who might chair the next meeting, if one is convened.

Hegseth was not expected to make any announcement on new weapons for Ukraine. He was not set to meet one on one with his Ukraine counterparts, but rather to be in a "listening mode" at the meeting, as well as at Thursday's NATO defense ministerial, one US official said.

BERLIN, Feb 11, (AP): German Chancellor Olaf Scholz accused his

by US President Donald Trump's foreign policy announcements and his announcement of tariffs on steel and aluminum, Scholz said that "the wind is blowing in our face at the moment. And the truth is that that won't change fundamentally in the coming years.

"Strong leadership, strong nerves, a clear course - that's what matters in such difficult times," he added. "Not fickleness and a loud mouth.'

He accused Merz of "constant about turns," for instance on aspects of policy toward Ukraine and refugees from that country.

Merz said Scholz and Vice Chancellor Robert Habeck of the environmentalist Greens, who also is running for the top job, reminded him of "two managers who have driven the company into the wall, then go to the owners and say they'd like to carry on the same way for four years."

Marcos thanks Cambodia for pardoning 13 Filipino women

Cambodia's Senate President Hun Sen says drone attack plot on mansion foiled

PHNOM PENH, Feb 11, (Agencies): Cambodia's Senate President Samdech Techo Hun Sen said on Tuesday that security personnel have foiled a plot to launch a drone attack on his mansion in southern Kandal province's Ta Khmau city.

Hun Sen, also president of the ruling Cambodian People's Party (CPP), said one of the plotters was arrested in southern Takeo province.

"I just want to confirm that in these few weeks, a drone attack has been plotted on my house," he said during the inauguration of a school building in Kandal province and his speech was live televised on the state-run TVK.

"This is an act of terrorism, and I'd like to urge foreigners to be cautious, refraining from supporting terrorist activities," he said. "Foreigners must not interfere in the domestic affairs of Cambodia.

Hun Sen said security forces thwarted the plot after he had received a secret voice message about the plan. Hun Sen, 72, has become the Sen-

ate president since April 2024 after

stepping down as the prime minister of Cambodia in August 2023, handing the reins of power to his eldest son Hun Manet.

MANILA, Philippines: Philippine President Ferdinand Marcos Jr thanked Cambodia's king on Tuesday for granting a royal pardon last year to 13 Filipino women who were convicted of illegally serving as surrogate mothers in the Southeast Asian kingdom.

Marcos expressed his gratitude in a meeting with Cambodian Prime Minister Hun Manet, who was visiting Manila for talks on expanding trade, agricultural, tourism, cultural and security relations.

The Philippines and Cambodia both belong to the 10-nation Association of Southeast Asian Nations, a regional bloc that promotes economic integration but is divided on other issues, including countries whose security alignments is with the United States or China.

Marcos has strengthened his coun-

try's treaty alliance with the United States to boost the Philippines' external defense as it confronts China's increasingly aggressive actions in the

disputed South China Sea. Cambodia has long been known as a key backer of China in the region.

The 13 Filipino women were convict-

ed in December in Cambodia on human trafficking-related charges for acting as surrogates for a criminal syndicate selling babies to foreigners for cash.

The women, who were in various stages of pregnancy, were each sentenced to four years in prison by a Cambodian court, but they avoided imprisonment and were instead flown back to the Philippines under a royal pardon granted by Cambodian King . Norodom Sihamoni.

"We will never forget this act of magnanimity from His Majesty, a testament to the strong relations between our two countries," Marcos said before a closeddoor meeting with the Cambodian premier and his delegation in Manila.

"We will continue to stand with you in the fight against transnational crimes and their adverse effects on our peoples and on our communities,' Marcos said.

The Filipino women were charged for violating a Cambodian law against human trafficking and sexual exploitation which was updated in 2016 to ban commercial surrogacy. Cambodia has become a popular destination for foreigners seeking women to give birth to their children.

It has a bad reputation for human trafficking, especially in connection with online scams in which illegally recruited foreigners work under conditions of virtual slavery and help perpetrate online criminal fraud that victimize citizens in other countries.

Several agreements were signed after Hun Manet's meeting with Marcos, mostly aimed at boosting trade, investment, tourism and agricultural engagements. One agreement aims to prevent looting and illicit trafficking of cultural artifacts.

In another development, the death toll in flash floods caused by unrelenting rain in Palawan province in the southwestern Philippines climbed to five, local authorities said Tuesday.

Jerry Alili, chief of the Palawan Provincial Disaster Risk Reduction and Management Office, said rescuers found two bodies who went missing after floodwaters swept away their van, carrying 12 people, on Sunday night.

S.Korean opp'n parties submit bill to probe corruption of Yoon, wife

SEOUL, Feb 11, (Agencies): South Korea's opposition parties on Tuesday submitted a bill to appoint a special counsel and investigate the alleged political corruption involving the impeached President Yoon Suk-yeol and his wife, Kim Keon-hee.

The main liberal opposition Democratic Party and five other

minor parties proposed the bill to let the independent prosecutor look into the allegations that Yoon and Kim were implicated in illegal pubopinion manipulation



during the 2022 presidential election in which Yoon was elected president.

A self-proclaimed political broker, Myung Tae-kyun, was suspected of providing fake and free opinion polls in return for various interests, such as his interference in the nomination of a lawmaker candidate of the ruling People Power Party.

Yoon and Kim were believed to have illegally intervened in the ruling party's candidate nominations for local elections and byelections in 2022 and parliamentary elections in 2024.

SEOUL, South Korea: South Korean police on Tuesday were questioning an elementaryschool teacher who allegedly stabbed a pupil to death in the city of Daejeon.

The incident on Monday during after-school care has shocked the nation and prompted the country's acting president to instruct reviews of school safety standards.

The female suspect is receiving hospital treatment for self-inflicted wounds following the death of the young girl in an audio-visual room on the second-floor of the school, said Yuk Jong-myeong, chief of Daejeon's western district police station.

Venezuela sends two planes to US to return migrants, signaling improvement in ties

McALLEN, Texas, Feb 11, (AP): Two Venezuelan planes returned home Monday with about 190 Venezuelans deported from the United States, signaling a possible thaw in relations between two longtime diplomatic adversaries and a victory for President Donald Trump in his efforts to get more

countries to take their people back. Deportation flights from the US to Venezuela have been halted for years except for a brief period in October 2023 during the Biden administration. Venezuelans began showing up at the US border with Mexico in large numbers in 2021 and are currently one of the largest nationalities entering illegally, making Venezuela's refusal to take them back a major challenge for the US.

The breakthrough came after Trump envoy Richard Grennell visited Caracas earlier this month.

"Flights of Illegal Aliens to Venezuela Resume," the White House said Monday in a post on the social platform X, saying they were overseen by

Venezuelan television and radio triumphantly covered the arrival of the Conviasa flights in Caracas from Fort Bliss, a US Army base in El Paso, Texas. "This is the world we want, a world

of peace, understanding, dialogue and cooperation," said Venezuelan President Nicolás Maduro.

The Venezuelan government confirmed the flights earlier in a statement that took issue with an "illintentioned" and "false" narrative around the presence of members of the Tren de Aragua gang in the US. It said most Venezuelan immigrants are

decent, hard-working people and that US officials sought to stigmatize the South American country.

Monday's flights came days after the first flights of immigrants to a US military base in Guantanamo Bay, Cuba, and after US Secretary of State Marco Rubio struck agreements with El Salvador and Guatemala for those countries to take people who were not their citizens.

A federal judge in New Mexico on Sunday preemptively blocked the transfer of three Venezuelan men to Guantanamo Bay. In their request for a temporary halt, lawyers for the men said their clients "fit the profile of those the administration has prioritized for detention in Guantanamo, i.e. Venezuelan men detained in the El Paso area with (false) charges of connections with the Tren de Aragua gang.'

5 killed in suicide bombing: A

suicide bomber blew himself up near a bank in northern Afghanistan on Tuesday, killing at least five people and wounding seven others, police

The attack happened near a branch of the Kabul Bank in Kunduz province, said Jumauddin Khaksar, a police spokesman. The dead included a guard at the bank.

Former Colombian president Uribe denies bribery, witness tampering charges in trial

BOGOTA, Colombia, Feb 11, (AP): Former Colombian president Álvaro Uribe on Monday denied charges of bribery and witness tampering as he made his opening statement in the first criminal trial of a former president in the country's history.

Speaking to a judge in the capital, Bogota, Uribe said that he would prove that the charges against him "are politically motivated.

The charges stem from allegations that Uribe attempted to influence witnesses in a case brought against him by leftist senator Iván Cepeda, who accused the conservative leader of having links to a paramilitary group founded by ranchers in the 1990s to fight rebel groups.

The case dates back to 2012, when Uribe filed a libel suit against Cepeda with the Supreme Court, the entity charged with investigating elected officials. But in a surprising turn of events, the court dismissed charges against Cepeda and launched an investigation against Uribe in 2018

Proceedings against the former president were transferred to another court after Uribe retired from the Colombian

The probe against Uribe was delayed multiple times by prosecutors who said there was not enough evidence against the former president to file charges, but investigations have proceeded more swiftly under the government of President Gustavo Petro, the leftist leader who was elected into office in 2022.

Uribe was formally charged last year, and his trial began last week.

The combative conservative governed Colombia from 2002 to 2010 with strong support from the United States.

During Uribe's presidency Colombia's military attained some of its biggest victories against rebel groups and pushed fighters from the Revolutionary Armed Forces of Colombia into remote pockets of the country, forcing the group's leadership to enter peace talks with the government that led to the disarmament of more than 13,000

fighters in 2016.

Uribe still has legions of followers in Colombia and is one of the most vocal opponents of Petro.

Dozens of supporters gathered outside the courthouse Monday, waving Colombian flags and carrying masks depicting the former president's face.

"It was my patriotic duty to come here and support this great Colombian," said Jesús Vivas, a 67-yearold Uribe supporter. "He saved this country when it was about to col-

Sudan paramilitary group preventing life-saving aid from famine-hit Darfur, says UN official

CAIRO, Feb 11, (AP): Paramilitary forces at war with the military in Sudan are preventing life-saving aid from reaching many people in the faminehit Darfur region, the United Nations' top humanitarian official in the country said Monday.

Clementine Nkweta-Salami, the UN resident and humanitarian coordinator in Sudan, said in a statement that the Rapid Support Forces have imposed "obstruction, undue interference and operational restrictions" on aid supplies to areas under their control, especially in Darfur. The RSF and their allied militias control most of that western region.

"The persistent restrictions and bureaucratic hurdles are preventing life-saving assistance from reaching those in desperate need," she said.

There was no immediate comment from the RSF.

The restrictions, implemented by the RSF's affiliate Sudanese Agency for Relief and Humanitarian Operations, include "demands for logistical support or mandatory engagement with selected vendors that risk corruption and aid diversion," Nkweta-Salami said.

On Sunday evening, a performer at the Super Bowl halftime show in the US unfurled a banner including the word "Sudan" in an apparent attempt to draw attention to the often-overlooked war from the event's massive audience.

The conflict in Sudan started in April 2023 when tensions between the leaders of the military and the RSF exploded into open fighting in the capital, Khartoum, and other cities across the African country. The conflict has killed more than

28,000 people, forced millions to flee their homes and left some families eating grass in an attempt to survive as famine sweeps parts of the country. Aid groups say they struggle to reach the most vulnerable as warring parties limit access, especially in Darfur.

Famine has been detected in at least five areas, including three camps for displaced people in Darfur, according to the Integrated Food Security Classification. In its December report, the IPC warned that famine was spreading, and five other areas in Darfur have been projected to experience famine in coming months.

The war has created the world's largest displacement crisis, driving over 14 million people - about 30% of the population - from their homes, according to the U.N. Of them, an estimated 3.2 million have crossed into neighboring countries including Chad, Egypt and South Sudan.

Market activity saw the exchange of 575.8 million shares through 24,678 cash transactions, with a total trading value of KD 118.5 million (approximately USD 364.9 million).

The Main Market Index registered a modest increase of 7.80 points, or 0.11 percent, settling at 7,417.62 points. Trading volume in this segment reached 415.3 million shares, with 16,030 transactions totaling KD 59.15 million (around USD 182.18 million).

Meanwhile, the Premier Market Index climbed 17.85 points, or 0.21 percent, closing at 8,487.60 points. A total of 160.5 million shares changed hands through 8,648 transactions, with a value of KD 59.4 million (approximately USD 182.9 million).

In parallel, the Major 50 Index recorded a more significant gain of 47.35 points, or 0.64 percent, reaching 7,490.65 points. This was backed by the trading of 323.3 million shares through 10,832 cash transactions, amounting to KD 48.7 million (about USD 149.9 mil-

Annual oil financing drops 2.1%

Kuwaiti banks boost oil and gas financing by 257.3% in Dec 2024

KUWAIT CITY, Feb 11: Kuwait's local banks significantly increased their financing for the oil and gas sector in December 2024, reaching KD 364.5 million, a sharp rise from KD 102 million in November. This represents a 257.3% monthly increase and a 229.2 million dinar rise from KD 135.3 million in December 2023

Fluctuations in Oil Sector Financing Throughout 2024

The total financing provided by local banks for the oil and gas sector in 2024 reached KD 2.538 billion. However, funding levels fluctuated throughout the year. In January, financing started at KD 50.6 million, then surged to KD 278.5 million in February and KD 286.3 million in March. The following months saw a decline, with KD 167.4 million in April and a sharp drop to KD 19.4 million in May.

A strong rebound followed in June, with financing climbing to KD 245.8

million, before plunging again to KD 12.3 million in July. In August, financing slightly improved to KD 42.7 million, and in September, it jumped to KD 285.7 million. October marked the highest point of the year, reaching KD 638.4 million, but this was followed by a sharp decline to KD 102 million in November, before recovering to KD 364.5 million in December.

Annual and Monthly Banking

The accumulated balance of oil and gas financing provided by local banks rose by KD 70 million in December, reaching KD 2.459 billion, compared to KD 2.389 billion in November. However, on an annual basis, financing declined by KD 54 million (2.1%), down from KD 2.513 billion in December 2023.

Historical Context: Oil Projects and Banking Support

Oil project financing has experienced volatility in recent years, particularly during the COVID-19 crisis, when falling oil demand and prices forced the

government to cancel key energy projects. The lowest recorded financing level was in July 2021, at just KD 100,000. However, 2022 marked the return of oil project offerings, leading to a gradual recovery in sector financing.

Global Oil Market Trends

Meanwhile, the U.S. Energy Information Administration (EIA) reported an increase in crude and gasoline inventories, while distillate stocks declined for the week ending November 15. Oil prices saw mixed movements. Brent crude settled at \$74.66 per barrel, rising 0.5%, but posting a

1.35% weekly loss. Similarly, U.S. West Texas Intermediate (WTI) rose 0.55% to \$71.00 per barrel, yet recorded a 2.1% weekly decline.

Fresh U.S. sanctions on Iranian crude exports pushed prices higher, but concerns over a renewed U.S.-China trade war kept investors cautious. Additionally, U.S. oil inventories rose for the second consecutive week, with an increase of 8.7 million barrels, surpassing market expectations.

MENA region records 54 IPOs raising \$12.6 billion during 2024

DUBAI, Feb 11: According to the EY MENA IPO Eye Q4 2024 report, MENA markets saw a total of 54 initial public offerings (IPOs) in 2024, raising \$12.6 bln in total. When compared to 2023, last year recorded a 12.5% increase in the number of IPOs and a 17.6% rise

The year-on-year increase in proceeds for 2024 was impacted by a number of largevalue IPOs such as Talabat Holding plc, OQ Exploration & Production and Lulu Retail Holdings PLC that were listed during the last quarter of the year.

Brad Watson, EY MENA Strategy and **Transactions Leader, says:**

"The year 2024 ended on a strong note with 54 IPOs in total, the highest in MENA over the past seven years. The region has been one of the busiest when compared to the global market. The momentum is expected to continue into 2025, with companies from various sectors announcing their intention to come to market.In addition, regional exchanges are actively working on initiatives to promote family-owned businesses and small to medium enterprises, aiming to strengthen the capital markets infrastructure and boost future liquidity. The market is also anticipating the Arena platform from the DFM, which is expected to

launch in 2025." Boost in listings across MENA during Q4

During Q4 2024, 25 IPOs raised US\$7.9b,

which represents a 32% increase in number and a 59.4% surge in proceeds when compared to Q4 2023.

Talabat Holding plc, which listed on the Dubai Financial Market (DFM), raised the highest proceeds, contributing 25.8% of the overall proceeds for Q4 2024. It was followed by OQ Exploration & Production, which listed on the Muscat Stock Exchange (MSX) and raised \$2.0 bln - the largest IPO in Oman to date - and accounted for 25.3% of the total quarterly proceeds.

Meanwhile, the Bahrain Bourse witnessed the AlAbraaj Restaurants Group IPO that raised \$23.9 mln.

Outside of the GCC region, there were two IPOs in Q4 2024 – Compagnie Marocaine de goutte a goutte et de pompage (CMGP) in Morocco and The United Bank in Egypt

Saudi Arabia continues to dominate list-

The Kingdom of Saudi Arabia (KSA) dominated the region's IPO activity with 17 out of the 25 listings in Q4 2024, with total proceeds of \$1.2 bln. Five IPOs took place on the Tadawul Main Market with total proceeds of \$1.1 bln. Arabian Mills for Food Products Company and United International Holding Company marked the highest proceeds at \$0.3 bln each. The remaining 12 IPOs, raising \$ 119 mln in total, were listed on the Nomu-Parallel Market.

In 2024, various sectors contributed to IPO funds raised in KSA, with the largest shares

In the United Arab Emirates (UAE), the Abu Dhabi Securities Exchange (ADX) welcomed two IPOs in Q4 2024 with \$2.0 bln in combined proceeds. For the UAE, ESG goals remain a priority. The country has introduced a law, effective May 2025, that requires companies to report carbon emissions. Additionally, businesses must adopt decarbonization strategies that include renewable energy and carbon offsetting. Applicable to all sectors, including free zones, the law sets penalties for noncompliance, encourages research and development and promotes carbon trading through a dedicated registry. These measures align with the UAE's 2050 net-zero ambitions and are likely to influence IPO market dynamics as companies prioritize sustainability to attract


Women Empowerment

Fed holds rates steady despite inflation and strong job market

Morgan Stanley predicts just one rate cut in 2025

WASHINGTON, Feb 11, (AP): The Federal Reserve is prepared to keep its key interest rate unchanged for now as inflation remains elevated and the job market is solid, Chair Jerome Powell said Tuesday on the first day of a two-day appearance before Congress.

After cutting its key rate a full percentage point in the final three months of last year, with "the economy remaining strong, we do not need to be in a hurry to adjust our policy stance," Powell said in written remarks to the Senate Banking Committee.

Powell's appearance comes as inflation is still above the Fed's 2% target and the Trump administration is upending many long-time U.S. policies by imposing tariffs on steel and aluminum and seeking to sharply cut government spending. President Donald Trump has also frequently attacked the Fed in the past, raising concerns about the Fed's historic independence from politics.

Powell did not mention those policy changes in his statement, but said that the Fed's interest rate is "well positioned to deal with the risks and uncertainties that we face.

The odds of further interest rate cuts this year by the Federal Reserve dwindled last week as unemployment fell and more officials say they want to see how new policies from the White House affect the economy.

While Fed officials penciled in two rate cuts this year at their December

meeting, economists and Wall Street investors are increasingly skeptical, with some predicting no reductions at all this year. On Friday, economists at Morgan Stanley said they now expect just one rate cut in 2025, and investors also expect just one - in July - according to pricing in futures markets.

Fewer cuts could translate into a longer period of elevated mortgage rates and high costs to borrow money for everything from autos to credit cards. Still, mortgage rates are closely tied to the yield on the 10-year Treasury note, which can move independently of the Fed's actions.

The shifting expectations come as Chair Jerome Powell heads to Capitol Hill for two days of testimony this week, beginning Tuesday, before House and Senate committees that oversee the central bank and the financial industry. Fed chairs are required by law to appear before Congress twice a year.

Members of Congress may urge that he cut rates more quickly. He will also likely be grilled about issues that are taking a higher profile under the Trump administration, such as crypto regulation, banking regulation, and allegations of "de-banking."

De-banking is the practice of banks shutting down customer accounts because they believe they pose financial, legal or reputational risks to the banks. Some crypto executives have charged that Biden administration regulators pressured financial firms to target their industry for de-banking.

Regarding interest rates, Fed officials have suggested recently that after cutting their key rate three times at the end of last year - to about 4.3%, down from two-decade high of 5.3% - they are likely to be on hold for an extended period, though none will specify how long that might be.

On Friday, Fed governor Adriana Kugler said that the labor market was "stable" and that "gives us a little bit of time to make some decisions." She noted that inflation has "moved sideways" since the fall and is above their 2% target.

She added that potential policy changes from the Trump administration have added uncertainty to their outlook for the economy. Economists have said that widespread tariffs, and the deportation of immigrants that Trump has also promised, could push up inflation. Others argue that Trump's deregulatory policies could, by increasing supply, reduce prices.

The cautious and the prudent step is to hold the (Fed's key) rate where it is for some time," Kugler said. "Given that the economy is solid, given the fact that we haven't achieved our 2% target, and given the fact that we may have uncertainties and other factors that may be pushing up inflation.

Separately, Austan Goolsbee, president of the Fed's Chicago branch, said in an exclusive interview with The Associated Press Friday that he still expects the central bank's rate will be lower in the next 12 to 18 months than it is now.

But he also said it makes sense for the Fed to take a slower approach as it nears a point where it may stop reducing rates.

He also noted that the prospect of tariffs has muddied the waters a bit for the Fed in the coming months. Tariffs may cause a one-time increase in prices but don't necessarily cause ongoing in-

Trump imposes 25 percent tariffs on all steel imports

Canada slams US steel tariffs

WASHINGTON, Feb 11, (AP): President Donald Trump on Monday removed the exceptions and exemptions from his 2018 tariffs on steel, meaning that all steel imports will be taxed at a minimum of 25%. Trump also hiked his 2018 aluminum tariffs to 25% from 10%.

"We were being pummeled by both friend and foe alike," Trump said as he signed two proclamations changing his orders during his first term that go into effect on March 4. "It's time for our great industries to come back to America.'

The moves are part of an aggressive push by the president to reset global trade, with Trump saying that tax hikes on the people and companies buying foreign-made products will ultimately strengthen domestic manufacturing. But the tariffs would hit allies as the four biggest sources of steel imports are Canada, Brazil, Mexico and South Korea, according to the American Iron and Steel Insti-

Trump also intends this week to reset U.S. taxes on all imports to match the same levels charged by other countries. All of that comes on top of the 10% tariffs he already put on China, China's retaliatory tariffs that started Monday and the U.S. tariffs planned for Canada and Mexico that have been suspended until March 1.

Monday's tariffs almost immediately drew criticism from Canada, the largest source of steel imports. Candace Laing, president and CEO of the Canadian Chamber of Commerce, said that Trump was a destabilizing force in the global economy.

"Today's news makes it clear that perpetual uncertainty is here to stay," said Laing

The tariffs carry inflation risks at a moment when voters are already weary of high prices and fearful that price increases will eclipse any income gains. Trump maintains that the tariffs will level the playing field in international trade and make U.S. factories more competitive, such that any pain felt by consumers and businesses would eventually be worth-

"'Fairness' is in the eye of the beholder, but the more fundamental question is whether the U.S. actually benefits from such new tariffs," Benn Steil, director of international economics at the Council on Foreign Relations, a New York-based nonpartisan think tank, said in an email. "The costs to the U.S. will include higher prices to U.S. consumers, retaliatory tariffs abroad, and the loss of U.S. jobs and competitiveness in firms hit by higher input costs."

Steil noted that other countries are already adopting Trump's approach from his first term as the president imposes tariffs on the premise that the imports create national security risks. That's because national security-related tariffs are legally unchallengeable at the World Trade Organization, meaning that so far Trump's approach has encouraged other countries to increase trade barriers.

"Not surprisingly, everything from 'door frames' to 'alcoholic beverages' have of late been subject to new import barriers in the developing world on the grounds of national security," Steil said.

Of the roughly 29 million net tons of steel imported into the United States last year, a little under 2% came from China. But the White House maintains that exemptions to the tariffs provided over the previous four years by the Biden administration enabled steel and aluminum from China and Russia to go through other nations to reach the United

While the tariffs could help the finances of steel mills and aluminum smelters, they could also increase costs for the manufacturers that use the metals as raw materials to make

autos, appliances and other products. Glenn Stevens Jr., executive director of MichAuto, said that the auto industry would likely need to raise prices in response to the tariffs. In turn, higher prices would decrease sales and hurt company's bottom lines, leading to fewer factory jobs.

"If you look at sudden tariffs to a system, there isn't a lot of good that comes out of that,"said Stevens, his remarks challenging Trump's own statements that his policies would stimulate massive gains in auto in-

dustry jobs.

The White House has yet to fully counter economic analyses showing that tariffs would hurt growth and intensify inflation, only saying that such analyses are incomplete without including the full extent of Trump's planned income tax cuts and regulatory curbs. But Trump has yet to propose a budget plan that would flesh out his policies so that economists can judge them.

Consumers already appear to be anticipating that inflation will become a bigger problem. On Friday, the preliminary February results from the University of Michigan Survey of Consumers found that year-ahead inflation expectations jumped to 4.3% from 3.3% a month prior.

The government inflation report scheduled to be released on Wednesday is expected by economists to show consumer prices rising at 2.8%, which would suggest that the public sees tariffs as a major risk to their financial wellbeing.

The stock prices of steel compa nies climbed sharply on Monday as investors assumed the tariffs would increase their profits. Cleveland-Cliffs, which wants to buy Pittsburgh's U.S. Steel, surged upward by nearly 18%. U.S. Steel rose almost 5%. Nucor increased almost 6%, and Steel Dynamics rose about 5%.

But some companies that could pay more for steel and aluminum saw their share prices decrease. For example, shares in automaker General Motors sold off, which could ultimately signal trouble for a manufacturing sector that Trump has promised to revive.

"We have far more steel and aluminum-consuming businesses, think construction, machinery and equipment manufacturing, auto manufacturing, than we do steel and aluminum producers, so the advantage created for the producers comes at a much greater cost to downstream users," said Erica York, vice president of federal tax policy at the right-leaning Tax Foundation.

Trump reiterated as he signed the proclamations that more tariffs would be coming on computer chips, autos and pharmaceutical drugs. But the president said that the import taxes would eventually enable more steel mills and aluminum plants to open in the U.S. to avoid the tariffs.

'You're ultimately going to have a price reduction because they're going to make their steel here," said Trump, adding that there would also be more jobs.

Howard Lutnick, Trump's pick to be commerce secretary, said that the strengthened tariffs would bring 120,000 jobs back to the United States. It wasn't clear how he reached that number. The primary metals industry added roughly 14,000 jobs during the first 12 months the steel and aluminum tariffs were originally imposed, though gains were quickly erased by the coronavirus pandemic in 2020.

Panos Kouvelis, a professor specializing in supply chains at Washington University in St. Louis, co-wrote a research paper last year finding that the 2018 tariffs did not deliver a stronger manufacturing sector as Trump had promised.

'Simple economics will tell you if prices go up then demand will go down," Kouvelis said, stressing that what was needed instead were incentives that were specific to advanced technologies, national security needs and pharmaceutical needs.

"It requires smart, targeted industrial policies," he said, "instead of general tariffs on everything."

'Anora' wins at Producers and Directors Guild Awards

'Dog Man' bests 'Heart Eyes,' 'Love Hurts' at box office

NEW YORK, Feb 11, (AP): On a quiet winter weeken d at the box office, DreamWorks Animation's "Dog Man" chased its own tail, repeating as the top movie in theaters.

The animated Universal Pictures release, adapted from Dav Pilkey's popular graphic novel series, collected \$13.7 million in ticket sales, according to studio estimates Sunday. Both new releases - the Ke Huy Quan action movie "Love Hurts" and the Valentine's Day-themed slasher "Heart Eyes" - were left nipping at the

heels of "Dog Man." Hollywood often largely punts Super Bowl weekend to the small screen. Last year, Apple's much-derided "Argylle" debuted on the same weekend. Instead, the movie industry spends more energy pitching its blockbusters in trailers for the huge football audience

It wasn't a banner weekend for "Dog Man." It fell steeply, dropping 62% in it second weekend. But with a production budget of \$40 million, "Dog Man" has already tallied \$54.1 million domestically in two weeks.

Coming in second was Spyglass Media Group's "Heart Eyes," released by Sony. The horror-rom-com mashup earned \$8.5 million from 3,102 locations. Reviews have been good for the film, directed by Josh Ruben and starring Oliva Holt and Mason Gooding, though audiences were less impressed. Moviegoers gave it a "B-" CinemaScore. Spyglass made "Heart Eyes" for \$18 million.

"Love Hurts," the action comedy from 87North Productions ("John Wick," "The Fall Guy"), debuted with a paltry \$5.8 million in 3,055 theaters. In his first big movie role since his Oscar-winning comeback in "Everything All at Once," Ke Huy Quan stars as a mild-mannered realtor with a hitman past. Ariana DeBose co-stars. It, too, was modestly budgeted at \$18 million. Audiences, however, mostly rejected the movie, giving "Love Hurts" a "C+" CinemaS-

Next weekend should bring Hollywood its biggest box-office weekend of the year with the release of Marvel's "Captain America: Brave New World" and Sony's "Paddington in Peru-

Meanwhile, did a wide-open Oscar race just get a frontrunner? Sean Baker's Brooklyn comedy "Anora" took top honors at both the Producers Guild Awards and the Directors Guild Awards on Saturday night, catapulting it to Oscar favorite status with wins from a pair of closely watched Academy Awards precursors.

Hollywood's award season has been uncharacteristically up for grabs with half a dozen films viewed as legitimate best-picture contenders. Some had pegged "Anora" as the frontrunner going into the season after the film, starring Mikey Madison as a Brooklyn exotic dancer who marries the son of a Russian oligarch, won the Palme d'Or at the Cannes Film Festival.

But after a number of films took turns in the spotlight, including Golden Globe winners "The Brutalist" and "Emilia Pérez," "Anora" reemerged in a big way over the weekend. Baker's film also won best picture at the Critics Choice Awards on Friday.

Both guild ceremonies were held in Beverly Hills, California. The PGA's top prize, the Darryl F. Zanuck Award, has matched the Oscar winner for best picture in 16 of the last 21 years. Since 2009, when the guild and the Academy of Motion Pictures Arts and Sciences both adopted a preferential ballot to pick a winner from 10 nominees, they've corresponded all but three times.

The DGA is similarly predictive. In the past 74 years, 66 winners have gone on to triumph at the Oscars. That makes Baker the favorite for best director in a field entirely composed of first-time nominees. The guild also named RaMell Ross' "Nickel Boys" best first film. Ross' movie, nominated for best picture by the Oscars, is his narrative film debut.

Oscar voting begins Tuesday. Jacques Audiard's "Emilia Pérez" is the lead nominee with 13 nominations, but the Netflix film has seen its chances crater following multiple waves of backlash and controversy. Another Oscar category also found clarity over the weekend. On Saturday at the Annie Awards, DreamWorks Animation's "The Wild Robot" cleaned up with nine awards including best film. "The Wild Robot" will be the heavy favorite to win best animated film at the March 2 Academy Awards.



The attorneys could not give comment outside court Monday because a judge has forbidden them from speaking to the media. Rocky faces up to 24 years in prison if convicted, after turning down a pre-trial plea deal that could have led to just 180 days in jail.

If Rocky testifies, he'll probably have to face a long and combative cross-examination from Deputy District Attorney John Lewin. In his most famous case. Lewin kept real estate heir Robert Durst on the stand for nine days of relentless questioning before he was convicted of murder.

Rocky is a Grammy-nominated hip-hop star, fashion mogul and the longtime partner of singing superstar Rihanna, with whom he has two toddler sons. She may appear Tuesday to watch his testimony.

She has shown up sporadically -most recently on Friday, when they left the courthouse together for the first time, walking arm-in-arm.

Rocky, whose legal name is Rakim Mayers, would likely testify that a gun he fired twice - in a scuffle with a former friend on a Hollywood street corner in 2021 - was a starter pistol that only fired blanks, and that he carried it for security.

On Monday, his tour manager became the second witness from Rocky's inner circle to testify that he carried the phony gun. (AP)

NEW YORK: A judge dismissed a lawsuit Monday by an acclaimed opera singer who sued the University of Michigan over his firing for what the school deemed sexual misconduct.

David Daniels waited too long to sue the university, US District Judge Sean Cox said

Daniels, 58, was hired as a voice professor in 2015 and granted tenure three years later in the School of Music, Theatre & Dance. He was fired in 2020 after an investigation found that he had solicited at least three students and shared a sexually explicit video with one, officials said.

Separately, Daniels and and his husband, Scott Walters, pleaded guilty in 2023 to sexual assault and were placed on probation in Texas. A Rice University graduate student said the couple drugged and sexually assaulted him years earlier after they met at a Houston Grand Opera reception. (AP)

NEW YORK: Testimony is set to continue Tuesday in the trial of the man charged with stabbing famed author Salman Rushdie in a frenzied knife attack on a western New York stage.

Jurors in the trial of Hadi Matar, 27, on Monday heard from staffers at the arts institution where Rushdie was set to give a speech in August 2022, when authorities say the Fairview, New Jersey man attacked the author on stage and stabbed him more than a dozen times.

Rushdie himself is expected to testify during the trial. Matar has been in custody since he was subdued by spectators after the attack. He has pleaded not guilty to attempted murder and assault. The 77-year-old author was blinded in one eye in the attack and spent months recovering, a process he detailed in a memoir released last year. A speaker who was to appear with Rushdie also was wounded. (AP)



Experts say bird flu remains low risk for public health

New strain of bird flu detected in US dairy worker: CDC

NEW YORK, Feb 11, (AP): A dairy worker in Nevada was infected with a new type of bird flu that's different from the version that has been spreading in US herds since last year, federal health officials said Monday.

The illness was considered mild. The person's main symptom was eye redness and irritation, similar to most bird flu cases associated with dairy cows. The person wasn't hospitalized and has recovered, according to the Centers for Disease Control and Prevention.

The newer strain had been seen before in more than a dozen people exposed to poultry, but this is the first time an infection was traced to a cow. The Nevada dairy worker was exposed at a farm in Churchill County, in the west central

CDC officials said there is no evidence the virus has spread from this person to any other people. The agency continues to say the virus poses a low risk to the general public.

The bird flu currently spreading through animals, and some people, is known to scientists as Type A H5N1 influenza. But there are different strains.

A version known as B3.13 was confirmed in March after spreading to cattle in late 2023, scientists said. It has infected 962 cattle herds in 16 states, the vast majority of them in California.

The newer version, known as D1.1, was confirmed in Nevada cattle on Jan. 31. It was found in milk collected as part

That discovery meant distinct forms of the virus spread from wild birds into cattle at least twice. Experts said it raises questions about wider spread and the difficulty of controlling infections in animals and the people who work with

At least 68 people in the U.S. have been reported infected with bird flu in the last year, according to CDC data. All but a small handful worked closely with cows or poultry.

Most caught the B3.13 version. The CDC previously said the D1.1 version had been seen only in cases in Louisiana and Washington state. But on Monday, the agency revealed that available data indicates D1.1 last year likely infected a

Washington and Wisconsin - all related to poultry.

The D1.1 version of the virus was linked to the first U.S. death tied to bird flu and to a severe illness in Canada. A person in Louisiana died in January after developing severe respiratory symptoms following contact with wild and backyard birds. In British Columbia, a teen girl was hospitalized

for months with a virus traced to poultry.

While the risk to the general public is low, the CDC says bird flu poses a greater threat to people with close or prolonged contact with infected cows, birds or other animals. Those people are encouraged to wear protective equipment and take other precautions.

UN says take your time to do it right

Most countries miss deadline for plans to combat climate change

NEW YORK, Feb 11, (AP): Nearly 200 nations faced a Monday deadline to file what the United Nations' climate chief calls "among the most important policy documents governments will produce this century" - their plans on how they will cut emissions of heattrapping gases.

Most won't make the deadline. The UN says that's OK as long as they are working on them.

So far only a dozen of the 195 nations that signed the 2015 Paris climate agreement have filed their national plans for cutting emissions by 2035. Those nations account for only 16.2% of the world's carbon dioxide emissions - the chief human-caused heat-trapping gas - and almost all of that is from the United States, where President Donald Trump has already discarded the plan submitted by President Joe Biden's administration.

Aside from the US, the only major emitters to submit 2035 targets are Brazil, the United Kingdom and the United Arab Emirates. The Marshall Islands, Singapore, Ecuador, Saint Lucia, Andorra, New Zealand, Switzerland and Uruguay have filed their plans, but they all produce less than 0.2% of the world's carbon dioxide.

UN Climate Secretary Simon Stiell said that more than 170 countries have told his office they are working on their national plans, so he's not worried. He emphasized quality over timeliness.

"Taking a bit more time to ensure these plans are first-rate makes sense,' Stiell said last week in a policy speech in Brazil. "These will be the most comprehensive climate plans ever developed."

Champa Patel, policy director of the nonprofit Climate Group, wasn't as forgiving.
"It's worrying that countries are

failing to meet the urgency of the moment," Patel said. "The world cannot afford inaction.

These plans - officially called Nationally Determined Contributions or NDCs - are the main mechanism of the landmark international agreement. Every five years, nations are supposed to come up with new and stronger fiveyear plans that outline their voluntary plans to limit or reduce emissions of greenhouse gases from the burning of coal, oil and natural gas.

The latest versions are supposed to be compatible with the Paris agreement's goal of limiting long-term warming to 1.5 degrees Celsius (2.7 degrees Fahrenheit) above pre-industrial times. The world is now at 1.3 degrees Celsius (2.3 degrees Fahrenheit) since the late 1800s and on pace to warm another 1.8 degrees Celsius (3.2 degrees Fahrenheit), according to the U.N.

Scientists say the warming atmosphere is driving ever more extreme weather events, including flooding, droughts, hurricanes, heat waves and wildfires that are killing people and causing billions of dollars in damage every year.

The new targets are also supposed to be for all greenhouse gases: carbon dioxide, methane, nitrous oxide, hydrofluorocarbons, perfluorocarbons and sulfur hexafluoride. They should cover the entire economy not just the energy sector, according to a 2023 agreement.

Space telescope spots rare 'Einstein ring' near Earth

CAPE CANAVERAL, Fla., Feb 11, (AP): Europe's Euclid space telescope has detected a rare halo of bright light around a nearby galaxy, astronomers reported Monday.

The halo, known as an Einstein ring, encircles a galaxy 590 million light-years away, considered close by cosmic standards. A light-year is 5.8 trillion miles. Astronomers have known about this

galaxy for more than a century and so were surprised when Euclid revealed the bright glowing ring, reported in the journal Astronomy and Astrophysics.

An Einstein ring is light from a much more distant galaxy that bends in such a way as to perfectly encircle a closer object, in this case a well-known galaxy in the constellation Draco. The faraway galaxy creating the ring is more than 4 billion light-years away.

Gravity distorted the light from this more distant galaxy, thus the name honoring Albert Einstein. The process is known as gravitational lensing.

"All strong lenses are special, because they're so rare, and they're incredibly useful scientifically. This one is particularly special, because it's so close to Earth and the alignment makes it very beautiful," lead author Conor O'Riordan of Germany's Max Planck Institute for Astrophysics said in a statement.

Euclid rocketed from Florida in 2023. NASA is taking part in its mission to detect dark energy and dark matter in the universe.

Detect rare diseases

GeneDx CEO wants genetic testing for every newborn

NEW YORK, Feb 11, (AP): GeneDx has a big market in mind for its genetic testing: every newborn baby.

The 24-year-old-company wants to make the testing common at birth. The goal: Identify potential diseases or conditions so doctors can begin treating them before symptoms appear in some cases. GeneDx specializes in whole ge-

nome sequencing. That involves looking at about 20,000 genes that make up a genome, the instructions to build and sustain a human.

More common multi-gene panels, in contrast, may look at a couple hundred genes to identify a specific issue like cancer risk.

GeneDx CEO Katherine Stueland likes the potential of newborn testing, but she says her Stamford, Connecticut, company is still studying the idea.

A potential challenge: Insurers would have to embrace the idea of covering the roughly \$2,000 tests rou-

Stueland spoke recently with The Associated Press. The conversation has been edited for clarity and length. Question: Your testing focuses on diagnosing rare diseases. Will patients eventually see it used in everyday care? Answer: What is really misunder-

stood about rare diseases is that they're

actually not that rare. One in 10 Amer-

icans has a rare disease. Half of them are children. Epilepsy is actually a constellation of 768 different genes that are associat-

ed with (it). It's really important when you're seeing a child with a seizure to look at the entirety of the genome to pinpoint whether one of those many genes is causing the disease.

O: What are some other examples of diseases your testing would detect? A: Hearing loss, cerebral palsy, cystic fibrosis. Ultimately, we want to be sequencing every baby at birth and figuring out whether there is a genetic condition that can be diagnosed right away. For some of these conditions, there may be something clinically actionable that can be done that would

prevent a symptom from ever arising.

Doncic makes winning debut for Lakers

Cavs sink slow-starting Timberwolves

LOS ANGELES, Feb 11, (AP): Luka Doncic had 14 points, five rebounds and four assists in his Lakers debut as Los Angeles beat the Utah Jazz 132-113 on Monday night.

LeBron James had 24 points, seven rebounds and eight assists, Austin Reaves scored 22 and the Lakers got their sixth straight win.

Doncic, acquired in a shocking trade from the Dallas Mavericks on Feb. 2, played for the first time since sustaining a calf strain on Christmas. He was limited to just under 24 minutes as a precaution and was able to sit out the fourth quarter with his new team in complete control, but still had several standout moments to help the surging Lakers get their 12 victory in 14 games.

Buoyed by its new superstar, Los Angeles had seven players reach double figures, shot a blistering 54.3% from the floor and led by as many as 34.

Lauri Markkanen and John Collins each had 17 points for the Jazz, who have dropped nine in a row on the road.

Jazz head coach Will Hardy said before the game that he hoped his young team would embrace the unusual circumstances, but Utah struggled in the spotlight.

Doncic's debut was a star-studded affair, even by Los Angeles standards. Adele, Will Ferrell, Flea and Chad Smith of the Red Hot Chili Peppers, and Mavericks great Dirk Nowitzki, were among those in attendance

Doncic made a series of impressive passes in his first game wearing the purple and gold, including setting up Jaxson Hayes for an alleyoop dunk 50 seconds into the game and finding a streaking James with a full-court heave for a layup in the final minute of the opening half.

Doncic looked heavy-legged after the long layoff, shooting 5 of 14 from the field and making only one of his seven attempts from 3-point range (14.3%).

In Cleveland, Evan Mobley scored 28 points, fellow All-Star Donovan Mitchell added 23 and the Cleveland Cavaliers broke out to a big early lead and had little trouble against Minnesota, beating the Timber-

\$1 million prize added in quest to get singles stars to play

US Open revamps mixed doubles format Feyenoord fires coach Priske ahead

NEW YORK, Feb 11, (AP): The U.S. Open is moving its mixed doubles championship to the week before the tournament begins, hoping a revamped format and \$1 million prize will persuade top singles players to chase a Grand Slam doubles title.

This year's event will feature 16 teams competing over two days in shorter matches. Tournament organizers believe that can attract the sport's biggest stars, many of whom have long passed on doubles to keep themselves fresh for singles.

"What I would say is the reason behind this is to appeal to more fans and grow the fan base around the world," said Lew Sherr, executive director and CEO of the US Tennis Association. "But the way to do that is to have the biggest names in the sport participating in doubles, and to showcase them teaming up and playing in a different format, we think is exciting. In fact, we know it's exciting."

The plan announced Tuesday calls for mixed doubles to be contested on Aug. 19 and 20, during the week when the qualifying rounds for men's and women's singles are being held. Main draw play in singles begins on Aug. 24.

The early round matches will be best-of-three sets played to just four games, with a deciding point played at deuce. Tiebreakers would be at 4-all - rather than 6-6 in a regular match - and a 10-point match tiebreaker would be played if the teams split sets, rather than a third set.

Only the final will closely resemble a Grand Slam match, a best-ofthree sets played to six games with no-ad scoring, tiebreakers at 6-all and a 10-point match tiebreaker.

Sherr said the USTA had discussed a format change in previous years but the idea truly picked up steam after last year, when a "Mixed Madness" event during the qualifying week drew singles superstars such as Coco Gauff, Naomi Osaka, Nick Kyrgios and Ben Shelton, and was won by Stefanos Tsitsipas and Paula Badosa.

"We've known and we've had conversations over the years, like, why don't they participate and we understand the scheduling challenges," Sherr said. "I think last year's task with that mixed madness event really informed our thinking, that if could unlock that week and free up the top singles players to participate, because it didn't compromise their fitness or their health going into the singles, there was a huge opportunity to attract them and that's what we

There was a \$500,000 prize for that event, which had just four teams. By doubling the prize money and expanding the field, Sherr believes it will create a competition worthy of a Grand Slam title, rather than keeping it as an exhibition.

"The athletes played hard," Sherr said. "It was not an exhibition, it was not a hit-and giggle, no kids got brought onto the court. It was a competition and that to me was the test. Would the athletes compete, and the answer to that was yes. Now we have an opportunity for a legitimate world championship, a Grand Slam championship, and we think the stakes

only go up by making it the actual

Eight teams will earn direct entry by their combined singles rankings, with eight other teams given wild cards into the field. Sherr declined to name any players who had committed, but said enough have expressed interest that some teams may be announced in the coming weeks, long

before the field is set in the summer. The tournament will be played in Arthur Ashe and Louis Armstrong, the two biggest stadiums, and be televised by ESPN in primetime, expo-

sure that is rarely given to doubles. But it will squeeze out doubles specialists who count on Grand Slam paychecks and now lose access to one of them. To compensate for that, Sherr said the prize money that was allocated to the 32-team mixed doubles tournament at last year's U.S. Open would be redirected toward men's and

women's doubles. "Yes, there's some that will be disappointed that they won't have the opportunity to compete in this event," Sherr said. "On the other side, we know that there's a huge opportunity to create more interest globally in doubles and there may be a cascading effect here, that the mixed creates a bigger spotlight on the men's and women's doubles when we get into

that portion of the tournament. "We'll have to see how that plays out, but we do know that our mixed competition historically has been competing with the men's and women's singles, and so the fields have suffered and the attention has suffered. A native of Naperville, Illinois, Cowell joined the Columbus Crew Academy in January 2023 as an under-15 player, started last season as an amateur with Crew 2 of MLS Next and signed a professional contract last August. He scored nine goals in 19 matches in the third tier MLS Next Pro, including 13 starts.

Adams assisted on the first U.S. goal in the second minute by Cowell, a San Jose Earthquakes forward who made his MLS Next Pro debut last year. Cowell is a younger brother of 21-year-old Chivas forward Cade Cowell, who has made 11 appearances for the U.S. senior national team.

The previous record for a U.S. team was a 20-0 win over Grenada at the 2022 CONCACAF

Women's U-17 Championship. The previous high for the men was a 13-0 victory over the U.S. Virgin Islands at the 2018 CONCACAF Under-20 Championship,

Cuba beat St. Kitts and Nevis 3-1 in the first Group A game. The eight group winners qualify for the expanded 48-nation Under-17 World Cup, to be played in Qatar from Nov. 5-27, and there is no knockout stage in CONCACAF qualifying. The FIFA tournament had 16 teams from 1985-2005 and 24 from 2007-23.

The U.S. Virgin Islands was outscored 33-0 while going 0-4 in 2022 CONCACAF Under-17 Crowning of winners at the end of the tournament.

Shiffrin & Johnson win gold in team combined at worlds

SAALBACH-HINTERGLEMM, Austria, Feb 11, (AP): Mikaela Shiffrin won a record-equaling 15th world championship medal and Breezy Johnson became double world champion on Tuesday when the American pair took gold in the new team combined event. Shiffrin was third-fastest in the sla-

lom at the Alpine skiing worlds, just over three hours after Johnson had clocked the fourth-best time in the downhill, as together they beat silver medalists Lara Gut-Behrami and Wendy Holdener of Switzerland by 0.39 seconds.

Stephanie Venier and Katharina Truppe of Austria took bronze.

The gold was Shiffrin's 15th career medal from world championships and she matches the record set in the 1930s by German skier Christl Cranz.

It's the second gold medal for Johnson, who won the downhill last Saturday, two months after she returned from a 14-month ban for three viola-

"It's pretty crazy. I think if you would have told us when we met that we would team up to win a world championship medal, I think neither of us would have believed it," said Johnson, who has been friends, and skied, with Shiffrin since their youth.

Shiffrin said: "So many things had to happen in the last ... how long it's been since we were 11. In order for this to happen we needed a new event entirely. This was an amazing day for me up there, nerve-racking because Breezy did her job just spectacularly this morning. It was so much fun to watch all these days, day in day out, she has been executing ... So, really, really unbelievable."

Reacting to Shiffrin's 15th career medal in the worlds, Johnson quipped, "If we keep adding team events, maybe we can get 32 for her or something," before adding, "she is a legend, it's super cool to be hitting my stride and she's obviously been on hers for

The team combined entails one racer competing in a downhill run and another in a slalom, with their two times added up to determine the final results.

The team combined will make its debut at next year's Milan-Cortina

Lauren Macuga had posted the fastest time in the downhill, but her American team dropped to fourth and missed a medal by 0.11 seconds after Paula Moltzen raced in the slalom.

Lindsey Vonn finished the downhill 2.51 seconds off the lead in 21st position out of 26 starters and ended up in 16th with teammate AJ Hurt.

Recovered from an abdominal inju-

ry that required surgery in December, Shiffrin competed in her first event at the worlds.

She initially planned to race in the giant slalom, as defending champion, and the slalom but skip the team combined, then changed her mind Monday when she felt not ready yet to compete in Thursday's GS.

With GS training off her schedule, she then decided to enter the team combined.

Vonn had campaigned to race with Shiffrin on an American team that would have united the two most successful skiers in World Cup history, but the coaching staff decided to form the teams based on "season-best results" in both downhill and slalom.

"It would have been a cool thing if those two greats would have raced together, but at the moment others are stronger in their performance," American speed coach Alex Hoedlmoser "We had to make sure to bring the fastest pairings together, and it was very obvious that Breezy was the fastest in the downhill and therefore would race with Mikaela.'

After her downhill display, American star Vonn said: "I had no speed at all ... I tried to give my best, as always. Unfortunately it was not my world championships. The skis are fast, but for me something is wrong with my boots and in the turns I don't get any speed. I stayed in my tuck but I was a turtle the whole way down."

Vonn came out of retirement, after nearly six years, at age 40 this season with a new titanium knee. She scored two top-10 finishes on the World Cup circuit in January but did not finish the super-G and placed 15th in the downhill at the worlds.

China sets new medal record, Thailand wins first-ever medal at Asian Winter Games

HARBIN, Feb 11, (Agencies): Kuwaiti skier Salman Al-Kandari secured 10th place in the freeski slopestyle competition at the 9th Asian Winter Games in Harbin 2025, successfully completing the three rounds of the event.

Al-Kandari, who made history as the first Kuwaiti athlete to compete in this event, described the competition at Yabuli Heights, located northwest of Harbin, as extremely challenging, with freezing temperatures adding to the difficulty. Despite the tough conditions, Al-Kandari completed all three rounds with strong times.

Reflecting on his performance, he noted that competing alongside the Asian champions in this discipline was an invaluable experience. He believes that the insights and experiences gained during the competition will significantly contribute to his growth as an athlete and help him achieve better results in future tournaments.

Al-Kandari expressed his gratitude for the support from the Kuwait Winter Games Club and the Kuwait Olympic Committee, who provided crucial assistance and organized strong training camps. The latest of these camps was held in Switzerland before the tournament.

China set a new record for the most medals won by the country's delegation in a single Asian Winter Games, while Thailand secured its first-ever medal on Tuesday

Ten gold medals were awarded at the Games on Tuesday, with China claiming six golds, five silvers, and five bronzes, bringing its total medal count to 70. This surpassed the previous record of 61, set at the 2007 Asian Winter Games in Changchun.

China's record-breaking moment came in the women's freeski slopestyle final, where Liu Mengting won gold and Yang Ruyi and Han Linshan took silver and bronze, respectively.

China added gold in freestyle skiing, as Feng Junxi and Wang Xue, along with Chen Meiting and Xu Mengtao, secured a 1-2 finish in the women's aerials synchro. Kazakhstan's Ardana Makhanova and Ayana Zholdas claimed bronze.

In the men's aerials synchro final, Kazakhstan's Roman Ivanov and Sherzod Khashirbayev won the country's first snow event gold at the Harbin Games, while China's Geng Hu and Yang Yuheng took silver, and Li Xinpeng and Qi Guangpu earned bronze.

Japan's Rai Kasamura won the men's freeski slopestyle title, with his teammate Ruka Ito taking silver. Thailand's Paul Henri Vieuxtemps claimed

bronze, marking the country's first-ever Asian Winter Games medal.

China's speed skating team wrapped up its competition with a dominant performance, winning all four gold medals awarded on the day. Ning Zhongyan set a new Games record in the men's 1,000 meters with a time of one minute, 8.81 seconds. South Korea's Cha Min-kyu took silver, and China's Lian Ziwen won bronze.

In the women's 1,000-meter final, China's Han Mei and Yin Qi finished one-two, with South Korea's Lee Na-hyun taking bronze. China also triumphed in both the men's and women's team pursuit events. South Korea and Japan took silver and bronze in the men's pursuit, while Japan and South Korea finished second and third in the women's event.

Elsewhere, South Korea's Ekaterina Avvakumova won the biathlon women's 7.5-kilometer sprint, with China's Meng Fanqi and Tang Jialin finishing second and third. In the men's 7.5-kilometer sprint, Kazakhstan's Vladislav Kireyev and Vadim Kurales took gold and silver, while China's Gu Cang earned

After Tuesday's events, China leads the medal tally with 27 golds, 13 silvers, and 20 bronzes. South Korea follows with 12 golds, 12 silvers, and 11 bronzes, while Japan sits third with five golds, six silvers, and

The IOC has partnered with the Saudi Olympic and Paralympic Committee in organizing the event. The Esports World Cup Foundation (EWCF) will also become a founding partner of the Games with expertise in game selection and tournament structures to bridge the gap between emerging esports and traditional

In order to ensure the integrity, sustainability and growth of esports, the IOC and EWCF will collaborate closely with key stakeholders to establish qualification pathways with broader global standards.

"There is now a very clear roadmap to the historic first-ever Olympic Esports Games. With the road to the Olympic Esports Games starting this year, the Games are becoming a reality," said IOC President Thomas Bach.

A joint committee chaired by IOC Member Ser Miang Ng and co-chaired by HRH Prince Abdulaziz bin Turki Al Faisal has been set up to steer the Games, working to define the games that will be part of the inaugural Olympic Esports Games. Saudi Arabia is also looking forward to welcoming the world and playing its part to help the dreams of so many esports athletes come true, adding the esports to the popular events in the country, which includes football, motorsports, tennis, equestrian and golf.

\$200,000 for Gulf Legends Championship winner

KUWAIT CITY, Feb 11: Mohsen Musabah, member of the Old Players Committee of the Arabian Gulf Cup Football Federation and former UAE national team goalkeeper, revealed the financial rewards for the upcoming "Gulf Legends" Championship, set to take place at Jaber Al-Mubarak Stadium from February 22-26.

Musabah confirmed that the champion of the tournament will receive a prize of \$200,000, while the runner-up will earn \$150,000. In addition, all participating teams will be rewarded with a financial incentive for each match played.

This announcement came during a press conference, where Musabah also explained a change in the tournament's name. He noted that some retired players from recent years had not been referred to as "legends," thus providing an opportunity for all former players to participate in this competitive event, which will be held for the first time.

The championship is set to

continue in the future, with plans for it to accompany all Gulf championships. The inaugural event will coincide with the 27th Gulf Championship, set to take place in Saudi Arabia.

Musabah also emphasized that financial rewards are not limited to the participating teams. The tournament will honor the best player, top scorer, and best goalkeeper with a prize of 150,000 Qatari riyals each. Additionally, he responded to a question regarding ticket pricing, stating that the decision lies with the Kuwait Football Association. From his personal perspective, he believes that offering free entry would allow more fans to enjoy the event, especially those celebrating Kuwait's national holidays, which could further boost attendance at the Gulf Cup for veteran players.

Hassan Matar Al-Suwaidi, head of the Old Players Committee, expressed gratitude to the State of Kuwait for hosting the event, which will take place from February 22-26 at Jaber Al-Mubarak Stadium in Al-Sulaibikhat Club. He also thanked Sheikh Hamad bin Khalifa, the Qatari Minister of Sports and Youth and President of the Gulf Federation, for initiating the idea of holding the tournament.

Al-Suwaidi further explained that the tournament was initially scheduled to coincide with the 26th Gulf Cup hosted by Kuwait from December 21 to January 4, but it was postponed to align with Kuwait's national holidays. He announced that the tournament will feature four matches per day, with each match lasting 40 minutes, divided into two 20-minute halves. Teams will also be permitted substitutions to avoid injuries during play.

Finally, Al-Suwaidi confirmed that the tournament's name had been changed from the Gulf Legends Championship to the Gulf Cup for Veterans to reflect its inclusive nature for all former players who participated in previous Gulf competitions. Therefore, the event is open to more than just "legends."
