

Arab Summit adopts Egypt's plan for Gaza reconstruction


'Displacement of Palestinians a crime against humanity'

Call for full Israeli pullout from Lebanon Israel's attacks on Syria slammed at summit

March CAIRO, 5, (KUNA): Arab leaders adopted, at their extraordinary summit in Cairo Tuesday, Egypt's plan for the reconstruction of the Gaza Strip without displacing its people and underlined the need for upholding the ceasefire and allowing unimpeded access to humanitarian aid. Speaking at the closing session, Egyptian President and Summit Chairman Abdelfattah El-Sisi stated that the participating Arab leaders and delegations has approved the final statement including Egypt's plan for the comprehensive recovery and reconstruction of the Gaza Strip.

Kuwait committed to defending Palestinian rights'

KUWAIT CITY, March 5, (KUNA): The representative of His Highness the Amir Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah, His Highness the Crown Prince Sheikh Sabah Khaled Al-Hamad Al-Sabah delivered Kuwait's speech during the Extraordinary Arab Summit in Cairo on Tuesday.

His Highness the Crown Prince stressed the need for the summit to formulate a unified Arab position against any attempts to displace Palestinians, highlighting a number of steps.

1. Raising the Arab voice, rejecting any attempts to displace the Palestinian people, and refusing to blame countries of the region, namely Jordan, Egypt, and Saudi Arabia of any consequences for calls of displacement.

2. Formulate plan for the reconstruction of Gaza and compensate the Palestinian people for the damage caused in addition to holding the Israeli occupation responsible for rebuilding what its forces destroyed.

3. Holding the Israeli occupation accountable through international law, international humanitarian law, General Assembly and Security Council Resolutions, Human Rights Council, the International Criminal Court, and the International Court of Justice.

4. Pursuing the two-state solution in a concrete and realistic way at the international conference for the implementation of the two-state solution in June.

Experts push for multi-storey solutions

Kuwait's 2.3 mln cars push parking crisis to new heights

KUWAIT CITY, March 5: The parking crisis in Kuwait is worsening due to the increasing number of cars.

The latest statistics from the Ministry of Interior revealed that there are 2,374,339 licensed vehicles in the country -- 1,188,624 owned by citizens; 552,009 owned by expatriates; 455,192 company vehicles; 132,263 owned by Gulf nationals and 26,316 owned by non-Kuwaitis.

Employment falls

Experts agree that it is necessary to resolve the crisis of cars parked randomly around private and government buildings and mosques, as this leads to visual pollution. They suggested the establishment of multi-storey parking lots in various areas to help solve this crisis.

Eng. Alia Al Farsi, a member of the Municipal Council and a transportation engineering consultant, explained that the parking crisis extends to all types of land use and is widespread in investment housing areas.

She submitted a proposal to the Municipal Council to solve this crisis in investment housing areas, and it is currently under technical study by the Construction Works Regulation Committee in Kuwait Municipality.



Misused iftar offers under Kuwait radar

KUWAIT CITY, March 5: The Ministry of Social Affairs has warned about restaurants and eateries that use promotional tactics during Ramadan, especially those soliciting donations under the guise of providing iftar meals to those who are fasting.

Sources from the ministry disclosed that donation campaign slogans; such as 'Contribute and share the reward with us' or 'Donate and share the iftar of a fasting person', are in violation of the rules and regulations on fundraising activities.

Sources confirmed to the newspaper that the ministry's teams are closely monitoring restaurants, which announced the availability of Iftar meals for fasting people with the possibility of distributing them; as this is considered a violation of the rules and regulations.

Jail for doctor receiving salary while abroad for over 15 years

KUWAIT CITY, March 5: The Criminal Court sentenced a Kuwaiti mental health doctor in absentia to five years in prison and fined him KD1 million for receiving full salary even if he has been abroad for over 15 years. According to the Legal Department

at the Ministry of Health, the doctor has been absent from work for 15 years as he is outside the country; yet he has been receiving his full salary in collusion with another employee in the ministry.

Ås a result, a report was filed at the Public Prosecution and the Criminal Investigations Department in the Inte-

rior Ministry conducted investigations. An inquiry into the doctor's entry and exit from the country led to the discovery that he has been residing in another country for 15 years. The necessary measures were taken against him.

Man held with drugs: A young man was arrested in Jahra for the possession of synthetic cannabinoids.

IN a recent article by colleague Dr. Khaled Montaser, he mentioned that the Pope of the Roman Catholic Church is currently facing a serious health crisis and he won-

dered about the reason behind the widespread global concern surrounding this issue.

Dr. Montaser explained that the reason for the global concern lies in the enlightened po-

alsarraf sitions Pope Francis took, which

mark his character. The Pope has worked to bring the Church closer to contemporary issues, such as advocating for the rights of immigrants and refugees, emphasizing the need to protect their rights, and warning against the rise of hatred and racism toward them.

He also implemented several important reforms within the Church. He has taken a strong stance against financial corruption, increased transparency, and, for the first time in history, appointed women to senior positions within the Church.

He has shown a strong commitment to environmental preservation, and criticized excessive capitalist consumption and greed.

The Pope advocated for interfaith dialogue and worked to strengthen relations with Muslims and Jews. In 2019, he signed the Human Fraternity Document with Sheikh Ahmed Al-Tayeb of Al-Azhar Mosque in Abu Dhabi, which calls for peaceful coexistence and religious tolerance. He also urged the Church to focus on mercy rather than punishment and to prioritize forgiveness over harsh penalties, even on issues such as divorce and abortion.

Furthermore, the Pope has been vocal in criticizing greed-driven capitalism, and denounced the global economic system for exacerbating the divide between the rich and the poor.

He called for a simplification of the clergy's lifestyle, and urged priests and bishops to embrace modesty and humility and reject extravagance within the Vatican.

Dr. Montaser shared a story from

April 2018 during the Pope's visit to his parish in Italy. A 10-year-old boy named Emmanuel approached the Pope with tearful eyes and asked if his atheist father, who had baptized him and his siblings as Christians, would find a place in Heaven (i.e., Paradise). The Pope responded with deep sympathy, explaining that God has a father's heart, and that the boy's father had done good deeds by baptizing him and his siblings.

"How could God abandon a good person who raised his children well, and keep him far from Him?" the Pope asked.

This incident attracted huge media attention at the time, as the Pope's compassionate nature and his humane approach to dealing with various issues. This is the kind of empathy and understanding we desperately need in our societies, where extremism and fanaticism have become dominant forces.

We hear nothing from the scholars, especially the occupant of the red chair, but reprimands, intimidation, warnings, and a long list of prohibitions, precautions, and dangers, threatening that anyone who commits such acts will surely find their place in Hell!

Of course, the problem is not with the occupant of the red chair or others like him, who are seeking fame, money, and influence. They are well aware that nothing attracts followers and generates wealth like extremism, spreading hate speech, adopting sectarian attitudes, and filling people's hearts with fear of Hell's torment.

The problem lies with the media that has provided platforms for them, and with the Ministry of Islamic Affairs that has allowed them to spread their extremist ideology and issue religious opinions.

In this special month, we hope for the establishment of a Ministry for Religious Affairs that focuses on religion for the benefit of all, rather than serving the interests of a specific group.

We are truly in dire need of following the example of our brothers in Saudi Arabia when it comes to religious reforms. We are truly tired of the growing extremism, and our hearts long for the sound of merciful words and tolerant thinking!

FIU – European firm to help Kuwait meet FATF demands

Contract with FTA to cost 6.1 mln euros

KUWAIT CITY, March 5 : Kuwait's Financial Investigations Unit (FIU) is in the final stages of completing procedures to contract directly with Financial Transparency Advisors (FTA) – an advisory firm based in Vienna, Austria, reports Al-Jarida daily.

The firm will provide expert advice and technical assistance to support Kuwait's ongoing efforts to combat money laundering and terrorism financing, particularly during the follow-up process conducted by the Financial Action Task Force (FATF) and the International Cooperation Review Team.

The daily obtained a copy of the letter affirming that the State Audit Bureau (SAB) has reviewed the direct contracting documents and raised no objections to proceeding with the contract with FTA for a total amount of 6.1 million euros within a period of 19 months; set to conclude on March 31, 2026.

SAB emphasized the need for FIU to ensure that the prices offered by the firm are appropriate and in line with the market rates for such services.

The bureau also highlighted the importance of continuing to train and qualify national staff to carry out the necessary tasks related to this research, so as not to further burden public funds with additional expenses related to special contracts for this issue.

In its most recent report - last October, FATF noted "serious shortcomings" in Kuwait's efforts to combat money laundering, despite the country having an adequate legal and regulatory frameworks.

FATF pointed out failures in addressing money laundering and terrorism financing; although it acknowledged that regulatory bodies like the Central Bank, Capital Markets Authority and the Insurance Unit have a good understanding of the associated risks.

Caesar asked him, "Then, what made you cry?"



Hunt launched as thief flees on foot in police chase

KUWAIT CITY, March 5: Four expatriates were arrested for begging in Farwaniya and Jahra Governorates.

A security source revealed that detectives caught four expatriates -- two of whom are Arabs -- in the act of begging in the aforementioned governorates. He affirmed these expatriates were immediately referred to the concerned authority to take the necessary action against them, including deportation.

The source also confirmed that the necessary legal measures were taken against the sponsors of the four expatriates.

Hunt launched for thief: Officers from the Jahra Investigations Department visited Jahra Hospital to take the statement of an injured individual who helped expedite the arrest of a thief who fled on foot, reports Al-Anba daily.

A security source reported that while a highway security patrol was on duty near Abdally Cooperative Society, they noticed a suspicious van. Upon checking the vehicle's details, they discovered it is wanted by law in connection with a theft case filed at Waha Police Station.

The officers instructed the driver to pull over, but he refused and sped off in an attempt to escape. The vehicle subsequently collided with another car. After the crash, the driver fled on foot, leaving behind the damaged vehicle with his injured companion inside.

The traffic police then discovered that the front and rear license plates on the vehicle did not match, and further inspection revealed two mo-

torcycles in the trunk, which were likely stolen. The injured individual denied any involvement in the theft of the vehicle or knowledge of the stolen motorcycles . However, he provided investigators with crucial information about his companion; including his name, telephone number and address. The fugitive's name was then circulated to aid in his capture. He will face charges related to theft, property damage, fleeing from law enforcement, and causing an accident resulting in injury.

Cash stolen from car: A Kuwaiti citizen reported to a police station in Hawally Governorate that his bag containing official documents and money were stolen from his car while parked at a cooperative society's parking lot, reports Al-Anba daily.

A case of burglary was registered, and forensic personnel were called in to collect fingerprints and identify the perpetrator.

Expat couple facing 15 years jail for drug peddling caught

KUWAIT CITY, March 5: The General Department of Execution of Judgments has successfully apprehended a male and female expatriate who had been sentenced to 15 years in prison for drug trafficking, reports Al-Anba daily. The individuals were transferred to the central prison - men's and women's sections - to begin serving their sentences

According to a security source, Criminal Execution Investigations officers tracked down the two expatriates after their final conviction was issued last week. Once their residence was identified, authorities swiftly moved in and arrested them without resistance.

The source further explained that all final rulings are handed over to the General Department of Execution for enforcement. If convicted individuals are present in court at the time of sentencing, they are taken into custody immediately. However, if a ruling is issued in absentia, law enforcement is tasked with locating and arresting them.

In a separate case, Capital Investigations officers arrested a citizen in his thirties with a criminal record involving multiple theft and drug-related charges. The arrest followed a well-planned ambush in the Capital Governorate.

A security source reported that a rise in car thefts from coastal parking lots and commercial markets prompted authorities to launch an investigation. The pattern of thefts indicated a single perpetrator, leading officers to identify the suspect – a repeat offender with a history of similar crimes. After monitoring his movements, authorities arrested him in possession of stolen goods, which were subsequently turned over to the relevant authorities along with the suspect.

Police arrest 3 for carrying drugs, consuming alcohol

KUWAIT CITY, March 5: Authorities have arrested three individuals in separate locations for possession of drugs and alcohol, with all suspects referred to the General Department for Combating Narcotics, reports Al-Anba daily.

In Jahra, backup patrol officers detained a citizen with a criminal record after finding him using drugs inside his vehicle. According to a security source, officers conducting a routine patrol in a cooperative parking lot noticed a suspiciously parked car. Upon approaching the vehicle, they discovered the driver - a man in his thirties - under the influence of drugs. A precautionary search of the car led to the discovery of narcotics and drug paraphernalia, prompting his immediate arrest.

In a separate incident, rescue police apprehended another citizen, born in 1992, in Ahmadi. He was found in possession of a drug-laced cigarette, a piece of hashish, rolling papers, and additional drug paraphernalia. His suspicious behavior led officers to detain and transfer him to the relevant authorities

Meanwhile, a Gulf national was arrested on the Fourth Ring Road after exhibiting erratic driving behavior. Upon investigation, officers determined he was under the influence of alcohol. Reforms aim to improve academic readiness and reduce failure rates

Higher Education unveils new regulations for foreign scholarships

KUWAIT CITY, March 5: The Ministry of Higher Education has unveiled its plan to amend the foreign scholarship regulations, as per a comprehensive study on the outputs of the scholarship program over the past years and the amended regulations will be implemented in the current academic year (2025/2026).

Undersecretary of the ministry Lamia Al-Malham disclosed that the most important changes include replacing the preparatory English language stage with a requirement that the student obtain a score of at least 5.5 in the International English Language Testing System (IELTS). "The student will be granted a full calendar year from the date of announcing the acceptance results to meet this condition," she added.

Al-Malham stated that the decision was made after analyzing the reasons behind the students' academic failure, such as failure to acquire the required English language skills at the end of the language program.

Other changes to the scholarship regulations are the condition that students accepted in the excellence scholarship program maintain a grade point average of at least 2.67 on a four-point scale, and that scholarship applicants who did not previously obtain a scholarship or grant in the country must obtain a bachelor's degree.

Al-Malham explained these changes aim to raise the quality of education, improve student performance, reduce linguistic obstacles and lessen the academic failure rate among students. She urged those who intend to study abroad to prepare early to pass the approved English language tests.

Kuwait's Audit Bureau seeks transparency in media deals

Ministry urged to standardize procedures

KUWAIT CITY, March 5: The State Audit Bureau (SAB) has asked the Ministry of Information to study the mechanism for purchasing and renting programs, artistic works and the executive producer, calling for the development of a unified and comprehensive regulation that includes all decisions and conditions regarding these operations.

Sources explained to the newspaper that this step aims to enhance transparency, fully benefit from the budget allocated to this sector, and achieve the highest level of efficiency in managing media contracts.

Sources said SAB asked the ministry to prepare a unified and comprehensive regulation that includes all decisions on purchasing and renting operations in order to ensure the clarity of procedures and the integrity of contract implementation, as well as to avoid any discrepancy or difference in the standards followed.

Sources added this procedure is in light of the ministry's purchase of a number of drama series and programs to be shown on Kuwait TV during the holy month of Ramadan. Sources said SAB stressed the need to verify the suitability of the prices that were adopted to evaluate the purchase of artistic

works and to make sure that the assessment is carried out according to accurate standards that reflect the actual cost of production and artistic quality.

Sources indicated that SAB stressed the importance of the declarations of the contracted companies being an integral part of the contract documents to guarantee clarity of obligations and rights between the contracting parties, as this contributes to raising the efficiency of government contracts and avoiding loopholes that may affect the quality of media content or the efficiency of financial contracts.

Sources confirmed that all works contracted for Ramadan shows have obtained the necessary approvals from the competent authorities, including the Central Agency for Public Tenders (CAPT) and the Distinguished Works Purchasing Committee at the ministry.

KD 10,000 fine for unlisted beneficiaries

MoCI mandates beneficiary disclosure

KUWAIT CITY, March 5: The Ministry of Commerce and Industry has affirmed that all commercial register owners are required to identify the actual beneficiary through the commercial register portal, in accordance with Ministerial Decision No. 16/2025, reports Al-Seyassah daily.

The ministry warned violators of the potential penalties, which include fines ranging from KD 1,000 to KD 10,000.

It urged commercial register holders to promptly disclose and identify the actual beneficiary to avoid financial penalties.

Arab Summit

President El-Sisi welcomed the outcome of the summit, expecting that the summit would help achieve interests, defend security and boost joint Arab action to meet Arab peoples' aspirations.

In their final statement, the Arab leaders called for full financial, material, and political support for the Egyptian plan and urged international donors to contribute to it while ensuring parallel efforts to establish a permanent political framework for a just resolution to the Palestinian issue.

They voiced unequivocal rejection of displacement of Palestinians, whether within or beyond their land, under any pretext or justification, saying such plans blatantly violate international law and are crimes against humanity amounting to ethnic cleansing.

They condemned policies of starvation and scorchedearth tactics aimed at forcing Palestinians from their land and emphasize Israel's obligation as an occupying power to abide by international legal rulings prohibiting demographic changes in the Palestinian territories.

The Arab leaders warned that any attempt to forcibly displace Palestinians or annex occupied land will plunge the region into new conflicts, destabilize the region, and broaden the scope of hostilities. They stressed that this would pose a direct threat to the foundations of Middle East peace and eliminate prospects for coexistence.

They acknowledged the crucial role of Jordan and Egypt in countering the threats of displacement and the eradication of the Palestinian cause.

They also urged full implementation of the ceasefire agreement, including its second and third phases, and ensuring all parties, particularly Israel, adhere to their commitments which includes a complete Israeli withdrawal from Gaza, including the Philadelphia Corridor, and guaranteeing the immediate and unimpeded delivery of humanitarian aid across the territory.

They also expressed backing to Palestine's decision to form an interim Gaza administration under the Palestinian government, composed of Gaza-based technocrats, as a transitional step towards reinstating the Palestinian Authority in Gaza.

They called on the UN Security Council to deploy international peacekeeping forces in the West Bank and Gaza.

'Kuwait committed

5. Urge all UN member states that have not yet recognized Palestine to do so, and support Palestine in obtaining full membership status in the UN.

6. Unite Palestinian ranks and the administration of the Gaza Strip, and strengthen the Palestinian government's capabilities, in addition to unifying Arab ranks to protect Arab national security

7. Strengthen financial and political support for the United Nations relief and Works Agency for Palestine Refugees in the Near East (UNRWA), and reject any attempts to reduce its role

His Highness reaffirmed Kuwait's position that a lasting, comprehensive, and just peace is the only way forward through what has been agreed upon in accordance with international resolutions, leading to establishing an independent Palestinian State on the borders of June 4, 1967, with East Jerusalem as its capital.

Earlier, Representative of His Highness the Amir Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah, His Highness the Crown Prince Sheikh Sabah Khaled Al-Hamad Al-Sabah attended an 'iftar' banquet, hosted by Egyptian President Abdelfattah El-Sisi.

The banquet was held on Tuesday evening in honor of leaders of the Arab countries participating in the Extraordi-nary Arab Summit in Egypt's New Administrative Capital, Cairo Governorate

Following the summit, His Highness the Crown Prince departed Cairo, where he was seen off by Egypt's Minister of Civil Aviation Dr. Sameh Al-Hafni, Kuwait's Minister of Foreign Affairs Abdullah Al-Yahya, Assistant Foreign Minister Ambassador Bader Al-Tunaib, and Kuwait's Permanent Representative to the Arab League Talal Al-Mutairi.

The proposal aims to eliminate the parking crisis through optimal urban planning for parking lots in investment housing, finding a way out of the randomness of parking cars. This will raise the standard of living for those living around the residential buildings by eliminating parking in dirt yards, roads and sidewalks; thereby, adding value to the buildings, creating a sense of responsibility among individuals, and raising the level of traffic safety in investment housing areas.

The proposal encourages the construction of multi-storey parking areas in investment housing buildings and complexes, in accordance with the terms and conditions set by the Municipality. The renewed decline in employment and purchasing activity painted a less favorable picture. Firms reduced output prices for the second time in three months, despite a sharp increase in input costs.

Output continued to rise strongly, extending the current expansion phase that began in February 2023. However, the growth slowed for the third consecutive month, reaching its slowest pace since October.

Powerful US storms kill two people

Powerful storms killed two people in Mississippi, tore the roofs off an apartment building and a nursing home in a small town in Oklahoma and threatened more communities across the nation Tuesday with wide-ranging weather.

The large storm system also brought blinding dust storms to the Southwest, blizzards with whiteout conditions to the Midwest and fears of wildfires elsewhere.

In Irving, Texas, a tornado with winds up to 110 mph (177 kph) struck, while another touched down in the 16,000-resident city of Ada, Oklahoma, according to preliminary information from the National

Weather Service There were also two tornadoes in Louisiana's northern Caddo Parish and at least five in eastern Oklahoma.

High winds forced some changes to Mardi Gras in New Orleans, which moved up and shortened the two biggest parades to wrap them up before the bad weather moved in. (AP)

Florida lawmakers begin legislative session DeSantis and Trump priorities hold sway

TALLAHASSEE, Fla, March 5, (AP): As Florida lawmakers officially kicked off their 2025 legislative session Tuesday, the political aspirations of two of the state's best-known residents - Gov. Ron DeSantis and President Donald Trump - were driving the conversation amid the pomp and ceremony.

As DeSantis approaches the end of his second term, the popular Repub-lican governor has been talking up one potential heir to succeed him: his wife, Casey DeSantis. At the same time, DeSantis has sparred with some of Trump's allies in the Legislature, working to lay the groundwork for his own political future while the president's supporters in Tallahassee try to follow through on the campaign promises of the man DeSantis dared to challenge for the party nomination.

Addressing a joint session of the Legislature on Tuesday, DeSantis touted the laws he signed last month to crackdown on illegal immigration in the state, which lawmakers passed after huddling in three special sessions that sparked a bitter feud between the governor and legislative leaders as they battled over whose ideas would better deliver on Trump's vision.

But speaking to a House chamber packed with lawmakers, DeSantis congratulated the legislative leaders on the immigration measures.

"No state has done more and no state did it sooner than we did in the free state of Florida," DeSantis said. "We can and we must continue to lead."

Heading into the regular session, DeSantis has called on lawmakers to consider a proposal to eliminate the state's property taxes, to roll back gun restrictions that a bipartisan coalition passed in the wake of the 2018 shooting at Marjory Stoneman Douglas High School in Parkland and to significantly restructure the citizens' ballot initiative process. In November, Florida voters used the ballot process to propose legalizing recreational marijuana and expanding abortion rights, though the measure fell short of the 60% needed

to pass.

'We saw how that constitutional amendment process was perverted," DeSantis said, alleging there was fraud in the petitions used to get the measures on the ballot. "We need to clean up this out-of-control amendment process."

Republican Senate President Ben Albritton has raised questions about the governor's call to undo changes made after the school shooting, saying law enforcement officers tell him the state's red flag law is working.

US president address to Congress showed country's stark partisan divide

Zelenskyy wants peace, ready to accept minerals deal after WH blowup: Trump

WASHINGTON, March 5, (AP): US President Donald Trump said Tuesday that Ukrainian leader Volodymyr Zelenskyy had written to him to say he appreciates US support for his country in its war with Russia and is ready to sign a deal that could ensure future American support.

In a speech to Congress following last week's disastrous meeting at the White House, Trump said Zelenskyy had told him that Ukraine is ready to negotiate a peace deal with Russia as soon as possible and would accept a critical minerals agreement with the US to facilitate that.

Trump's remarks came after Vice President JD Vance, who was a major player in the breakdown between the president and Zelenskyy on Friday, struck a new nerve with allies by offering skeptical comments about a potential international security force for postwar Ukraine proposed by Britain and France.

"Earlier today, I received an important letter from President Zelenskyy of Ukraine," Trump said. Quoting from the letter, Trump said Zelenskyy told him that "Ukraine is ready to come to the negotiating table as soon as possible to bring lasting peace closer.

Nobody wants peace more than the Ukrainians.

"My team and I stand ready to work under President Trump's strong lead-ership to get a peace that lasts," Trump quoted Zelenskyy as writing. "We do really value how much America has done to help Ukraine maintain its sovereignty and independence.'

Trump added that Zelenskyy said he was ready to sign the minerals deal "at any time that is convenient for you."

Although Trump said he "appreciated" getting the letter, he did not say if it would affect his policy toward Ukraine, which on Monday was domin nated by his decision to pause military aid to the country.

Earlier Tuesday, Vance had said the minerals deal would be a more practical deterrent against Russian President Vladimir Putin than a peacekeeping force for postwar Ukraine that includes "some random country." In an interview with Fox News

Channel's Sean Hannity, Vance said the economic pact with Kyiv sought by Trump "is a way better security guarantee than 20,000 troops from some random country that hasn't fought a war in 30 or 40 years. The Trump administration has been

making the case that tightening US-Ukraine economic ties through an agreement that gives the US access to valuable mineral deposits in Ukraine will give Russia pause about taking malign action against Ukraine in the future

Vance did not mention any particular country in his skeptical comments about a potential peacekeeping mis-sion. But the "random country" comment was seen by some lawmakers and government officials in the UK and France as a slight that discounted both countries' partnership with the US military in conflict zones over the past 25 years.

UK Prime Minister Keir Starmer and French President Emmanuel Ma-cron are leading the call for a post-conflict peacekeeping force in Ukraine to prevent Russia from invading again if Moscow and Kyiv reach a truce to put a stop to Russia's invasion, launched in February 2022.

French troops deployed to Afghani-stan following the Sept. 11, 2001, at-tacks on the United States. And British troops have served alongside American forces in Afghanistan and Iraq and in a US-led coalition against the Islamic State group. Reform UK leader Nigel Farage

told broadcaster GB News that "JD Vance is wrong, wrong, wrong, wrong, wrong.

"For 20 years in Afghanistan, pro rata our size against America's, we spent the same amount of money, we put the same number of men and women in, and we suffered the same losses," Farage added. "We stood by America all through those 20 years putting in exactly the same contribution. And, all right, they may be six times bigger, but we did our bit.

Vance on Tuesday took to social media to try to head off the criticism by noting that he didn't name any countries in the TV interview. He also applauded Britain and France for fighting "bravely alongside the US over the last 20 years, and beyond."

Later, during an appearance on Capitol Hill, Vance underscored to reporters that "the British and the French have offered to step up in a big way.

French Defense Minister Sébastien Lecornu, in France's parliament, noted the move by Vance. "Thankfully, the American vice president corrected his comments," Lecornu said.

But in London, Liberal Democrat defense spokeswoman Helen Maguire, a former Royal Military Police officer who served in Iraq, called for the U.K. ambassador in Washington to ask Vance to apologize.

Trump was speaking to a house divided. Republicans stood and cheered. For Democrats, it was silence, with occasional shouts of protest, with the only applause when he announced that Ukraine wanted to restart peace negotiations. He inflated the scale of his victory in November, the margin of which was actually among the smallest in American history.

Slovak president swears in new minister in reshuffle to stabilize government

BRATISLAVA, Slovakia, March 5, (AP): Slovakia's President Peter Pellegrini swore in a new minister of tourism and sports on Wednesday in a reshuffle aimed to stabilize the government.

The appointment of Rudolf Huliak came two weeks after the three parties in the governing coalition agreed on a move to increase the power of the Smer (Direction) party of populist Prime Minister Robert Fico.

Under the agreement, the coalition's two junior partners - the Hlas (Voice) party and the ultranationalist and pro-Russian Slovak National Party - gave up control of one ministry each to Smer.

With the addition of the ministries overseeing investments, regional development and information, and tourism and sports, Smer now controls nine ministries, Hlas six and the Slovak National Party two.

The deal was a result of a recent crisis in the coalition that risked its parliamentary majority.

The coalition had 79 seats in the 150-seat parliament known as the National Council before four Hlas lawmakers and three others, including Huliak, in the Slovak National Party parted with their parliamentary factions. The lawmakers did not join the opposition but have demanded posts in the government, parliament and state institutions in exchange for their loyalty.

That has made it difficult for the government to advance its agenda.

Huliak is not a member of the Slovak National Party but heads a fringe, farright National Coalition party.

Pellegrini's predecessor, Zuzana Čaputová, refused to accept Huliak's nomination for the post of environment minister after the 2023 parliamentary election. Čaputová said she would not appoint as minister someone who doesn't believe in the threat of climate change.

She also cited Huliak's advocacy of violence against environmentalists as a reason not to swear him in. Huliak, the mayor of Ocová town in central Slovakia, and expressed pro-Russian views.

Fico has yet to announce his plans with the Investments, Regional Development and Information Ministry.

Greenland defiant leader says island 'is ours' as Trump vows to acquire territory

NUUK, Greenland, March 5, (AP): Greenland's prime minister declared Wednesday that "Greenland is ours" and cannot be taken or bought in defiance of a message from U.S. President Donald Trump, who said his administration supported the Arctic island's right of self-determination but added that the United States will acquire the territory "one way or another.

Greenlandic Prime Minister Múte Bourup Egede said the island's citizens are neither American nor Danish because they are Greenlandic. The United States needs to understand that, he wrote in a post in Greenlandic and Danish on Facebook Wednesday.

The future of Greenland will be decided by its people, he wrote.

French President Macron to discuss nuclear deterrence with European allies

PARIS, March 5, (AP): French President Emmanuel Macron says that he's ready to start discussions on nuclear deterrence with European allies.

Macron has hinted that France could help to protect other nations after U.S. President Donald Trump raised questions both about the trans-Atlantic alliance and the defense of Ukraine.

While Macron's offering has been on the table for several years, it has gained urgency after Trump's remarks raised concerns among European NATO allies, which have for decades counted on the powerful U.S. deterrent.

Nuclear deterrence is a strategy based on the idea that the destructive force of nuclear weapons would prevent other nations' hostile actions, particularly nuclear attacks.

During the Cold War, the US nuclear umbrella was aimed at ensuring that allies, especially NATO members, would be protected by American nuclear forces in case of a threat. That's one of the reasons why many nations

across the world haven't pursued their own nuclear arsenals.

France is the only nuclear power in the European Union. The United Kingdom, which is no longer an EU member but is working on restoring closer ties with the 27-nation bloc and belongs to NATO, also has nuclear weapons.

In the wake of Trump's push for Europe to carry the defense burden, German election winner Friedrich Merz recently called for a discussion on "nuclear sharing" with France.

EU leaders are set to address the issue during a special summit in Brussels on Thursday, focusing on support for Ukraine and European defense. UK Prime Minister Keir Starmer won't be attending the summit. The only non-EU guest is Ukrainian President Volodymyr Zelenskyy.

France's nuclear deterrence is strictly conceived as defensive. It is meant to protect the country's "vital interests."

Although France is a NATO member, it independently maintains its nuclear forces, cooperating with the alliance's broader deterrence strategy.

Since a 2020 keynote speech, Macron has said that France's "vital interests" have a "European dimension" - comments that he reiterated in recent

days. "What may be new today ... is the somewhat urgent nature of these comments and how they are perceived abroad," said Emmanuelle Maitre, senior research fellow at France's Foundation for Strategic Research.

"Obviously, faced with the feeling of abandonment felt by NATO countries, there's some kind of logical search for what might enable them to keep some form of deterrence mission within Europe," Maitre said.

Nuclear deterrence involves maintaining ambiguity about which circumstances would lead to the use of nuclear weapons, in order to prevent a potential aggressor from calculating risks - which is why France wouldn't provide details over how it would help in defending other European countries.

Residents prepare for first cyclone in 51 years to hit Australian coast near Brisbane

MELBOURNE, Australia, March 5, (AP): Residents were stacking sandbags to protect low-lying properties Wednesday ahead of a tropical cyclone forecast to become the first in 51 years to hit the Australian east coast near Brisbane, the nation's third-most populous city. Tropical Cyclone Alfred is forecast to cross the coast

between the Queensland state capital Brisbane and the tourist city of Gold Coast to the south late Thursday or early Friday, Bureau of Meteorology manager Matt Collopy said. Brisbane and Gold Coast are a continuous urban sprawl. Their centers are 80 kilometers (50 miles) apart.

Alfred was over the Pacific Ocean 400 kilometers (250 miles) east of Brisbane and tracking west Wednesday with sustained winds near the center of 95 kph (59 mph) with gusts to 130 kph (81 mph).

"That is destructive winds," Collopy said. It was expected to maintain that strength until reaching land.

"Large swells and powerful waves have been observed along the Queensland coast for several days now with severe coastal erosion and inundation happening," Collopy told reporters in Brisbane. "This will continue and likely get worse as the system approaches and makes landfall.'

Heavy rain and life-threatening flooding were expected in the days ahead, he said.

"The wave, wind, rainfall and particularly the storm surge present significant risks," Collopy added. Cyclones are common in Queensland's tropical north

but are rare in the state's temperate and densely populated southeast corner that borders New South Wales state.

Cyclone Zoe crossed the coast at the southern end of Gold Coast on the New South Wales border in March 1974, causing extensive flooding.

Prime Minister Anthony Albanese said his government was providing the Queensland government with 250,000 sandbags in addition to 80,000 the military had already delivered.

"This is a rare event, to have a tropical cyclone in an area that is not classified as part of the tropics, here in southeast Queensland and northern New South Wales,' Albanese told reporters in Brisbane.

"That is why this preparatory work is so important," Albanese added.

Brisbane Lord Mayor Adrian Schrinner said modeling showed that up to 20,000 homes in his city of more than 3 million people could experience some level of flooding.

N.Korea appears close to completing its 1st airborne early warning aircraft

SEOUL, South Korea, March 5, (AP): North Korea appears close to completing its first airborne early warning aircraft, satellite imagery showed, an asset that experts say will sharply bolster the country's air force power when it's deployed.

North Korea's nuclear and missile programs pose a significant security threat to South Korea, the US and others. But its aerial surveillance capability is far behind those of its rivals, while most of its fighter jets and other military aircraft are aging.

38 North, a website specializing in North Korea studies, reported Tuesday that recent commercial satellite imagery showed an Ilyushin IL-76 aircraft parked at a Pyongyang airport, with a large radome mounted on top of the fuselage. A radome refers to a structure that encircles a radar system.

It called the aircraft's near-completion "a significant upgrade for an air force that has not seen new airborne capabilities in years.'

The website said the radome has a distinctive triangle design on top, similar to what is seen on some Chinese airborne early warning aircraft, but not used on U.S. or Russian aircraft. "This could indicate support or influence from China, although the triangle alone is not conclusive proof," the website said.

TAIPEI, Taiwan, March 5, (AP): China said Wednesday it will increase its defense budget 7.2% this year, as it continues its campaign to build a larger, more modern military to assert its territorial claims and challenge the US defense lead in Asia.

China's military spending remains the second largest behind the US and it already has the world's largest navy.

The budget, which adds up to about \$245 billion, was announced at the National People's Congress, the annual meeting of China's legislature. The Pentagon and many experts say China's total spending on defense may be 40% higher or more because of items included under other budgets.

The boost is the same percentage as last year, far below the double-digit percentage increases of previous years and reflecting an overall slowdown in the economy. The nation's leaders have set a target of around 5% growth for this year.

Tensions with the US, Taiwan, Japan and neighbors who have overlapping claims to the crucial South China Sea are seen as driving spending on increasingly high-tech military technologies. Those include stealth fighters, the country's three - soon to be four - aircraft carriers, and a broad expansion of its nuclear arsenal.

China generally ascribes the budget increases to exercises and maintenance and improving the lives of its 2 million service members

The People's Liberation Army - the

military branch of the ruling Communist Party- has build bases on artificial islands in the South China Sea but its main objective is asserting Chinese control over Taiwan, a self-governing democracy Beijing claims as its own territory that has close ties to the US.

China sent a relatively small military contingent near Taiwan on Wednesday, just days after sending dozens of aircraft. Such missions are intended to demoralize and wear down Taiwan's defenses, which have been bolstered by upgraded US F-16s, tanks and missiles, along with domestically developed armaments.

In his comments at the Congress, Premier Li Qiang told the nearly 3,000 party loyalists that China still preferred a peaceful solution to the Taiwan issue, but "resolutely opposes" those pushing for Taiwan's formal independence and their foreign supporters.

"We will firmly advance the cause of China's reunification and work with our fellow Chinese in Taiwan to realize the glorious cause of the rejuvenation of the Chinese nation," Li said.

Taiwan's defense minister this week said the island is planning to boost military spending in the face of

the "rapidly changing international situation and the escalating threats from adversaries."

Faced with slower growth, China will likely prioritize key strategic goals over social and economic reforms, said Antonia Hmaidi, a senior analyst with the Mercator Institute for China Studies.

"Those resources are more important to the CCP's goals of advancing a techno-industrial agenda and modernizing the military," Hmaidi said, using an acronym for the governing Chinese Communist Party.

Chinese President Xi Jinping, who oversees the armed forces, has attempted to force through major reforms and removed senior military leaders including two former defense ministers and the head of the missile corps

Whether that will reduce the armed forces' influence remains unclear though, and the official Xinhua News Agency ran an item after Wednesday's announcement praising the government for keeping defense spending at below 1.5% of GDP for the last decade and criticizing the US for not cutting its spending.

"China's development strengthens the world's forces for peace, and the country will never seek hegemony or engage in expansionism no matter what stage of development it reaches," Xinhua said, using standard Chinese terms defining its stance as purely defensive in nature

China to increase its defense budget 7.2% this year

MOSCOW, March 5, (Agencies): Russian President Vladimir Putin was holding talks on Tuesday with the head of Myanmar's military government, who seeks to cement cooperation with Moscow as he faces isolation and sanctions from the West.

Gen. Min Aung Hlaing was on his fourth trip to Russia since his army seized power in February 2021 from the elected government of Aung San Suu Kyi. Western nations have imposed economic and political sanctions in response to the takeover and the violent repression of opposition, which has led to the deaths of thousands of civilians and given rise to an armed conflict widely seen as civil war.

At the start of the Kremlin talks, Putin noted growing bilateral trade and close cooperation in the international arena, and thanked the Myanmar leader for sending six baby elephants to Moscow.

Russia, along with China, is a major supporter and arms supplier to Myanmar. Russian-made fighter jets are used in attacks on territory under control of ethnic minority groups, many of them allies with pro-democracy resistance forces.

Russia defends Myanmar's military government in international forums, and the ruling generals generally sup-

port Moscow's foreign policy agenda. The countries have held joint military drills and signed a pact on developing nuclear power.

The countries signed agreements to outline cooperation around Moscow building nuclear power plants in Myanmar and recognize academic qualifications.

Ming Aung Hlaing emphasized his

military government's support for Russia's military action in Ukraine.

"Russia is a key backer of the Myanmar military," said Morgan Michaels, a Singapore-based analyst with the International Institute of Strategic Studies. "In addition to diplomatic and symbolic support, it plays a vital role in enhancing and sustaining the regime's warfighting capacity.'

PESHAWAR. Pakistan. March 5, (AP): A city in northwestern Pakistan was preparing for funeral prayers and observing a day of mourning Wednesday after a twin suicide bombing that targeted a military base the evening before killed 18 people, including five soldiers.

A militant group linked with the Pakistani Taliban claimed responsibility for the bombing in Bannu on Tuesday evening, which also left 42 wounded, some of them critically.

It was the latest in a spate of violence, including suicide bombings, that has hit the country in recent days.

The attack unfolded with two suicide bombers first blowing themselves up first to breach the wall surrounding the base. Most of the local residents were breaking their daylong fast during the Muslim holy month of Ramadan or praying at a nearby mosque.

The powerful blasts tore through walls and ripped off roofs and also severely damaged the mosque. After the explosions, other attackers stormed the compound and set off a firefight with the troops.

A statement from the army's media department on Wednesday said five soldiers and 16 militants were

killed. It said the suicide bombers "rammed two explosive-laden vehicles into the perimeter wall" at the base.

Gunshots could still be heard early Wednesday as security forces combed through the area, looking to clear it of any militants involved in the attack. At the scene of the bombings, a mechanical digger was

clearing away rubble where homes used to stand, and debris-covered prayer mats lay crumpled on the mosque floor.

A day of mourning was being observed, said Bannu community elder Alam Khan, and joint funeral prayers were to be held for the victims at a sports complex in the area.

Neither Machar nor his SPLM-IO party have commented about the fighting, but Water Minister Pal Mai Deng, who is also the party's spokesperson, said Lam's detention "puts the entire peace agreement at risk.

Western envoys last week urged leaders to de-escalate the tension.

Ter Manyang Gatwich, Executive Director of the Center for Peace and Advocacy, has called for the immediate release of those detained to avert further escalation of violence and further bloodshed from degenerating into what he called a "full-scale war.

South Sudan is yet to fully implement the 2018 peace agreement and elections that were scheduled for last year were postponed by two years due to a lack of funds.

Meanwhile, the United Nations World Food Program (WFP) said Tuesday it faces a critical funding shortfall of 412 million US dollars to meet the urgent humanitarian needs of millions in crisis-hit South Sudan in 2025.

Al-Roumi affirms stability goals

'OPEC+ to gradually increase oil production starting April'

KUWAIT CITY, March 5, (KUNA): Kuwait Oil Minister Tariq Al-Roumi has affirmed that the decision of eight oil-exporting countries within the OPEC Plus group to begin in-creasing their production starting next April is a decision aimed at ensuring the stability of the global oil market.

This came in a press statement by Minister Al-Roumi after his participation in the ministerial meeting of the eight OPEC Plus countries that are implementing voluntary production cuts, which was held yesterday via video conference, namely Algeria, Saudi Arabia, the Emirates, Iraq, Kazakhstan, the Sultanate of Oman, Russia, in addition to Kuwait.

Al-Roumi said a comprehensive assessment of the current oil market conditions and prospects for their development during the coming months was reviewed, noting that it was decided to proceed with a gradual increase in production starting from the first of next April, in line with market data, in accordance with what was agreed upon during the meeting held last December.

He stressed that this decision reflects the commitment of the eight countries to adopt a proactive and responsible approach aimed at ensuring the stability of the global oil market.

The quota set for Kuwait is 2.413 million barrels per day, rising from April to 2.421 million barrels per day, then gradually increasing to reach 2.548 million barrels per day by September 2026.

GCC sukuk issuance falls after record highs in 2024

Global sukuk issuance to decline in 2025 and 2026


Global long-term sovereign and supranational su-kuk issuance volumes will decline this year from exceptionally high levels in 2024 as the two largest government issuers curb issuance activity, not withstanding still high financing needs in most jurisdictions.

■ Sukuk issuance volumes to decline in 2025 and 2026. We expect government and supranational sukuk issuance to drop by nearly 20% to around \$92 billion in 2025 and contract further to less than \$90 billion in 2026. Saudi Arabia (Aa3 stable) will lead the decline because the government is unlikely to repeat its large liability management operations, which nearly doubled its issuance of sukuk in 2024. By contrast, we expect issuance to increase in Indonesia (Baa2 stable) and Turkiye (B1 positive) because of higher sukuk refinancing needs.

Saudi Arabia drove near-record high sukuk issuance volumes in 2024. Sovereign and supranational sukuk issuance increased by nearly 20% in 2024, reaching \$110.5 billion, the second highest after the all-time high in 2020. We estimate that the stock of outstanding long-term sovereign and supranational sukuk exceeded \$500 billion in 2024. The big jump in issuance during 2024 was mainly because of the Saudi Arabian government's decision to issue long-dated sukuk to refinance some nearer-term sukuk maturities. Other Gulf Cooperation Council (GCC) governments and Turkiye also increased issuance, partly because of higher sukuk refinancing needs and to take advantage of strong demand for Shariah-compliant assets from Islamic banks in the GCC region. Indonesia's issuance also increased, reflecting fiscal deterioration, while Malaysia's (A3 stable) issuance volumes declined in

plan that it will aim to finance most of its borrowing requirement outside the domestic sukuk market, which has been the source of most of the government's financing since the middle of 2017.

The share of domestic sukuk in the government's financing mix declined significantly during 2023-24, and the government has indicated that domestic sukuk will account for at most 25% of total financing during 2025, down from an average of 65% in 2019-24

The government expects that in 2025 most of its financing will be met from international bond issuances and other external borrowing such as syndicated loans.

Reducing reliance on domestic banks, which are the rincipal investors in the government's domestic Saudi riyal-denominated sukuk, probably reflects Saudi Arabia's desire to free up the local banks' lending capacity to be able to finance the country's large pipeline of economic diversification projects. Lower sovereign sukuk issuance over the next two years will also be driven by smaller sukuk repayment in 2025, and no repayments in 2026. The projected decline in the government's sukuk issuance means that in 2025 Saudi Arabia may lose its status as the largest long-term sovereign sukuk issuer, which it has held for seven of the past eight years. Malaysia's fiscal consolidation efforts will probably lead to a further reduction in the government's net financing need during 2025, which will weigh on the sukuk issuance outlook. We expect that the government's fiscal deficit will decline to 3.8% of GDP (\$18.2 billion) in 2025 and 3.4% of GDP (\$17.6 billion) in 2026 from an estimated 4.3% of GDP (\$18.4 billion) in 2024. The introduction of the Public Finance and Fiscal Responsibility Act, which aims to cut the fiscal deficit to 3% of GDP or less in the next three years, will reinforce the trend decline in Malaysia's sovereign sukuk, although sukuk issuance will remain a major source of fiscal deficit financing, accounting for around 50% on average during the past five years. We expect Indonesia's fiscal deficit to remain broadly stable as a share of GDP at around 2.6% in both 2025 and 2026, but increase in nominal terms to \$38.6 billion in 2025 and \$44 billion in 2026 from an estimated \$38.3 billion in 2024. This will support larger gross sukuk issuance, under the assumption that the government meets around 15% of its net financing need with sukuk issuances. The increase in issuance in 2025 will also be supported by an increase in scheduled sukuk repayments to \$16 billion from \$12 billion in 2024, which we expect to be refinanced through new sukuk issuance. As a result, we forecast that the government will issue \$22 billion of sukuk in 2025 and \$19 billion in 2026, compared with \$18 billion in 2024 and \$16 billion in 2023. In Turkiye, we expect sukuk issuance to increase gradually in the next two years, driven partly by the rise in scheduled sukuk repayments to \$3.9 billion in 2025 and \$7 billion in 2026, from \$3.5 billion in 2024. Increased sukuk issuance volumes will also be supported by more favourable investor sentiment toward Turkiye after the government's pivot to a more orthodox monetary policy framework since the 2023 elections. We forecast that the increasing share of sukuk in the government's total financing mix will broadly offset a narrowing of the fiscal deficit in 2025, reflecting the government's efforts to increase the share of Islamic finance to 15% of total banking assets in the short term. Sovereign sukuk issuances in the GCC excluding Saudi Arabia will probably decline in 2025-26 compared to the record-high issuance of nearly \$10 billion in 2024. This is mainly because of smaller domestic sukuk refinancing needs in Qatar (Aa2 stable) and Oman. We expect the government of Oman to continue to retire its external debt, including the \$1.5 billion international sukuk that matures later this year. Sovereign sukuk issuance out of the United Arab Emirates (UAE, Aa2 stable) will remain supported by the government of 4 4 March 2025 Sovereign & Supranational: Sovereign sukuk issuance to decline in 2025 from exceptional highs of 2024 Sharjah (Ba1 stable), which is the most regular GCC sukuk issuer after Saudi Arabia, and the federal government, which launched its local-currency sukuk issuance programme in 2023 with the aim of developing the domestic sukuk market. Among multilateral development banks (MDBs), we expect IsDB to continue to issue around \$4 billion to \$5 billion of sukuk each year. It will remain by far the largest and the most regular supranational issuer in the cross-border sukuk market.

Lower oil prices than we assume in our baseline fiscal projections for 2025 and 2026 would likely increase sukuk-issuing oil producers' government financing needs and lead to larger sovereign sukuk issuance volumes, as seen during 2020. Similarly, another large liability management exercise, like that undertaken by Saudi Arabia in 2024, could also increase sovereign sukuk issuance beyond what we currently project.

result of the government's domestic sukuk liability management operation. This exceeded \$17 billion and involved partial early redemptions of domestic sukuk maturing in 2024, 2025 and 2026, funded by issuance of new sukuk with longer maturities.

Qatar was the second-largest sovereign sukuk issuer in the GCC during 2024, with \$4.6 billion of domestic sukuk issuance, up from \$2.1 billion in 2023. The increase was driven by large \$3.5 billion domestic sukuk amortizations, which the government chose to chose to roll over by issuing new sukuk. Similarly, Bahrain's longterm sovereign sukuk issuance increased to \$2.2 billion in 2024, from only \$1 billion in 2023, as the government rolled over \$2 billion of scheduled sukuk repayments. By contrast, Oman decided not to refinance its maturing \$2 billion international sukuk with new external sukuk issuances, in line with its strategy of using fiscal surpluses to pay down external debt. Instead, it only refinanced domestic sukuk maturities to support the development of domestic debt capital markets and supply treasury assets for Oman's Islamic banks.

The UAE federal government also increased its sovereign issuance, doubling it to \$0.9 billion in 2024 from \$0.4 billion in 2023. This is partly because the federal government ramped up its dirham-denominated treasury sukuk issuance programme, which also aims to support domestic debt capital markets development. However, Sharjah remained the largest and most regular government sukuk issuer in the UAE in 2024, issuing \$1.3 billion of sukuk in the public markets.

In Indonesia, long-term sukuk issuance increased by 14% to \$18 billion in 2024 from around \$16 billion in 2023. This mainly reflects higher external sukuk issuance, which rose to \$5 billion in 2024, the largest annual international sukuk issuance on record, from \$2 billion in 2023, signalling improving external financ ing conditions. In Malaysia, gross long-term issuance declined by around 11% to \$19 billion in 2024 from \$21.4 billion in 2023, despite an increase in scheduled sukuk repayments to \$10.5 billion in 2024 from \$9.3 billion in 2023. Islamic T-bills issuance also contracted very significantly compared to 2023, contracting by more than 70%. This decline reflects the normalisation of sukuk issuance volumes following record high government sukuk issuance in 2023. It was also driven by the government's ongoing fiscal consolidation efforts, which reduced its net financing needs. We estimate that the fiscal deficit declined to 4.4% of GDP in 2024 from 5.0% of GDP in 2023. Turkiye's long-term sukuk issuance increased to around \$7.7 billion in 2024 from \$6.9 billion in 2023, reflecting more favourable market conditions and investor sentiment, as well as a \$3.5 billion sukuk redemption in 2024. The government of Turkiye has been a regular issuer in the international sukuk market since 2021, issuing \$2.5 billion in 2024. Pakistan remains locked out of the international capital markets, so did not issue any international sukuk in 2024 or 2023, following a \$1 billion seven-year issuance in 2022. However, its domestic sukuk issuance increased to \$7.3 billion in 2024 from \$6.3 billion in 2023, driven by the government's efforts to support the development of the local Islamic banking sector. Since December 2023, the government has been conducting regular Ijarah sukuk auctions on the Pakistan Stock Exchange, issuing both fixed- and variable-rental rate sukuk across one, three, five and 10-year maturities. Cross-border sukuk issuances stabilised in 2024, accounting for around 20% of total sovereign and supranational sukuk issuance Despite an increase in overall sukuk issuance volumes, cross-border gross sukuk issuance in the international capital markets declined slightly to \$20.4 billion in 2024 from \$20.8 billion in 2023, marking a stabilisation after last year's significant increase.

line with its narrowing fiscal deficit.

Cross-border sukuk issuance stabilised in 2024, accounting for around 20% of total sovereign and supranational sukuk issuance. Despite an increase in the overall sovereign and supranational sukuk issuance volumes, sukuk issuance in the international capital markets fell slightly to \$20.4 billion in 2024 from \$20.8 billion in 2023. Larger than usual issuances from Indonesia and Bahrain (B2 stable) were not enough to offset the absence of nontraditional sovereign issuers such as Egypt (Caa1 positive) and Philippines (Baa2 stable), both of which debuted in the international sukuk market in 2023. The Islamic Development Bank (IsDB, Aaa stable) remained the largest and most regular supranational sukuk issuer, accounting for 21% of all cross-border sukuk issuance in 2024.

Sukuk issuance volumes to decline in 2025 and 2026

Global sovereign long-term sukuk issuance volumes, which include all issuances by national governments and multilateral development banks (MDBs) with a tenor of more than one year, are set to decline from \$111 billion recorded in 2024, and are unlikely to return to this level for several years.1

We expect issuance activity in the sovereign longterm sukuk market to decline by nearly 20% to \$92 billion in 2025 and further to \$87 billion in 2026 (Exhibit 1). A key driver of our forecast is our expectation that the government of Saudi Arabia will not execute additional large liability management exercise, which significantly boosted overall 2024 issuance volumes. This expectation reflects the government's very modest sukuk repayment schedule over the next couple of years, with only around \$4 billion of sukuk maturing in 2025 and no sukuk maturing in 2026. Consequently, global issuance volumes will fall in 2025 despite our assumption that oil prices will ease to an average of around \$75 a barrel (bbl) for the Brent crude benchmark in 2025 from \$80/bbl in 2024, underpinning a deterioration in the fiscal positions of the oil-producing sovereign sukuk issuers, including Saudi Arabia, Bahrain and Oman (Ba1 positive).

Notwithstanding the expected deterioration in some oil producers' fiscal positions, the aggregate fiscal balance of the key sovereign sukuk issuers will remain broadly stable, albeit elevated, during the next two years. We expect the combined fiscal deficit, which is equivalent to the net financing need, will fall to \$159 billion in 2025 from an estimated \$168 billion in 2024, before increasing again slightly to \$164 billion in 2026.

Combined with a declining sukuk repayment schedule during 2025-26, broadly stable net financing needs of the key sukuk issuing governments support our view that global sovereign sukuk issuance volumes will contract in the next two years compared to the 2024 peak.

We expect country-specific factors to dampen issuance in 2025 and 2026, bringing back the trend of declining sovereign sukuk issuance that started in 2021, before it paused in 2024:

We expect Saudi Arabia's fiscal deficit to increase slightly to an average of \$34 billion in 2025 and 2026 from an estimated \$30 billion in 2024, driven by lower oil prices and higher budgetary spending related to the government's economic diversification agenda. However, gross sukuk issuance volumes will drop considerably. In addition to our expectation that the liability management exercise will not be repeated in 2025, the government announced in its 2025 annual borrowing

Another small boost to our issuance forecasts could come from new entrants into the global sovereign sukuk market. For example, the government of Algeria has recently introduced provisions to develop the legal and regulatory framework for the issuance of sovereign sukuk in its 2025 Finance Law. Egypt, which issued its first government sukuk in 2023, could also return to the cross-border sukuk market this year, taking advantage of improved market sentiment following the large UAE investment in 2024, which strengthened the government's external buffers. And in November 2024, the Ministry of Finance indicated that it may issue its first EGP-denominated sukuk in the first quarter of 2025. Separately, in November Nigeria's (Caa1 positive) finance minister suggested that his government may include a \$500 billion sukuk in its funding plan.

Shariah Standard 62 proposed in a draft form by the Accounting and Auditing Organization for Islamic Fi-nancial Institutions (AAOIFI) in late 2023 presents a medium-term risk for sovereign and supranational sukuk issuance trends. The standard, if implemented in the proposed form, would fundamentally change the risk profile and legal complexity of a typical sukuk issued by entities seeking to comply with the AAOIFI regulation. It would also limit demand for sukuk which does not comply with the new standard from investors which are regulated by the national authorities seeking to implement AAOIFI standards, such as in the UAE. We would therefore expect the implementation of the new Shariah standard to dampen cross-border sukuk issuance volumes as market participants take time to come up to speed with the new regulation and assess potential risks associated with new sukuk structures. Nevertheless, the timeline for the implementation and the final form of the new standard remain uncertain. We would also expect the national regulators to allow market participants enough time to adjust.

Saudi Arabia drove near-record high sukuk issuance volumes in 2024

Gross long-term sovereign and supranational sukuk issuance increased by 19% to a near-record high of \$111 billion in 2024 from \$93 billion in 2023. This increase was largely the result of exceptionally high issuance volumes from Saudi Arabia, which exceeded the previous record of 2020. We estimate that at the end of 2024, the stock of outstanding long-term sovereign and supranational sukuk exceeded \$500 billion.

In 2024, Saudi Arabia, Malaysia, Indonesia and Turkiye remained the four largest issuers of sovereign sukuk. Together, they account for 80% of total long-term gross sovereign sukuk issuance as well as 80% of total outstanding long-term sovereign sukuk as of the end of 2024.

At the end of 2024, Saudi Arabia's outstanding sukuk accounted for 67% of total general government debt, compared to 44% for Malaysia and 17% for Indonesia. Despite being one of the smaller sovereign issuers, the government of Sharjah has been one of the most regular participants in the sukuk market over the past decade, with sukuk and other Islamic finance instruments making up 60% of its total outstanding debt in 2024

In Saudi Arabia, sovereign sukuk issuance increased by 58% to \$44 billion in 2024, much more than the 2021-23 average of \$29.5 billion. Except for \$5 billion of dollar-denominated international sukuk, it was mostly issued in the domestic market through the established regular issuance programme. The exceptionally large sukuk issuance volumes in 2024 were the

Cross-border issuances, mostly in US dollars, accounted for nearly 20% of total gross sovereign and supranational sukuk issuance in 2024, about the same share as over the past 10 years.

Supranational issuances declined to \$4.6 billion in 2024 from \$5.1 billion in the previous year. The Islamic Development Bank and Islamic Corporation for the Development of the Private Sector (ICD, A2 stable) were the sole multilateral sukuk issuers in 2024. IsDB issued four euro-denominated sukuk during March-July, totalling around \$0.9 billion, and two US dollar-denominated sukuk in May and October, for a total value of \$3.3 billion. ICD issued a \$500 million five-year sukuk in February.

Increased international sukuk issuance by Indonesia and Bahrain more than offset lower issuance by the government of Saudi Arabia. The government of Indonesia issued \$5.1 billion of international sukuk in 2024 compared to \$2 in 2023. Bahrain issued \$2.2 billion in 2024 compared to \$1 billion in 2023. Meanwhile, Saudi Arabia's international issuance declined to \$5 billion from \$6 billion in 2023, although even this was significantly higher than \$1.8 billion on average during 2018-2022.

Last year was marked by an absence of nontraditional sukuk issuers in the international sukuk market, such as Egypt and the Philippines which raised \$1.5 billion and \$1 billion, respectively, by issuing their inaugural international sukuk during 2023.

Pay just 10% advance and block the 'gold rate'

Malabar Gold unveils 'gold rate' protection offer

Black women's long wait for absent men highlighted

Play reflects on Winnie Mandela's fight for freedom

JOHANNESBURG, March 5, (AP): A new play about anti-apartheid icon Winnie Madikizela-Mandela seeks to highlight the struggles of Black women in South Africa who had to wait years for their husbands' return from exile, prison or faraway work during decades of white minority rule.

The play about the late former wife of Nelson Mandela, South Africa's first Black president, is adapted from the novel "The Cry of Winnie Mandela" by Njabulo Ndebele. It explores themes of loneliness, infidelity and betrayal.

At the height of apartheid, Madikizela-Mandela was one of the most recognizable faces of South Africa's liberation struggle while her husband and other freedom fighters spent decades in prison. That meant constant harassment by police.

At one point, she was banished from her home in Soweto on the outskirts of Johannesburg and forcefully relocated to Brandfort, a small rural town she had never visited nearly 350 kilometers (217 miles) away

Even after she walked hand-in-hand with her newly freed husband in 1990 and raised her clenched fist, post-apartheid South Africa was tumultuous for her.

Madikizela-Mandela, who died in 2018 aged 81, was accused of kidnapping and murdering people she allegedly suspected of being police informants under apartheid. She also faced allegations of being unfaithful to Mandela during his 27 years in prison.

Those controversies ultimately led to her divorce from Mandela, while their African National Congress political party distanced itself from her.

Inspired

The isolation and humiliation inspired Ndebele to write about Madikizela-Mandela for South Africa's post-apartheid generations.

"How can they implicate Winnie in such horrendous events? She is the face of our struggle," Nde-bele's character, played by South African actor Les Nkosi, wonders as he describes his thoughts upon hearing the news of the ANC distancing itself. "The announcement invokes in me a moral anguish from which I'm unable to escape. Is she a savior or a be-

Film

trayer to us?"

A key scene addresses Madikizela-Mandela's ap-pearance before the Truth and Reconciliation Commission, a body formed to investigate human rights abuses during apartheid. She denied murder and kidnapping allegations and declined a request to apologize to families of alleged victims.

"I will not be the instrument that validates the politics of reconciliation, because the politics of reconciliation demands my annihilation. All of you have to reconcile not with me, but the meaning of me. The meaning of me is the constant search for the right thing to do," she says in a fictional monologue in the novel.

The play also reflects how the Mandelas' divorce proceedings played out in public, with intimidate details of their marriage and rumors of her extramarital affair

For the play's director, Momo Matsunyane, it was important to reflect the role of Black women in the struggle against apartheid who also had to run their households and raise children, often in their husbands' long absence.

iHeart, Drake settle dispute

HOUSTON, March 5, (AP) Texas-based iHeartMedia said it settled its legal dispute with Drake over Kendrick Lamar's dis track "Not Like Us" after demonstrating that it "did noth-

ing wrong." Drake had alleged in a legal petition filed in November that iHeartMedia received illegal payments from Universal Music Group to boost radio airplay

ly declined

to comment on the settlement, which was revealed last week in court documents. The media company released an updated statement Saturday.

"In exchange for documents that showed iHeart did nothing wrong, Drake agreed to drop his petition. No payments were made - by either one of us," the statement said.

A representative for Drake



disputed iHeart's statement Tuesday, saying the company "has not provided a single document as of yet to Drake, let alone any information that showed they did nothing wrong."

Petition

"This back and forth is silly. Drake dropped the petition. We did nothing wrong. End of story," iHeartMedia said in a statement late Tuesday.

In a court document filed Thursday in Bexar County, where San Antonio is located, attorneys for Drake said the rapper and iHeartMedia had "reached an amicable resolution of the dispute" but did not offer any other information.

The dismissal of iHeart-Media from the petition was done "with prejudice," meaning Drake would not be able to refile the petition against the company.

A hearing on a motion by UMG's lawyers to dismiss Drake's petition had been set for Wednesday but was changed to March 24, according to court records filed this week.

Alleges

Drake's petition in Texas also alleges UMG knew "the song itself, as well as its accompanying album art and music video, attacked the character of another one of UMG's most prominent artists, Drake, by falsely accusing him of being a sex offender.'

Besides the legal petition in Texas, Drake in January filed a defamation lawsuit in federal court in New York City against UMG over what he alleges are false allegations of pedophilia made in "Not Like Us." Lamar is not named in the lawsuit.

On Tuesday, a judge overseeing the defamation lawsuit rejected a request from UMG to delay a pretrial hearing and put a pause on discovery, which is the exchange of evidence between the two sides. UMG had sought the delay until a judge could hear its request to dismiss the case.

Drake's lawyers said in a statement that they were "pleased with the Court's decision to reject UMG's continued attempts to stall discovery - another clear sign that UMG cannot run from or bury the truth.'

UMG's lawyers did not immediately reply to a request for comment.

Deep-sea rescue thrills with tension

A true-life rescue drama in 'Last Breath'

LOS ANGELES, March 5, (AP): A routine deep-sea diving mission in the North Sea goes terribly wrong when a young diver is stranded some 300 feet below the surface in the new film "Last Breath." His umbilical cable has severed. The support vessel above is aimlessly drifting away from the site through violent, stormy waters. And the diver has only ten minutes of oxygen in his backup tank.

As if that wasn't enough, it's also a true story.

If merely reading this is giving you heart palpitations already, you can only imagine the white-knuckle experience of watching this all play out on the big screen. It's 40ish minutes of pure suspense and anxiety as the story shuffles between the man at the bottom of the ocean, Chris Lemons (Finn Cole), his fellow saturation divers (Woody Harrelson as Duncan and Simu Liu as Dave) in the diving bell below the waters who are unable to help and the crew in the support vessel above (including Cliff Curtis and Mark Bonnar) scrambling to get their systems back online and operational as the clock rapidly runs out. Ten minutes has never felt so short - and then it just gets worse as the clock starts counting up, showing Chris's time without oxygen.

At one point, Liu's character Dave, a no-nonsense, all-business diver says matter-of-factly at that it's a body recovery, not a rescue. Deep-sea saturation diving is a dangerous business,

described at the start of the film as the most dangerous job on earth. Chris tells his fiancé, in a short introduction, that it's no more dangerous than going to space. She replies that it's funny that he thinks that is comforting. The real incident happened in September 2012 - Dave, Dun-

can and Chris were just one team of divers sent to the ocean floor off the coast of Aberdeen, Scotland, to repair oil pipeline.

Dynamic

The seas were particularly rough that day, with winds up to 35 knots, common for the North Sea but also not what one might call safe. Chris and Dave were in the middle of their work when they heard the urgent calls to abort: The dynamic positioning system in the support vessel above had failed and they were in drift. Chris scrambled to maneuver out of the pipeline corridors, but his umbilical got caught. For a brief, awful moment he's the anchor to the ship above, but soon enough the cord snapped, and he was thrown back to the ocean floor in pitch black with no coms, no heat and very little hope for survival. News articles about the incident clock his backup oxygen supply as being closer to five or six minutes - perhaps the movie wanted to give the audience a little buffer.

If this sounds at all familiar, it may be because it was made into a documentary, also called "Last Breath" and released in 2019. While it was well-received, some true stories are just too gripping to exist solely in that form. It's not exactly a surprise that a narrative film was made as well. There's a good track record of recent complimentary adaptations - think Ron Howard's "13 Lives" and "The Rescue" about the Thai boys soccer team stuck in the cave.

This one was made by Alex Parkinson, the same director who co-directed the doc, and it's a well-executed narrative interpretation that doesn't get in its own way with padding. Harrelson gets to be the wise mentor who really doesn't want to lose someone on his last mission. Liu gets to flex his action muscles (literally and figuratively) in a modest but solid role. And they don't go out of their way to shoehorn in a villain - this is just a group of people trying their best to save a life.

The only real problem, if one can even call it that, is that it's so short. The film doesn't take liberties with stretching out the timeline much at all and after 93 minutes, the whole thing is over. It feels strange to want a movie to be longer, but in the case of "Last Breath" I was both desperate for it to end, for anxiety reasons, and also wanting more.

"Last Breath," a Focus Features released in theaters Friday, is rated PG-13 Motion Picture Association for "brief strong language." Running time: 93 minutes. Three stars out of four.

NEW YORK: A cybercrime crew stole then resold more than 900 digital tickets to Taylor Swift concerts and other pricey events on Stub-Hub, according to prosecutors in New York.

The international scam involved people working in Jamaica for a firm contracted by the online ticket marketplace, Queens District Attorney Melinda Katz said Monday. bThe contractors stole the URLs of tickets purchased on StubHub and emailed them to others in New York, who then downloaded and resold them on StubHub at exorbitant prices, she said.

The crew raked in more than \$600,000 in profits over roughly a year between June 2022 and July 2023, according to prosecutors.

The majority of the stolen tickets were for Swift's Eras Tour, but the thieves also boosted ones for Adele and Ed Sheeran concerts, NBA games and the U.S. Open Tennis Championships. bKatz added that investigators are still determining the extent of the operation, including other potential co-conspirators.

Two of those involved, Tyrone Rose and Shamara Simmons, were arrested and charged

"Based on a thorough review of the evidence, I've directed the Office of Statewide Prosecution to execute search warrants and issue subpoenas in the now-active criminal investigation into the Tate brothers," Uthmeier said.

After the Tates landed in Fort Lauderdale on Thursday, Gov. Ron DeSantis told reporters that the brothers weren't welcome in Florida and that he would have the attorney general examine whether the state may have any jurisdiction over their alleged crimes.

During an appearance Monday on the PPD Podcast, Andrew Tate said the governor was caving to media pressure. Tate said he has a US passport and a right to visit his home country. He said he has broken no laws and that he has never even been tried, let alone convicted, of a crime. (AP)

The Tates, who are dual US-British citizens, were arrested in late 2022 and formally indicted last year in Romania on charges they participated in a criminal ring that lured women to that country, where they were sexually exploited. Andrew Tate was also charged with rape. They denv the allegations.

Andrew Tate, 38, is a former professional kickboxer and self-described misogynist who is a hugely successful social media figure, attracting millions of followers, many of them young men and schoolchildren drawn in by the luxurious lifestyle the influencer projects online. (AP)

Chinese architect honored for celebrating ordinary people's lives

Liu Jiakun wins Pritzker Prize for people-centered design

NEW YORK, March 5, (AP): The annual Pritzker Architecture Prize has been awarded to Liu Jiakun of China, who earned the field's highest honor for "affirming architecture that celebrates the lives of ordinary citizens," organizers announced Tuesday

Liu, 68, becomes the 54th laureate of the prize, considered akin to a Nobel in the field of architecture. In an interview with The Associated Press in his office in Chengdu in China's southwestern Sichuan region, the architect said he had a simple definition of his profession:

"To simplify, the task of architects is to provide a better living environ-ment for human beings," he said, speaking in Mandarin. "First of all, you do something that is functional. But if it is just like that, it cannot be called architecture. (So) you have to provide poetry."

Liu is known for creating public areas in highly populated cities where there is little public space, "forging a positive relationship between density and open space," a Pritzker statement said.

The architect "upholds the transcendent power of the built environment through the harmonizing of cultural, historical, emotional and

social dimensions, using architecture to forge community, inspire compassion and elevate the human spirit," the statement said.

Among his 30 or so projects, which range from academic institutions to commercial buildings to civic spaces, organizers cited in particular his 2015 West Village in Chengdu, which spans a block. The

five-story project includes a perimeter of pathways for cyclists and pedestrians around "its own vibrant city of cultural, athletic, recreational, office and business activities within, while allowing the public to view through to the surrounding natural and built environments."

They also noted the Sichuan Fine Arts Institute Department of Sculpture in Chongqing, which they said displays an alternate solution to maximizing space, "with upper levels protruding outward to extend the square footage of a narrow footprint.

Liu was born in 1956 in Chengdu and sent at age 17, during the Cultural Revolution, to labor on a farm in the countryside. He has said life felt inconsequential - until he was accepted to architecture school in Chongqing, where he "suddenly re-alized my own life was important."

Interview

In the interview Sunday in his office in Chengdu, Liu said the speed of change in China during his early adulthood was "very fast, and it was turning things upside down. Even until now, sometimes I feel like I have lived several lifetimes.

Liu established his practice, Jiakun Architects, in 1999. He said he is not one of those architects who likes to have a strongly recognizable visual style. Rather, Liu said, he pays more attention to method and strategy.

"Many architects use a strong personal style and form to gain a foot-hold in the world," Liu said. "No matter where it is, people can tell immediately that it is his or her work with a very strong symbolism. But I am not such a kind of architect.

"I don't want to have a very clear or obvious style that can be recognized as mine just at a glance," he said. "I take a more methodological and strategic approach. I hope that when I go to a specific place, I can use my methodology and strategy to adapt to local conditions. I like to fully understand the place, and then look for resources, problems ... and then distill and refine, and finally turn (this) into my work."

Liu also said he tries to balance his country's artistic and architectural heritage with the realities of modern technology

"I think China's traditional architecture is of course brilliant and very classic," he said, "but it is a product of its time.

He said he hopes to deeply understand "the thematic part of tradition that can survive," and then express it with contemporary technology and language. In that way, he said, "tradition can be used as a core ... but the presentation of your work is contemporary."

Liu said he also seeks to balance commercial imperatives with civic concerns

"The rapid development of cities

nowadays is basically driven by capital. It is natural for capital to pursue profits," he said. But he added: "You have to leave the public the space they deserve. Only in this way can the development of a city be positive and healthy, rather than being completely high-density, where people live in drawers and boxes ... without even a place to go and no space for communication.'

The Pritzker Architecture Prize was established in 1979 by the late entrepreneur Jay A. Pritzker and his wife, Cindy. Winners receive a \$100,000 grant and a bronze medallion.

Asked if he thought the honor would impact his life, Liu replied: "I have thought about it. But I want to maintain normalcy ... I don't want to become nervous about everything. Of course, it has its advantages. I will definitely not need to promote myself too much. But will it also make me better at work? Not necessarily. Excessive expectations may become a pressure.

He had another concern, too.

"And will it make me too busy and prevent me from working more attentively?" he pondered. "I hope to keep the normalcy and the freedom, as well as calmness."

Stuck astronauts near Earth return

CAPE CANAVERAL, Fla., March 5, (AP): NASA's two stuck astronauts are just a few weeks away from finally returning to Earth after nine months in space.

Butch Wilmore and Suni Williams have to wait until their replacements arrive at the International Space Station next week before they can check out later this month. They'll be joined on their SpaceX ride home by two as-

tronauts who launched by themselves in September alongside two empty seats.

During a news conference Tuesday, Wilmore said that while politics is part of life, it did not play into his and Williams' return, moved up a cou-ple weeks thanks to a change in SpaceX capsules. President Don-ald Trump and SpaceX's Elon Musk said at the end of January that they wanted to accelerate the astronauts' return, blaming the previous administration.

What if extreme heat not only leaves you feeling exhausted but actually makes you age faster?

Scientists already know that extreme heat increases the risk of heat stroke, cardiovascular disease, kidney dysfunction and even death. I see these effects often in my work as a researcher studying how environmental stressors influence the aging process. But until now, little research has explored how heat affects biological aging: the gradual deterioration of cells and tissues that increases the risk of age-related diseases.

New research my team and I published in the journal Science Advances suggests that long-term exposure to extreme heat may speed up biological aging at the molecular level, raising concerns about the long-term health risks posed by a warming climate.

My colleagues and I examined blood samples from over 3,600 older adults across the United States. We measured their biological age using epigenetic clocks, which capture DNA modification patterns - methylation -

predict age-related disease risk and lifespan.

shown that extreme heat can trigger what's known as a maladaptive epigenetic memory, or lasting changes in DNA methylation patterns. Studies indicate that a single episode of extreme heat stress can cause long-term shifts in DNA methylation across different tissue types in mice. To test the effects of heat stress on people, we linked epigenetic clock data to climate records to assess whether people living in hotter environments exhibited faster biological aging.

Biological

We found that older adults residing in areas with frequent very hot days showed significantly faster epigenetic aging compared with those living in cooler regions. For example, participants living in locations with at least 140 extreme heat days per year - clas-sified as days when the heat index exceeded 90 degrees Fahrenheit (32.33 degrees Celcius) - experienced up to 14 months of additional biological aging compared with those in areas with fewer than 10 such days annually.

This link between biological age and extreme heat remained even after accounting for a wide range of individual and community factors such as physical activity levels and socioeconomic status. This means that even among similar lifestyles, the living in hotter environments may still be aging faster at the biological level. Even more surprising was the magnitude of the effect - extreme heat has a comparable impact on speeding up aging as smoking and heavy alcohol consumption. This suggests that heat exposure may be silently accelerating

aging, at a level on par with other major known environmental and lifestyle stressors

While our study sheds light on the connection between heat and biological aging, many unanswered questions remain. It's important to clarify that our findings don't mean every additional year in extreme heat translates directly to 14 extra months of biological aging. Instead, our research reflects population-level differences between groups based on their local heat exposure. In other words, we took a snapshot of whole populations at a moment in time; it wasn't designed to look at effects on individual people.

Our study also doesn't fully capture all the ways people might protect themselves from extreme heat. Factors such as access to air conditioning, time spent outdoors and occupational exposure all play a role in shaping personal heat exposure and its effects. Some individuals may be more resilient, while others may face greater risks due to preexisting health conditions or soioeconomic barriers. This is an area where more research is needed.

What is clear, however, is that extreme heat is more than just an immediate health hazard - it may be silently accelerating the aging process, with long-term consequences for public health.

Older adults are especially vulnerable because aging reduces the body's ability to regulate temperature effectively. Many

older individuals also take medications such as beta-blockers and diuretics that can impair their heat tolerance, making it even harder for their bodies to cope with high temperatures. So even moderately hot days, such as those reaching 80 degrees Fahrenheit (26.67 degrees Celcius), can pose health risks for older adults. (AP)

Jordan evacuates 29 kids from Gaza for treatment

AMMAN, March 5, (Xinhua): A total of 29 Gaza children along with their families were evacuated to Jordan on Tuesday, the first batch of the 2,000 children who will receive medical treatment in the Kingdom.

The Jordanian Armed Forces said the evacuation was coordinated by the army, the World Health Organization,

and the Health Ministry as part of the Jordanian medical corridor initiative. During a press conference, Mili-

tary Media Director Brigadier General Mustafa Al-Hiyari said that four children were evacuated via helicopters from the Royal Jordanian Air Force through the Marka Military Airport, and 25 children were evacuated via land in ambulances through the King Hussein Bridge, also known as the Allenby Bridge.

According to Al-Hiyari, the total number of patients treated in Jordan's field hospitals in Gaza and the West Bank since the beginning of the Hamas-Israel conflict has exceeded half a million.

Colossal made a splash in 2021 when it unveiled an ambitious plan to revive the woolly mammoth and later the dodo bird. Since then, the company has focused on identifying key traits of extinct animals by studying ancient DNA, with a goal to genetically "en-gineer them into living animals," said CEO Ben Lamm.

Outside scientists have mixed views about whether this strategy will be helpful for conservation.

You're not actually resurrecting anything - you're not bringing back the ancient past," said Christopher Preston, a wildlife and environment expert at the University of Montana, who was not involved in the research.

On Tuesday, Colossal announced that its scientists have simultaneously edited seven genes in mice embryos to create mice with long, thick, woolly new technologies like CRISPR "make it a lot more efficient and easier," said Lynch.

The Colossal scientists reviewed DNA databases of mouse genes to identify genes related to hair texture and fat metabolism. Each of these genetic variations are "present already in some living mice," said Colossal's chief scientist Beth Shapiro, but "we put them all together in a single mouse."

They picked the two traits because these mutations are likely related to cold tolerance - a quality that woolly mammoths must have had to survive on the prehistoric Arctic steppe.

Colossal said it focused on mice first to confirm if the process works before potentially moving on to edit the embryos of Asian elephants, the closest living relatives to woolly mammoths.

LeBron scores 34 after historic 50,000th point

Pacers recover from blown lead, close out Rockets

LOS ANGELES, March 5, (AP): LeBron James finished with 34 points and became the first player to score 50,000 combined points in the regular season and playoffs, and the Los Angeles Lakers extended their longest winning streak in four years to seven games with a 136-115 victory over the New Orleans Pelicans on Tuesday night.

Luka Doncic had 30 points, 15 assists and eight rebounds for the Lakers, who have won 17 of 20 to move into second place in the Western Conference at 39-21. Jaxson Hayes had a season-high 19 points and 10 rebounds as Los Angeles won its second straight without injured starters Austin Reaves and Rui Hachimura.

Zion Williamson scored 37 points for the 14th-place Pelicans, who went 2-2 on an encouraging road trip. Trey Murphy III added 19 points.

James surpassed his latest milestone with a 3-pointer early in the first quarter. Lakers fans gave a standing ova-tion moments later to James, who acknowledged it with a wave of his hand

Trailblazing Olympic refugee boxer Cindy Ngamba set for a pro debut

LONDON, March 5, (AP): Something stood dy Ngamba as she glanced arour

MILAN, March 5, (AP): Met Gala chair, co-producer on a Brad Pitt movie, activist, and now Ferrari driver.

Lewis Hamilton's impact stretches far beyond Formula 1 and his quest to win a record-breaking eighth world title with his new team.

The partnership of F1's biggest celebrity - and only Black driver - with its biggest brand reaches people who don't consider themselves F1 fans, and may not even have watched a race.

In some respects, Hamilton's move is already a marketing triumph. He won't race for Ferrari until next week in Australia, ending 13 months of hype since he announced his decision to leave Mercedes.

"Obviously the commercial success and the success for Ferrari's brand has been unprecedented." Michael E. Sawyer, author of an upcoming biography of Hamilton, "Sir Lewis," told The Associated Press. "It just makes the brand that much more iconic. It's always been about pushing boundaries.

In an interview with Time last month, Hamilton said he's thought about soccer racism in Italy in the context of joining Ferrari. "I'm not going to lie, it definitely crossed my mind when I was thinking about my decision," he said.

"Like in so many things, it's often such a small group of people that set that trend for many. I don't think that it's going to be a problem." One way Hamilton has already endeared himself to

Ngamba had arrived in Britain at age 11 her father and siblings live here, too - in Bolton, just north of Manchester, and set about learning English and trying to fit in. She picked up boxing at age 15, and it became an escape from the stress of worrying about her residency status.

She described being arrested as a teenager while checking in at an immigration center in Manchester.

"My case was still pending. I applied and they rejected it. When they reject your case, you have to go and re-apply again. I was in a situation where even though I was re-applying every time, they could have arrested me at any moment," she said. "I visualized that they could arrest me in the street or in my house, in school or with my friends. I never knew it was going to be at an immigration center where I usually (went) every weekend.'

Worried she would be deported, she thought to herself: "'I have no one in Cameroon, no family in Cameroon. Who is going to take care of me?"

She was held overnight at a detention fa-

cility in London before being released.

Her progress in the boxing ring - Ngamba was an England amateur champion at three different weights - attracted the attention of Britain's elite development program. Ngamba was brought in to spar the likes of Jonas, Price and others in hopes that she would eventually compete for Britain.

Ngamba, one of the flagbearers for the Olympic refugee team at the opening ceremony in Paris, is still treated as one of their own at "GB Boxing." After the Olympics, her name was added to the wall of fame at the English Institute of Sport in Sheffield, and she joined British Olympians at a Buckingham Palace reception where she meet King Charles III.

The main attraction is a welterweight clash of generations with 40-year-old Natasha Jonas facing 30-year-old Lauren Price.

Both are former Olympians. Welsh boxer Price (8-0) won a gold medal for Britain at the Tokyo Olympics in 2021. She is the WBA champion.

Currently leading the Zain Premier League, the "Whites" are enjoying a period of stability and are on course for their 20th league title and fourth consecutive championship. Despite defeating Al-Tadamon 3-0 in their only meeting this season, Kuwait remains cautious, recalling last season's Amir Cup quarter-final exit at the hands of Al-Tadamon.

Meanwhile, Al-Tadamon aims to continue its impressive run this season and hopes to replicate its past success in knocking Kuwait out of cup competitions

Both Sulaibikhat and Khaitan enter this clash with equal chances of advancing, with each side eager to make a deep run in the tournament.

Real Madrid struck early against Atletico, with Rodrygo scoring in the third minute after a pass from Fede Valverde. The forward cut inside and curled a shot into the far post.

Vinicius Jr had chances to extend Real's lead but was denied by Jose Gimenez and Jan Oblak. Atletico equalized through Julian Alvarez, who beat Eduardo Camavinga and finished with a precise shot past Thibaut Courtois.

Despite Atletico's strong start to the second half, Real Madrid regained the lead in the 54th minute when Brahim Diaz scored with a low shot from outside the area.

Aston Villa's win against Club Brugge saw Leon Bailey open the scoring in the third minute with a powerful finish. Maxim De Cuyper quickly equalized for the Belgian side, but Villa took control when Brandon Mechele scored an own goal. Marco Asensio added a third from the penalty spot to give Villa a commanding lead.

Arsenal made an emphatic statement in Eindhoven. Jurrien Timber's header



from Declan Rice's free kick put them ahead in the 18th minute. Ethan Nwaneri doubled the lead just three minutes later with a left-foot shot.

Mateta needed lengthy medical treatment before he was stretchered off the field wearing a neck brace and taken to hospital. Palace said he needed "specialist treatment and 25 stitches to a severe laceration to his left ear." Palace won the game 3-1 for a place in the FA Cup quarterfinals.

Mateta, Palace's top scorer this season, has said he hopes to be back in action "very soon." (AP)
