This girl is not the only one who lived through the long suffering of deprivation, as there are thousands who were born and educated in Kuwait, and lived all their lives here but eventually find themselves stranded because there are some who refuse to recognize their humanity in the country of humanity!

Isn't this the slogan that we sang before the world, while it looks at us with a different eye because we did not grant the legitimate rights to this group?

All that Narjes Ahmed dreams of is to serve the country in which she lived, like any person who seeks to return the favor to those who embraced it.

However, there are those who deliberately prevent this, because the complex of privileges controls his behavior and his decision, as if the life he is living makes him believe that he is living in the Garden of Eden, and he will not allow anyone to share it with him.

In this regard, I remembered the story of a British doctor in 1920. The Medical Association in England held a graduation ceremony for a batch of new doctors. grant him a cure.' The narrator had hardly finished speaking when the Prime Minister David Lloyd George jumped from his seat and went to the podium, saying, "Mr Captain, allow me to kiss your hand. For twenty years I have been looking for you, as I am that child you mentioned in your speech.'

He then said to the audience, "May my mother be happy in her final resting place, and be content; for her only commandment to me was that I should find you and repay you for the favor you had done to us in time of our poverty. You saved my life.'

I don't know, but isn't it possible that Naries Ahmed could heal one of those who struggle to deprive her of the opportunity to study what she wants?

In all countries of the world, governments work to benefit from creative people, and even entice them to come to them, because they realize that these are the ones who write their true history with creativity.

The United States has tens of millions of immigrants to it, and it benefits from them and grants them its nationality. The same happens in Australia, Britain, France, and other countries, which are not controlled by the complex of nationality and the purity of national identity.

Kuwait, on the contrary, educates people who do not know any other homeland, and then expels them, based on the fear of asking them for a plot of land and a house. We must bear in mind

KUWAIT CITY, July 4: The National Assembly Secretariat General issued a statement, denying the allegation posted on some Twitter accounts about the cancellation of the sessions slated for July 11-13, 2023.

The Secretariat affirmed that the abovementioned sessions will push through.

Meanwhile, MPs Muhammad Al-Regaib, Khalid Al-Tamar, Ahmed Lari, Jarrah Al-Fawzan and Fahd Al- Masoud have submitted a proposal to allocate two hours of the upcoming session for deliberations on the recent price hikes.

MP Osama Al-Shaheen sent a letter to the Assembly on assigning the Foreign Affairs Committee to follow up the Kuwaiti-Iranian dispute over the Durra offshore oil field. He voiced objection to the Iranian activities, stressing that Durra field is located in Kuwaiti territorial waters.

He hailed the prompt response of the ministries of Foreign Affairs and Oil regarding the issue, adding that the people of Kuwait and the lawmakers are committed to protecting the sovereignty of the nation by monitoring the government's steps in

MPs Muhammad Hayef Al-Mutairi, Adel Al- Damkhi, Mubarak Al-Tasha and Hamad Al- Obaid submitted a bill about the punishment for those convicted of practicing black magic —

10 years imprisonment and KD 10,000 fine. According to the bill, the death penalty will be imposed in

case the magic leads to committing crimes punishable by death. A total of 37 MPs have proposed allocating three hours of the session slated for July 11 to deliberate on the country's official stand regarding the burning of a copy of the Holy Quran in Sweden.

MP Majed Al-Mutairi submitted a bill on establishing Nawaf Al-Ahmad University for Applied Sciences. The bill states that the College of Basic Education at the Public Authority for Applied Education and Training (PAAET) will be the headquarters of the university

MP Meteb Al-Ra'athan Al-Anzi criticized the decision of the

KUWAIT CITY: Kuwait has handed Egypt's ambassador Osama Shaltout a note of protest urging immediate legal action over footage on social media showing the Kuwaiti flag being set on fire, the foreign ministry said on Tuesday.

Kuwait's embassy in Cairo carried out a similar measure calling for the perpetrators behind the incident to be brought to justice in a way that is "reflective of the solidity of bilateral ties," said a ministry statement. (KUNA)

ANKARA: Turkey's foreign minister said Tuesday that Swedish authorities' failure to prevent Quran-burning protests in the country is raising security concerns and questions about Sweden's credentials for possible NATO membership.

But **Hakan Fidan** said Turkey would still ap-

prove Sweden's membership in the military alliance if Stockholm "completes its homework" and presses ahead with efforts to address Turkey's concerns. (AP)

ANKARA: Egypt and Turkey took a further step toward restoring full diplomatic ties on Tuesday by dispatching ambassadors for the first time in years, the latest step in the reconciliation between the two regional powers.

In a joint statement, the two countries announced the appointment of Salih Mutlu Sen as Turkish ambassador to Cairo and of Amr El**hamamy** as the Egyptian ambassador to Ankara.

"This step aims to establish normal relations between the two countries once again and demonstrates their mutual determination to work towards enhancing their bilateral relations for the best in-terest of both the Turkish and Egyptian peoples," the statement said. (AP)

**BEIRUT:** The U.N. peacekeeping force on the **Lebanon-Israel** border said Monday its commander is in contact with officials in both countries over tensions regarding two tents set up by the militant Hezbollah group last month.

Israel filed a complaint with the United Nations in June claiming that Hezbollah had set up tents several dozen meters (yards) inside of Israeli territory. (AP)

**PARIS:** France has returned 35 people - 10 women and 25 minors - from a sprawling camp in northeast Syria housing thousands of people

linked to Islamic State extremists.

Al-Hol Camp - named after a town near the Iraqi border - holds about 51,000 people, including many widows, wives and children of Islamic State fighters Iraqis make up nearly half the population, but a sizeable minority are from outside the **Middle East**. (AP) 

THE HAGUE: The global chemical weapons watchdog said Tuesday it found no evidence to support a claim by Syria that its forces were attacked using toxic gas in 2017.

The Organization for the Prohibition of Chemical Weapons said that its fact-finding mission concluded that "there are no reasonable grounds to determine that chemicals were used as a weapon' in two incidents in July and August 2017 in Massasneh, a village in the central province of Hama.

Syria asked the OPCW to investigate after reporting a "mortar attack with poisonous gas" on its army in the town in fighting with rebels. (AP)

LONDON: UK Prime Minister Rishi Sunak hosted Crown Prince Salman Bin Hamad Al Khalifa, Prime Minister of Bahrain, at Downing Street

Monday for a bilateral meeting.

The leaders welcomed the signing of a new Strategic Investment and Collaboration Partnership today between the UK and Bahrain, said Sunak's office in a statement. The agreement aims to facilitate additional investment of more than GBP one billion into the UK, support the diversification of Bahrain's economy and drive greater cooperation between both countries in clean technology, business services and manufacturing. ### Palestinian wounds eight in Tel Aviv

KUWAIT CITY, July 4, (Agencies): The State of Kuwait strongly condemns the Israeli occupation forces' aggression on a refugee camp in the West Bank's city of Jenin, which resulted in martyrdom and injury of many Palestinians, the foreign ministry said Tuesday.

Kuwait categorically rejected this "blatant escalation and ongoing assaults carried out by the occupation forces against the Palestinian people, which represent a new series of their systematic violations of international humanitarian law and international agreements," the ministry added in a statement.

Kuwait, it said, called anew on the international community and UN Security Council to intervene, and live up to their political, legal and humanitarian responsibilities to stop this aggression, and to provide international protection for the Palestinian people in line with the international law.

The Arab League extraordinary session at the level of permanent delegates kicked off Tuesday, at the request of Palestine, to discuss the Arab movement to confront the continuous Israeli aggression on the city of Jenin.

Egypt's permanent representative to the Arab League, Chairman of the current session, Mohammad Orfy, affirmed in his speech that the brutal killing taking place in Jenin, using the Israeli war machine, would reduce to a large extent the chances of reviving the peace process.

He also added that the practices of the Israeli occupation in Jenin are a clear and explicit "violation of international law" and international legitimacy and hinder the efforts exerted to achieve the necessary calm and settlement for the same purpose that the peoples of the region and the world aspire to.

Orfy said that what is happening in Jenin is somehow linked to the continuous violations of Al-Aqsa Mosque, which are being subjected to at an accelerating pace, under public directives, and not only in disguise, by

For his part, Jordan's delegate to the League of Arab States, Amjad Al-Adayleh, affirmed the "total rejection" of all the repeated Israeli aggression and condemnable crimes committed against the Palestinian people without the slightest regard for humanitarian standards and international legal charters and constants.

He also stressed the need to stop the Israeli attacks on the occupied Palestinian territories, stop the continuous incursions into Palestinian cities, protect them from repeated attacks, and provide protection for the Palestinian people.

In latest development, a Hamas militant drove his car into a crowded bus stop in Tel Aviv on Tuesday and began stabbing people, wounding eight in an attack praised by Palestinian militant groups as a response to Israel's ongoing military operation in the occupied

Police chief Kobi Shabtai told reporters that an armed civilian shot and killed the as-

The attack came as Israeli troops pressed ahead with their hunt for Palestinian militants and weapons in a West Bank refugee camp Tuesday, after military bulldozers tore through alleys and thousands of residents fled to safety. The two-day Palestinian death toll rose to 10.

The large-scale raid of the Jenin camp, which began Monday, is one of the most intense military operations in the occupied West Bank in nearly two decades. It bore hallmarks of Israeli military tactics during the second Palestinian uprising in the early 2000s and came as Prime Minister Benjamin Netanyahu faces growing pressure from his ultranationalist political allies for a tough response to recent attacks on Israeli settlers, including a shooting last month that killed four people.

Meanwhile, the Palestinian Health Ministry said Tuesday that the two-day death toll rose to 10, with two more deaths reported overnight. The Israeli military has claimed all were militants, but did not provide details.

During Tuesday's operations, the military said it had seized weapons and demolished tunnels beneath a mosque in the Jenin refugee

A spokesman for the Israeli military, Rear Adm. Daniel Hagari, said Monday that Israel

KUWAIT CITY, July 4: The Minister of Foreign Affairs Sheikh Salem Al-Abdullah held a session of official talks with the Minister of Foreign Affairs and European Affairs of the French Republic Catherine Colonna within the framework of the official visit that he and the accompanying delegation are making to the capital, Paris, reports

According to a statement issued by the Ministry of Foreign Affairs, the minister, at the outset of the meeting, conveyed regards of the political

leadership in the State of Kuwait to the French Republic and its wishes for continued growth, progress and prosperity for France and its friendly people.

Sheikh Salem also expressed his deep pride in the close relations between the two friendly countries and the advancement and development they have reached in all fields.

Catherine Colonna He praised the prosperity and continuous progress witnessed as a result

of the bilateral cooperation between the State of Kuwait and France at all levels. He also praised the distinguished level of cooperation between the two friendly countries in the humanitarian and joint development fields. The ministry explained that the session of of-

ficial talks dealt with all aspects of the close historical relations that bind the two countries, the frameworks for strengthening and developing them at various levels, and the need for introducing areas of bilateral cooperation to new horizons that are in the interest of the two countries and

The issue of exempting Kuwaiti citizens from

the Schengen visa topped the topics of the official consultations that took place recently, and the joint efforts towards mobilizing European support to obtain the full exemption for Kuwaiti nationals, and discussing future entitlements in this frame-

In this regard, the French Foreign Minister expressed her country's position in support of exempting Kuwaiti citizens from the Schengen visa, and the positive impact of this file in maximizing common and inter-related interests at various

On the other hand, the French minister expressed her praise for the high level of cooperation between the State of Kuwait and France at all levels, and her aspiration to continue the pattern of this strong cooperation between the two countries and to elevate it to broader and more comprehensive horizons and dimensions.

She praised the wisdom of the State of Kuwait, its balanced foreign policy, its efforts in consolidating the pillars of maintaining security and peace in the region, and its principled and firm stances in international forums.



## 19 questions for charities

The Ministry of Social Affairs, the body that monitors the activities of charity associations, has submitted 19 questions to the boards of directors of these associations and foundations, all of which relate to the measures it follows in combating money laundering

and terrorist financing. minis-The try also asked to know about its projects and methods of collecting and disbursing the money it collects in the form donations. the pursuit

of the ministry, or rather the desire of external, international parties, to confront the crimes of money laundering and terrorist financing, and the need to expand the use of automated systems, which limit, as much as possible, from human intervention.

It was clear from the questions that they depend mainly on knowledge of the approved procedures related to combating money laundering and terrorist financing crimes, the financial powers of the various job grades in the association, the previous internal violations of the er tivities and projects licensed at home or abroad, in addition to the number of Knet devices used and electronic donation devices, and how to transfer money, whether through a company or an employee authorized by the associa-

The ministry emphasized that these measures come within the framework of the efforts of government agencies to prepare for the international review process, which awaits Kuwait next November, from the Middle East and North Africa Financial Action Task Force (MENAFATF), to assess its experience in combating money launder-

ing and terrorist financing. The well-known charity evaluation form also includes questions not only about financing terrorism, but also about the extent to which there are approved organizational structures for associations and foundations, financial and administrative regulations regulating work, and a clear guide to performance governance, in addition to the extent to which there is a clear guide or list of financial authorities and powers for various job grades.

The association or the foundation, the number of monthly meetings of its boards of directors, the availability of printed hard copies of these minutes, the methods of collecting donations and transferring funds, the limits of the powers of any member of the board of directors of the association or the foundation in any supervisory positions in the country, the number of bank accounts approved for the association, and the financial powers and powers to its employees.

By answering questions, checking the monthly or quarterly trial balance of the association or foundation, and the presence of an internal audit department, it is possible to find out if the association has special risks that deserve attention!

What the international authorities do not know, or know, is that "all" of these charities and foundations, with the exception of four or five out of 50, are structures affiliated with two religious political parties, or run by those who strongly sympathize with them, as the state is today almost in the grip of the Muslim Brotherhood.

It is natural to assume that the ministry will not be able to impose what it wants on it, especially with regard to its

vague answers. Most of the boards of directors of these politicized charities have gained extensive experience over a period of nearly a hundred years, in how to dodge, and not disclose everything, as this is not in their interest, as a large part of their operations is confidential.

The real thing is to take money from the well-to-do, or those looking for a wage, and hand it over to the person in need, the sick, the needy, or the incapacitated. Its role is more complex than that, and the evidence is the complexity of its financial operations, the multiplicity of its associations and branches, despite the strong similarity in its objectives, and its refusal to disclose the sources of its funds or publish their budgets, or what the "in charge of them" get in terms of commissions or percentages of money they receive as donations, which are in the tens of millions, after it was once in the hundreds of millions!

This deliberate obscurity is the biggest evidence that there are many things that most of these associations seek to cover up.

## Kuwait, Hungary FMs discuss 'Schengen' waiver for citizens

KUWAIT CITY, July 4, (KUNA): Kuwait's Minister of Foreign Affairs Sheikh Salem Abdullah Al-Jaber Al-Sabah discussed the issue of Schengen visa waiver for Kuwaiti nationals with his Hungarian

In a joint press conference on Tuesday with Hungarian Minister of Foreign Affairs and Trade Peter Szijjarto in the capital Budapest, Sheikh Salem expressed his gratitude to Hungary for its support to the

Kuwaiti case. A statement issued by the Foreign Ministry mentioned that Sheikh Salem's visit to Hungary comes at a time when the two countries are celebrating 59 years of diplomatic ties.

Regional and international issues of common interest were discussed during the meeting, with the Ukrainian crisis at the helm. The Kuwaiti top diplomat reasserted Kuwait's firm belief in peaceful resolution of conflicts, and that he hopes for Russia and Ukraine to meet at the negotiations table.

Kuwait is a main ally to the international anti-terrorism coalition, stressed the Foreign Minister presenting the state's positive role in combating radicalism.

The minister held Monday an official negotiations session with Hungarian counterpart where the two discussed the various dimensions of the sturdy bilateral relations tying the two nations and modes of pushing these relations to further developments.

The visit encompassed signing of a Memorandum of Understanding on tour-

The issue of Schengen visa waiver for Kuwaiti nationals took precedent at the talks where Hungary, represented by its foreign minister, asserted its full support

Sheikh Salem began his European tour on June 26, first landing in France then to Italy, Austria and Hungary.

The top diplomat sat through numerous meetings with officials, and held political talks to discuss vital issues and bolster bilateral ties. The Minister of Foreign Affairs dis-

cussed with the Hungarian Parliament

Speaker Laszlo Kovier ways to upgrade

bilateral ties and expand cooperation in a variety of domains.

Both sides mulled strengthening bilateral cooperation and developing political ties to build a sustainable partnership. They also discussed ways to enhance cultural and legislative cooperation.

They reaffirmed keenness to take friendship and bilateral relations to broader horizons in order to realize the

common interests of the both countries. The Kuwaiti top diplomat Sheikh Salem stressed the strength of relations that bind the two countries and their peoples and the common denominators that unite them, especially since they are democratic countries that deeply believe in the universal human values and the importance

of stability, dialogue, peace and neutrality. Speaker of the Hungarian Parliament Kovier praised the friendly and historical relations between Kuwait and Hungary and the continuous expansion of mutual cooperation.

He stressed eagerness to deepen the historical friendship in a way that serves common interests and meets the aspirations of the two friendly peoples.

Both sides reviewed the recent regional and international developments of common interest.

They asserted the importance of supporting international efforts to maintain the world security and stability

visa requirements and rallying European support for such move was of the main topics discussed in the meeting, according to a foreign ministry statement.

The Hungarian top diplomat, noted the statement, underlined his country's "full" support for the Kuwaiti request, pointing to his country's efforts in this regard; within its partnership with the European Union.

Both sides saw eye-to-eye and exchanged views on a host of vital issues, including neutral and peaceful approach to solving conflicts that would respect and reserve countries' sovereignities; a matter that would reflect on international peace and security.

KUWAIT CITY, July 4: Within the framework of coordination among all sectors of the Ministry of Social Affairs to implement the projects included in the development plan for the 2023/2024 fiscal year, and to discuss its views on the government's work program for the years 2023/2024 and 2026/2027, the Acting Undersecretary of the ministry Abdulaziz Sari held the first coordination meeting with the team responsible for the preparation and follow-up of the development plan in the presence of representatives of the Supreme Council for Planning and Development Affairs, reports Aljarida daily.

The attendees reviewed the projects listed for the 2023/2024 fiscal year, which include the establishment and completion of the mobile unit building for the elderly in Ishbiliya area, and the completion of the mechanization of the ministry's sectors.

The social safety network aims to ensure the subsidies provided by the state reach the most needy people, as per a performance mechanism that guarantees fairness and transparency in the distribution of wealth, with the cooperation of the World Bank, at a total cost of KD 860,000 over a period

As for the second initiative, it is related to early childhood development. It aims to provide the necessary opportunity for children to obtain good quality early childhood development and care according to modern educational curricula so that they are ready for the primary stage. This will be implemented with the cooperation of UNICEF at an estimated cost

The third initiative is related to improving and developing cooperative work by amending some organizing decisions and developing national competencies. It will be implemented through specialists in cooperative work, provided that the implementation period is two years without any financial cost to the state budget.

In addition, the meeting discussed the government's work program, which includes the application of governance in the public sector. This is in implementation of the directives of the Council of Ministers for combating administrative corruption and enhancing the principles of transparency and integrity in the work and activity of government agencies.

The Ministry of Social Affairs is the first entity to form a team specialized in corporate governance. It is currently reviewing the legislation, regulations and systems in force in the ministry to make observations and recommendations in line with the principles of governance. This is in preparation for measuring the rate of application of governance in the ministry, and measuring the extent to which its concepts are understood by leaders and officials.

The ministry has trained more than 130 supervisory employees since the implementation of the approved plan and schedule for the governance team. The research and study of legislation related to the sectors of cooperation, social development, legal affairs, planning and administrative development, and the minister's office has been completed. The governance team has finished submitting preliminary reports to the concerned sectors regarding ob-

servations and recommendations on



the legislation in force in the sectors, some of which stated

therein was taken into account and issued in the form of ministerial and administrative decisions.

The ministry confirmed that the price control teams are continuously inspecting markets to monitor the prices of vari-

## **Monitoring private schools exams**

KUWAIT CITY, July 4: Minister of Education, Dr. Hamad Al-Adwani has issued a decision on the necessity of activating the supervision of exams in private schools, starting from the next academic year 2023-2024 defining the mechanism for monitoring private schools during exams, reports Al-Qabas daily.

He also spoke of the need to tighten control over the exams, and called for assigning a sufficient number of assistant directors and heads of departments who are not part of the exams conducting committees, to supervise the proper conduct of exams.

The daily quoting the minister said this comes as a continuation of the approach to control the examination committees which the ministry has succeeded in

The decision stated, "The General Administration of Private Education will take action against private schools if the decisions or regulations issued by the Ministry of Education are violated in any

Meanwhile, the ministry has com-

Reliable sources told the daily that this is done based on the agreement signed previously by the ministry with the university to cooperate in the field of restructuring MEW and overhauling the organizational structure and job description for each organizational unit.

The MEW sources noted that the structure includes the creation of new departments, the most prominent of which include the renewable energy management.

On the other hand, the Minister of Electricity, Water and Renewable Energy, Dr Jassim Al-Ustad met the senior officers of the ministry to discuss the plans and projects of all sectors, in the midst of assistant undersecretaries at all sectors reviewed the visions and plans in each

Informed sources in the ministry said, "The assistant undersecretaries have provided an overview of their development projects included in the ministry's plan, and the projects being implemented and others to be implemented in the future."

## 'Are decisions of Ministry of Foreign Affairs issued from within the ministry?'

"LAST November, Kuwait, through the Ministry of Foreign Affairs, nominated its representative to head the largest Islamic university in Africa, in response to an invitation it received from the Organization of Islamic Cooperation, which thanked Kuwait for this nomination on the eighteenth of May this year, and sent a letter to our representative, the Permanent Delegate of the State of Kuwait at the Organization of Islamic Cooperation, and an invitation was attached to him that he should attend the meeting on the nineteenth of June, to be elected as the president of the university, after he was recommended and appointed as a member of its board of trustees, columnist Bader Khaled Al-Bahr wrote for Al-Qabas daily.

"Three days later, our representative sent the letter of the organization to the Department of International Organizations Affairs at the Ministry of Foreign Affairs, and a copy to the deputy minister, with a recommenda-

tion to send an invitation to attend the meeting to the person concerned.

"When no action was taken by the Ministry of Foreign Affairs, this aroused the concern of the Organization of Islamic Cooperation, so it sent a reminder letter four days before the date of the meeting, confirming that the candidate's presence is very important, but it appears from the sequence of events that the Ministry of Foreign Affairs may have ignored this letter, and it is likely that it did

not notify the concerned person officially, who learned about the matter from other sources, so he took the initiative to address the ministry, asking it to respond to the letter of the organization to facilitate his mission, which the ministry has not paid attention to, to date.

"The reader might say, what is the importance of raising a topic of this kind in an article? However, the Organization of Islamic Cooperation is considered a broad interface that includes fifty-seven countries, and constitutes the collective voice of nearly two billion Muslims.

"Therefore, it is a significant weight that we can resort to diplomatically, as a formality when we resort to the Arab League during the invasion, to exert pressure to achieve our interests, or when we need cover for an international politician to confront imminent threats in the region

"By the way, we remind the Ministry of Foreign Affairs that its statement of condemnation last week, which was nothing more than a formality regarding the recent incident of burning the Qur'an in Sweden; Saudi Arabia went further in its regard by submitting an official request to the Organization of Islamic Cooperation to hold an emergency conference in the city of Jeddah to take action on the issue, which made Sweden, according to what has been reported recently, apologize and open an investigation for fear of sanctions led by the Kingdom, so that the ministry realizes the size of this organization, which is not appropriate for it to ignore

"On the other hand, it is also not appropriate for the ministry to repeat practices that would have led to the resignation of a former foreign minister, or to continue working with cadres that did not improve their performance, in addition to the need to stop unjustified policies, including, for example, supporting the presence of embassies in the country for all countries of the world if possible, under the pretext of intensifying and consolidating international recognition of Kuwait, which made us exhaust the public treasury with exorbitant costs to open embassies for poor countries while bearing their operating expenses, while we are not linked to any interests.

"This is what the Palestinian embassy mostly enjoys, which must be stopped immediately, as the black history of this organization is sufficient justification for its termination! In addition to ending the presence of embassies of countries that do not add any political weight to Kuwait, the absence of diplomatic representation for all countries does not mean that there is no recognition of Kuwait, as there is not a single country in the world that does not recognize us as an independent entity.

"In view of the criticisms we referred to in previous articles, and what we alluded to now of the inability to make decisions and the delay in deciding them, it makes us wonder: Is appointing a former ambassador as a minister sufficient to run a ministry of this size? Does the ministry still receive its decisions from a sovereign authority higher than it, as was the case in the past? Are the decisions of the Ministry of Foreign Affairs issued from within the Ministry of Foreign Affairs?

"Some people may view the military as tough and arrogant, as people who have been trained to be hard-hearted, but the reality is completely different, as inside these strong bodies often live soft hearts," columnist Dr Abdul Mohsen Al-Jarallah Al-Kharafi wrote for Al-Qabas daily.

'The soldier at heart is a human being, no matter how hard they train him to be, and despite the harshness that wars and training impose upon him, the soldier remains a human being as God Almighty created him with the same feelings and sentiments, just like all civilians.

"What drew me to this article is a beautiful scene of loyalty, which reflects the size of the sincere brotherhood between two Kuwaiti army

"Perhaps the manifestations of brotherhood and friendship between officers and soldiers in general reflect the beautiful emotional relations between them, and I will suffice with one example in this article as the available space permits.

"This is an elegy for one of the retired officers, lamenting his brother, the retired officer, who passed away recently, in which he mentions his virtues and the beautiful time they lived together.

"Whereas, in 2000, that is, nearly a quarter of a century ago, the retired Brigadier General, Musaed Khalifuh, suffered a stroke that confined him to bed and retired Colonel Walid Ibrahim Al-Toura, lamenting his death and remembering his virtues and the beautiful time they lived together.

"It is worth noting, that we recall the great national role played by the retired Brigadier General Omar Khalifuh, with a good group of his military brothers, when they entered the Hawalli Traffic Department on the first day of the invasion, and the departments concerned with issuing the raw materials and seals used in printing driving licenses and car registration books, which were used in the State of Kuwait, as proof of identity alongside the civil card, so that those in the resistance cells would issue these identities to hundreds, if not thousands of military personnel, officials in sensitive positions, and some members of the ruling family, so that they could use them to move easily in Kuwait, or to facilitate their exit from the country, and thus they contributed to saving all of these from the oppression of the occupation.

What should I say in the lamentation of a dear brother whom I have known for more than half a century, who brought together the virtues in

one body? Am I talking about his piety, his morals, or his cheerfulness and good manners? As for his patience, he spent twenty-three years on his bed, patient, hopeful, and satisfied with God's will and destiny.

"Difficult moments have passed for him, but the most severe of them is when the beloved brothers joined him before the Maghreb prayer to cheer

"All our condolences to the patient, the Mutasbah, Umm Umar, his righteous offspring, the family of his successors, and the honorable family of Al-Abd Al-Jader."

"Since ancient times, Kuwait has been playing an important and strong role in foreign relations and its position in the world, especially in the United Nations, through its accession as an important international entity in the progressive and developed revolution, in addition to the oil revolution, which gave it a prominent position in global economic forums and oil organizations like OAPEC and OPEC, as well as in taking international decisions regarding the economies of the world," columnist Dr Ghadeer Aseeri wrote for Al-Qabas daily.

"Undoubtedly, the role of Kuwait has been evident in various important periods – from independence to the Gulf War and Corona. It has presented initiatives and proposals. Its role is not limited to discussing global issues. The future of Kuwait depends on this role, as it has been showing the same boldness and strength in dealing with issues related to civilization, development, human rights, peace and security.

The Kuwaiti diplomacy efforts must be intensified in terms of visits and relations with major countries, which play a role in opening the global civil construction and influencing global currencies, particularly the value of the dinar.

"Countries in the modern world are keen on restoring the global economic map. This serves Kuwaiti interests in the political, security and economic fields. This is in addition to the need for advanced legislation, like that of modern countries which realized the need for sciences on local tourism and the tourism revolution taking place in the surrounding region and the civilized world. Kuwait has a vital role and place in this environ-

"The international vision of Kuwait must always keep pace with global developments. This should be the mentality of the local legislator in order to balance the surrounding developments and the country's international positions. Since the inception of Kuwait, it has a legacy that makes us distinguished in the outside world.

"Cooperation on economic, political, security, educational, health, tourism and industrial development adds value to Kuwait. Thus, parliamentarians must ratify laws compatible with recent developments, without courtesies that could make the country backward.

'The country's needs in the coming years in terms of laws differ from that of the last 10 years. Modernity is important at this stage of enacting laws. The minds and concerns of the next generation have changed, as well as the states and policies.

'There is an urgent need for the mentality of those who enact, think and legislate to be in line with balancing domestic politics and international developments.'

### Top-level coordination meet held to set 'controls' for transporting highly flammable materials: KFF

KUWAIT CITY, July 4, (KUNA): The Kuwait Fire Force (KFF) hosted today, Tuesday, a high-level coordination meeting to discuss the development of standards and special measures to prevent the recurrence of truck accidents loaded with highly flammable materials in the future.

The Kuwait Fire Force stated in a press statement that the meeting, which was held in its headquarters building, was based on the directives of the First Deputy Prime Minister and Minister of Interior Sheikh Talal Khaled Al-Ahmad Al-Sabah, during which the reasons that led to the fire of a truck loaded with highly flammable materials on Al-Ghazali Road last week were exam-

It said that the meeting, which was attended by the head of the fire brigade, Lieutenant General Khaled Al-Mekrad, the Undersecretary of the Ministry of Interior, Lieutenant-General Anwar Al-Barjas, and the relevant government agencies in the country, witnessed a discussion of the mechanism for setting standards and procedures from the concerned authorities in the country, each according to its competence, to prevent the recurrence of such incidents in the future.

It pointed out that the controls and procedures that apply to all trucks transporting highly flammable materials that are in force internationally have been put in place in a safe manner to ensure the safety of road users, in addition to setting specific dates for the exit of trucks to ensure the regulation of traffic safety.

It indicated that the team expressed its thanks to the representatives of the concerned authorities in the state for their efforts in preserving lives and property and achieving community security through coordination and

#### 'Do not leave vehicles in parking lots after work'

KUWAIT CITY, July 4: The Ministry of Education has called on all its employees to "commit to security and safety procedures and follow the instructions issued by the Public Relations and Media Department of the Directorate-General of Fire Department (DGFD), reports Al-Rai daily.

According to the instructions the employees are requested not to leave cars inside the parking lots after the end of the official working hours, and in the event of a malfunction to inform the building management to take the necessary action in this regard."

## Ministry received 13,000 divorce cases during '22: show statistics

Panel to continue 'power cut' to violating apartments

KUWAIT CITY, July 4: The Family Counseling Department of the Ministry of Justice received a total of 13,814 cases during the year 2022, of which 6,033 cases were provided with the "case search" service, and 597 of them ended in divorce, reports Al-Rai daily.

According to the annual statistics of the Ministry of Justice, the cases that ended in revocable divorce amounted to 4,131 cases, or 68.5 percent. The cases that ended in reconciliation between the spouses reached 1,305 cases, or 21.6 percent. The number of cases in which the divorce was finalized reached 597 cases, or 9.9 percent of the total 6,033 cases.

In conclusion, the Family Counseling Department received 13,814 cases during its morning branches in Farwaniya, Reqqa, Sulaibikhat, Ahmadi, Jahra, Mubarak Al-Kabeer and Hawally areas. They are distributed as fol-

- 6,033 cases for which the case search service was provided.
- 3,844 cases were presented to the Centers for Settlement of Disputes and Combating Domestic Violence.
- 3,356 cases were presented to family dispute experts. ■ 581 cases were provided with the required legal

According to the numbers, the Farwaniya and Capital Governorates had the largest number of cases that were examined, which amounted to 2,753 each, followed by Ahmadi Governorate with 1,060 cases, Jahra with 994 cases, Hawally with 757 cases, and finally Mubarak Al-Kabeer with 469 cases.


Campaigns to cut power: The Deputy Head of the Judicial Enforcement Team at the Ministry of Electricity, Water and Renewable Energy and a member of the Committee to Address the Phenomenon of Bachelors, Ahmed Al-Shammari, said inspection teams are preparing to resume the campaign to cut off power supply for bachelors' quarters in all governorates of Kuwait - bachelors who reside in model areas, reports Al-Anba daily.

Al-Shammari said the Ministry of Electricity is a key member of the committee that was formed in 2019, and its campaigns have met with success over the past years and added that last June, the number of violations exceeded 90, which is a record number for one month, during which the team members identified persons stealing power supply and illegal water connections in all commercial, investment, industrial, agricultural and private housing sectors.

He pointed out this month till date 6 reports have been filed, especially those related to bachelors quarters, and the judicial police teams coordinates with the committee to cut off illegal power supply, which poses a threat to the safety of the network and people living in those proper-

He stressed that there are deterrent penalties against foreign investors, which in some cases may lead to deportation, in the event that the committee seizes more than one property managed by the foreign investor, in addition to the existence of heavy financial fines from the Environment Public Authority that may reach 50,000 dinars for bachelors' real estate.

Al-Shammari said: We will not be complacent in the case of violations, and that the law is applied on everyone without exception.

Grades 12, 11 students begin training in cooperatives

**KUWAIT CITY, July 4: The Ministry of Interior has** called on citizens to verify the validity of the passport, and ensure that it is not less than 6 months before travel or when applying for a visa, reports Al-Rai daily.

The ministry indicated that the process of renewing the electronic passport for those who are 21 years old and above takes place through the website of the Ministry of Interior http://moi.gov.kw and an easy application. As for those who are below 21, they must visit the National Identity Centers with the guardian in the six governorates distributed as follows:

Capital Governorate (Al-Shamiya Center) working two shifts, morning

and evening; Farwaniya Governorate (Ishbiliya Centre); Al-Jahra Governorate (Sa'ad Al-Abdullah Center); Hawalli Governorate (West Mishref Centre); Mubarak Al-Kabeer Governorate (Al-Adan Center) and Al-Ahmadi Governorate (Jaber Al-Ali Center) working two shifts, morning and

The ministry noted the electronic passport are received through selfservice devices, which are located in the national identity centers in the six governorates, which receive citizens from 8:00 am until 1:30 pm, and 3:00 until 7:00 pm at Al-Shamiya and Jaber Al-Ali centers.

Students being trained: Kuwaiti students began work in cooperative societies Monday, as part of a project to train students during the summer

period, under the supervision of the Ministry of Social Affairs, reports Al-Qabas daily. The cooperative societies sources told the daily that several cooperative outlets met with students who had shown their desire to receive training during July, while those who could not be accommodated will get their opportunity in August.

The sources stated that most of the cooperatives will pay the selected trainee students 150 dinars each. to enable the cooperative societies movement to absorb the biggest number of trainees, which, according to the circular issued by the ministry, several students of the twelfth and eleventh grades will benefit over two months. The circular also stated that each student will work for four hours every day and will have to adhere to the fingerprint attendance.

#### Indicated

The sources indicated that two work shifts, morning and evening, are allocated to the trainees, where they have the option to attend in any one of them, and must carry the identification document issued by the cooperative.

Haya Al-Maqroun, Vice Chairman of the Board of Directors of the People's Cooperative Society, told Al-Qabas that she met yesterday with the trainee students, and informed them of the basic principles required of them during the training period.

Al-Magroun stated that the trainees will be divided into 10 sectors, and they will be trained to work as what she called, "receipt officer, cheese department, nuts, vegetables, and furniture, library, family supplies, catering and wholesale, administrative work, and small projects."

She indicated that a certificate of appreciation will be given to those who pass the training, and a financial reward that will be determined by the association

Sources pointed out that the country's roads and highways were at the highest level of qual-

Meanwhile, the Public Authority for Housing Welfare has requested that the Kuwait Municipality to allocate temporary roads to serve the East Sabah Al-Ahmad Residential City project for the benefit the residents of the area, reports Al-Qabas daily.

He asserted the decision indicates contradictory positions; considering the Ministry of Health is hiring doctors and nurses from Egypt and Jordan and it sends patients for treatment there, while the Ministry of Higher Education does not accept Kuwaiti graduates from their universities. He called for providing slots for Kuwait students who want to pursue medical studies in Kuwait University.

MPs Jenan Bu Shehri, Osama Al-Shaheen, Ahmed Lari, Mubarak Al-Tasha and Hamad Al-Elyan submitted a bill on granting civil rights to the children of Kuwaiti women married to foreigners. These rights include permanent residency, renewal of civil identification cards every five years regardless of the validity of passports, salaries equal to their Kuwaiti counterparts if they

are employed in the private sector, and priority in public sector recruitment next to the citizens

MP Abdullah Al-Mudhaf asked the government to present a program in line with the citizens' demands with a timetable for achieving goals. He clarified that parliamentary cooperation with the government depends on the quality of the latter's program.

He added the program of the government must include clear plans on addressing major issues like education, employment, health and housing.

had launched the operation because some 50 attacks over the past year had emanated from Jenin.

The Jenin camp and an adjacent town of the same name have been a flashpoint since Israeli-Palestinian violence began escalating in spring 2022. It was also a hotbed of Palestinian military activity in the second Palestinian uprising in the early 2000s.

On Tuesday, hundreds of Israeli troops continued to operate in the camp, seizing weapons and explosives and destroying tunnels and command posts, the army said.

Israeli media reported that the army had arrested at least 120 suspected Palestinian militants since Monday.

The Palestinian self-rule government in the West Bank and three Arab countries with normalized ties with Israel - Jordan, Egypt and the United Arab Emirates - condemned Israel's incursion, as did the 57-nation Organization of Islamic Cooperation. More than 140 Palestinians have been

#### Reissuance of family visas for expatriates constitutes a breakthrough

## New decision brings glimmer of hope to real estate sector

KUWAIT CITY, July 4: From time to time, the real estate sector witnesses a change in the attitudes of investors depending on the economic indicators and political conditions, and the resulting decisions that may negatively or positively affect the course of market activity, reports Al-Qabas daily.

There is no doubt that the investment sector in particular was the most affected during the past years due to the repercussions of the COVID-19 pandemic. It continued to suffer with the recent rise in the interest rates, in conjunction with the authorities' tendency to address imbalances in the demographics, and the issuance of strict decisions on the category of expatriates - the main operator of this sector. The news circulating about the resumption of the issuance of visas for the families of expatriate residents during the coming period brought a glimmer of hope among the real estate investors, with expectations that it would revive the sector to return to its status prior to the

Real estate circles expect the decision to reopen "family visa" to constitute a breakthrough for the investment real estate market (apartments), which witnessed a decline in occupancy rates from their previous rates. It is expected to record about 85.5 percent in 2023, which is a decline from 89 percent prior to the pandemic.

The number of vacant units in the investment housing sector amounted to approximately 59,000 units, compared to 46,000 empty units in 2019. It is expected that the occupancy rates will gradually improve with the reissuance of family visas for expatriates.

The real estate community unanimously agreed that the authorities' move to resume family visa issuance will reflect positively on the real estate market and the rental prices, which constitute investment revenues for many citizens who faced unusual crises due to the decline in demand and the accumulation of rents for tenants during the pandemic period.

The community stressed that the activity of the investment sector is closely linked to expatriates; therefore, the less stringent the decisions are for expatriates to bring their families from their home countries, the more the sector will flourish and vice versa. In the event of a decrease in the number of expatriates and their families, it must be matched by serious support from the authorities for the investment sector.

On the other hand, a number of real estate agents believe the suspension of family visa for expatriates is not the only reason that led to a decline in the apartment sector. They explained that there are other factors that directly contributed to the large number of vacant flats such as the increase in the investment construction activities in many areas of Kuwait such as Mahboula, Sabah Al-Salem, Mangaf and others, in addition to the increase in the rental rates in private housing areas, which led to an increase in supply and a decline in demand for investment real estate.

#### **Revenues achieved**

They indicated that the spread of the phenomenon of leasing in typical areas is mainly due to the high prices of land and construction, as the revenues achieved from leasing may be the most appropriate solution for the citizens to compensate for the exaggerated cost in prices.

Some real estate agents suggested that allowing expatriates to own apartments in Kuwait will revive the currently declining real estate sector and the investment apartments market, and relieve pressure on private housing rented to expatriates.

This will in turn lead to reviving the construction sector, the building materials market and some national industries related to real estate, as well as revitalizing the economic movement in general.

Others believe that enabling expatriates to own housing units without liberating lands will crowd out Kuwaitis who are looking for housing for themselves, in light of the housing crisis that the country is suffering from. It will also raise the prices of investment real estate, which may lead to the inability of citizens with limited income to buy an apartment.

A real estate expert ruled out that the stagnation in the investment sector was caused by just a decline in the number of expatriate families.

He explained that the hikes in interest rates to curb inflation and the rise in land values, and the economic situation in general had greater repercussions on the sector. On the other hand, the extent of the impact on buildings remains directly related to the proportions of occupancy and return rates.

The local real estate market plays a prominent role in the national economy, due to which it is necessary to strengthen the hedging policy and protect the sector from the repercussions of inflation and new hikes in interest rates.

The investment real estate market is expected to improve during the next stage in the event that Kuwait witnesses more development projects that would need additional employment.

Furthermore, properties with finishes of medium and low quality witnessed an improvement in occupancy rates. According to real estate reports, these two categories represent 95 percent of the size of the local investment housing market. The occupancy rates in first-class properties showed stability during the past five years, but this category also witnessed a sharper decline in rents compared to the last two categories. This indicates that some families have moved from mid-grade properties to first-class properties due to the lower

#### French court upholds freezing of assets of Lebanon's cbank chief

A French court Tuesday upheld the freezing of the assets of Lebanon's embattled central bank governor, rejecting his appeal to have them released, an official close to the investigation said.

Several European countries are investigating central bank Gov. Riad Salameh and his associates over myriad alleged financial crimes, including illicit enrichment and laundering of \$330 million. A French investigative judge on May 16 issued an international arrest warrant, or Interpol red notice, for the 72-year-old

Salameh after he failed to show up in Paris for questioning. France, Germany and Luxembourg in March 2022 froze more than \$130 mil-

lion in assets linked to the investigation. The European Union Agency for Criminal Justice Cooperation, or Eurojust, said at the time that the investigation targets five suspects accused of money laundering.

Salameh, who has repeatedly denied charges of corruption had requested that his assets be unfrozen.

On Tuesday, a French appeals court rejected his appeal, saying that his assets will remain frozen, according to an official close to the investigation who spoke on condition of anonymity in line with regulations.

The central governor has repeatedly said that he made his wealth from his years working as an investment banker at Merrill Lynch, inherited properties and investments. He said he would only resign if convicted of a crime. (AP)

## Asian stocks mixed after Wall St hits 15-month high ahead of holiday

BEIJING, July 4, (AP): Asian stock markets were mixed Tuesday after Australia's central bank kept its key lending rate unchanged and Wall Street hit a 15-month high.

Tokyo and Seoul retreated. Hong Kong and Sydney advanced. Shanghai was unchanged. Oil prices rose after Saudi Arabia and Russia said they are extending cuts to the amount of oil they pump to the world to try to prop

up prices..
Wall Street's benchmark S&P 500 index lost 0.1% on Monday ahead of a report this week on U.S. employment, one of the factors watched by the Federal Reserve in deciding on possible additional interest rate hikes.

The Shanghai Composite Index held steady at 3,243.86 while the Nikkei 225 in Tokyo shed 0.9% to 33,445.55. The Hang Seng in Hong Kong advanced 0.4% to 19,393.33.

Sydney's S&P-ASX 200 gained 0.5% to 7,280.80 after the Reserve Bank of Australia left its benchmark lending rate at 4.1% in the day's biggest market data point.

Australia's inflation is past its peak but "still too high and will remain so for some time," said RBA Gov. Philip Lowe in a statement. He warned "further tightening of monetary policy may be required.

The Kospi in Seoul lost 0.3% to 2,594.32 while India's Sensex opened up 0.1% at 65,292.46.

New Zealand and Bangkok advanced while Singapore and Jakarta

declined On Monday, the S&P 500 rose to 4,455.59, its highest level since April 2022. The benchmark has climbed in six of the past seven weeks for a 16% gain so far this year.

The Dow Jones Industrial Average advanced 0.1% to 34,418.47, and the Nasdaq composite added 0.2% to 13,816.77.

Traders expect at least a brief re-cession following U.S. and European rate hikes to cool inflation but have been encouraged by signs U.S. hiring



## Meta looks to 'target' Twitter with rival app called Threads

LONDON, July 4, (AP): Meta is poised to unveil a new app that appears to mimic Twitter - a direct challenge to the social media platform owned by

A listing for the app, called Threads, appeared on Apple's App Store, in dicating it would debut as early as Thursday. It is billed as a "text-based conversation app" that is linked to Instagram, with the listing teasing a Twitter-like microblogging experience.

"Threads is where communities come together to discuss everything from the topics you care about today to what'll be trending tomorrow," it said.

Instagram users will be able to keep their user names and follow the same accounts on the new app, according to screenshots displayed on the App Store listing. Meta declined to comment on the app.

Musk replied "yeah" to a tweet from Twitter co-founder Jack Dorsey saying, "All your Threads are belong to us," along with a screenshot from the App Store's privacy section showing what personal information might be collected by the new Meta app.

Threads could be the latest headache for Musk, who acquired Twitter last year for \$44 billion and has been making changes that have unnerved advertisers and turned off users, including new daily limits on the number of tweets people can view.

Meta has good timing because Twitter users are growing frustrated with Musk's changes and looking for a viable alternative, said Matt Navarra, a social media consultant.

Threads presents the "opportunity to jump to a platform that can give them many of the things that they want Twitter to continue to be that it no longer is," he said.

Allowing Instagram users to port their profile to Threads could give the new app more traction with potential users by providing a ready-made set of accounts for them to follow, said Navarra, former director of social media at tech news site The Next Web and digital communications adviser for the British government.

Twitter has rolled out a series of unpopular changes in recent days, including a requirement for users to be verified to use the online dashboard TweetDeck. The policy announced Monday takes effect in 30 days and appears to be aimed at raising extra revenue because users need to pay have their accounts verified under Musk's changes.

TweetDeck is popular with companies and news organizations, allowing users to manage multiple Twitter ac-

It comes after outcry over Musk's announcement this weekend that Twitter has limited the number of tweets users can view each day - restrictions that the billionaire Tesla CEO described as an attempt to stop unauthorized scraping of potentially valuable data.

Still, some users might be put off by Meta's data privacy track record, Navarra said. And would-be Twitter challengers like Mastodon have found it a challenge to sign up users.

LONDON: Facebook lost a legal challenge Tuesday at the European Union's top court over a groundbreaking German antitrust decision that limited the way the company uses data for advertising.

The European Court of Justice said competition watchdogs can consider whether companies like Facebook comply with the continent's strict privacy rules, which are normally enforced by national data privacy regulators.

The court ruled that antitrust authorities can take into account any violations of data privacy rules as they investigate whether tech giants are abusing their dominance in the market by boxing out competitors.

"We are evaluating the court's decision and will have more to say in due course," Facebook parent Meta said in a statement.

The court sided with a 2019 German antitrust ruling that threatened to upend Meta's business model of selling ads targeted to users based on data gleaned from how they spend time on its services.

Meta, which also owns Instagram and WhatsApp, appealed that finding, which led German authorities to seek an opinion from the Court of Justice,

the 27-nation bloc's top tribunal. Tuesday's decision could pave the way for stricter scrutiny of tech companies. Europe has taken a pioneering role in reining in the power of big digital platforms with sweeping new standards taking effect next month and rules in the works on artificial intelli-

The German Federal Cartel Office, or Bundeskartellamt, wasn't contesting the company's use of customer data to target ads to users on Facebook.

But it said for the company to combine data from all the services it runs to target ads more precisely, Facebook should have to first get permission separately from the other apps and websites to do so.

At issue is the way Facebook gains consent from users to process their data.

A press release summarizing the court's decision said the company "cannot justify" claiming "legitimate interest" as a reason for using personal data to serve ads to users. Under European Union privacy rules, users need to freely give consent for their data to be used.

The EU court's decision will have "far-reaching effects on the business models of the data economy," said Andreas Mundt, president of the German Federal Cartel Office.

## What are they and what might happen?

Engineering and technology used for deep sea mining are still evolving. Some companies are looking to vacuum materials from seafloor using massive pumps. Others are developing artificial intelligence-based technology that would teach deep sea robots how to pluck nodules from the floor. Some are looking to use advanced machines that could mine materials off side of huge underwater mountains and volcanoes.

Companies and governments view these as strategically important resources that will be needed as onshore reserves are depleted and demand continues

#### How is deep sea mining regulated now?

Countries manage their own maritime territory and exclusive economic zones, while the high seas and the international ocean floor are governed by the United Nations Convention on the Law of the Seas. It is considered to apply to states regardless of whether or not they have signed or ratified it. Under the treaty, the seabed and its mineral resources are considered the "common heritage of mankind" that must be managed in a way that protects the interests of humanity through the sharing of economic benefits, support for marine scientific research, and protecting marine environments.

#### What are the environmental concerns?

Only a small part of the deep seabed has been explored and conservationists worry that ecosystems will be damaged by mining, especially without any environmental protocols.

Damage from mining can include noise, vibration and light pollution, as well as possible leaks and spills of fuels and other chemicals used in the mining process.

Sediment plumes from the some mining processes are a major concern. Once valuable materials are taken extracted, slurry sediment plumes are sometimes pumped back into the sea. That can harm filter feeding species like corals and sponges, and could smother or otherwise interfere with some creatures.

## Elon Musk puts new limits on tweets

TikTok and Instagram users can scroll with abandon. But Twitter owner Elon Musk has put new curfews on his digital town square, the latest drastic change to the social media platform that could further drive away advertisers and undermine its cultural influence as a trendsetter.

Keeping up with a sports game, extreme weather conditions or a major news event is getting harder under Musk's new rules, which cap the number of tweets you can view as part of an apparent attempt to relieve the company's overloaded web infrastructure.
"The joke on Twitter is that people

are going to go outside instead, but the reality is that they're going to go to another app," said Jasmine Enberg, an analyst with Insider Intelligence. "By sending users elsewhere, Musk is killing the main proposition Twitter has had for advertisers - a highly engaged user base, especially around news and

Musk recently hired longtime NBC Universal executive Linda Yaccarino as Twitter's CEO to try to win back advertisers annoyed by a host of changes since Musk bought the platform for \$44 billion last year. But she's been silent about the new restrictions that lock users out if they view too many tweets in a day, leaving Musk to announce and explain them.

The moves are "remarkably bad for Twitter's users and advertisers," decimating the reach and engagement that advertisers depend on, according to a statement from Forrester analyst Mike "The advertiser trust deficit that

Linda Yaccarino needs to reverse just got even bigger. And it cannot be reversed based on her industry credibility alone," Proulx said.

An Associated Press inquiry on Monday about how long the limits will last triggered a crude automated reply that Twitter sends to most media queries without addressing the question.

Musk had tried on Saturday to describe how the limits work, saying accounts that don't pay for a monthly subscription will temporarily be re-

stricted to reading 600 posts per day, while verified accounts will be able to scroll through up to 6,000.

After facing backlash, he tweeted that the thresholds would be raised to 800 posts for unverified accounts and 8,000 for verified accounts before later settling on 1,000 and 10,000 tweets, respectively.

Many unverified users are "going to hit that limit fast," said Enberg, because most Twitter users are consuming, not creating posts, and "typically scroll through an enormous number of tweets in a short period of time."
Enberg said Musk should be doing

whatever he can to encourage engagement to show Twitter is still viable as it faces growing competition from upstart rivals, as well as a new Twitterlike service coming from Facebook and Instagram parent Meta. "Instead, he's throttling it," she said.

Proulx, of Forrester, said the "real reason behind Musk's temporary rate limits" is still unclear.

Musk over the weekend explained the new restrictions as an attempt to prevent unauthorized scraping of potentially valuable data from the social media platform. He said it was a temporary measure that was taken because we were getting data pillaged so much that it was degrading service for normal users!" (AP)

## Do credit card late fees actually protect consumers?

In a time when inflation is driving up the cost of nearly everything you buy, something else has increased, too: credit card late fees. Thanks to a clause in the 2009 Credit Card Act, credit card issuers can raise late fees, and over time those fees have risen to current maximums of up to \$41.

The Consumer Financial Protection Bureau recently proposed a rule that would slash credit card late fee maximums by 75%, to \$8 per late payment. While lower fees may seem like a good thing for the consumer, some argue that paying less could do more harm than good. According to the American Bankers Association, such a reduction "will result in more late payments, higher debt and lower credit scores.'

Habitual late payments can indeed damage your credit score, which impacts access to credit and how much you'll pay in interest. And as payment due dates pile up, late payments can lead to an escalation of debt. That escalation is especially concerning when, according to a first-quarter 2023 study by TransUnion, credit card debt is at near-record levels, rising nearly 20% year over year.

**Deterrent or profit source** 

The CFPB argues that credit card companies are using late fees to pad their bottom lines, not to help people manage their financial health. A 2022 Federal Reserve report shows that credit card fees - including late fees in particular - account for about 15% of total credit card profitability. And according to the CFPB's 2021 Consumer Credit Card Market Report, that cost is borne most by the customers who can least afford it. The report shows that of the over \$14 billion in late fees paid by consumers in 2019, subprime and deep subprime consumers paid 42% of that total while representing just 12% of total accounts.

## Making a will is not just for the old and wealthy

Making a will isn't a task just for the old and wealthy. It's also for the well-prepared.

Recent years serve as a heavy reminder that you might not know when your last days are. Life expectancy in the US dropped in both 2020 and 2021, driven by COVID-19 deaths and an increase in accidental deaths, according to the most recent data available from the Centers for Disease Control and

Over 1 million people in the US have died of COVID-19, according to the CDC. And in 2021, accidents or unintentional injuries were the fourth leading cause of death in the US, the organization found.

It's unlikely that you'll die young. But if the unexpected happens, having a will in place – even if it feels like you don't need one – can be a simple way to avoid leaving important decisions about your assets and guardianship wishes to your state's laws and courts. It doesn't have to cost thousands of dollars, either.

What can happen if you don't have a will?

If you don't have a will - called "dying intestate" - your assets are dis-

about the long-term dangers of lower late fees for consumers, it's important to remember their bias. As Scott Gilpatric, a behavioral economist at the University of Tennessee who specializes in procrastination and self-control, puts it, "credit card companies aren't trying to set up a mechanism in the consumer's interest. They're trying to maximize their tributed by a probate court according to your state's laws of intestacy. Going through probate without a will can be a longer, more complicated process, as inheritors must file a petition to make a claim to the assets.

Intestacy laws vary among states, but they generally prioritize close family members, such as spouses, children, parents and siblings, as beneficiaries. If you don't have a will, "funds can wind up in the hands of unintended recipients," says Regina Kiperman, managing attorney at estate planning law firm RK Law PC in New York.

Dying intestate can be damaging even if you don't have a spouse or kids. In this case, your next of kin will likely be a parent. Significant assets can disqualify an older adult from Medicaid eligibility, Kiperman says.

If you do have kids, a will is just as crucial. Whether or not you have assets to pass down, a will is the only way to name a legal guardian of your choosing in the event of your death. Otherwise, state laws determine who cares for your child and what they inherit. When should you make a will?

"The right time to make a will is based on life events, not age," Kiperman says. Generally, these events fall into three categories: acquiring assets (such as buying a house); legal attachment to someone else (getting married or having a child); and risk of death (health diagnosis or even remote

In some cases, it's helpful to make a will as soon as you're of legal age – 18 in most states.

"I wanted to protect myself as early as possible," says Mariel Picknelly, 21, a singer and content creator based in New York. Her mother encouraged her to make a will as soon as she reached adulthood to protect assets titled to her at birth. Having her own will has given her and her family security about the

"I keep my purse close because I don't want anyone to take the things that are meant for me and my family and my future," she says. "A will works the same way.'

How to get started

Making a will doesn't have to be time-consuming or costly. Some websites offer will templates you use for free; make sure it complies with your state's will requirements. Online willmaking software allows you to make a custom will for around \$100.

Those with more complex assets or family situations may want to consult an estate planning attorney to help craft a will. Costs can range from around \$200 to \$350 per hour, or \$1,000 to \$2,000 for a flat-rate estate package, depending on your location and the experience level of your lawyer.

While a will is a good starting point, more is needed in some cases. If you have complex assets or family situations, setting up trusts could make the transfer of assets faster and more seamless, potentially helping you bypass the time-consuming probate process, which is the legal process for distributing assets of a person who has died.

For example, "If you have volatile assets, such as investments in different securities, you might want a trust instead of a will so someone can take immediate control of the assets," Kiperman says. Trusts also offer more protection if you have minor children or a lifelong dependent whom you'd like to inherit assets in a more controlled

However, just because there may be more optimal estate planning tools doesn't mean a will isn't valuable. An imperfect plan is better than none at

"People say that having a will is just for rich people," Picknelly says. "It's not – it's for careful people. You don't need to have a huge amount of assets; you just need protection for when you're not around to speak for yourself."(AP)

While increased notifications and credit score monitoring may be useful, experts question whether these alone would be sufficient to dissuade late-paying consumers. A 2022 ABA-commissioned survey showed that 46% of respondents said avoiding a late fee was the most important reason to pay on time. In that same survey, 83% of respondents said that a \$10 late fee would be insufficient to deter them

from paying a credit card bill late.

Data from NerdWallet's latest Consumer Credit Card Report seems to support this argument. In a March 2023 survey conducted online by The Harris Poll on behalf of NerdWallet, Americans who would miss a credit card payment say that a late fee of \$30, on average, would prevent them from ever missing a payment.

Gilpatric notes that while the effects of paying late such as a reduction in credit score are ultimately more impactful for the consumer than a \$30 late fee, that long-term consequence isn't necessarily effective at driving short-term consumer behavior.

If issuers truly wanted to deter late payments, Gilpatric argues, there are stronger mechanisms available. "If the moment you are late on a payment your credit card becomes deactivated," he argues, "that would be a big wake-up call."

How to avoid late fees
Regardless of where the ruling lands on the future of late fees, you can take proactive measures to avoid these penalties, such as:

Due date notifications: Whether through the credit card issuer if they offer this feature or using your personal calendar, setting reminders of your upcoming due date will help you avoid late payments.

Use autopay: Enabling automatic payment will guarantee that you never again face a late fee. If you're not sure that you can pay in full each time, set your autopay to cover the minimum payment due, then pay the balance of your bill separately as your budget al-

Request a late fee waiver: If you've been hit with a late fee from an issuer for the first time, it's worth asking to have the late fee waived. Some issuers will grant this upon request. (AP)

#### **Job-shadowing encouraged**

## Your DoorDash driver? He is company's co-founder

SAN FRANCISCO, July 4: (AP): On a recent afternoon in San Francisco, a DoorDash driver was circling the neighborhood - first in his car, then on foot - trying to find the restaurant where he needed to pick up two orders. Finally, he Googled the location and realized DoorDash's app sent him to the wrong address.

It's an error he vowed to fix, and he probably will. Because that worker is Andy Fang, DoorDash's chief technology officer and one of the company's three co-founders. "If it happens with one restaurant, it might actually be happening with a lot of other restaurants as well," Fang said after he retrieved the orders and settled back into his car. "If we can see why that happened, maybe we can fix other issues too.'

Fang is one of a growing number of executives who occasionally do the hourly work that makes their companies hum. Starbucks' new CEO, Laxman Narasimhan, is a trained barista and puts in a half-day of work at a store each month. Uber ČEO Dara Khosrowshahi and Lyft CEO David Risher occasionally shuttle passengers. Air New Zealand CEO Greg Foran has been spotted serving drinks and snacks on flights.

Amazon recently re-launched a program called the Associate Experience Week, which encourages employees to shadow operations workers for a week to gain a better understanding of their job. The program is mandatory for some managers. A1 Garage Door Service, which operates in 16 states, also encourages job-shadowing and requires all employees to learn skills outside their immediate responsibilities. A1 CEO Tommy Mello says the policy promotes empathy and collaboration.

#### **Program**

But few companies have a program as robust as WeDash, which requires thousands of salaried DoorDash employees in the US, Canada and Australia to complete at least four deliveries per year. Employees are strongly encouraged to make deliveries monthly. They can use work time to complete those shifts, and they keep any money they make.

"We just want to make sure that people who are working here, who are supporting our audiences, are understanding what people are going through," Fang told The Associated Press.

When they started DoorDash a decade ago, while they were still students at Stanford, Fang and the company's other two co-founders - CEO Tony Xu and Chief Product Officer Stanley Tang - made all the deliveries themselves.

"We had to. There was nobody else to do them," Fang said. "But what we quickly found out was that by doing these deliveries ourselves, we learned a ton of insights into what it actually took to get these deliveries fulfilled.'

The company started WeDash in 2015 to make sure every employee was getting those insights. Fang said there are some exceptions; if an employee can't drive, for example, they might visit merchants or work in

#### **Exponentially**

DoorDash has grown exponentially since then. In 2022, more than 6 million DoorDash drivers - all independent contractors - fulfilled 1.7 billion orders worldwide. DoorDash has expanded beyond restaurant delivery into convenience stores, groceries, pet stores and pharmacies.

Fang, who makes deliveries for at least an hour each month - sometimes with Xu and Tang in tow - says he has made real changes to DoorDash's app based on his experiences. When he was on the East Coast recently, he set a time to make deliveries when he returned to California. But when he got home, he realized the time he had set was off by three hours because the app assumed he was still on the East

Another new feature, introduced this week, arose from employee feedback in WeDash. The feature, Dash Along the Way, lets drivers specify where they want to start making deliveries and then assigns them orders that they can complete en route.

Fang also experiences drivers' other frustrations. The wrong address in the DoorDash app cost him time delivering orders from Bonchon, a Korean fried chicken chain. On the afternoon he drove with an AP video journalist, Fang only made \$15.50 for 51 minutes of work. DoorDash says that's lower than the \$34 per hour that California drivers make on average, including tips.

It's also vastly lower than what Fang pulls in as CTO. His annual compensation in 2022 totaled \$2.79 million and Forbes pegged his net worth that same year at \$1.1 billion, illustrating the gap between those at the top of a company and those at the bottom.

DoorDash and others recently pushed back against a new rule introduced in New York City implementing a minimum pay rate for app-based food delivery workers that could nearly triple their average earnings in the coming years. DoorDash said it may

## **US** agencies buy vast quantities of personal info on open market

Numerous government agencies, including the FBI, Department of Defense, National Security Agency, Treasury Department, Defense Intelligence Agency, Navy and Coast Guard, have purchased vast amounts of US citizens' personal information from commercial data brokers. The revelation was published in a partially declassified, internal Office of the Director of National Intelligence report

released on June 9, 2023. The report shows the breathtaking scale and invasive nature of the consumer data market and how that market directly enables wholesale surveillance of people. The data includes not only where you've been and who you're connected to, but the nature of your beliefs and predictions about what you might do in the future. The report underscores the grave risks the purchase of this data poses, and urges the intelligence community to adopt internal guidelines to address these

As a privacy, electronic surveillance and technology law attorney, researcher and law professor, I have spent years researching, writing and advising about the legal issues the report highlights.

#### **Available**

These issues are increasingly urgent. Today's commercially available information, coupled with the nowubiquitous decision-making artificial intelligence and generative AI like ChatGPT, significantly increases the threat to privacy and civil liberties by giving the government access to sensitive personal information beyond even what it could collect through courtauthorized surveillance.

The drafters of the report take the position that commercially available information is a subset of publicly available information. The distinction between the two is significant from a legal perspective. Publicly available information is information that is already in the public domain. You could find it by doing a lit-

Commercially available information is different. It is personal information collected from a dizzying array of sources by commercial data brokers that aggregate and analyze it, then make it available for purchase by others, including governments. Some of that information is private, confidential or otherwise legally protected.

The sources and types of data for commercially available information are mind-bogglingly vast. They include public records and other publicly available information. But far more information comes from the nearly ubiquitous internet-connected devices in people's lives, like cellphones, 'Highly repetitive and often simple'

## Visual misinformation widespread on FB and often undercounted by experts

How much misinformation is on Facebook? Several studies have found that the amount of misinformation on Facebook is low or that the problem has declined over time.

This previous work, though, missed most of the story.

We are a communications researcher, a media and public affairs researcher and a founder of a digital intelligence company. We conducted a study that shows that massive amounts of misinformation have been overlooked by other studies. The biggest source of misinformation on Facebook is not links to fake news sites but something more basic: images. And a large por-

tion of posted pictures are misleading. For instance, on the eve of the 2020 election, nearly one out of every four political image posts on Facebook contained misinformation. Widely shared falsehoods included QAnon conspiracy theories, misleading statements about the Black Lives Matter movement and unfounded claims about Joe

effort, on any social media platform, to measure the prevalence of imagebased misinformation about US politics. Image posts are important to study, in part because they are the most common type of post on Facebook at roughly 40% of all posts.

Previous research suggests that images may be especially potent. Adding images to news stories can shift attitudes, and posts with images are more likely to be reshared. Images have also been a longtime component of statesponsored disinformation campaigns, like those of Russia's Internet Research Agency.

We went big, collecting more than 13 million Facebook image posts from August through October 2020, from 25,000 pages and public groups. Audiences on Facebook are so concentrated that these pages and groups account for at least 94% of all engagement - likes, shares, reactions - for political image posts. We used facial recognition to identify public figures, and we tracked reposted images. We then classified large, random draws of images in our sample, as well as the most frequently reposted images.

Overall, our findings are grim: 23% of image posts in our data contained misinformation. Consistent with previous work, we found that misinformation was unequally distributed along partisan lines. While only 5% of leftleaning posts contained misinformation, 39% of right-leaning posts did.

The misinformation we found on Facebook was highly repetitive and often simple. While there were plenty of images doctored in a misleading way, these were outnumbered by memes with misleading text, screenshots of fake posts from other platforms, or posts that took unaltered images and misrepresented them.

For example, a picture was repeatedly posted as "proof" that now-former Fox News anchor Chris Wallace was a close associate of sexual predator Jeffrey Epstein. In reality, the grayhaired man in the image is not Epstein but actor George Clooney.

There was one piece of good news. Some previous research had found that misinformation posts generated more engagement than true posts. We did not find that. Controlling for page subscribers and group size, we found no relationship between engagement and the presence of misinformation. Misinformation didn't guarantee virality - but it also didn't diminish the chances that a post would go viral.

But image posts on Facebook were toxic in ways that went beyond simple misinformation. We found countless images that were abusive, misogynistic or simply racist. Nancy Pelosi, Hillary Clinton, Maxine Waters, Kamala Harris and Michelle Obama were the most frequent targets of abuse. For example, one frequently reposted image labeled Kamala Harris a "'high-end' call girl.' In another, a photo of Michelle Obama was altered. (AP)



## Fiber is your body's natural guide to weight management

Fiber might just be the key to healthy weight management - and nature packages it in perfectly balanced ratios with carbs when you eat them as whole foods. Think unprocessed fruits, vegetables, whole grains, beans, nuts and seeds. Research suggests that carbohydrates are meant to come packaged in naturebalanced ratios of total carbohydrates to fiber. In fact, certain types of fiber affect how completely your body absorbs carbohydrates and tells your cells how to process them once they

Fiber slows the absorption of sugar in your gut. It also orchestrates the fundamental biology that recent blockbuster weight loss drugs like Wegovy and Ozempic tap into, but in a natural way. Your microbiome transforms fiber into signals that stimulate the gut hormones that are the natural forms of these drugs. These in turn regulate how rapidly your stomach empties, how tightly your blood sugar levels are controlled and even how hungry

It's as if unprocessed carbohydrates naturally come wrapped and packaged with their own instruction manual for your body on how to digest them.

I am a physician scientist and gastroenterologist who has spent over 20 years studying how food affects the gut microbiome and metabolism. The research is clear - fiber is important not just for happy bowel movements, but also for your blood sugar, weight and overall health.

#### **Processed**

Unfortunately, most Americans get the majority of their carbohydrates stripped of their natural fibers. Modern processed grains like white rice and white flour as well as many ultraprocessed foods like some sugary breakfast cereals, packaged snacks and juices have removed these fibers. They essentially come unwrapped and without instructions for the body on how much it should absorb and how it should process them. In fact, only 5% of Americans eat the recommended amount of carbohydrates with enough of their natural packaging intact. Guidelines recommend at least 25 to

30 grams of fiber a day from food. It may not be surprising that lack of fiber contributes to diabetes and obesity. What is surprising is that the fiber gap also likely contributes to heart disease, certain types of cancer and maybe even Alzheimer's disease.

One popular approach to mitigating some of the ill health effects of low fiber and high refined carbohydrates has been to limit carbohydrate intake. Such approaches include the low-carb. keto, paleo and Atkins diets. Each diet is a variation on a similar theme of limiting carbohydrates to varying amounts in different ways.

There is scientific backing to the benefits of some of these diets. Research shows that limiting carbohydrates induces ketosis, a biological process that frees energy from fat reserves during starvation and prolonged exercise. Low-carbohydrate diets can also help people lose weight and lead to improvements in blood

That said, some keto diets may have negative effects on gut health. It is also unknown how they may affect heart health, some forms of cancer and

Even more confusing, research shows that people with diets high in plant-sourced carbohydrates, like the Mediterranean diet, tend to lead the longest and healthiest lives. How can this be reconciled with studies that suggest that low-carbohydrate diets can benefit metabolic health?

#### Focusing

the types of carbohydrates that studies are evaluating. Limiting simple sugars and refined carbohydrates may improve certain aspects of metabolic health, as these are some of the most easily digested and absorbed calories. But a more sustainable and comprehensive way of improving health may be increasing the percentage of unprocessed, more complex and slowly absorbed carbohydrates that come with their natural packages and instructions intact - those that have fiber.

These natural carbohydrates can be found in whole grains, beans, nuts, seeds, fruits and vegetables. They come in ratios of total carbohydrate to fiber that rarely exceed 10-to-1 and are often 5-to-1 or lower. Eating mostly whole foods is a simple way to ensure you're consuming quality carbohydrates with the right ratios.

On occasions when you're eating out or celebrating someone's birthday, consider taking a fiber supplement with your meal. One pilot study found that a supplement containing a blend of fibers decreased the blood sugar spike - an increase in glucose levels in the blood that if too high can damage the body over time - after a meal in healthy individuals by roughly 30%.

## Hellyer, prolific writer who chronicled UAE's rise, dies at 75

DUBAI, United Arab Emirates, July 4, (AP): Peter Hellyer, a UK-born writer who spent nearly five decades chronicling the history, natural beauty and modern transformation of the United Arab Emirates, has died peacefully at the age of 75, local media reported Monday.

Hellyer, who was granted UAE citizenship and awarded the country's highest civilian honor, helped found the state-run WAM news agency and established its English service. He also helped establish an archaeological group that uncovered several historical sites.

Sheikh Mohammed bin Zayed Al Nahyan, the president of the UAE, said on Twitter that Hellyer's dedicated service to UAE over the course of decades had left "notable" marks in the fields of antiquities, the environment and the media.

"With his passing, we lost a model of commitment and giving," Sheikh Mohammed wrote.

Hellyer came to the UAE in 1975 to make a documentary film about Sheikh Zayed bin Sultan Al Nahyan, Sheikh Mohammed's father and the founder and first president of the federation of seven sheikhdoms. He stayed on to chronicle its dramatic rise from a sparsely populated

desert nation to an ultra-modern hub of tourism and commerce, home to the futuristic cities of Dubai and Abu Dhabi, and the world's tallest Hellyer wrote several articles and books on the country's rise, in-

cluding the official history of its vital oil industry, as well as a broader, maritime history of the Gulf nation. He co-founded WAM with the late Palestinian journalist Ibrahim al-Abed and later served as director of external information and research at the National Media Council, a government regulatory body.

He co-founded and led the Abu Dhabi Islands Archaeology Survey

from 1991 to 2006 and was involved in several discoveries shedding light on the history of the Arabian Gulf, including a 1,400-year-old Christian monastery unearthed on Sir Bani Yas Island near the border with Saudi Arabia.

He wrote widely on the UAE's desert ecology. He chaired the Emirates Natural History Group in the early 1990s and launched its journal, Tribulus, at which he was a longtime editor.

He also founded a local birdwatching society. He was awarded the Abu Dhabi Medal in 2013 - the country's highest civilian honor. Organizers hailed him as "a self-taught jack-ofall-trades" whose "devotion to this land and its people is expressed through his commitment to protecting the country's fragile ecosystems and history in a time of rapid development.

He continued writing about the UAE in regular columns for The National, an English-language newspaper founded in 2008 that he had advised in its early years.

The National was among several local media outlets that reported his death. A family member did not immediately respond to a request for comment. "Peter's enormous role in documenting the UAE's past and present cannot be exaggerated," said Mina Al-Oraibi, the editorin-chief of The National.

"Peter and his long-time friend, the late Ibrahim Al-Abed, were instrumental in laying the foundations for the UAE's media scene and never hesitated to advise and support any journalist who reached out to them. We will miss his writings in The National and thank him for his years of contribution.

In his final column for The National, published last December, he marveled at what he said had been a "golden year" for UAE archaeology. He expressed particular fascination at the recent discovery of artifacts dating back more than 400,000 years, before the emergence of Homo sapiens.

"Most exciting of all?" he wrote. "There's still much more to learn about the history of this land."

KYIV, Ukraine: Award-winning Ukrainian writer Victoria Amelina was among those killed by a deadly Russian missile attack on a popular restaurant frequented by journalists and aid workers in eastern **Ukraine**, PEN America said.

Amelina, 37, who had turned her attention from literature to document Russian war crimes after the invasion, died from her injuries after the June 27 strike in the city of **Kramatorsk**, the literature and human rights organization said Sunday in a statement.

Ukraine's Culture Minister Oleksandr Tkachenko expressed condolences to Amelina's family, adding that Russia bears the responsibility. "For every crime on our soil, for every interrupted life and unspoken word, the terrorist must bear the harshest punishment," he said.

Friends, colleagues and admirers of Amelina mourned her, with many saving hers was a life full of potential that was tragically cut short. "So many books unwritten, stories untold, days unlived," tweeted journalist **Olga Tokariuk**, a friend of Amelina's.

## Elba uses his brains not brawn in 'Hijack'

Standing 6-foot-2-inches, Idris Elba's size helps to sell his characters. As a detective in "Luther," he often averted protocol and went rogue. On "The Wire," he played a shrewd, intimidating crime boss in the drug world. In the 2022 movie "Beast," he protected his daughters from a ferocious lion while on holiday in South Africa. But, in his new Apple TV+ series "Hijack," it's his mental strength that helps him navigate a crisis,

Elba plays Sam, a passenger on a flight from Dubai to London that turns into a hostage situation. The first two episodes of "Hijack" debuted on Apple TV+, with one new episode released

"I'm used to being cast as a big man," said Elba. "In this situation Sam is vulnerable. He isn't there to fight."

Sam's strength here is that he works as a corporate negotiator, and his ability to assess highstakes situations like mergers and acquisitions, serves him well. "It's all a bit of a psych game," he said. "Pitting one against the other and figuring out what your weak spot is. And then, of course, being able to make people feel comfortable, not threatened,"

Space - or lack thereof - was an integral part of filming. The set was an actual plane which Elba said "really helped" the look and feel of the scenes.

"We thought about builds and then we thought, 'What if we just bring a plane in and shoot within what we've got?" said Elba, who was also an executive producer on the show. "You've just got the space that you've got... It felt a little bit like a play and the camera could only go so many places.

The seven-episode series also unfolds in roughly the same amount of time it takes to fly from Dubai to London.

"It's difficult to to make that happen because you shoot things out of sequence, but each minute of every episode is important," said Elba. The show cuts between what's happening in the air and on the ground as officials try to piece together

what they're dealing with and how to react. "It just made sense to get these real time decisions as a way to propel the narrative forward rather than sort of jump out of time sequence," said Elba, adding that the two perspectives are "really reflective of each other the whole time."

"It was very intense," added Archie Panjabi, who plays a counter-terrorism official. "As the series progresses, the tension multiplies and so did the number of people in the room." In the end, Panjabi says there was a feeling of resolution that was freeing. "I should tell people I spent six hours on screen

saving your butt," she tells Elba to laughter. Elba felt his own kind of relief at the end of six months of filming, in part because his adrenaline

was often running high even between scenes. "You stay keyed up. You go to your trailer or whatever, chill out, but you can't undo your mindset. Your body does not know it's acting."



#### **Fires to worsen**

### Wildfires and smoke the 'new abnormal'

NEW YORK, July 4, (AP): It was a smell that invoked a memory. Both for Emily Kuchlbauer in North Carolina and Ryan Bomba in Chicago. It was smoke from wildfires, the odor of an increasingly hot and occasionally on-fire world.

Kuchlbauer had flashbacks to the surprise of soot coating her car three years ago when she was a recent college graduate in San Diego. Bomba had deja vu from San Francisco, where the air was so thick with smoke people had to mask up. They figured they left wildfire worries behind in California, but a Canada that's burning from sea to warming sea brought one of the more visceral effects of climate change home to places that once seemed immune.

"It's been very apocalyptic feeling, because in California the dialogue is like, 'Oh, it's normal. This is just what happens on the West Coast,' but it's very much not normal here,' Kuchlbauer said.



As Earth's climate continues to change from heat-trapping gases spewed into the air, ever fewer people are out of reach from the billowing and deadly fingers of wildfire smoke, scientists say. Already wildfires are consuming three times more of the United States and Canada each year than in the 1980s and studies predict fire and smoke to worsen.

While many people exposed to bad air may be asking themselves if this is a "new normal," several scientists told

The Associated Press they specifically reject any such idea because the phrase makes it sound like the world has changed to a new and steady pattern of extreme events.

"Is this a new normal? No, it's a new abnormal," University of Pennsylvania climate scientist Michael Mann said. "It continues to get worse. If we continue to warm the planet, we don't settle into some new state. It's an ever-moving baseline of worse and worse.

It's so bad that perhaps the term "wildfire" also needs to be rethought, suggested Woodwell Climate Research Center senior scientist Jennifer Francis.

#### **Emissions**

"We can't really call them wildfires anymore," Francis said. "To some extent they're just not, they're not wild. They're not natural anymore. We are just making them more likely. We're making them more intense.

Several scientists told the AP that the problem of smoke and wildfires will progressively worsen until the world significantly reduces greenhouse gas emissions, which has not happened despite years of international negotiations and lofty goals.

despite years of international negotiations and lofty goals.

Fires in North America are generally getting worse, burning more land. Even before July, traditionally the busiest fire month for the country, Canada has set a record for most area burned with 31,432 square miles (81,409 square kilometers), which is nearly 15% higher than the old record.

"A year like this could happen with or without climate change, but warming temperatures just made it a lot more probable," said A. Park Williams, a UCLA bioclimatologist who studies fire and water "We're seeing especially across

who studies fire and water. "We're seeing, especially across the West, big increases in smoke exposure and reduction in air quality that are attributable to increase in fire activity.'

Numerous studies have linked climate change to increases in North American fires because global warming is increasing extreme weather, especially drought and mostly in the West.

As the atmosphere dries, it sucks moisture out of plants, creating more fuel that burns easier, faster and with greater intensity. Then you add more lightning strikes from more storms, some of which are dry lightning strikes, said Canadian fire scientist Mike Flannigan at Thompson Rivers University in British Columbia. Fire seasons are getting longer, starting earlier and lasting later because of warmer weather, he said.
"We have to learn to live with fire and smoke, that's the new

reality," Flannigan said.

Ronak Bhatia, who moved from California to Illinois for college in 2018 and now lives in Chicago, said at first it seemed like a joke: wildfire smoke following him and his friends from the West Coast. But if it continues, it will no longer be as funny.

"It makes you think about climate change and also how it essentially could affect, you know, anywhere," Bhatia said. "It's not just the California problem or Australia problem. It's kind of an everywhere problem."

Wildfires in the US on average now burn about 12,000 square miles (31,000 square kilometers) yearly, about the size of Maryland. From 1983 to 1987, when the National Interagency Fire Center started keeping statistics, only about 3,300 square miles (8,546 square kilometers) burned annually.

During the past five years, including a record low 2020, Canada has averaged 12,279 square miles (31,803 square kilometers) burned, which is three and a half times larger than the 1983 to 1987 average.

The type of fires seen this year in western Canada are in amounts scientists and computer models predicted for the 2030s and 2040s. And eastern Canada, where it rains more often, wasn't supposed to see occasional fire years like this

until the mid 21st century, Flannigan said. If the Canadian east is burning, that means eventually, and probably sooner than researchers thought, eastern US states will also, Flannigan said. He and Williams pointed to devastating fires in Gatlinburg, Tennessee, that killed 14 people in 2016 during a brief drought in the East.

America burned much more in the past, but that's because people didn't try to stop fires and they were less of a threat.

#### Control

The West used to have larger and regular fires until the mid-19th century, with more land settlement and then the

US government trying to douse every fire after the great 1910 Yellowstone fire, Williams said.

Since about the 1950s, America pretty much got wildfires down to a minimum, but that hasn't been the case since about

"We thought we had it under control, but we don't," Wil-

liams said. "The climate changed so much that we lost control The warmer the Arctic gets and the more snow and ice melt there - the Arctic is warming three times faster than the rest

of Earth - the differences in the summer between Arctic and mid-latitudes get smaller. That allows the jet stream of air high above the ground to meander and get stuck, prolonging bouts of bad weather, Mann and Francis said. Other scientists say they are waiting for more evidence on the impact of bouts of

A new study published on June 23 links a stuck weather pattern to reduced North American snow cover in the spring. For people exposed to nasty air from wildfire smoke, increasing threats to health are part of the new reality.

Wildfires expose about 44 million people per year worldwide to unhealthy air, causing about 677,000 deaths annually with almost 39% of them children, according to a 2021 study out of the United Kingdom.

One study that looked at a dozen years of wildfire smoke exposure in Washington state showed a 1% all-ages increase in the odds of non-traumatic death the same day as the smoke hit the area and 2% for the day after. Risk of respiratory deaths jumped 14% and even more, 35%, for adults ages 45 to 64.

Based on peer-reviewed studies, the Health Effects Institute estimated that smoke's chief pollutant caused 4 million deaths worldwide and nearly 48,000 deaths in the US in 2019.

The tiny particles making up a main pollutant of wildfire smoke, called PM2.5, are just the right size to embed deep in the lungs and absorb into the blood. But while their size has garnered attention, their composition also matters, said Kris Ebi, a University of Washington climate and health scientist.

"There is emerging evidence that the toxicity of wildfire smoke PM2.5 is more toxic than what comes out of tailpipes,' Ebi said.

## US maternal deaths doubled in last 20 yrs

NEW YORK, July 4, (AP): Maternal deaths across the US more than doubled over the course of two decades, and the tragedy unfolded unequally.

Black mothers died at the nation's highest rates, while the largest increases in deaths were found in American Indian and Native Alaskan mothers. And some states - and racial or ethnic groups within them - fared worse than others.

The findings were laid out in a new study published Monday in the Journal of the American Medical Association. Researchers looked at maternal deaths between 1999 and 2019 - but not the pandemic spike - for every state and five racial and ethnic groups.

"It's a call to action to all of us to understand the root causes - to understand that some of it is about health care and access to health care, but a lot of it is about structural racism and the policies and procedures and things that we have in place that may keep people from being healthy," said Dr. Allison Bryant, one of the study's authors and a senior medical director for health equity at Mass General Brigham.

Among wealthy nations, the US has the highest rate of maternal mortality, which is defined as a death during pregnancy or up to a year afterward. Common causes include excessive bleeding, infection, heart disease, suicide and drug overdose.

Bryant and her colleagues at Mass General Brigham and the Institute for Health Metrics and Evaluation at the University of Washington started with national vital statistics data on deaths and live births. They then used a modeling process to estimate maternal mortality out of every 100,000 live births.

#### **Disparities**

Overall, they found rampant, widening disparities. The study showed high rates of maternal mortality aren't confined to the South but also extend to regions like the Midwest and states such as Wyoming and Montana, which had high rates for multiple racial and ethnic groups in 2019.

Researchers also found dramatic jumps when they compared maternal mortality in the first decade of the study to the second, and identified the five states with the largest increases between those decades. Those increas-

es exceeded: ■ 162% for American Indian and Alaska Native mothers in Florida, Illinois, Kansas, Rhode Island and Wis-

■ 135% for white mothers in Georgia, Indiana, Louisiana, Missouri and Ten-

■ 105% for Hispanic mothers in Georgia, Illinois, Indiana, Minnesota and Tennessee; ■ 93% for Black mothers in Arkansas, Georgia, Louisiana, New Jersey and

■ 83% for Asian and Pacific Islander mothers in Georgia, Illinois, Kansas, Michigan and Missouri.

"I hate to say it, but I was not surprised by the findings. We've certainly seen enough anecdotal evidence in a single state or a group of states to suggest that maternal mortality is rising," said Dr. Karen Joynt Maddox, a health services and policy researcher at Washington University School of

### **Morning-after pill vending machines** gain popularity on college campuses

SEATTLE, July 4, (AP): Need Plan B? Tap your credit card and enter

Since last November, a library at the University of Washington has featured a different kind of vending machine, one that's become more popular on campuses around the country since the US Supreme Court ended constitutional protections for abortion last year. It's stocked with ibuprofen, pregnancy

tests and the morning-after pill. With some states enacting abortion bans and others enshrining protections and expanding access to birth control, the machines are part of a push on college campuses to ensure emergency contraceptives are cheap, discreet and wide-

There are now 39 universities in 17 states with emergency contraceptive vending machines, and at least 20 more considering them. according to the American Society for Emergency Contraception. Some, such as the University of Tulsa in Oklahoma, are in states where abortion is largely banned.

Over-the-counter purchase of Plan B and generic forms is legal in all 50 states.

The 2022 ruling overturning Roe v. Wade "is putting people's lives at stake, so it makes pregnancy prevention all the more urgent," said Kelly Cleland, the ASEC's executive director. "If you live in a state where you cannot get an abortion and you can't get an abortion anywhere near you, the stakes are so much higher than they've ever been before.

Washington this year became first US state to set aside money - \$200,000 to fund \$10,000 grants that colleges can obtain next year through an application process - to expand access to emergency contraceptives at public universities and technical colleges through the automatic dispensers.

The University of Washington's machine was installed after a student-led campaign. It offers boxes of generic Plan B for \$12.60, about a quarter of what the name-brand versions sell for in stores, and more than 640 have been sold.

The drug is even cheaper in as low as \$7 per box. That's because it is sold at just above wholesale cost, compared with pharmacy retail prices that might go up to \$50.

In Illinois and New York, lawmakers are developing legislation that would require at least one vending machine selling emergency contraceptives on state college cam-

In Connecticut, Yale had to drop plans to install an emergency contraceptive vending machine in 2019 after learning it would violate state

But this year the state approved a measure allowing Plan B and other over-the-counter medications to be sold from vending machines on campuses and other locations.

Medicine in St. Louis who wasn't involved in the study. "It's certainly alarming, and just more evidence we have got to figure out what's going on and try to find ways to do something about this."

Maddox pointed to how, compared with other wealthy nations, the US underinvests in things like social services, primary care and mental health. She also said Missouri hasn't funded public health adequately and, during the years of the study, hadn't expanded Medicaid. They've since expanded Medicaid - and lawmakers passed a bill giving new mothers a full year of Medicaid health coverage. Last week, Missouri Gov. Mike Parson signed budget bills that included \$4.4 million for a maternal mortality prevention plan.

#### Disparity

In neighboring Arkansas, Black women are twice as likely to have pregnancy-associated deaths as white women, according to a 2021 state report.

Dr. William Greenfield, the medical director for family health at the Arkansas Department of Health, said the disparity is significant and has "persisted over time," and that it's hard to pinpoint exactly why there was an increase in the state's maternal mortality rate for Black mothers.

Rates among Black women have long been the worst in the nation, and the problem affects people of all socio-

economic backgrounds. For example, US Olympic champion sprinter Tori Bowie, 32, died from complications of childbirth in May.

The pandemic likely exacerbated all of the demographic and geographic trends, Bryant said, and "that's absolutely an area for future study." According to preliminary federal data, maternal mortality fell in 2022 after rising to a six-decade high in 2021 - a spike experts attributed mainly to COVID-19. Officials said the final 2022 rate is on track to get close to the pre-pandemic level, which was still the highest in decades.

Bryant said it's crucial to understand more about these disparities to help focus on community-based solutions and understand what resources are needed to tackle the problem. Arkansas already is using telemedi-

### Court finds consultant guilty of taking bribes in Oly trial

TOKYO, July 4, (AP): One of several Japanese officials charged in a widespread bribery scandal involving Tokyo Olympic organizers was found guilty Tuesday but avoided

The verdict in Tokyo District Court for Joji Matsui, the former head of Amuse consulting company, was the first for someone on

the receiving end of the bribes from companies seeking sponsorships and licensing for the 2020 Games.

Matsui was sentenced to two years in prison, suspended for four years.

Presiding Judge Kenji Yasunaga said the facts showed Matsui had allowed his company bank account to be used to disguise the transfer of funds to Haruyuki Takahashi, who, as an executive on the Japanese Olympic and Paralympic organizing committee, wielded considerable influence in selecting sponsors.

Yasunaga said the bribes involved, totaling about 27 million yen (\$186,000), were significant and "the damage to public trust has been great." Matsui, who acknowledged guilt

during the trial, remained silent and His defense had argued Matsui was just following orders from Takahashi. That and his expres-

sion of remorse were factors in the decision on a suspended sentence, which kept him out of prison. Takahashi has been charged with

receiving bribes from five companies, estimated at nearly 200 million yen (\$1.4 million). The date for his trial has not yet been set. He has denied the charges.

Previous verdicts in the sprawling Olympic bribery scandal, in which 15 people have been charged, have included suspended sentences.

They included officials at Sun Arrow, which made the Olympic mascots, and clothing manufacturer Aoki Holdings, tapped to dress the Japanese Olympic team.

BARCELONA, Spain, July 4, (AP): Alexia Putellas heads to the Women's World Cup after winning back-to-back Ballon d'Or awards and helping Barcelona win two of the last three Champions League titles.

Even so, her role on Spain's national team is in doubt. The 29-year-old midfielder with a knack for scoring has barely played for her club since recently returning from a leg injury that sidelined her for nearly 10 months.

Alexia was included on Spain's squad for the tournament beginning later this month in Australia and New Zealand. But it is not clear what part she will play on a team that has made huge strides in recent years. Alexia, who leads Spain with 100 appearances, has had a role in that boom by becoming only the second Spaniard, woman or man, to win the Ballon d'Or.

#### SOCCER

She was set to take the 2022 European Championship by storm, only for the anterior cruciate ligament in her left knee to rupture days before the tournament. She played her first game since that injury in late April when Barcelona clinched the Spanish league

In total, she has made six appearances since her injury, all as a substitute, including in the Champions League final. She lifted the trophy as Barcelona's captain after her teammates pulled off a 3-2 comeback victory over Wolfsburg.
Spain coach Jorge Vilda praised Alexia

when he announced his preliminary squad. But it was unclear if he felt he would get more from her playing as a starter or as a backup who could handle the pressure of the final minutes.

Alexia guided Barcelona to its first European Cup in 2021. The next season she led the Champions League in scoring with 11 goals but Barcelona lost in the final. This season, she was an observer until the final minutes of her club's triumphant Champions League campaign. If fully recovered, Alexia would be a formidable weapon for Spain thanks to her ability to join the attack, find spaces to shoot, and her superb strike from distance.

"We know that she is going to help us a lot, not just on the field, but also with her leadership and the respect she commands from the other players, her experience, her ability to know what is needed, and that talent she has to rise to the challenge," Vilda said. "That is what we were missing in the last European Championship.'

But Alexia is also returning to a team that has undergone an unwanted overhaul.

Relations deteriorated between several players and Vilda after Spain exited last year's European Championship in the quarterfinals. Fifteen players, including several Barcelona teammates of Alexia, said they would not continue to play for Vilda unless he improved his coaching methodology.

The federation interpreted the players' decision as an attempt to force the ousting of Vilda. The federation backed the coach firmly and left the rebels off the team.

Now, three of the 15, including Barcelona playmaker Aitana Bonmatí, have been included after a behind-the-scenes reconciliation with Vilda.

The 12 still left off the squad include Patricia Guijarro, who scored twice in Barcelona's win over Wolfsburg.

Alexia was injured at the time of the split between the players and coach and was not among the 15 who refused to continue playing. She did show support for them in a message posted on social media. That, however, did not impede her return for Spain once she had healed.

Spain opens the World Cup against Costa Rica in Wellington on July 21. Japan and Zambia are also in Group C.

Alexia may also have to deal with offfield distractions - this time from her club.

# Philipsen makes it back-to-back wins

Yates keeps Tour overall lead

NOGARO, France, July 4, (AP): Belgian rider Jasper Philipsen won a mass sprint to earn a second straight stage victory at the Tour de France on Tuesday, while Adam Yates kept the race leader's vellow jersey heading into the Pyrenees mountains.

Philipsen followed up his win on Monday's third stage and was once again expertly helped into position to attack by his Alpecin-Deceuninck teammate and countryman Mathieu van der Poel.

Philipsen showcased his pure speed by holding off Australian rider Caleb Ewan at the line to underline his credentials to win the sprinter's green jersey with another impressive performance. Philipsen's countryman Wout van Aert won it last year.

German rider Phil Bauhaus was third to make it the same top three finishers as Monday, with Ewan beating Bauhaus this time. Several riders behind them crashed as they jostled for position on the final straight.

The 181.8-kilometer (112.7-mile) route from Dax to Nogaro in southwestern France was almost totally flat and again favored sprinters.

On the eve of the Tour's first mountain stage - a difficult Pyrenean trek - riders were

keen to save some energy.

The peloton started at a leisurely pace with no team prepared to place a rider in a breakaway. So there was time to glance over and take in some of the countryside scenery, such as the 12th-century Saint-Saturnin

The gentle procession was interrupted when the first attack came about 100 kilometers (62 miles) out, when Frenchmen Benoît Cosnefroy and Anthony Delaplace formed a breakaway. They were still together when they got over the day's only ascent - the modest Côte de Dému is small compared to Wednesday's climbs -but were caught with 25 kilometers (15.5 miles) remaining.

The closing stages were around a circuit with a smooth tarmac, but that didn't make

it easier for Danish sprinter Fabio Jakobsen, who fell off his bike, and several other riders

fell as they clipped barriers in a nervy finish. But Van der Poel showed both his class and his race craft by timing an attack on the left and putting Philipsen in an ideal position from which he made no mistake. It effectively gave him a hat trick of sprint-stage wins after winning the last stage of last year's Tour.

Meanwhile, Yates maintained his six-second lead over two-time Tour winner Tadej Pogaar of Slovenia and his twin brother Simon Yates in third.

## Brazil's Neymar fined \$3.3 million

SAO PAULO, July 4, (AP): Brazilian soccer star Neymar was fined more than \$3.3 million for violating local environmental rules during renovations at his mansion in the city of Mangaratiba outside Rio de Janeiro.

The Mangaratiba city hall said in a statement Monday night it had issued four fines totalling about 16 million Brazilian reals after Neymar was accused of illegally building an artificial lake at his mansion.

"Among the dozens of infractions that were noticed at the player's property are the start of an unauthorized construction which requires environmental control; capture of a river course and detouring it without authorization; moving rock and sand; supressing vegetation without authorization and non-compliance of

an embargo," the statement said. A city hall document obtained by The Associated Press says that the latter charge is related to Neymar's decision to swim in the artificial lake despite the fact that local authorities had shown up to forbid him from that area due to environmental consequences. "Because of that, the athlete was fined again," it said.
"The footballer was at the mansion on

Friday and entered the lake, ignoring the restriction order made by the (environment) secretariat and local police, which showed up there the day before," the document said.

Brazilian media reported on Friday that Neymar threw a party that day to celebrate the completion of the artificial lake.

A spokesperson for the 31-year-old Neymar declined to comment on the issue after a request from the AP. The Paris Saint-Germain striker can appeal the decision, which will be handed to police for possible pros-

## After Boehly's miserable first year at Chelsea, Pochettino is promising to turn things around

MANCHESTER, England, July 4, (AP): It's fair to say things have not gone to plan for Todd Boehly at Chelsea.

Mauricio Pochettino is promising to change all that. The Premier League club's new manager officially got down to work on Monday and in his first day in the office gave a glimpse of the ambition that likely convinced Boehly he was the man to turn Chelsea's fortunes around.

"In the last 10, 12, 15 years, Chelsea is the greatest team in England. I know very well the Premier League and what the culture of Chelsea means," Pochettino said. "We need to be sure that we bring what the club needs to be at the top because the history of the club is Pochettino is already Boehly's

third managerial appointment in what has been chaotic first year of the American businessman's coownership with private investment firm Clearlake Capital. Champions League-winning

manager Thomas Tuchel was fired within weeks of the start of last season and replaced with Graham Potter, who was then shown the door seven months into a five-year

contract. Interim boss Frank Lampard saw out the end of a miserable campaign, which was Chelsea's worst ever in the Premier League and saw the club fail to qualify

Pochettino

All that, despite Boehly and Clearlake overseeing a spectacular transfer spend of around \$630 million on

Notably, Pochettino said there would be more arrivals this off-season, following the signings of forwards Christopher Nkunku and Nicolas Jackson for a reportedly combined fee of 87 million pounds (\$110.4 million).

"It is not closed, the squad, and the club is doing a fantastic job to finish the squad so we have the players here to work with us as soon as possible," he said. "Together, we are going to be in a perfect situation to work and develop the way we want to apply ourselves

on the pitch."

While Potter had to try to balance a bloated squad on the back of Chelsea's recruitment drive, Pochettino takes over after a slew of players have already departed.

N'Golo Kante, Kalidou Koulibaly, Mateo Kovacic, Kai Havertz, Edouard Mendy and Ruben Loftus-Cheek have all gone. They are expected to be followed by Cesar Azpilicueta, Pierre-Emerick Aubameyang, Romelu Lukaku and Hakim Ziyech.

Pochettino is in his first job since leaving Paris Saint-Germain in 2022.

Having been under consideration for the Manchester United job before Erik ten Hag's appointment, he has had to wait for the right position to become available.

"From the beginning, the owners and sporting directors were very clear about the project and we were excited to join them in this project," he said. objective is to win because football is about winning. # Alcaraz opens with win at rainy Wimbledon

Murray and Rybakina also advance

WIMBLEDON, England, July 4, (AP): In only his third Wimbledon tournament, Carlos Alcaraz is already one of the main men to beat.

The top-seeded Spaniard hasn't been past the fourth round at the All England Club, but he has become the primary threat in Novak Djokovic's quest for a recordequaling eighth men's title at the grass-court Grand Slam.

On Tuesday, Alcaraz beat Jeremy Chardy 6-0, 6-2, 7-5 on No. 1 Court - a fitting location for the No. 1 player in the world.

The match was played under the roof because rain affected play on the outside courts for the second straight day.

"Obviously without the roof, with sun, is much better for me. I think for everyone as well," Alcaraz said on court. "With the roof or not, I have to show my best level."

His best led Alcaraz to his first major title at the U.S. Open last year. He reached the semifinals at this year's French Open, but Djokovic ended up winning that match en route to his 23rd Grand Slam title.

#### **TENNIS**

At Wimbledon, Alcaraz reached the second round in 2021, playing as a wild card. He made the fourth round last year and entered this year's tournament after winning the grass-court title at Queen's Club.

The 36-year-old Chardy, who was playing at Wimbledon for the 14th time and at his 56th major overall, planned to retire from the sport after this year's tournament.

Kate, the Princess of Wales, was at a rainy Wimbledon on Tuesday and sat in the Royal Box at Centre Court next to Roger Federer, an eight-time champion who has retired from the sport. Federer was feted before play began.

Matches began on most courts shortly after 11 a.m. at the All England Club, but the tarps came out as the rain came down about an hour later. Play never resumed, and all matches on the outside courts were finally suspended

for the day at about 6 p.m. Only Centre Court and No. 1 Court have retractable roofs at Wimbledon.

Elena Rybakina opened play on Centre Court play against American opponent Shelby Rogers - the traditional spot for the defending women's champion. The defending men's champion, Djokovic, had the honor of starting play in the main stadium on Day 1.

Rybakina, who withdrew from the Eastbourne International last week citing a virus illness, improved her serve after the first set and beat Rogers 4-6, 6-1, 6-2.

"I'm feeling much better," Rybakina said on court. "It was a bit unlucky for me. It was not easy to get again to the fitness and physical condition, but now I'm much better. Hopefully this win gives me more



confidence for the next round." Rybakina had also pulled out of the French Open because of an illness and said she was "pretty nervous" at the start of Tuesday's

Two-time champion Andy Murray was second on Centre Court, beating Ryan Peniston 6-3, 6-0, 6-1.

"It was amazing to have some royalty here but also some tennis royalty, as well," Murray said on court, referring to the princess and to Federer. "It's amazing to have Roger here supporting the event."

Sixth-seeded Ons Jabeur, who lost to Rybakina in last year's final, advanced with a 6-3, 6-3 win over Magdalena Frech on No. 1 Court.

Djokovic's match was delayed by rain Monday, and he even helped dry the court before play resumed. The seven-time champion ended up beating Pedro Cachin 6-3, 6-3, 7-6

Wednesday is normally the day the second round starts at Wimbledon, but there are still outstanding first-round matches from Monday to add to the nearly full slate of uncompleted matches from 'Glad to be able to come back with Norway and get a new story started'

## **Hegerberg seeks to emulate Messi and win World Cup**

OSLO, July 4, (AP): She has often been described as the Lionel Messi of women's soccer because of her scoring feats.

Now Ada Hegerberg is looking to accomplish what the Argentinian great finally achieved a few months ago and win a World Cup to sate a largely unfulfilled international ca-

A total of three goals across three major international tournaments for Norway doesn't do justice to one of the greatest scorers in the history of the women's game. Hegerberg, after all, has netted more goals in the Champions League - the highest stage in women's soccer at club level - than any player, with 59. She became the record holder at the age

With Lyon, she's a six-time Champions League winner, an eighttime French league winner and a sixtime French Cup winner. She has a scoring average of more than a goal per game for Lyon, European soccer's most decorated team.

Oh, and of course, she was the first female winner of the Ballon d'Or in

2018 at an award ceremony in Paris marred by a French DJ asking Hegerberg to twerk. Yet when it comes to hardware

through feats for her national team, Hegerberg's cupboard is bare.

The closest she came to a trophy for Norway was at her first ever senior international tournament - the

European Championship in 2013 - when her team lost in the final to

Since then, it's been a fairly sorry tale for a player who for many has transcended her national team. She has never competed at the Olympics, her only World Cup was in 2015 when Norway exited in the round of 16, and there was a group-stage elimination at the European Championship last year.

Hegerberg would have played in more major tournaments had she not decided to rule herself out of selec-

tion for her national team for five years because of what she perceived to be a general disregard for women's soccer in Norway at the time. The crux of her frustration was the uneven pace of progress and strategy in the women's game. She was absent until 2022, when she opted to return ahead of that year's European Championship - coinciding with the arrival of Lise Klaveness, her former Stabæk teammate, as president of the Norwegian soccer federation.

"I was able to have very honest discussions with the federation, firstly through Lise," she said. "I am very glad to be able to come back with the team and get a new story

A year later, Hegerberg is still attempting to make up for lost time in a Norway uniform - and after a frustrating domestic season, too.

Hegerberg, who spent 21 months out in 2020-21 because of an anterior cruciate ligament injury, was missing for another seven months this season because of an unspecified injury that was not widely reported.

Naturally, she scored a minute after coming off the bench in her comeback game, for Lyon at Montpellier, and ended the season with six goals in nine games in all com-

Scoring is never a problem for this most natural of finishers - even at international level, she has 43 goals in 76 games since making her senior debut for Norway in 2011 at the age

And neither is making a stand for what she believes in. Only a few months ago, Hegerberg appeared in a video by human rights organization Amnesty, demanding compensation for the families of migrant workers who died while working at the men's World Cup in Qatar.

"An extremely large responsibility is placed on footballers and it is tough, but that is the reality," she said in the video. "I know I have a position to show my opinion on it."

For Hegerberg, it's the trophies that are missing with Norway, which has won four major titles but none since the 2000 Sydney Olympics.

For that to change, it can't all just be down to Hegerberg. Her teammates are going to have to step up, Like Caroline Graham Hansen,

the Barcelona midfielder who has 44 goals in 98 games for Norway and briefly took a break from her national team after last year's European Championship.

Norway is in a group with Switzerland, the Philippines and New Zealand. While expected to reach the knockout stage, the Norwegians aren't among the favorites to win the tournament that begins later this month.

### **Indonesia pulls out of hosting beach** games, 3 months after losing U20 WC

LAUSANNE, Switzerland, July 4, (AP): Indonesia pulled out of hosting another global sports event at short notice Tuesday, three months after refusing to welcome Israel's team for soccer's Under-20 World Cup.

The World Beach Games had been set to be staged in Bali from Aug. 5-15 but were canceled after the Indonesian government pulled the budget, the global group of national Olympic bodies known as ANOC said Tuesday.

ANOC said it had no option but to cancel the 14-sport championships including beach versions of soccer, tennis and volleyball, plus surfing and open water swimming - because it was unable to find a replacement host with so little time.

About 1,500 athletes from 100 nations, including Israel, were expected to compete in Bali across 41 medal events.

Indonesia is the world's most populous Muslim-majority country and does not have formal diplomatic relations with Israel, while publicly supporting the Palestinian cause.

"The KOI (Indonesian Olympic Committee) stated the decision was taken after the budget was not released by the government of the country and there is now not time to deliver the games," Lausanne-based ANOC said in a statement, noting its "great surprise and extreme disappointment."

"ANOC and the KOI met for weekly coordination meetings, as recently as last week, and at no point did the KOI indicate there were any issues that would lead to such an outcome," the umbrella group said.

No political issue was cited in the ANOC statement but the problem loomed after Indonesia's refusal to comply with FIFA's hosting requirements to let Israel play in the U20 soccer tournament it had qualified for several months earlier.

FIFA first postponed the tournament draw that was scheduled in Bali then stripped Indonesia of the actual championship days later.

After Argentina stepped in to host the U20 World Cup, Israel achieved one of its best results in international soccer last month. Israel lost in the semifinals to eventual champion Uruguay and placed third.

Indonesia's political stance on hosting events prompted the International Olympic Committee to caution sports bodies about picking the country for
