Malaysia in talks with **Kuwait to buy F/A-18s**

KUWAIT CITY, Aug 14: Malaysian Defense Minister Mohammad Khaled Noordin announced that Malaysia is negotiating with Kuwait to acquire F/A-18 Legacy Hornet aircraft currently in use by the Kuwaiti Air Force, reports Al-Seyassah daily.

The Malaysian government has expressed its desire to integrate these aircraft into the Malaysian Armed

Minister Khaled Noordin made the statement following the 2024 Firepower Training (LKT) at Camp Syed Sirajuddin, according to the Malaysian News

He highlighted that Malaysia had previously shown interest in these aircraft after conducting discussions with Kuwait and sending a technical team to evaluate the planes last June.

The ongoing negotiations aim to finalize Kuwait's decision on the matter.

MoE, MoH evaluate school clinics needs

KUWAIT CITY, Aug 14: The Ministry of Education, in coordination with the Ministry of Health, is working to evaluate approximately 1,000 school clinics. This evaluation includes identifying their needs for medical equipment and assessing the condition of existing equipment, particularly devices for measuring blood pressure and blood sugar levels, as well as First

According to informed sources from the ministry, determining the required materials will begin immediately after the nursing staff starts their work on September 7. They will prepare a list of medical supplies that need to be restocked or supplied, including bandages, disinfectants, gloves, and examination tools.

Equipping school clinics is one of the important matters that the ministry is following up on as part of the preparations for the new school year to ensure a safe and healthy environment for students and teach-

It stressed the need to provide First Aid items such as gauze, bandages, wound disinfectants, and medications that students may need such as painkillers and antihistamines.

The sources called on the Ministry of Education to coordinate with the School Health Department to ensure the medical personnel are aware of the latest health protocols and guidelines and are trained on how to deal with emergencies and infectious diseases that may occur in schools.

They stressed the importance of regularly updating students' electronic health files in school clinics, particularly given the electronic link between health centers, schools, and the Ministry of Education. This link allows school nurses to access students' health information, including any chronic conditions and recommended treatments, as well as to identify cases where sports participation is restricted without guardian approval.

BAGHDAD: The extremist Islamic State (IS) militant group carried out a drone attack on a military base of a local tribal force affiliated with the Iraqi Hashd Shaabi paramilitary forces in Iraq's western province of Anbar, security sources said Wednesday.

The attack occurred on Tuesday night when the drone bombed the base which houses the Sunni tribal fighters in a desert area, a security source in Anbar told Xinhua on condition of anonymity

Meanwhile, Sheikh Mandol al-Jaghifi, leader of the tribal force, said in a statement that IS militants fired a drone equipped with hand grenades on his fighters' base in the Anbar desert without causing casualties. (Xinhua)

ANKARA: Turkish police detained 520 suspects for manufacturing and trafficking drugs during extensive operations across the country, Interior Minister Ali Yerlikaya said on Wednesday.

The police seized more than 3.7 tonnes of narcotics and 861,000 drug pills in those raids, Yerlikaya said on social media X, without specifying the time of the action.

The operations, dubbed "Narkocelik-32," were conducted across 59 provinces, including **Istanbul**, Ankara and **Izmir**, and involved 3,250 personnel, he added. (Xinhua)

Kuwait reiterates commitment to UN nuclear safety code of conduct

KUWAIT CITY, Aug 14, (KUNA): Kuwait has enhanced its "commitment" to the code of conduct established by the UN nuclear agency on the safety and security of radioactive sources, a health official said on Tuesday.

The measure is a testament to Kuwait's "firm belief" in nuclear safety on both regional and international levels, said health ministry radiation protection department chief Ilham Al-Fares, underlining the solid rapport between relevant Kuwaiti bodies and the International Atomic Energy

Agency (IAEA).


As part of Kuwait's commitment to the UN Code of Conduct on the Security and Safety of Radioactive Sources, the country has formed a rigid policy and effective strategy to manage these sources, which includes ratcheting up inspection efforts to ensure the "validity and safety" of radioactive tools, added the official.

On the intricacies of the IAEA code of conduct, Kuwait's UN nuclear agency liaison officer Nader Al-Awadhi said that it was tantamount to an instrument that provides an appropriate framework for radiation safety and security, while it also has the backing more than 150 countries from around the world.

National commitment to this nuclear code of conduct demonstrates the "broad safety" of radioactive material management in Kuwait, he said, emphasizing Kuwait's determination to further cooperate with the IAEA as part of efforts to ensure global nuclear safety.

Penalties toughen for attacking staff

KUWAIT CITY, Aug 14, (KUNA): The Cabinet expressed its sincere condolences to His Highness the Amir Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah, His Highness the Crown Prince Sheikh Sabah Khaled Al-Hamad Al-Sabah and the Al-Sabah family on the passing away of His Highness the Commander of Kuwait National Guard Sheikh Salem Al-Ali Al-Salem Al-Sabah.

The meeting also heard a presentation by Minster of Public Works and Minister of State for Municipal Affairs Dr. Noura Mohammad Al-Meshaan on the project to develop Al-Mubarkiya marketplace, according to statements by Deputy Prime Minister and Minister of State for Cabinet Affairs Shereeda Abdullah Al-Mousherji. The project aims to build a hotel with a classical architecture, a shopping complex, a parking lot and numerous facilities at the

Minister of Social Affairs, Labor, Family and Childhood Affairs and Minister of State for Youth Affairs Dr. Amthal Hadi Al-huwailah briefed the meeting on the activities of the committee on national cooperative projects, including the cooperatives' center for addiction treatment, the cooperatives' center for pediatric hereditary disease treatment, and the social care

The Cabinet session approved the minutes of the higher committee on verification of Kuwaiti citizenship, including citizenship withdrawal cases under Act 15 (1959) and the subsequent amendments.

Based on the recommendations of the ministerial committee on legal affairs, the Cabinet decided to:

Approve draft bills to amend Act 16 (1960), Act 31 (1970) and the Penal Code 16 (1960) to toughen the penalties for aggression on civil servants and prohibit dropping of complaints or barring reconciliation with aggressor;

Gov't sector must start enforcing 3rd 'biometric' attendance: CSC

KUWAIT CITY, Aug 14: The Civil Service Commission (CSC) on Tuesday obligated all government agencies to implement its decision on the mandatory third biometric attendance registration within the official working hours starting Sunday.

The CSC took this step after the push and pull on the implementation of the decision since its issuance on Aug 4; as some entities have adopted the new attendance mechanism, while others have yet

A circular issued by CSC Chairman Dr. Issam Al-Rubaian stated: "All government agencies must start implementing the new attendance system on Sunday.'

He advised the government agencies that use smartphone applications for recording the attendance of employees to activate the system in order to include the additional biometric attendance registration during official working hours through the activation of the biometric feature and the completion of technical procedures in the integrated systems of the CSC

He added: "Government agencies that are still using automated fingerprint devices must add the new feature to the current attendance fingerprint system, along with the activation of the face print feature and the acceleration of the introduction of smartphone applications for attendance registration."

KUWAIT CITY, Aug 14, (Agencies): Kuwait Ministry of Foreign Affairs (MoFA) expressed its strong condemnation regarding the storming of the Al-Aqsa Mosque courtyards by two occupying forces' ministers, members of the Knesset, and hundreds of settlers and extremists.

In a press release, the Ministry emphasized that the occupying forces' repeated irresponsible and provocative actions violate international humanitarian law, undermine peace resolutions, and escalate the situation and aggression, further deepening the

Kuwait reaffirmed its call for the international community to take an active role in confronting Israeli occupation violations and to provide protection for the people of Palestine.

Meanwhile, political and diplomatic efforts are at breakneck speed to prevent further military escalation in southern Lebanon since the start of Operation 'Al-Aqsa Flood' in Gaza in October last year.

Diplomatic contacts were active to stop the Israeli occupation's threats against Lebanon and work on reaching a ceasefire in Gaza, as both are geo-politically interconnected.

Biometrics mandatory for gov't transactions

KUWAIT CITY, Aug 14: The Ministry of Interior has announced that biometric fingerprints will be mandatory for completing government transactions after the specified deadlines,

reports Al-Seyassah daily.
According to Major Shaheen Al-Gharib, the Ministry's security media officer, all government transactions for citizens and residents who have not completed biometric fingerprinting will be halted. The deadlines for fingerprinting are set for September 30 for citizens and December 31 for residents.

MoH tells staff to stick to official work hours

KUWAIT CITY, Aug 14: The Ministry of Health (MoH) has reiterated its call for employees and staff to strictly adhere to official working hours, reports Al-Seyassah daily.

This reminder was issued in an administrative circular by the acting Undersecretary of the Ministry, emphasizing the importance of following the Civil Service Council's rules and provisions regarding official work hours to maintain efficient workflow.

According to the circular, official working hours are set from 7:00 am to 2:00 pm for male employees and from 7:00 am to 1:45 pm for female employees.

The period of delay is calculated after a grace period of thirty minutes upon arrival. Medical, technical, and administrative staff are urged to comply with these working hours, with outpatient clinics in hospitals and specialized medical centers expected to start work at 7:30 am.

In addition, due to a technical issue with the automated system at Al-Oyoun Health Center, the Ministry announced the temporary transfer of residents from the Al-Oyoun area to Al-Qasr Health Center for laboratory tests.

Residents of the Al-Naseem and Al-Waha areas have also been redirected to Al-Jahra Health Center (medical complex) for their healthcare needs.

The Ministry of Health emphasized that adherence to these working hours is crucial for ensuring the provision of the best possible health services to the public.



"The Democrats describe their stance towards China as 'strategic competition' rather than 'strategic conflict', which implies direct confrontation, the absence of any potential for cooperation on specific issues, and a perpetual military threat

a perpetual military threat.

"While former president Trump currently has strong prospects for winning the presidency again, Vice President Kamala Harris could still surprise many, given the growing support and endorsements she receives daily.

"Trump's approach to China has been characterized by his unconventional foreign policy, marked by a unilateral stance. He initiated an economic confrontation through a broad trade war, followed by a technological war, seemingly believing that weakening China economically was the key to reducing its global influence.

"This strategy resonated with the Biden administration, which publicly praised it and continued its implementation, particularly in the technological sector. The Biden administration has imposed stringent restrictions on the export of advanced technology components to China, and in April, signed legislation to ban the TikTok

app.
"However, Trump's approach has seen a relative neglect of alliance policies, especially in the Pacific. His administration was less aggressive on two critical issues in the conflict with China: Taiwan and the South China

"It is expected that if Trump were to return to office, he would continue this approach. Ironically, despite his tough rhetoric on China, Beijing might prefer Trump's return, as his lack of focus on Taiwan and the South China Sea, coupled with a confrontational stance toward US allies, could weaken the strong security alliances the Biden administration has cultivated in the Pacific such as the Quad and ALIKUS.

"Trump's return could provide
China with a strategic advantage, as
his strained relationships with Washington's closest allies might create
opportunities for China to expand its

influence.

"Vice President Harris, on the other hand, has made few public comments on the China conflict, though this issue is expected to be a focal point in her upcoming debate with Trump. However, it is highly likely that Harris would continue Biden's approach to China.

"Her previous statements, including those made during her 2022 visit to Asia, indicate a commitment to Washington's military support for Taiwan and opposition to China's expansionist policies in the South China Sea. Harris has also emphasized the importance of constructive cooperation with China and maintaining open lines of communication.

"In conclusion, confronting China has become a cornerstone of U.S. strategic policy. The main difference between the two major parties, or between different presidents, lies in the methods and tactics used. While Trump's direct confrontational approach may appear more dangerous to China, the Democrats' strategy, particularly their emphasis on building strategic alliances, is potentially more effective -- and more threatening to China -- in the long term."

"For instance, the new traffic law focuses solely on increasing penalties without offering any tangible benefits to citizens, such as extending the duration of private car ownership for three years.



Drug bust leads to shootout in Jahra stables, 2 suspects held

Accountant swindles KD1,790; Egyptian faces deportation

KUWAIT CITY, Aug 14: In a dramatic operation, officers from the General Department of Narcotics Control arrested two suspected drug traffickers following a shootout at the Jahra stables. Two additional suspects managed to flee and are currently being pursued by authorities, reports Al-Anba daily.

The incident began when a force from the Anti-Narcotics Department raided a stable on suspicion of drug activity. The situation quickly escalated into an exchange of heavy gunfire between the suspects and the anti-narcotics team. In response to the incoming fire, the officers were compelled to return fire to neutralize the threat.

Notably, the father of one of the detained suspects reported

to the Ministry of Interior Operations that his son had been kidnapped by individuals in two luxury vehicles, including a four-wheel drive. Upon investigation, it was revealed that the son was actually in custody at the General Department for Combating Narcotics, not abducted as initially feared.

The Ministry of Interior had also received multiple reports

from visitors to the Jahra stables who heard the intense gunfire. The situation was soon confirmed to be the result of the anti-narcotics raid. Although two suspects were captured, two others escaped, and efforts are underway to apprehend them. A security source emphasized that the anti-narcotics officers

A security source emphasized that the anti-narcotics officers were left with no choice but to return fire when they came under attack, and that a manhunt is ongoing to locate the fugitives.

'True fame lies in good morals': The Criminal Court has warned users of the X platform against being influenced by the allure of fame and the pursuit of increasing followers.

The court stressed that true fame should be rooted in good morals and exceptional knowledge. It should be about conveying truth and presenting positive contributions to society, rather than posting phrases or content that could lead to criminal liability or involvement in unlawful activities.

This statement was made in a ruling issued by the Fifth Criminal Circuit, presided over by Dr. Khaled Mohammed Al-Omara, to acquit a Twitter user of charges related to challenging the rights of His Highness the Amir and his authorities, spreading false information about the internal situation of the country, and misusing their phone.

The ruling stated, "Undoubtedly, a person's respect for

The ruling stated, "Undoubtedly, a person's respect for themselves and, more importantly, for others, makes them an example to be emulated. A true role model is someone who masters the art of choosing the best meanings and words and shares what is beneficial to others. The goal should not be to seek false or superficial fame, which may be based merely on obtaining a large number of followers or enhancing the popularity of an account."

Deportation for collecting donations: The Ministry of Interior has arrested an Egyptian after a video surfaced on the social media showing him collecting donations in cash without obtaining the necessary authorization from the relevant authorities, reports Al-Seyassah daily.

The suspect was also found to be in violation of residency and labor laws. Legal procedures are currently underway, with deportation from the country being the next step.

Power poles, cutter stolen: The Deputy Public Prosecutor has filed a 'felony' case against an unidentified person for stealing public property, reports Al-Anba daily.

According to a security source, a citizen representing the Ministry of Electricity reported the incident to the Sulaibiya police station.

The theft involved 11 electricity poles and an antenna cutter,

stolen from a ministry site located off the Sixth Ring Road.

The theft was reported to have occurred around 7 am.

Expat's passport, ID, cash stolen from home while he was asleep

KUWAIT CITY, Aug 14: Forensic technicians were dispatched to an expatriate's residence in Taima to gather evidence in hopes of apprehending an unknown suspect who robbed the individual while he was asleep. According to a security source, the expatriate, born in 1984, reported waking up to find his room in disarray, reports Al-Anba daily. Upon inspection, he discovered that his passport, national ID, 50 dinars, and 7,000 rupees had been stolen. Although he did not suspect anyone specific, he mentioned that the apartment door was left open. The incident has been registered as a theft and classified as a misdemeanor.



Stalled South Saad Al-Abdullah plot distribution sparks public criticism

Citizens demand clarity

KUWAIT CITY, Aug 14: The delay in resolving the issue related to the distribution of residential plots in the South Saad Al-Abdullah project is still ongoing.

It has been a month since the Public Authority for Housing Welfare (PAHW) announced a temporary suspension of payments. This suspension remains in effect until the board of directors meets to review and update the distribution mechanism.

Several housing observers criticized the stagnation in finalizing the distribution mechanisms for the project, amid the lack of comprehensive information about the remaining plots. This uncertainty has caused confusion regarding the future of the distributions and whether new, unconventional housing policies or alternatives will be introduced.

They said that the impact of the absence of official information has contributed to the increase in rumors and misinformation about transferring the rest of the plots to real estate developers.

The observers demand the Minister of State for Housing Affairs to activate the media role, especially since there are a number of citizens who are on the verge of submitting requests to view the progress of housing projects in implementation of the Right to Access Law.

In this regard, housing activist Hadi Al-Ajmi stated that the procrastination and failure to resolve the distribution of plots in South Saad Al-Abdullah, despite a month having passed since PAHW announced it would find mechanisms to improve the distribution process, has caused considerable confusion for those entitled to housing care.

He explained that the media sector of PAHW is currently facing a setback due to the lack of clear and transparent information for the public. This absence has led to speculation on social media about the future of distributions in South Saad Al-Abdullah, with these concerns not being addressed

There is a lack of information for the public, especially the monthly statistics PAHW used to publish several years ago concerning the projects and implementation statuses. The current reluctance to disclose information may be an attempt to avoid provoking

Al-Qahtani called on PAHW to be more transparent, especially since the distributions are paper-based

and do not require all this waiting.

He said, "The housing authority can distribute the entire project within weeks, not years, as long as the distribution is paper-based."

Al-Qahtani stressed that the majority of those waiting for housing care from the South Saad Al-Abdullah project are over 45 years old, and they are still waiting for housing

waiting for housing.

He urged PAHW to pay attention to the citizens, address their concerns, and quickly resolve their issues.

Amendments to Sulaibikhat Bay master plan near final approval

KUWAIT CITY, Aug 14: According to informed sources, the final approvals for the amendments to the master plan for the Sulaibikhat Bay development project are nearing completion, following its approval in mid-July by the municipality's organization sector led by Deputy Director General of the Organization Sector Manal Al-Omran. This is in preparation for presenting it to the technical committee of the Municipal Council before the end of its summer vacation, which is scheduled to end on September 12.

The sources explained that the project is part of the municipality's efforts to advance the completion of development projects with recreational aspects in the country. It is based on the directives issued by the Council of Ministers in recent meetings that urge the municipality to expedite the completion of two key projects - the waterfront development in Jahra (Jahra Corniche) and the Sulaibikhat Bay project.

The master plan for the Sulaibikhat Bay project includes amendments to land uses, building regulations, and occupancy rates for the area situated within Kuwait Bay, west of Kuwait City. This area, which overlooks the coast, spans from the service sector No. 16 in Shuwaikh and Al-Rai commercial service and industrial area to the borders of Doha Port.

The total area of the Sulaibikhat Bay project is 8,152 square kilometers and includes six development zones. These zones are:

- Innovation Area: 609,311 square meters
- Sulaibikhat Coast Area: 1,611,879 square meters
 Sulaibikhat Sports Area:

1,707,314 square meters

Ras Ashairj Area: 2,725,980 square meters

Asharej Residential Area: 600,995 square meters

MoE completes distribution of school supplies ahead of new academic year

Inventory checks underway

KUWAIT CITY, Aug 14: The Ministry of Education has completed the distribution of school furniture and equipment to both new and existing schools across most educational regions, reports AlJarida daily.

As the start of the 2024/2025 academic year approaches, educational sectors are now engaged in a detailed review and inventory of school supplies to ensure that all necessary resources are provided before the academic year begins on Sept 8.

Mansour Al-Dhafiri, the Acting Assistant Undersecretary for Public Education, has emphasized the importance of efficient coordination and follow-up among educational and religious education district directors.

In a letter addressed to these directors.

tors, Al-Dhafiri underscored the urgency of assessing and reporting on the needs of schools to ensure a conducive educational environment for both students and teachers.

He instructed directors to provide detailed reports to the Public Education Office within two days to facilitate any necessary actions by relevant authorities.

Preparation follow-up teams, established by school principals or their representatives, commenced their work on Sunday.

These teams are tasked with coordinating with liaison officers in various sectors to ensure that preparations are completed effectively. According to sources, the process is progressing as planned, with ongoing efforts to supply schools with textbooks, laboratory tools, screens, and cameras, among other essentials.

All school work requirements are expected to be fulfilled before the start of the academic year, aided by existing contracts with specialized companies.

Ministry warns of legal consequences

MoSA issues new directive for caregivers

KUWAIT CITY, Aug 14: The Ministry of Social Affairs has issued a directive requiring caregivers of disabled persons to provide a statement confirming they accompany the 'sick' if they stay outside the country for more than 45 days, reports Al-Seyassah daily.

This measure is intended to protect the rights of people with disabilities, with the ministry warning of legal consequences for those who do not comply.

The directive was outlined in a circular issued by Dr Amthal Al-Huwailah, the Minister of Social Affairs, Family and Childhood Affairs, and Minister of State for Youth Affairs.

It mandates that caregivers submit an annual certificate from the Public Ports Administration, along with copies of the passport and residency documents for the servant or driver assigned to the disabled

Additionally, a periodic report must be submitted if the caregiver is compelled to

stay abroad for more than 45 days.

Former Lebanese Foreign Minister Fares Bouez expressed his concern to KUNA that the head of the Israeli occupation government is striving to "implicate" the US and the world in a regional war against Iran through continued military provocations, targeting of defenseless civilians, and his refusal to compromise and release the

He pointed out that the US would be the only party capable of pressuring the Israeli occupation to stop the war, but the latter calls on; the one hand to de-escalate the tension, and on the other hand declares its commitment to supporting the Israeli occupation and providing it with weapons and ammunition.

For his part, former Lebanese Ambassador to the US Riad Tabbara said that the Lebanese Prime Minister Naiib Mikati reaffirmed Lebanon's position in rejecting the war and adhering to international resolution 1701 by asking friendly countries to pressure the Israeli occupation to stop its attacks on civilians.

He told KUNA that no one has an interest in entering an "open war", noting that even the resistance in Lebanon says this and does not want to deviate from the rules of confrontation with the Israeli occupation.

For his part, Political Science Professor at the American University of Beirut Dr. Hilal Khashan said in a similar statement to KUNA that there will be no expansion of the war zone due to the fact the Iran and Hezbollah there is an impression that Benjamin Netanyahu has a short period of time before the US elections in November to accomplish his goals with the war.

scores of fighter jets and advanced airto-air missiles, the State Department announced Tuesday. Congress was notified of the im-

pending sale, which includes more than 50 F-15 fighter jets, Advanced Medium Range Air-to-Air Missiles, or AMRAAMs, 120 mm tank ammunition and high explosive mortars and tactical vehicles and comes at a time of intense concern that Israel may become involved in a wider Middle East

However, the weapons are not expected to get to Israel anytime soon, they are contracts that will take years to fulfill. Much of what is being sold is to help Israel increase its military capability in the long term, the earliest systems being delivered under the contract aren't expected until the 2026

to develop and maintain a strong and ready self-defense capability. This proposed sale is consistent with those objectives," the State Department said in a release on the sale.

The Biden administration has had to balance its continued support for Israel with a growing number of calls from lawmakers and the U.S. public to curb military support there due to the high number of civilian deaths in Gaza. It has curbed one delivery of 2,000-pound weapons amid continued airstrikes by Israel in densely populated civilian areas in Gaza.

The contracts will cover not only the sale of new 50 aircraft to be produced by Boeing. It will also include upgrade kits for Israel to modify its existing fleet of two dozen F-15 fighter jets with new engines and radars, among other upgrades. The jets comprise the biggest portion of the \$20 billion in sales with the first deliveries expected in 2029.

A senior adviser to U.S. President Joe Biden said Wednesday it's critical to take advantage of "this window for diplomatic action" to end the Israel-Hamas war in Gaza and ongoing hostilities along the Lebanon-Israel border, fearing that escalations could spiral "out of control."

Amos Hochstein, tasked with shuttle diplomacy between Lebanon and Israel, spoke to journalists after meeting Lebanese Parliament Speaker Nabih Berri, as the region anxiously anticipates retaliatory attacks from Iran and the allied Lebanese Hezbollah group on Israel. Hochstein met with Israeli officials Tuesday.

Cease-fire talks between Hamas and Israel are expected to resume in Qatar on Thursday with Qatari, Egyptian, and U.S. mediators.

Hezbollah and Israel have traded strikes since Oct. 8, a day after Palestinian Hamas militants' surprise attack into southern Israel that sparked the

"The more time goes by of escalated tensions, the more time goes by of daily conflict, the more the odds and the chances go up for accidents, for mis-

takes, for inadvertent targets to be hit that could easily cause escalation that goes out of control," Hochstein said.

Hochstein said he and speaker Berri agreed there were "no more valid excuses from any party for any further delay" on a cease-fire based on a framework Biden presented months

ago.
"The deal would also help enable a diplomatic resolution here in Lebanon," the U.S. envoy added.

Diplomatic efforts continue to prevent the regional tensions to spiral into all-out war. Iran and Hezbollah say they are committed to their retaliatory

Hochstein also met with Lebanon's caretaker Prime Minister Najib Mikati and Army chief Gen. Joseph Aoun Hochstein.

The "broad consensus" is that a cease-fire in Gaza would help bring calm to hostilities in Lebanon and elsewhere in the region, said Maha Yahya, the director of the Beirut-based Carnegie Middle East Center. She believes that Hezbollah and Iran did not expect the war in Gaza to continue for so long.

"Nobody counted on the fact that this would last 10 months and still going, with an increasing humanitarian toll," she told The Associated Press. "Put aside the rhetoric and public anger, which is very much there and not for show, they have been open to diplomatic back-channel discussion to try Yahya said Iran and Hezbollah not

attacking over the past two weeks slightly dims the element of surprise, while the U.S. military increases its naval reinforcements in the area and more diplomatic discussion takes place.

If war breaks out between Hezbollah and Israel, it would be the first since a six-week war in the summer of 2006 ended in a draw.

Kyiv denies occupation

Russian forces stop Ukrainian incursion

KYIV, Ukraine, Aug 14, (AP): Russia said Tuesday that its forces checked an effort by Ukrainian troops to expand a stunning weeklong incursion into the Kursk region, as a Ukrainian Foreign Ministry spokesperson said Kyiv has no intention of occupying Russian territory.

Russian army units, including fresh reserves, aircraft, drone teams and artillery forces, stopped Ukrainian armored mobile groups from moving deeper into Russia near the Kursk settlements of Obshchy Kolodez, Snagost, Kauchuk and Alexeyevsky, a Russian Defense Ministry statement



Meanwhile, Ukrainian Foreign Ministry spokesperson Heorhii Tykhyi said the cross-border operation was aimed at protecting Ukrainian land from long-range strikes launched from Kursk.

"Ukraine is not interested in taking the territory of the Kursk region, but we want to protect the lives of our people," Tykhyi was quoted as saying by local media.

He said Russia had

launched more than 2,000 strikes from the Kursk region in recent months using anti-aircraft missiles, artillery, mortars, drones, 255 glide bombs and more than 100 missiles.

'The purpose of this operation is to preserve the lives of our children, to protect the territory of

Ukraine from Russian strikes," he said. The commander of the Ukrainian military, Oleksandr Syrskyi, said in a video posted Tuesday to President Volodymyr Zelenskyy's Telegram channel that Ukraine now controls 74 settlements in the Kursk region.

Nord Stream warrant issued: German prosecutors have issued a first arrest warrant in their investigation into the undersea explosions in 2022 that damaged the Nord Stream gas pipelines between Russia and Germany, according to a media report Wednesday. German authorities refused to comment.

German public broadcaster ARD, the daily Sueddeutsche Zeitung and the weekly Die Zeit said in a joint report that federal prosecutors obtained an arrest warrant in June against a Ukrainian man believed to have resided until recently in Poland. The reports, which did not cite sources, identified the man as Wolodymyr Z.

The federal prosecutor's office said it doesn't comment on media reports or on arrest warrants. Explosions on Sept, 26, 2022, damaged the pipe-

lines, which were built to carry Russian natural gas to Germany under the Baltic Sea. The damage added to tensions over the war in Ukraine as European countries moved to wean themselves off Russian energy sources.

France probe gender cyber: French prosecutors opened an investigation into an online harassment complaint made by Olympic boxing champion Imane Khelif after a rain of criticism and false claims about her sex during the Summer Games, the Paris prosecutor's office said Monday.

The athlete's lawyer Nabil Boudi filed a legal complaint with a special unit in the Paris prosecutor's office that combats online hate speech on Friday.

Boudi said that the boxer was targeted by a "misogynist, racist and sexist campaign" as she won gold in the women's welterweight division, becoming a hero in her native Algeria and bringing global attention to women's boxing.

The prosecutor's office said it had received the complaint and its Office for the Fight against Crimes against Humanity and Hate Crime had opened an investigation on charges of "cyber harassment based on gender, public insults based on gender, public incitement to discrimination and public insults on the basis of origin.'

Freed on Aug. 1 in the historic East-West prisoner swap, Pivovarov now is figuring out a new life in Germany, where he reunited with his wife, Tatyana Usmanova.

Of all the dissidents Russia released, Pivovarov, 42, spent the most time behind bars. He had only about a month left to serve when he was plucked from the prison in northern Russia and flown to Germany. Usmanova already had started readying their St. Petersburg apartment for his homecoming.

Possible sabotage probed: Investigators are looking into suspicions of unauthorized entry and possible sabotage at a major military barracks in western Germany, the Defense Ministry said Wednesday.

Ministry spokesperson Arne Collatz said the Wahn barracks outside Cologne was closed off. He said there were suspicions of attempted or actual illegal entry, as well as sabotage, but gave no further details.

German news agency dpa, which didn't name its sources, said a hole had been found in a fence and there was an unconfirmed suspicion that the facility's water supply might have been tampered with. It said that water samples had been taken for the

Harris opts for long-term solutions

WASHINGTON, Aug 14, (AP): President Joe Biden, watching tens of thousands of migrants from Central America reach the U.S.-Mexico border just a few months into his administration, tapped his second-incommand to help address the influx - a decision that has exposed Vice President Kamala Harris to one of her biggest political liabilities.

In grappling with migration, Harris proceeded cautiously. She focused her time and prestige on boosting private investment in El Salvador, Honduras and Guatemala, the so-called Northern Triangle; her goal was to help create jobs to bolster economies and dissuade migrants from making the perilous journey to the United

It was a decidedly long-term - and limited - approach to a humanitarian crisis, and it has allowed Republicans to tie her to the broader fight over the border. While migration from the Northern Triangle ebbed, it surged from other nations, sparking an emergency at the U.S.-Mexico border, one that Republicans have aggressively sought to exploit at Harris' expense.

A review of Harris' work on immigration reveals a record that is more nuanced than the one presented by her critics or allies. It also provides insights into how Harris - who took over as the Democratic standardbearer when Biden dropped out of the presidential race last month - might tackle one of the nation's most vexing concerns.

Harris was never the "border czar," or put in charge of border security or halting illegal border crossings, as former President Donald Trump, Republicans and even the occasional media outlet have claimed. Instead, she was tasked in March 2021 with tackling the "root causes" of migration from the Northern Triangle and pushing its leaders - along with Mexico's - to enforce immigration laws, administration officials said.

Harris' backers say she demonstrated leadership by leveraging her stature to win investments that might curb migration years down the road. "She felt - and I think she was right

that what she could do the most was help basically lead the effort to draw in investment, using the confidence that a relationship with the White House would give to investors," said Ricardo Zúniga, a former State Department official who specialized in the Northern Triangle and who traveled with Harris to the region.

Critics contend that she could have done far more but chose a less risky path, ensuring the problem only

"She was like, 'nope, I'm just root causes," said Mark Krikorian, executive director of the Center for Immigration Studies, which advocates for less immigration. "Even if it worked, it's the sort of thing that takes generations, not one term.'

He also said there was no evidence that Harris pushed Mexico and the Northern Triangle nations to enforce immigration laws.

Border security

Harris has defended her work, and her campaign began running a television ad Friday that said Harris as president would "hire thousands more border agents and crack down on fentanyl and human trafficking." Democrats have also blasted Trump for helping tank a bipartisan immigration bill earlier this year that would have increased funding for border security, including the hiring of new Customs and Border Protection personnel.

Trump "has been talking a big game on securing the border, but he does not walk the walk," the vice president said last month in Atlanta. Later, she added, "Donald Trump does not care about border security. He only cares about himself."

Immigration has long been an issue that motivates Trump and his base of supporters, and polls show it

is among the most important issues on the minds of voters. As a presidential candidate in 2016, Trump said he would build a wall along the border between the United States and Mexico and get Mexico to pay for it. Trump was not able to complete the project, and Mexico did not fund the part of the barrier that was constructed. The former president also used explosive language to describe immigrants, launching his campaign by suggesting Mexico was sending its "rapists" and criminals to the United

ASHEVILLE, N.C.: Donald Trump will have another opportunity Wednesday to recalibrate his presidential comeback bid, this time with a rally and speech in North Carolina that his campaign is billing as a significant economic address.

Ernesto devastates

'Venezuela's election lacked transparency'

MIAMI, Aug 14, (AP): A panel of experts from the United Nations said Venezuela's recent presidential elections lacked "basic transparency and integrity," adding an important voice to those who have cast doubt on President Nicolás Maduro's claim he won

A four-member team sent by UN Secretary General António Guterres was in Caracas for over a month in the run up to the July 28 election, one of the few independent outside observers invited by Maduro's

While the UN group praised the logistic organization of the voting, it harshly criticized the National Electoral Council, or CNE, for flouting local rules and announcing Maduro the winner without tabulated results from each of the 30,000 polling booths nation-

wide, something it said "had no precedent in contemporary democratic elections.'



"This had a negative impact on confidence in the outcome announced by the CNE among a large part of the Venezuelan electorate," the U.N. experts said in a statement late Tues-

The U.N. statement follows criticism by another invited observer, the Atlanta-based Carter Center, which said it could not verify the CNE's results. Venezuela's foreign min-

ister has blasted the Carter Center, accusing it of lying and servings as a tool of U.S. "imperialism. While the U.N. team stopped short of validating claims by the opposition that its candidate, former

diplomat Edmundo González, trounced Maduro by a more than 2-to-1 margin, it said that the voting records the anti-Maduro coalition published online appeared to exhibit all of the original security features. "This suggests a key transparency safeguard may be available, as intended, with respect to any officially released results," the experts added, noting that elec-

toral authorities failed to meet with the group prior to the mission's departure from Venezuela five days after Since the election, security forces have arrested more than 2,000 people for demonstrating against Maduro or casting doubt on his claims that he won

Separately on Tuesday, the U.N.'s top human rights official expressed concern over the arbitrary detentions and "disproportionate use of force" in Venezuela as part of the crackdown.

"It is especially troubling that so many people are being detained, accused or charged either with incitement to hatred or under counterterrorism legislation," U.N. High Commissioner for Human Rights Volker Türk said in a statement. "Criminal law must never be used to limit unduly the rights to freedom of expression, peaceful assembly and association.'

Türk's comments come as Venezuela's opposition gears up for a demonstration Saturday that it hopes will increase pressure on Maduro to recognize defeat and negotiate a political transition.

"If Maduro makes a realistic evaluation of his options, he'll understand that digging in is not sustainable," opposition leader María Corina Machado told journalists Tuesday.

Machado, who anointed previously unknown retired diplomat Edmundo González as her stand-in once she was banned from running in the presidential campaign, spoke to journalists at a virtual press conference from an undisclosed location due to safety

In her comments, she tried to temper expectations for a quick resolution of the political crisis.

The UN human rights office said that in most of the cases it has documented, detainees haven't been allowed to appoint lawyers of their choice or have contact with their families. "Some of these cases would amount to enforced disappearances," it said.

Thousands left without power: Tropical Storm Ernesto dropped torrential rain on eastern Puerto Rico early Wednesday and left hundreds of thousands of people without power in the US territory as it threatened to strengthen into a major hurricane en route to

A hurricane watch remained in effect for the British Virgin Islands as Ernesto began moving over open

The storm was located about 85 miles (135 kilometers) north-northwest of San Juan, Puerto Rico. It had maximum sustained winds of 70 mph (110 kph) and

was moving northwest at 16 mph (26 kph). "While it is possible Ernesto is already a hurricane, radar data does not yet support an upgrade," the National Hurricane Center in Miami said.

Ernesto is expected to become a hurricane later Wednesday morning. A tropical storm warning was in effect for Puerto Rico, Vieques, Culebra and the U.S. and British Virgin Islands.

Ernesto is forecast to move through open waters for the rest of the week and make its closest approach to Bermuda on Saturday. It is expected to become a major Category 3 storm in upcoming days, with forecasters warning of heavy swells along the U.S. East Coast as Ernesto moves north-northwest in the Atlantic.

Between 4 to 6 inches of rain is expected in the US and British Virgin Islands, and between 6 to 8 inches in Puerto Rico, with up to 10 inches in isolated areas.

3 killed in armed assault: At least five people were killed and three others injured in an armed assault at a mine in Camilo Ponce Enriquez in southern Ecuador's Azuay province, police said Tuesday.

"This morning an attack was reported between members of organized armed groups that caused the death of five people and the injury of three others," the police force said on social media X.

Authorities are investigating the incident in the region of the Andean province, where both legal and illegal mining activities are expanding.

3 crash victims remains flown home: A Brazilian air force plane on Tuesday carried the remains of three of the 62 people killed in last week's plane crash to a small, distraught city in the country's south where they were to be handed over to their families for burial.

Forensics experts have so far identified 45 of the victims and authorized that the remains of 27 of them be returned to their families, the Sao Paulo state gov-

ernment said later Tuesday.

Eight of the victims had been returned by Monday night to their families. The 35-year-old pilot of the plane, Danilo Santos Romano, was the first to be buried. He was laid to rest on Monday in the city of

Media outlets protest: Media organizations in Senegal staged a blackout day on Tuesday to protest a government crackdown they say targets them directly and is aimed at curtailing press freedoms in the West African country.

Television screens went blank on the main TV stations TFM, ITV and 7 TV, and radio outlets such as RFM and iradio were silent. Most of the daily newspapers did not publish Tuesday's editions, except for the government-owned Le soleil and the private pro-government WalfQuotidien and Yoor Yoor Bi.

The move comes as tensions have been rising between media organizations and the government, triggering international con-cerns over press freedoms in one of Africa's most stable democracies. Separately, Senegal's main media companies have accumulated massive debt over the years, threatening the sector's economic survival.

The Senegalese Council of Press Distributors and Publishers, an organization representing both private and public media companies, claimed that the government had frozen banks accounts belonging to the media outlets, allegedly for owing back taxes, "seized production equipment" and "unilaterally and illegally terminated advertising contracts." (AP)

Over 700K hit by flooding: Torrential rains and severe flooding have impacted more than 700,000 people in West and Central Africa, just two months into the rainy season, a UN spokesman said on Tuesday.

Torrential rains and severe flooding in the Central African Republic, Chad, Cote d'Ivoire, the Democratic Republic of the Congo, Liberia, Niger, Nigeria, Mali and Togo have impacted more than 700,000 people, said Farhan Haq, deputy spokesperson for the UN secretary-general, at a daily briefing.

The UN Office for the Coordination of Humanitarian Affairs (OCHA) said it is concerned about flooding in the region.

In Chad, the worst-hit, more than 245,000 people were affected by high water in just a few weeks, OCHA said, adding that floods have destroyed or damaged more than 60,000 houses, affected schools and medical facilities, and hampered access to health care and education. (Xinhua)

LRA's ex-chief convicted: A former commander of the Lord's Resistance Army (LRA) rebel group has been convicted of dozens of crimes against humanity in a key moment of justice for many in Uganda who suffered decades of its brutal insurgency.

The long-awaited verdict in the trial of

Thomas Kwoyelo was delivered Tuesday by a panel of the High Court that sat in Gulu, the northern city where the LRA once was active. It was the first atrocity case to be tried under a special division of the High Court that focuses on international crimes. Kwoyelo faced charges including mur-

der, pillaging, enslavement, imprisonment, rape and cruelty. He was convicted on 44 of the 78 counts he faced for crimes committed between 1992 and 2005.

It was not immediately clear when he would be sentenced.

Kwoyelo, whose trial began in 2019, had been in detention since 2009 as Ugandan authorities tried to figure out how to dispense justice in a way that was fair and credible. Human Rights Watch described his trial as "a rare opportunity for justice for victims of the two-decade war between" Ugandan troops and the LRA. (AP)

Japan's premier paves way for new PM

Kishida will not run for PM again

TOKYO, Aug 14, (AP): Japanese Prime Minister Fumio Kishida, in a surprise move Wednesday, announced he will not run in the upcoming party leadership vote in September, paving the way for Japan to have a new prime minister.

Kishida was elected president of his governing Liberal Democratic Party in 2021 and his three-year term expires in September. Whoever wins the party vote will succeed him as prime minister because the LDP controls both houses of parliament. A new face is a chance for the party to show that it's changing for the better, and Kishida said he will support the new leader.

"We need to clearly show an LDP reborn," Kishida told a news conference Wednesday. "In order to show a changing LDP, the most obvious first step is for me to bow out."

"I will not run for the upcoming party leadership election," he said.

Corruption

Stung by his party's corruption scandals, Kishida has suffered dwindling support ratings that have dipped

below 20%. In order to achieve policies to tackle difficult situations in and outside Japan, regaining public trust in politics is crucial, Kishida said. He called on aspiring party lawmakers to raise their hands to run for leadership and have active policy debate during the cam-

"Once a new leader is decided, I hope to see everyone unite and form a dream team to achieve politics that can

gain public understanding," he said. Kishida said he has been mulling his possible resignation for some time but waited until he could put his key policies on track, including energy policy that calls for a return to nuclear power, a drastic military buildup to deal with security threats in the region, and improving ties with South Korea, as well as political reforms.

Speculation on potential candidates has landed on a number of senior LDP lawmakers, including party Secretary-General Toshimitsu Motegi, Digital Minister Taro Kono, Economic Security Minister Sanae Takaichi and Foreign Minister Yoko Kamikawa.

A winner will replace Kishida as party president, and will be endorsed as the new prime minister in a parliamentary vote soon after. LDP executives are expected to decide next week on the date for the party election.

Since the corruption scandal broke, Kishida has removed a number of Cabinet ministers and others from party executive posts, dissolved party factions that were criticized as the source of money-for-favor politics, and tightened political funds control law. Ten people - lawmakers and their aides - were indicted in January.

Despite Kishida's efforts, support for his government dwindled.

Local election losses earlier in the year eroded his clout, and LDP lawmakers have voiced the need for a fresh face ahead of the next general election. Major losses in the Tokyo metropolitan assembly by elections in

Thai PM Srettha removed from office over an ethics violation

BANGKOK, Aug 14, (AP): A court in Thailand on Wednesday removed Prime Minister Srettha Thavisin from office over an ethical violation, further shaking up Thai politics after the court-ordered dissolution of the main opposition party a week ago.

The Constitutional Court ruled on a case involving Srettha's appointment of a Cabinet member who had been imprisoned in connection with an alleged attempt to bribe a court official.

The court voted 5:4 against Srettha and the ruling removed him from of-

fice immediately.

The Cabinet will remain in place on a caretaker basis until Parliament approves a new prime minister. There is no time limit for Parliament to fill the position. The caretaker Cabinet could also dissolve Parliament and call a new election.

The acting PM is expected to be Phumtham Wechayachai of the Pheu Thai party. Phumtham was first deputy prime minister and commerce min-

ister under Srettha. If Parliament is given the task of choosing a new prime minister, it can select from a roster of candidates nominated for the post last year by the major political parties. The Pheu Thai Party, to which Srettha belongs, has two eligible candidates, including Paetongtarn Shinawatra, the daughter of former Prime Minister Thaksin

Shinawatra.

Another frontrunner would be Anutin Charnvirakul, head of the Bhumjaithai Party, which ran third in last year's election. He is currently a deputy prime minister and interior minister. Anuthin, a powerbroker in the vote-rich northeast whose family owns a major construction group, has served in both a military-backed government and the civilian one that

Also in the running would be two former senior military officers: Prayuth Chan-ocha, who served as prime minister for nine years after staging a coup in 2014, and Prawit Wongsuwan, who was one of Prayuth's depu-

ty prime ministers. Srettha, speaking at Govern-ment House shortly after the verdict, thanked the judges for giving him the opportunity to defend himself. He said he respected the ruling and that he always sought to act ethically during his time in office.
"I'm sorry that I'd be considered as

a prime minister who's unethical, but that's not who I am," he said. Srettha had appointed

Chuenban as a minister of the Prime Minister's Office in a Cabinet re-shuffle in April. Pichit was jailed for six months in 2008 on contempt of court charges after he allegedly tried to bribe a judge with 2 million baht (\$55,000) in cash in a grocery bag over a case involving Thaksin, the former prime minister.

Pichit resigned from the post weeks after being appointed when controversy over the incident was revived.

The court said that although Pichit has already served his jail term, his behavior - as ruled by the Supreme Court - was dishonest. Srettha as prime minister has sole

responsibility for vetting the qualifications of his Cabinet nominations, the court ruled. It said he knew about Pichit's past but still nominated him, and therefore it ruled that he violated the ethics codes. The petition against Srettha was

initiated by former members of the military-installed Senate who had refused to approve Move Forward's prime ministerial candidate when the party was attempting to form a government after its election victory.

The petition against Srettha was seen as a move favoring a pro-military political party in his coalition gov-

Thailand's courts, especially the Constitutional Court, are considered a bulwark of the country's royalist establishment, which has used them and nominally independent state agencies such as the Election Commission to issue rulings to cripple or sink political opponents.

July also added to the push.

The scandal centers on unreported political funds raised through tickets sold for party events. It involved more than 80 LDP lawmakers, mostly belonging to a major party faction previously led by assassinated former Prime Minister Shinzo Abe. TOKYO: A Japanese business executive has returned home from Myanmar following his release from more than a month of detention after being convicted of violating rice pricing rules, his company said Wednesday.

Hiroshi Kasamatsu, a director of the Myanmar supermarket Aeon Orange, was in custody in Myanmar since his June 30 arrest for selling rice at prices above the official regulations. Japan's Foreign Ministry confirmed Monday that the Japanese national was convicted of violating law related to daily necessities and service. He was sentenced to one year in prison and fined 500,000 kyat (about \$150).

His parent company Aeon released a statement Wednesday confirming his return home after the conviction. The company said that retailers operating in Myanmar had no way of knowing the change of law in that country about the rice pricing, which caused Aeon Orange's rice prices to "deviate" from the controlled price in violation to the related law.

KUWAIT CITY, Aug 14: The Boursa Kuwait experienced a decline, with the general index falling by 43.2 points to 7009 points, marking a 0.6% decrease.

The market saw a total trading volume of 199.9 million shares through 13,181 transactions, amounting to 49 million dinars (approximately \$149.4 million). As a result of the selling pressures on most listed shares, the market value dropped by 255 million dinars, from 41.701

billion dinars to 41.446 billion dinars. Main Market Index rose by 29.8 points to 5983.84 points (up 0.5%), with 88.1 million shares traded through

5,105 transactions worth 13 million dinars (about \$39.3 million). First Market Index fell by 64.86 points to 7620.04 points (down 0.8%), with 111.7 million shares traded

through 8,076 transactions worth 36 million dinars (about \$109.8 million). Main 50 Index increased by 68 points to 5844.27 points (up 1.1%), with 36.3 million shares traded through 2,595 transactions worth 5.3 million dinars (about \$16.1 million). Market analysts suggest that the current decline in stock prices may present investment opportunities, as valuations become more attractive.

They remain optimistic about the long-term outlook for the Kuwait Stock Exchange, driven by government development plans, economic diversification, strong financial foundations, and significant sovereign wealth funds. The continued improvement in company profits and foreign investments further support this positive outlook.

Phase-in plan proposed for mandatory sustainability disclosures

CMA explores new regulations for compulsory sustainability reports

KUWAIT CITY, Aug 14: The Capital Markets Authority (CMA) is exploring the implementation of a mandatory requirement for the disclosure of sustainability reports among listed companies, currently submitted on a voluntary basis.

This initiative aims to enhance transparency and commitment to sustainable development practices across various sectors, reports Al-Jarida daily

Sources revealed that under Law No. 7 of 2010 and its amendments, companies are permitted to submit sustainability reports voluntarily.

At present, twenty-one listed companies provide these reports, adhering to the Global Reporting Initiative standards, with only one exception. These reports align with both the United Nations Sustainable Development Goals and the Kuwait Development Plan 2035.

The CMA is considering a phased approach to make sustainability reporting compulsory, starting with companies listed on the first market, where reporting is already more

The proposed regulations are expected to improve compliance with CMA rules, boost company profitability and competitiveness, manage governance-related risks, and enhance stakeholder confidence.

Currently, companies disclose sustainability information in various formats: some include it in their annual reports, others issue standalone reports, and some provide integrated reports.

The CMA's study will assess the feasibility of mandatory reporting and set timelines for its implementation.

Kuwait oil sector merger expected to save \$2 billion annually

KUWAIT CITY, Aug 14: A committee has been established to oversee the comprehensive merger of the Kuwait National Petroleum Company (KNPC), the Kuwait Integrated Petroleum **Industries** Company (KIPIC), and the Kuwait Oil Tanker Company (KOTC).

The committee, formed on August 12, 2024, is chaired by Wadha Al-Khatib, CEO of both Kuwait National Petroleum and KIPIC.

The formation of this committee follows a memorandum from Sheikh Nawaf Al-Saud Al-Sabah, CEO of the Kuwait Petroleum Corporation, dated July 18, which approved the merger.

The committee, comprising 11 members, includes experts from financial, legal, and gas transpor-

tation departments, and is tasked with completing the merger process within six months.

This merger is anticipated to yield annual savings of \$2 billion. The successful integration of these companies aims to enhance efficiency and consolidate operations within Kuwait's oil sector.

The merger process between the KNPC, KIPIC, and the KOTC has commenced due to the complementary roles of these entities. The KNPC manages the Ahmadi and Mina Abdullah refineries, while KIPIC oversees the Al-Zour refinery. The merger aims to consolidate these refineries under a single entity to streamline operations and

rationalize spending.

Additionally, integrating the liquefied gas filling operations of the KOTC with the KNPC aims to centralize marketing efforts, enhance efficiency, and reduce the risk of accidents at the gas filling plants.

The merger is projected to save between \$1.5 to \$2 billion annually by cutting costs related to security, maintenance, and management salaries. The unification will also facilitate better implementation of digital transformations, boosting business volume and reducing bureaucracy.

The full merger of these companies is expected to be completed by 2025. Sheikh Nawaf Al-Saud Al-Sabah, CEO of the Kuwait Petroleum Corporation, is focused on this initiative to achieve significant cost savings, enhance operational efficiency, and support the corpo-

ration's broader goals. Furthermore, there are ongoing efforts to integrate the Kuwait Gulf Oil Company with the Kuwait Oil Company, with an announcement likely within this year. This merger is part of a strategic vision to consolidate similar activities and enhance overall efficiency.

Studies on the merger indicate that it will not negatively impact national labor and is essential for achieving the KPC's 2040 strategy. The consolidation is expected to enable the corporation to increase its production capacity to 4 million barrels per day or more and better meet Kuwait's gas needs, potentially reducing the

country's reliance on imports. The direct merger between the oil companies is expected to result in increased profitability for the entities affiliated with KPC.

This anticipated rise in profits is expected to lead to higher revenues and reduced expenses. The merger aims to address the decline in profits experienced by some companies in the 2023-2024 budget compared to the previous 2022-2023 budget.

By consolidating operations and streamlining management, the merger is projected to enhance operational efficiency, lower costs, and improve financial performance.

This strategic move aligns with the KPC's goals to bolster profitability and achieve better financial outcomes in the coming years.

Experts criticize 700-day drilling timeline

Kuwait Oil Company embarks on marine exploration project

KUWAIT CITY, Aug 14: The Kuwait Oil Company (KOC) has announced the commencement of its marine exploration project, aimed at enhancing the country's hydrocarbon reserves and ensuring the sustainability of oil and gas resources, reports Al-Jarida

daily. The project, led by CEO Ahmed Al-Eidan, will involve drilling six exploratory wells in Kuwait's marine area, which spans over 6,000 square kilometers, representing a significant

portion of the country's total land area. The following are the project details: Seismic Surveys and Drilling -- The

initial phase includes drilling exploratory wells based on two-dimensional seismic surveys to identify optimal offshore drilling sites.

According to opinions of the experts, the success of the initial drilling will determine the next phases of the project.

Dr. Abdul Samie Behbehani criticized the prolonged drilling time of 700 days and suggested the need for faster operations. He emphasized the potential of the Noukhatha field, which contains significant gas and light oil reserves. Behbehani also highlighted the inefficiencies in the oil sector's investment and operations, urging the adoption of modern technology and

expertise.

Kamel Al-Harami stressed the importance of involving international oil companies with advanced technology to expedite production processes. He pointed out challenges such as declining production rates and the need for a specialized offshore oil company in Kuwait, Harami noted that current oil reserves do not align with production demands, affecting local refinery operations.

Dr. Khaled Boodai highlighted the importance of the Noukhatha field in enhancing Kuwait's oil reserves and meeting future market needs. He also emphasized the need to expand renewable energy use to reduce emissions and energy costs, and the potential of hydrogen energy as a future energy source.

Dr. Abdul Mohsen Al-Mutairi emphasized that the exploration strengthens Kuwait's position as a major oil producer and has geopolitical implications. He called for a multi-faceted approach to exploration that includes sustainable practices, advanced technologies, and global partnerships to maximize benefits and minimize environmental impact.

Fed edges closer to cutting rates

Inflation likely stayed low last month

WASHINGTON, Aug 14, (AP): If the Federal Reserve needs any further evidence that the worst price spike in four decades is steadily easing, it's likely to come Wednesday, when the government is expected to report that inflation cooled further last month.

Consumer prices are thought to have risen just 0.2% from June to July, according to economists surveyed by FactSet, a pace only slightly above the Fed's 2% annual inflation target. Measured from a year earlier, inflation is forecast to have remained 3%, the same as in June.

Excluding volatile food and energy costs, socalled core prices are also expected to have risen 0.2% from June and 3.2% from 12 months earlier, just below the 3.3% annual increase in June.

For months, cooling inflation has provided gradual relief to America's consumers, who were stung by the price spikes that erupted three years ago, particularly for food, gas, rent and other necessities. Inflation peaked two years ago at 9.1%, the highest level in four decades.

Inflation has taken a central role in the presidential election, with former President Donald Trump blaming the Biden administration's energy policies for the price spikes. Vice President Kamala Harris on Saturday said she would soon unveil new proposals to "bring down costs and also

strengthen the economy overall." Grocery prices are expected to have been largely unchanged from June to July, according to economists at UBS. Over the past year, food prices are up just 1.1%. Still, food costs have soared roughly 21% in the past three years, squeezing

many family budgets. Fed Chair Jerome Powell has said he is seeking additional evidence of slowing inflation before the Fed begins cutting its key interest rate. Economists widely expect the Fed's first rate cut to occur in mid-September.

When the central bank lowers its benchmark rate, over time it tends to reduce the cost of borrowing for consumers and businesses. Mortgage rates have already declined in anticipation of the

Fed's first rate reduction. At a news conference last month, Powell said

Spending at small businesses went up in July as consumers spend more on general goods

NEW YORK, Aug 14, (AP): Consumers spent more at small businesses in July, a rebound fueled by strong sales of general merchan-

dise and health and personal care products. The Fiserv Small Business Index rose 1 point to 141 after a 4 point decline in June. The figure is derived from point-of-sale transaction data, including card, cash, and check transactions in-store and online across about 2 million U.S. small businesses.

"Following modest declines in June, consumer spending rebounded nicely in July to help many small businesses start the second half of the year strong." said Jennifer LaClair, head of merchant solutions at Fiserv.

Compared with July of last year, sales rose 3.5% and number of transactions rose 3.3%.

"Consumer spending patterns continue to shift, most notably with retail spend experiencing a decisive bounce back compared to

June," said Prasanna Dhore, chief data officer at Fiserv. "Specialty trade and professional services also performed very well due to sea-

sonal demand and stabilizing inflation rates."
Retail spending rose 4.6% and retail transactions jumped 5.8%. General merchandise was the strongest category, up 10.9%. Health and personal care products rose 8.6%, building equipment and garden materials rose 6.2%, food and beverage sales rose 4.9% and furniture, electronics and appliances rose

One weak spot was restaurant sales, which slipped 1.6% despite seeing modest growth in foot traffic, up 0.7%. Consumers dining out have also seen a significant decrease in average check size, down 2.4% compared to July 2023, although it was not clear if the decrease came from lower prices or diners ordering less.

that cooler inflation data this spring had strengthened the Fed's confidence that price increases are falling back to a 2% annual pace. Inflation was low in May, and overall consumer prices slipped 0.1% in June, the first decline in four years.

"It's just a question of seeing more good data," Powell said. Another inflation report will be issued next month before the Fed's Sept. 17-18 meeting, with economists expecting that report to also show that price increases remained mostly

Raphael Bostic, president of the Fed's Atlanta branch, sounded more explicit about rate cuts in remarks he made Tuesday:

"Yes, it's coming," Bostic said in Atlanta to the Conference of African American Financial Professionals. "I want to see a little more data. ... We need to make sure the trend is real ... but it is coming.

Inflation has eased substantially in the past two years as global supply chains have been repaired, a spate of apartment construction in many large cities has cooled rental costs and higher interest rates have slowed auto sales, forcing dealers to offer better deals to potential car buyers.

Consumers, particularly lower-income ones, are also becoming more price-sensitive, forgoing high-priced items or shifting to cheaper alternatives. This has forced many companies to rein in price hikes or even offer lower prices.

Prices are still rising sharply for some services, including auto insurance and health care. Auto insurance costs have shot up as the value of new and used vehicles has soared compared with three years ago. Economists, though, expect those costs to eventually grow more slowly.

Al race with Apple heats up

Google rolls out Pixel Nine phones earlier than usual

MOUNTAIN VIEW, Calif., Aug 14, (AP): Google on Tuesday unveiled its next generation of Pixel phones, providing the maker of Android software a head start on the next iPhone in the race to bring more artificialintelligence services to devices that have become people's constant companions.

The showcase held near Google's Mountain View, California, headquarters took place two months earlier than when the company typically rolls out the next models in its Pixel phone line-up, which made its debut eight years ago.

Although Pixel phones still represent a sliver of worldwide smartphone sales, they are still closely watched because they serve as Google's platform for demonstrating the latest advances in the Android operating system that powers virtually every phone not made by Apple.

And Google left little doubt that the Pixel 9 phones are meant to be a vessel for the AI technology that is expected to reshape the way people live and work, just as smartphones in general have done over the past 15 years.

"We are obsessed with the idea that AI can make life easier and more productive for people," Rick Osterloh, a Google senior vice president who oversees the Pixel phones, said Tuesday.

That's similar to the theme Apple is accentuating as it prepares to make AI a centerpiece of the iPhone.

That moment is expect to arrive shortly after Labor Day when Apple traditionally takes the wraps off its next iPhone. The next model, the iPhone 16, is expected to be a big attraction because it will be equipped with the special chip needed to run a suite of AI features. Those features are designed to make Apple's virtual assistant Siri smarter

and perform a wide variety of other tasks that the company is promising will bring more joy to people's lives, while still protecting their privacy.

But Apple's plans for AI remain hazier than Google's vision, and Google is also rolling it out more broadly, including on Samsung phones powered by Android, said Emarketer analyst Grace Harmon. That may increase the pressure on Apple next month when it unveils the next iPhone

Not surprisingly, the Pixel 9 lineup is also packed with AI technology, a shift that the Google began last October when it released that year's model. This generation of phones will be the first centered around the Gemini technology that's become the focal point of its push into AI.

Just as Apple is aiming to do with Siri, Google has designed its Gemini assistant to be more conversational, providing it with a range of 10 different human-like voices. It's able to handle even more tasks, especially if users are willing to give it access to email and other documents.

In another move mirroring Apple, Google is equipping the Pixel 9 lineup with a special chip enabling many AI-powered services to be handled on the device instead of remote data centers, with the aim of boosting personal privacy and security.

In on-stage demonstrations Tuesday, the Gemini assistant speaking in a voice called "Ursa" was able to come up with helpful ideas for a fun way to use invisible ink when asked to come up with creative ideas.

But the Gemini assistant also stumbled when shown a picture of a poster for singer Sabrina Carpenter, and when asked to let the questioner know when she was performing a

Germany's auto industry's electrification plans falter

BERLIN, Aug 14, (Xinhua): German seat manufacturer Recaro Automotive, known for supplying luxury brands like BMW, Mercedes-Benz, and Lamborghini, has filed for bankruptcy amid a wider trend of German automotive component suppliers facing financial challenges.

Germany, a major player in the global automotive industry, is witnessing a surge in bankruptcies and layoffs among its suppliers. German automotive suppliers are implementing substantial

layoffs due to the ongoing economic downturn. ZF Group plans to cut 11,000 to 14,000 jobs in Germany by 2028. Continental has announced layoffs impacting 7,150 employees, and Bosch is set to reduce 1,200 jobs in its software division.

Larger suppliers have shown more resilience, whereas smaller suppliers are approaching insolvency. In the first half of 2024, 20 German automotive component suppliers with annual revenues exceeding 10 million euros (about 10.99 million U.S. dollars) filed for bankruptcy, marking a 60-percent increase from the previous year, according to management consultancy Falkensteg. This surge in bankruptcies is attributed to factors such as inflation, rising energy costs, and weakening consumer demand.

In addition, the declining German economy and decreased demand for domestic automotive components have contributed to reduced demand from German car manufacturers. The German Association of the Automotive Industry reported that car production in 2023 declined by over 10 percent, with 4.1 million cars manufactured compared to 4.7 million in 2019.

The global shift towards automotive electrification is putting significant pressure on German automotive manufacturers and component suppliers. It is predicted that employment in the German automotive supplier industry could decrease from 270,000 to 200,000 by 2030, according to Frank Schopp, an automotive industry lecturer at Hannover University of Applied Sciences. This trend indicates a gradual erosion of the German automotive industry's job capacity.

German components focused on internal combustion engines are increasingly being replaced by batteries and electrification components, which are driving growth in the automotive market. Some German automotive suppliers are compelled to invest in both technology platforms, leading to rising R&D costs.

Furthermore, the German government's decision in December 2023 to prematurely end EV subsidies has contributed to consumer hesitancy. New EV registrations in July decreased by 36.8 percent year-on-year, according to the Federal Motor Transport Authority.

The market share of new EV registrations dropped from 15.8 percent in the same period last year to 12.5 percent in the first



Higher education ranks 10th in US exports

Int'l students contribute \$40 bln to US economy

Of the millions of young adults heading off to college this fall, many will be international students. If trends continue, about 1 million students from around the world will come to the U.S. to pursue higher education this year.

These young scholars make a big economic impact. Altogether, they pump more than US\$40 billion into the U.S. economy and support over 368,000 jobs. That's not just paying professors and buying textbooks - it includes everything from renting apartments to late-night DoorDash and Grubhub deliveries. And it's near a record high.

In fact, higher education is the 10th-leading export of the United States, according to the U.S. Bureau of Economic Analysis - except the export is really an import, of students from around the world

Think of it this way: If you went to Paris to see the Olympics this year, the Olympics was the export that brought you - the tourist, or, in economic terms, the import - to France. In the complex world of economic balance of trade accounting, international students are the tourists visiting U.S. campuses.

Only economists could think that studying and taking exams is somehow a vacation.

While China, India and South Korea send the most students to the U.S., young people come from around the globe to pursue degrees here. Last year, they represented some 221 nations and territories, including three students from the independent island nation of Tuvalu.

In any of the 50 largest American cities, you'll find at least one college or university with international students on campus. For these communities, global learners offer a most welcome financial aid package.

Consider Boston. With its pantheon of venerable institutions - including Boston University, where I teach multinational finance and trade - the region boasts over 50 colleges and universities. Boston's economic gains from the more than 60,000 international students at these schools are huge: some \$2.7 billion.

Or look at Greater Phila-

delphia. The region's higher education institutions rank fifth nationwide in attracting students from around the world. From the perennially top-drawing University of Pennsylvania - itself ranked in the top 25 for international students - or the more specialized Curtis Institute of Music, together they can expect to host nearly 17,000 international students in fall 2024.

Prestigious private schools are a draw, but hands down the biggest pull for international students are state universities and colleges. Of the nation's top schools enrolling these students last year, 32 were state colleges and universities, attracting over 240,000 students in total.

In the top three of those public institutions alone - Arizona State University, the University of Illinois Urbana-Champaign and the University of California, Berkeley - international students contributed nearly \$1.6 billion, supporting close to 16,900 jobs. Expand that to the top 10 - the University of California system takes four of those spots - and the numbers pop up to \$4.5 billion and 47,900 jobs.

But it's not just the geographically sprawling University of California and other large state systems. Mankato, Minnesota, hosts a Minnesota State University campus; in the 2022 academic year, some 1,700 international students called this small city, 80 miles from Minneapolis, their home away from home.

Those students brought an infusion of \$44.9 million into that community, supporting around 190 jobs. There are dozens of similar campuses in cities and towns like Mankato across the country. It adds up quickly.

In addition to private and public universities, community colleges also attract thousands of international students. Although their international enrollment has fallen off in recent years, community colleges still attracted just shy of 53,600 international students in 2023, with China, Vietnam and Japan leading the list.

Generating some \$1.5 billion and supporting 6,620 jobs, they have a major economic impact - particularly in Texas, California and Florida, where the majority of these students come to learn.

One thing's for sure: Whether they're attending small-town community colleges or Ivies in big cities, international students have a "high degree" of economic impact. (AP)

Defense claims Swift concert plot allegations exaggerated

VIENNA, Aug 14, (AP): A lawyer for the main suspect in an alleged plot to attack now-canceled Taylor Swift concerts in Vienna said Tuesday that authorities' presentation of the case is exaggerated, and his client wouldn't have been able to carry out plans that the attorney described as "fantasies."

The 19-year-old Austrian man, whose name hasn't been released because of Austrian privacy rules, was arrested last Wednesday - one of three people who were detained. Hours later, organizers canceled the concerts that Swift was scheduled to play Thursday, Friday and Saturday at the Austrian capital's Ernst Happel Stadium. Fans were devastated by the decision.

Austrian officials have said that the suspect wanted to carry out an attack outside the stadium, killing as many people as possible using knives or home-made explosives. They say that, during a raid of the suspect's home, investigators found chemical substances and technical devices

Authorities said last week that the man confessed that he had started planning the attack in July. Defense lawyer Werner Tomanek told the Austria Press Agency that he hasn't yet had access to the case files, but cited a "fragmentary record" of his client's initial questioning to dispute their account of a full confession.

"He had neither the means nor the possibility and the explosives to carry this out," Tomanek said. He added that authorities' allegations against the 19-year-old suspect were "overacting at its best," and contended that they are "presenting this exaggeratedly" in order to get new

surveillance powers.

Tomanek said that his client appeared to have mental problems and described him as "a lone wolf without social contacts." He said that "the alleged attack plans were pure fantasies."

The lawyer said that, in his first questioning by investigators, his client had admitted "in principle to Islamist tendencies" and conceded that he had sought and found "contact with such people online," APA reported. He added that the young man did make a pledge of loyalty to the Islamic State group and put it online, but said he deleted it shortly after.

Asked why his client did so, Tomanek replied: "Because he found it cool." He said the man wanted to imitate poses struck by the assailant in a Nov. 2, 2020, attack in Vienna in which four people were killed and the gunman - who had a previous conviction for trying to join IS in Syria - also was killed.

Swift has five concerts at London's Wembley Stadium scheduled starting on Thursday.

Family and friends of actor Johnny Wactor called for action Tues-

day from the public and officials to help find and convict his killers. The former "General Hospital" actor was shot on May 25 when he interrupted thieves stealing the catalytic converter from his car in downtown Los Angeles, authorities said. No arrests have yet been

"I'm asking that anybody that knows anything please come forward," the actor's mother, Scarlett Wactor of South Carolina, said at a news conference outside Los Angeles City Hall. "It will help me and his brothers in our healing to know that they've been captured and convicted.

Police made their own plea for public help on Aug. 5 when they released surveillance images of three unidentified suspects and their getaway car - a stolen 2018 black Infiniti Q50.

Johnny Wactor was born in Charleston, South Carolina, and grew up in the nearby town of Summerville. He portrayed Brando Corbin on the ABC soap opera "General Hospital" from 2020 to 2022. He also appeared in films and TV series including "Station 19," "NCIS" and 'Westworld."

Scarlett Wactor said previously that her son had left work at a rooftop bar with a coworker when he saw someone at his car and thought it was being towed. A mask-wearing suspect opened fire, his mother said.

"Grief is my constant companion," she said Tuesday. "I can't wish him happy birthday on Aug. 31 - he would have been 38. I can't ask if he's coming home for Christmas. I can't ask how his day went.'

Others at the news conference called for more action from Mayor Karen Bass and other leaders to combat crime.

"We will make sure that no family has to endure the pain that Scarlett is enduring today," City Councilman Kevin de León said. "We want justice for Johnny and we shall have it."

Elon Musk uses X to heighten his 'views'

NEW YORK, Aug 14, (AP): As X's owner and most followed user, **Elon Musk** has increasingly used the social media platform as a megaphone to amplify his political views and, lately, those of right-wing figures he's aligned with. There are few modern parallels to his antics, but then again there are few modern parallels to Elon Musk himself.

Of course, none of this should come as a surprise. Back in 2022 when he was trying to buy Twitter, Musk said he was doing so because it wasn't living up to its potential as a "platform for free speech." Protecting free speech - not money - was his motivation because, as he put it, "having a public platform that is

maximally trusted and broadly inclusive is extremely important to the future of civi-

the future of civilization. For

coming "population collapse," threatening to wipe out human-



ity. And he joined prominent scientists and tech leaders last year in warning the world about artificial intelligence doing the same. Musk has framed threats to free speech as yet

another existential crisis looming over the world. And he is going to try his best to

"Free speech is the bedrock of a functioning democracy, and Twitter is the digital town square where matters vital to the future of humanity are debated," Musk said in an April 2022 post, adding hearts, stars and rocket emojis to highlight the statement.

Two years on, the platform - now called X - has indeed become a haven for the type of free speech Musk has come to champion. In the U.S., he's spread memes - and sometimes misinformation - about illegal immigration, alleged election fraud and transgender policies, and he formally endorsed former President Donald Trump's presidential bid this summer.

Glitches

In May 2023, he co-hosted Florida Gov. Ron De-Santis' official presidential bid announcement. That turned out to be a disastrous rollout marred by technical glitches but it underscored Musk's desire to turn X into a "digital town square." After the event was marred by technical difficulties, Musk extended an open invitation to any other presidential candidate who wants to do one. Trump took him up on it, agreeing to an interview with the billionaire Tesla CEO on Monday evening. The conversation started with technical glitches with people unable to join in and began some 42 minutes late.

"I've not been very political before," Musk said during his conversation with Trump.

Overseas - where most X users live - he's feuded with top officials in Australia, Brazil, the European Union and the U.K. over the balance between free speech and the spread of harmful misinformation. And he accused a political party in his native South Africa of "openly pushing for genocide of white people."

"Elon Musk is a master of the media and controls one of the world's largest microphones. Musk understands the power of social media in shaping a political narrative," said Emarketer analyst Jasmine Enberg "The concern is that as he pushes his own political agenda, X could suppress viewpoints that oppose Musk's own, either intentionally or by nature of the platform becoming more partisan. That could turn off users who feel marginalized on the platform, and disillusion some who may have earlier bought into his free

Musk's political shift playing out on X comes as other social media platforms, notably Meta's Facebook and Instagram, are shying away from politics. Meta CEO Mark Zuckerberg has never endorsed a presidential candidate - and in February, the world's largest social media company announced it would avoid recommending political content to people who don't already follow such accounts.

Lately, Zuckerberg appears to contrast Musk in other ways too. While as recently as January, the Facebook founder was testifying before Congress about the harm his platforms have caused children, he seemed to have embraced a more stylish look that includes gold chains, longer curls and a beaming confidence coupled with slightly self-deprecating humor that seems to embrace his eccentricities. On July 4th, for instance, he posted a video of himself riding an electric surfboard, wearing a tuxedo and holding a can of beer in one hand and an American flag in the other. The online response was far more positive than to a 2021 surfing photo, where he's seen slathered in so much sunscreen it looks like he is wearing a white mask.

Musk, meanwhile, is veering from cool nerd territory into what Kara Swisher, the elder stateswoman of tech journalism, recently called "the Howard Hughes portion" of an inevitable decline. He's sparring with those who disagree with him - be they foreign governments or people infected by what he calls the "woke


Last week, the British government called on Elon Musk to act more responsibly after the tech billionaire used X to unleash a barrage of posts that risk inflaming violent unrest gripping the country.

Justice Minister Heidi Alexander made the comments after Musk posted a comment saying that "Civil war is inevitable" in the UK Musk later doubled down, highlighting complaints that the British criminal justice system treats Muslims more leniently than farright activists and comparing Britain's crackdown on social media users to the Soviet Union.

Officials at X did not immediately respond to re-

quests for comment. Of course, some of Musk's current battles over free speech are similar to those that the previous Twitter administration was fighting in repressive regimes that have, at times, restricted or blocked access to the platform to suppress dissent. In Venezuela, for instance, President Nicolás Maduro ordered a 10-day block on access to X in the country last week - the latest in a series of efforts by his government to try to suppress information sharing among people voicing doubts about his claim to victory in the July 28 presidential election. Maduro accused X of being used by his opponents to create political unrest, and gave the company 10 days to "present their documents," but he gave no additional details.

Musk's antics are unlike any other Big Tech leader, and while it may be off-putting to a segment of his X user base, it could also attract eyeballs to his platform. Could this all be part of a broader plan? After all, despite publicly criticizing Musk's antics, those on the left continue to use his platform.

ATLANTA: Jurors in the long-running racketeering and gang prosecution against rapper Young Thug and others returned to an Atlanta courtroom Monday after an eight-week pause to find a new judge on the bench.

The jury was already on a break in early July when the trial was put on hold to allow a judge to determine whether the judge overseeing the case should be removed. Two weeks later, Fulton County Superior Court Chief Judge Ural Glanville was removed from the case after two defendants sought his recusal, citing a meeting the judge held with prosecutors and a state witness.

Fulton County Superior Court Judge Paige Reese Whitaker was appointed to take over the case. After she denied motions for a mistrial, the trial resumed Monday with Kenneth Copeland returning to the witness stand, The Atlanta Journal-Constitution reported.

Young Thug, a Grammy winner whose given name is **Jeffery Williams**, was charged two years ago in a sprawling indictment accusing him and more than two dozen others of conspiring to violate Georgia's anti-racketeering law. He also is charged with gang, drug and gun crimes. He is standing trial with five other peo-

ple indicted with him.

Lawyers for Young Thug and co-defendant **Deamonte Kendrick** had filed motions seeking Glanville's recusal. They said the judge held a meeting with prosecutors and prosecution witness Copeland at which defendants and defense attorneys were not present. The defense attorneys argued the meeting was "improper" and that the judge and prosecutors had tried to pressure the witness to testify.

Glanville's colleague, Judge Rachel Krause, did not fault Glanville for holding the meeting but said he should be removed to preserve the public's confidence in the judicial system. (AP)

Modern 'Tristan' opens Bayreuth fest

BAYREUTH, Germany, Aug 14, (AP): Thorleifur Örn Arnarsson's phone rang in his Icelandic highlands cabin back in January 2022. Katharina Wagner, the Bayreuth festival director and great-granddaughter of composer Richard Wagner, wanted to get in touch.

She invited Arnarsson to create a new production of "Tristan und Isolde" to open the 2024 festival. He listened to Carlos Kleiber's 1982 recording on Spotify that night and accepted the next day.

"The skies are clear and stars are so bright and the northern lights are very common," he said. "I can't imagine a better place to sit down and close your eyes and listen to 'Tristan und Isolde' than in that place. I immediately had a very strong, almost visceral personal reaction because I understood their struggles so well to try to understand what was going on inside of themselves.'

Arnarsson's staging, starring Andreas Schager and Camilla Nylund and conducted by Semyon Bychkov, opened July 25 in a run of seven performances through Aug. 26. Video from opening night can be streamed on Stage+.

Along with the traditional tragic love story, this "Tristan" is a psychoanalytic examination of self-loathing and burdensome expectations. The intellectually dense production with sets by Vytautas Narbutas and costumes by Sibylle Wallum is so layered with symbolism that a study guide would be

They start singing of their ardor 20 feet apart before Tristan gets the courage to draw near for an embrace and kiss. He wanders away from Isolde to caress a framed photo of his mother and stare in a mirror - which he puts a fist through when Melot bursts in.

"It has to do with his loneliness that he's felt his whole life," Arnarsson said. "He cannot dare to meet Isolde at face level as himself but he knows that he cannot longer live as the hero."

NEW YORK: Paramount Global is restructuring its TV-production business as part of a cost-cutting effort and what the company said were significant changes in the TV and streaming marketplaces.

Paramount on Tuesday said that Paramount Television Studios was shutting down at the end of the week, and that its sister TV unit -- CBS Studios -- would absorb the production of Paramount shows as a result of the move. CBS Studios produces content for the CBS network, Paramount+ and other platforms.

"For decades, Paramount has been one of the pre-eminent producers of television shows," said The Wall Street Journal in its report about the move. Paramount Television Studios recently produced several hits for streaming services including "13 Reasons Why" for Netflix, "Reacher" for Amazon Prime Video and "Defending Jacob" for Apple TV+

"Over the past several years, however, the studio has shrunk in size and status -- a victim of industry consolidation and challenges facing its parent company," noted The Journal.

The move is part of a shake-up at Paramount Global that will result in about 15 percent of its US workforce being eliminated, or a cut of approximately 2,000 jobs. Paramount Global parent National Amusements is in the process of being acquired by Skydance Media in a complex deal that would result in the combination of Paramount and Skydance. (Xinhua)

'Domestic cats may transmit avian flu to humans'

23 species of mammals found infection of H5 bird flu in US

LOS ANGELES, Aug 14, (Xinhua): The outbreak of H5 bird flu in the United States has showed up in more animal species, including 23 species of mammals, according to the US Department of Agriculture.

The department's website tracking the virus updated Tuesday that Influenza A, also known as HPAI, Highly Pathogenic Avian Flu H5N1, had been detected in many mammals, such as deer mouse, house mouse, desert cottontail, prairie vole, raccoon, striped skunk, red fox, mountain lion, bobcat and black bear.

"There are many species that are potentially susceptible to highly

pathogenic avian influenza (HPAI)," the website said. "In addition to birds and poultry, H5N1 viruses have been detected in some mammals. Infection may cause illness, including severe disease and death in some cases."

The department noted that due to the increased interest in domestic cats associated with the HPAI outbreak, the authority collected the concerned information since March and reported them to World Organization for Animal Health (WOAH).

"As companion animals, domestic cats provide a potential pathway for avian influenza viruses to spillover into humans," according to Kristen Coleman, an assistant professor at the School of Public Health of the University of Maryland and an affiliate professor at Department of Veterinary Medicine, reported in the university's news outlet in June.

"We looked at the global distribution and spread of bird flu infections in feline species between 2004 and 2024 and found a drastic rise in reports of feline infections starting in 2023, with a spike in infections reported among domestic cats, as opposed to wild or zoo-kept animals. This increase coincides with the rapid spread of the current strain of H5N1 among mammals," Coleman added.

Bird flu is not currently reported to be contagious between humans, and it is not guaranteed to evolve in that direction, but the disease is clearly changing, the report warned. "The current strain of the H5N1 has been spreading to animals that have never been affected before, and pets that can pass it to people could play a role in how it evolves."

Bird flu, a virus usually spread among wild birds and domesticated poultry, made the leap to dairy cattle in the United States in December or January, and has since spilled to other species of animals. Since the emergence of H5N1 in US dairy cattle, 35 domestic cats have been reported to be infected to date, while no known human cases of H5N1 have been linked to exposure to infected cats, according to health officials.

"It's just remarkable how fast and furious it's moving. So I hope we can get a handle on it soon," said Kay Russo, a Colorado veterinarian who has worked with both dairy cows and poultry, which have been hard hit by the virus this year.

In Colorado, six feline cases of Influenza A have been diagnosed in domestic cats so far this year, according

to the Colorado Veterinary Medical Association's website.

The federal Centers for Disease Control and Prevention (CDC) continued to state that the risk to the general public is low. However, Russo said the surge of confirmed cases raise the level of concerns.

"People with direct contact to infected cats should be considered at the same risk as those in direct contact with other infected animals, such as cows or poultry," she wrote in an email to Colorado Public Radio Tuesday, "The risk of human infection from contact with cats is not well understood."

New push to ban use of cellphones in US schools

Mental health in focus

SACRAMENTO, Calif., Aug 14, (AP): California and South Carolina could become the next states to limit cellphone use in schools, with state officials taking up the issue Tuesday.

California Gov. Gavin Newsom is sending letters to school districts, urging them to restrict students' use of smartphones on campus. South Carolina's State Board of Education took up guidelines to tell local districts to ban cellphone use during class time, but postponed a final vote until next month to take more time to craft the proposal.

The efforts mark a broader push by officials in Utah, Florida, Louisiana and elsewhere to try to limit cellphone use in schools in order to reduce distractions in the classroom - and address the impacts of social media on the mental health of children and teens.

But progress can be challenging. Cellphone bans are already in place at many schools, but they aren't always enforced.

Districts should "act now" to help students focus at school by restricting their smartphone use, Newsom said in the letter. He also cited risks to the well-being of young people, a subject which garnered renewed attention in June after US Surgeon General Vivek Murthy called on Congress to require warning labels on social media platforms.

"Every classroom should be a place of focus, learning, and growth," the Democrat said in his letter. "Working together, educators, administrators, and parents can create an environment where students are fully engaged in their education, free from the distractions on the phones and pressures of social media."

a mandate but nudges districts to act.

The debate over banning cellphones in schools to improve academic outcomes is not new. But officials often resort to bans as a solution rather than find ways to integrate digital devices as tools for learning, said Antero Garcia, a professor at Stanford University's Graduate School of Education.

"What I'm struck by is society's inability to kind of move forward and find other kinds of solutions other than perpetually going back to this 'Should we ban devices?' conversation as the primary solution to something that hasn't worked," Garcia said.

"Suggesting curtailing cellphone use in schools is a great thing to say," he added. "What that means for the middle school teacher come next week when many schools start is a very different picture."

Some schools and districts in California have already taken action. The Santa Barbara Unified and Los Angeles Unified school districts passed bans on student cellphone use in recent years.

But some school board advocates say the state should not go further by passing a blanket ban on cellphone use. That decision should be left up to districts, said Troy Flint, spokesperson for the California School Boards Association.

What is it and what's the WHO doing? Mpox has been declared a public health emergency across Africa

LONDON, Aug 14, (AP): The Africa Centers for Disease Control and Prevention declared this week that the increasing spread of mpox across the continent is a health emergency, warning the virus might ultimately spill across international borders.

On Wednesday, the World Health Organization is convening its own expert meeting to consider making a similar emergency declaration over mpox. The UN health agency said there have been more than 14,000 cases and 524 deaths this year, which already exceed last year's figures.

So far, more than 96% of all cases and deaths are in a single country - Congo. Scientists are concerned by the spread of a new version of the disease there that might be more easily transmitted among people.

Here's a look at what we know about mpox, and what might be done to contain it:

Mpox, also known as monkeypox, was first identified by scientists in 1958 when there were outbreaks of a "pox-like" disease in monkeys. Until recently, most human cases were seen in people in central and west Africa who had close contact with infected animals.

In 2022, the virus was confirmed to spread via sex for the first time and triggered outbreaks in more than 70 countries that had not previously reported mpox.

Causes

Mpox belongs to the same family of viruses as smallpox but causes milder symptoms like fever, chills and body aches. People with more serious cases can develop lesions on the face, hands, chest and genitals.

The number of cases has jumped dramatically. Last week, the Africa CDC reported that mpox has now been detected in at least 13 African countries. Compared with the same period last year, the agency said cases are up 160% and deaths have increased by

19%.

Earlier this year, scientists reported the emergence of a new form of mpox in a Congolese mining town that can kill up to 10% of people and may spread more easily.

Unlike in previous mpox outbreaks, where lesions were mostly seen on the chest, hands and feet, the new form of mpox causes milder symptoms and lesions on the genitals. That makes it harder to spot, meaning people might also sicken others without knowing they're infected.

WHO said mpox was recently identified for the first time in four East African countries: Burundi, Kenya, Rwanda and Uganda. All of those outbreaks were linked to the epidemic in Congo.

In the Ivory Coast and South Africa, health authorities have reported outbreaks of a different and less dangerous version of mpox that spread worldwide in 2022.

Africa CDC Director General Dr. Jean Kaseya said the agency's declaration of a public health emergency was meant "to mobilize our institutions, our collective will and our resources to act swiftly and decisively." He appealed to Africa's international partners for help, saying that the escalating caseload in Africa had largely been ignored.

"It's clear that current control strategies

aren't working and there is a clear need for more resources," said Michael Marks, a professor of medicine at the London School of Hygiene and Tropical Medicine. "If a (global emergency declaration) is the mechanism to unlock these things, then it is warranted," he said.

During the global outbreak of mpox

in 2022, gay and bisexual men made up the vast majority of cases and the virus was mostly spread through close contact, including sex. Although some similar patterns

Although some similar patterns have been seen in Africa, children under 15 now account for more than 70% of the mpox cases and 85% of deaths in Congo.

Ahead of its emergency meeting on mpox, WHO Director-General Tedros Adhanom Ghebreyesus said officials were dealing with several mpox outbreaks in various countries with "different modes of transmission and different levels of risk."

"Stopping these outbreaks will require a tailored and comprehensive response," he said.

Greg Ramm, Save the Children's Congo director, said the organization was particularly worried about the spread of mpox in the crowded camps for refugees in the east, noting there were 345,000 children "crammed into tents in unsanitary conditions." He said the country's health system was already "collapsing" under the strain of malnutrition, measles and cholera.

Also:

MOGADISHU: The Somali Ministry of Health and Human Services has launched an awareness campaign on mpox, which has emerged as a public health emergency of major concern in **Africa** amid a surge in cross-border transmission.

The ministry said in a health alert released Tuesday that the campaign will provide information on symptoms of the virus, preventive measures, its risks, and how mpox is transmitted.

The ministry said its surveillance team has not detected or reported any cases of the disease in **Somalia**. "However, **Kenya**, a neighboring country, has confirmed the presence of the disease with one case. Therefore, the Ministry of Health considers the situation a significant health threat that requires full vigilance."

The ministry said its health workers will use social media, posters, and pamphlets to disseminate information across the country about mpox, whose prevention and control rely on raising awareness in communities and educating health workers to prevent infection and stop transmission.

Philippines sees 136,161 dengue cases, 364 deaths

MANILA, Aug 14, (Xinhua): Dengue cases in the Philippines surged to 136,161 from January to Aug. 3 this year, with at least 364 deaths, the country's Department of Health (DOH) said Tuesday.

"Fewer deaths continue to be recorded this year despite the rising number of cases," DOH spokesperson Assistant Secretary Albert Domingo said.

He attributed the relatively lower number of deaths this year to "people seeking early consultation and hospitals doing better management."

Domingo urged the public to be vigilant, reminding them that dengue cases

"are still on an uptrend."

Dengue is endemic in t

Dengue is endemic in the Philippines. Water-borne infectious diseases, including dengue, usually peak at the start of the rainy season from July to October due to fluctuating weather conditions, flooding, and accumulation of contaminated water.

Meanwhile, DOH said Tuesday that leptospirosis cases have continued to rise after the July 24 severe flooding that hit Metro Manila and nearby provinces. From January to Aug. 3, DOH tallied

From January to Aug. 3, DOH tallied 2,115 cases and 224 deaths. The most recent epidemiologic data recorded 255 new leptospirosis cases from July 21 to

Aug. 3, 17 percent higher than the 217 cases recorded from July 7 to 20.
"The DOH epidemiologists continue

to be cautious in interpreting trends as there may be late reports," DOH spokesperson Assistant Secretary Albert Domingo said. The incubation period of leptospirosis ranges from two to 30 days, with a clinically observed average of seven to 14 days.

At least two government hospitals in Metro Manila have expressed concern over the rising number of leptospirosis patients, forcing them to set up additional wards to accommodate more patients, especially those requiring dialysis.

PERTH, Australia, Aug 14, (AP): Scrumhalf Morne van den Berg and lock Ruan Nortje were expected to earn their first test starts in a South Africa team with 10 changes to the starting lineup which beat Australia last weekend in the first round of the Rugby Championship.

Salmaan Moerat will captain the 2023 World Cup champions from lock while regular captain Siya Kolisi was one of nine players from last Saturday's 33-7 victory over the Wallabies at Brisbane who has been rotated in the squad.

The teams will play at Perth, Western Australia on Saturday.

Loose forward Marco van Staden was promoted from the bench to take Kolisi's No. 6 jersey, while the players retaining starting places were wing Cheslin Kolbe, center Jesse Kriel, flyhalf Sacha Feinberg-Mngomezulu, No. 8 Elrigh Louw and Pieter-Steph du Toit, who moves from lock to flanker.

Springbok coach Rassie Erasmus says the reason for the wholesale changes was a desire to expand his squad's depth.

"We made it clear from the outset this season that one of our main goals is to build squad depth with an

eye on the next Rugby World Cup here in Australia, and we feel there is no better way to test some of the younger players and assess where we are as a group against a top-tier nation, especially away from home, in this match," Erasmus said in a statement Wednesday.

"We have a group of about 45 players that are part of our wider squad this season and we've seen what most of these players can do.

We feel this is the right time to test them against an Australian outfit that will be desperate to bounce back strongly from last weekend."

Australia had won its first three matches of the season, beating Wales twice and defeating Georgia, before losing to the Springboks last weekend. The Wallabies were expected to name their team for the Perth test on Thursday.

French prosecutors investigate gender-based cyber harassment of Algerian Olympic champ Imane Khelif

PARIS, Aug 14, (AP): French prosecutors opened an investigation into an online harassment complaint made by Olympic boxing champion Imane Khelif after a torrent of criticism and false claims about her sex during the Summer Games, the Paris prosecutor's

office said Wednesday. The athlete's lawyer Nabil Boudi filed a legal complaint with a special unit in the Paris prosecutor's office that

combats online hate speech on Friday. Boudi said the boxer was targeted by a "misogynist, racist and sexist campaign" as she won gold in the women's welterweight division, becoming a hero in her native Algeria and bringing global attention to women's boxing.

The prosecutor's office said it had received the complaint and its Office for the Fight against Crimes against Humanity and Hate Crime had opened an investigation on charges of "cyber harassment based on gender, public insults based on gender, public incitement to discrimination and public insults on the basis of origin.

Khelif was unwillingly thrust into a worldwide clash over gender identity and regulation in sports after her first fight in Paris, when Italian opponent Angela Carini pulled out just seconds into the match, citing pain from open-

ing punches. False claims that Khelif was transgender or a man erupted online, and the International Olympic Committee defended her and denounced those peddling misinformation. Khelif said that the spread of misconceptions about her "harms human dignity."

Pakistan rewards Nadeem with \$359,000 for record-breaking throw

ISLAMABAD, Aug 14, (Agencies): Olympic javelin gold medalist Arshad Nadeem received \$359,000 from the Pakistani government as the country continued to celebrate his record-breaking throw at the Paris Games.

Punjab's Chief Minister Mariam Nawaz visited Nadeem's house in a village in the Mian Channu district and presented him with a cheque for 100 million rupees (\$359,000).

Nawaz also handed him the keys to a new car which has a special registration number of "PAK 92.97" to commemorate Nadeem's throw of 92.97 meters at Paris, which was an Olympic record. Nadeem's coach Salman Iqbal Butt was also given 5 million rupees (\$18,000).

Last Thursday, Nadeem set off celebrations across Pakistan when his throw easily surpassed the previous Olympic mark of 90.57 set by Andreas Thorkildsen of Norway in 2008. It was also well clear of India's Neeraj Chopra, the Tokyo champion, who reached a season-best 89.45 for

"Arshad Nadeem has brought unprecedented happiness to the na-

tion," Nawaz said in a statement.

Nadeem won Pakistan's first Olympic gold in 40 years, when the men's field hockey team won at the 1984 Los Angeles Games. Pakistan's last medal of any color was a field hockey bronze at the 1992 Barcelona

Stopping Man City, VAR and 'burnout' an authorized board to sign off on their fears, big talking points ahead season

LONDON, Aug 14, (AP): A look at some of the big talking points heading into the new Premier League season, which starts on Friday when Manchester United hosts Fulham:

Stopping City Since 2017, only one team - Liverpool, in 2020 - has stopped Manchester City winning the title. Can anyone stop Pep Guardiola's juggernaut capturing a record-extending fifth straight title in what could be a tumultuous season for the champions? Arsenal took City all the way last season, having collapsed late the year before, and looks to be the best equipped to win what would be its first title since 2004. Otherwise, only Liverpool seems capable of producing the consistency to finish

ahead of City - and that is a big ask for Arne Slot in his first season in charge since replacing Jurgen Klopp as manager. Manchester United and Chelsea should improve after more heavy spending in the offseason, but they are unlikely to deliver a sustained push for the title.

Improved VAR?

It will be the sixth season of video reviews in England's top division and it still hasn't prevented regular flashpoints popping up, much to the frustration of players, managers and fans alike. New for this season is an account on X, formerly Twitter, dedicated to offering live refereeing and VAR clarifications and explainers

Goals, Goal, Goal Premier League teams will do well to top the record 1,246 goals scored last season, which was a staggering 162 more than the previous most for a single campaign. It worked out at 3.28 goals per match - never before had it exceeded 2.85. Increased amounts of stoppage time, more adventurous managers and VAR interventions were credited as some of

Long Season

For some, this could be the longest ever club season. Take the players at Manchester City, who have just started the season by winning the Community Shield on Saturday and might not finish it until the final of FIFA's expanded and revamped Club World Cup, scheduled for July 13 next year in the United States. Make that an 11-month season for City and Chelsea, the other Premier League team involved in the Club World Cup. City manager Pep Guardiola has already gone public with his concerns that there is too much soccer on the calendar, with the Champions League also expanding for this season. Expect talk of burnout and the threatened legal action by soccer leagues and player unions against FIFA to be a constant

issue throughout the season. **More Points Deductions?**

Everton and Nottingham Forest were hit with points deductions last season for overspending, forcing all the clubs in the league to take a closer look at their finances to ensure compliance with the competition's regulations that are being more strictly applied. Leicester, one of the three promoted teams, is facing a points deduction for breaching spending rules during their previous stay in the Premier League but have others learned their lesson? Judging by some of the creative transfer activity in the last weeks of June and the lack of blockbuster signings so far in the summer window, teams appear to be more aware of what it takes to comply.

Farewells

Pep Guardiola is heading into his ninth year at Manchester City and he will have to decide at some point this season whether his stay at the club will extend to a decade. Similarly, this might mark Kevin De Bruyne's final season at City - enjoy him while you can - while Liverpool stars Mohamed Salah and Virgil van Dijk are in the final years of their contracts at Anfield. Then there's Everton, which is preparing for its last season playing at Goodison Park, its storied home since 1892, before moving to a new stadium at Bramley Moore Dock that has cost a reported 760 million pounds (\$975 million).

KUWAIT CITY, Aug 14: The Kuwait Football Association has decided to postpone Al-Jahra Club's matches for the first three rounds of the Zain First Division League for the 2024-2025 season due to ongoing issues at the club and the inability to register players with the association.

Al-Jahra was initially set to begin their league campaign next Sunday against Al-Sahel, followed by matches against Burqan on August 24 and Al-Shabab on August 29. However, the association has not yet rescheduled these fixtures, stating that new dates will be announced later.

The club has been facing significant "administrative" problems since last November, following a court ruling that invalidated the board of directors led by Khaled Al-Jarallah. This has led to a period of "regression" across various sports at the club, including the loss of local and foreign players due to financial issues and the lack of

dues. The club's employees have also struggled with delayed salaries.

These challenges have severely impacted the first football team, which was relegated to the first division. The team's professionals left immediately after the season ended, and key local players have moved to other clubs.

Al-Jahra has been further hindered by these issues, particularly in football, where the team has been unable to recruit new coaches or players. Ahmed Hassan, a former player and youth team coach, and Frenchman Enrique were initially brought in to lead the team during preparations last July. Meanwhile, volunteers Mubarak Al-Jadaan and Aziz Madloul have managed the team in an effort to maintain its cohesion amid the crisis, despite the lack of approved technical, medical, and administrative staff.

Jadaan and Madloul have appealed to Dr. Amthal Al-Huwailah, Minister of Social Affairs, Family and Childhood Affairs and Minister of State for Youth Affairs, as well as Bashar Abdullah, Director General of the Public Authority for Sports, seeking urgent attention to Al-Jahra Club's situation.

Lakers open title defense vs Spurs

NEW YORK, Aug 14, (AP): The Los Angeles Lakers' defense of the NBA Cup title will begin on Nov. 15 in San Antonio against Victor Wembanyama and the Spurs, and Klay Thompson will be back at Golden State - as a visitor with Dallas - on Nov. 12.

The NBA released the schedule of the group play games on Tuesday, with those contests getting played on a series of Tuesdays and Fridays starting Nov. 12 and ending Dec. 3. Each team was assigned to a five-team group and plays the other four clubs in that

group once. LeBron James, Anthony Davis and the Lakers went 7-0 in the tournament last season - when it was simply called the In-Season Tournament - and beat the Indiana Pacers in the final in Las Vegas. The semifinals and finals return to Las Vegas this year, with the semis on Dec. 14 and the title game on Dec. 17.

The NBA Cup will provide some obvious storylines. Among them: Thompson going back to Golden State, where he helped the Warriors win four titles, after joining the Mavericks this summer. And then the Lakers open defense of the Cup title, it'll be a game where James and Davis face Wembanyama again after helping the U.S. beat France in the gold-medal game at the Paris Olympics.

Almost all of the games for the

2024-25 NBA season will be released Thursday. All games in the NBA Cup will count in the regular-season standings except for the title game in Las Vegas; that would be an 83rd game for both of those teams, which doesn't fit into an 82-game season.

Teams will get schedules Thursday with 80 games on them. Every team will play two more, either in the playoffs of the NBA Cup or in games scheduled between teams that did not make the tournament quarterfinals. And those teams that lose in the

BASKETBALL

quarterfinals will meet for what essentially becomes the 82nd game on their schedule for the coming season.

There will be 60 group-stage games in all - eight games on Nov. 12, then 12 on Nov. 15, six on Nov. 19, eight on Nov. 22, five on Nov. 26, 10 on Nov. 29 and the final 11 on Dec. 3.

Each NBA team will play four designated group play games one game against each opponent in its group, with two games at home and two games on the road. The four group winners will make the quarterfinals, along with one wild-card team from each conference. That wild-card club will be the best second-place team from each conference.



ndia is the world's largest country in terms of population, comprising around 17% of the global population. It is also the fifth largest economy in the world, on its way to becoming the third largest economy by 2030.

Yet, its contributions to cumulative carbon dioxide emissions since the industrial revolution are a mere 3.4% of the world total and at 2 tons its current per-capita emissions are less than half of the global average of 4.7 tons.

India's per-capita carbon footprint is also the lowest among the G-20 countries with the International Finance Corporation (IFC) acknowledging India as the only G20 nation in line with 2-degree centigrade upper limit for global warming.

Additionally, the IFC has highlighted that India's GDP grew by a Compound Annual Growth Rate (CAGR) of about seven per cent between 2005 and 2019, whereas the emissions grew at a CAGR of about four per cent. This would appear to underscore India's relative success in decoupling economic growth from greenhouse gas emissions, reducing the emission intensity of its GDP and being a possible model for the globe in general and the global South

Leading India's determination to be part of the solution on climate change, Prime Minister Narendra Modi announced a five-point climate action plan (Panchamrit) for India at the UN Framework Convention on Climate Change

(UNFCCC) meeting in Glasgow in November 2021. This included the key commitment of achieving Net Zero emissions by $2070\,$ along with four elements of the pathway. These, enumerated below, were later

incorporated in India's Nationally Determined Contributions (NDCs):

Reach 500 GW of non-fossil fuel generation by 2030 ■ 50% of India's power requirements would come from renewable energy

by 2030 Reduction of total projected carbon emissions by one billion tons till 2030 ■ Reduction of the carbon intensity of the economy by 45% by 2030, over

Many of these goals upped the already significant targets set by India for itself following the UNFCCC meeting in Paris in 2015. This was possible given the fact that India had achieved its NDCs well ahead of time.

In-fact, in so far as use of non-fossil fuel resources for energy, India achieved 40 percent cumulative electric power installation capacity from nonfossil fuel-based energy sources in 2021, nine years before the initial target

Further, between 2017 and 2023, India added around 100 GW of installed electric capacity, of which around 80% is attributed to non-fossil fuel-based

As of now, the share of non-fossil fuel-based resources in installed electricity capacity has reached 45.4 percent. And the key target of 33 percent reduction of emissions intensity of GDP by 2030, from the 2005 level, was met in 2019, 11 years ahead of time.

Apart from the four pathway elements, India has undertaken to create an additional carbon sink of between 2.5 to 3 billion tons of carbon dioxide equivalent through additional forest and tree cover by 2030. As of date, around 1.97 billion tons of carbon dioxide equivalent sinks have been created putting India on track for achieving this Nationally Determined Contribution.

Two other initiatives by India are of global importance:

The first is LiFE – Lifestyle for Environment, a mass movement launched at Glasgow by Prime Minister Modi to encourage the adoption of sustainable lifestyles to address the challenges of environmental degradation and climate


The G-20, in its communiqué issued in New Delhi in September 2023, emphasised the importance of behavioural and lifestyle changes as pillars in the strategic plan adopted for advancing energy efficiency across all demand sec-

production capacity of at least 5 million metric tons per annum with an associated renewable energy capacity addition of about 125 GW (SIDS). This could result in an annual abatement of nearly 50 million metric tons of greenhouse gas emissions. India's efforts on climate change are not only domestic but also seek build global partnerships. At the UNFCCC meeting in Paris in 2015, India joined hands with France and launched the International Solar Alliance (ISA) which today has 119 signatories to its framework agreement and is in the forefront of deploying solar energy solutions in the global South to mitigate climate change. India's huge domestic efforts on pushing solar power have led to majorly reducing the cost of solar power and hence vastly increasing interest in its adoption at home and acting as a model across the global South.

In 2019, India established the Coalition for Disaster Resilient Infrastructure which led to the launch at Glasgow in 2021 of the Infrastructure for Resilient Island States (IRIS), a flagship initiative designed to achieve and deliver resilience and climate adaptation solutions to the Small Island Developing States


At the UNFCCC meeting in Dubai in 2023, India collaborated with Sweden and launched the second phase of the Leadership Group for Industry Transition (Lead IT) 2.0 and at the G-20 Summit in Delhi India joined many countries across the globe in launching the Global Biofuels Alliance.

India through its ambitious policies, successful renewable energy growth trajectory, along with effective achievement of international commitments has strongly demonstrated climate leadership at the global level. With climate change being seen by many as the defining challenge of our times, India's has assumed a pivotal role in tackling climate change, both in terms of its actions and as the leading voice of the global south for sustainability.





GIFT IFSC - positions itself as a 'New Age Global Financial Centre'

The Government of India implemented a major financial sector reform by establishing the country's maiden International Financial Services Centre (IFSC) in GIFT City, Gujarat.

The IFSC has been developed as a unique international financial jurisdiction within onshore India, which has been designated as a non-resident zone under the Foreign Exchange Management (FEM) Act. This special status enables financial transactions to be carried out in any of the notified fifteen foreign currencies, including USD, GBP, Euro and Yen.

The IFSC has been set up with two primary objectives namely -- onshoring India-centric international financial services business, and Serve as a preferred gateway for channelising global capital flows into and out of the country.

Over the last few years, GIFT IFSC has made remarkable progress in positioning itself as a 'New Age Global Financial Centre,' providing an ideal platform for the global financial services industry to integrate more efficiently with the Indian economy.

A key landmark in IFSC's journey so far has been the establishment of the International Financial Services Centres Authority (IFSCA) as a unified statutory body for the development and regulation of IFSCs in India. Since October 2020, IFSCA has assumed its statutory powers and has notified over 29 regulations and more than 14 frameworks encompassing the entire spectrum of financial services, including - banking, capital markets, insurance, the fund industry, Fintech, aircraft leasing, ship leasing, and global corporate treasury centers.

The Government endeavors to develop GIFT IFSC as an internationally recognised financial centre with trusted business regulations, competitive tax regime and ease of doing business.

Today, the GIFT IFSC initiative is a testament to India's firm resolve to undertake bold and transformative reforms in the financial sector.

This ambitious project is envisaged global capital flows into the country and accelerate the integration of the Indian economy with the global financial ecosystem.

As of July 2024, more than 600 + entities across banks, capital markets, insurance, Fintech, aircraft leasing, ship leasing, bullion exchange, etc. have been registered with the IFSCA.

The financial service market is gaining momentum with healthy and growing participation of global and domestic financial services institutions.

The business growth in some of the key sectors is highlighted below:

Banking Sector -- The Banking ecosystem in GIFT IFSC is rapidly evolving with a healthy mix of foreign and domestic banks, primarily catering to the foreign currency borrowing requirements of Indian corporates and public sector enterprises through external commercial borrowing, trade finance, etc.

Transactions under these heads, previously booked from overseas financial centres are now being booked out of GIFT IFSC. As of March 2024, the total asset size of IFSC Banking Units (IBUs) crossed USD 60 billion, and the cumulative value of transactions undertaken by IBUs crossed USD 795

Fund Industry -- The growth of a robust fund industry in GIFT IFSC is has a transformative impact in catalysing global capital inflows into India, including for the start-up ecosystem. Previously, pooling of international capital for investments in India was structured through funds (private equity, venture capital, hedge funds, etc.) set up in offshore jurisdictions.

Now, with enabling regulations, a competitive tax regime, and beneficial cost of operations, GIFT IFSC is emerging as a preferred jurisdiction for the pooling of global capital by foreign and Indian fund managers.

In the last three years, there has been rapid growth in Fund Management Entities (FMEs) and Alternative Investment Funds (AIFs) registered with IFSCA. The cumulative FMEs and funds registered rose from 39 and 33 in September 2022 to 114 and 120, respectively, in March 2024.

Aircraft Leasing -- The aviation industry in India is on the cusp of unprecedented growth, with a strong order book of more than 1500 + aircraft placed by Indian airlines and a projected demand for over 2,200 aircraft by 2042.

Currently, most aircraft operated by Indian airlines are leased from offshore lessors that have access to competitive capital costs. The aircraft leasing and financing business, the most profitable segment in the aviation value chain, was entirely residing in foreign

Recognizing the immense potential of aircraft leasing and financing business, IFSCA introduced the enabling leasing framework, and the Government supported the endeavour by providing several tax incen-

In three years, green shoots have been visible in IFSC with more than 28 aircraft lessors already registered. These have leased more than 120 + aviation assets, including commercial aircraft, helicopters, aircraft engines and ground support equipment.

Foreign universities initiative -- The IFSC, being an offshore jurisdiction is uniquely positioned to become an 'International Higher Education Hub' by attracting top-quality international universities which are keen on exploring India for its talent and demographic pro-

IFSCA achieved a significant milestone in FY24 when Australia's Deakin University became the first foreign university to be granted final registration for their International branch campus in GIFT IFSC under IFSCA (setting up and operation of international branch campus and offshore education centres) Regulation, 2022.

University of Wollongong of Australia became the second foreign university to receive in-principal approval for their international branch campus in GIFT

Global In-House Centres -- Globally, information technology and digital practices have facilitated the cross-border flow of services such as - accounting, auditing, taxation, book-keeping and has fuelled the growth of Global In-House Centres (GIC). GIFT IFSC, is uniquely positioned to offer such services to global clients.

A leading US institution, i.e. Bank of America has already set up a large GIC unit in GIFT IFSC, which is providing in-house support services to the bank's global operations. Several other international firms are now looking at the GIC opportunity in GIFT IFSC.

In the future, GIFT IFSC is slated to play a significant role in achieving the vision of a developed India@2047.






India's automotive industry at a glance

The automotive industry in India is the world's fourth-largest by production and valuation as per 2022 statistics. As of 2023, India is the 3rd largest automobile market in the world in terms of sales; as of April 2022, India's auto industry was worth more than US\$100 billion and accounts for 8 percent of the country's total exports and 7.1 percent of India's GDP

According to the 2021 National Family Health Survey, barely 8 percent of Indian households owned an automobile. According to government statistics,

India has barely 22 automobiles per 1,000 people.

The automobile industry produced a total 28.43 million vehicles including passenger vehicles, commercial vehicles, three wheelers, two wheelers, and quadricycles in April 2023 to March 2024 showing a strong position in the international heavy vehicles arena as it is the largest tractor manufacturer, second-largest bus manufacturer, and third largest heavy trucks manufacturer in the world.

The EV market is expected to grow at CAGR of 49 percent between 2022 and 2030 and the EV industry is set to create 5 million direct and indirect jobs by 2030. A market size of \$50 billion for the financing of EVs in 2030 has been identified, about 80 percent of the current size of India's retail vehicle finance industry, worth \$60 billion now.

India's trucking market is expected to grow over 4 times by 2050. The number of trucks is expected to more than quadruple, from 4 million in 2022 to roughly 17 million trucks by 2050.

As per the Society of Indian Automobile Manufacturers (SIAM), the auto industry generates employment of 13 persons for each truck, 6 persons for each car and four persons for each three wheelers and one person for each two-wheelers. India aims to double its auto industry size to INR 15 lakh crores

In the Automobile market in India, two-wheelers and passenger cars account for 75.3 percent and 17.6 percent market share, respectively. Passenger car sales are dominated by small and midsized cars.

Export of total number of automobiles in 2023-24 was recorded at 45,00,492 out of which two wheelers accounted for about 76.8 percent of the total exports. In April 2023 to March 2024, Passenger Vehicle Exports increased from 6,62,891 to 6,72,105 units, registering a positive growth of 13.8 percent. The Union Cabinet chaired by the Prime Minister, Narendra Modi an-

nounced the Production-Linked Incentive (PLI) Scheme in the Automobile and Auto Components sectors. The PLI scheme (outlay of \$3.5 billion) for the automobile sector proposes financial incentives of up to 18 percent to boost domestic manufacturing of advanced automotive technology products and attract investments in the automotive manufacturing value chain. Incentives are applicable for determined sales of products manufactured in India from April , 2022, for a period of five consecutive years.

The Ministry of Heavy Industries has announced the extension of the tenure of the Production Linked Incentive (PLI) Scheme for Automobile and Auto Components by one year. Under the amended scheme, the incentive will be applicable for a total of five consecutive financial years, starting from the

Recently a total of 115 companies had filed their application under the PLI scheme. Out of 115, 85 applicants have been approved under this scheme -- 18 applicants for Champion OEM Incentive scheme and 67 applicants have been approved under Component Champion Incentive scheme; the scheme has been successful in attracting proposed investment of INR 67,690 Cr against the target estimate of investment INR 42,500 crores over a period of five years; apart from Indian business groups, approved applicants for Champion OEM Incentive scheme include groups from countries such as Republic of Korea, USA, Japan, France, Italy, UK and the Netherlands.

India's major automobile manufacturing companies include Maruti Suzuki, Hyundai Motor India, Tata Motors, Ashok Leyland, Mahindra & Mahindra, Force Motors, Tractors and Farm Equipment Limited, Eicher Motors, Royal Enfield, Sonalika Tractors, Hindustan Motors, Hradyesh, ICML, Kerala Automobiles Limited, JSW MG Motor India, Tara International and Vehicle Factory Jabalpur.

Maruti Suzuki is undeniably the leading car manufacturer in India. With a



has established itself as a trusted brand over the years.

Passenger vehicles comprised 368,086 units, three-wheelers 56,723 units, and two-wheelers dominated with 1,487,579 units sold domestically. India's automotive market is on track to hit a significant milestone, with projections estimating it will reach US\$ 300 billion by 2026.

Chennai is nicknamed the "Detroit of Asia" due to the presence of major automobile manufacturing units and allied industries around the city.

With the Indian automotive market now growing at a rapid rate, a number of carmakers are shifting their primary focus to India and are developing made-for-India products to attract buyers. 

The Araku story - a testimony to the power of democratic participation

The opening of Araku café in Paris in 2017, marked India's arrival on the world map of specialty coffee. It was the tribal farmers of Araku Valley, a rich biodiverse region on the borders of Andhra Pradesh and Odisha that have placed India

The story of Araku Coffee dates back to the year 2000, when the Naandi Foundation started interacting with the local community there. Conscious of the unique cultural and historical heritage of adivasi (tribal) communities,

Naandi Foundation focused on developing a deeper understanding of their culture and the environment they lived in.

The tribal farmers who had been relying on the traditional shifting cultivation were slowly introduced to regenerative agriculture practices. By 2005, these farmers had started working with Naandi Foundation on growing and improving the quality of their coffee

Coffee plantation not only provides better income but also helps in afforestation since it is grown under shade. It provides round the year employment to the local inhabitants and their family members.

The entire valley witnessed a turned around in a

massive annual forest festivals resulting in the planting of 49 million trees, a world-class organic coffee brand with a flagship store in Paris and exports to more than 12 countries.

The tribal farmers and their families are now in the coffee and pepper business, some have their own orchards; they are also growing paddy, pulses and millets using organic regenerative agriculture and are living testimony to the efficacy of a model that ensures economic and ecological security.

Araku stands as a testimony to the power of democratic participation in the form of the tribal farmers' cooperative, which now boasts a 40,000+ membership, regularly conducts democratic elections, and has a current executive body with 50% women.

Araku is an example of how globalization can be leveraged to benefit the smallest farmer in a remote corner of the world - innovative financing models introduced by European companies; international coffee experts frequenting the valley to support the adoption of the 19 steps to world-class coffee; a flagship store in Paris and a score of gourmet partner stores in Paris selling the premium speciality coffee grown here.

Buoyed by the success in Paris, a first-of-its-kind large format Araku Cafe was opened in Bengaluru, India, in 2021. This not only serves the best coffee and food but has also become an interactive cultural



kunomics. Signature coffee equipment borne out of a landmark collaboration with Norwegian design duo Anderssen & Voll – the first of its kind for Indian coffee – was launched first in France and then in India in 2018. Araku opened a restaurant in South Mumbai.

Araku Coffee is now a premium luxury social enterprise with high socio-economic and ecological impact that has demonstrated how India can excel globally across the entire value chain from soil to foil. It is a matter of pride for the Naandi team that Araku coffee was included as one of the prized items in the Government of India's gift hamper presented to visiting heads of state at the G20 Summit in 2023.

Gems of Araku is an annual harvest festival that celebrates the seasons' speciality coffee micro-lots and the farms and farmers of Araku for their contribution to creating this world-class coffee. The event brings together over 20,000 farmer families and coffee experts from across the globe to discover extraordinary coffee lots. Over 1800 micro-lots each season are put through a rigorous evaluation by professional coffee cuppers following international cupping protocols.

Since 2009, the event has helped unite over 40 coveted international jurors and Araku farmers to perfect coffee quality. These stimulating interactions have helped incorporate the best farm and processing practices and raise the coffee to international standards by improving the quality of the beans year after year.

In the pursuit of excellence, Araku farmers are continuously learning about and honing their coffee terroirs to enhance coffee bush health, build soil organic carbon, and regenerate the Araku Coffee landscape. And the proof is in the cup. As the soils get richer and coffee flavour notes more complex, Gems of Araku, currently in its 16th edition, top micro-lots score ratings as high as 94 out of 100 from professional cup-

Internationally acclaimed for their quality, the 'Gems' of Araku has now reached over 42 countries including - Korea, Japan, France, the UK, Germany, and the USA. The event has helped nurture an Indianorigin international coffee brand produced by small and marginal tribal farmer families of Araku by taking it to the global buyer and consumer.

The biodiverse, carbon-rich, wealth-creating model for agriculture, christened Arakunomics by Naandi, was awarded the Food System Vision Prize by the Rockefeller Foundation in 2020 and the Seeding the Future Prize by the Institute of Food Technologists in 2023. It is now being replicated in other geographies of India with complex agrarian realities, such as the Vidarbha region in Maharashtra, ground-water-depleted districts in Punjab and forgotten border districts in northern Uttar Pradesh.
